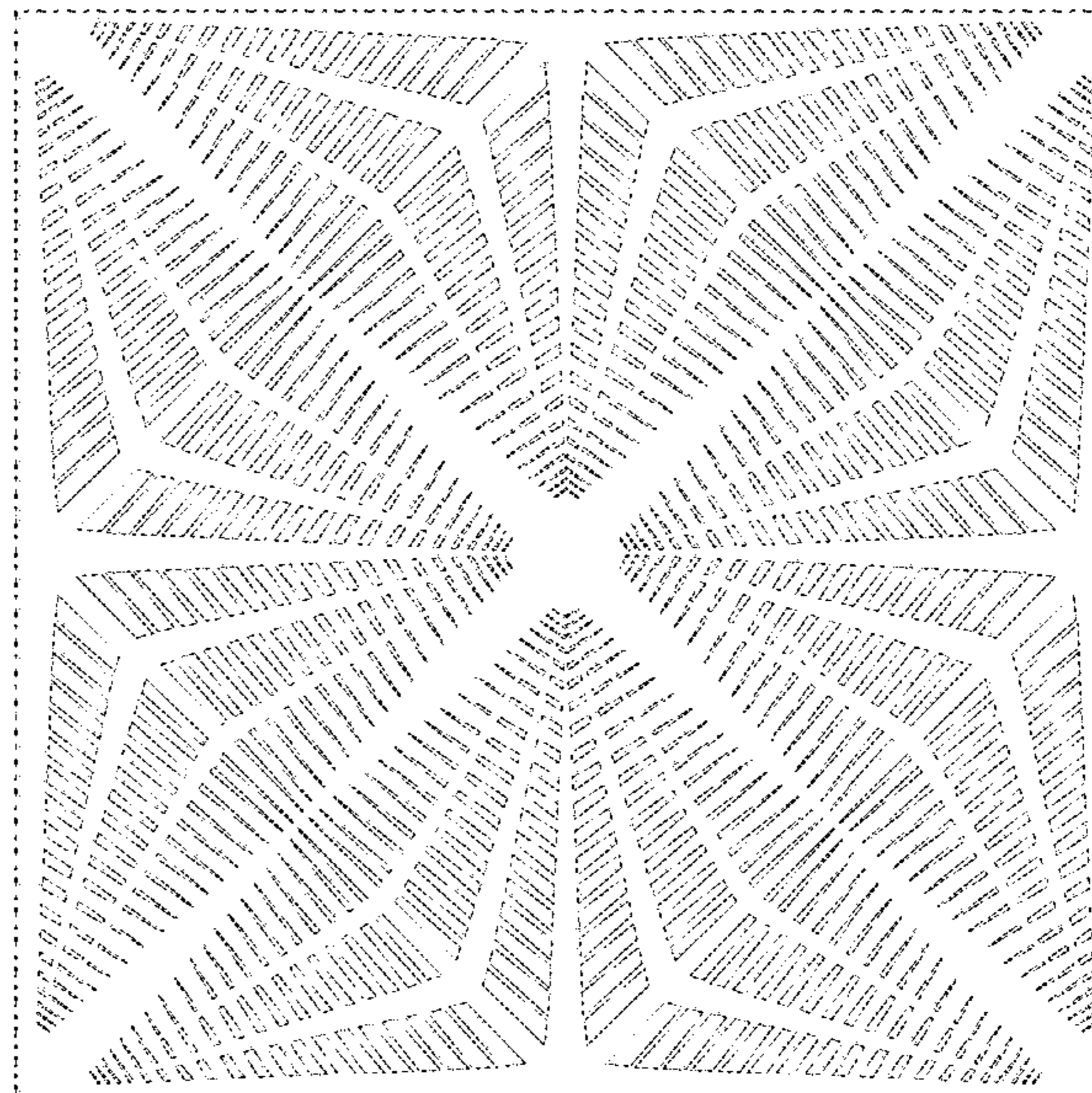
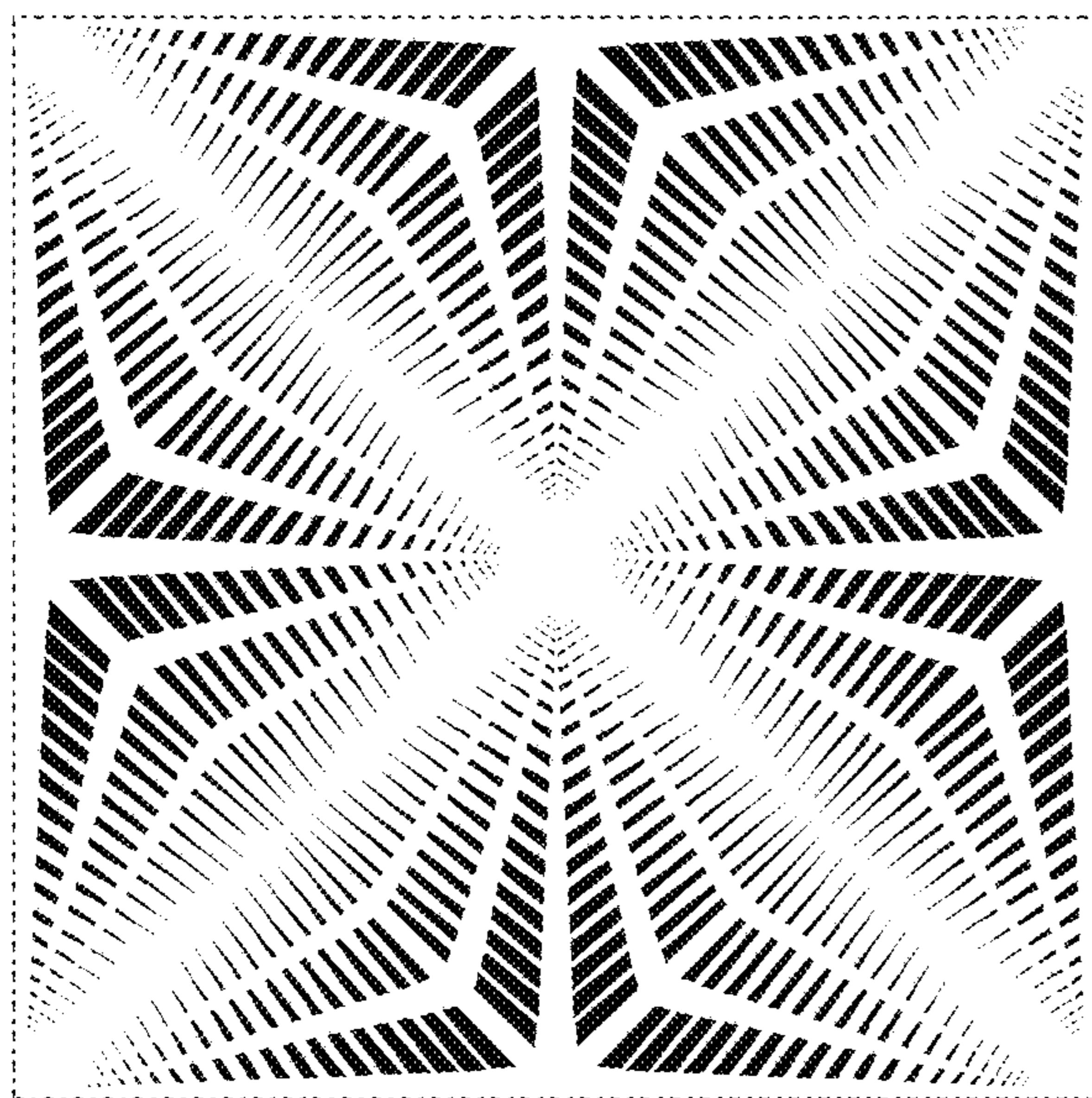
The ornamental design for a woven, knitted or non-woven textile for apparel, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a woven, knitted or non-woven textile for apparel showing my new design; and, FIG. 2 is a top plan view of a second embodiment of a woven, knitted or non-woven textile for apparel showing my new design.

The bottom plan views of FIGS. 1 and 2 are flat and unornamented, thus are not illustrated. The dot-dash lines, which define the bounds of the claimed design, form no part thereof.

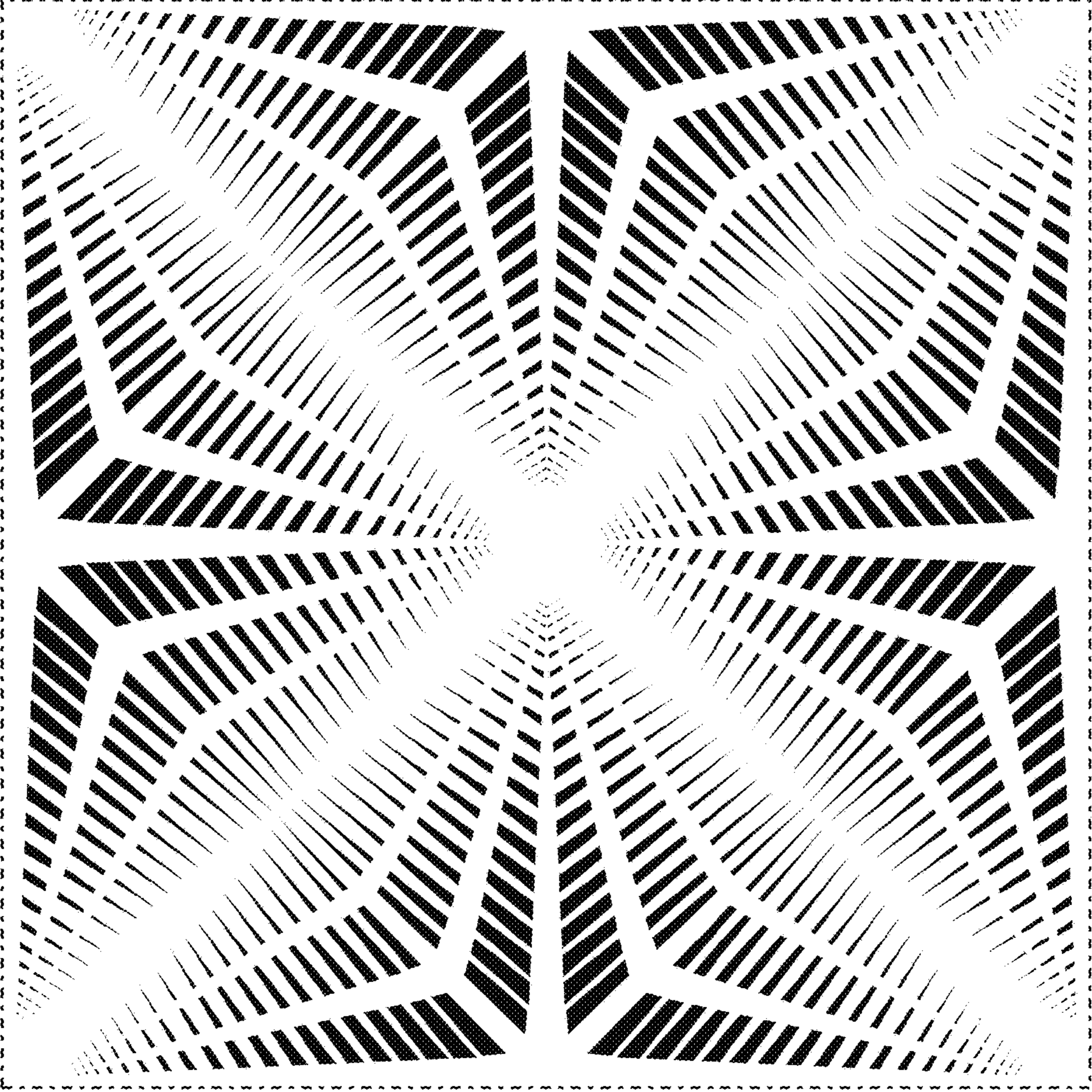

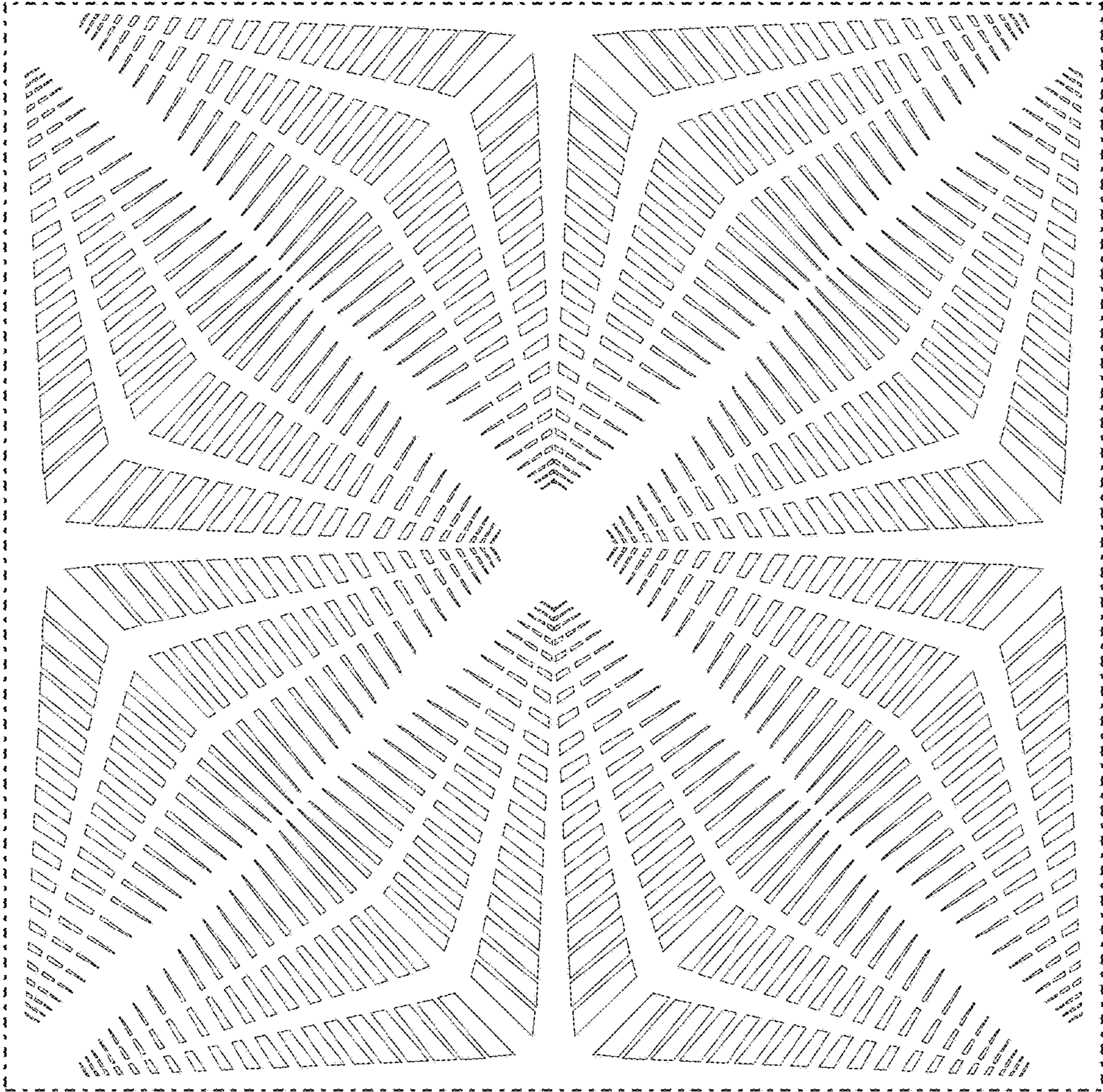
