**DESCRIPTION**

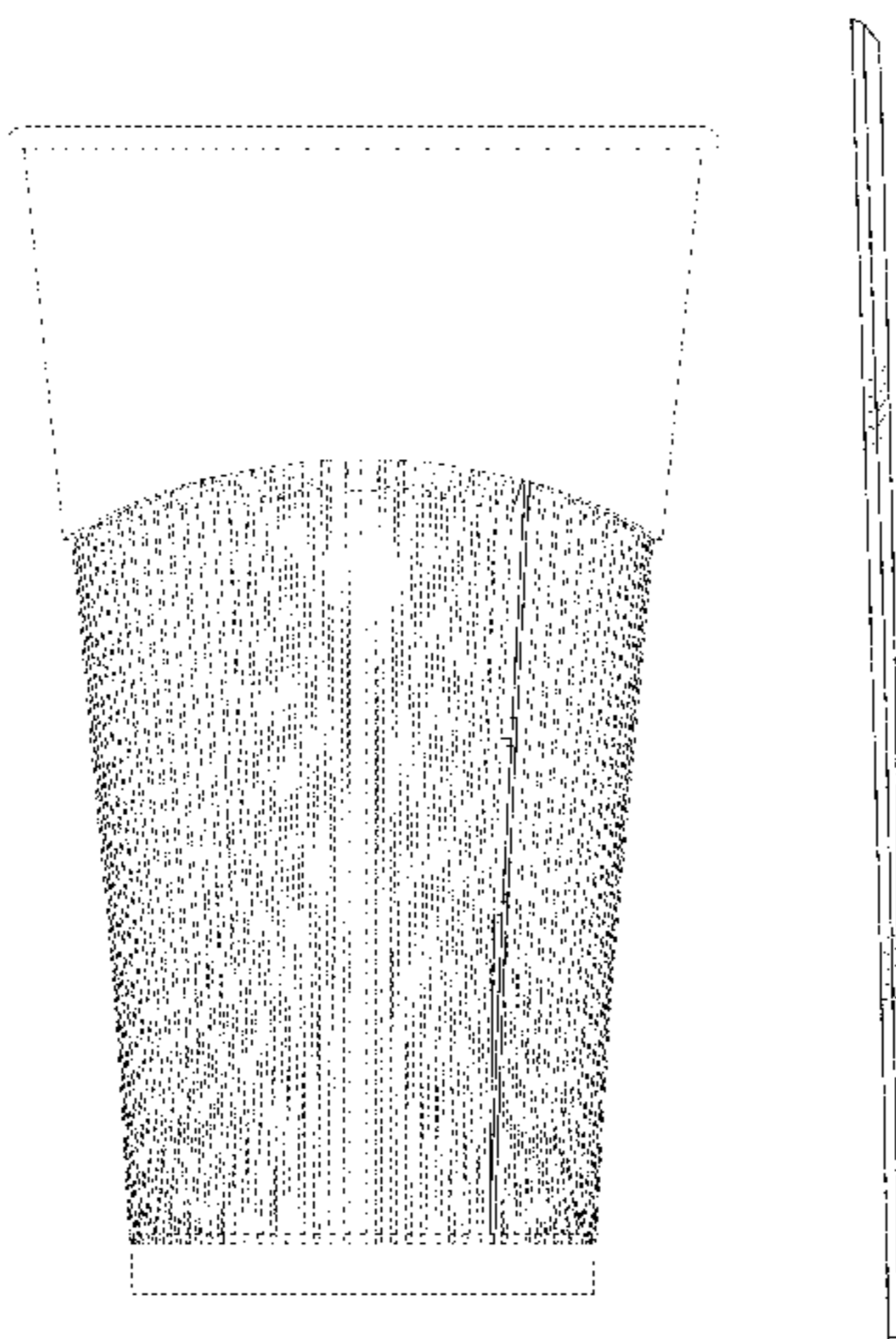
FIG. 1 is a top, front, right perspective view of a container rib showing our new design;

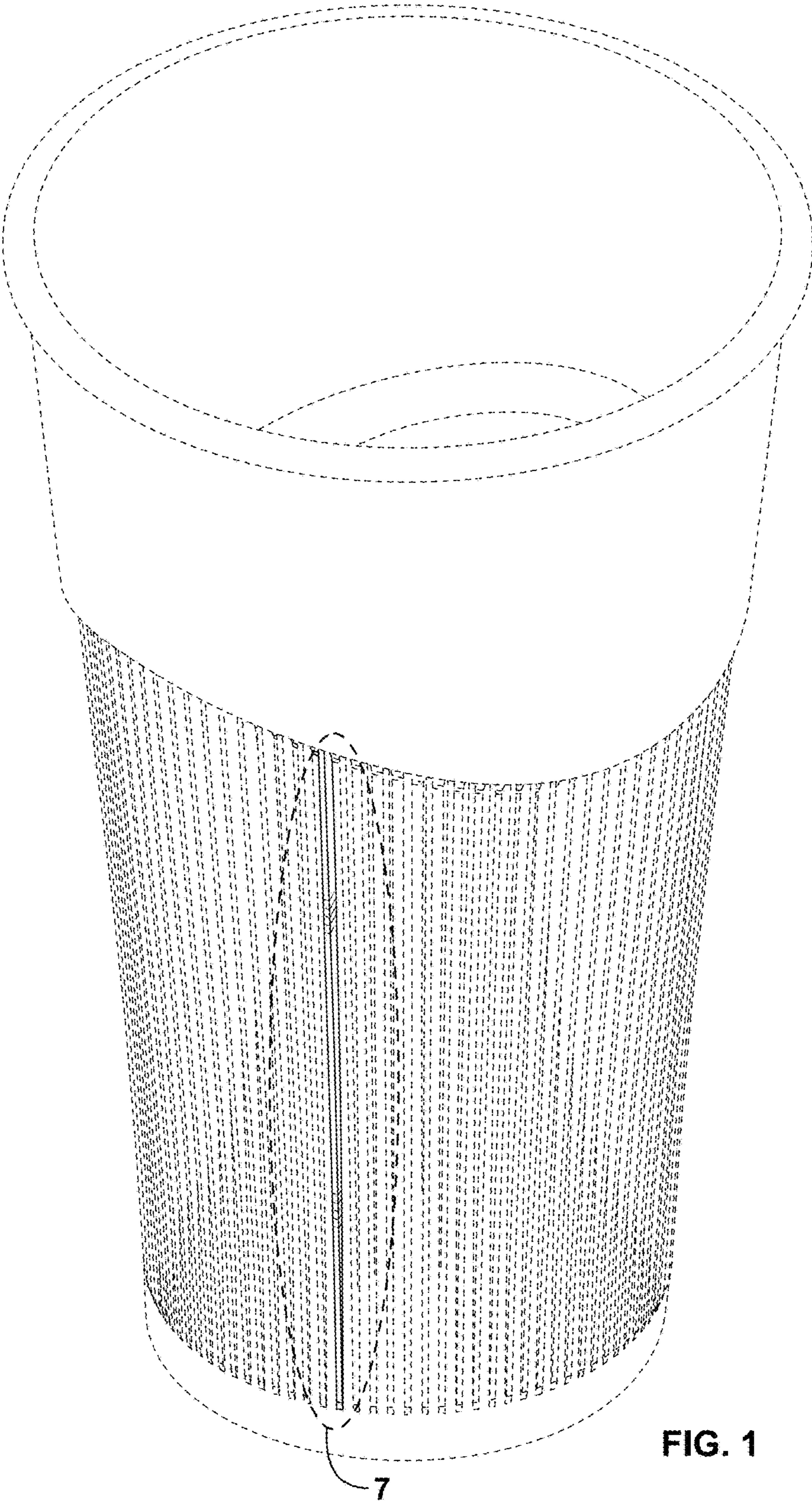

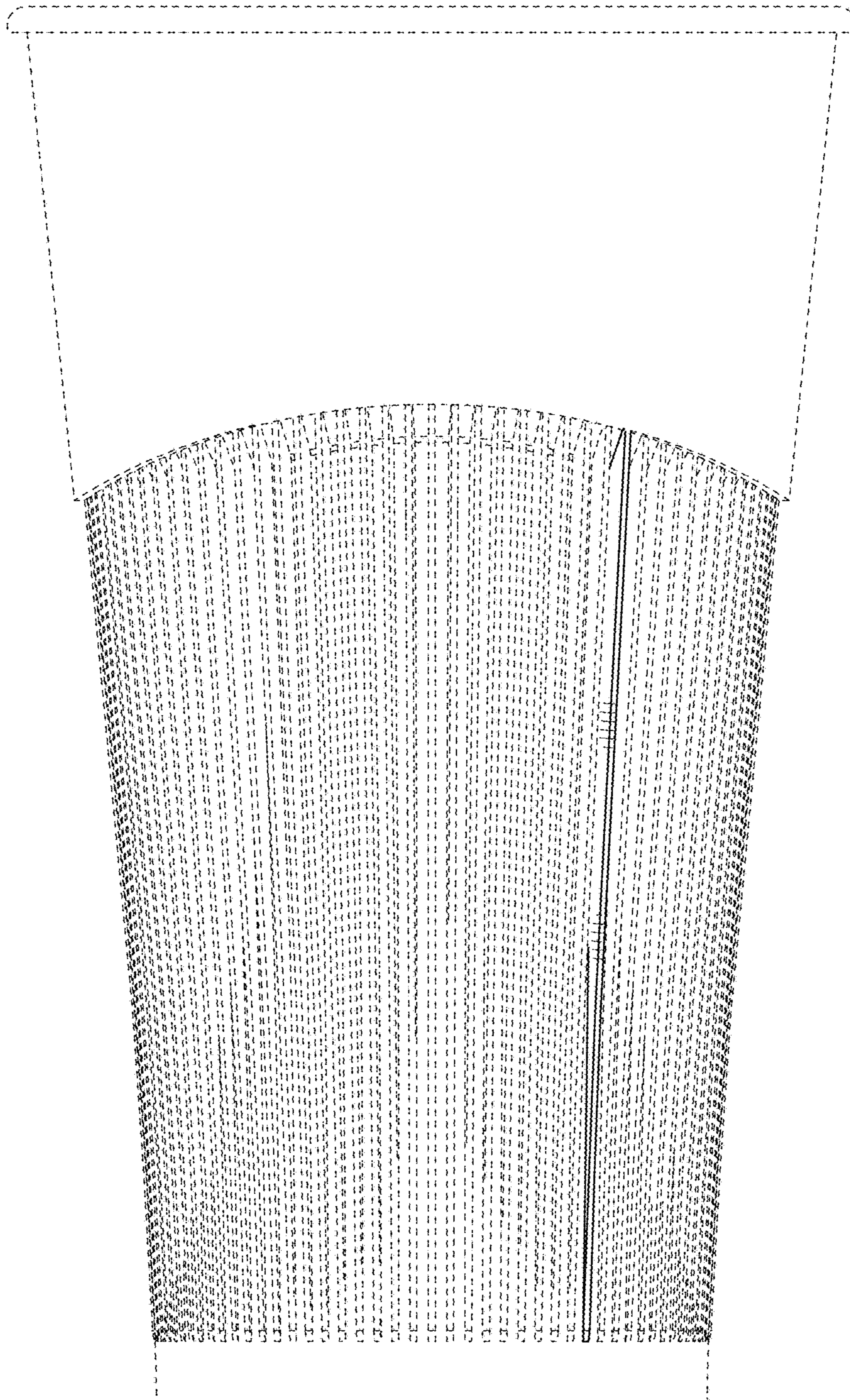

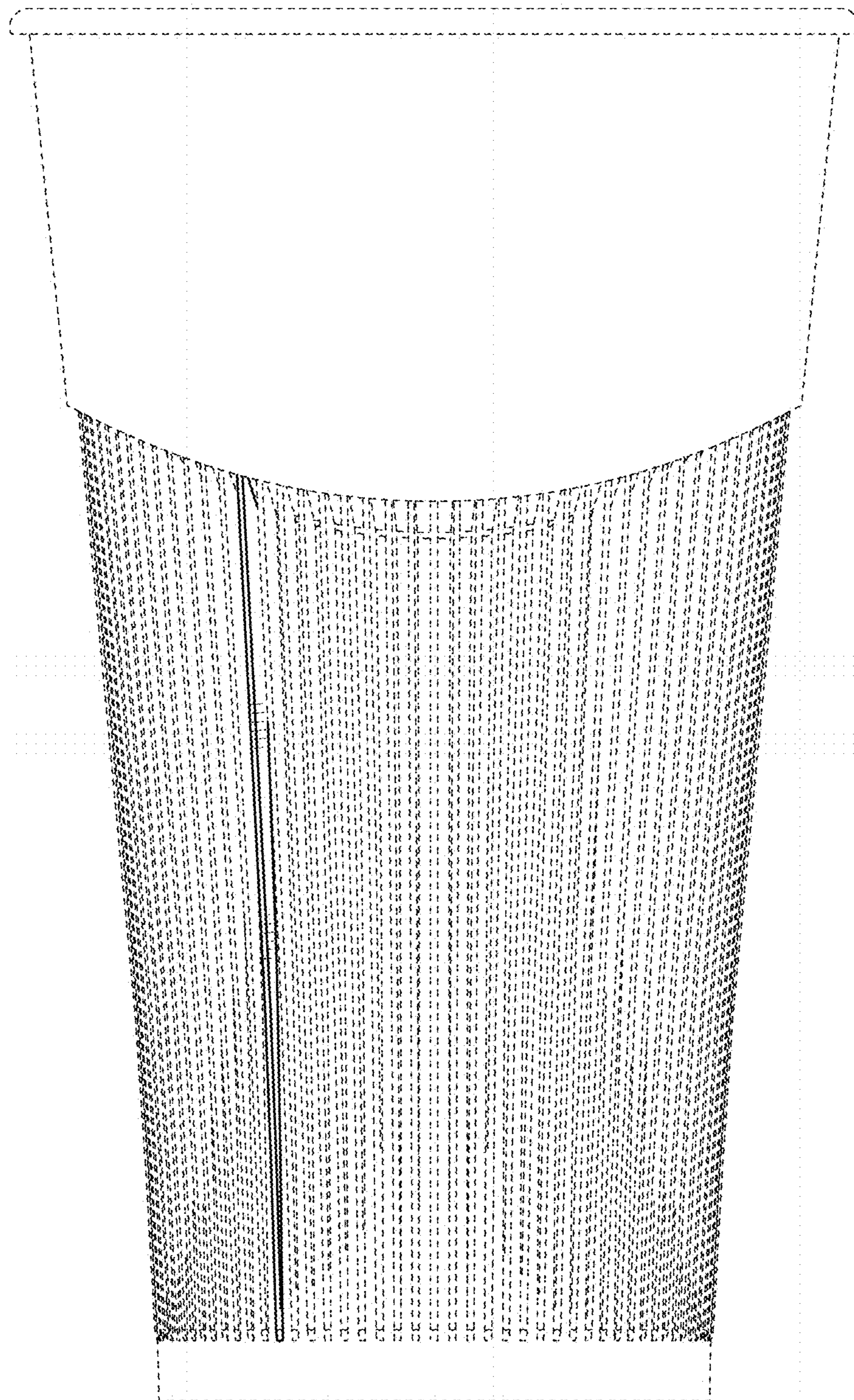

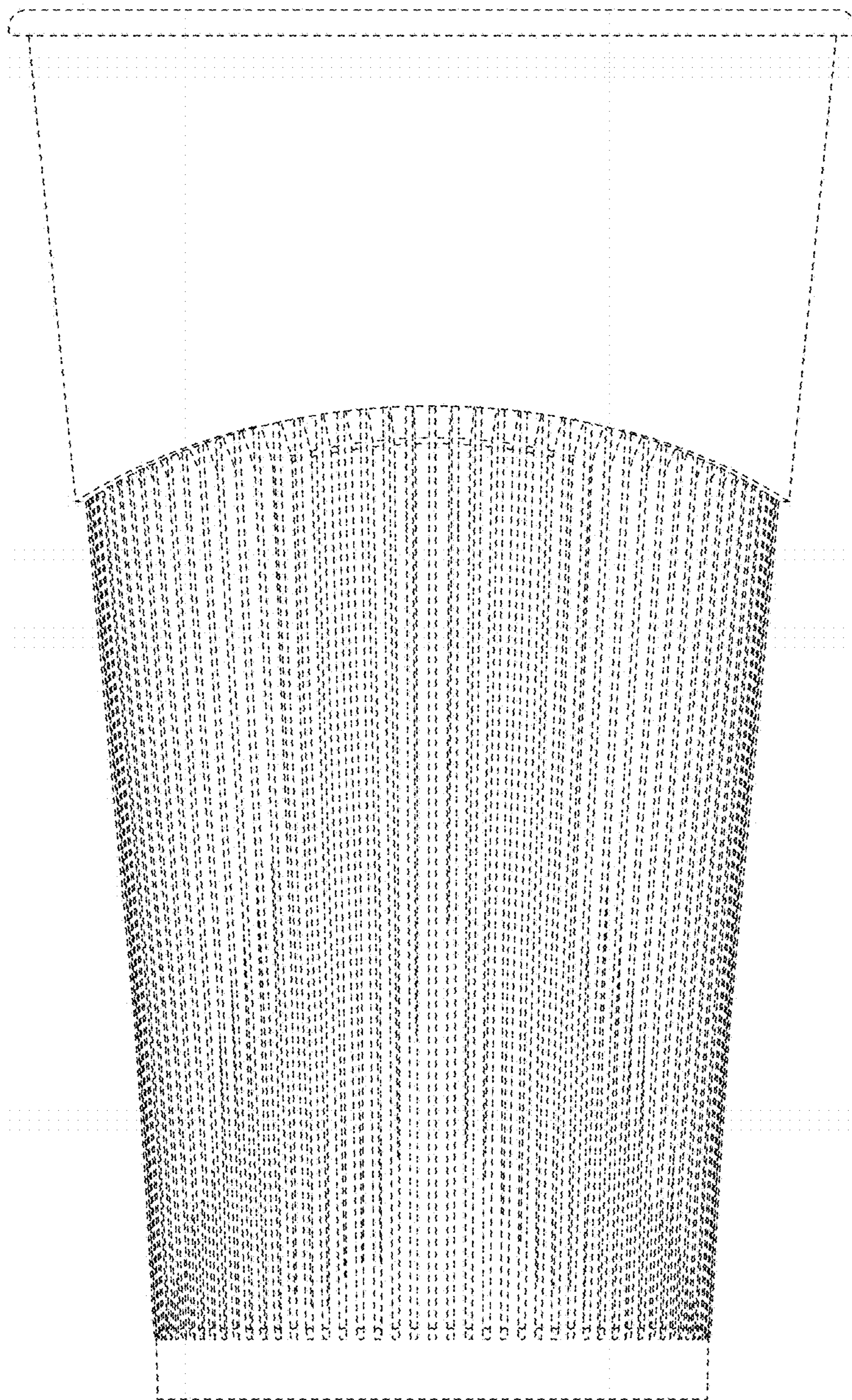

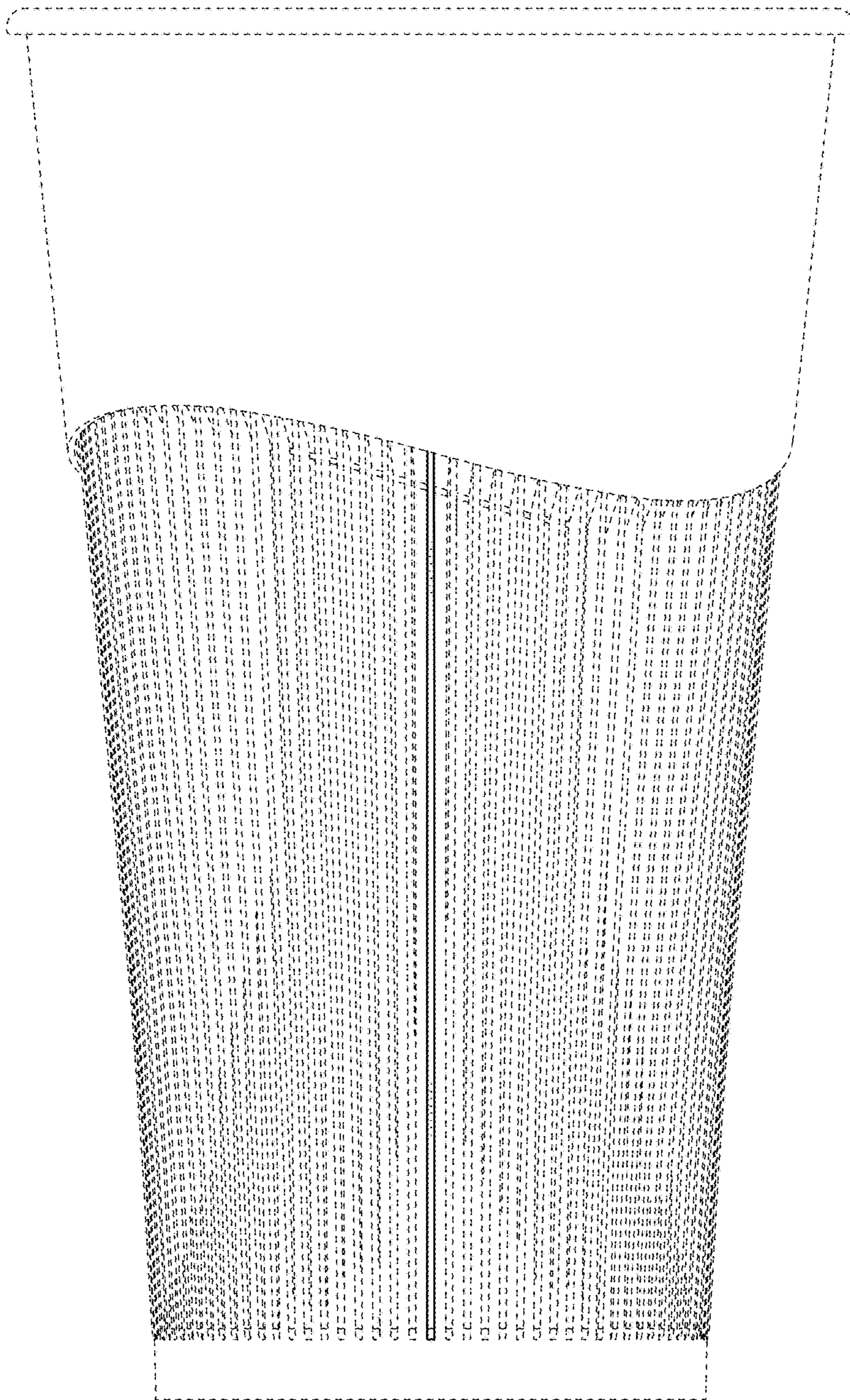
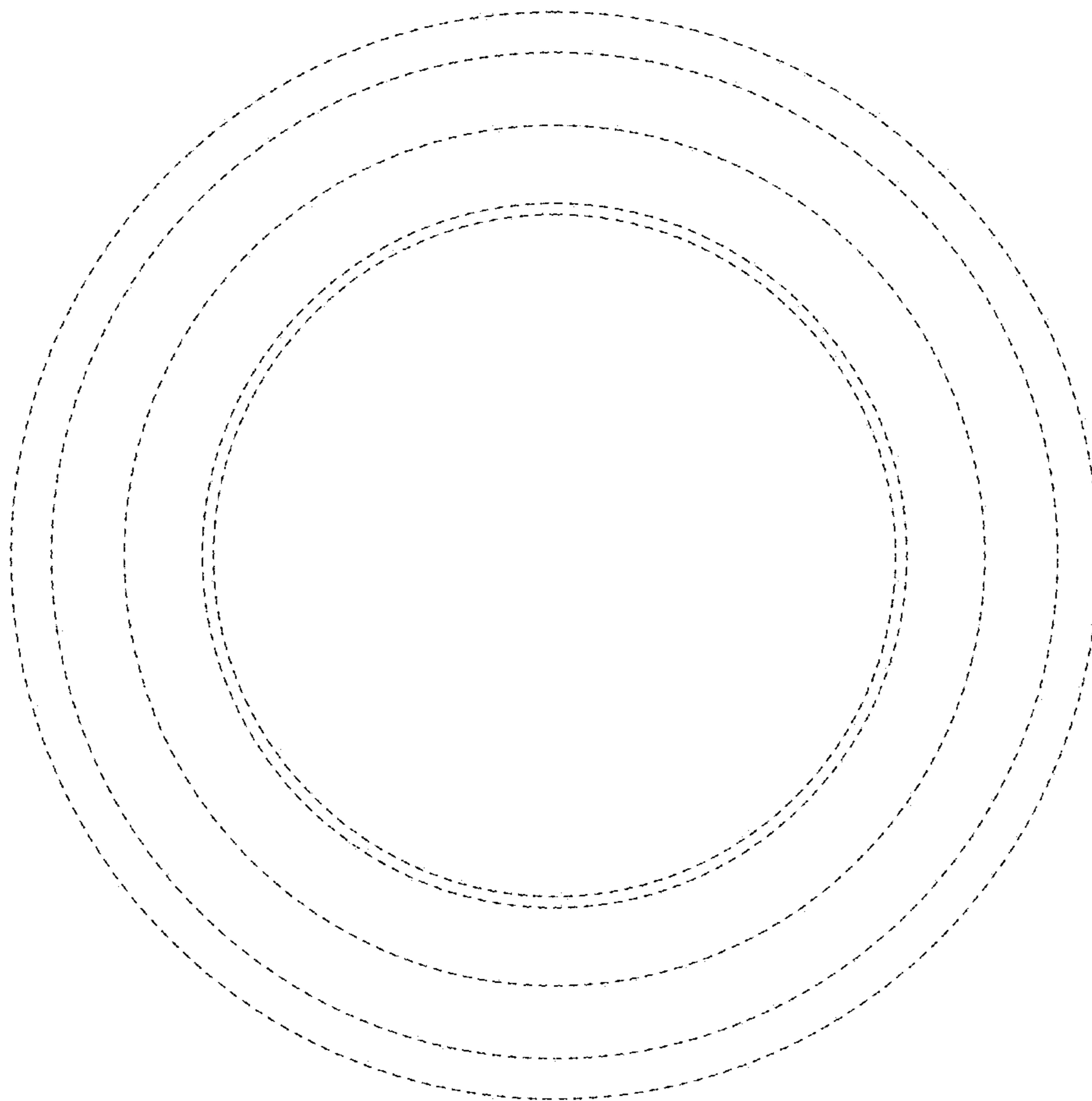
