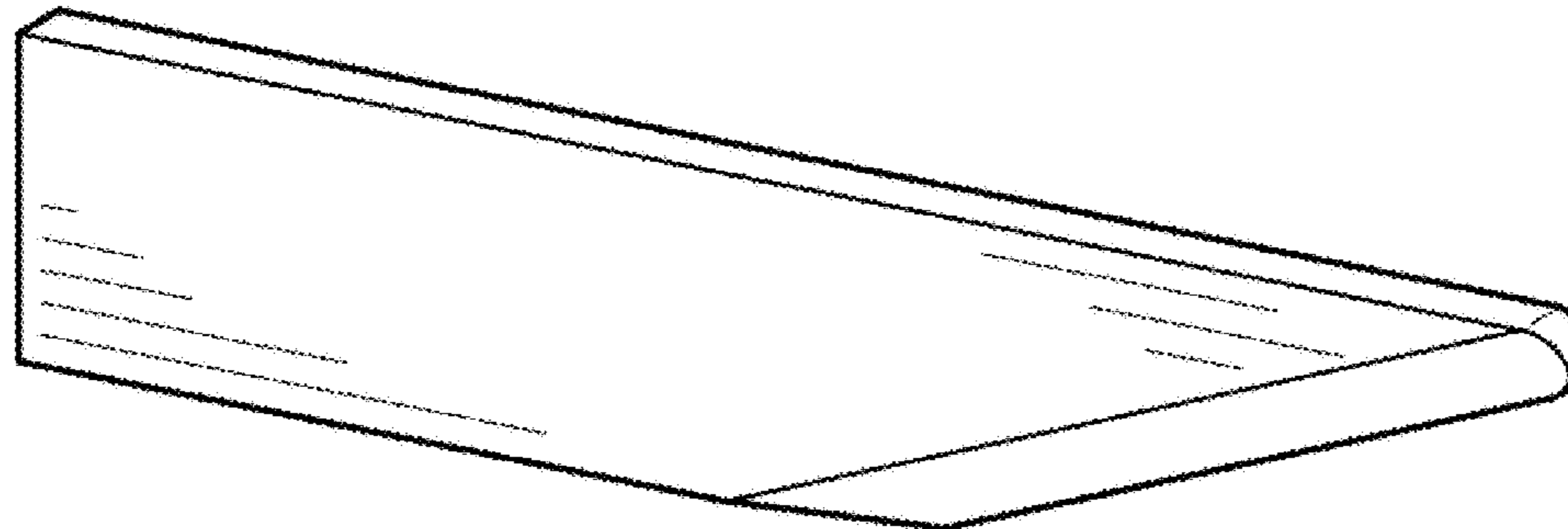

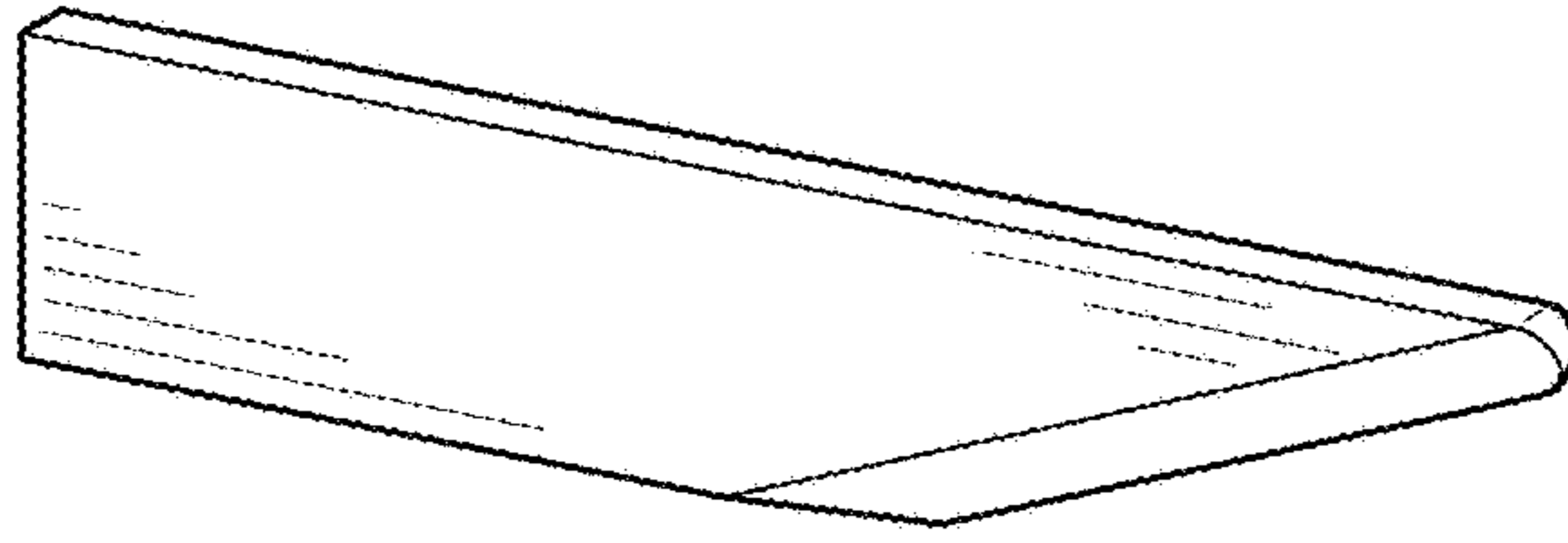

I claim the ornamental design for a blade, as shown and described.

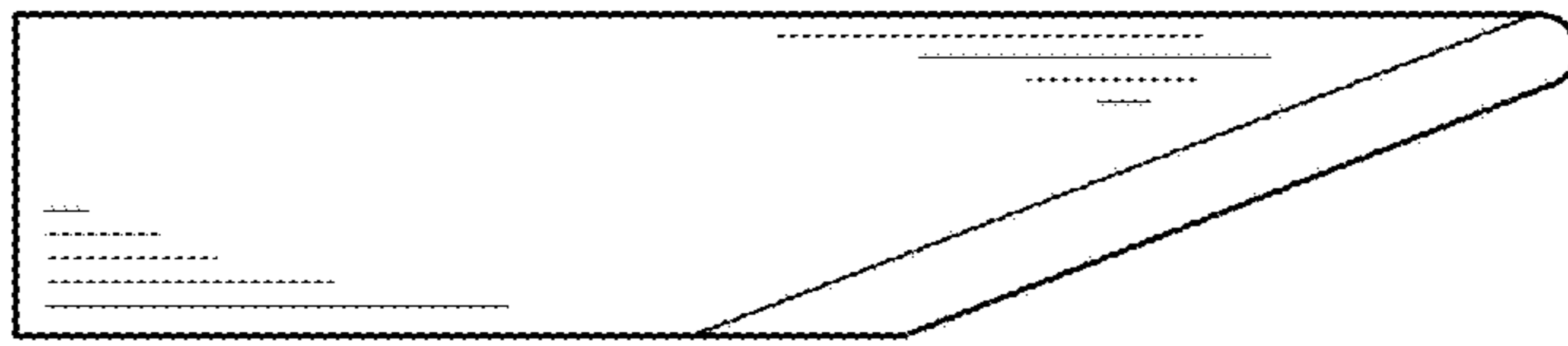
**DESCRIPTION**

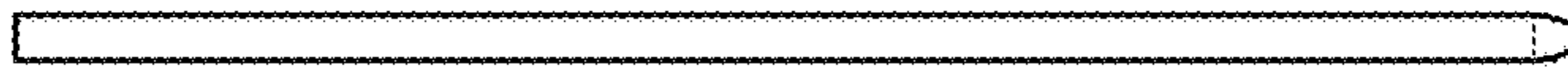




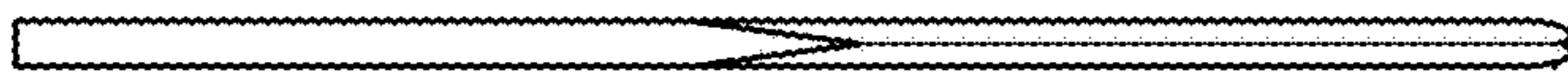
