The ornamental design for a gift bag decoration, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a gift bag decoration, the back being a mirror image;

FIG. 2 is a side elevation view thereof, the opposite side being the mirror image thereof;

FIG. 3 is a top view thereof; and,

FIG. 4 is a bottom view thereof, showing the view opposite that of the gift bag decoration in FIG. 3.

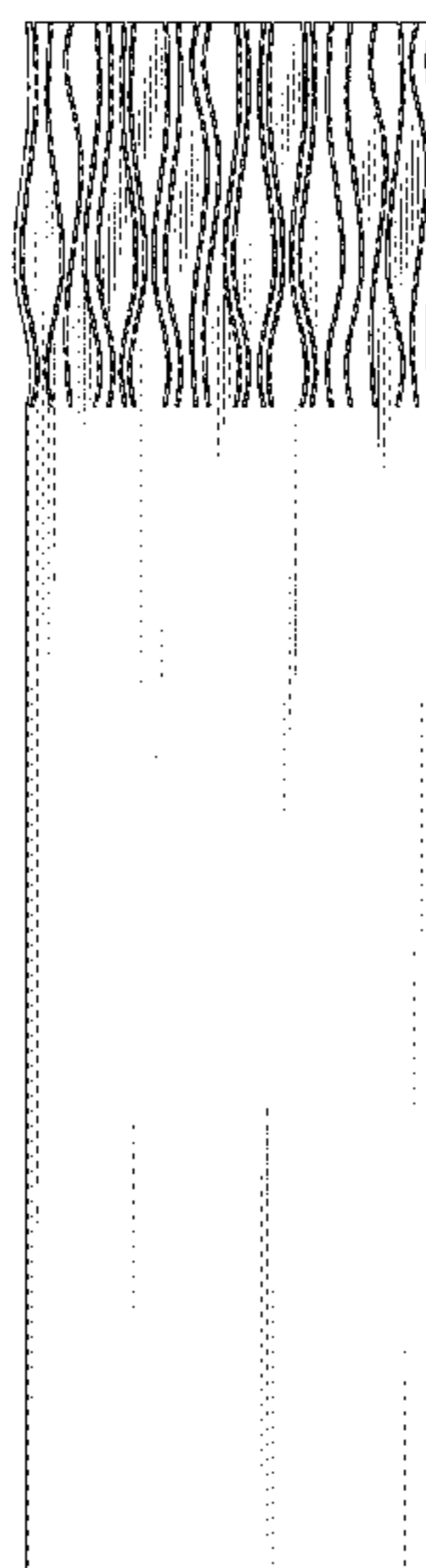

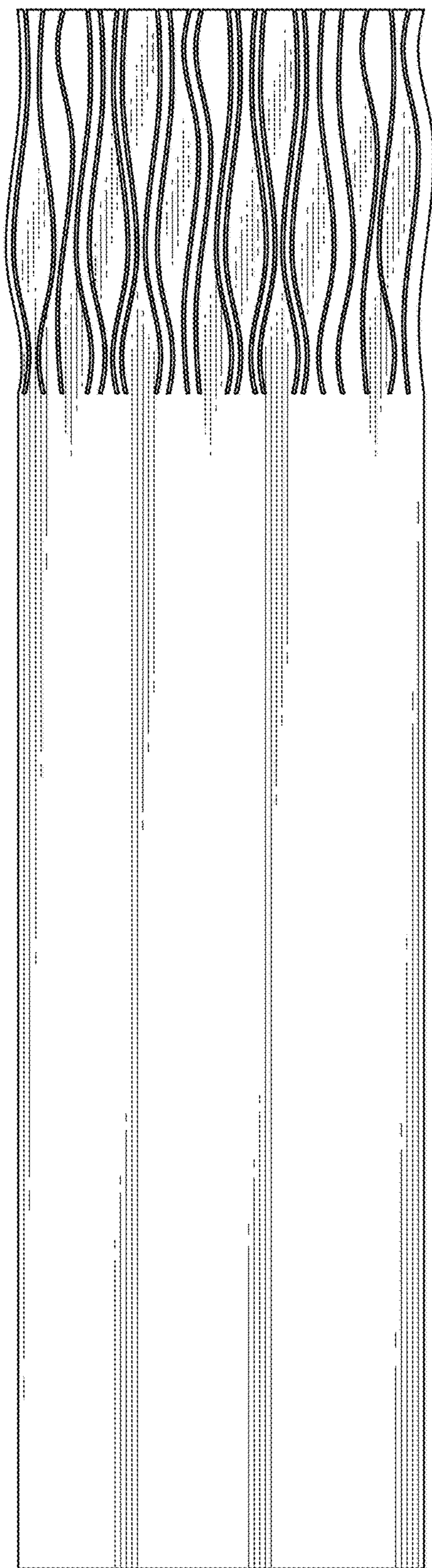

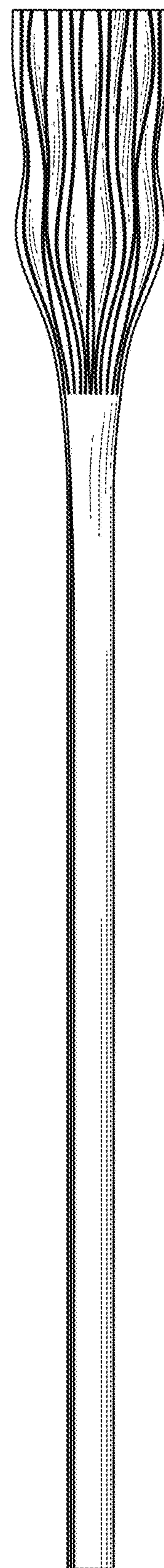

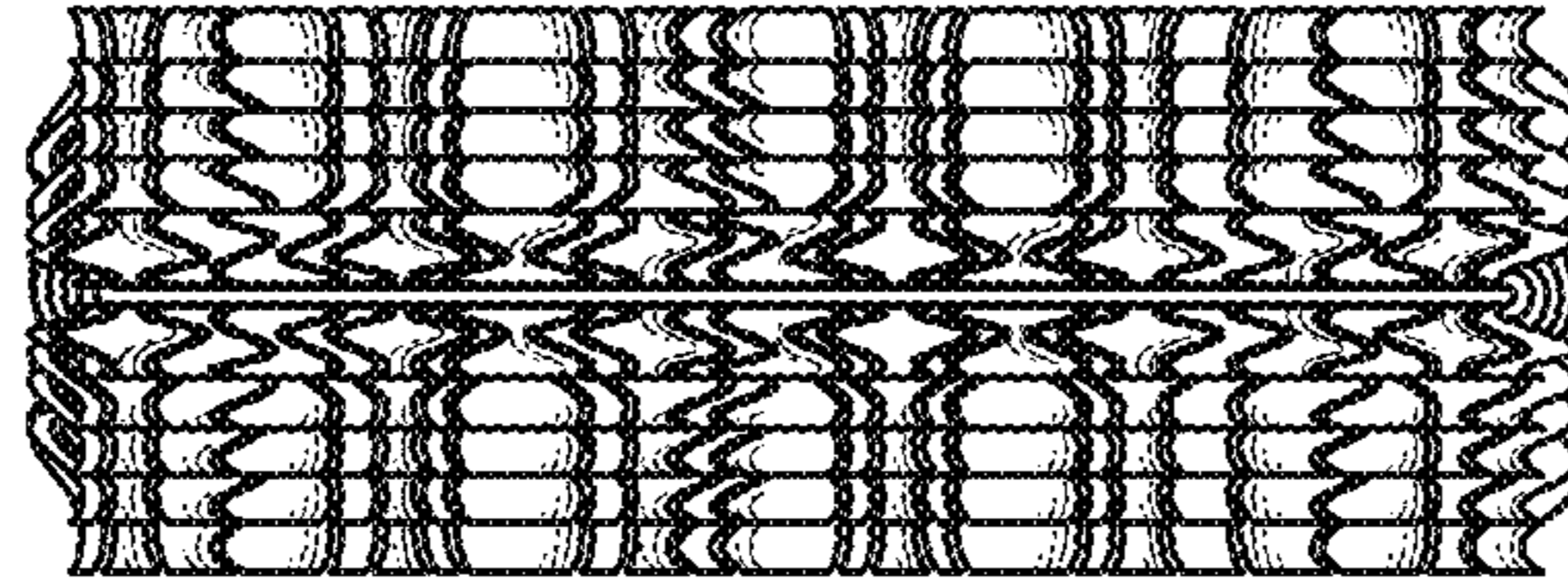

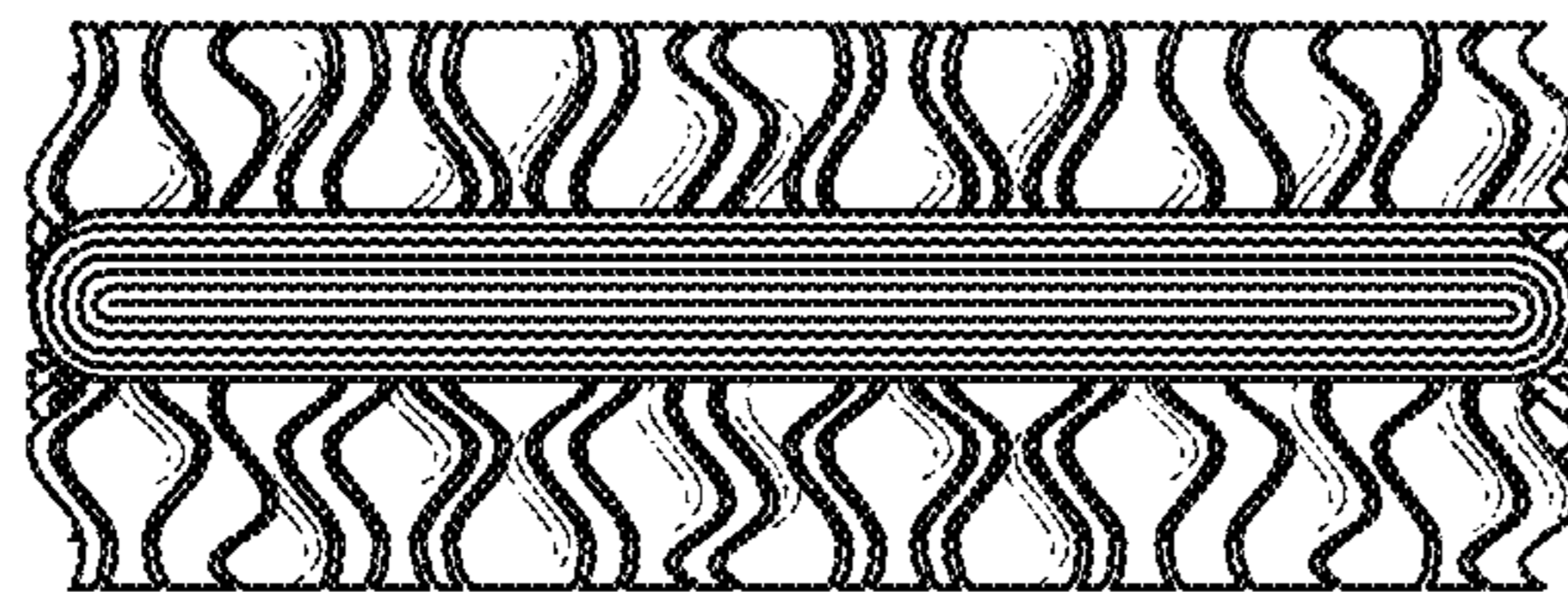
