DESCRIPTION

FIG. 6 is a side elevational view thereof.

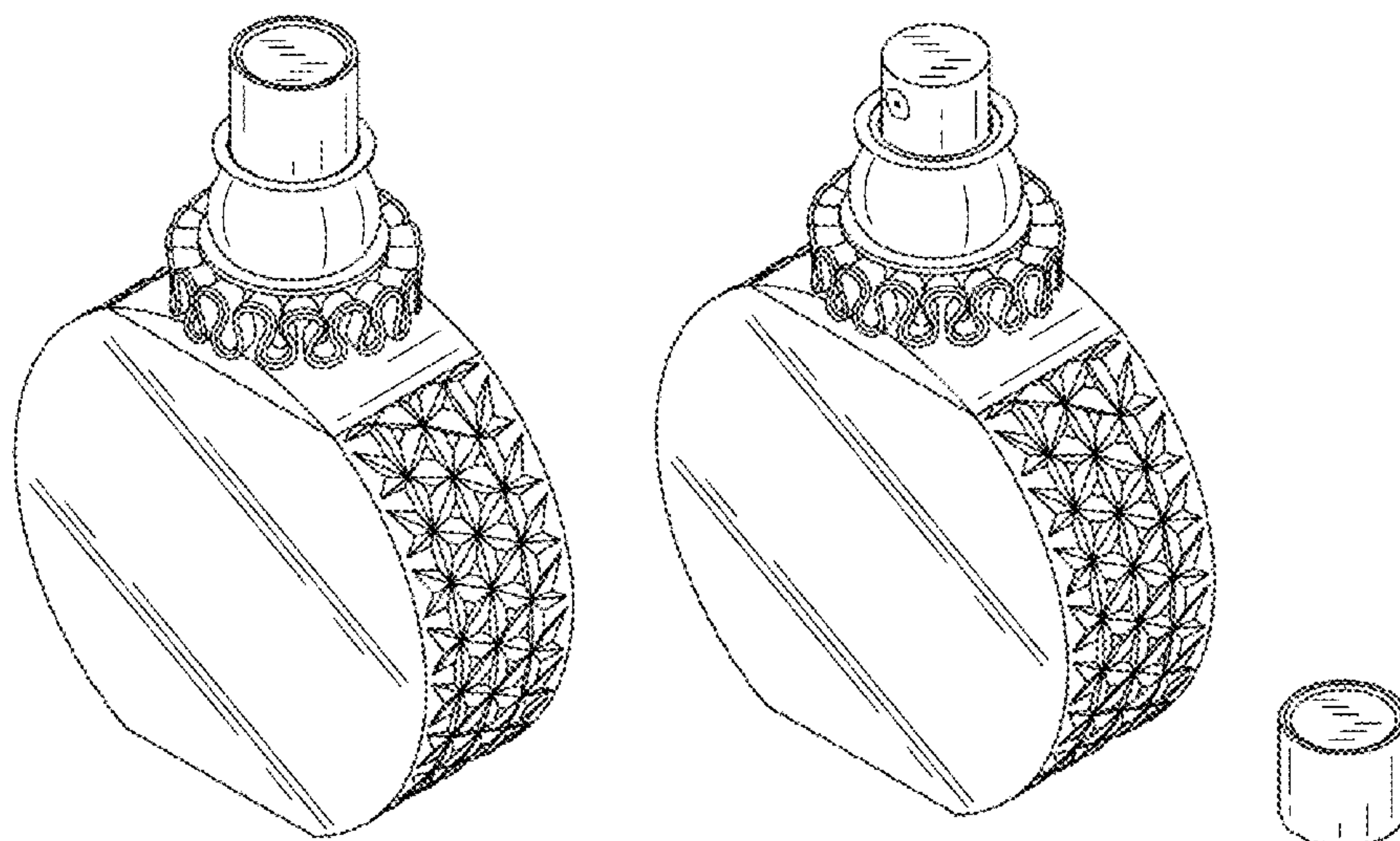
FIG. 7 is a cross sectional view taken along line 7-7 of FIG. 2.

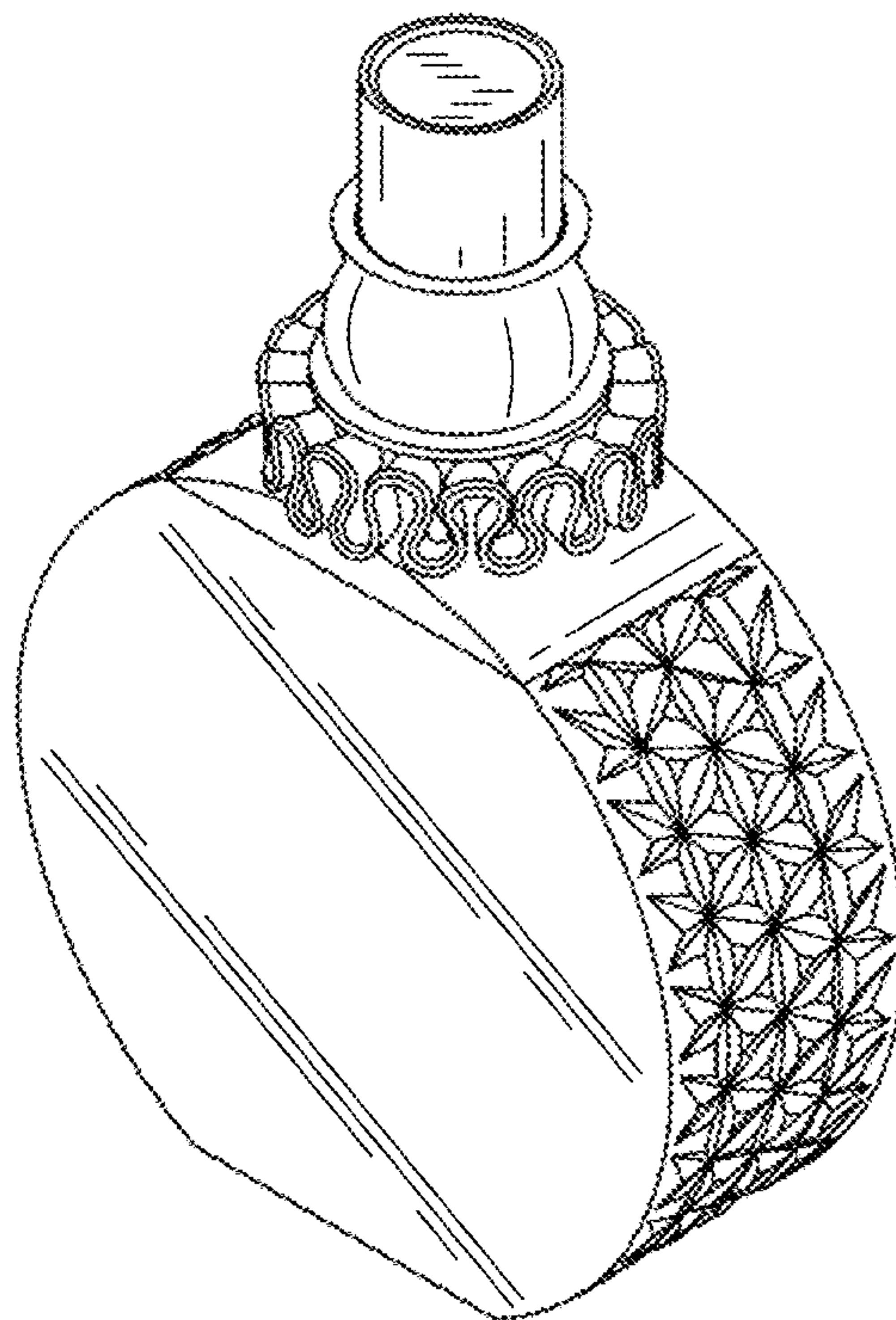

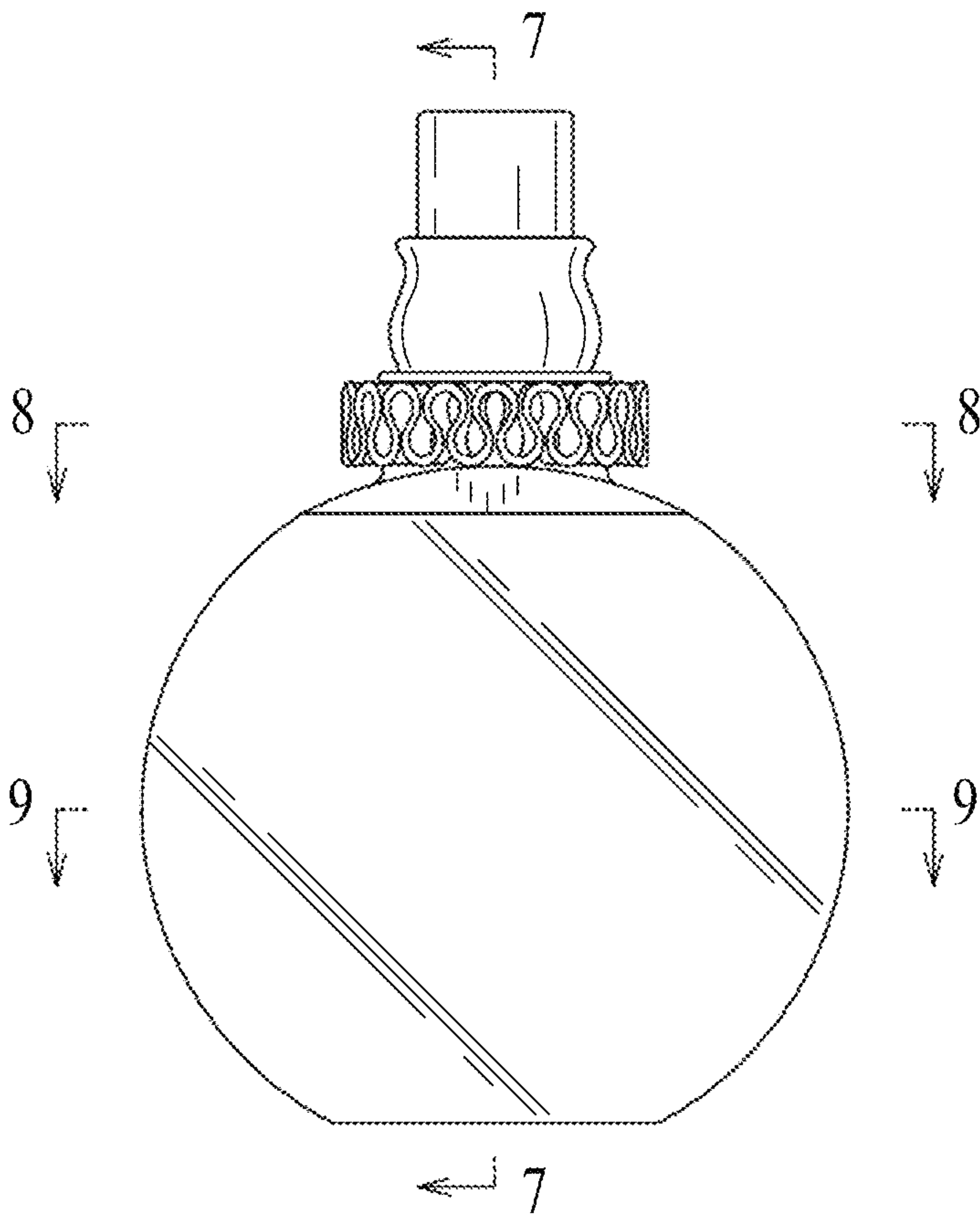

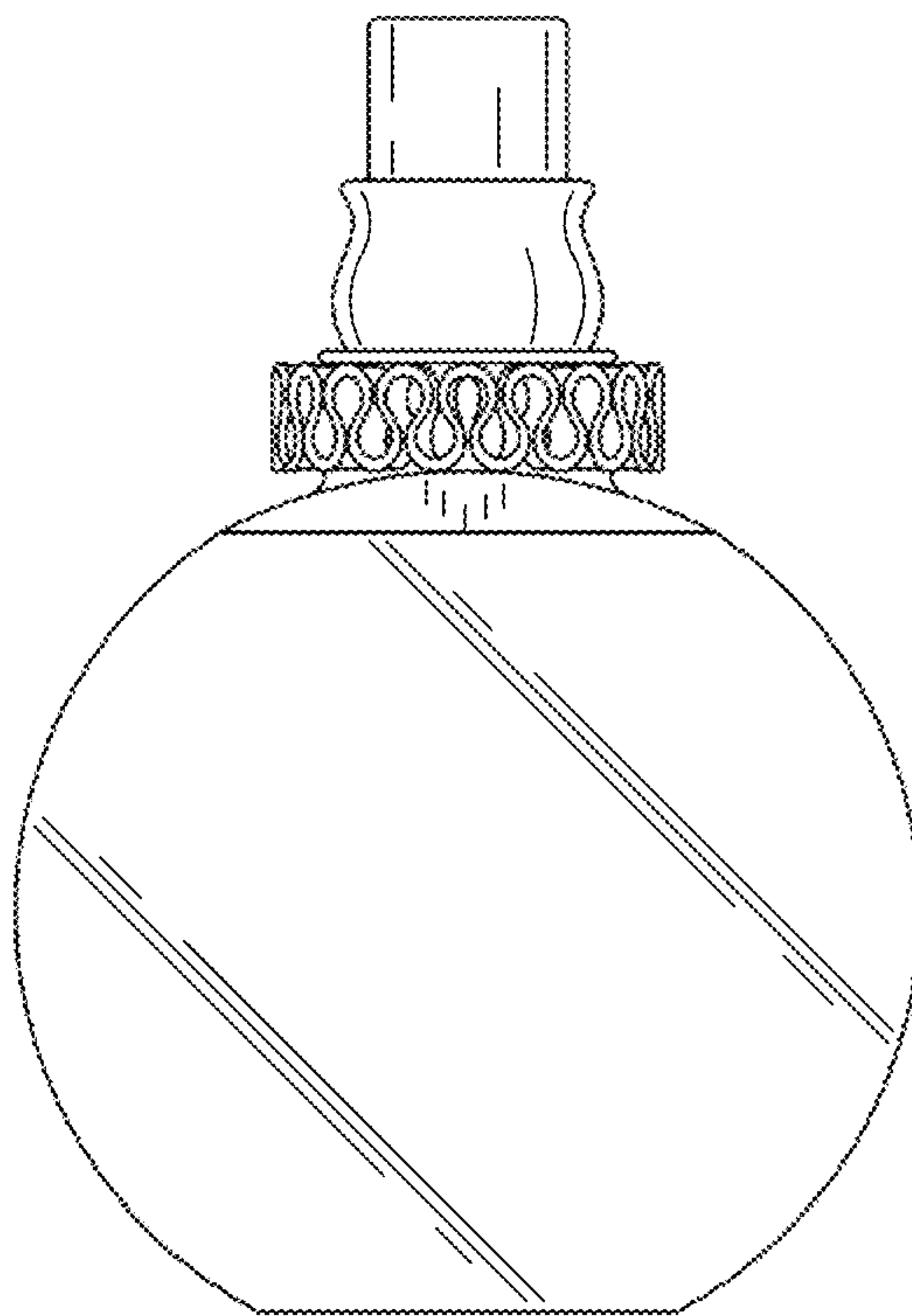

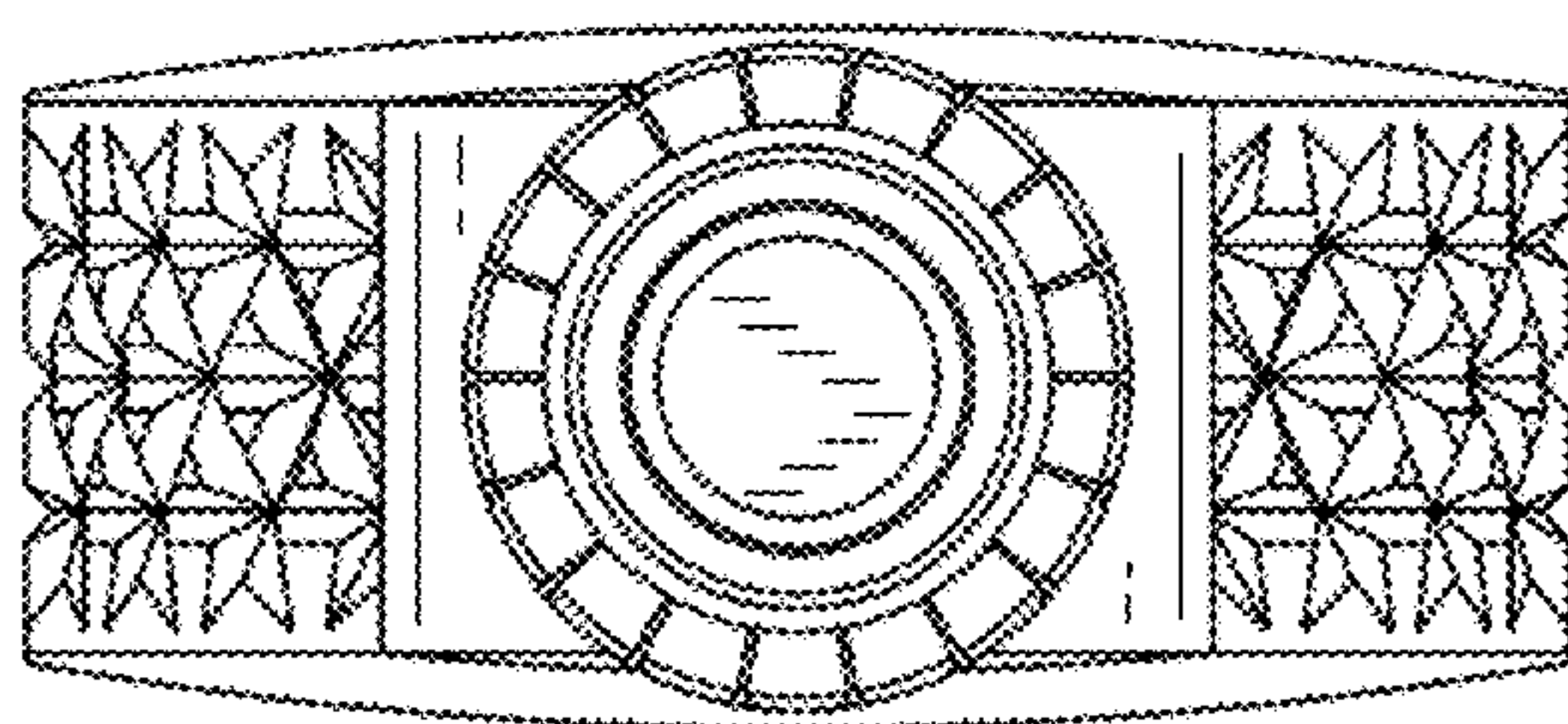

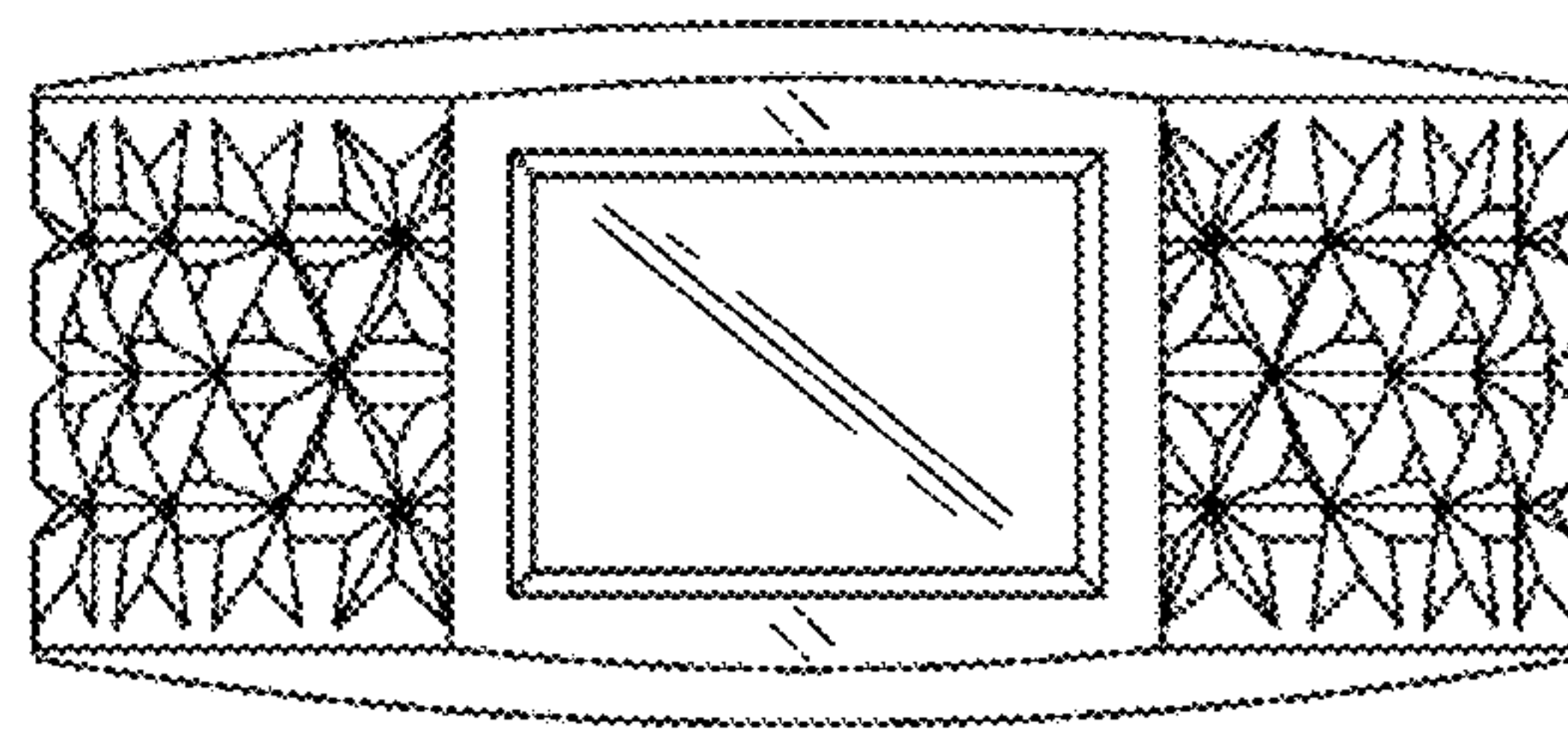

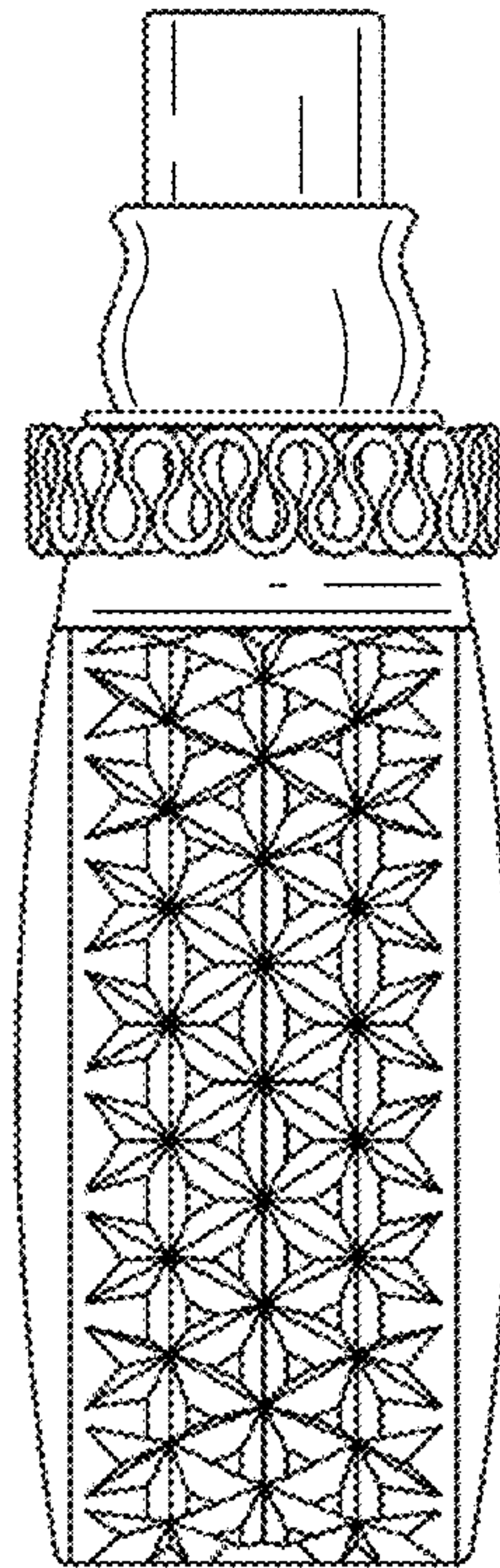

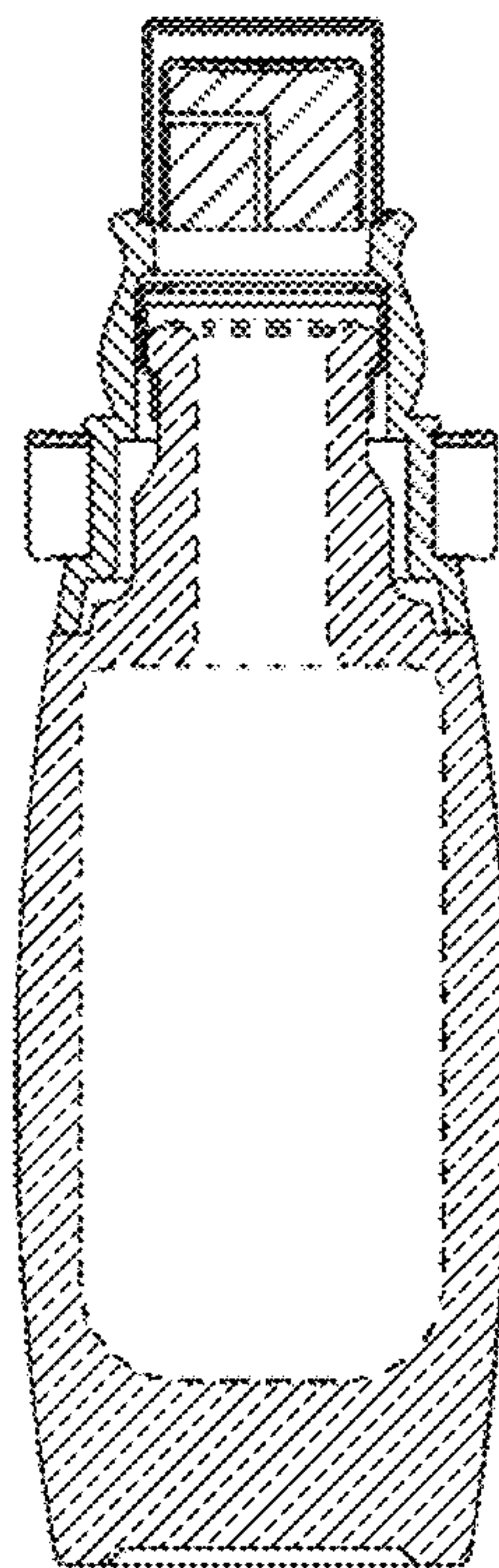

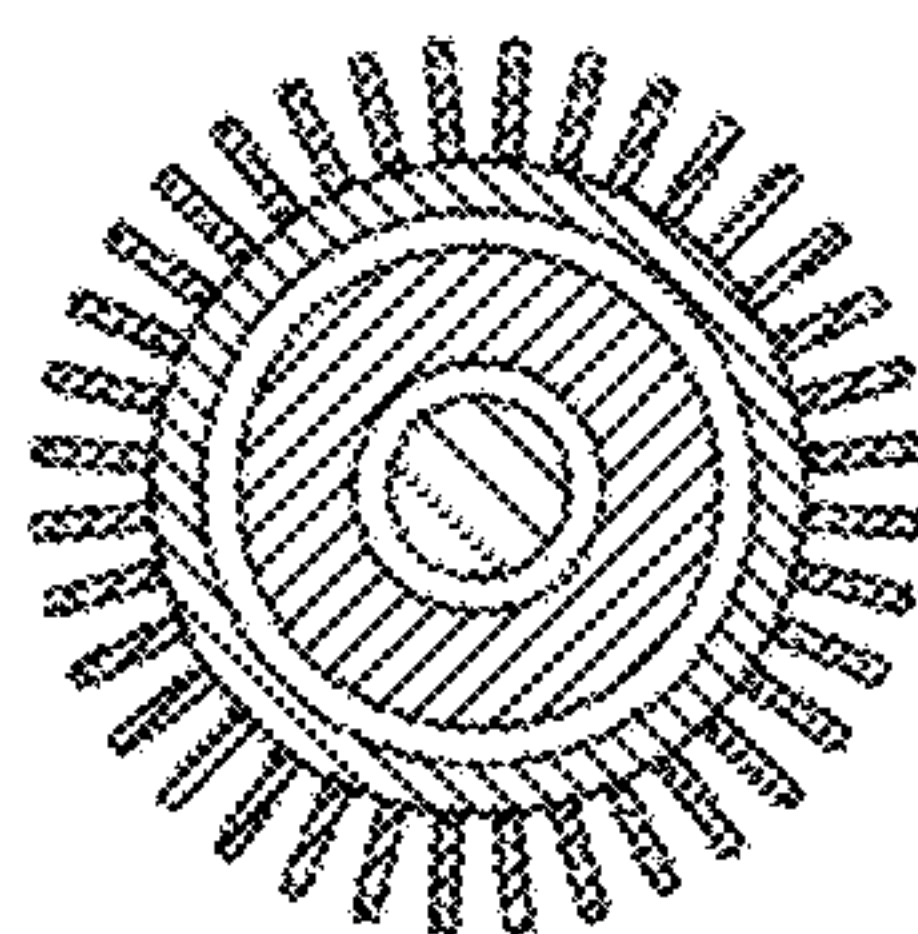

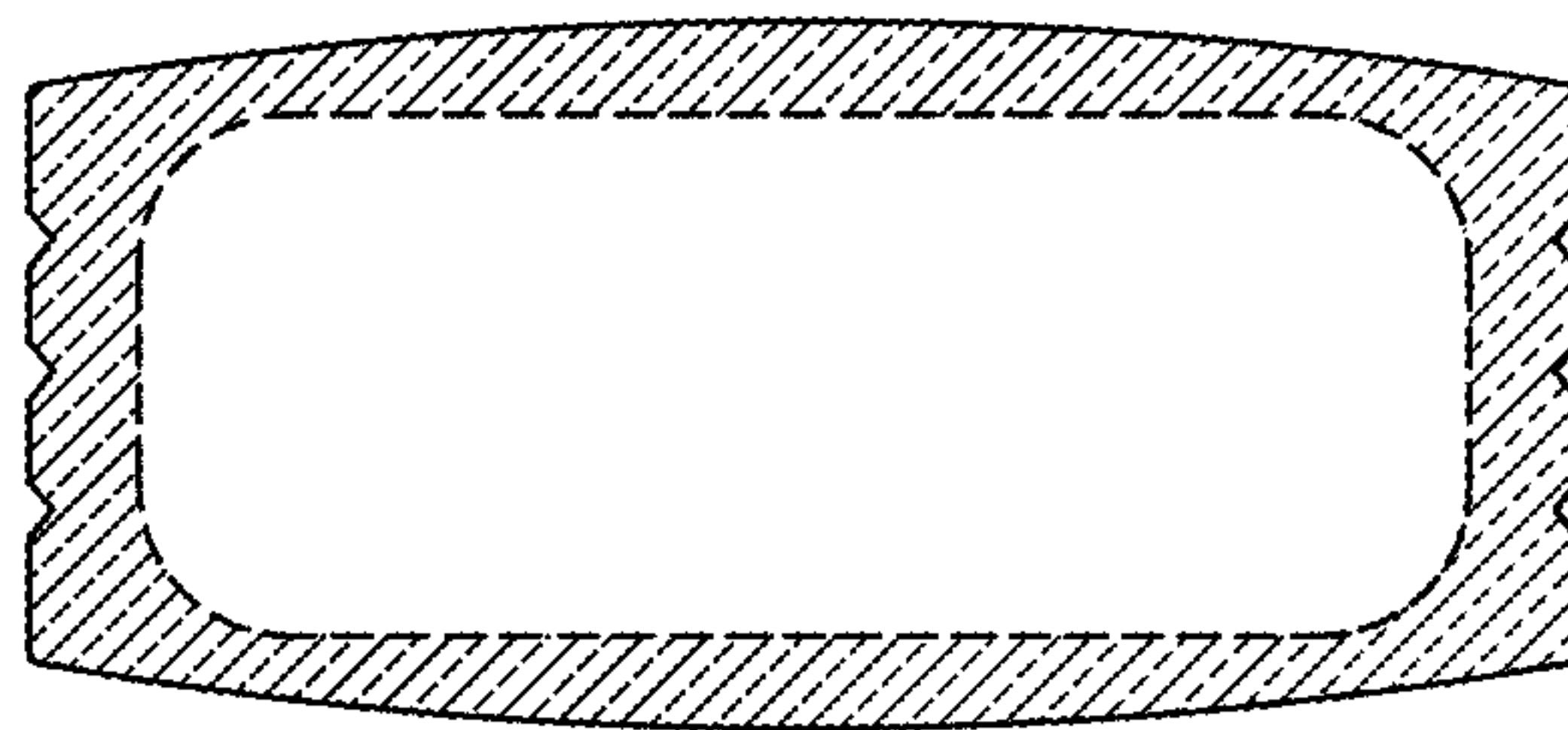

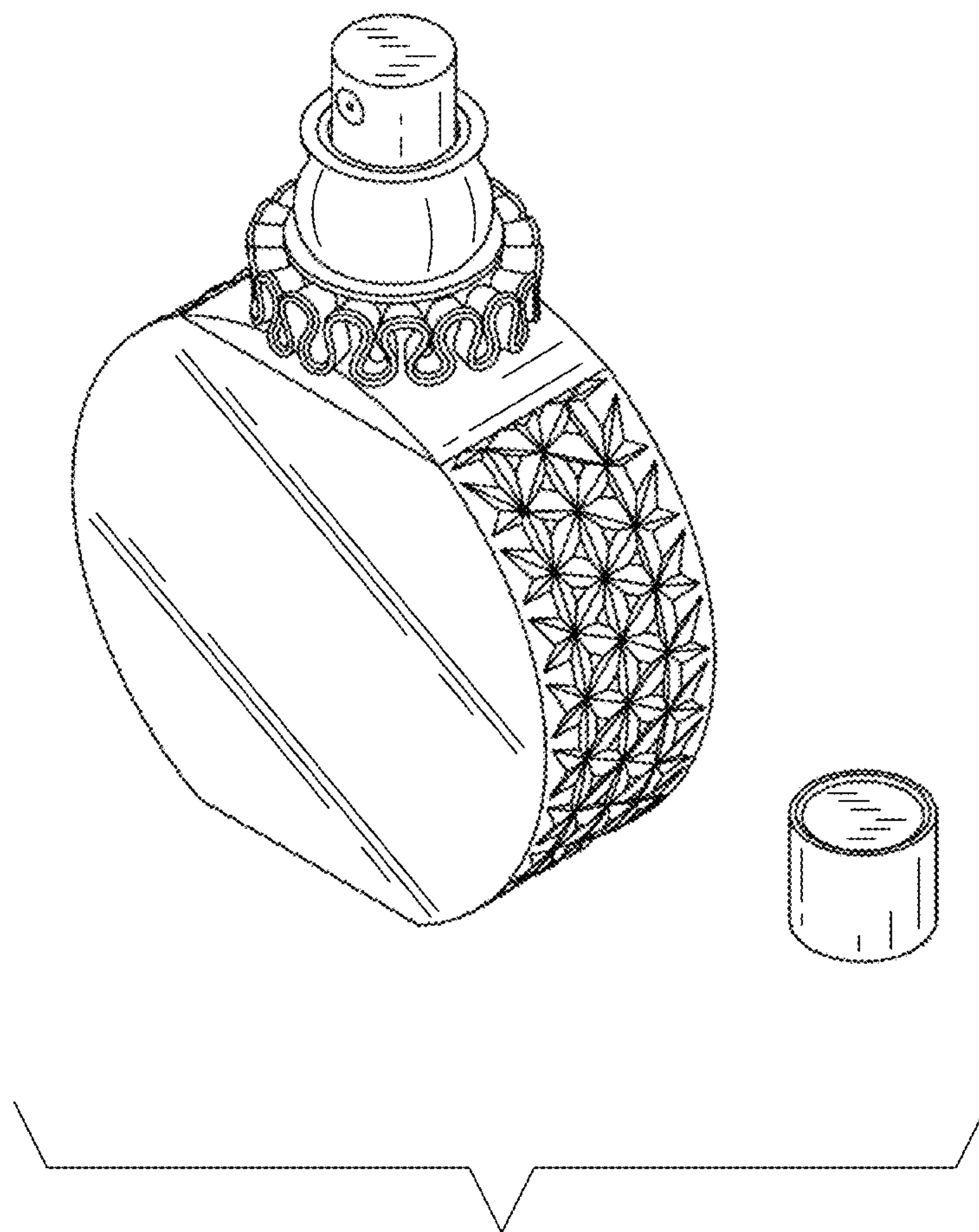
