The ornamental design for a rope formed by interlocking stitches for use in jewelry, clothing, accessories, or applied to the surface of articles of manufacture, as shown.

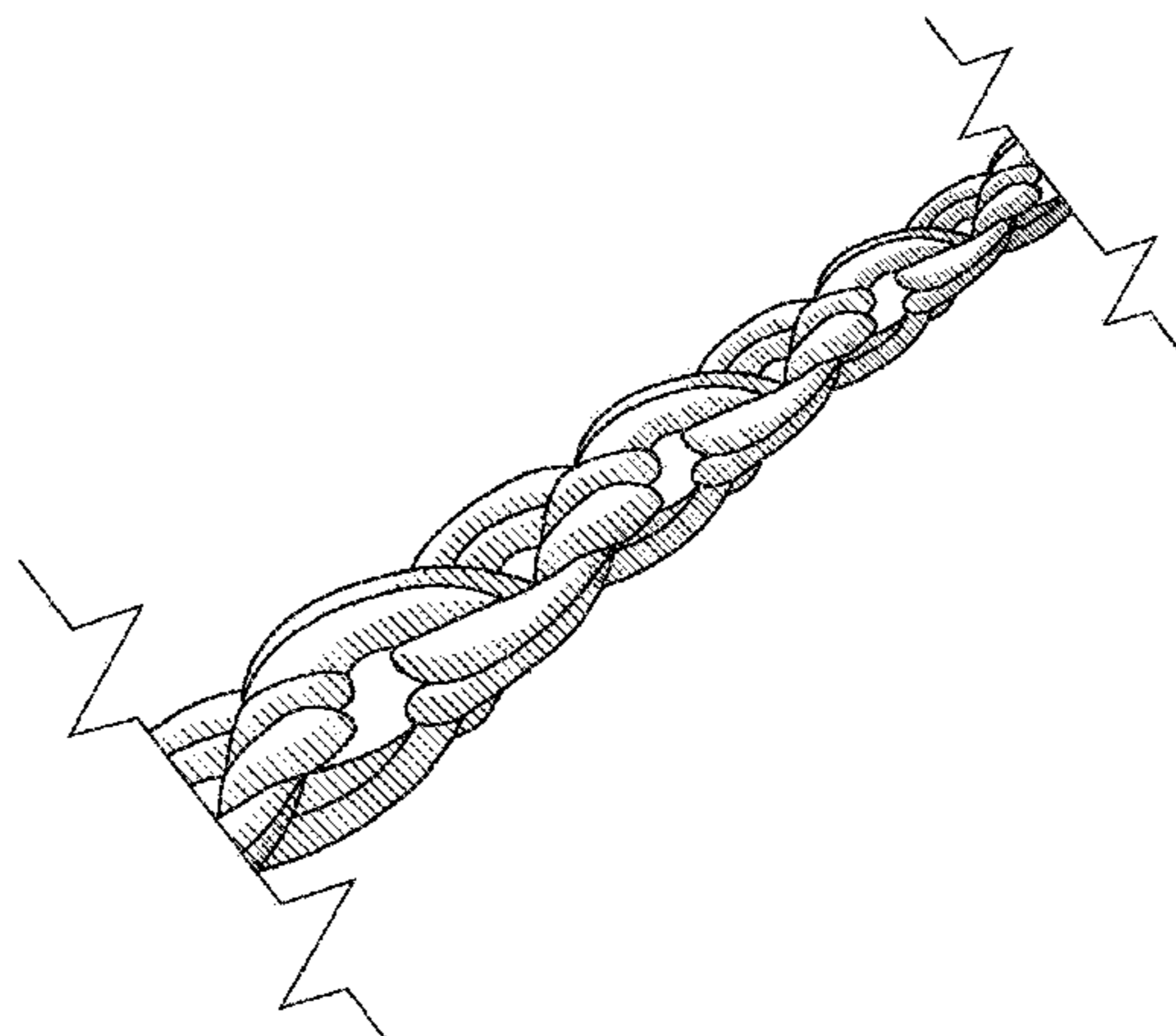
DESCRIPTION

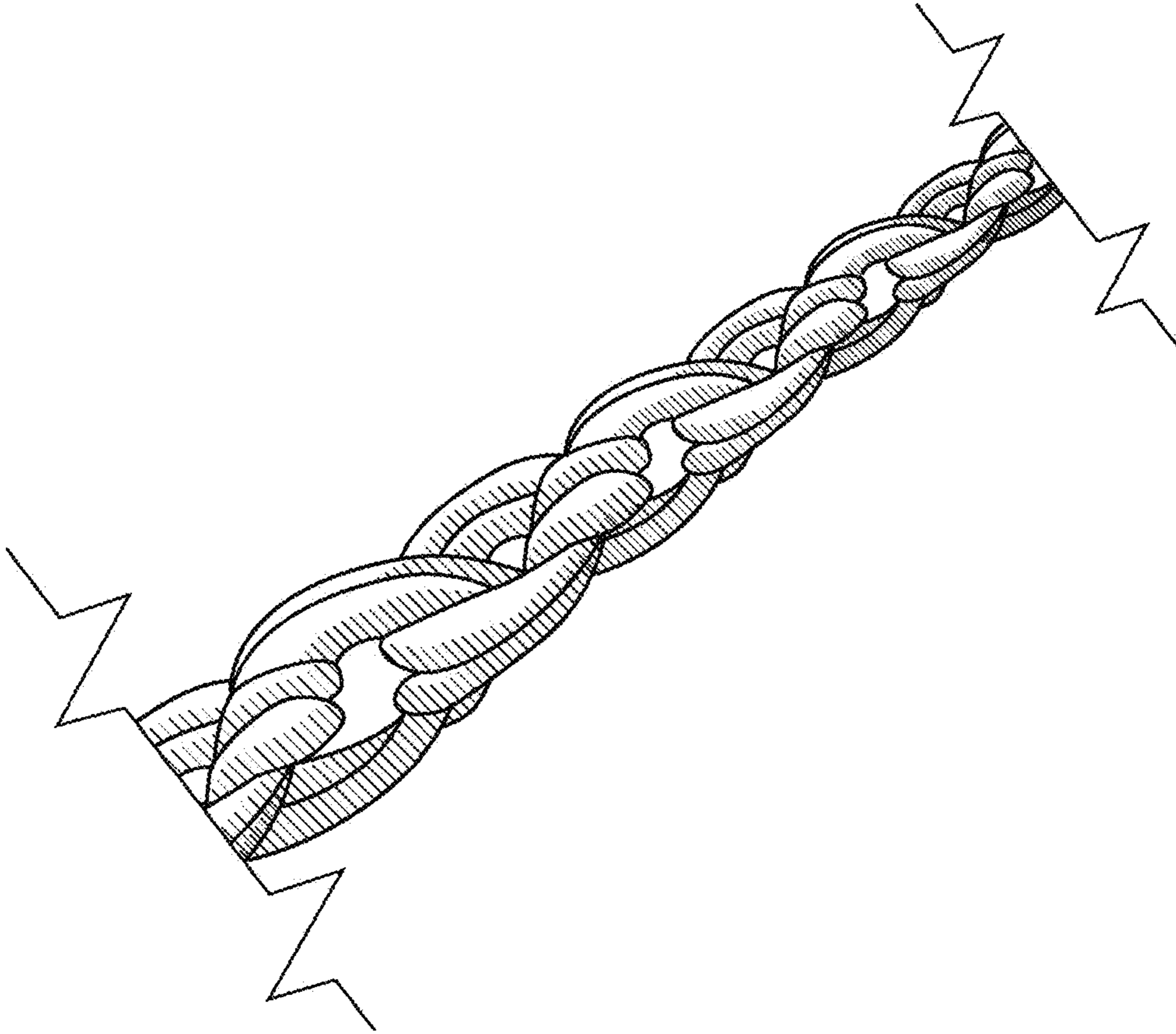

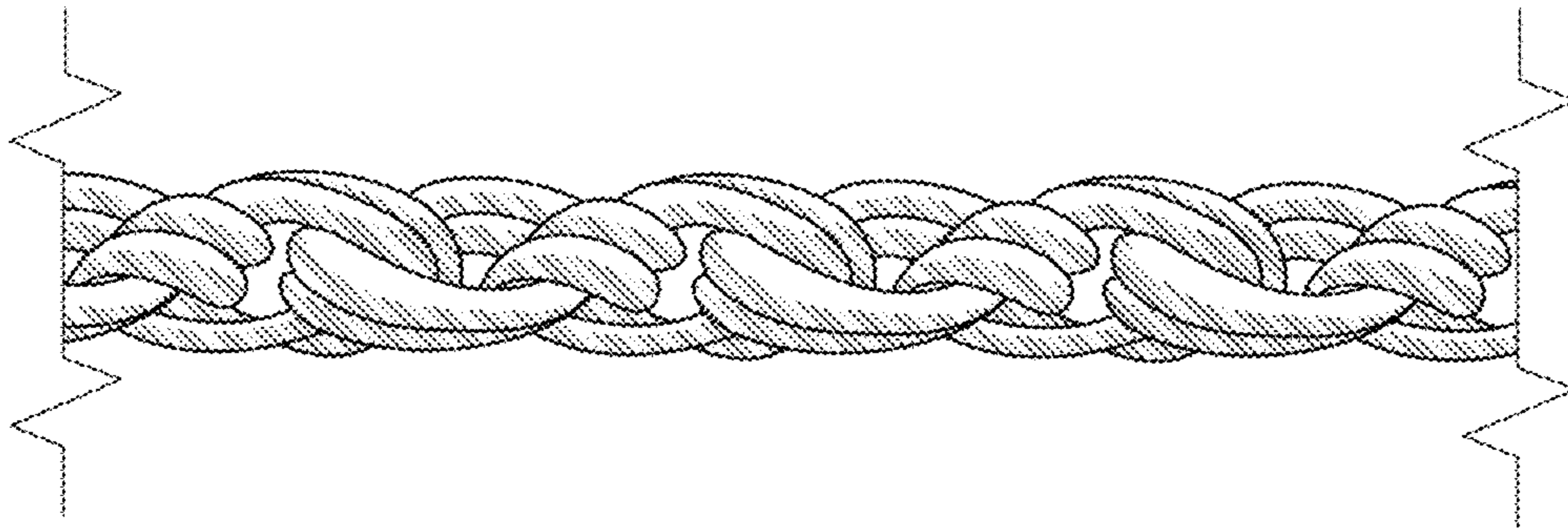

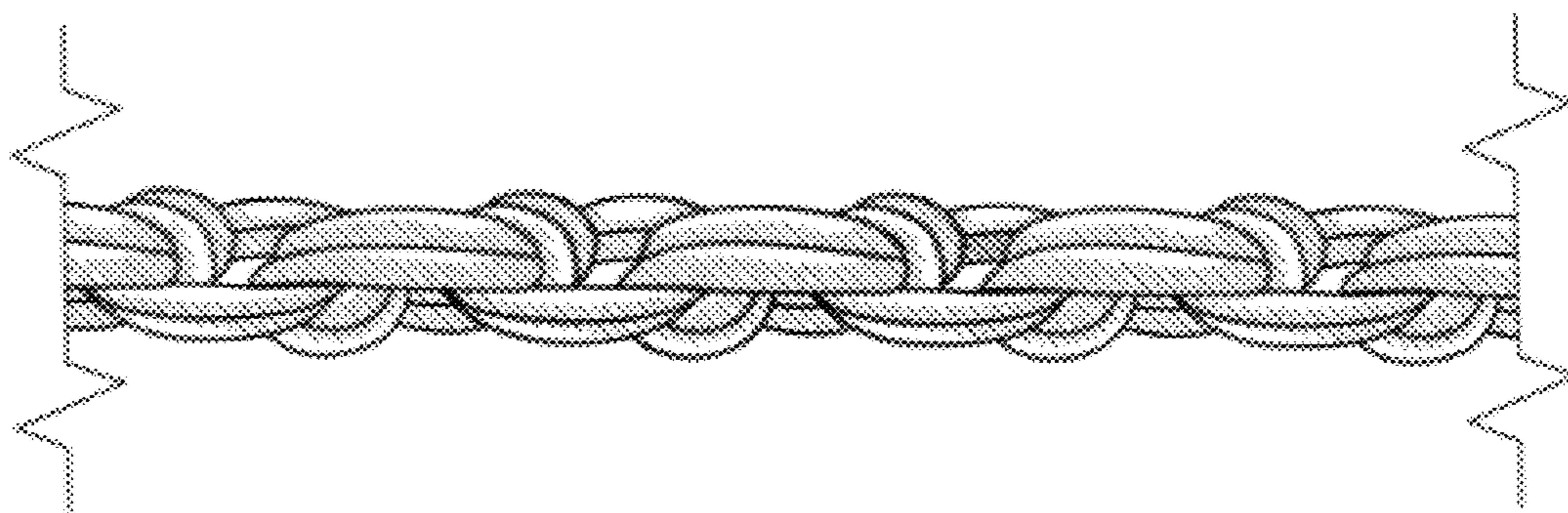
