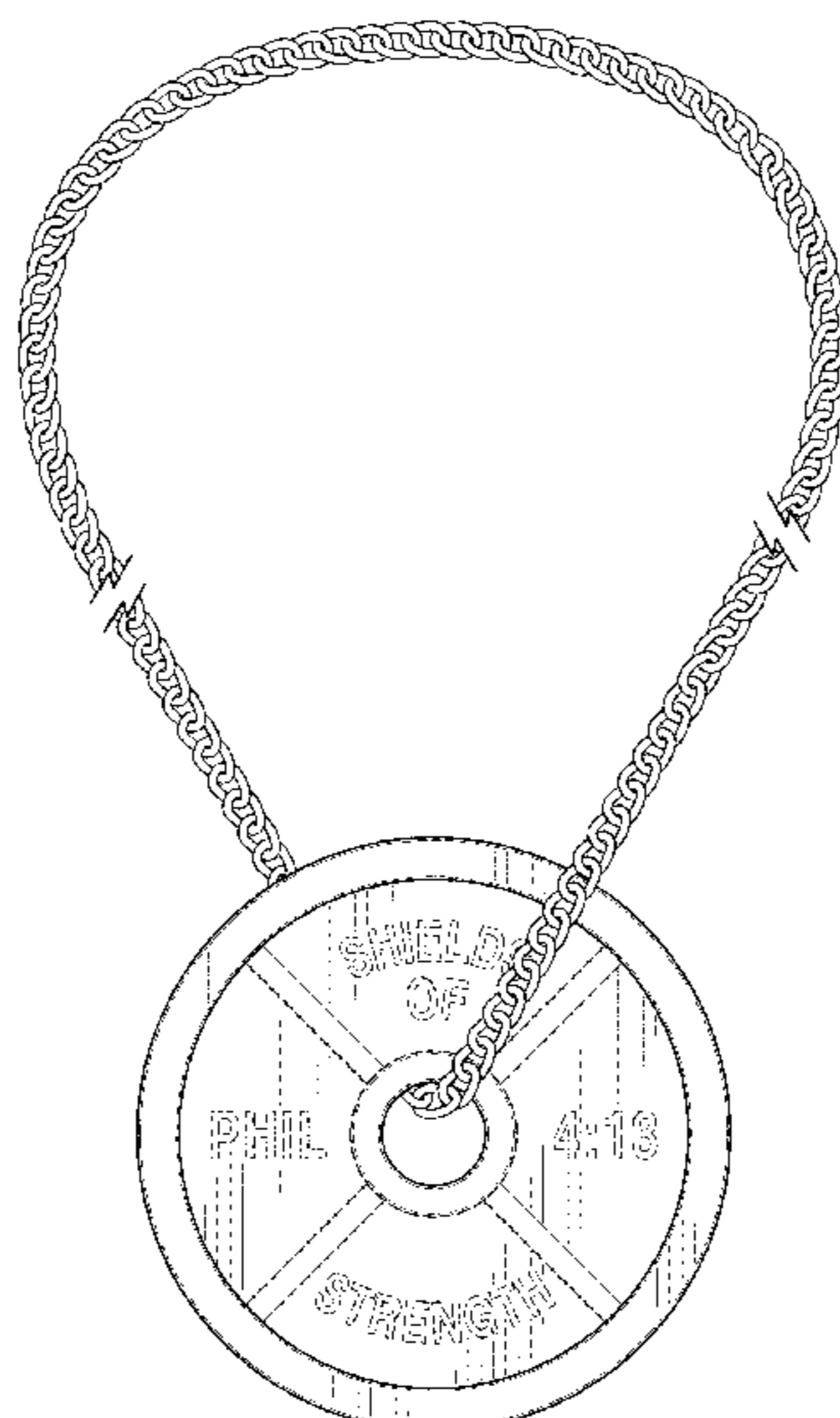
(57) **CLAIM**

The ornamental design for a pendant with chain, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a pendant with chain showing our new design.  
FIG. 2 is a top view thereof;  
FIG. 3 is a bottom view thereof;  
FIG. 4 is a side view thereof;  
FIG. 5 is an opposite view thereof;  
FIG. 6 is a front thereof; and,  
FIG. 7 is a rear view thereof.  
The chain is shown with a symbolic break in its length in FIG. 2, and the appearance of any portion of the chain between the break lines forms no part of the claimed design. The claimed design is shown in full in FIG. 2 and the remaining figures show portions of the chain omitted for ease of illustration. The broken lines in the drawings represent portions of the pendant with chain which form no part of the claimed design.

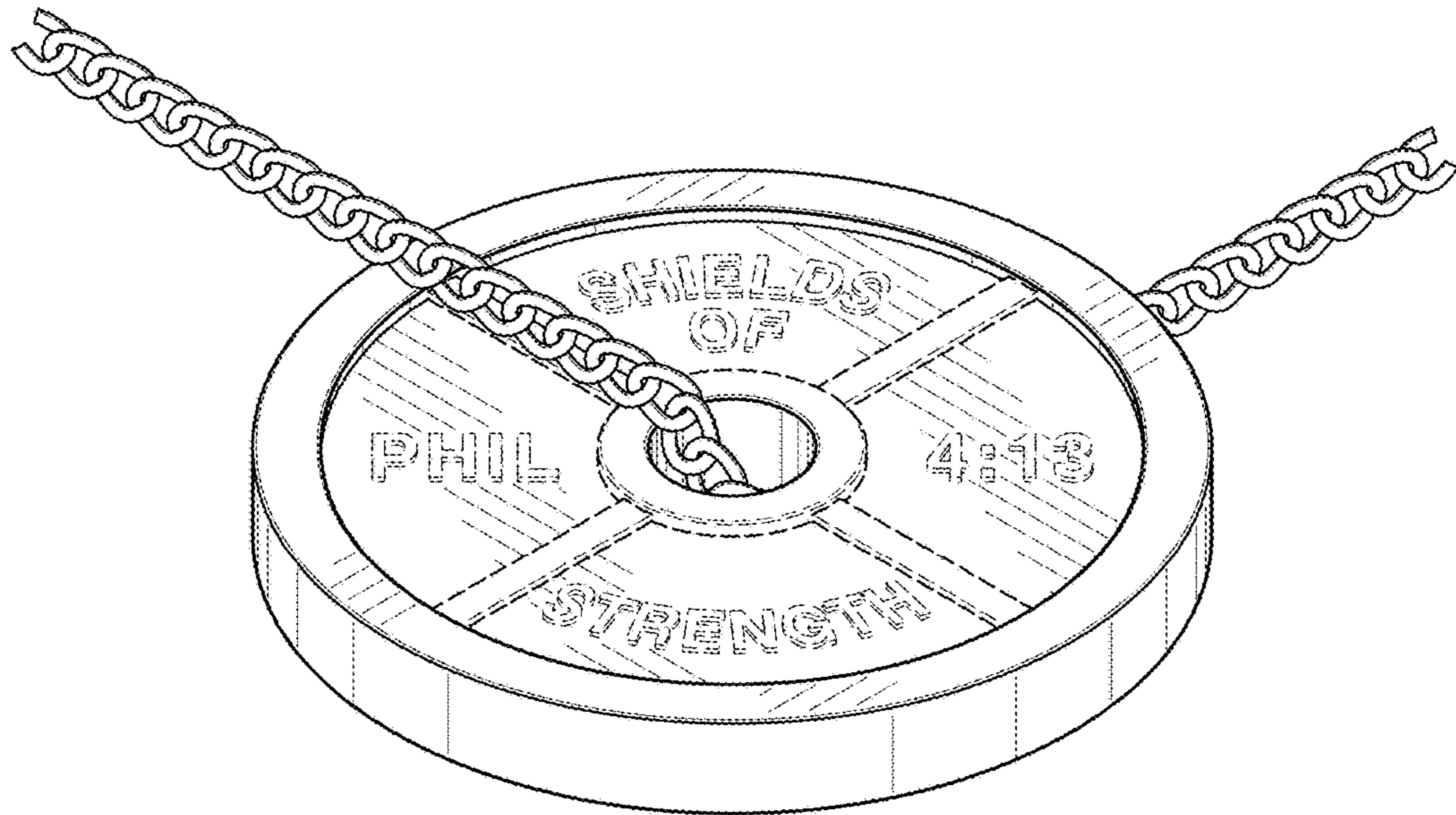

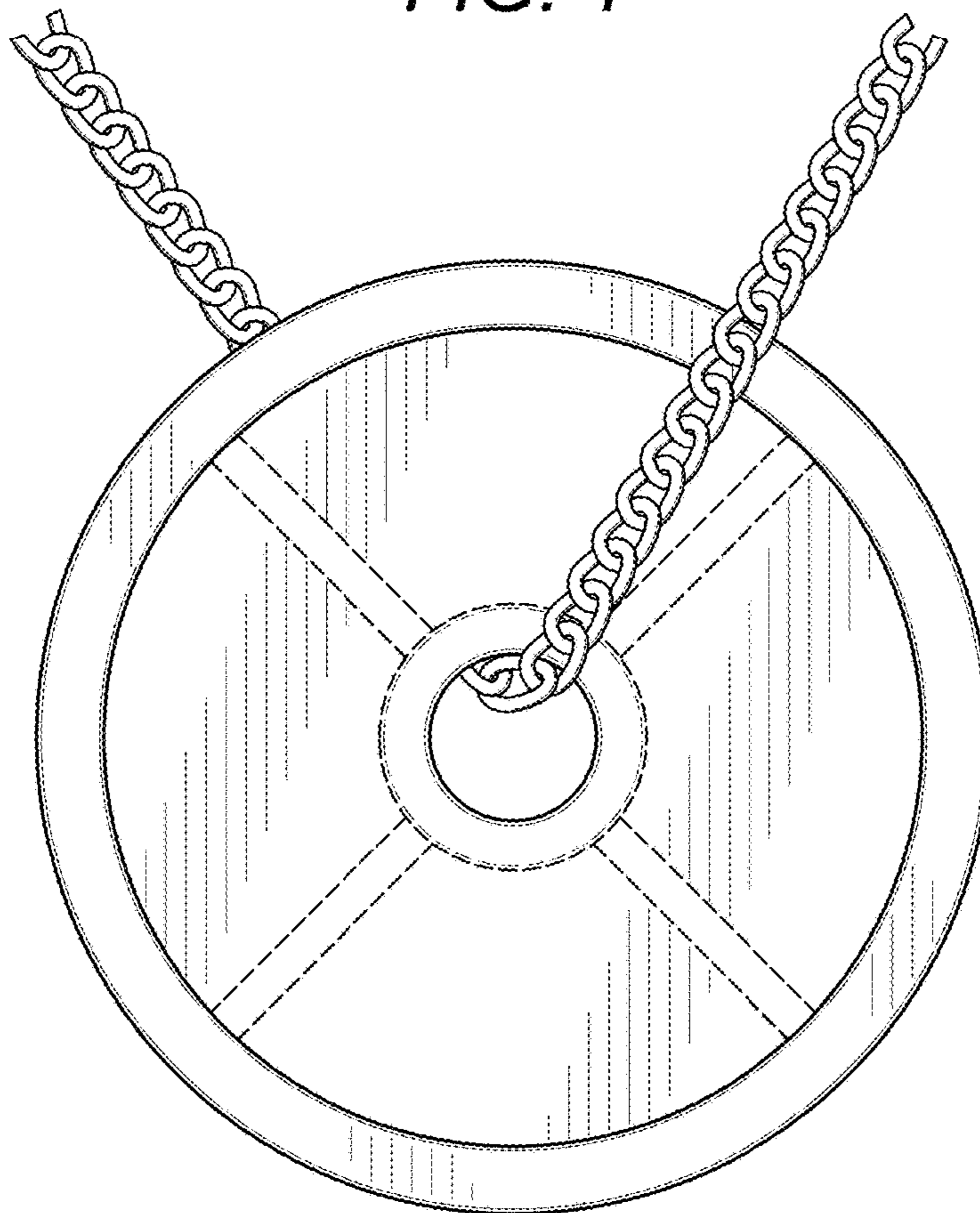

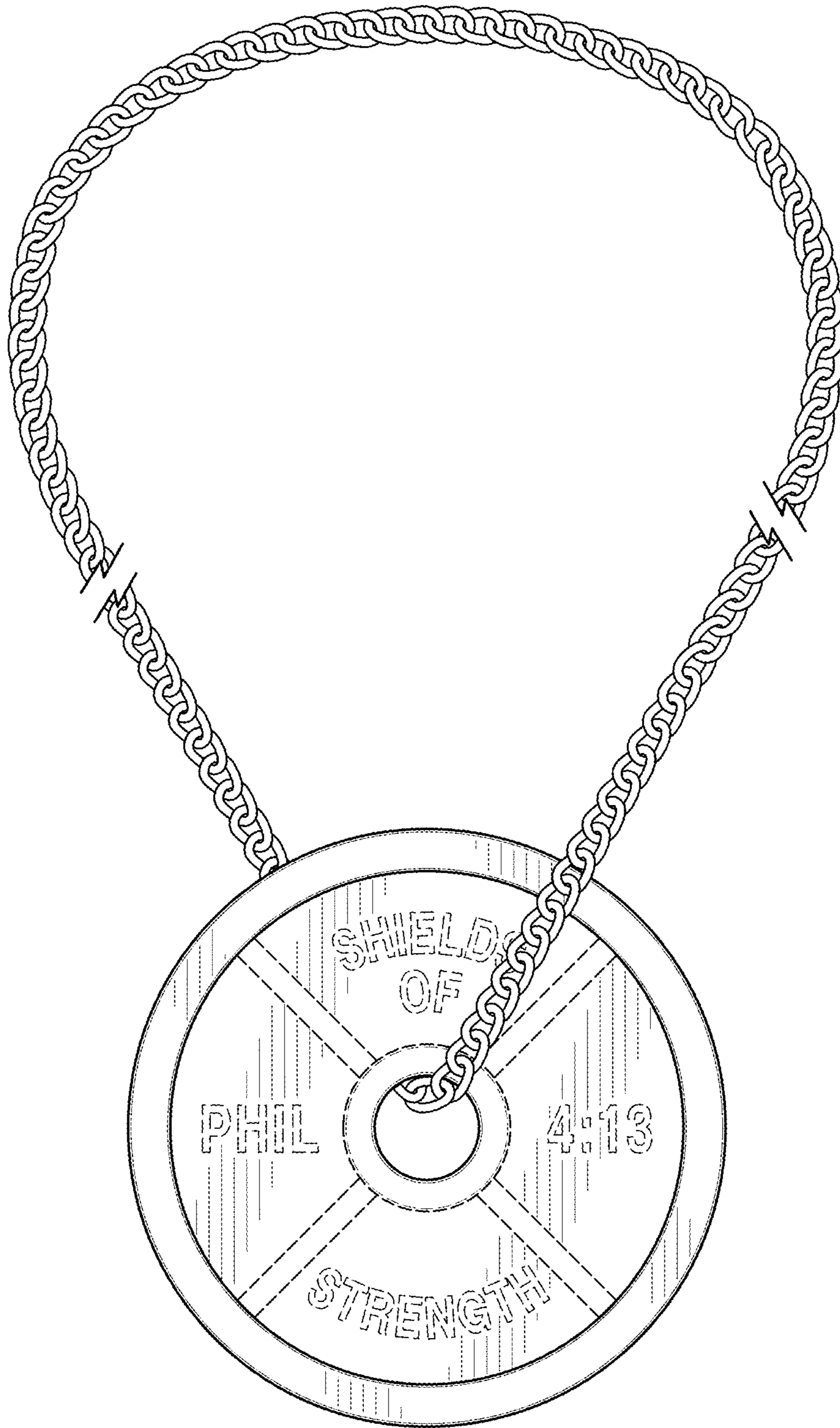

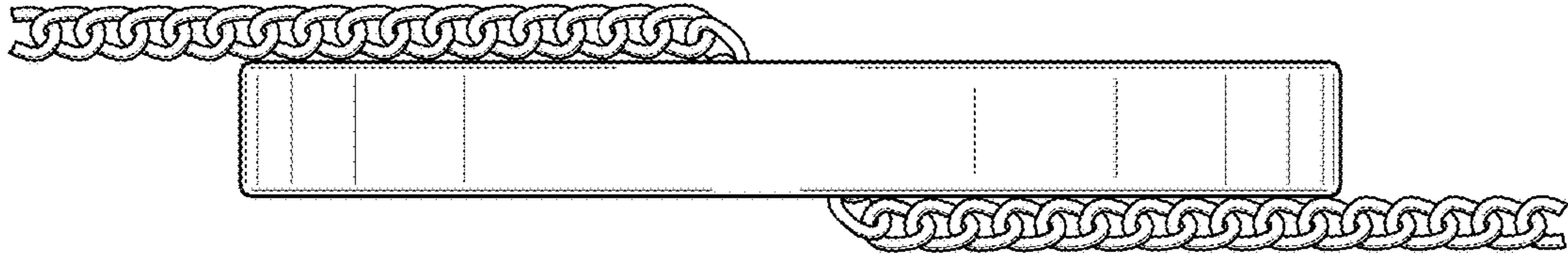

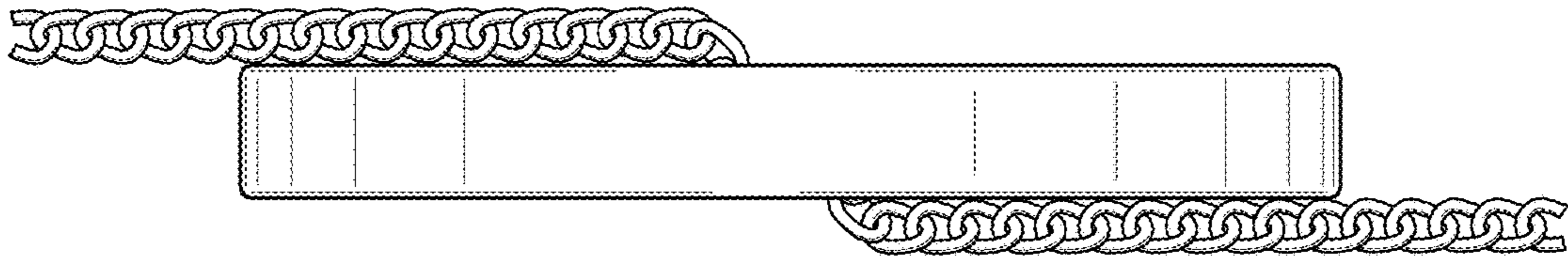

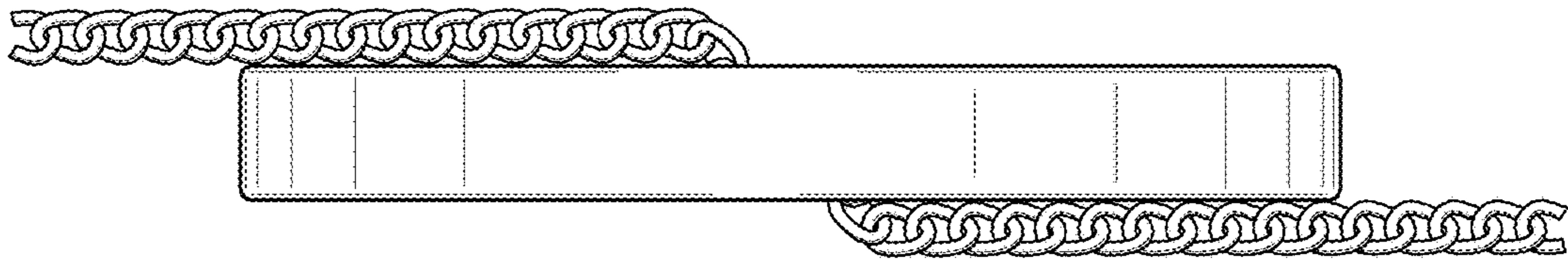

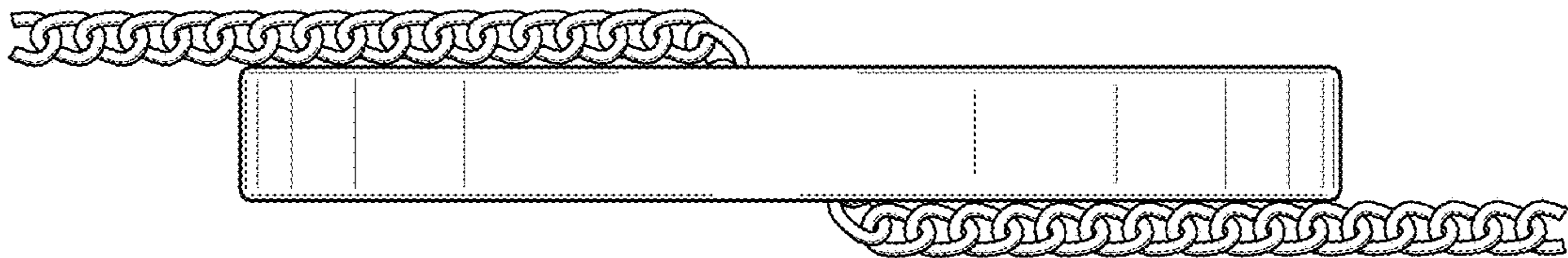
