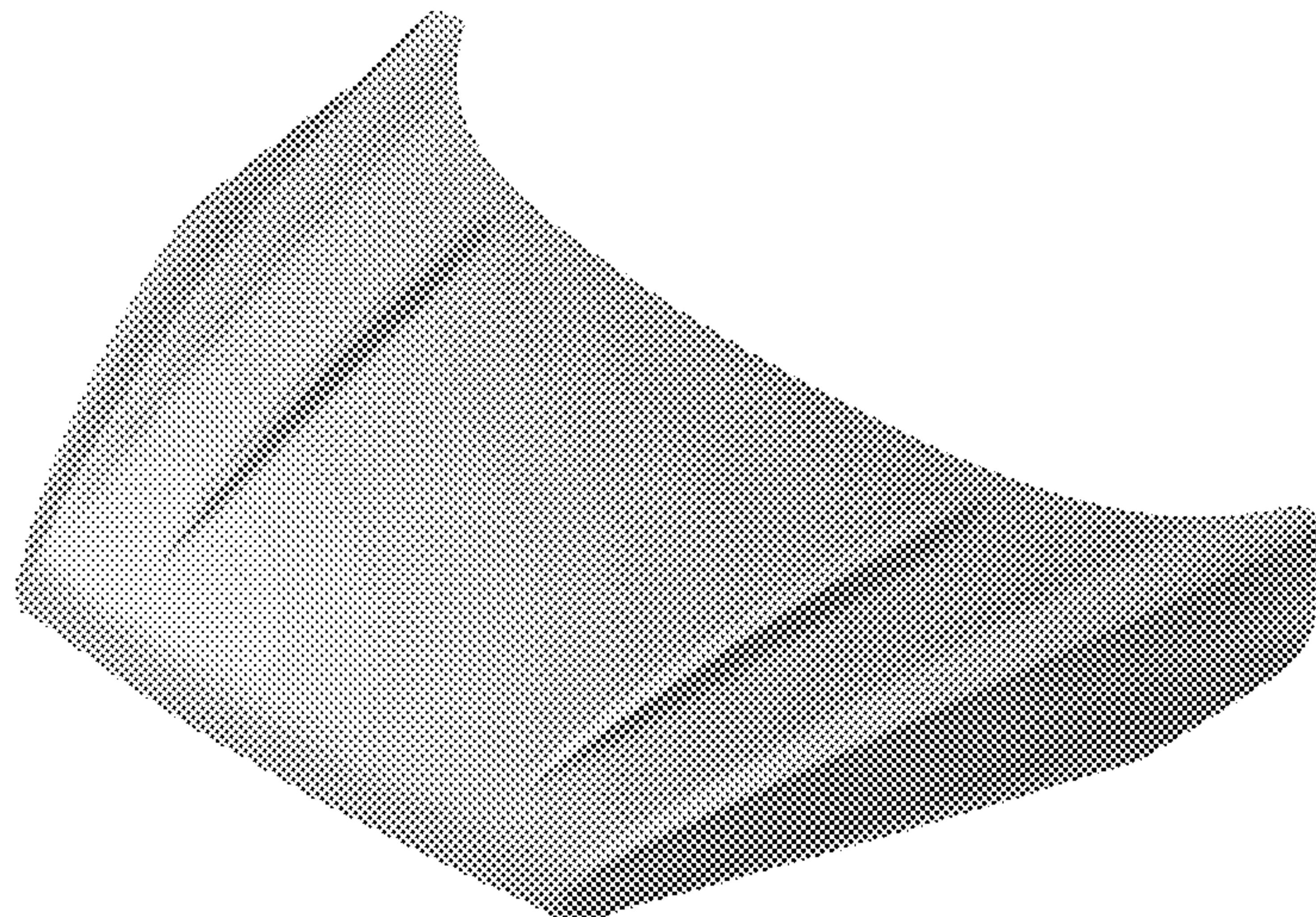
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, front and left side perspective view of a vehicle hood showing our new design;

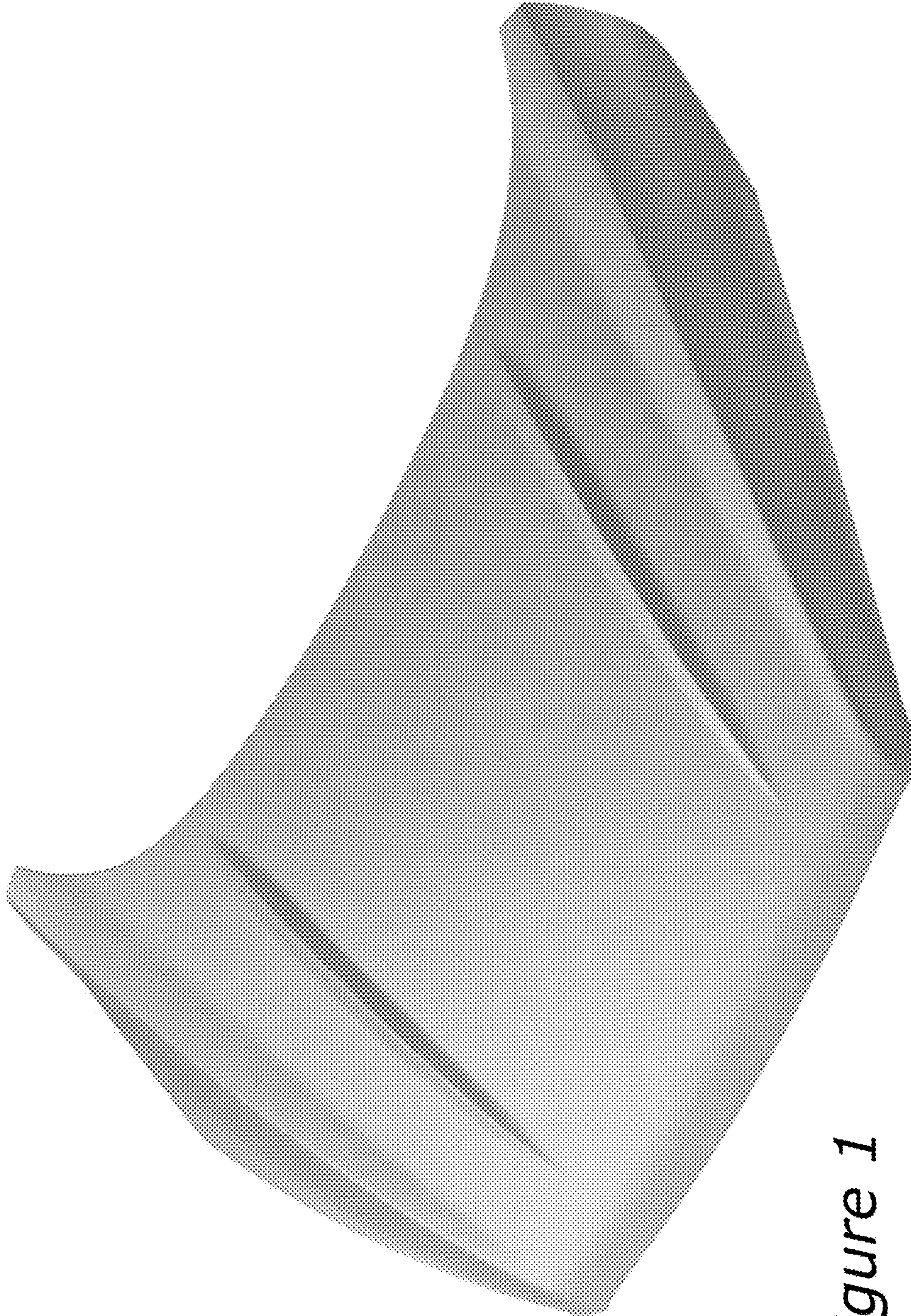

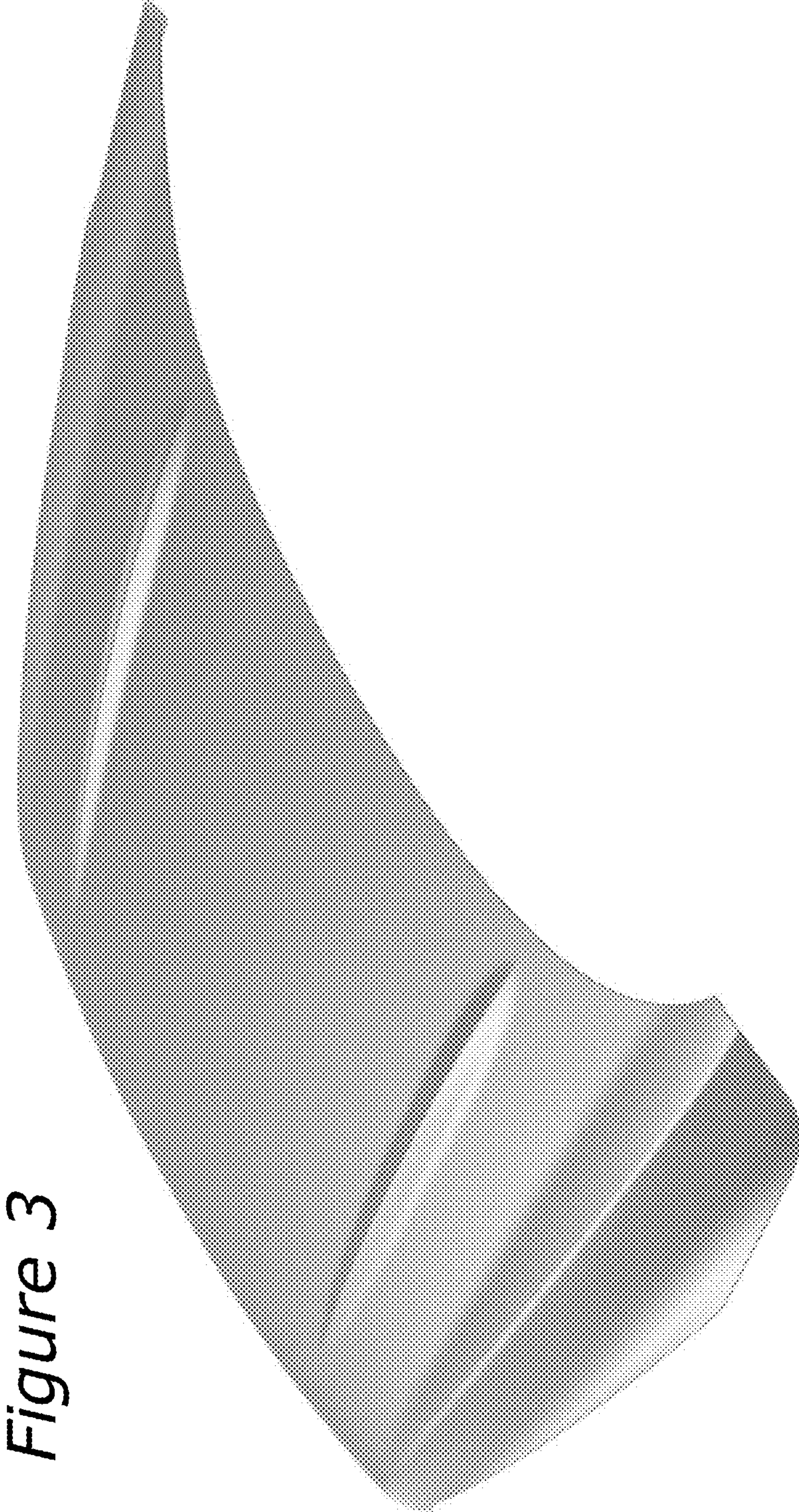

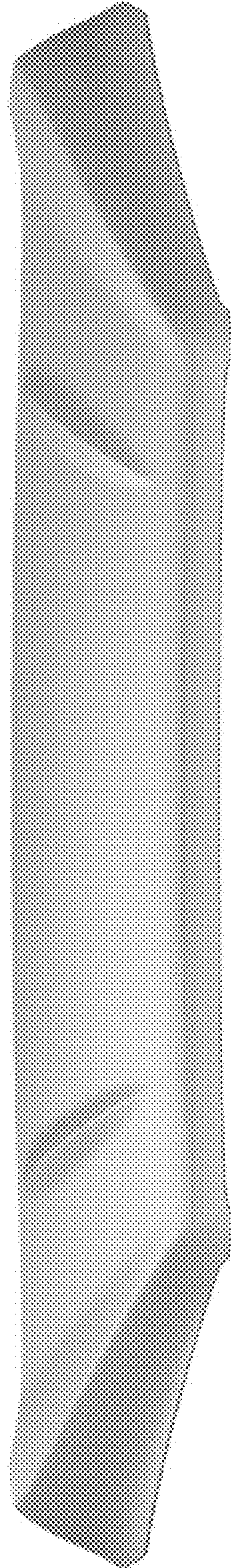

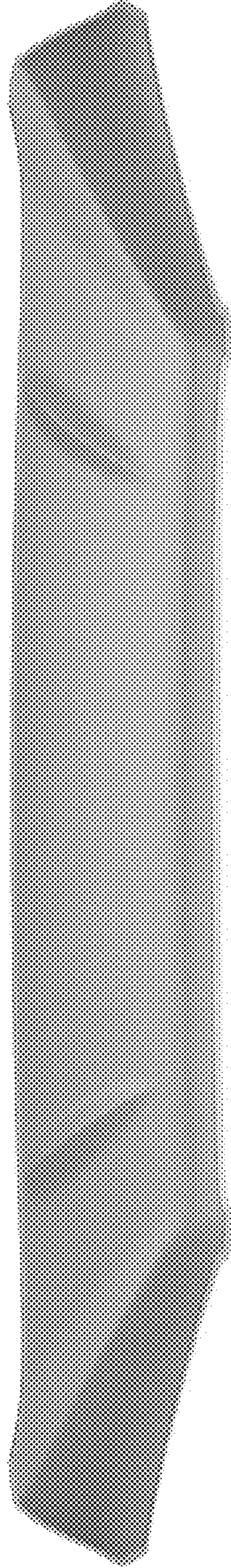

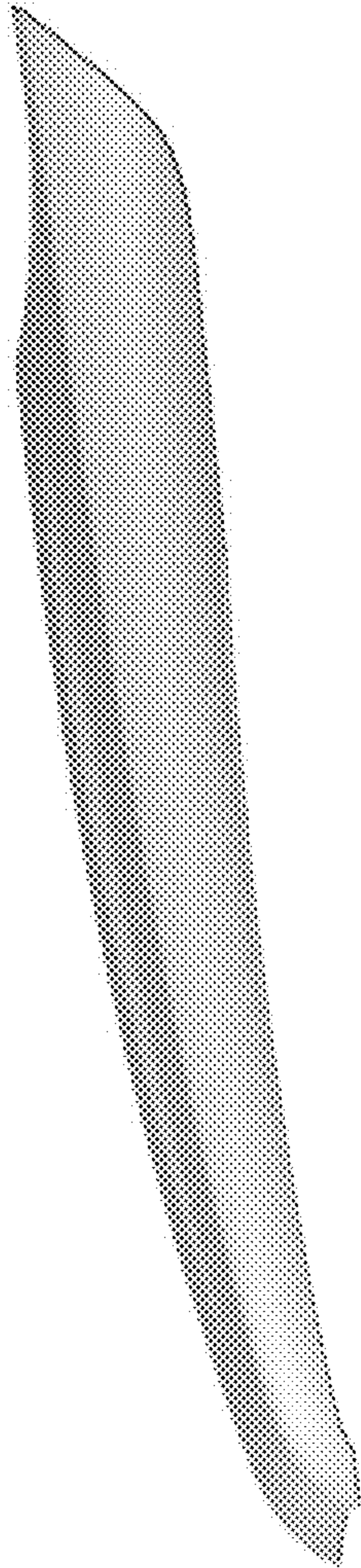

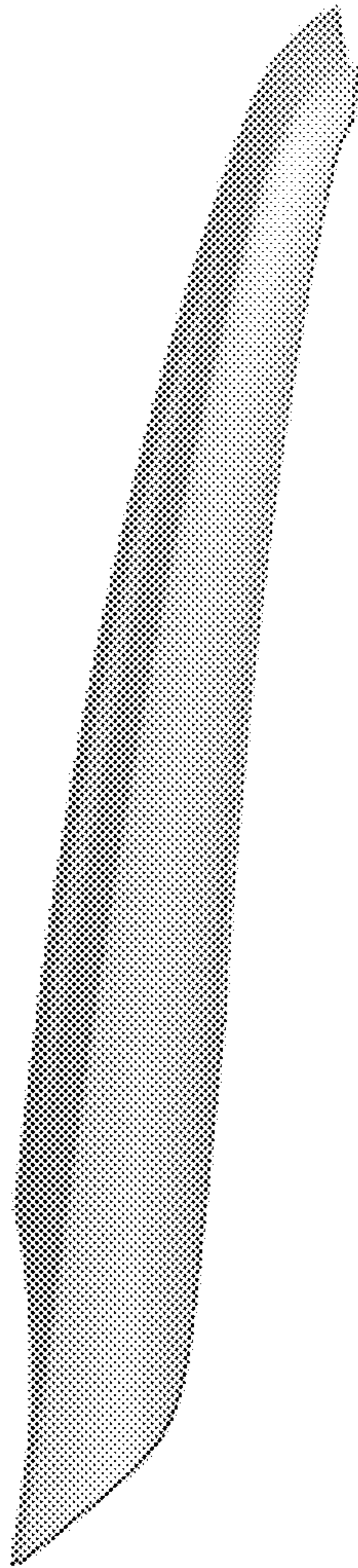
