(57) **CLAIM**

The ornamental design for an automobile tire, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of an automobile tire, for which a rear view is the same;

FIG. 2 is a top view of the automobile tire, for which a bottom view is the same;

FIG. 3 is a right-side view of the automobile tire, for which a left-side view is the same;

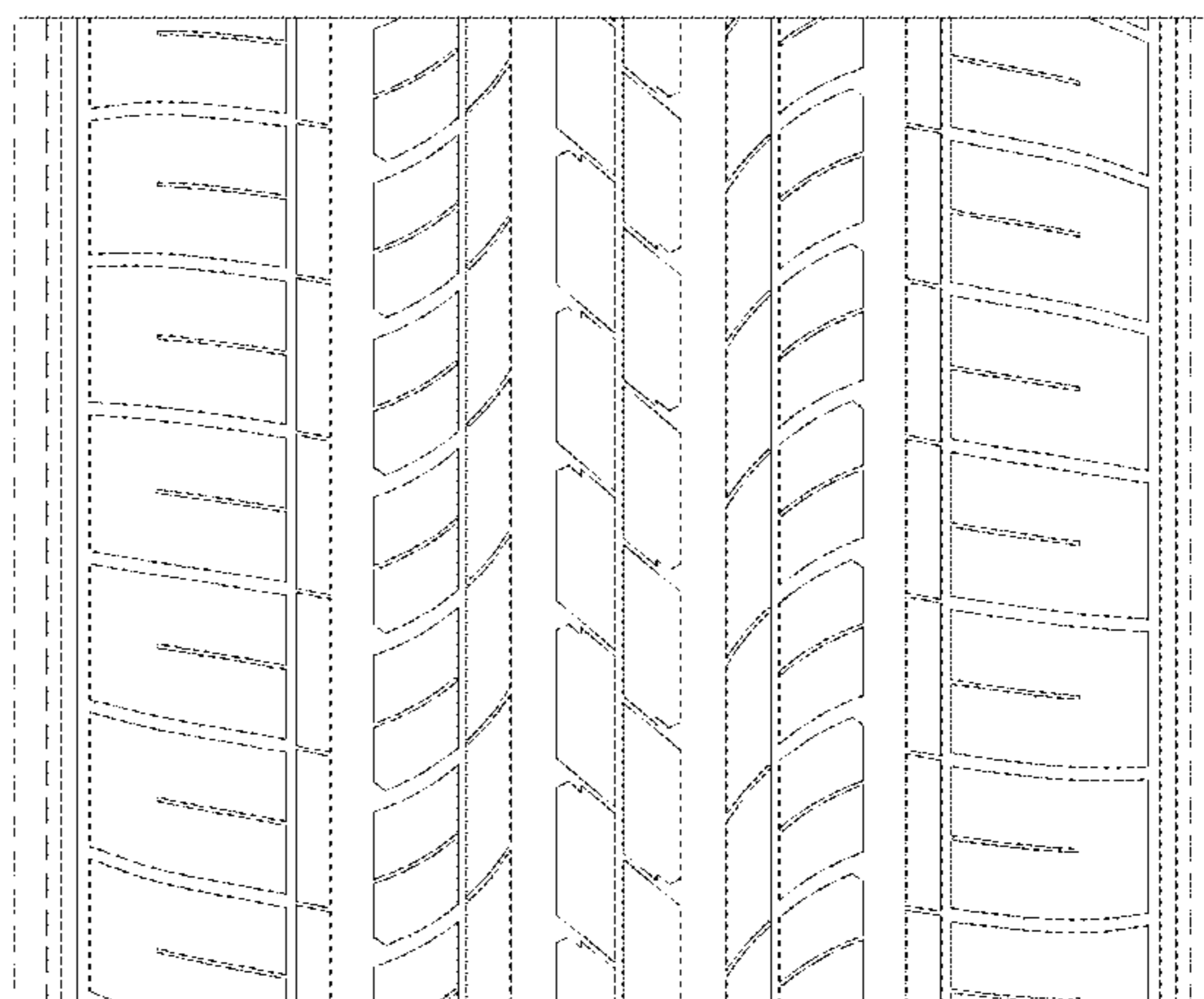
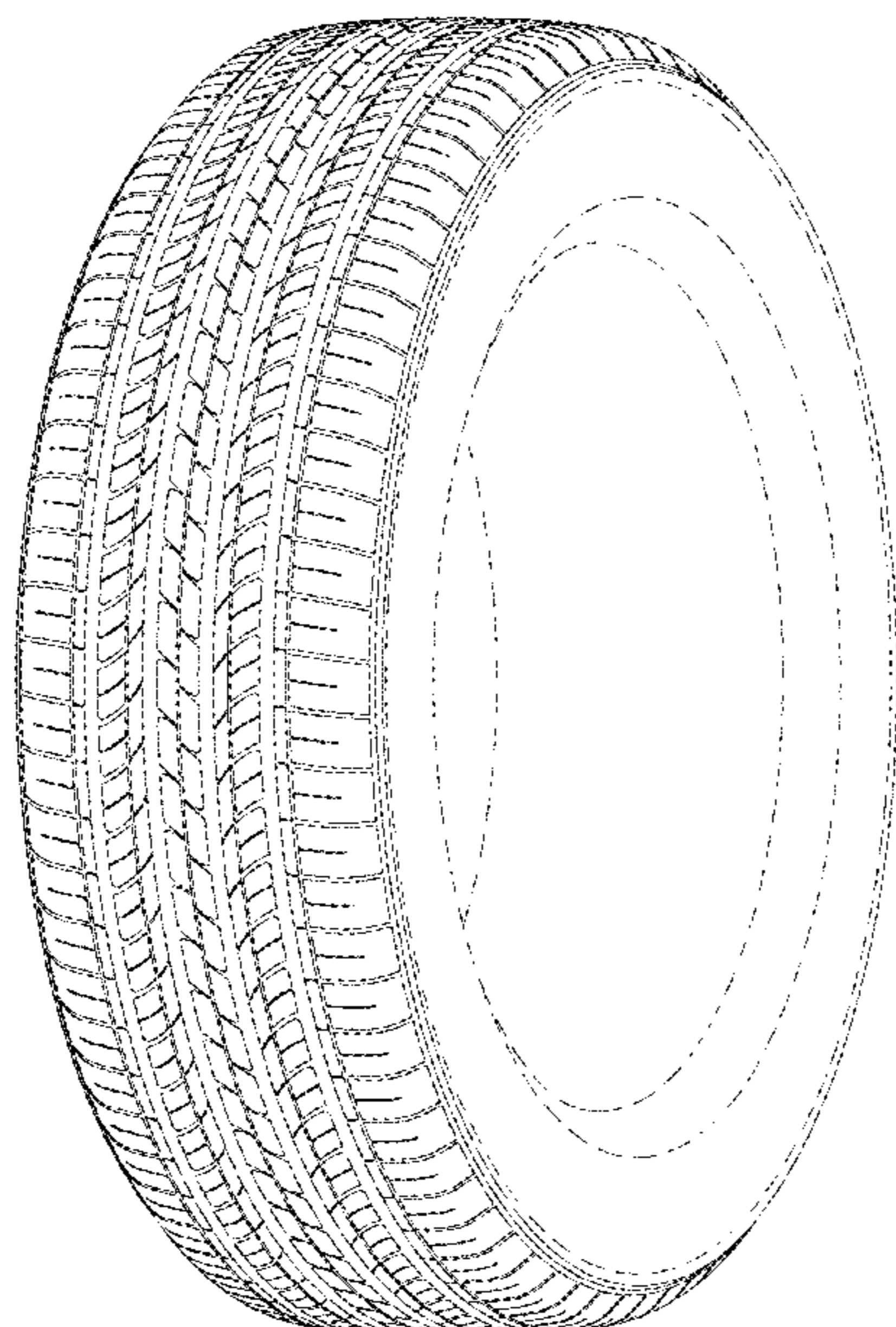
FIG. 4 is a right-side perspective view of the automobile tire, for which a left-side perspective view is the same;

FIG. 5 is an enlarged front cross-sectional view of the automobile tire along line 5-5 in FIG. 1; and,

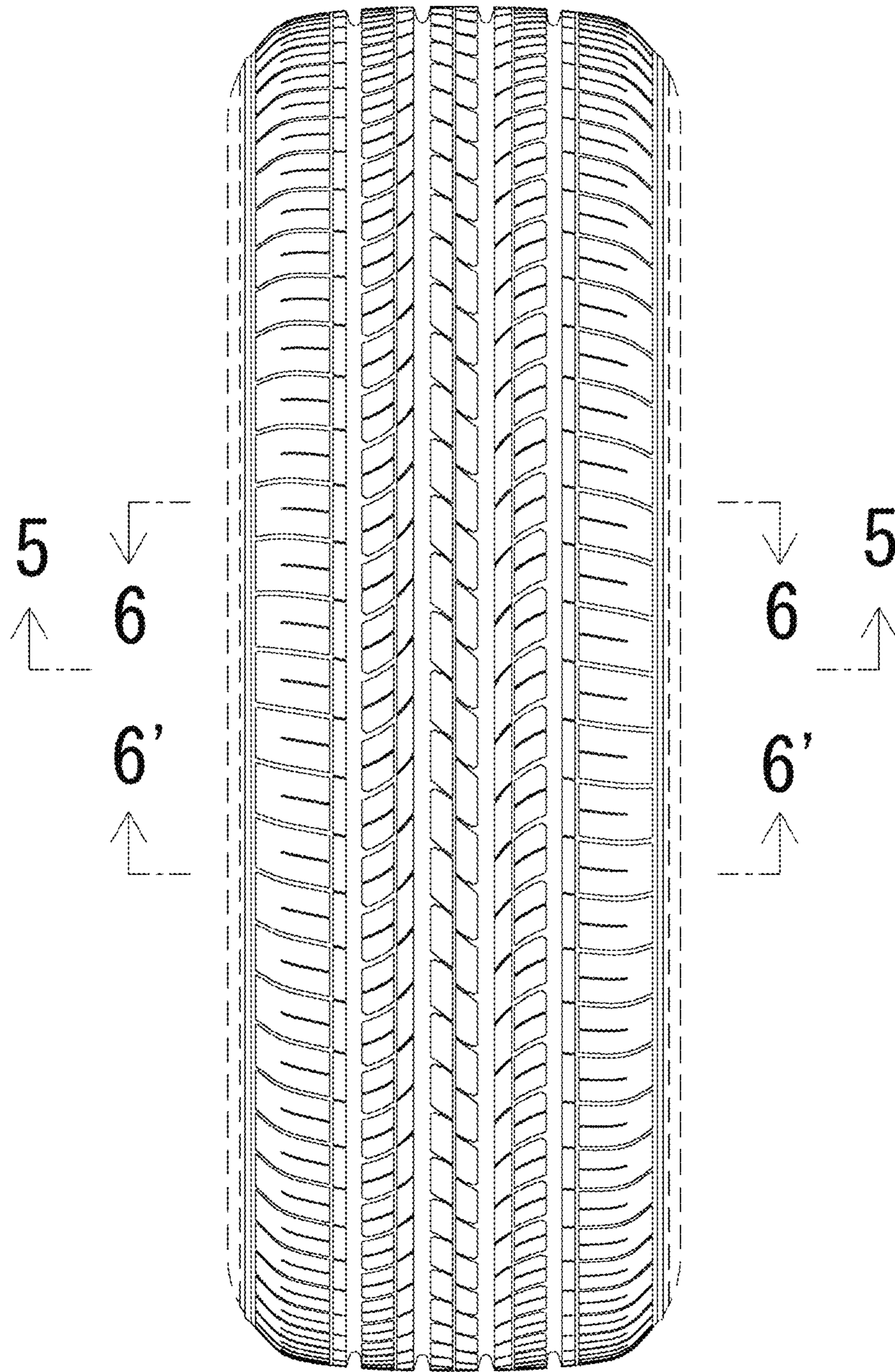

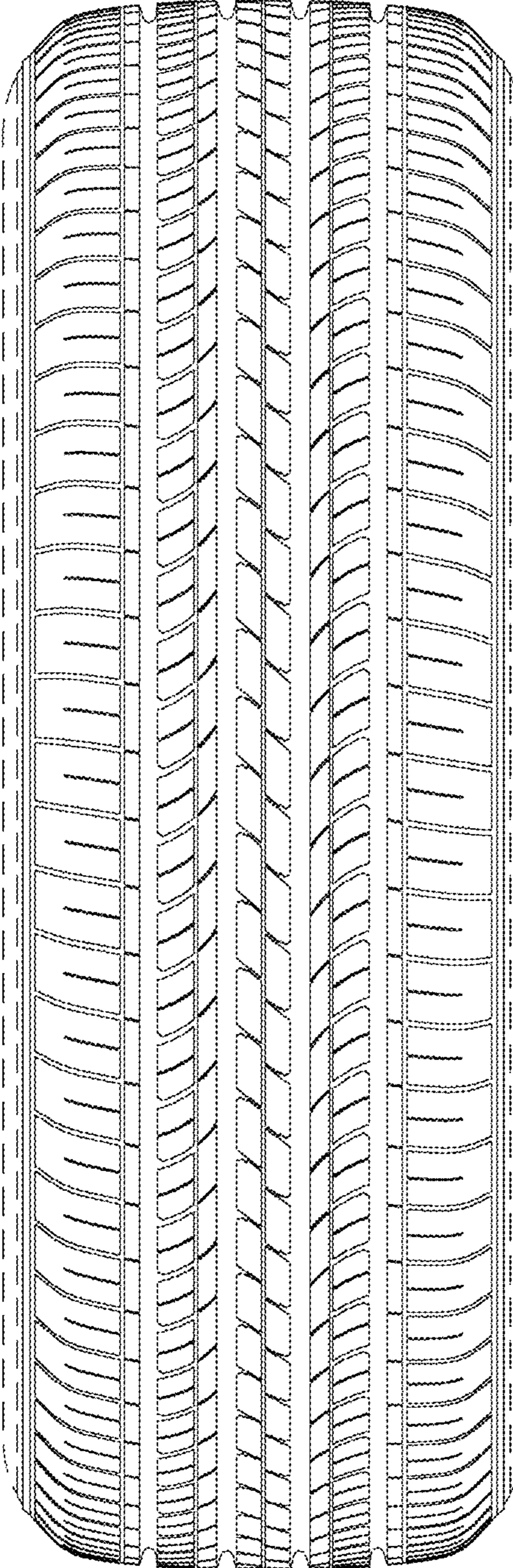

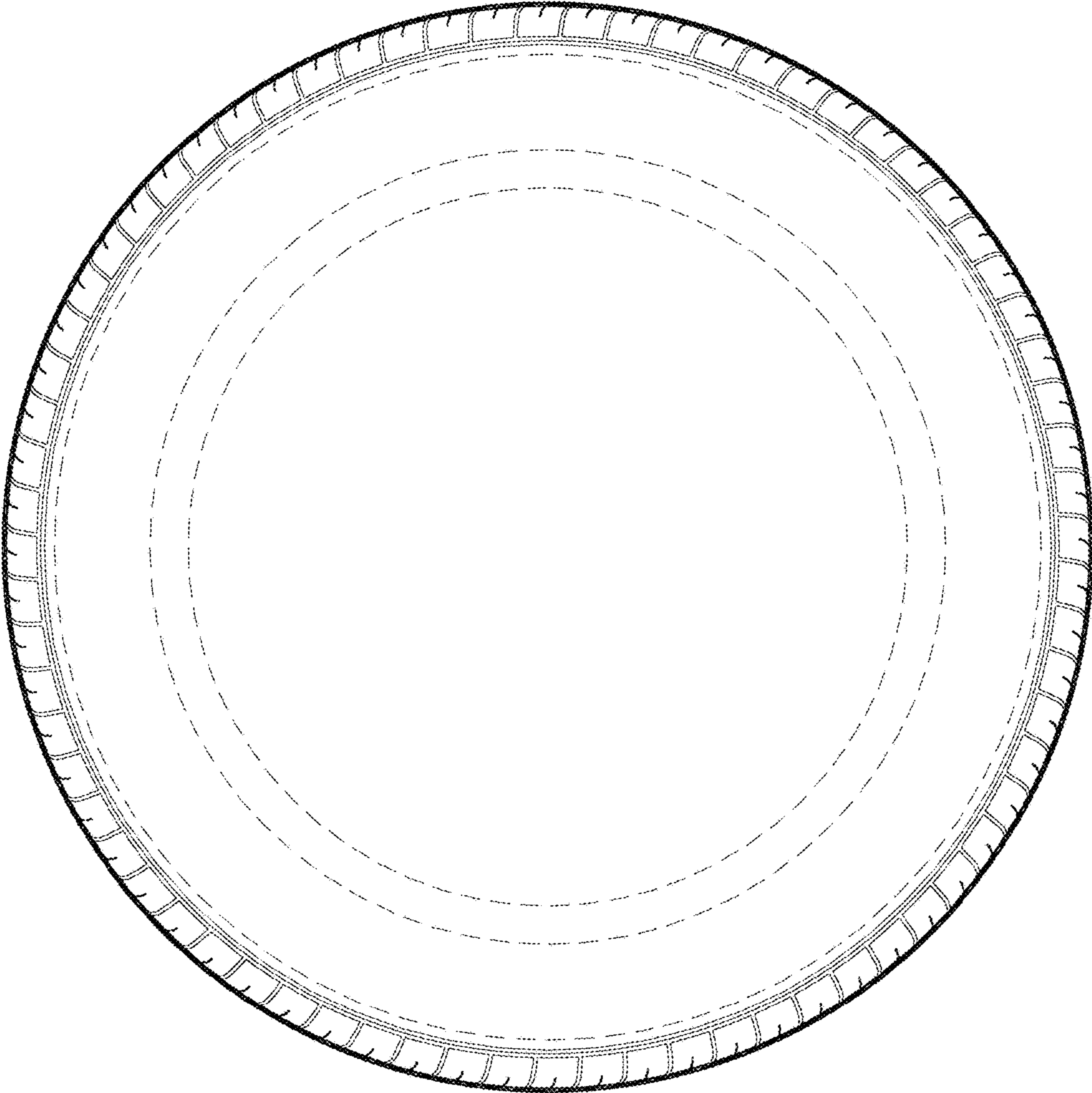

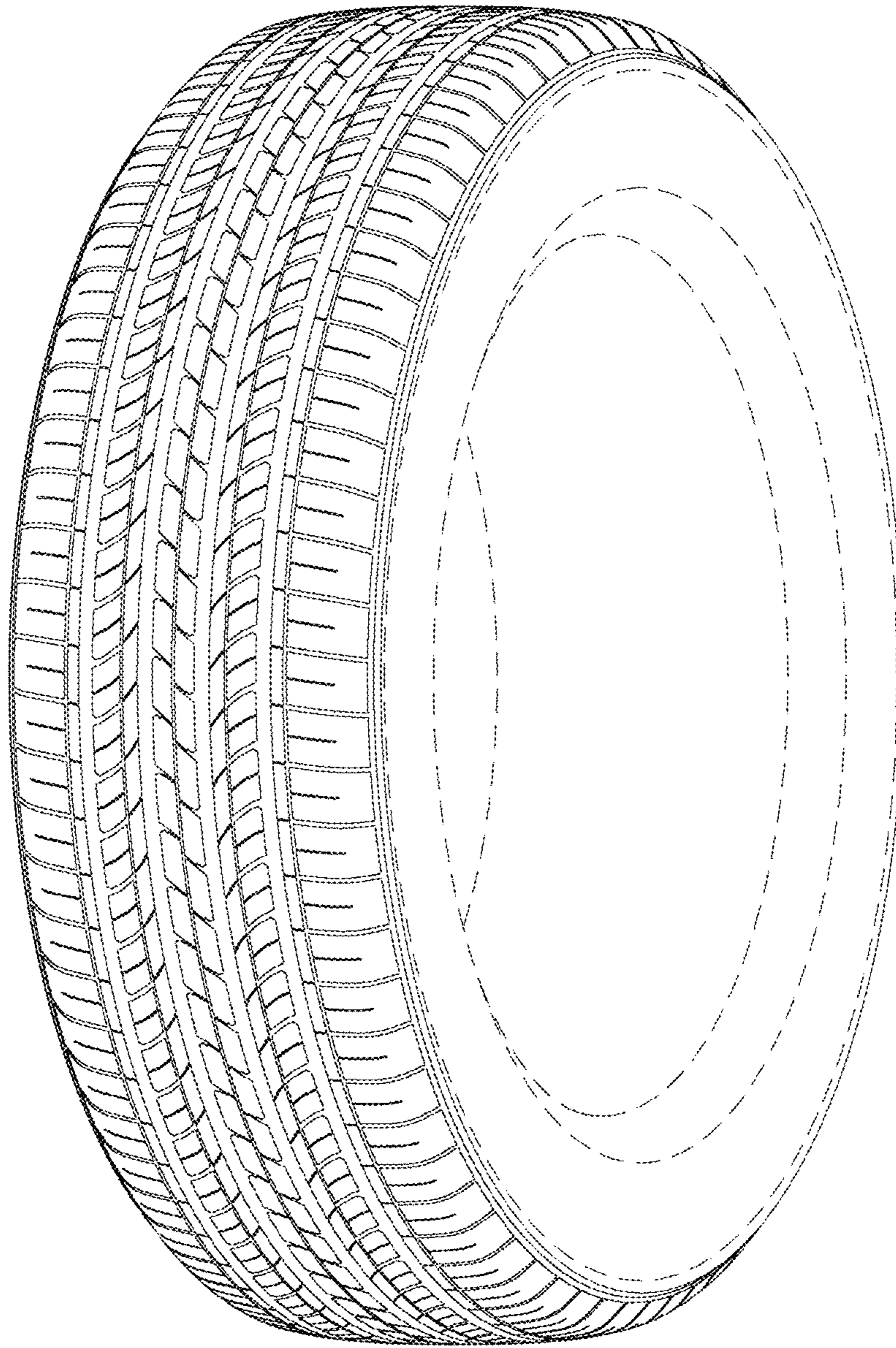

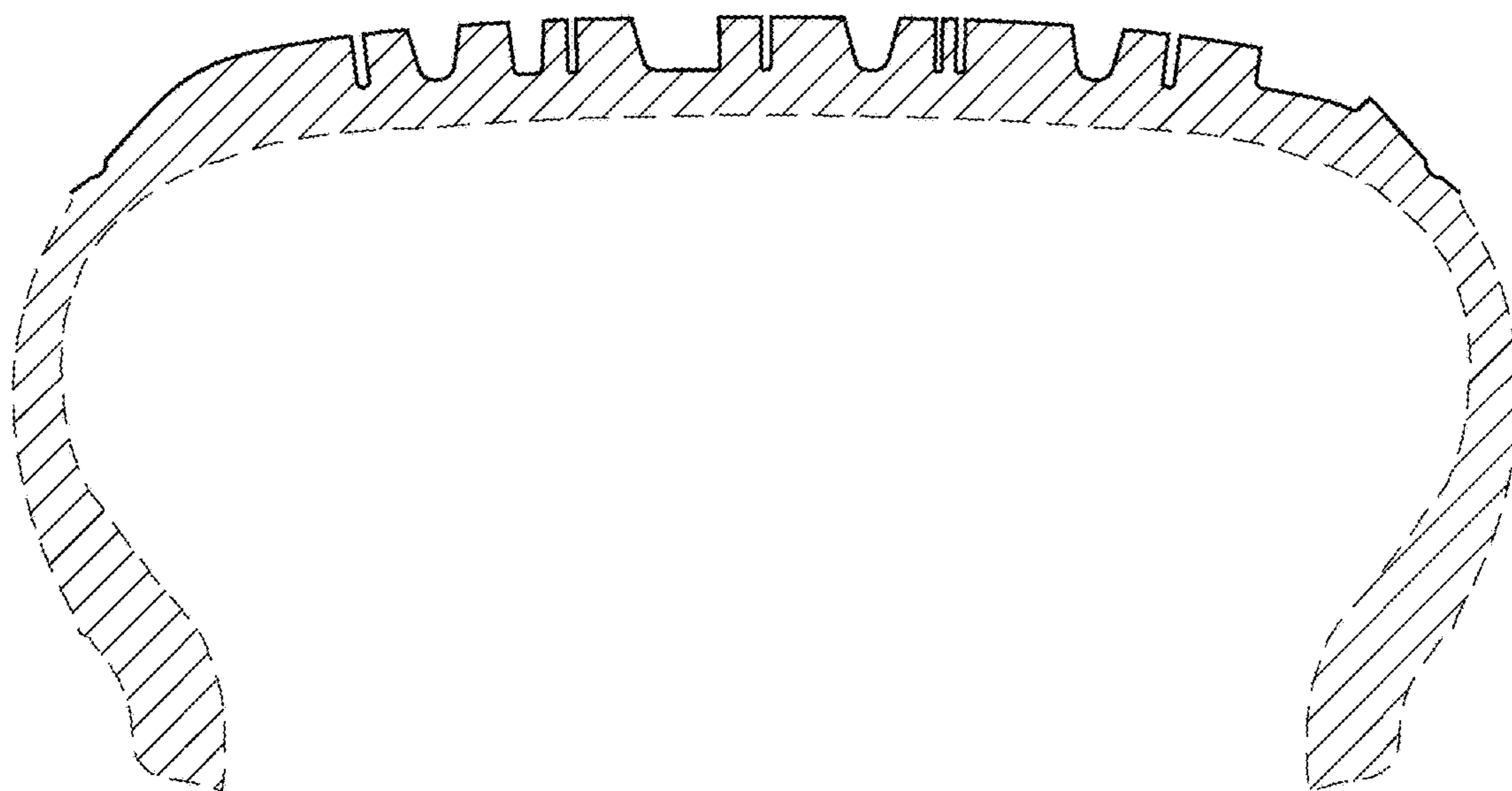

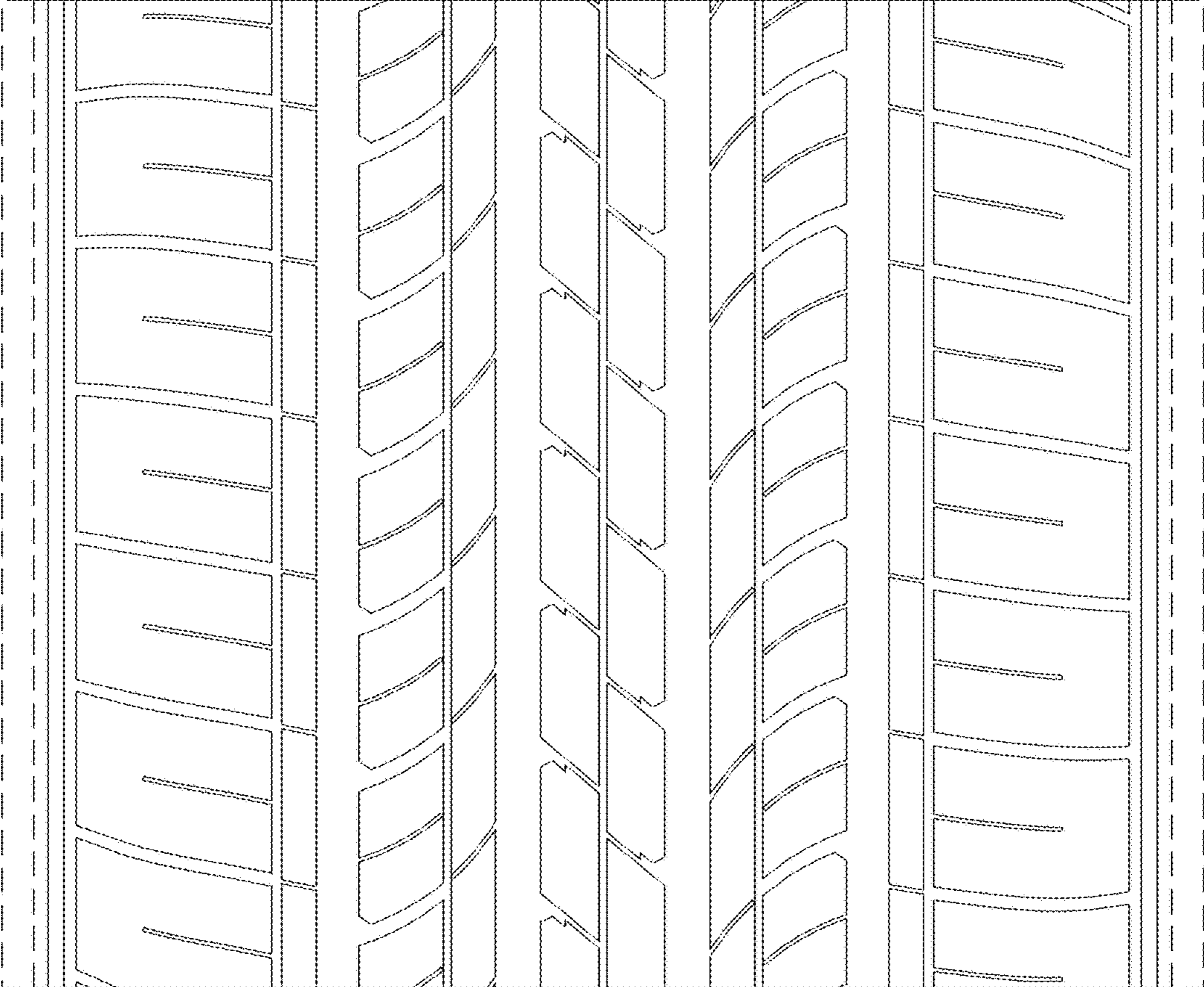
