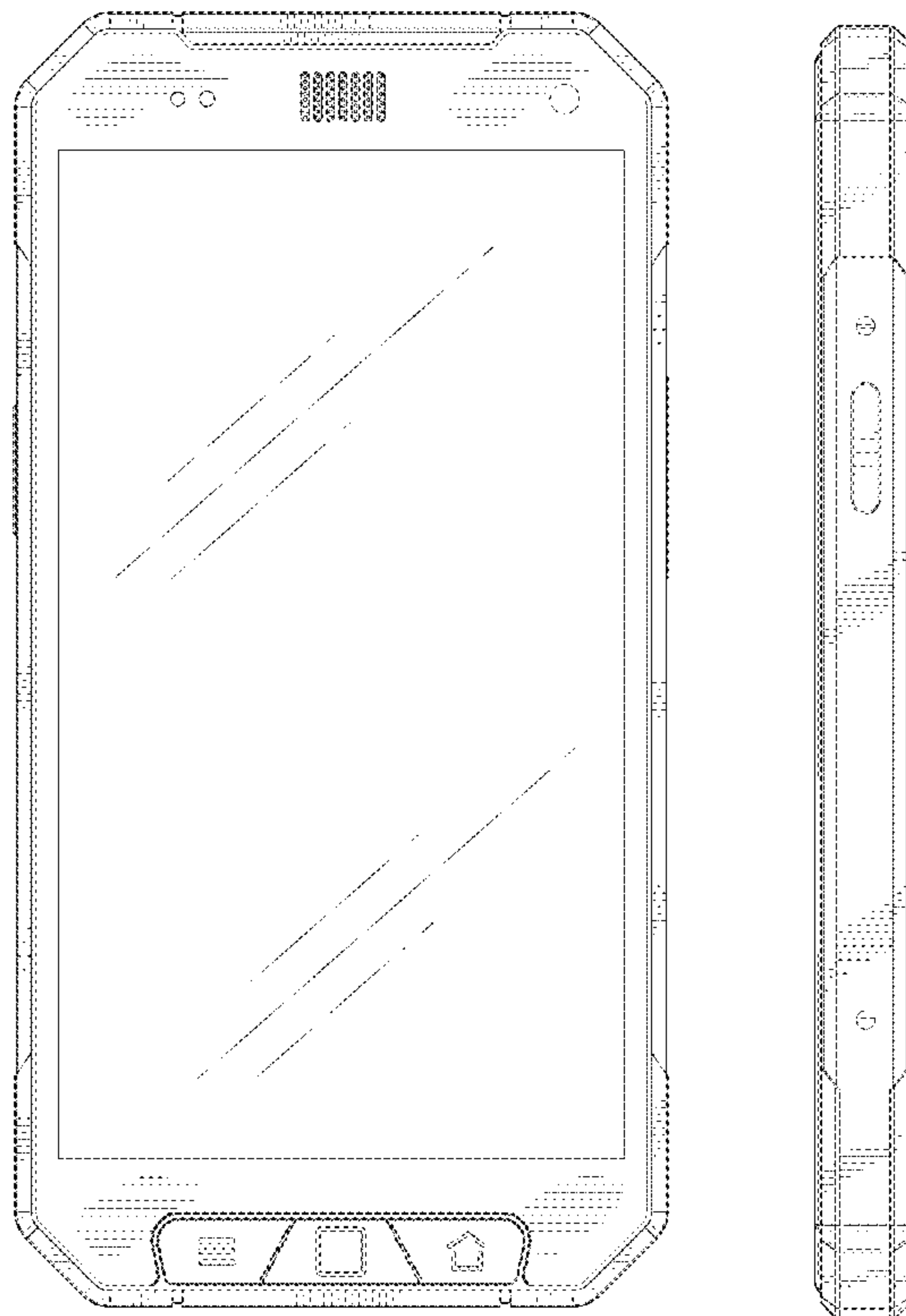
FIG. 1 is a front perspective view of the invention.

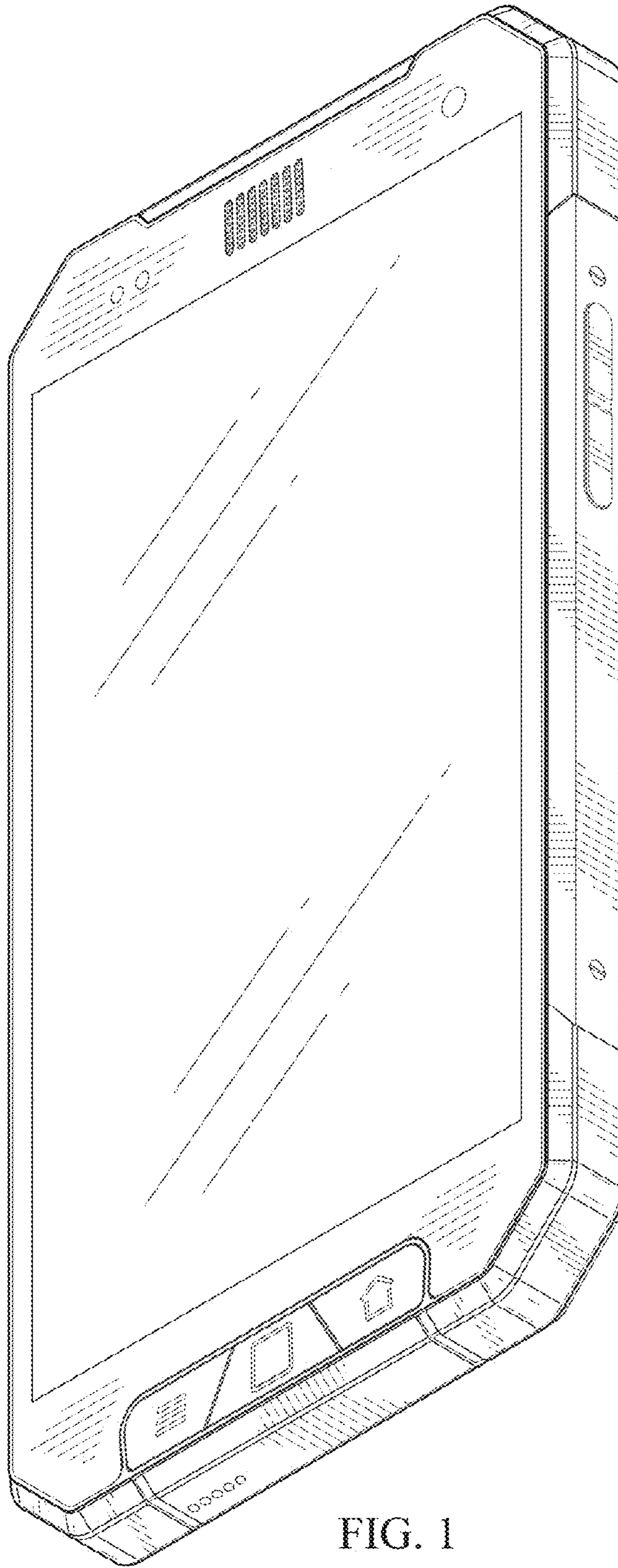

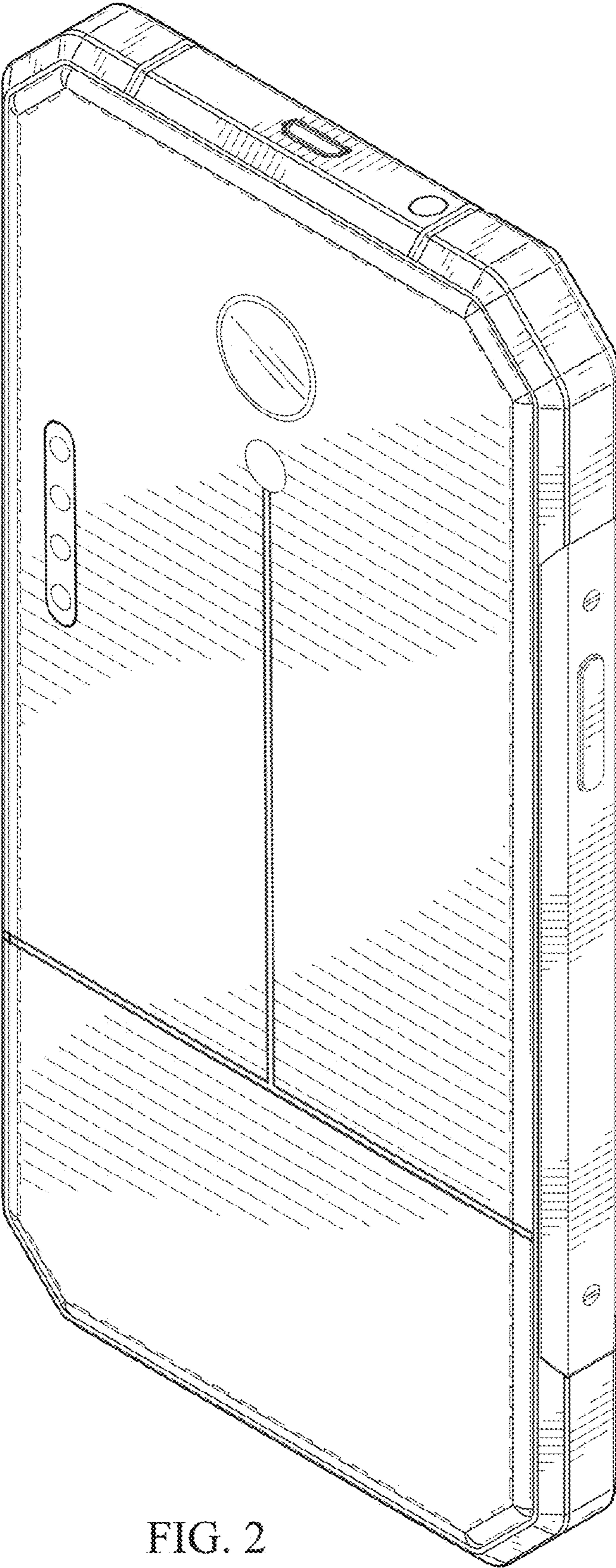

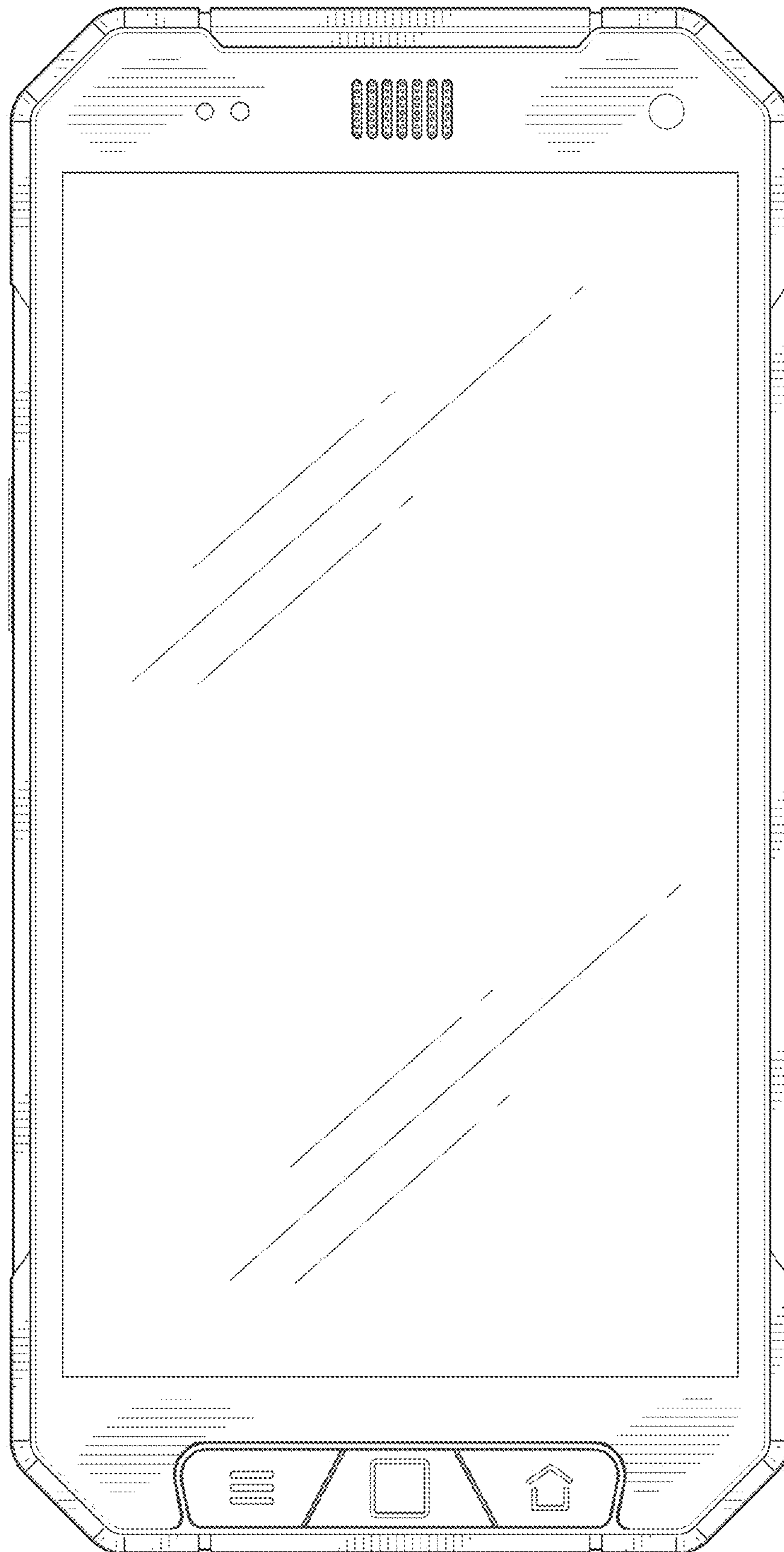

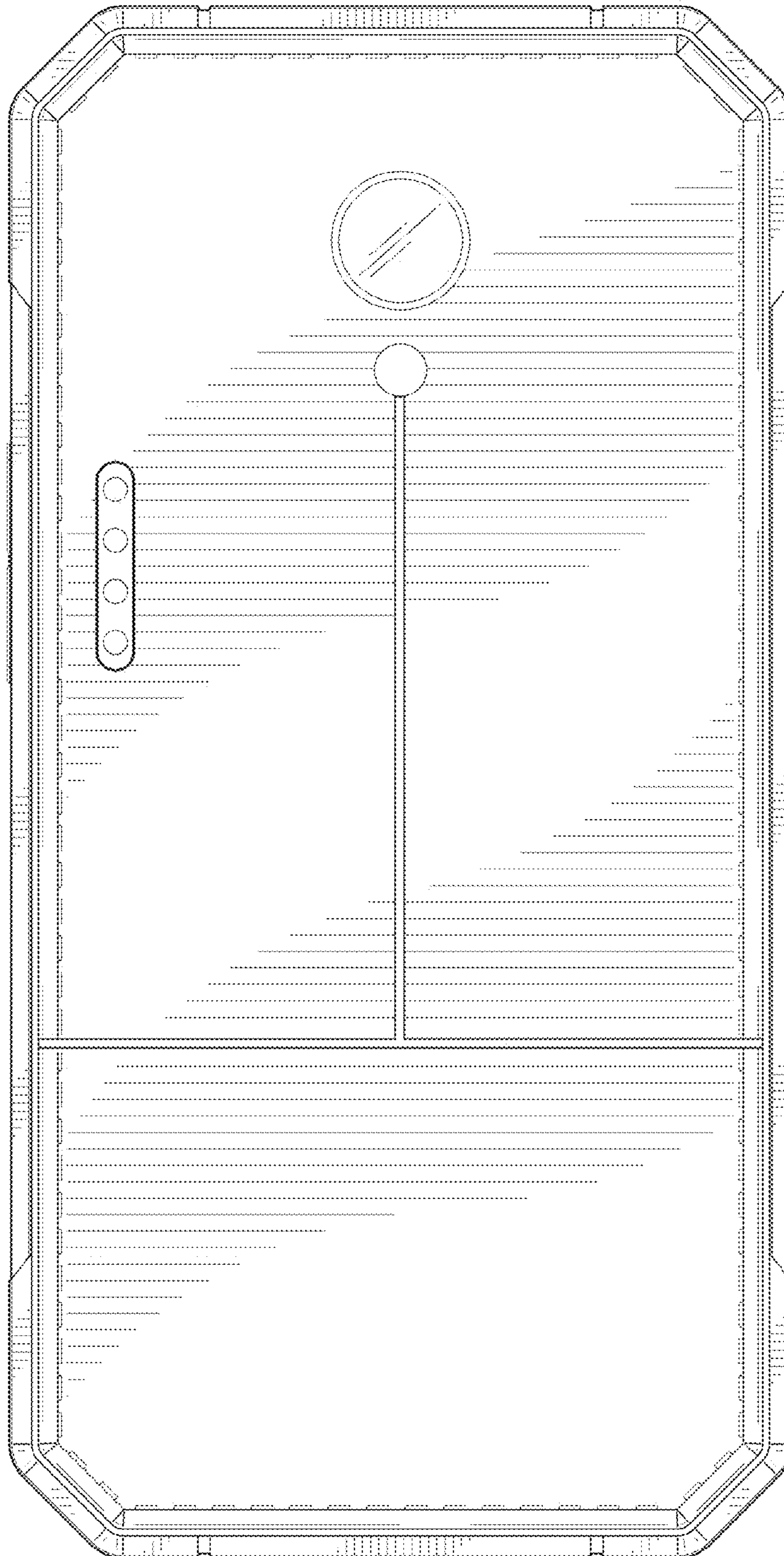

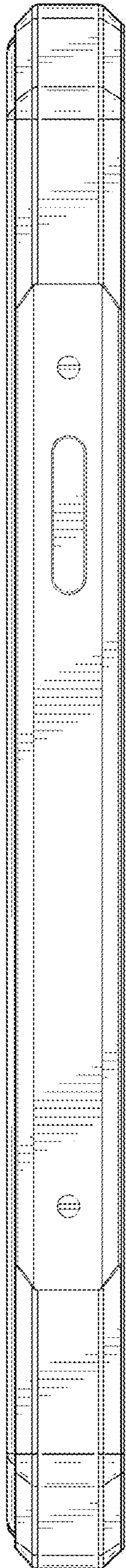

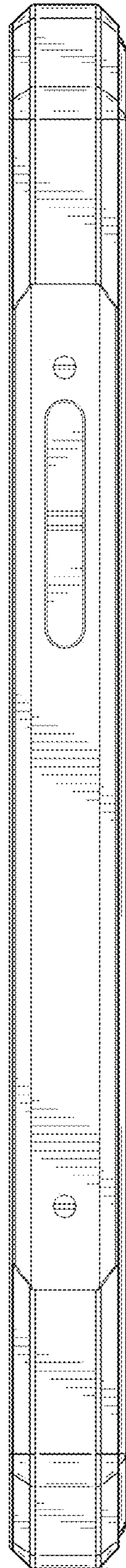

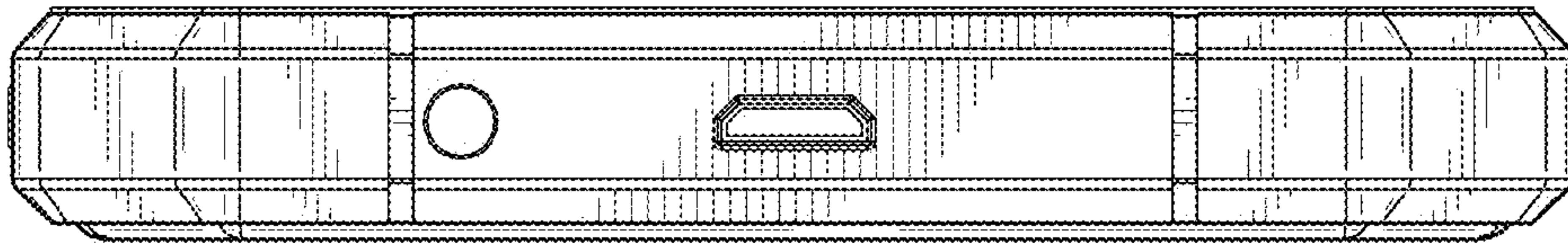

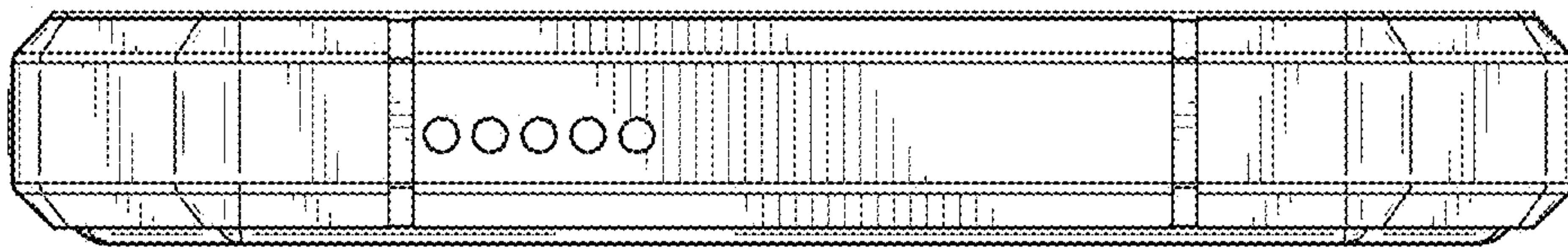
