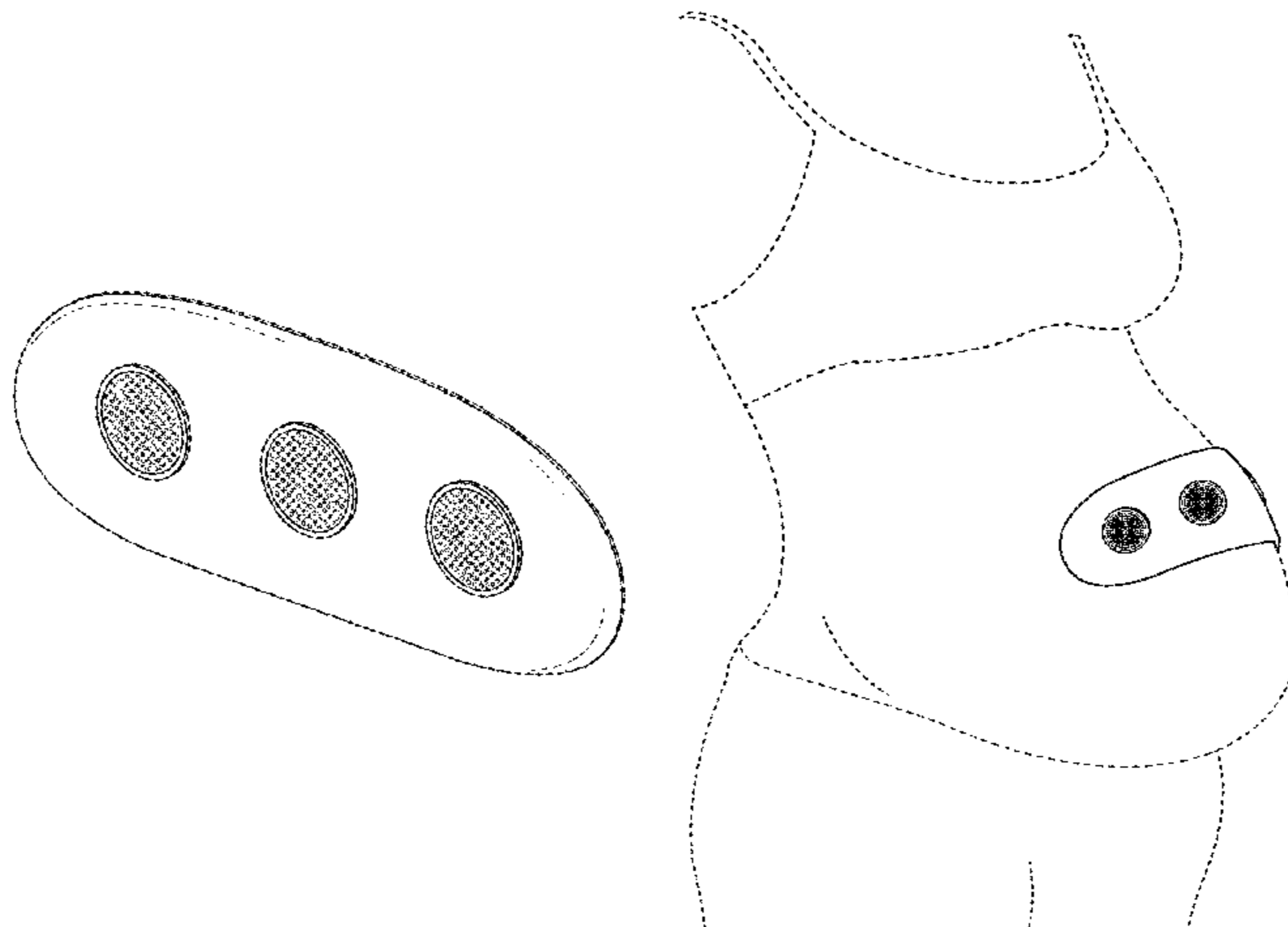
The ornamental design for a fetal wave device, as shown and described.

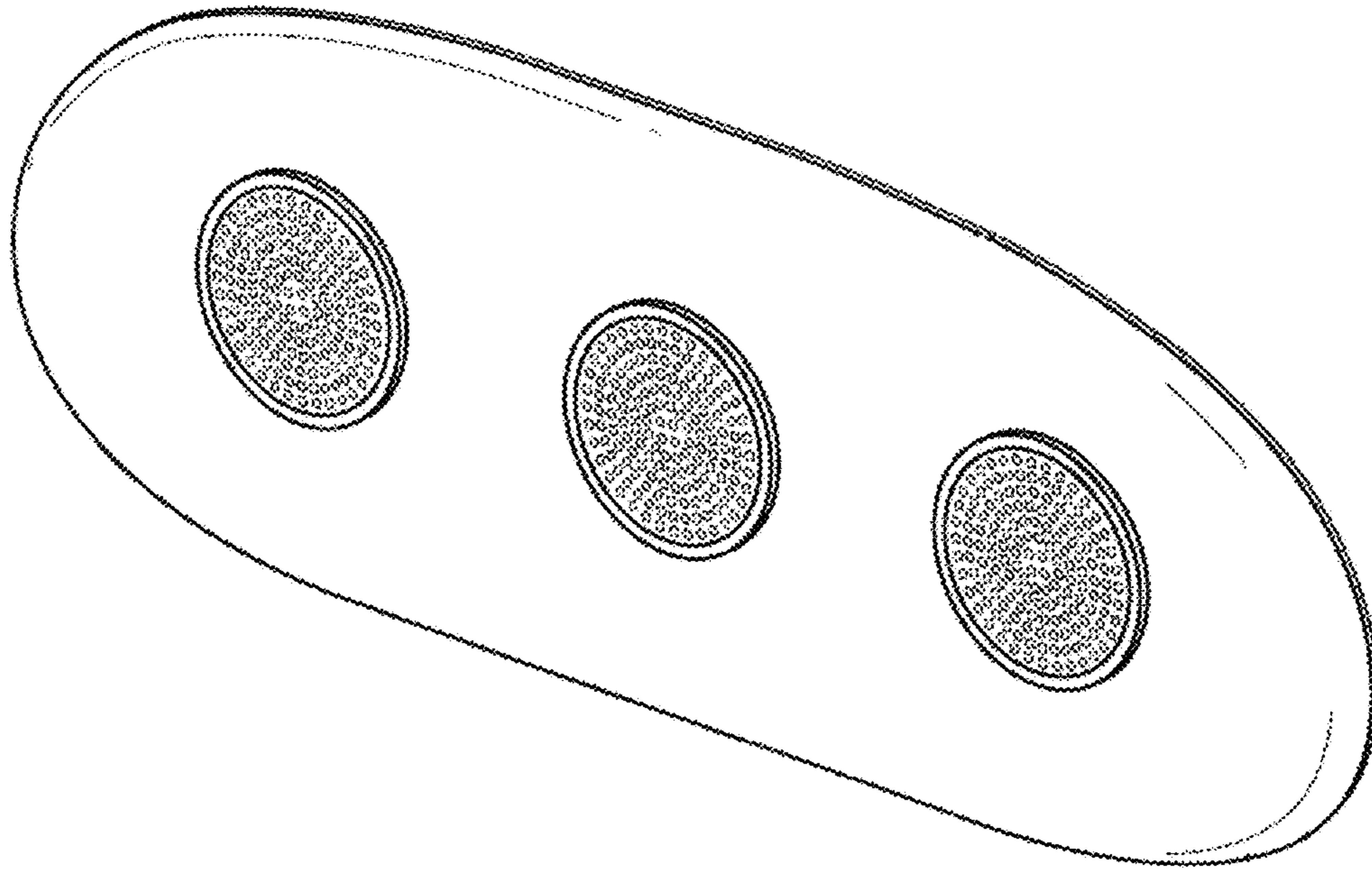
**DESCRIPTION**

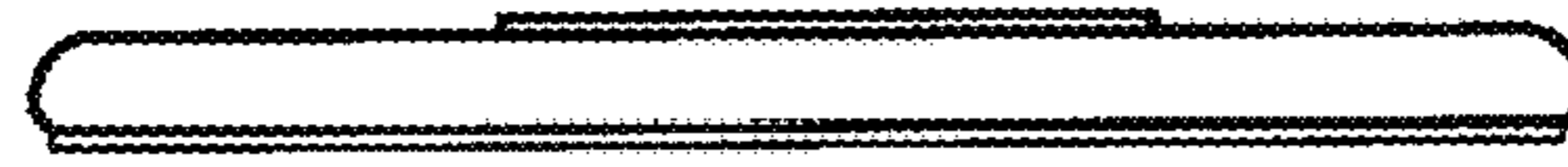

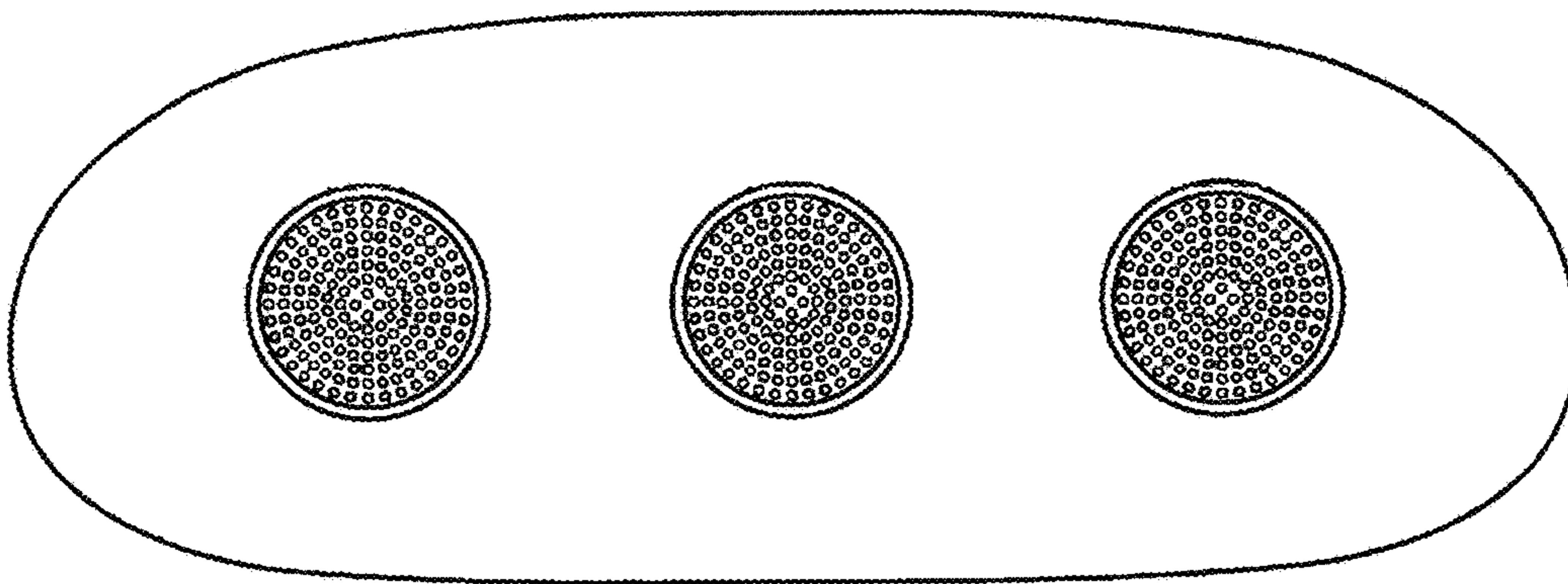

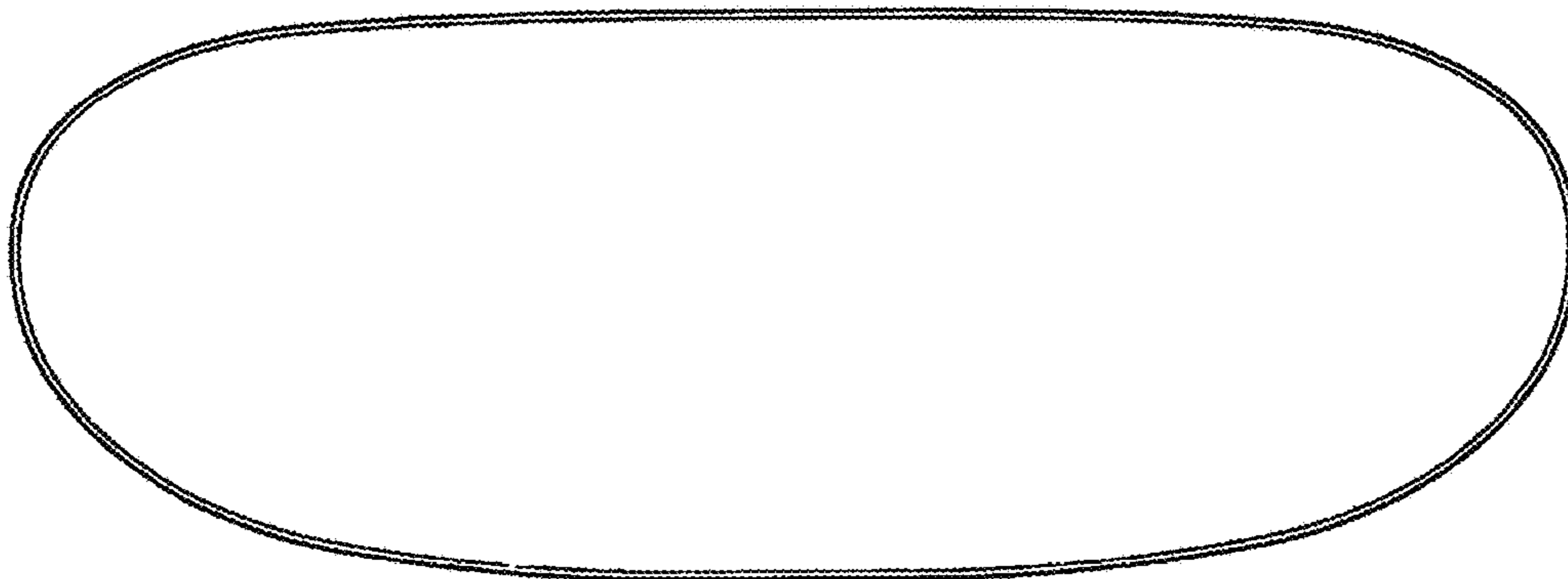

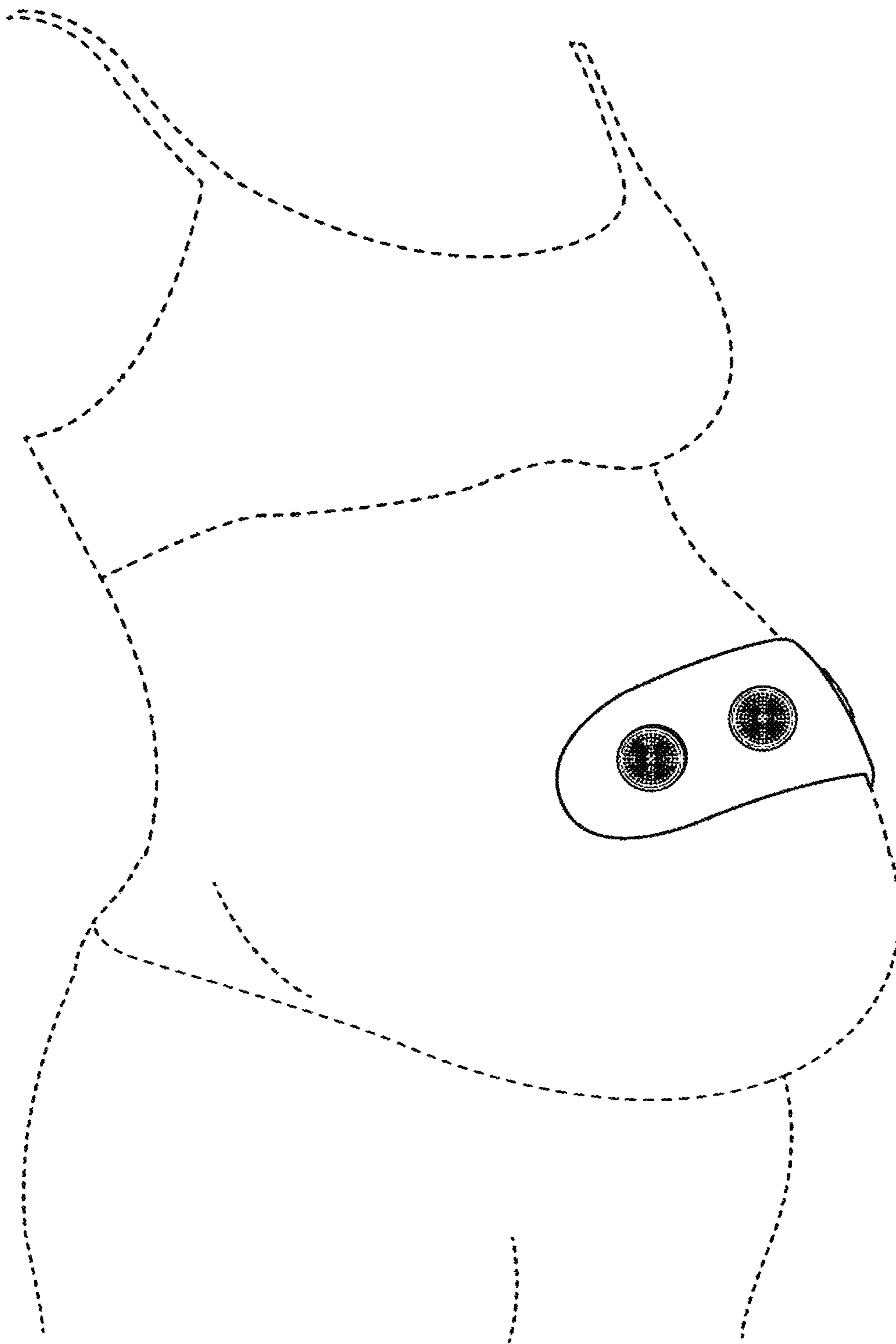
