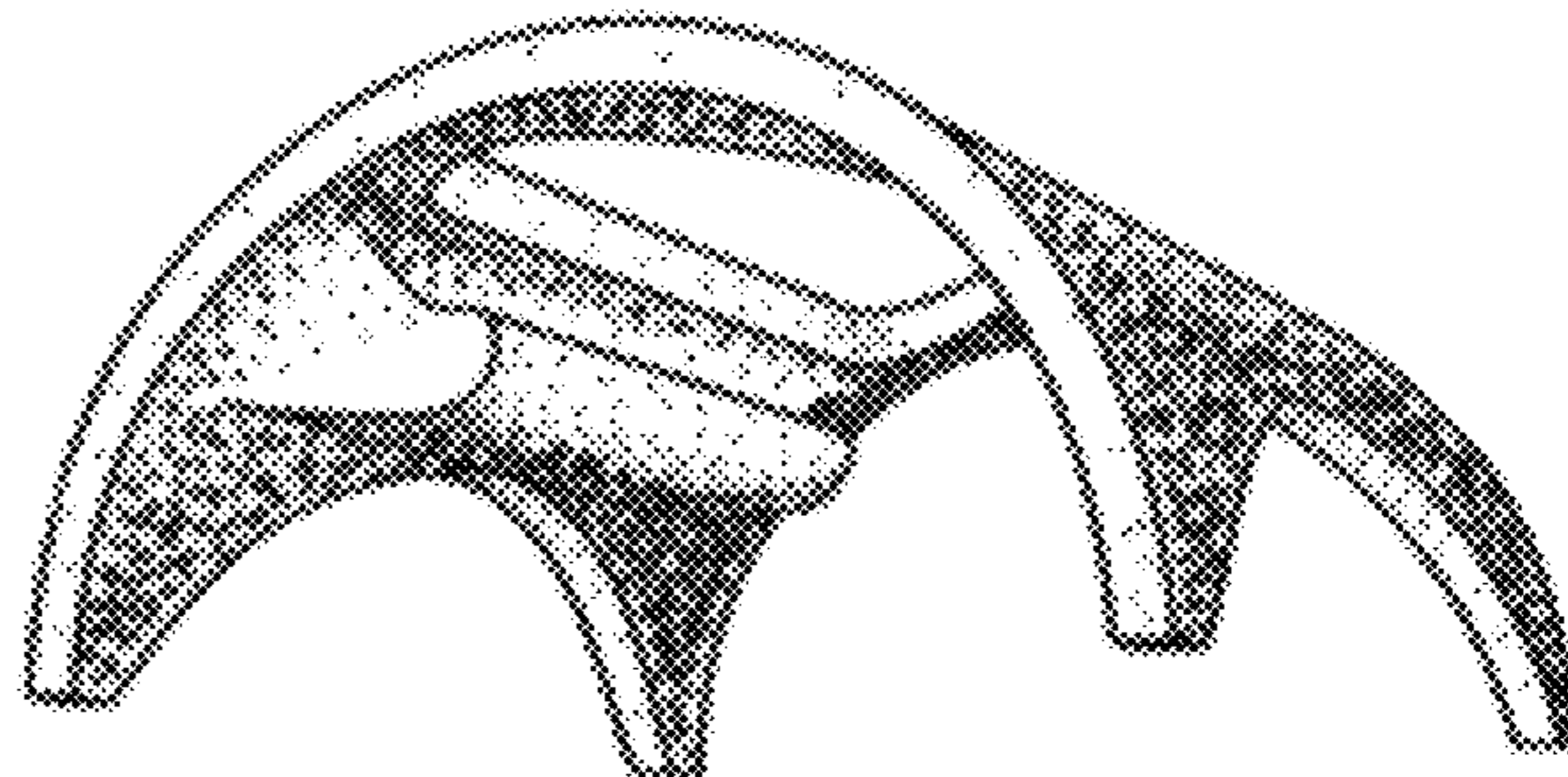
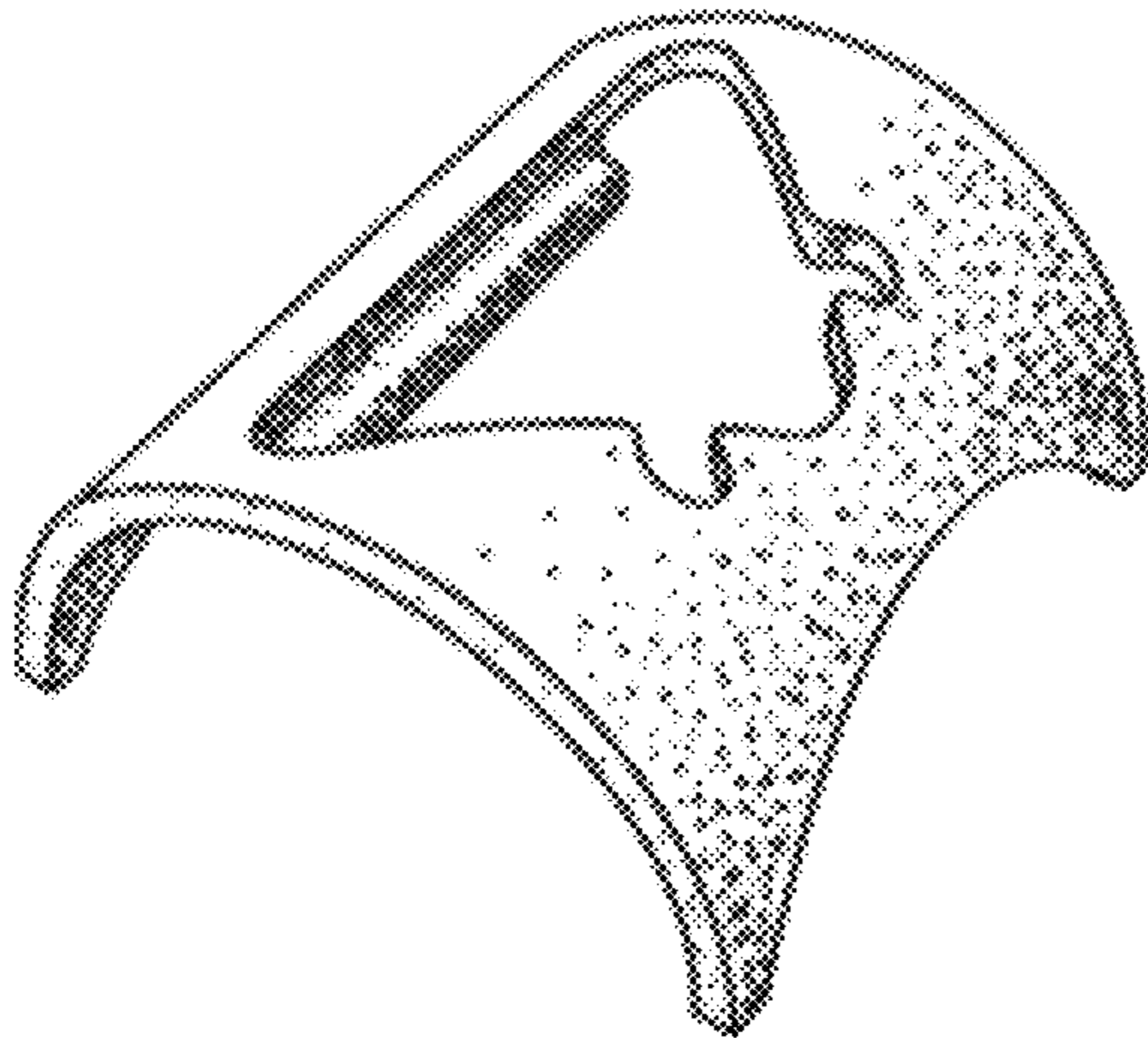

The ornamental design for a stand to hold a portable device, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the stand to hold a portable device
FIG. 2 is a rear view of the stand to hold a portable device
FIG. 3 is a right side view of the stand to hold a portable device; the left side view is a mirror image of the right side view
FIG. 4 is a top view of the stand to hold a portable device
FIG. 5 is a bottom view of the stand to hold a portable device
FIG. 6 is a top, right rear perspective view of the stand to hold a portable device; and,
FIG. 7. is a bottom, right rear perspective view of the stand to hold a portable device.

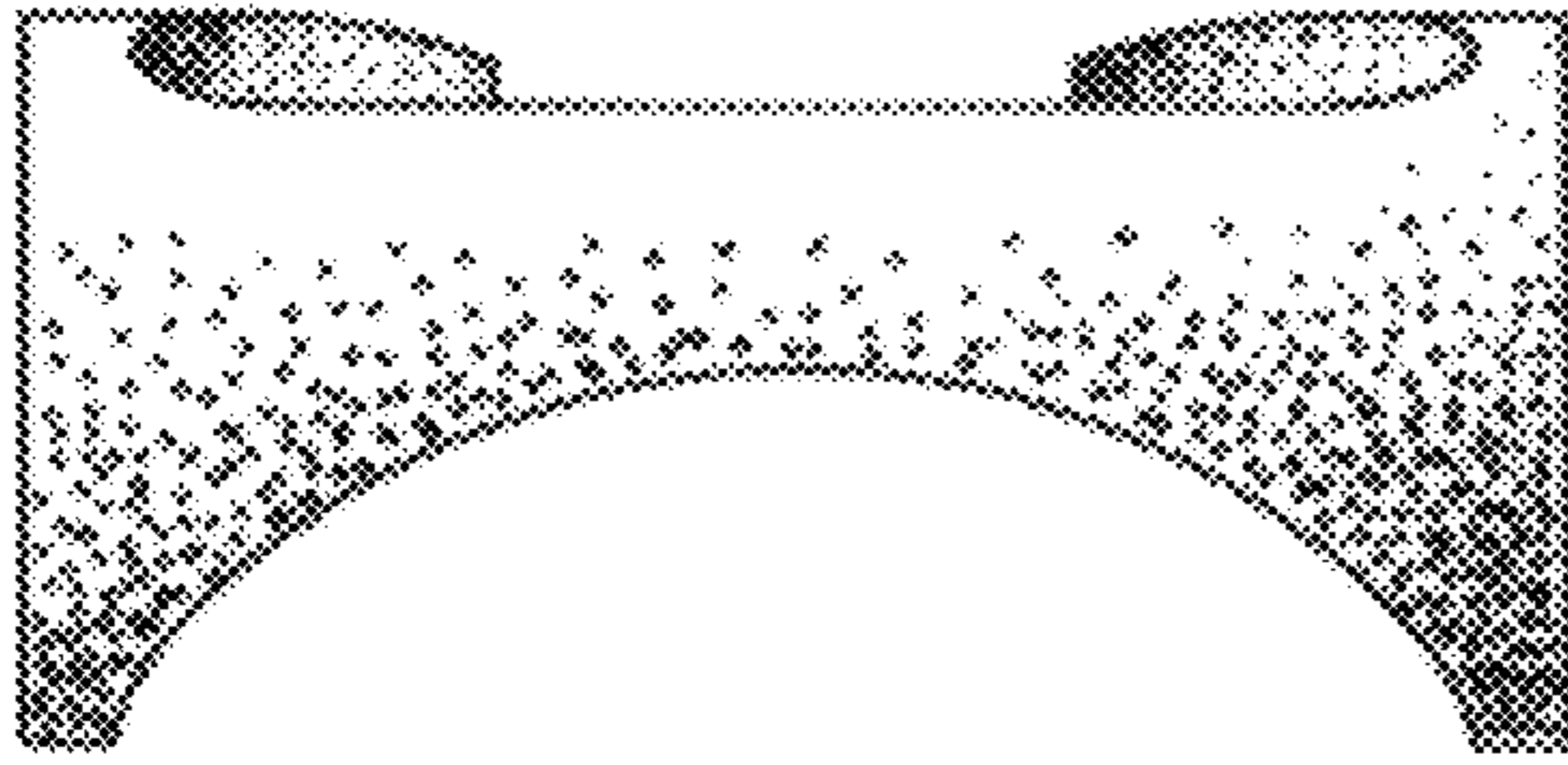

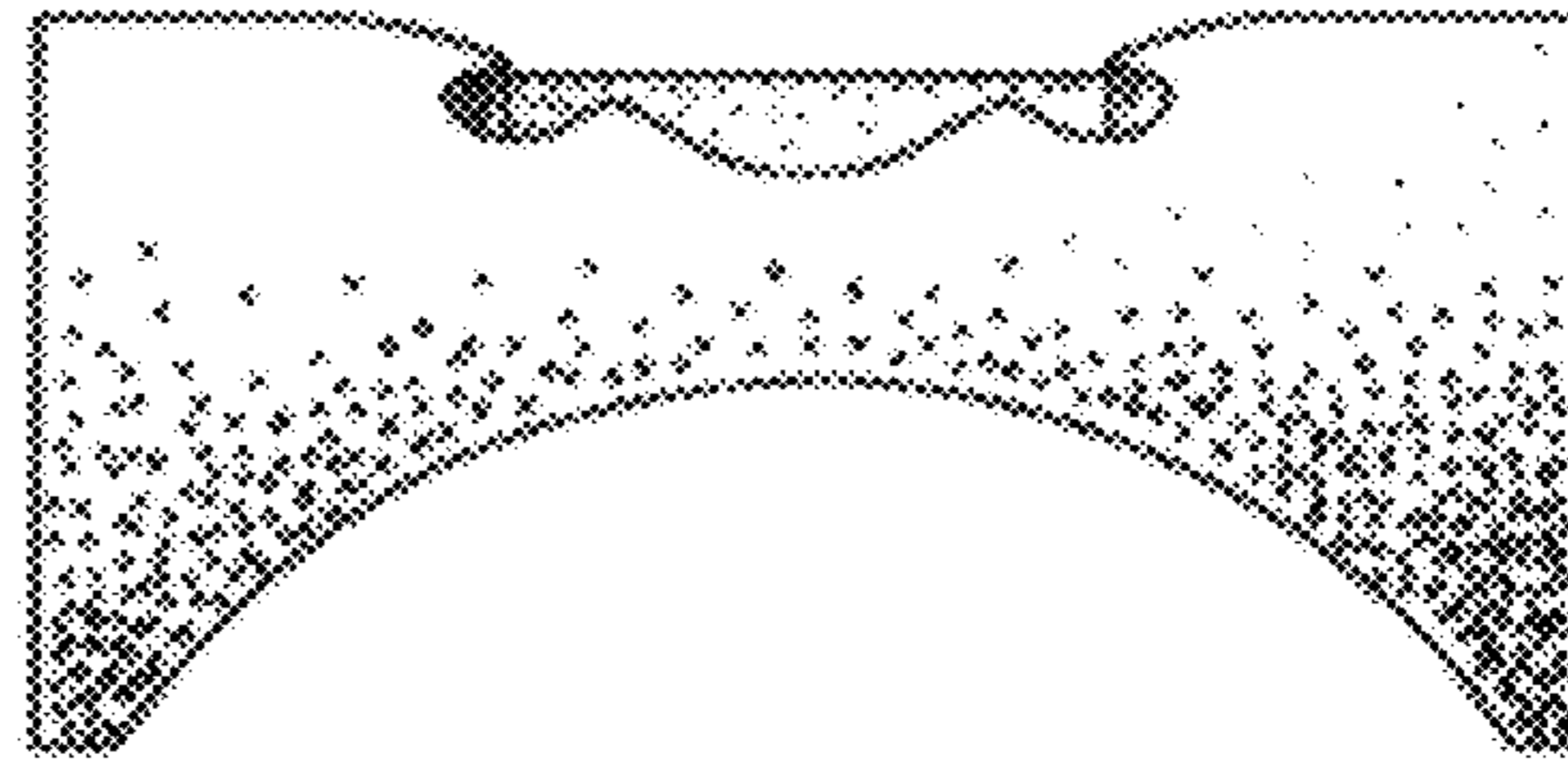

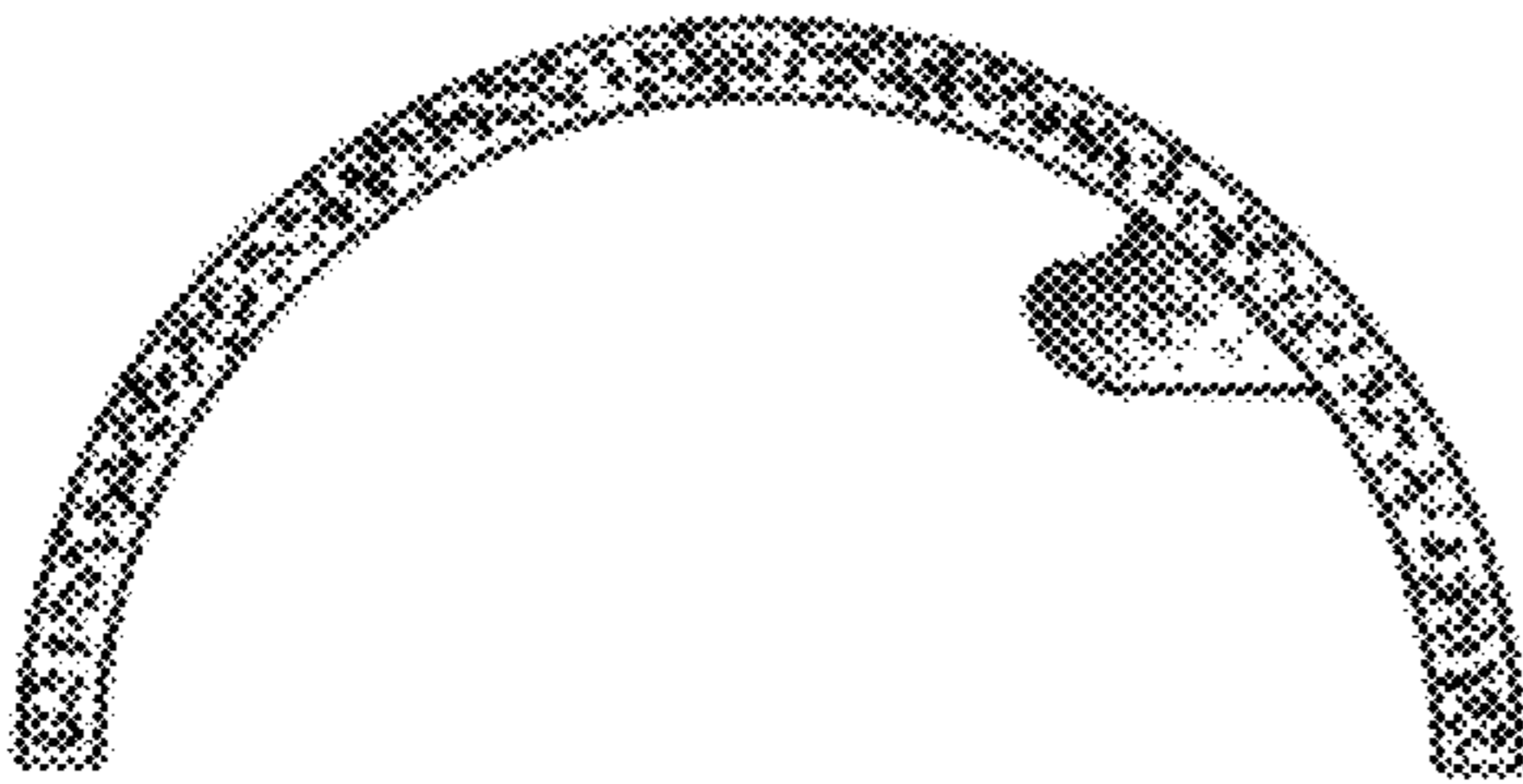

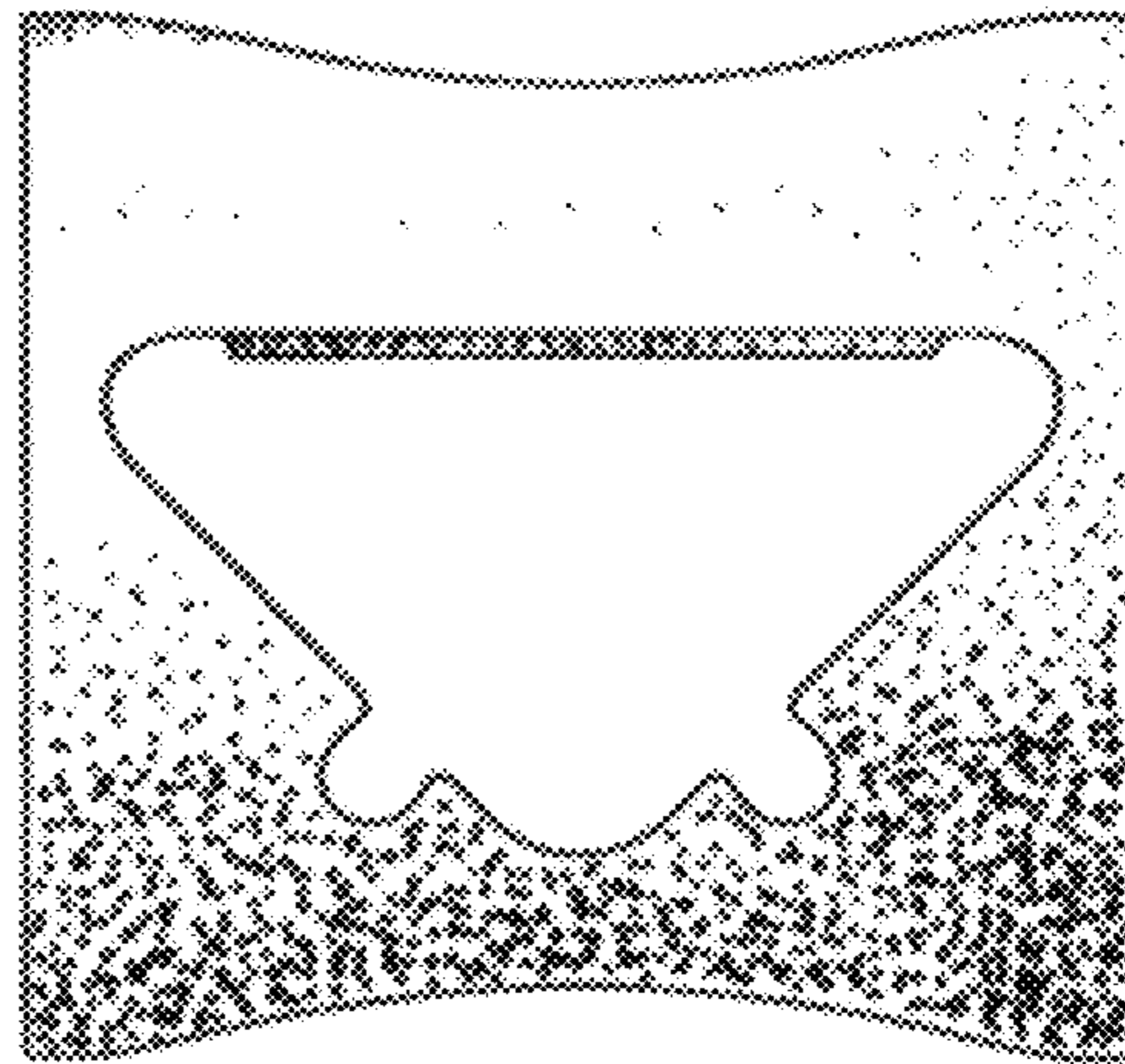

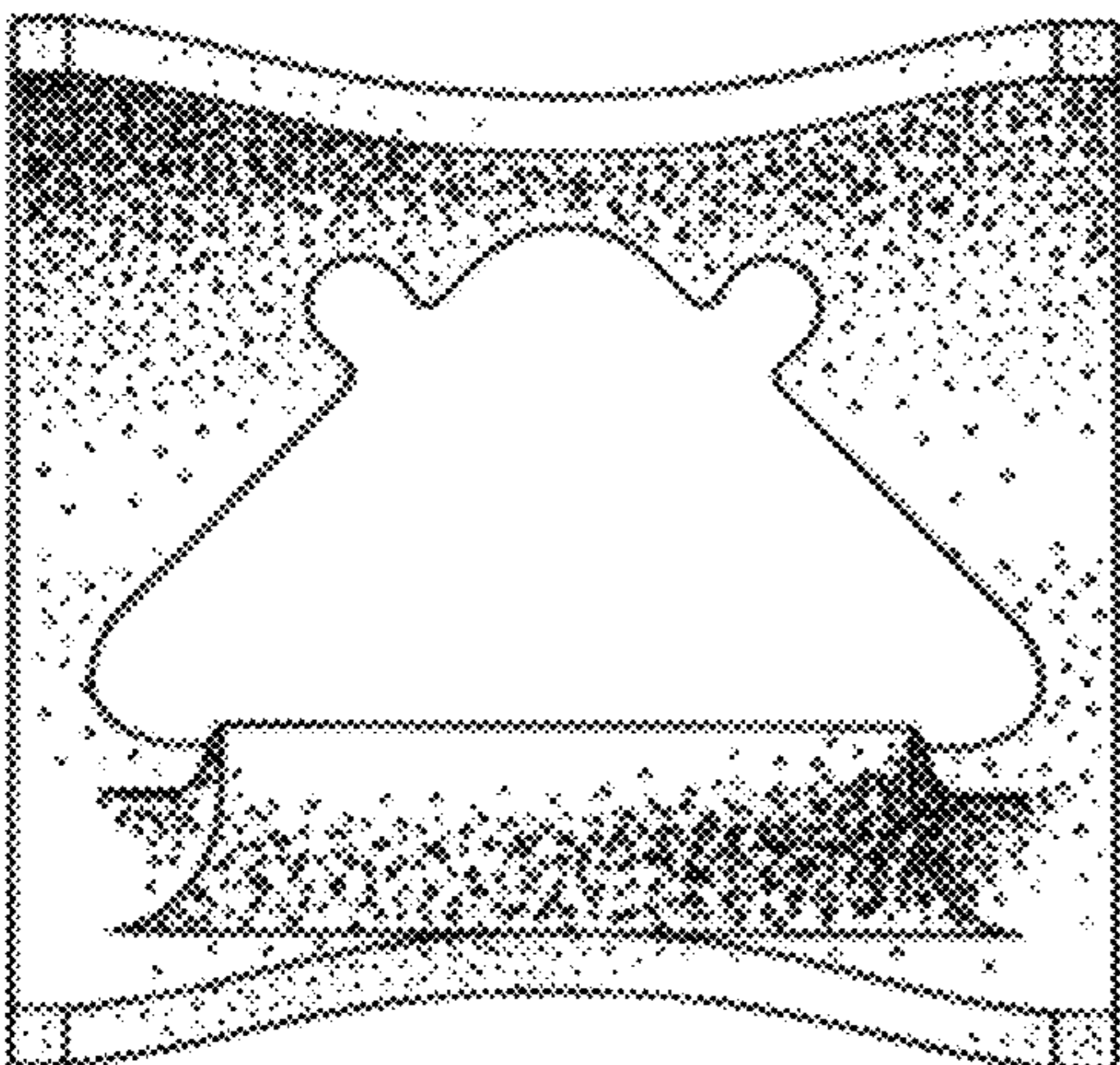

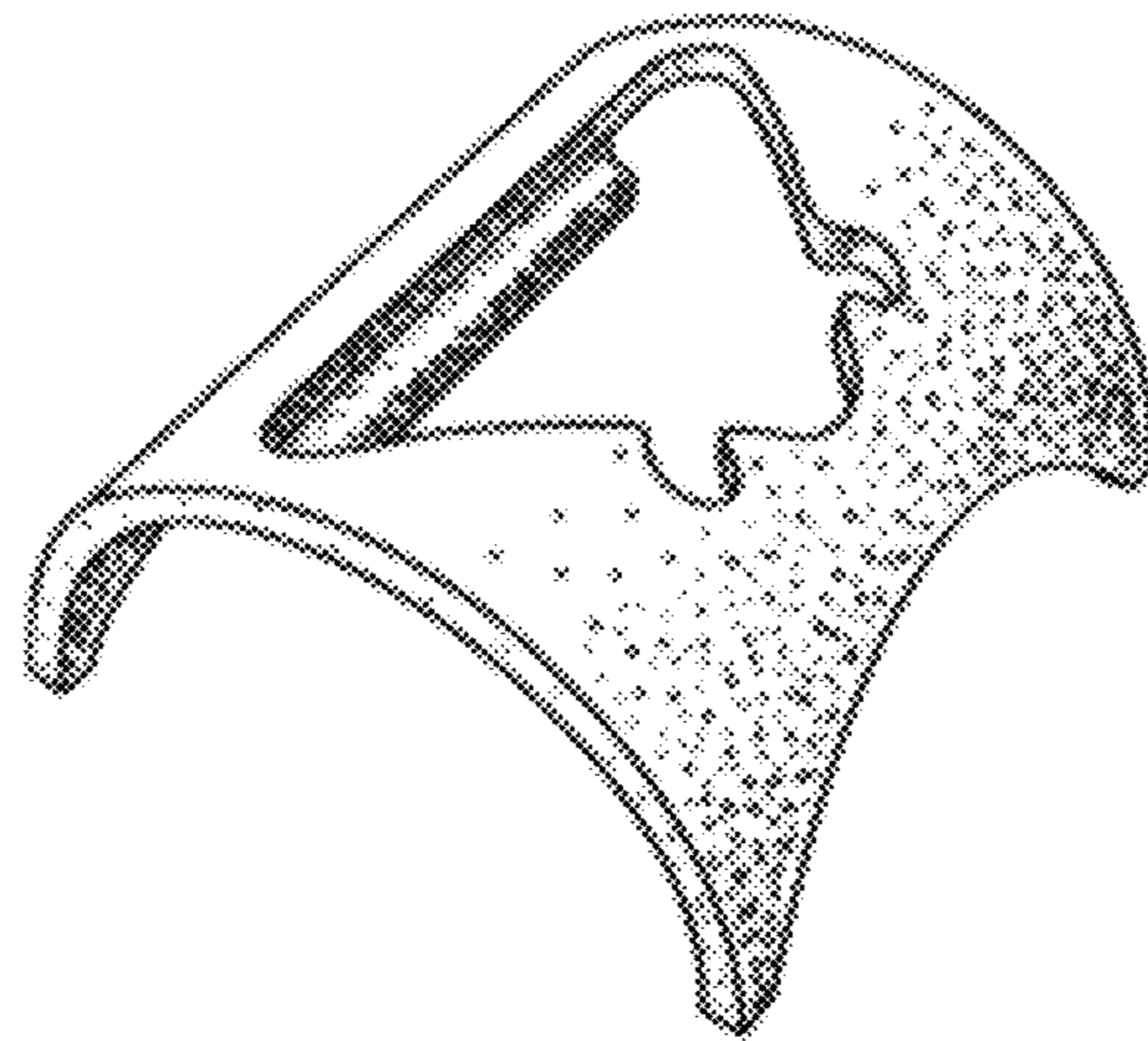

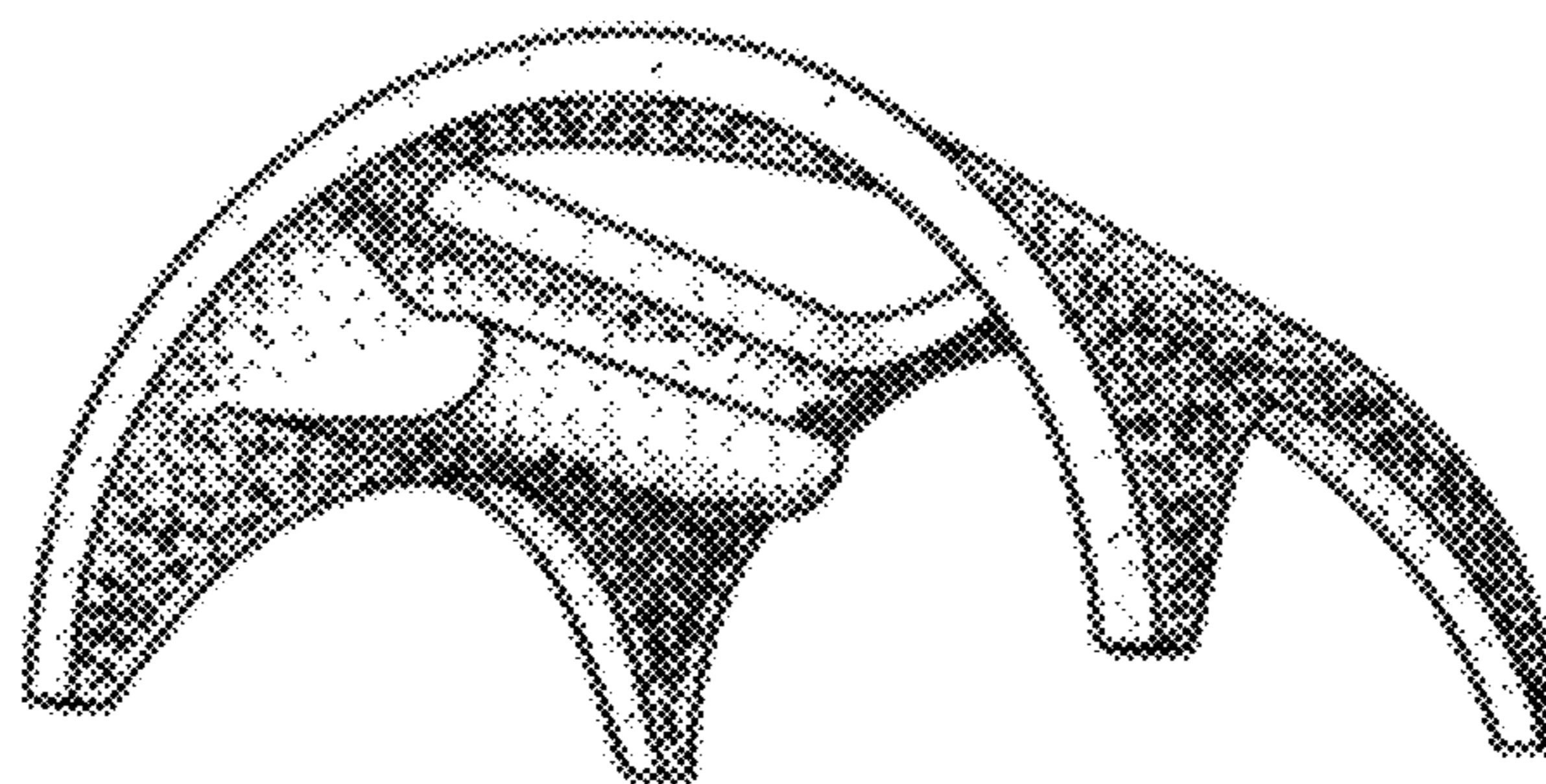
