(57) **CLAIM**

The ornamental design for display screen or portion thereof with animated graphical user interface, substantially as shown and described.

**DESCRIPTION**

FIG. 6 is a sixth image thereof;

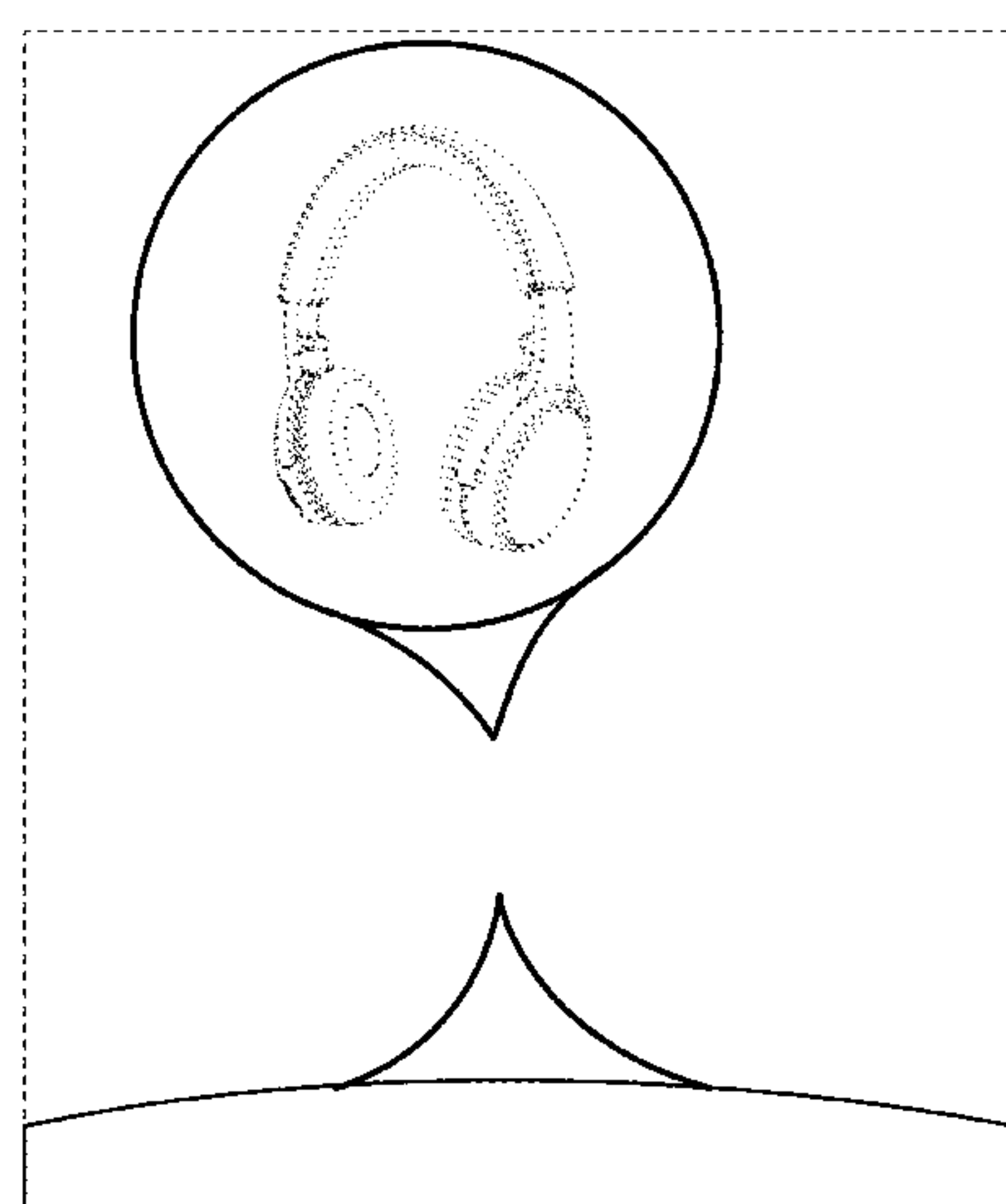
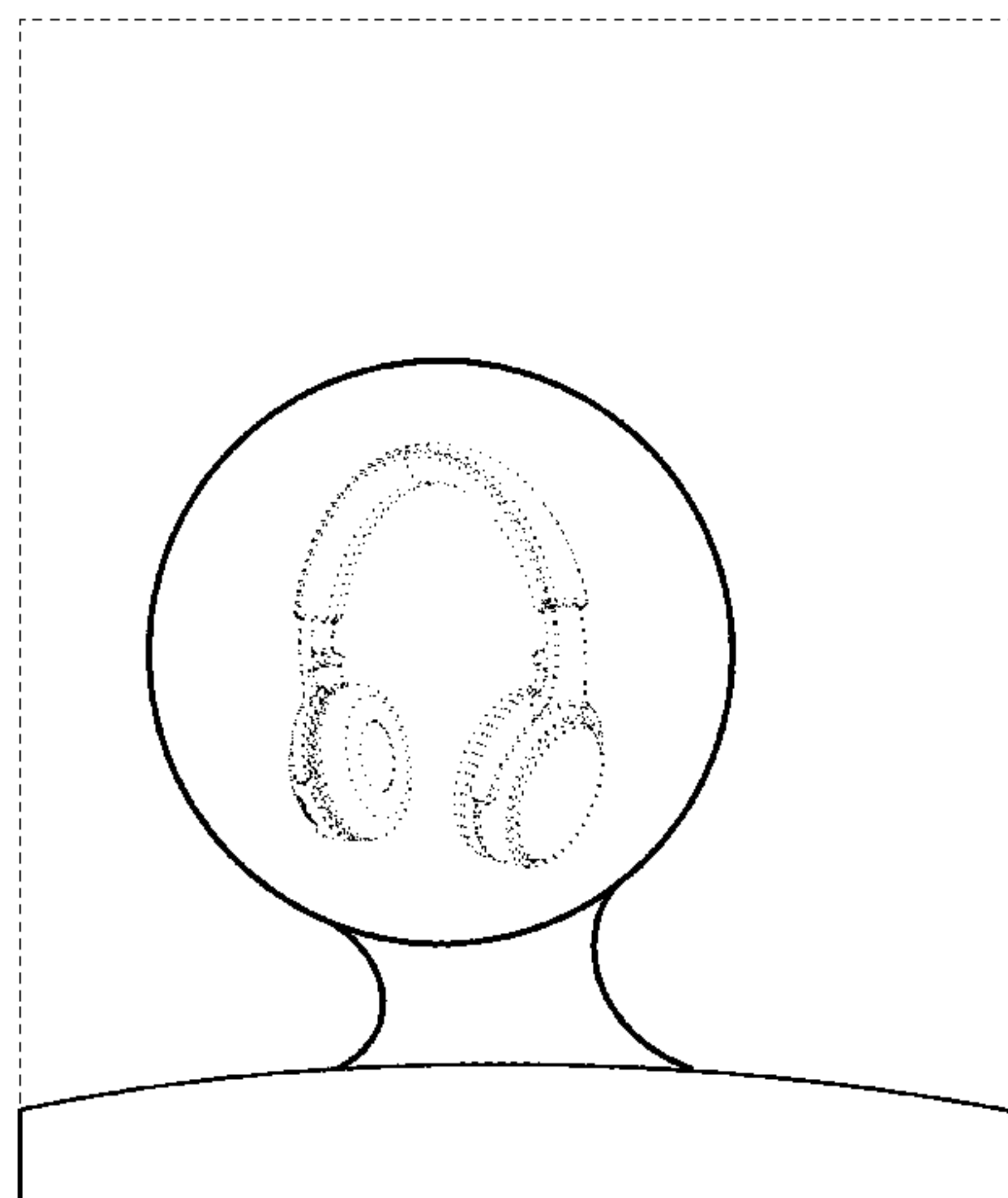
FIG. 7 is a seventh image thereof; and,

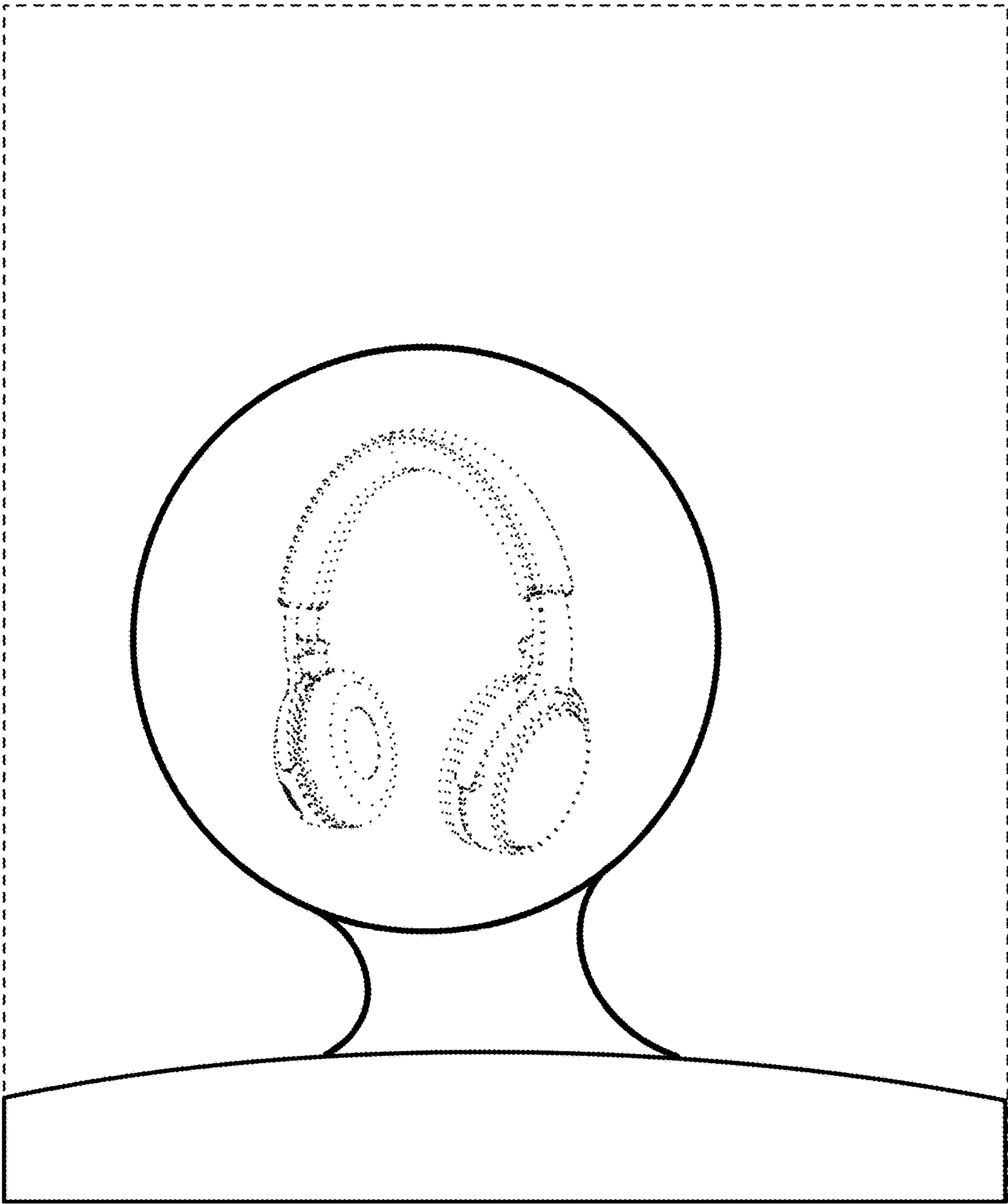

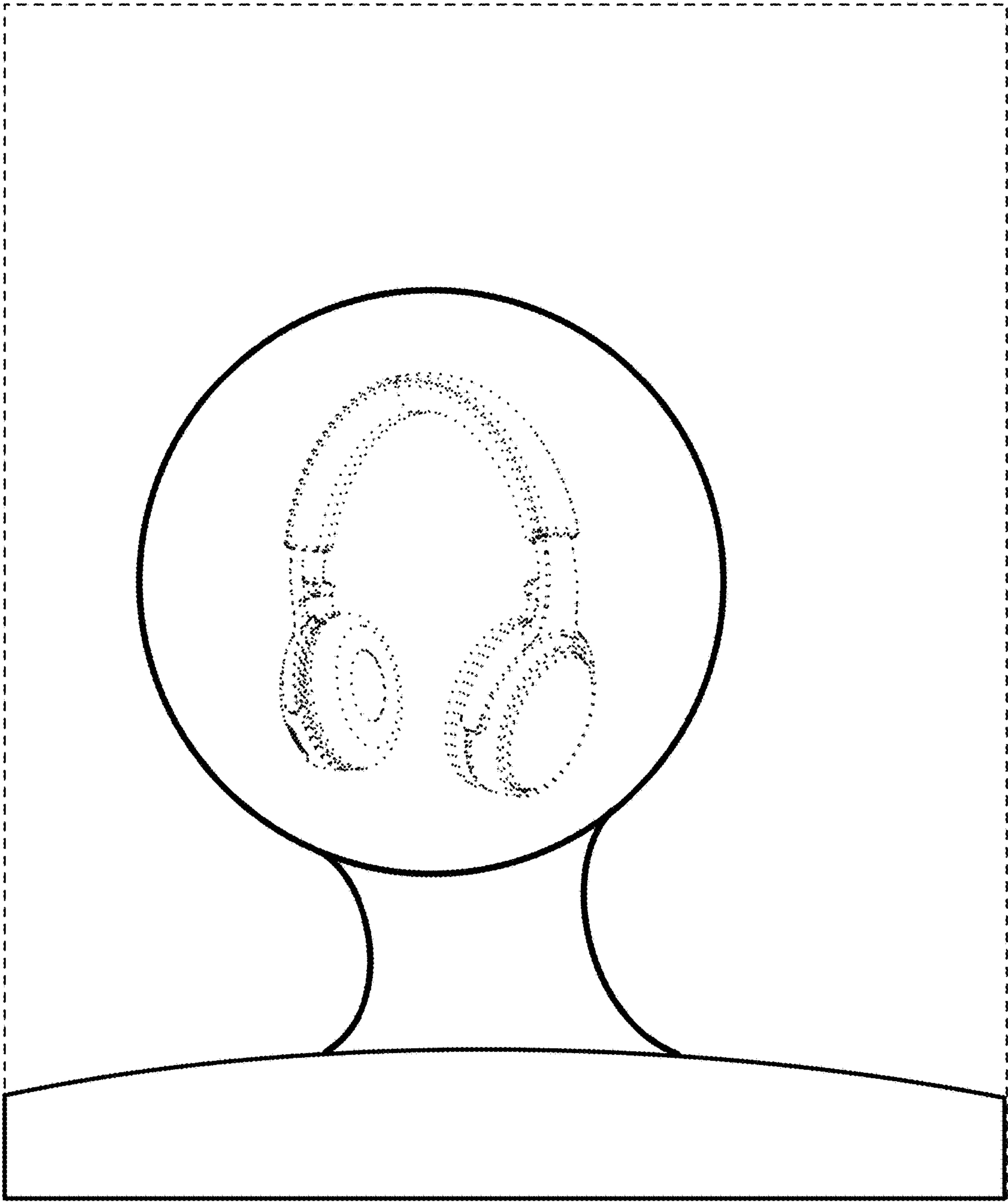

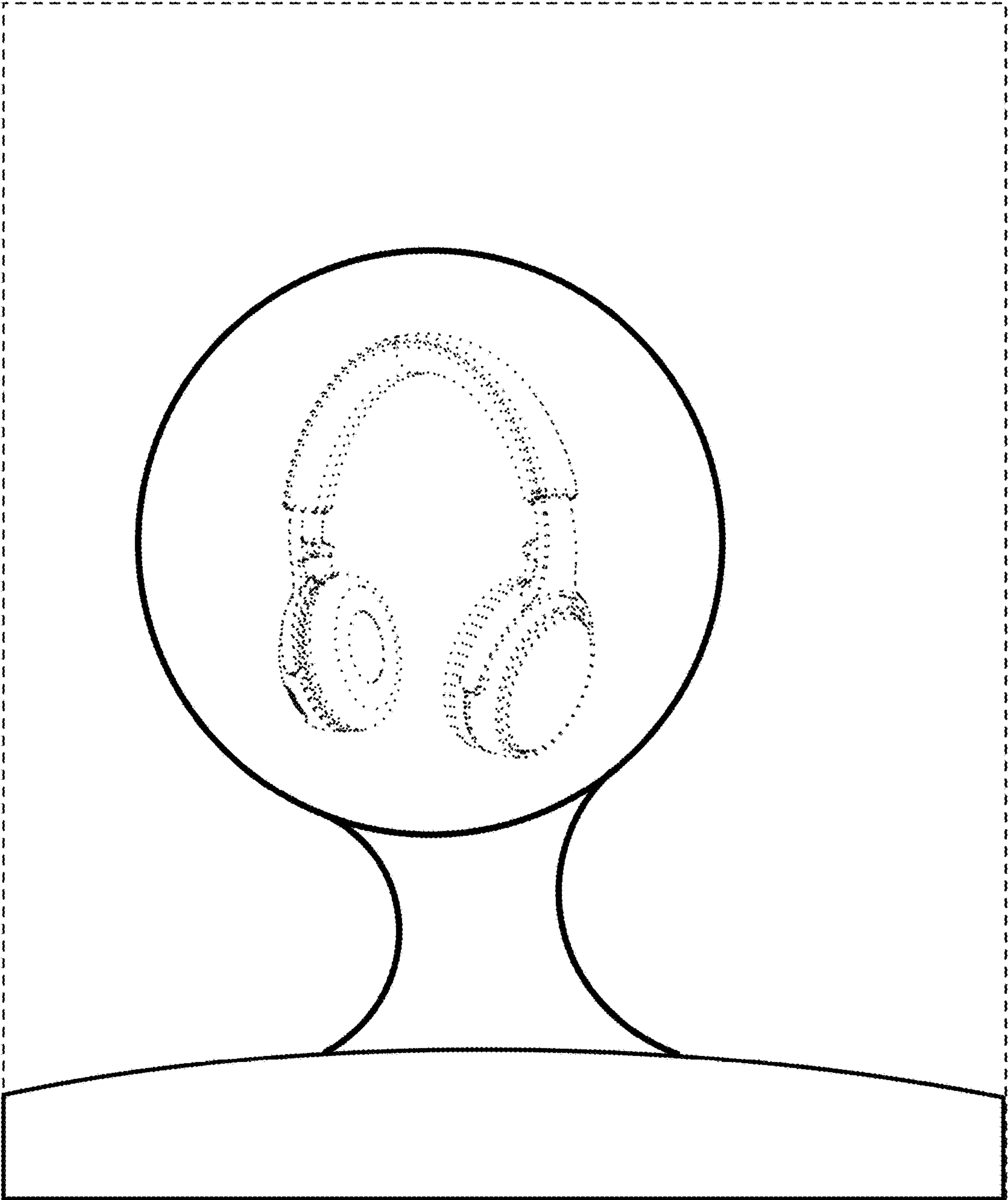

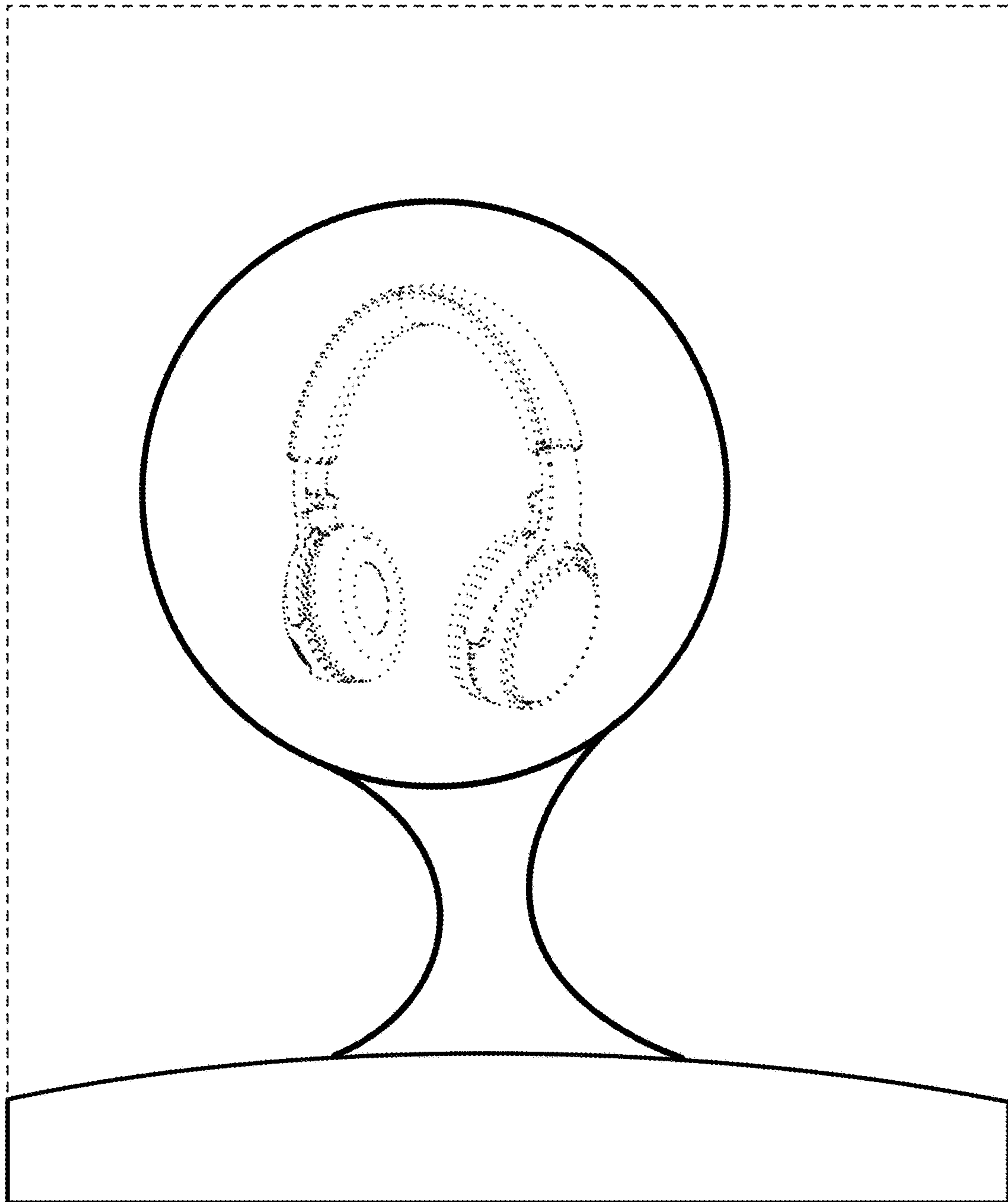

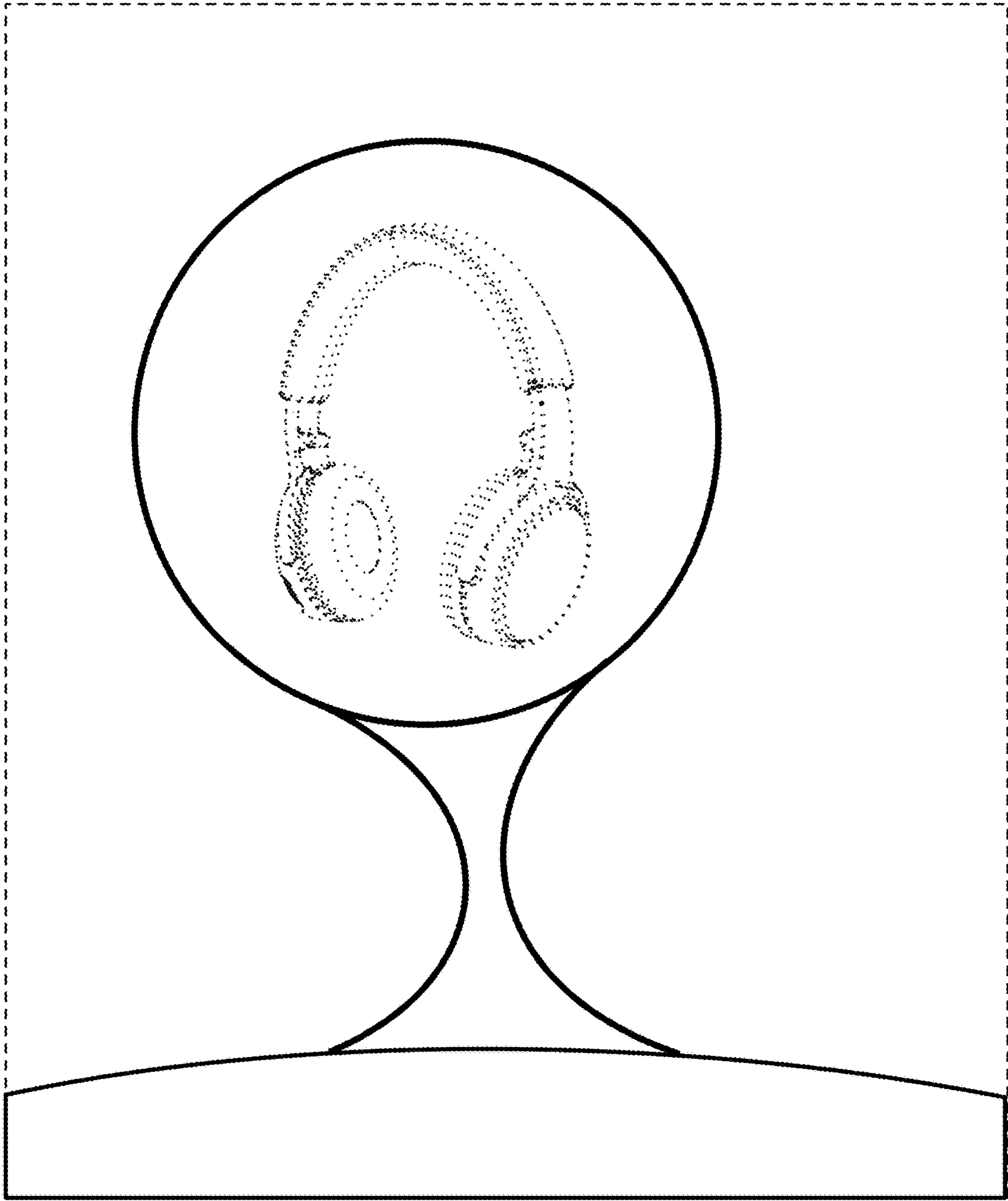

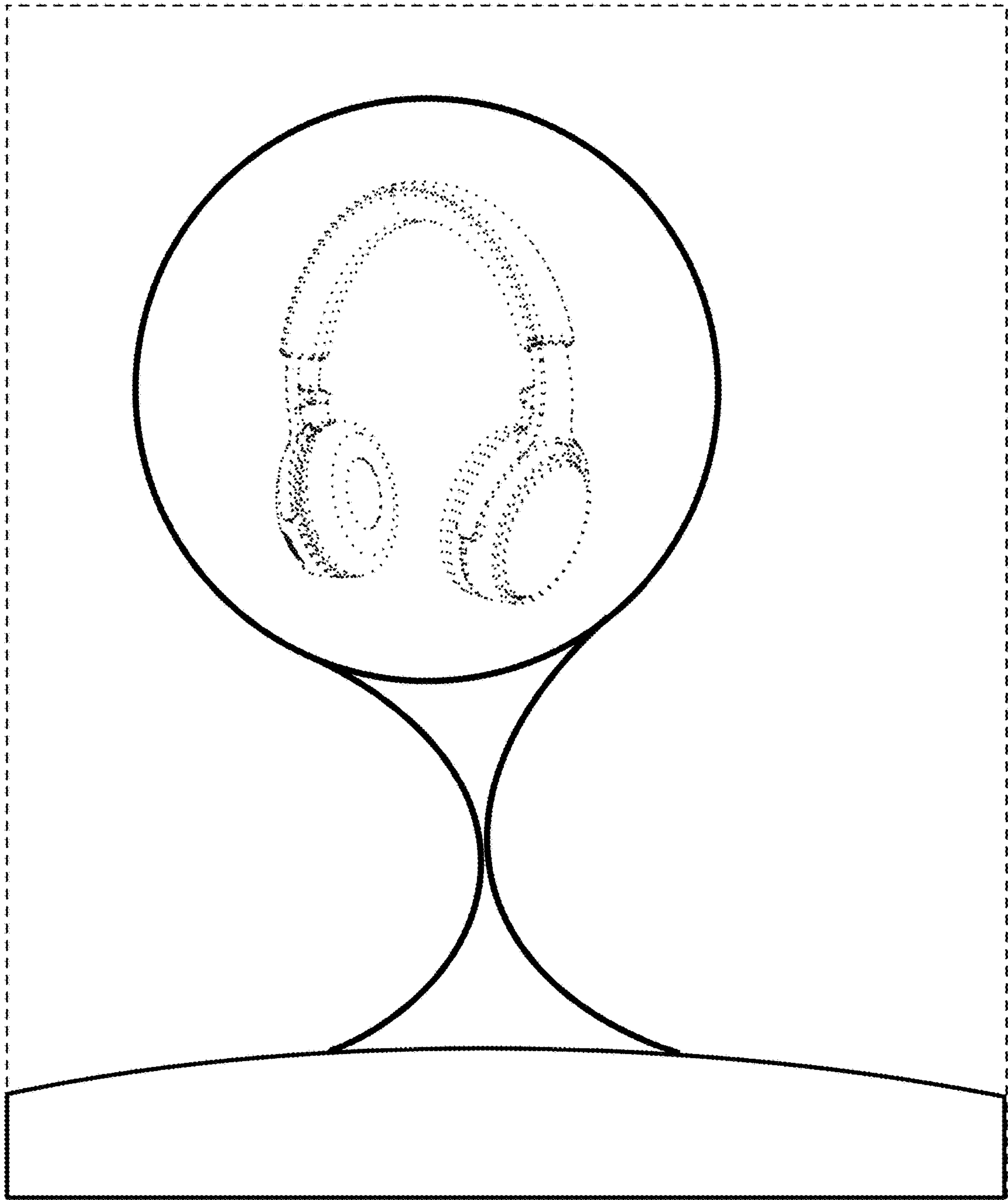

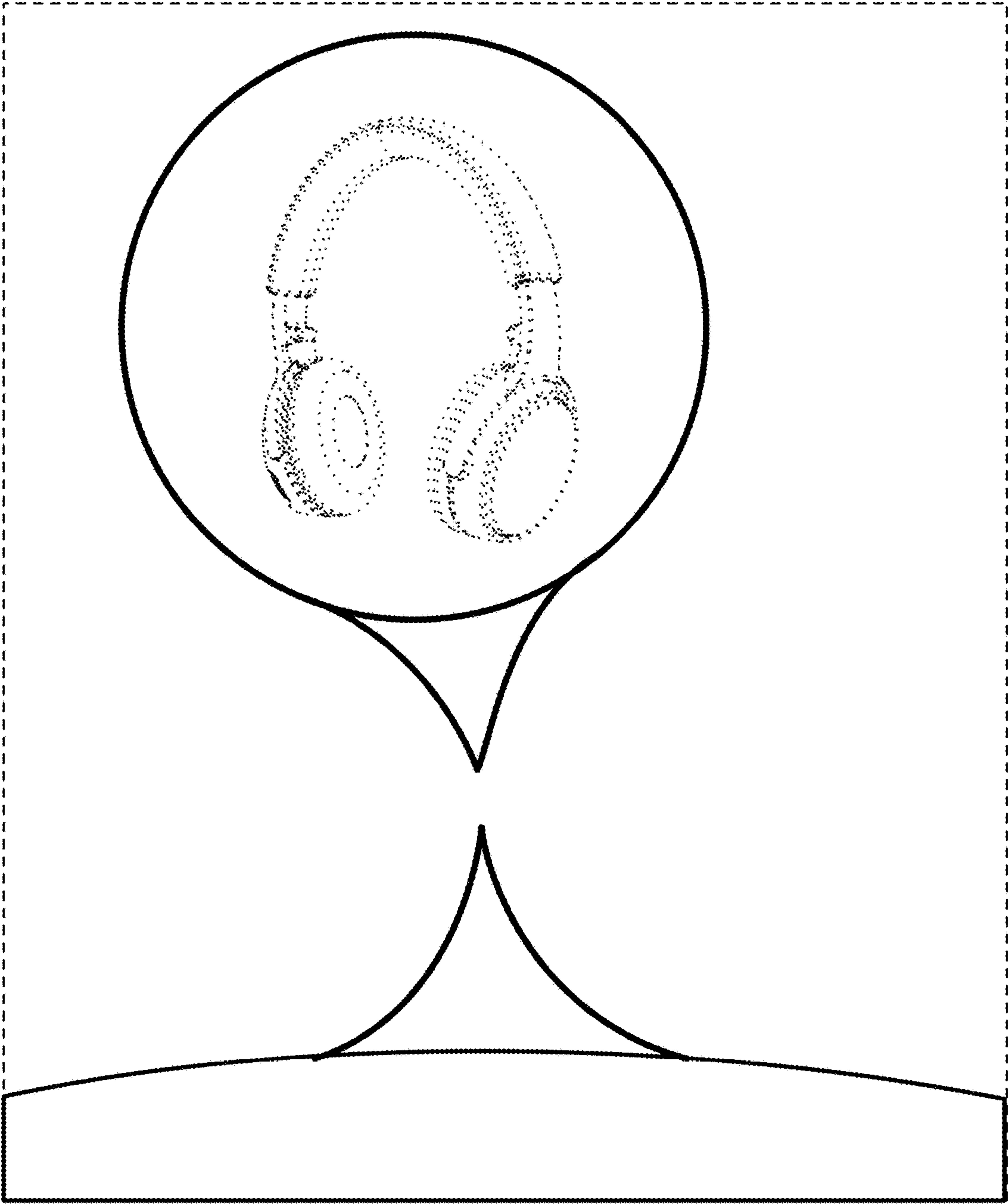

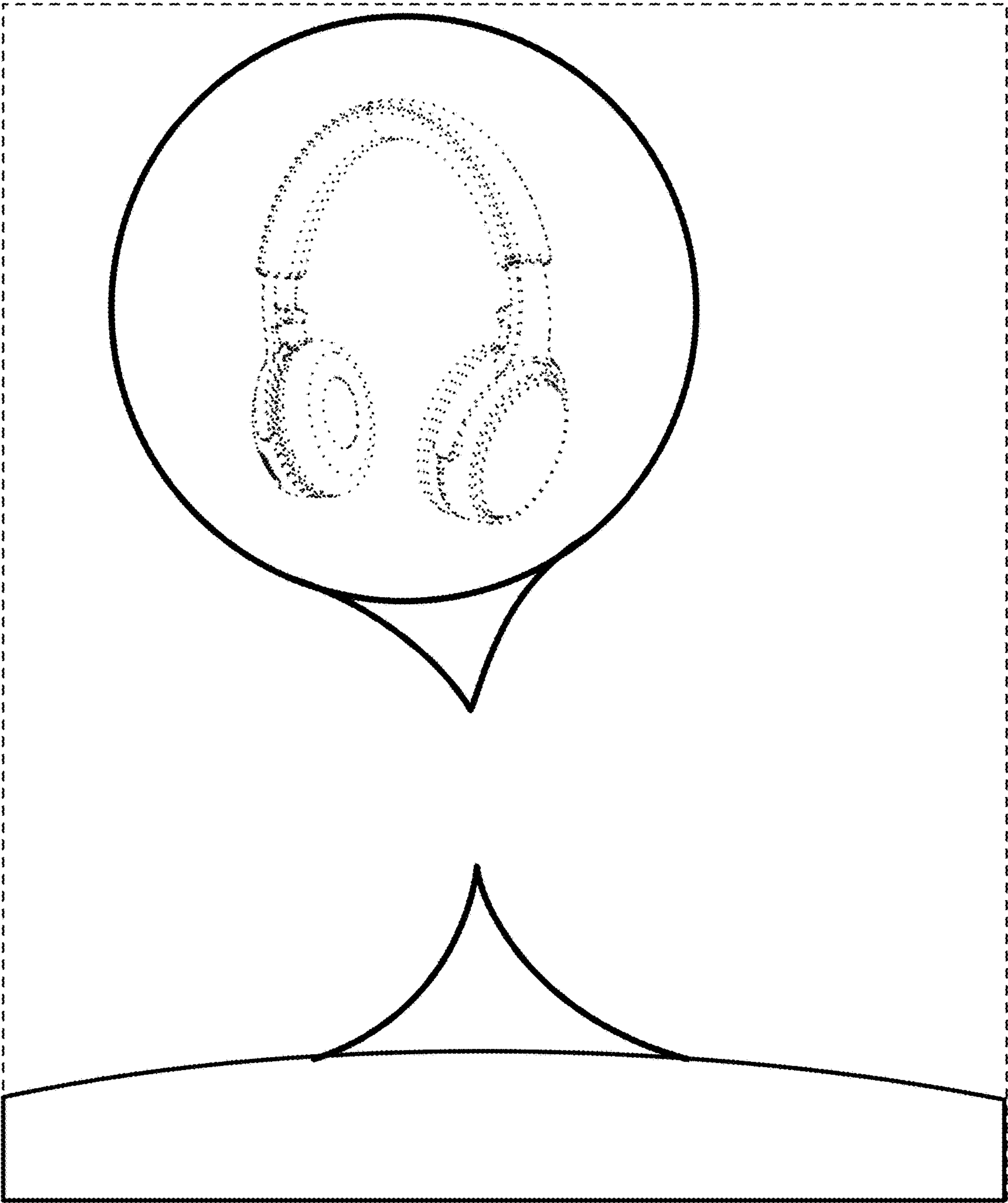
