(57) **CLAIM**

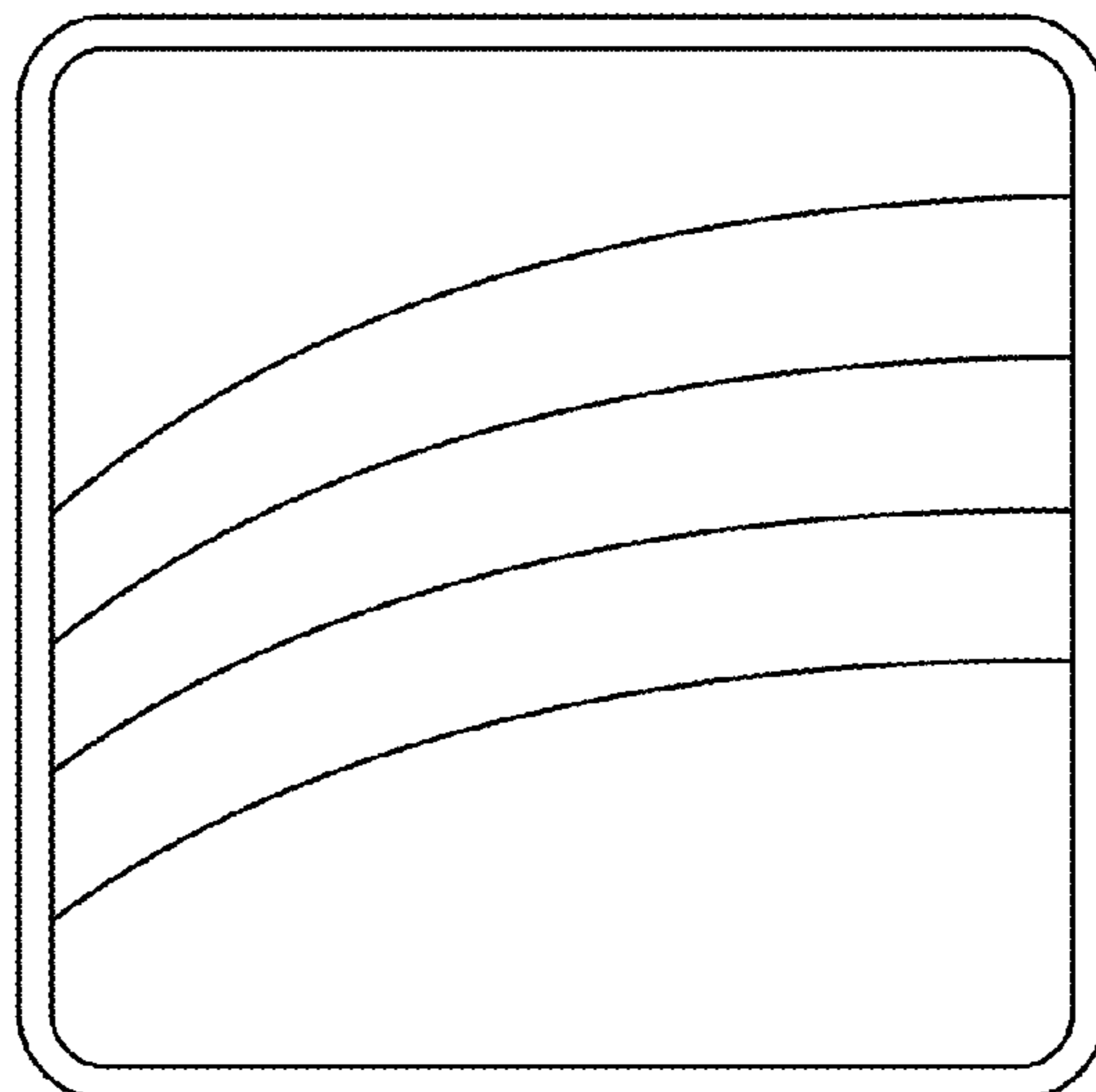
The ornamental design for an office machine display screen with graphical user interface including a color function icon, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an office machine display screen with graphical user interface including a color function icon in accordance with the present invention; and, FIG. 2 is a front view of the design shown in FIG. 1, shown enlarged for clarity of illustration.

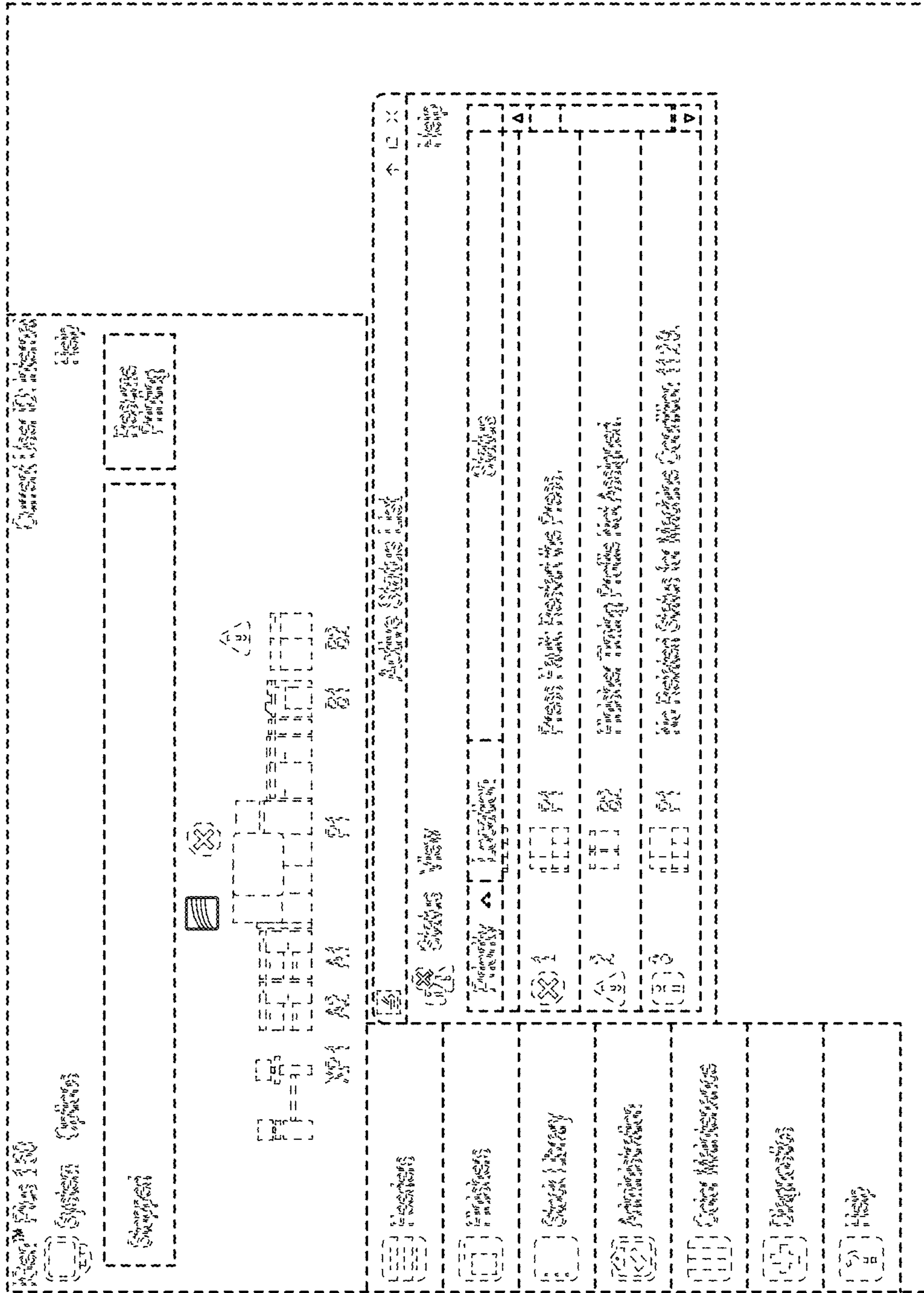

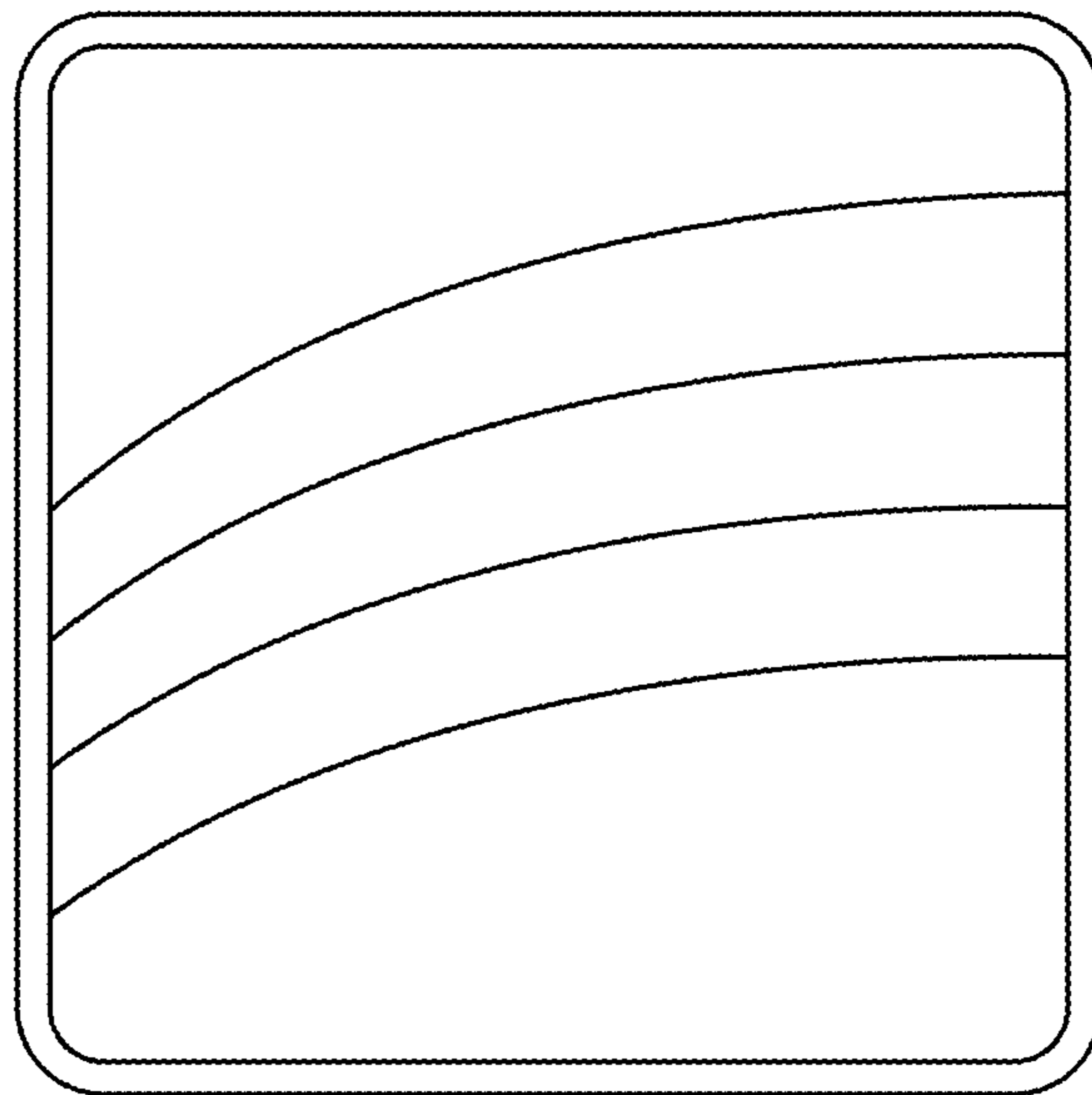
