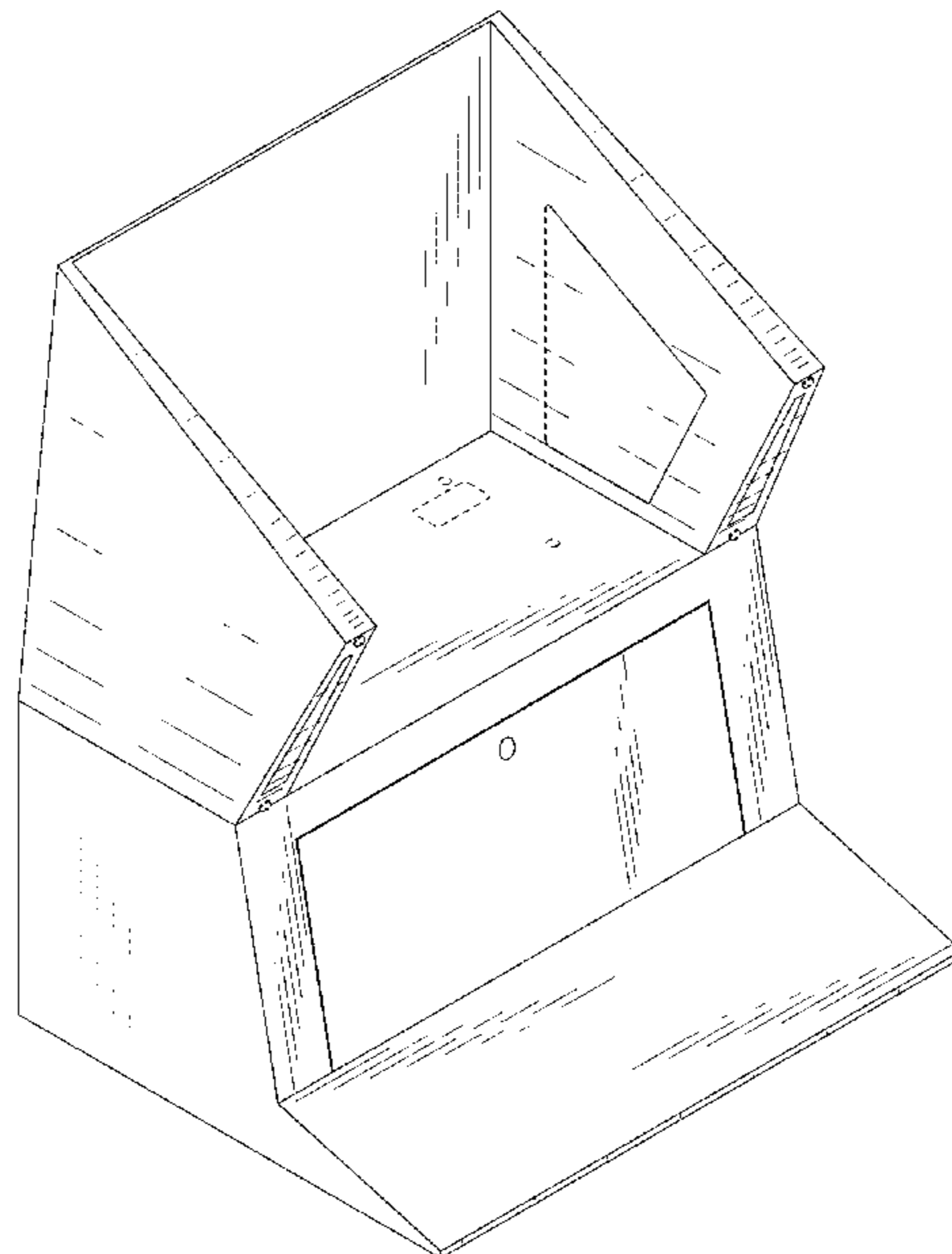
(57) **CLAIM**

The ornamental design for a gaming slot base, as shown and described.

DESCRIPTION

FIG. 1 is a left and top perspective view of a gaming slot base of our new design;
FIG. 2 is a right and top perspective view thereof;
FIG. 3 is a left and bottom perspective view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a left side elevational view thereof;

FIG. 9 is a bottom plan view thereof.

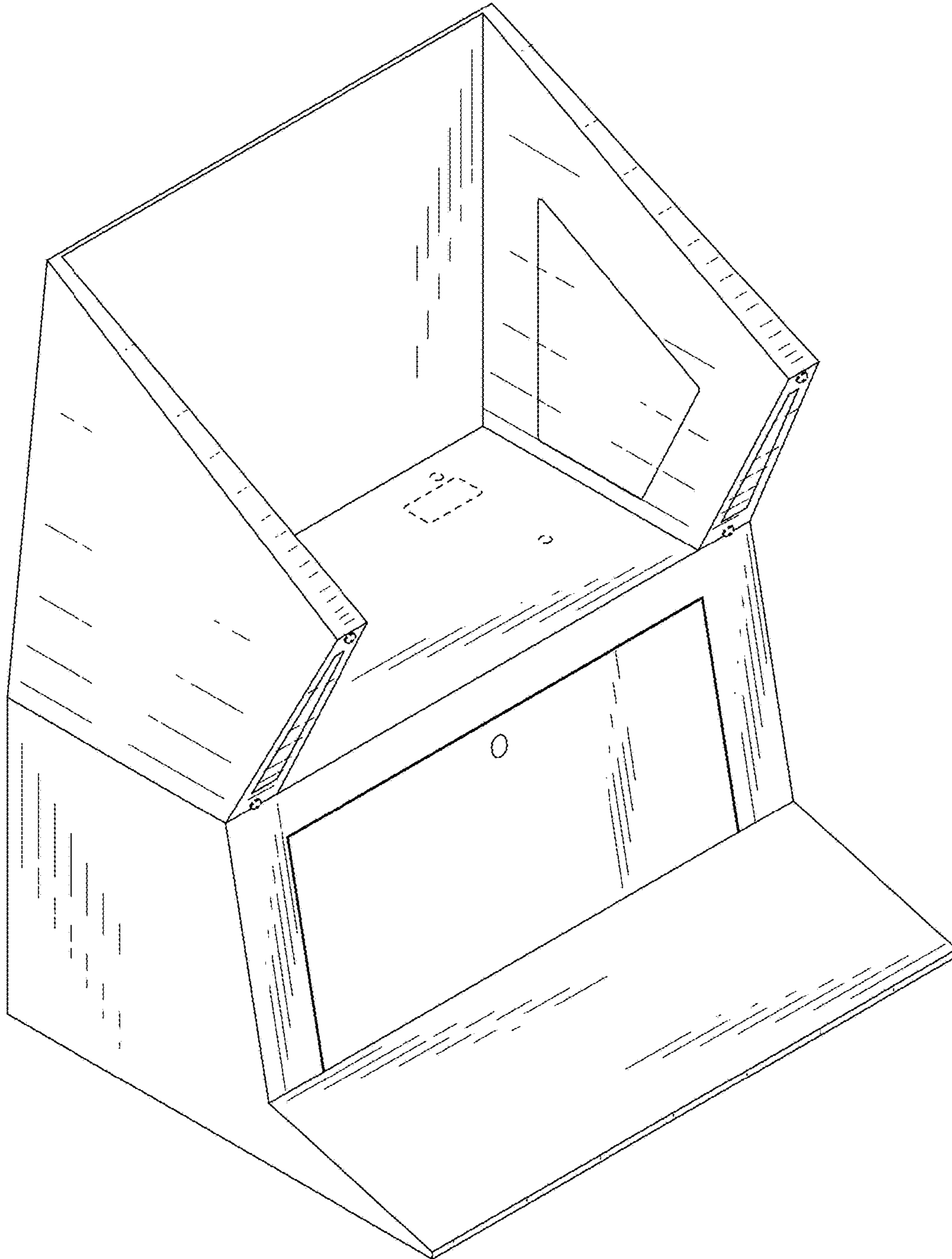

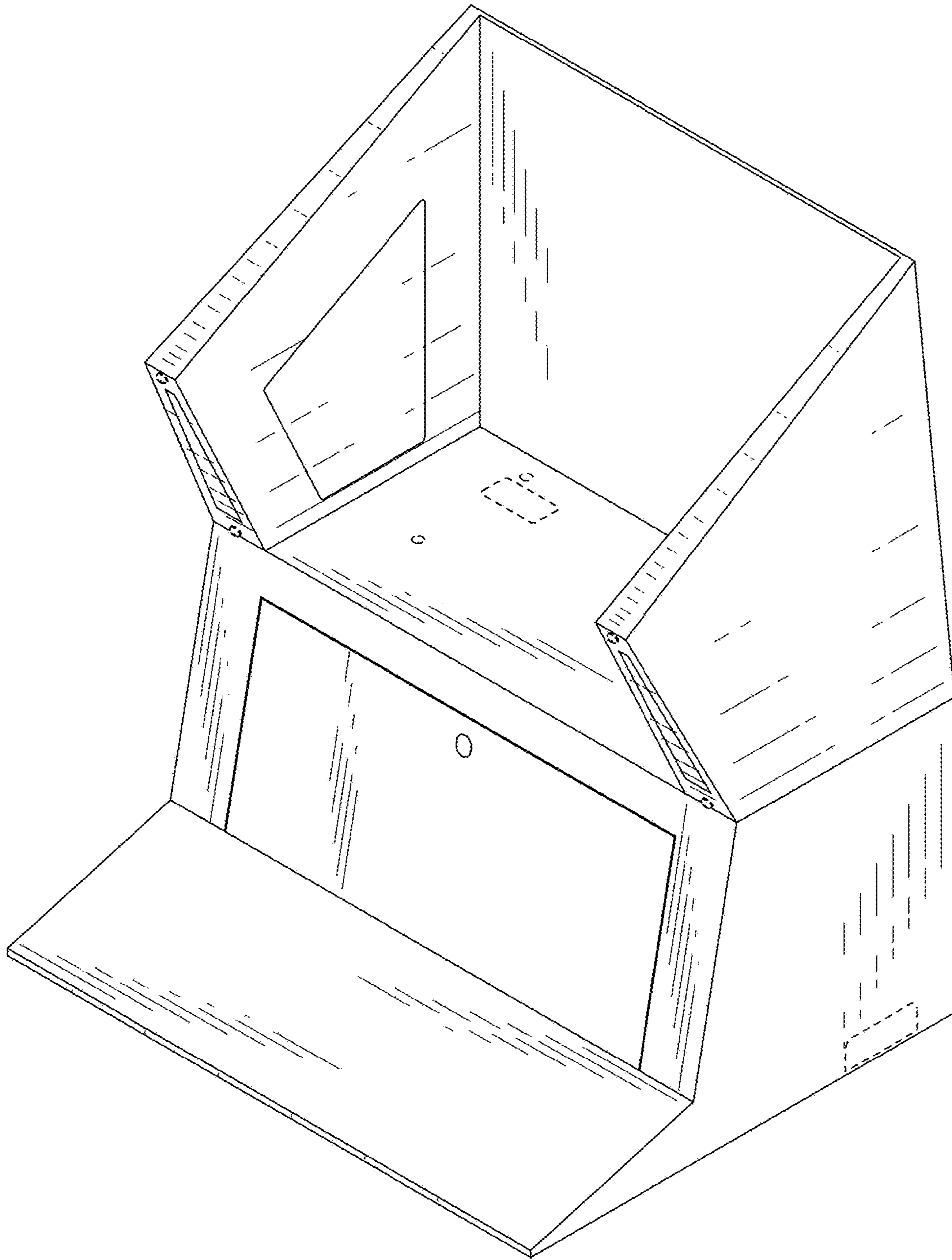

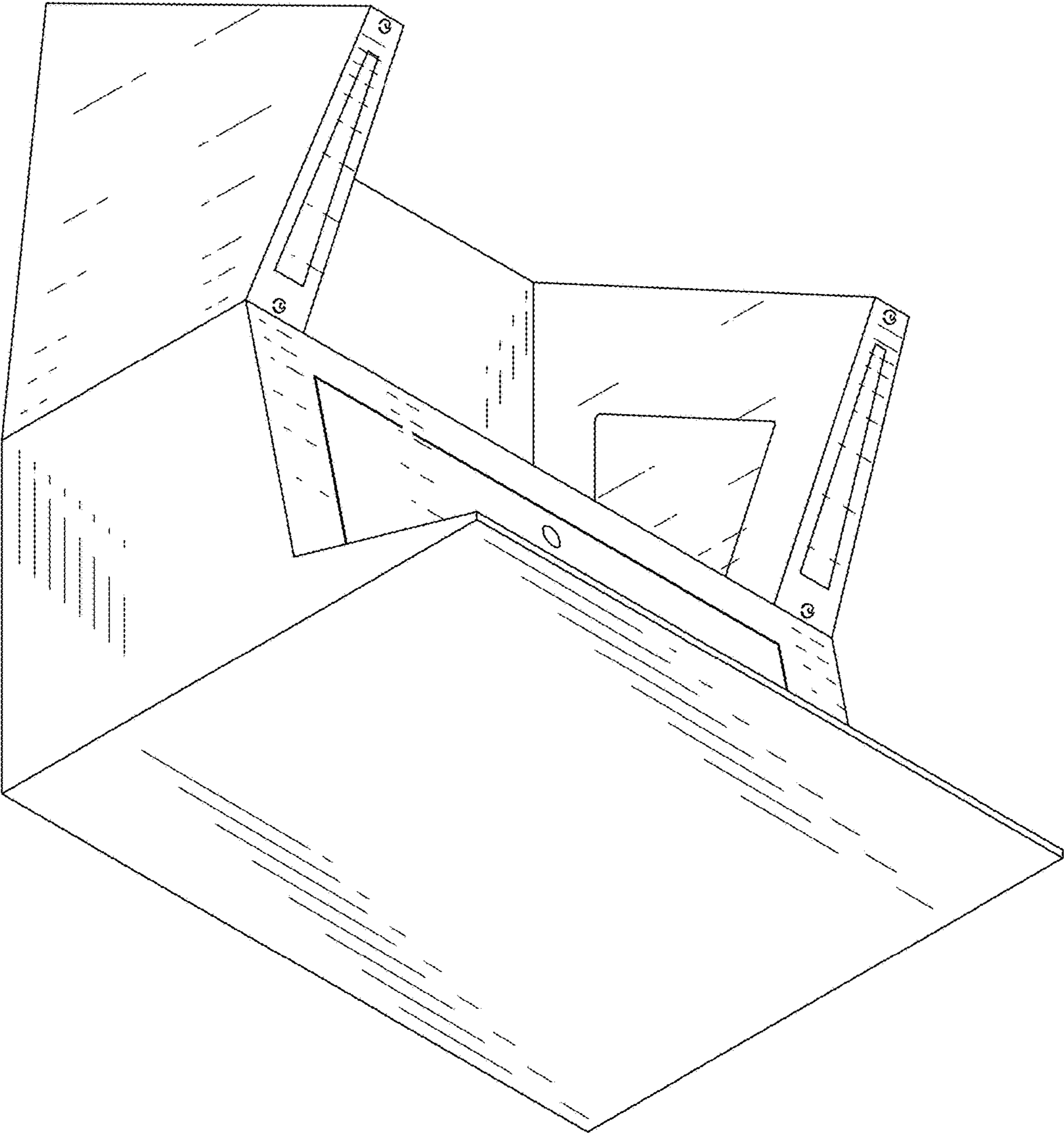

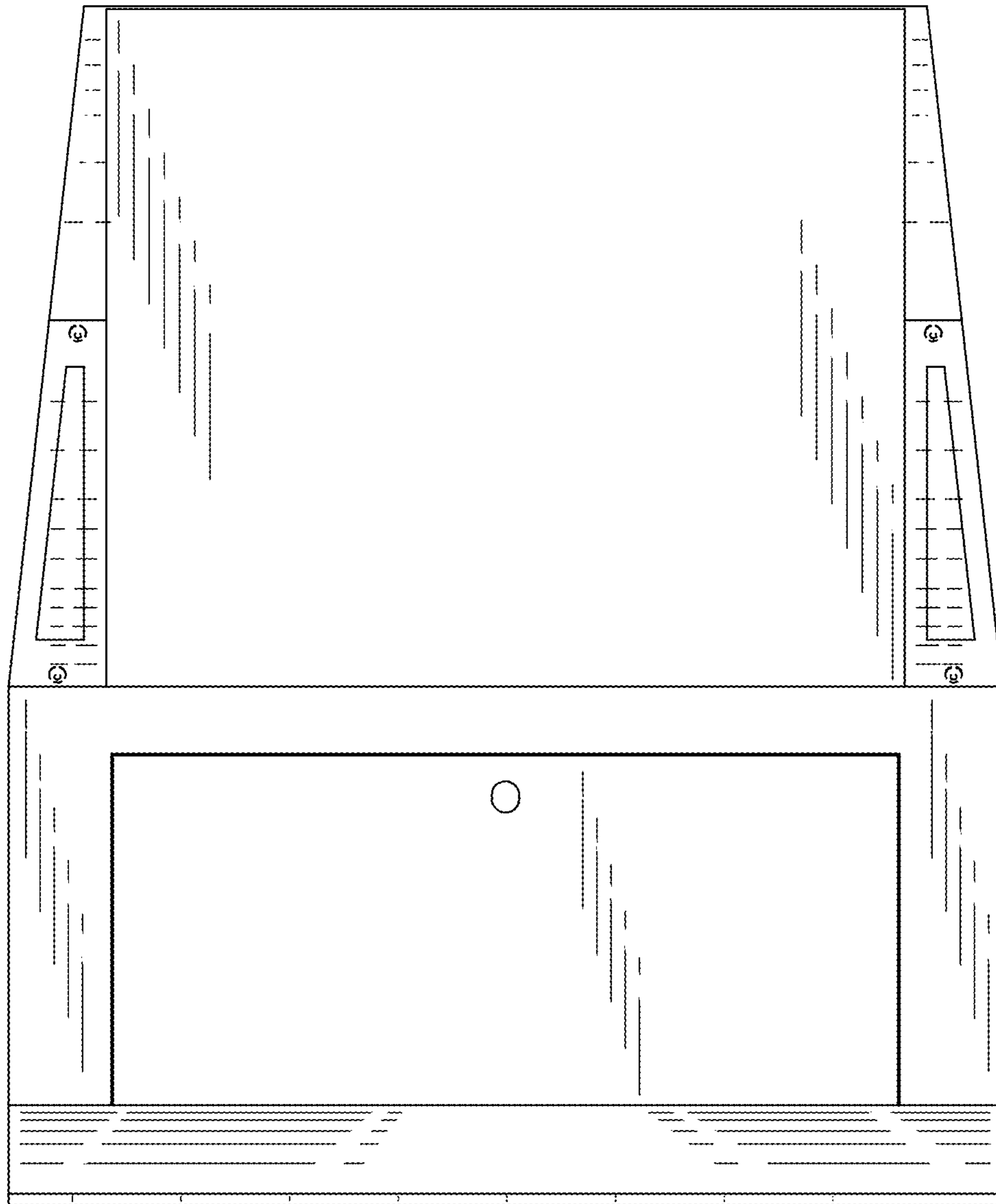

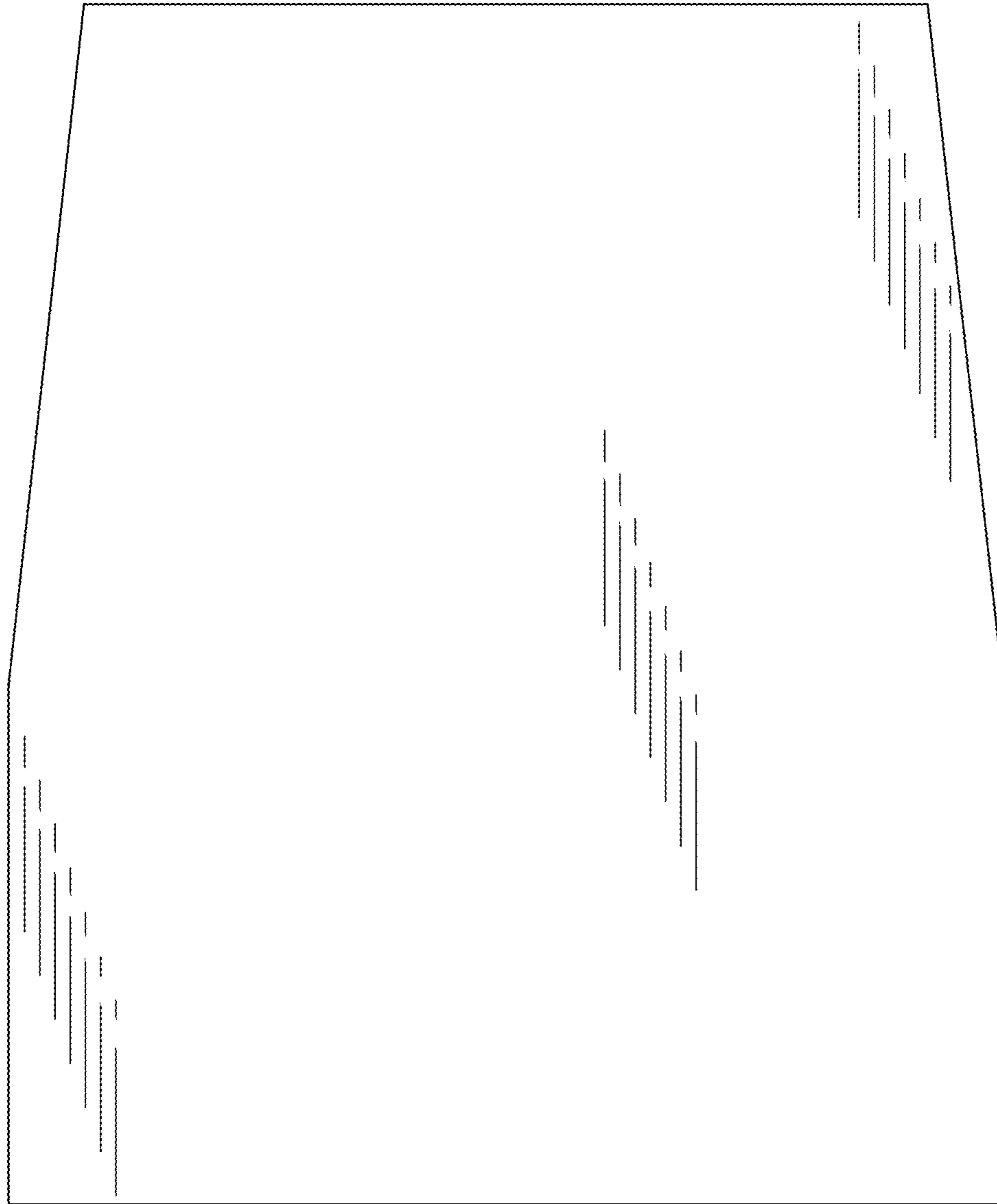

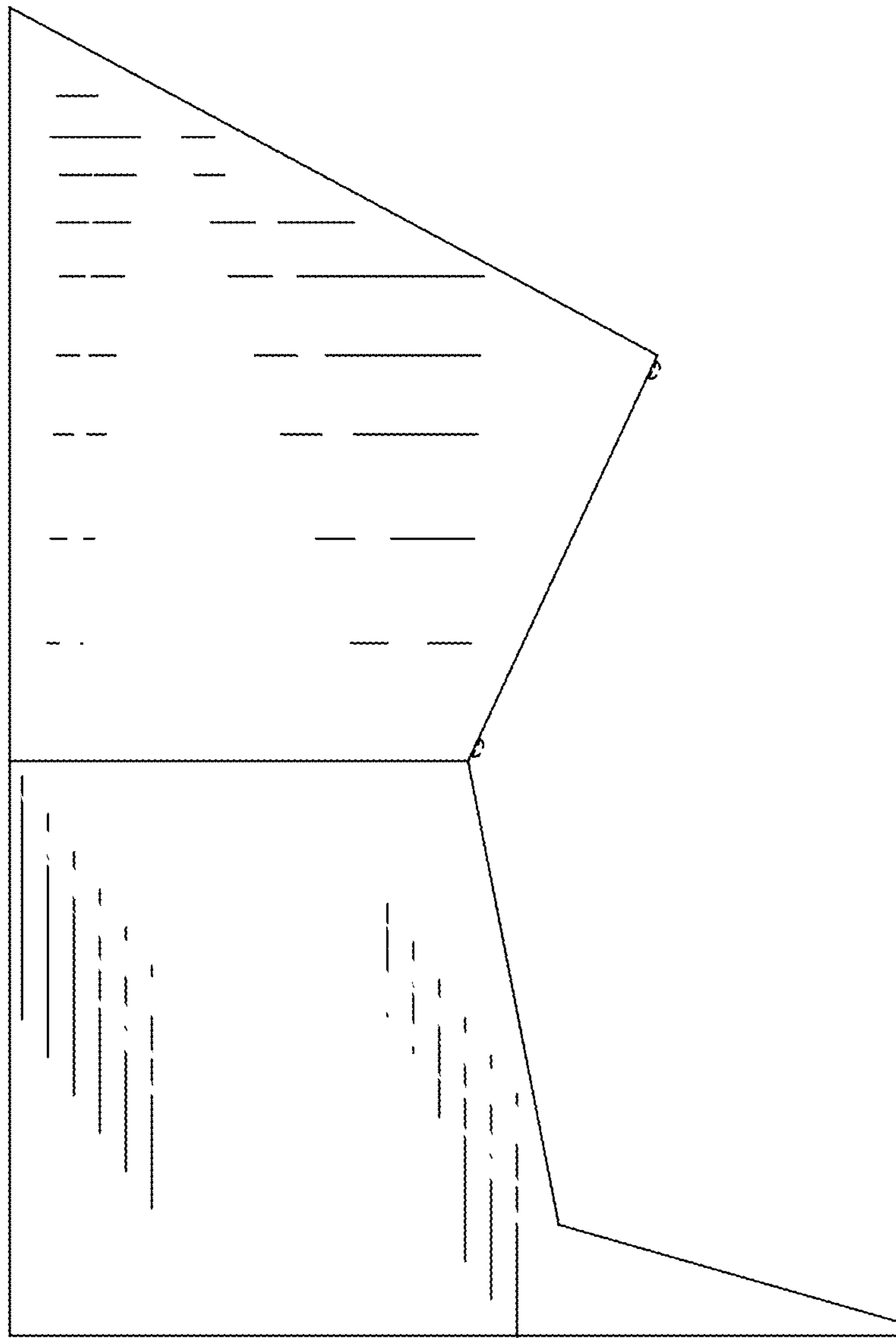

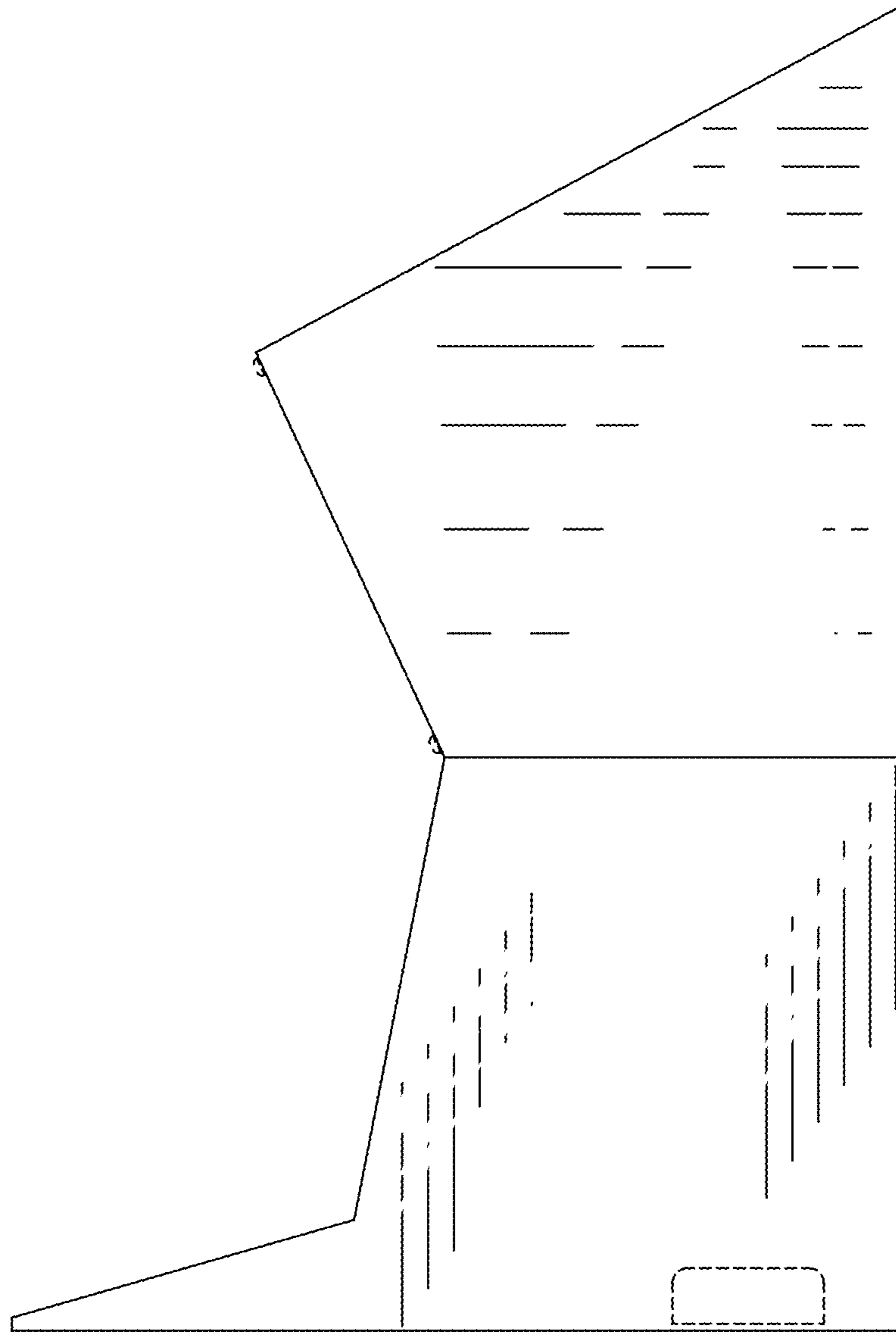

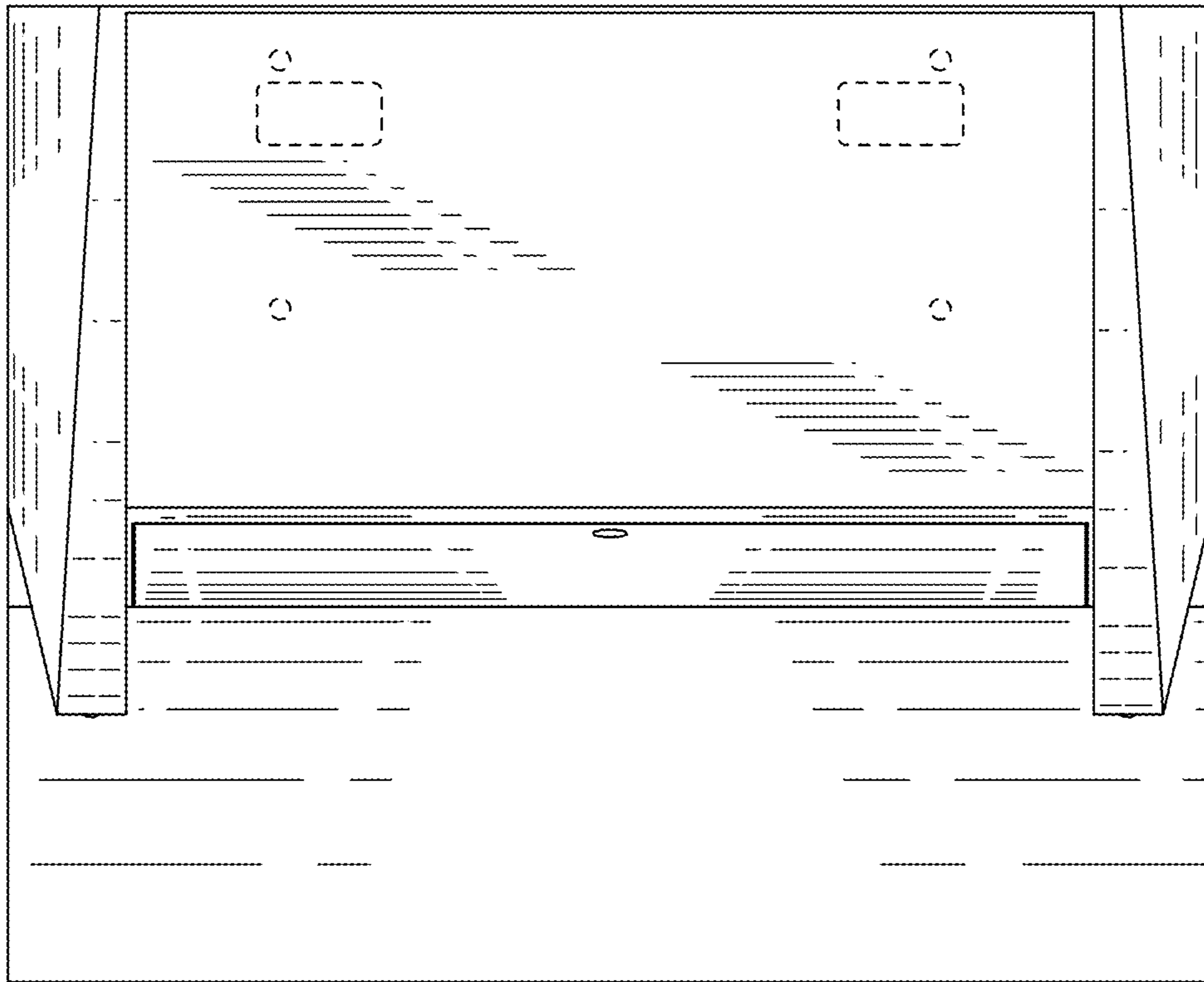
