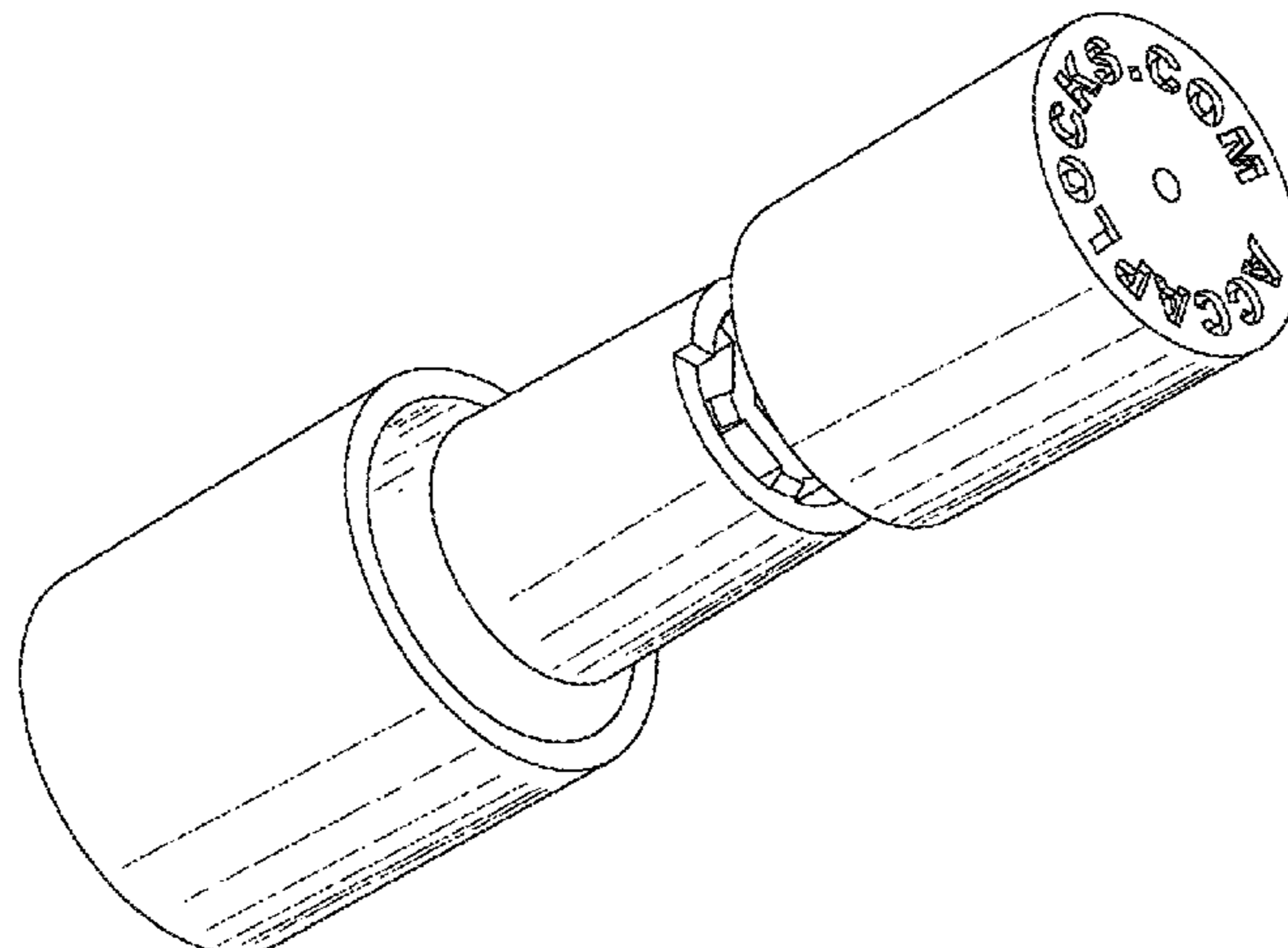
(57) **CLAIM**

The ornamental design for a one-way valve cap, as shown and described.

DESCRIPTION

FIG. 1 is an exploded top perspective view for a one-way valve cap showing my new design;
FIG. 2 is an exploded underside perspective view thereof;
FIG. 3 is an exploded front side view, the rear side view being the same image thereof;
FIG. 4 is an exploded right side view, the left side view being the same image thereof;
FIG. 5 is a top side view thereof;
FIG. 6 is a bottom side view thereof;
FIG. 7 is a front side sectional view taken along lines 7-7 from FIG. 4 thereof;
FIG. 8 is a right side sectional view taken along lines 8-8 from FIG. 3 thereof;

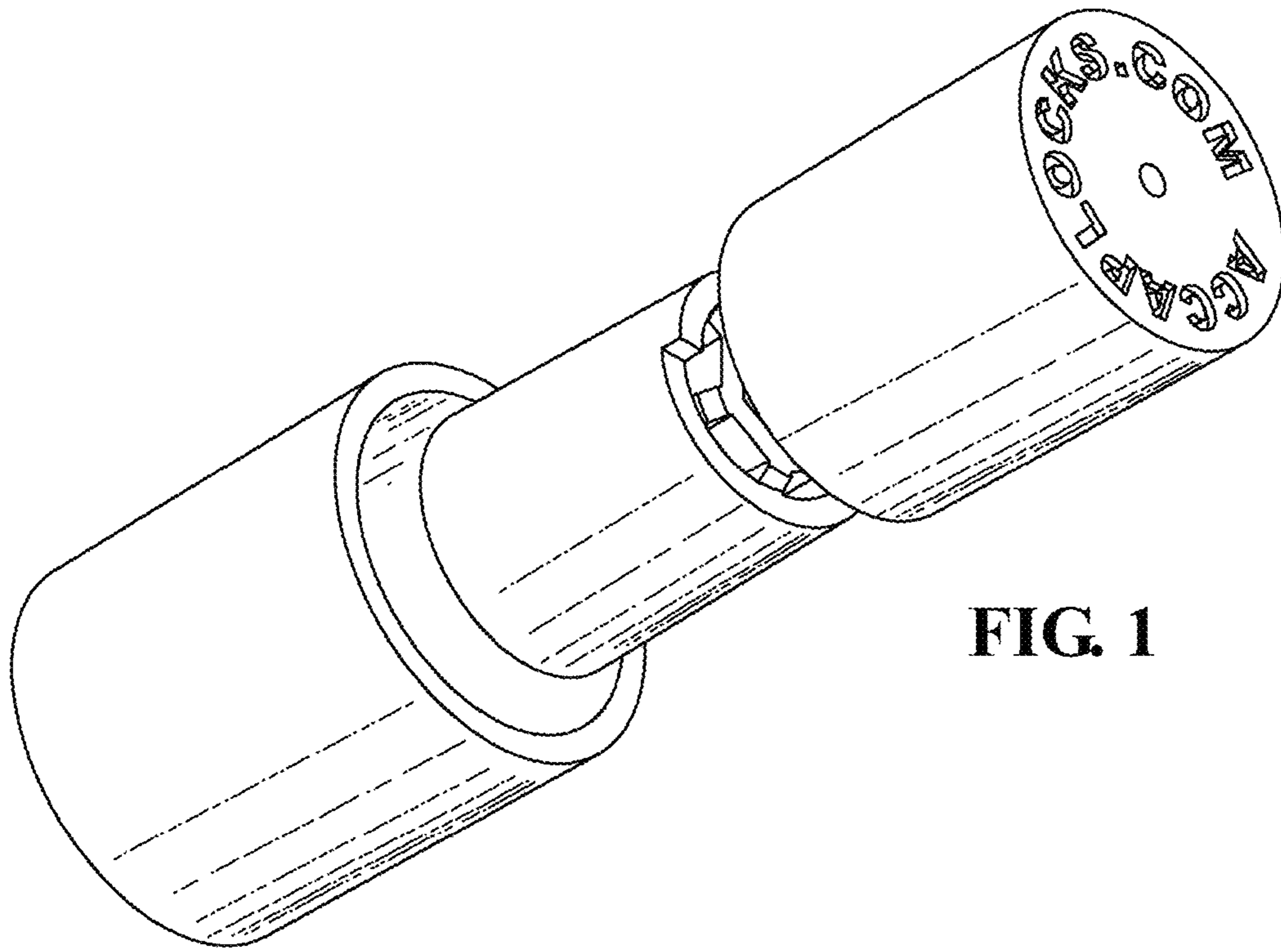

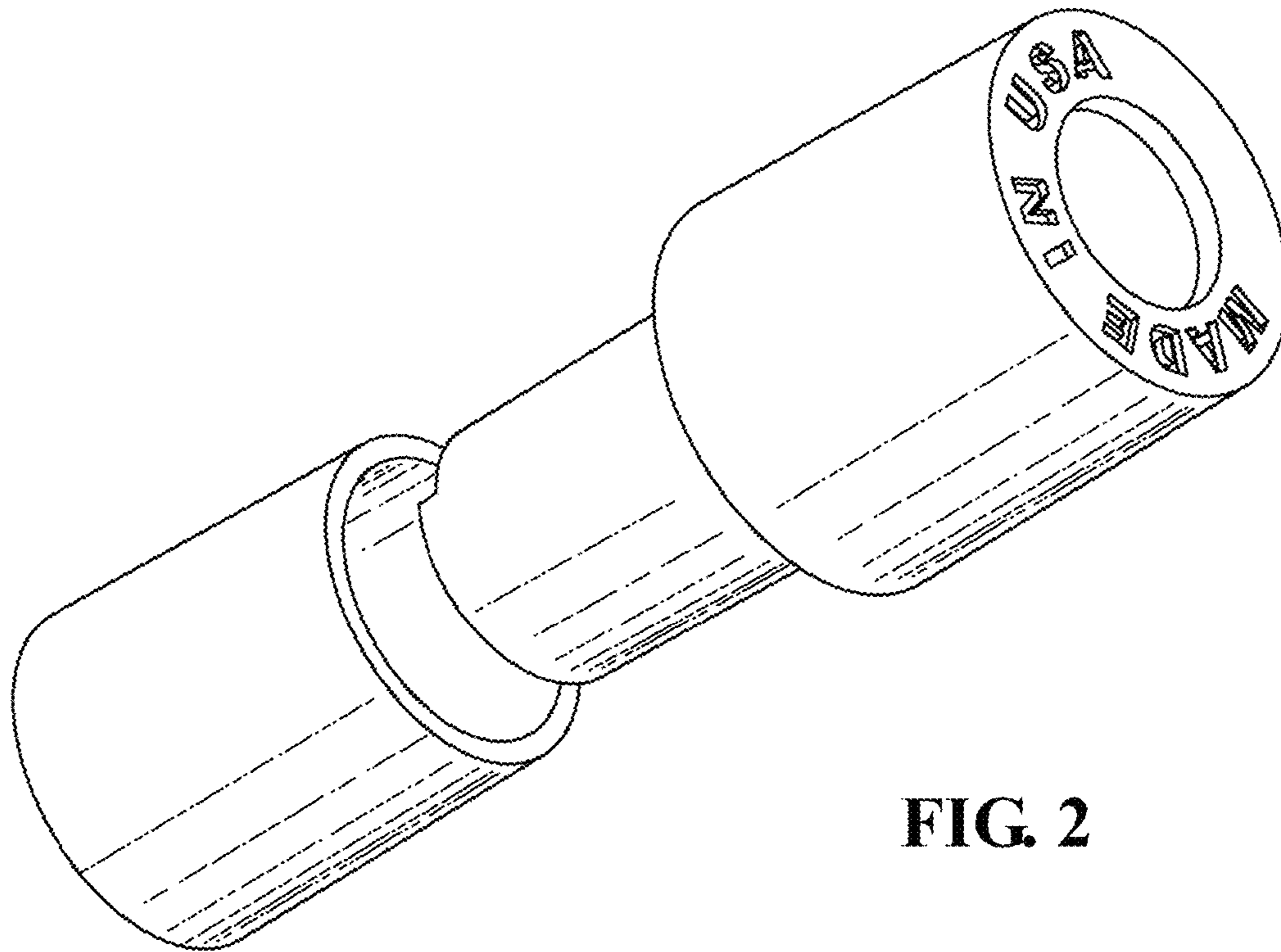

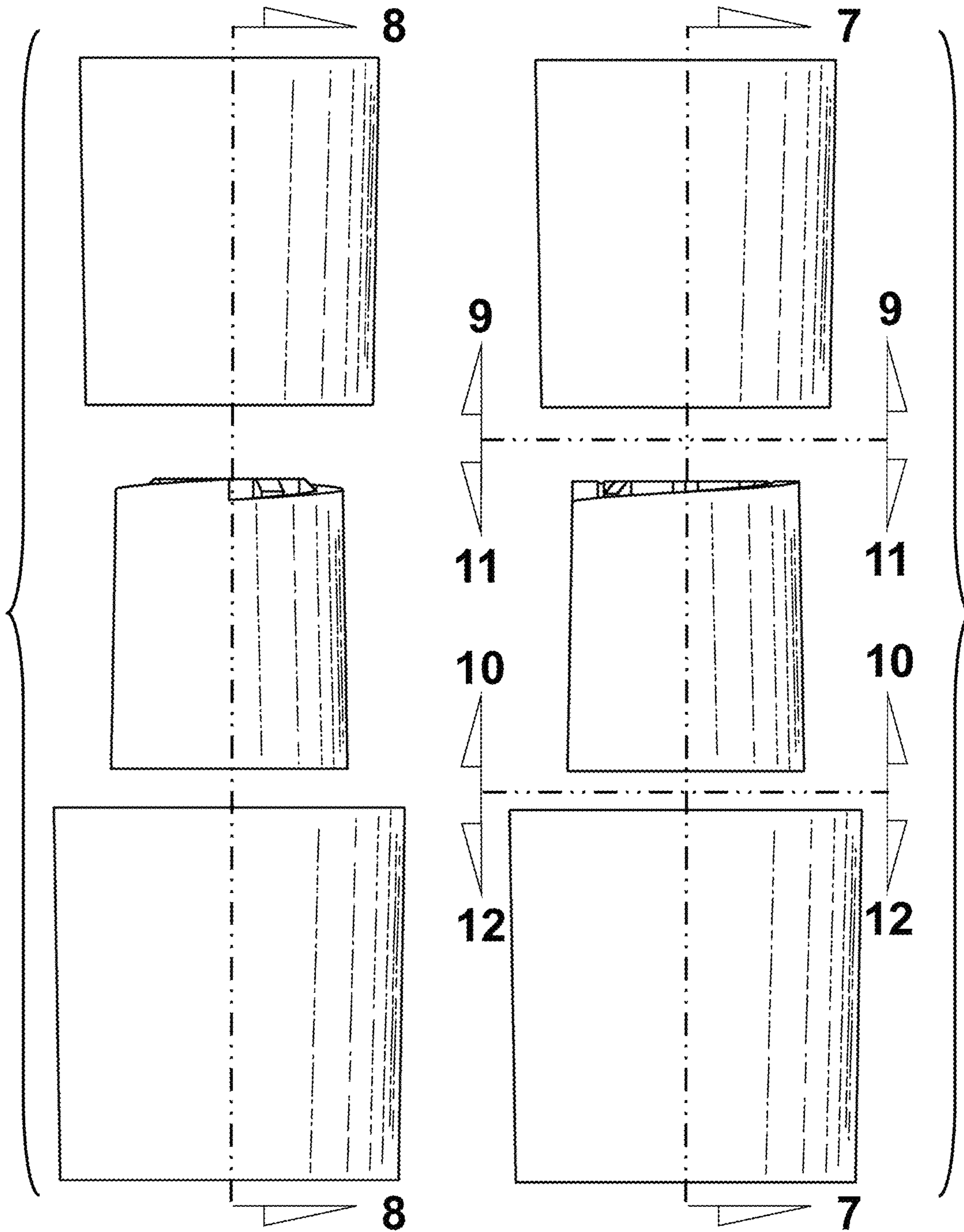

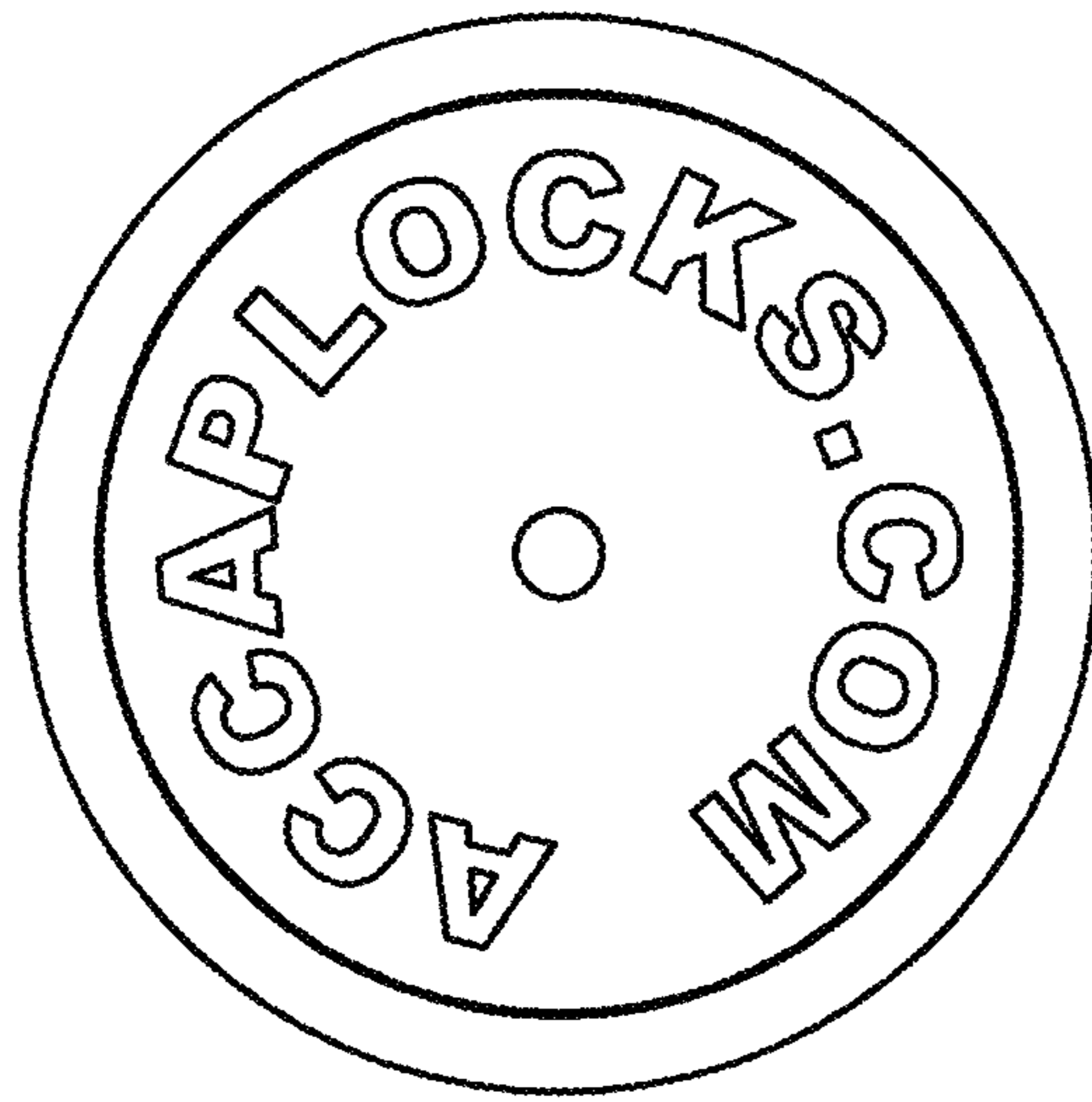

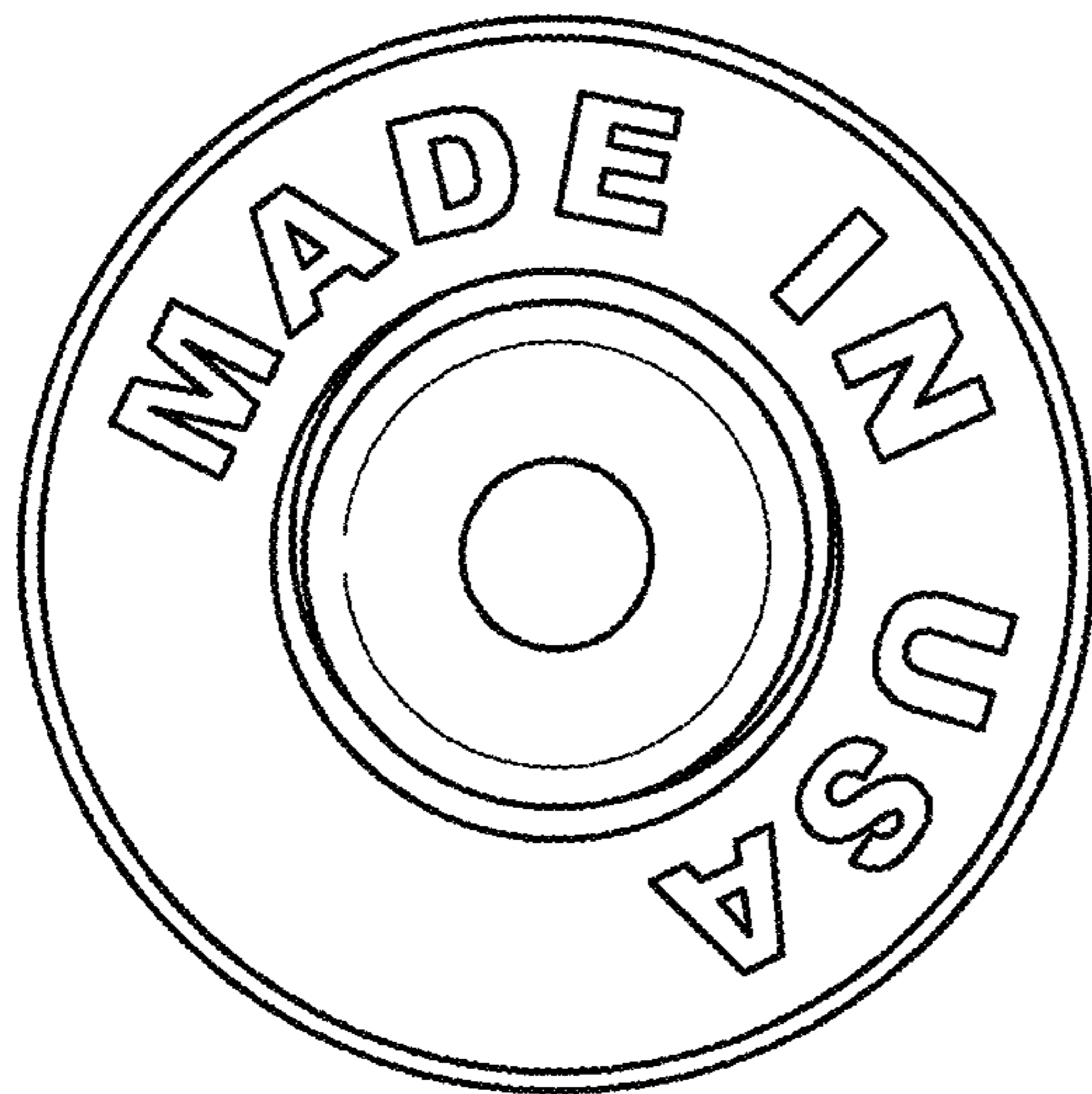

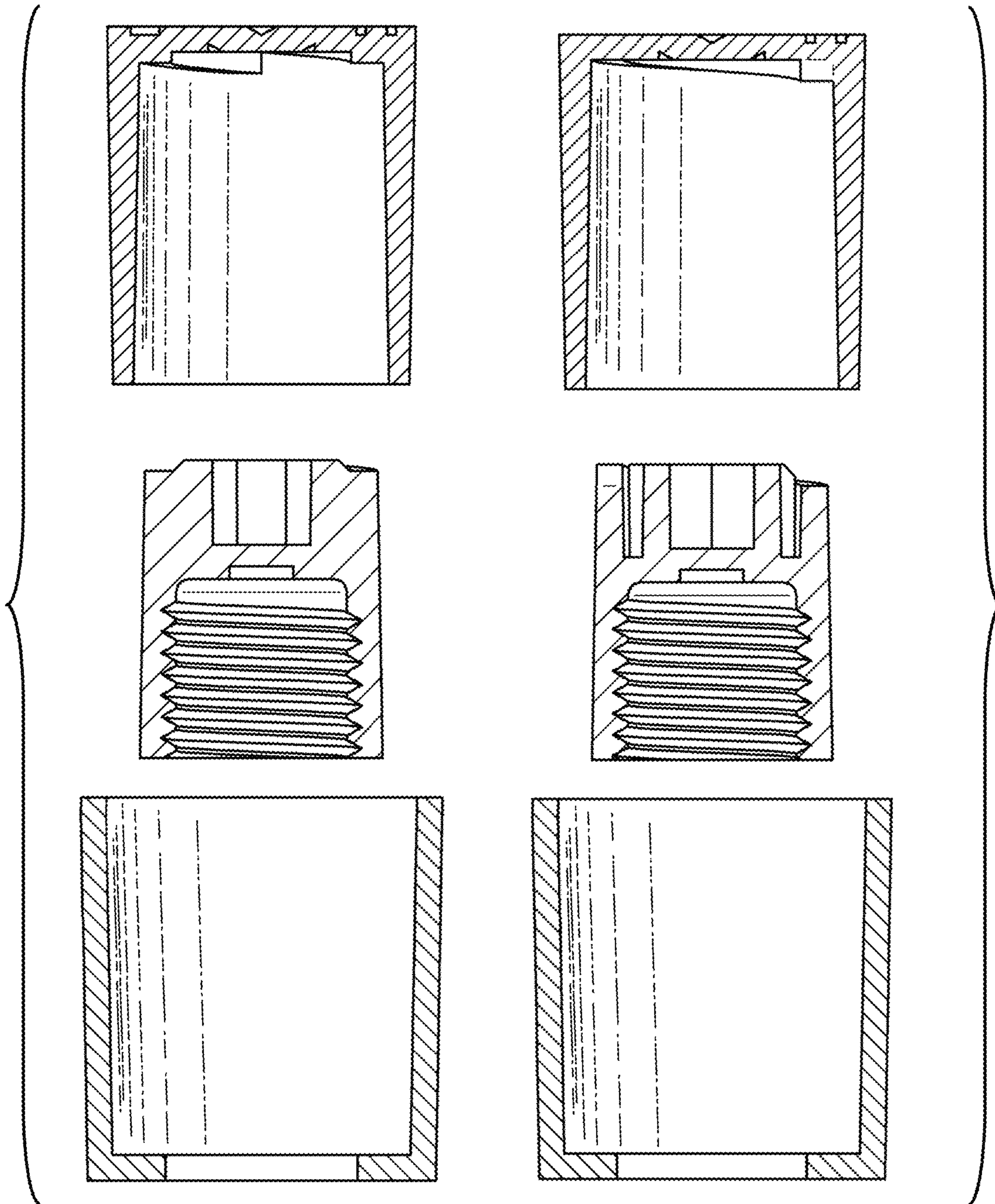

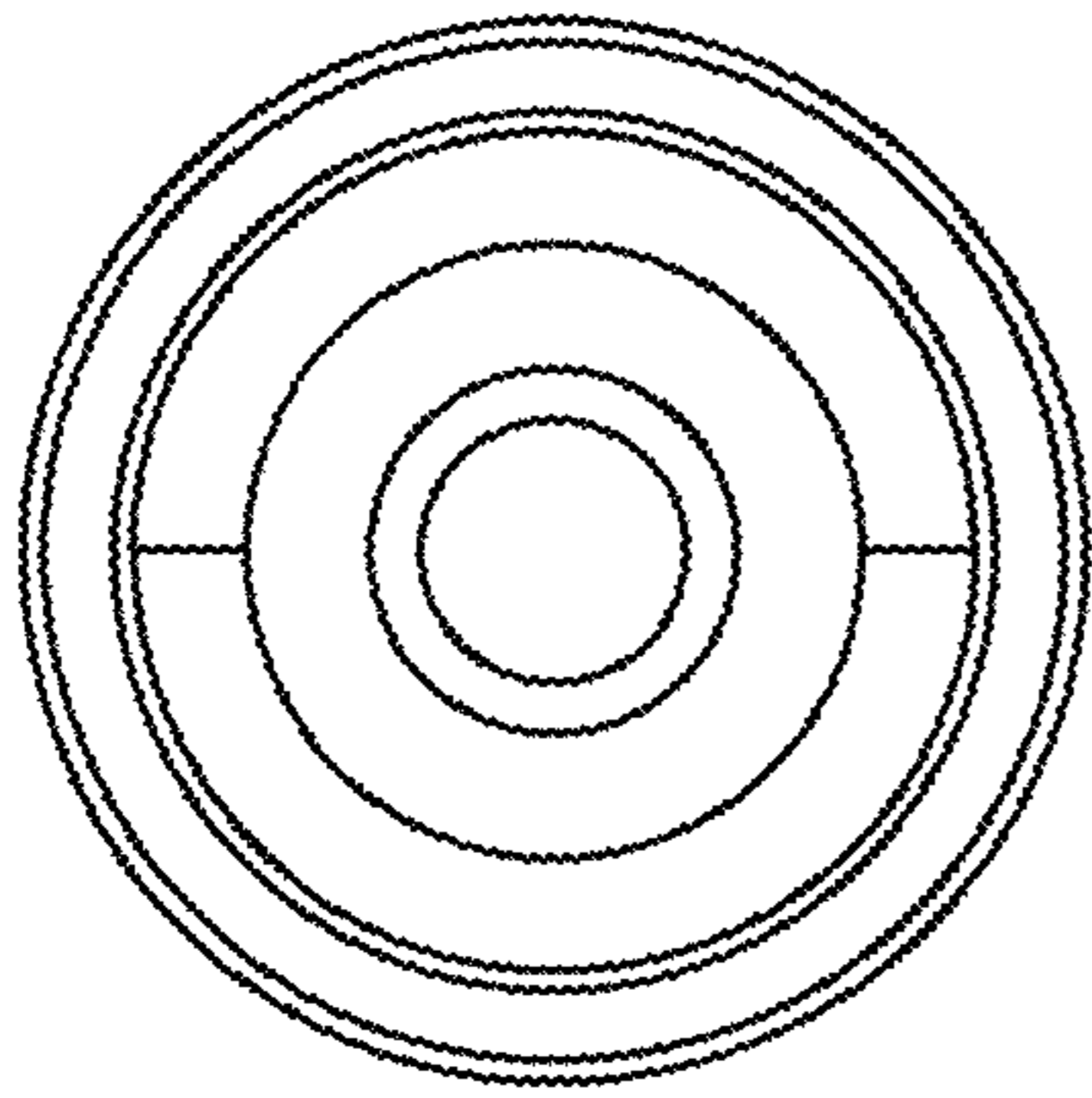

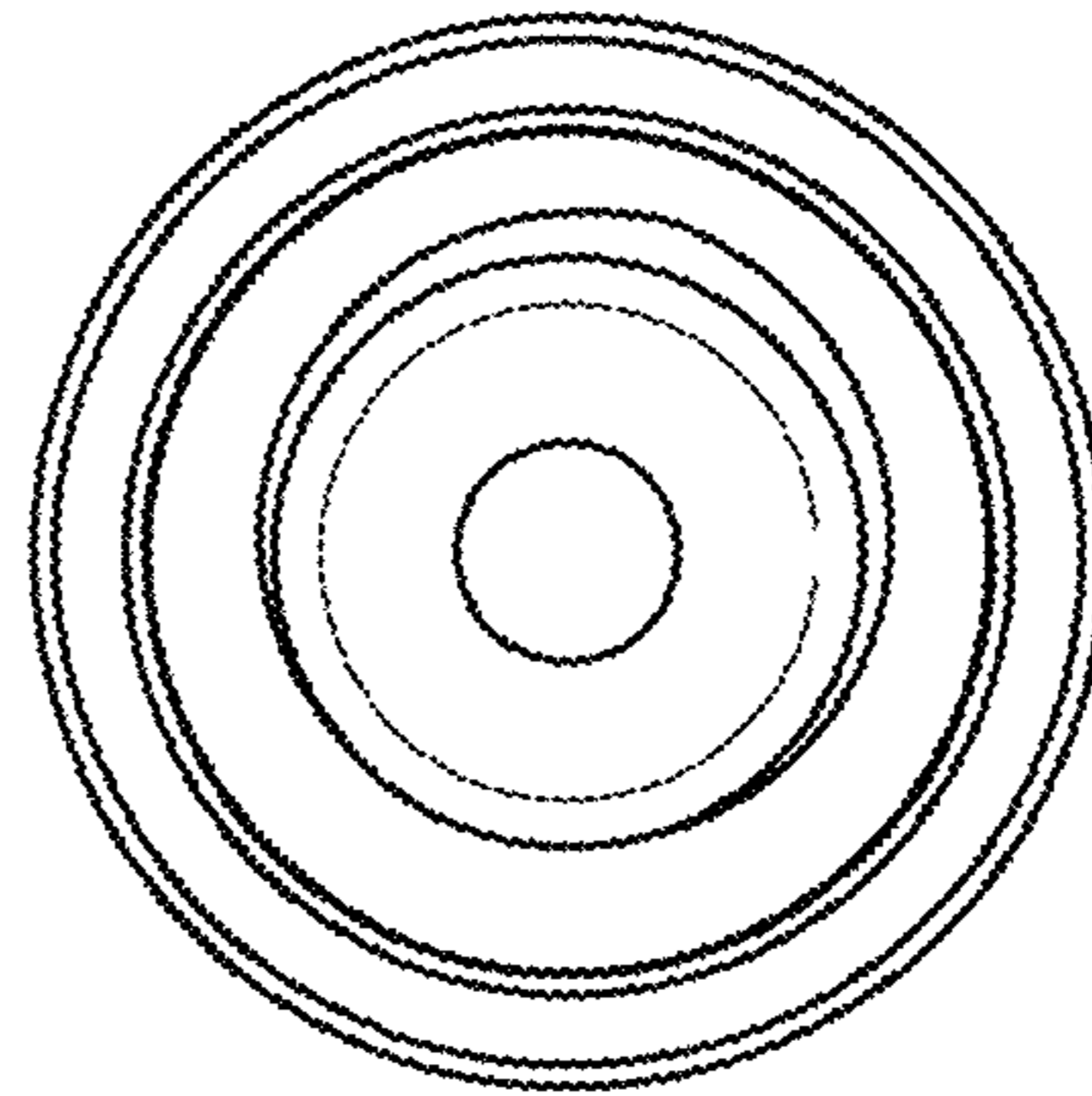

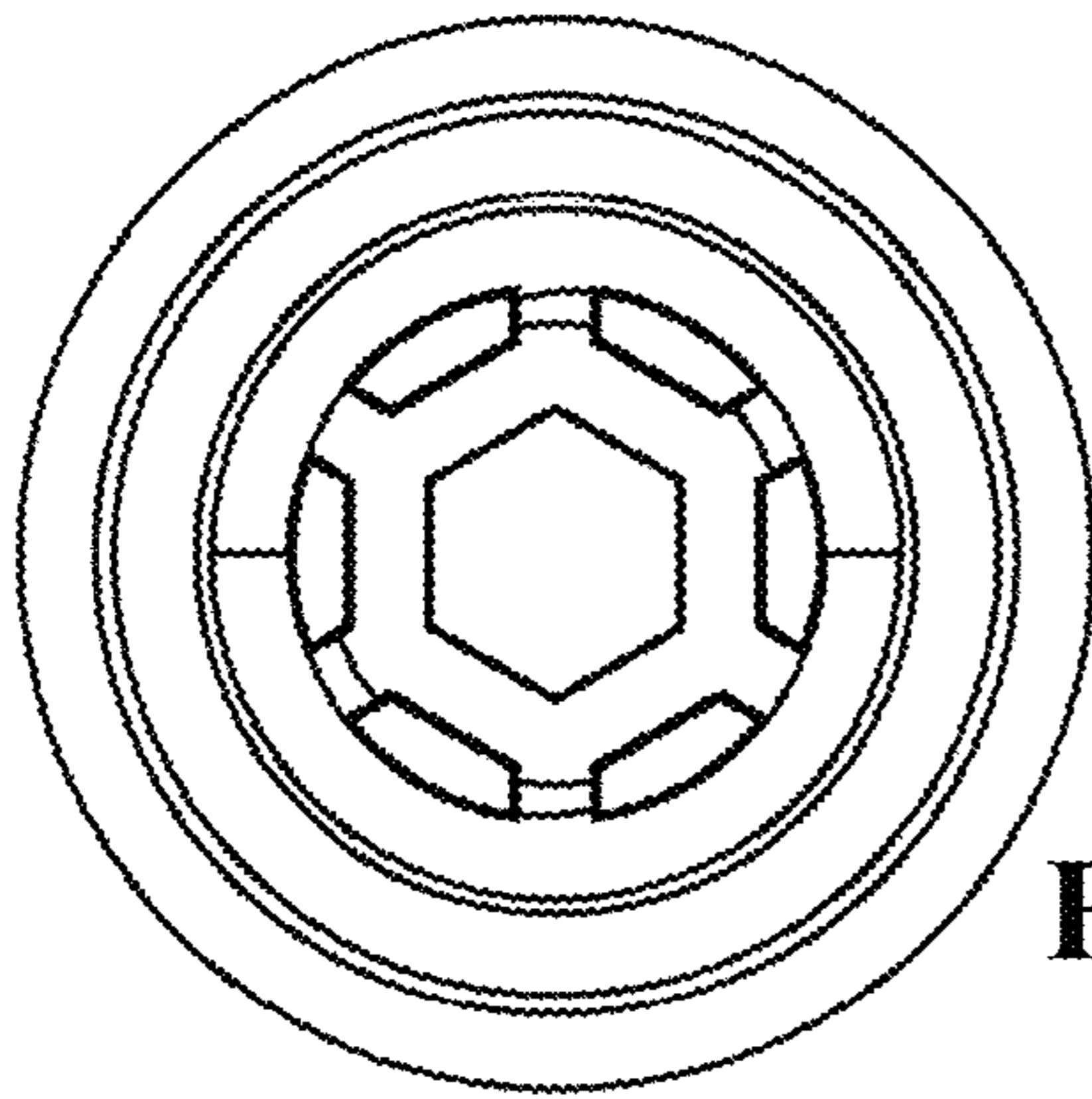

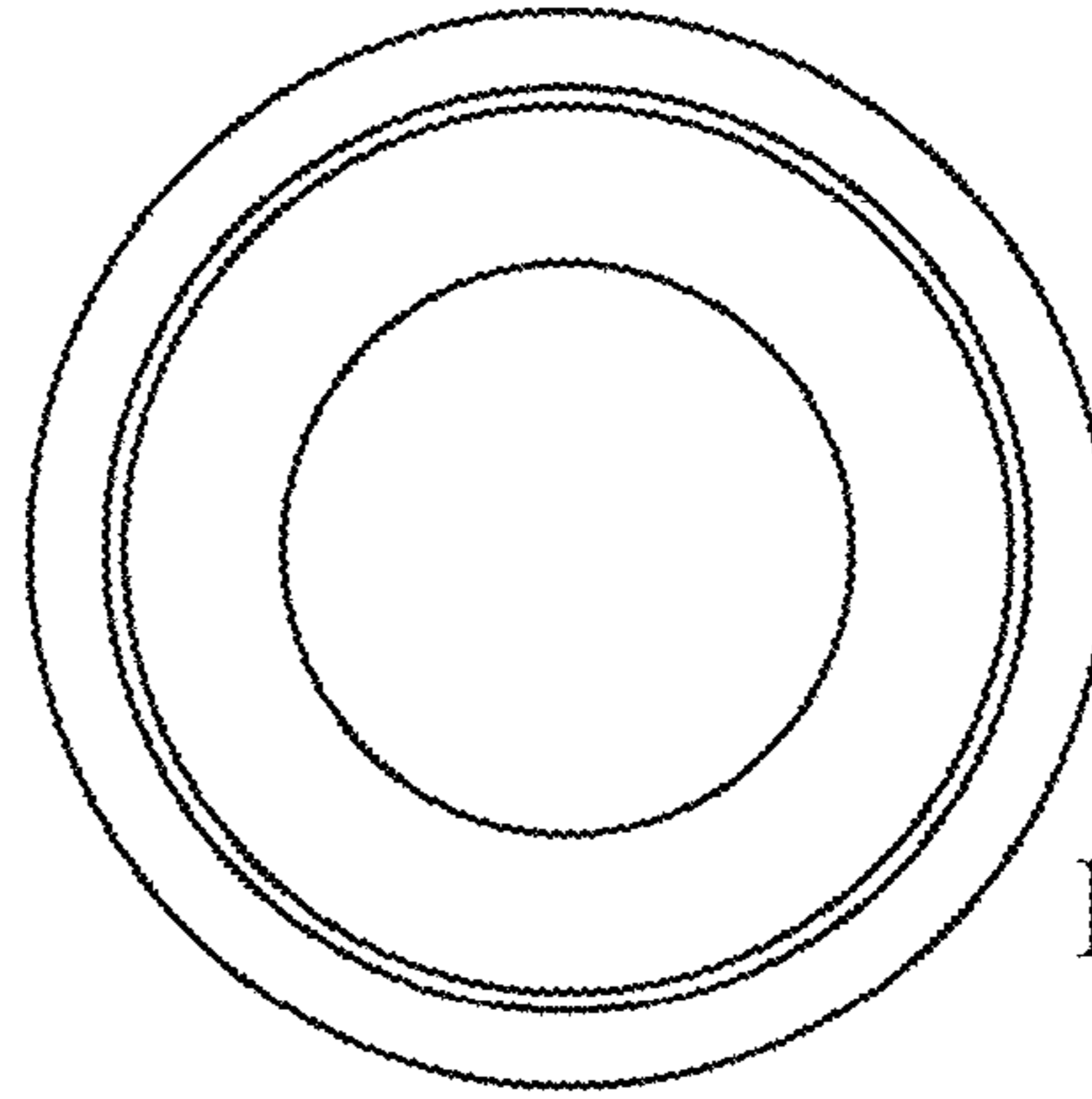

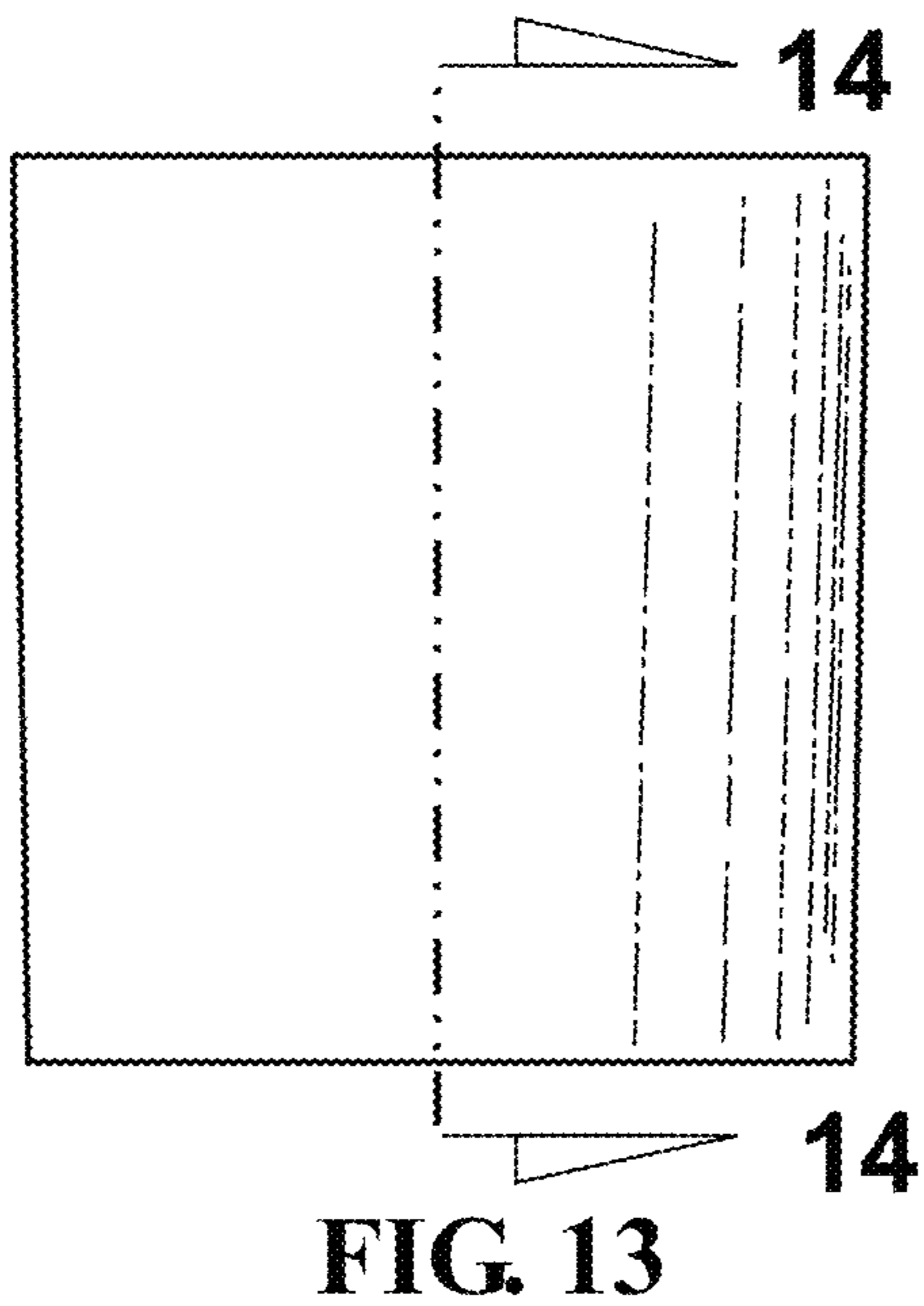

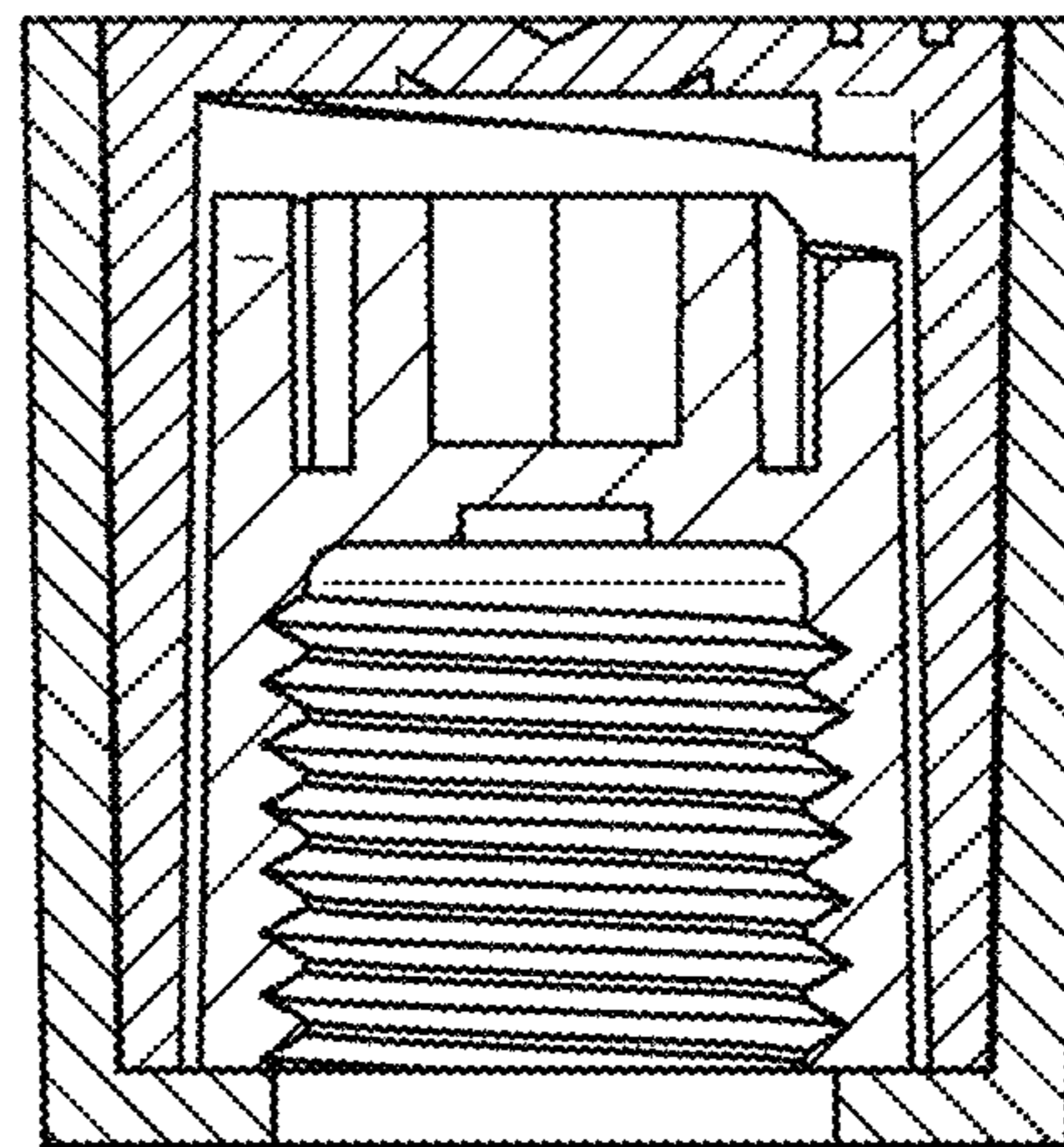
