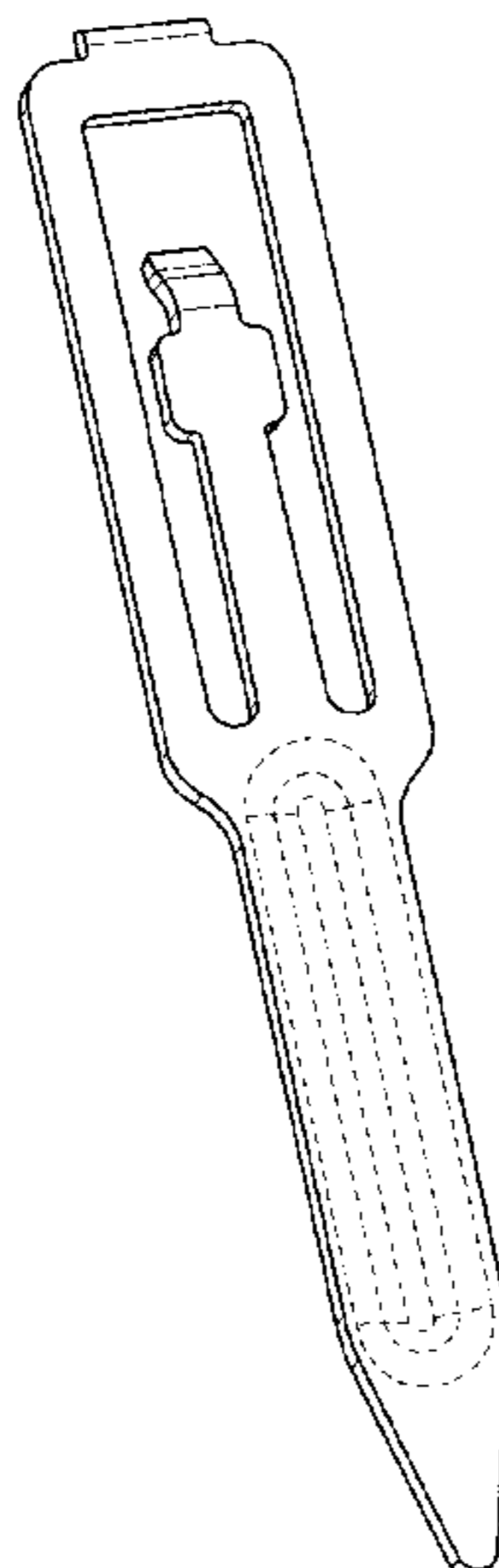
(57) **CLAIM**

shim showing our new design;

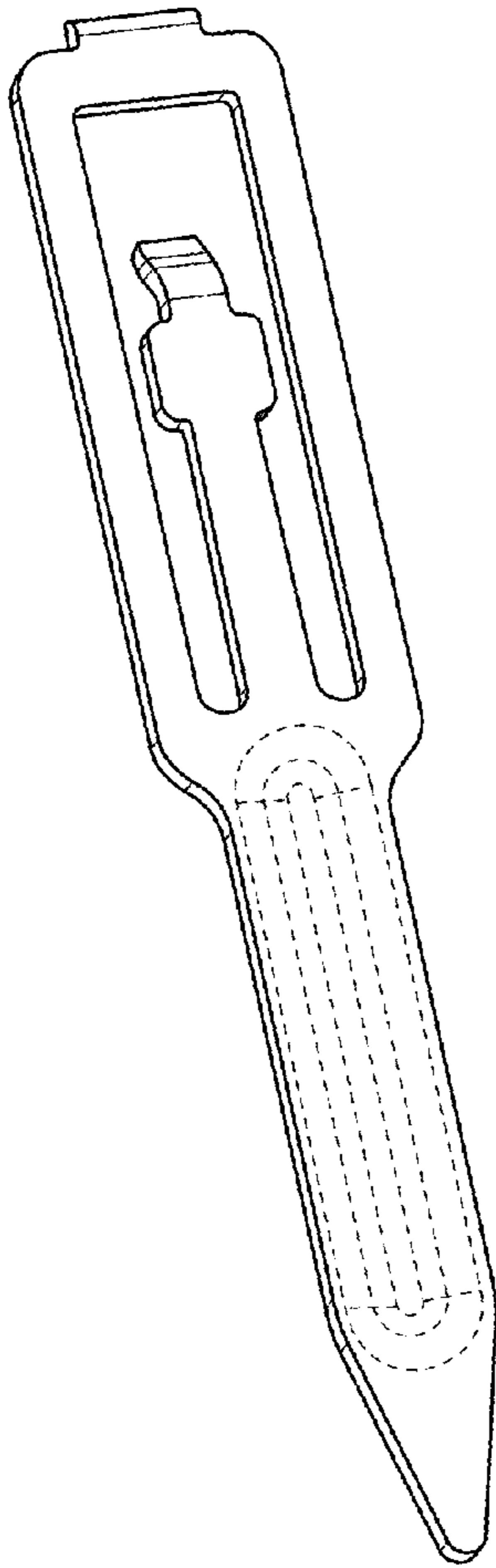

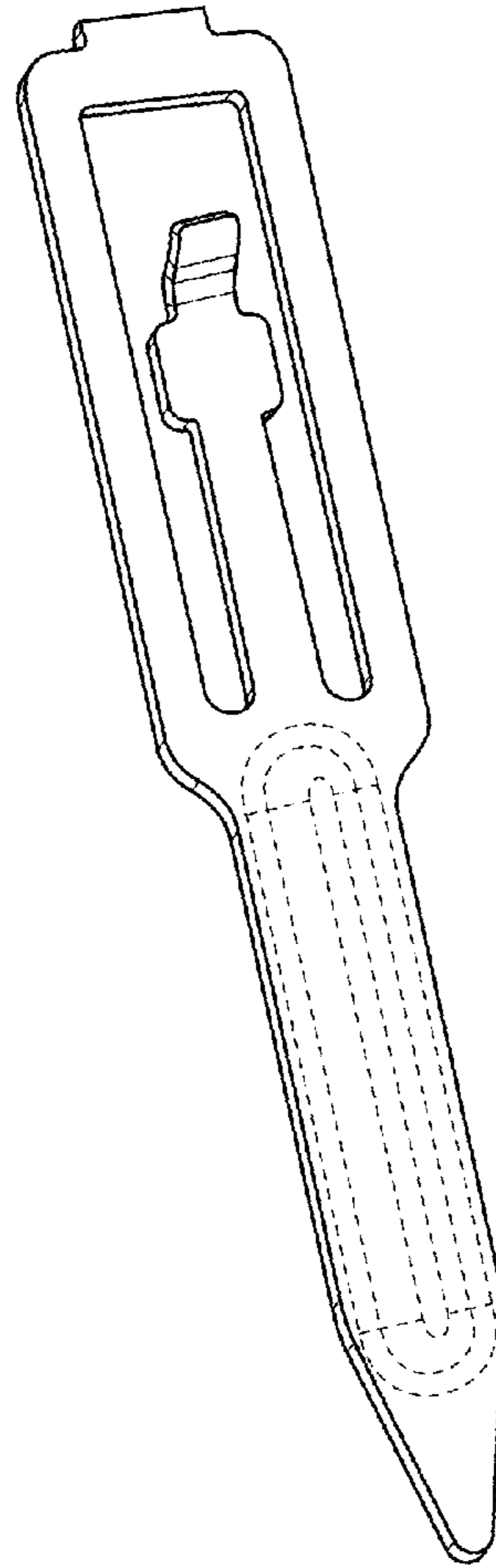

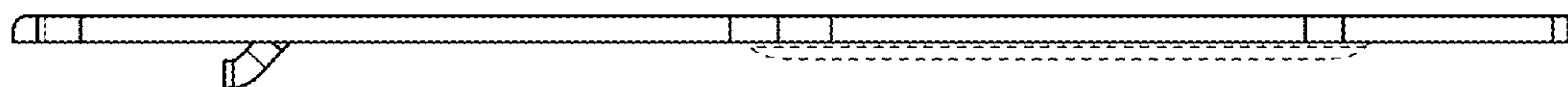
