DESCRIPTION

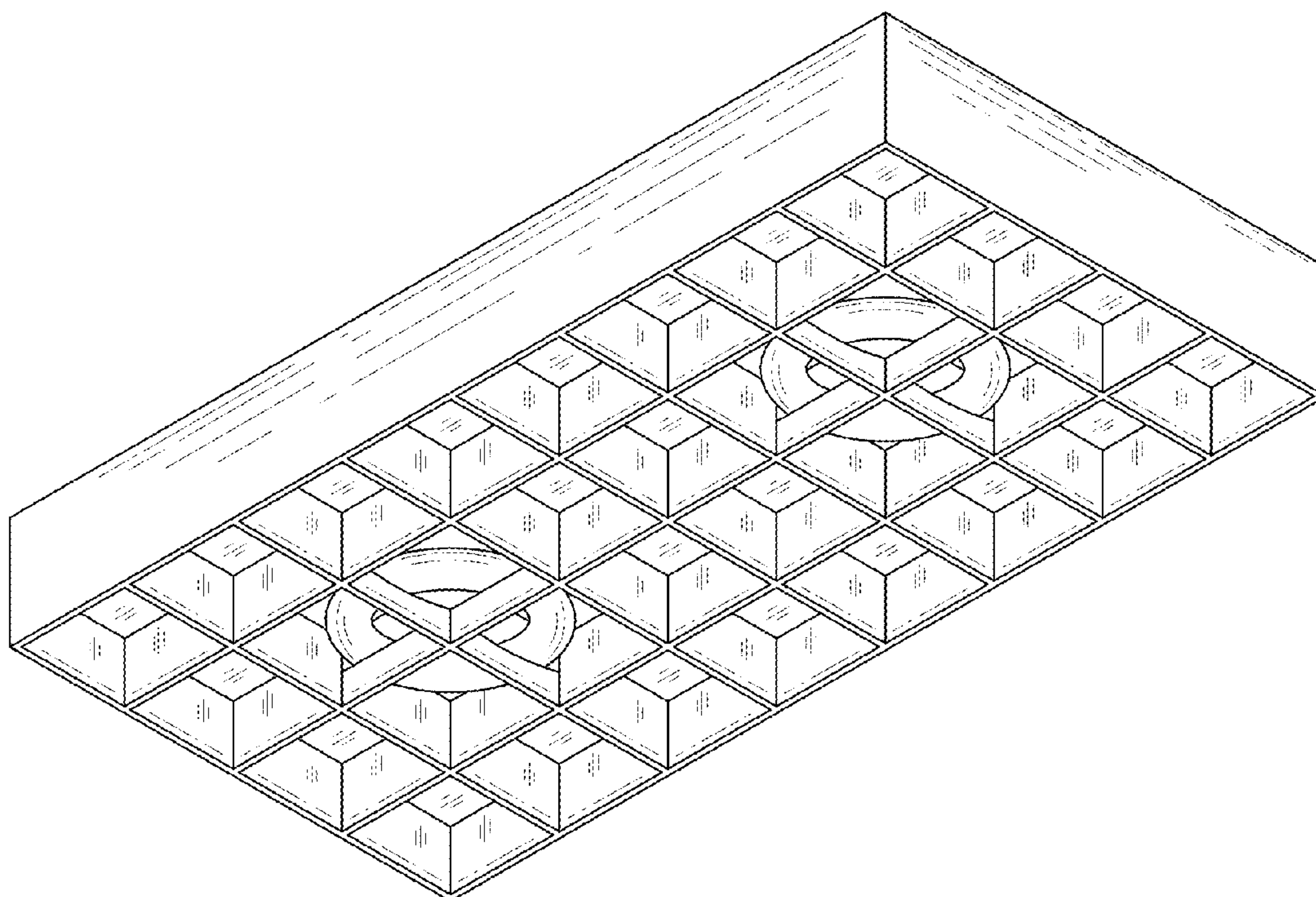
FIG. 1 is a perspective view showing the right, front, and bottom sides of a circular induction lamp fixture showing my new design, wherein a perspective view showing the left, back, and bottom sides is a mirror image thereof;

FIG. 2 is a bottom plan view thereof.

FIG. 4 is a left side elevation view, wherein the right side elevation view is a mirror image thereof.

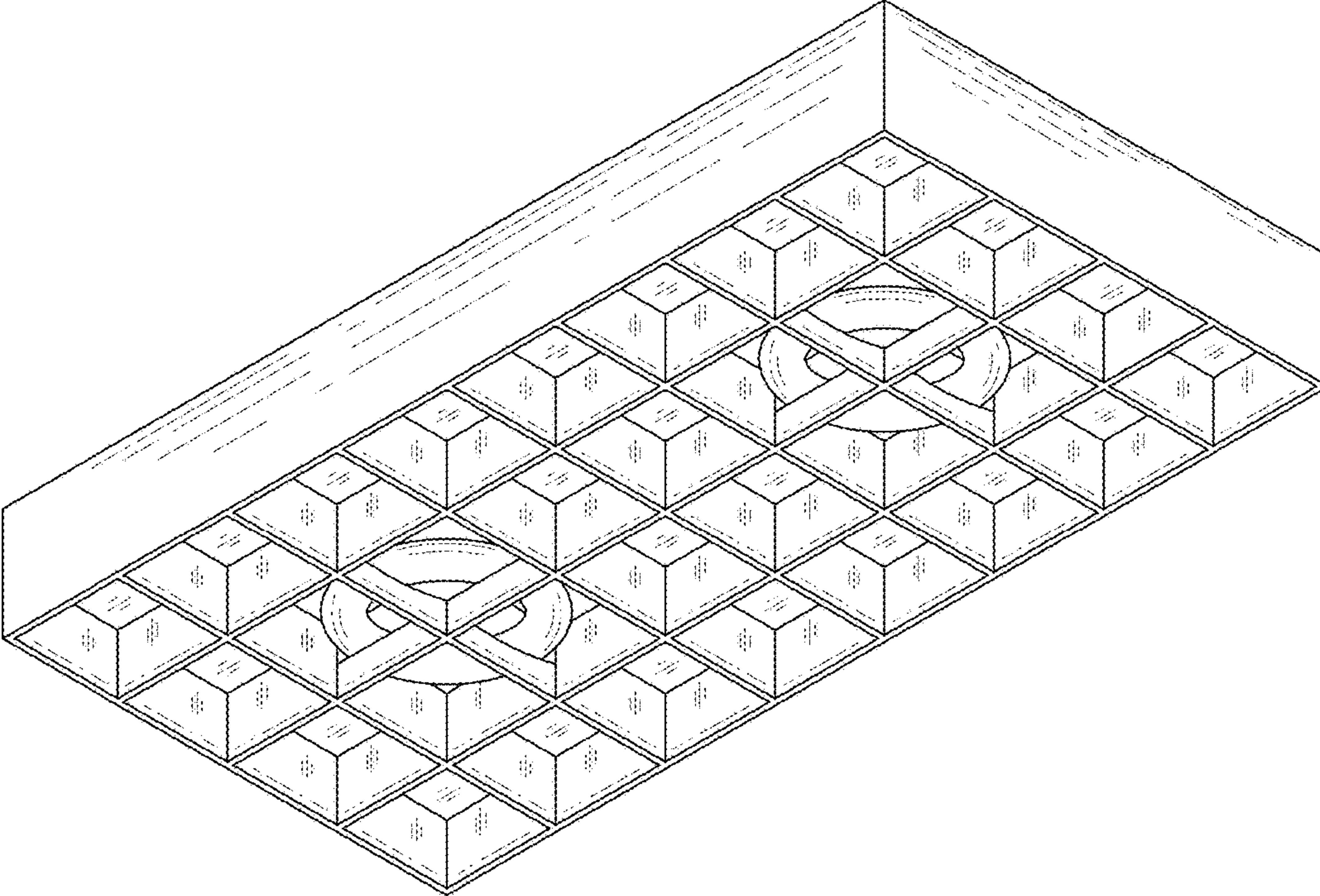

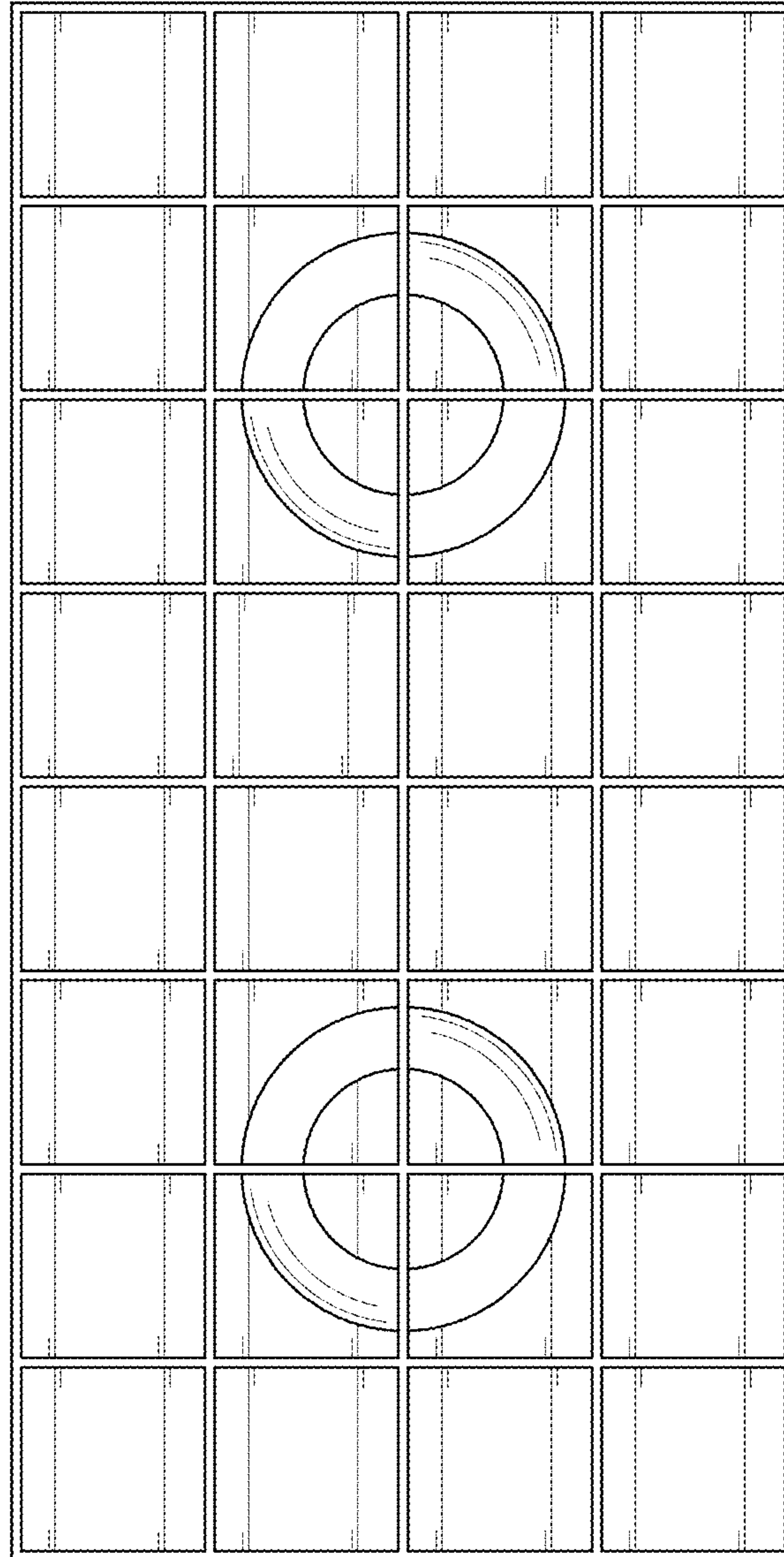

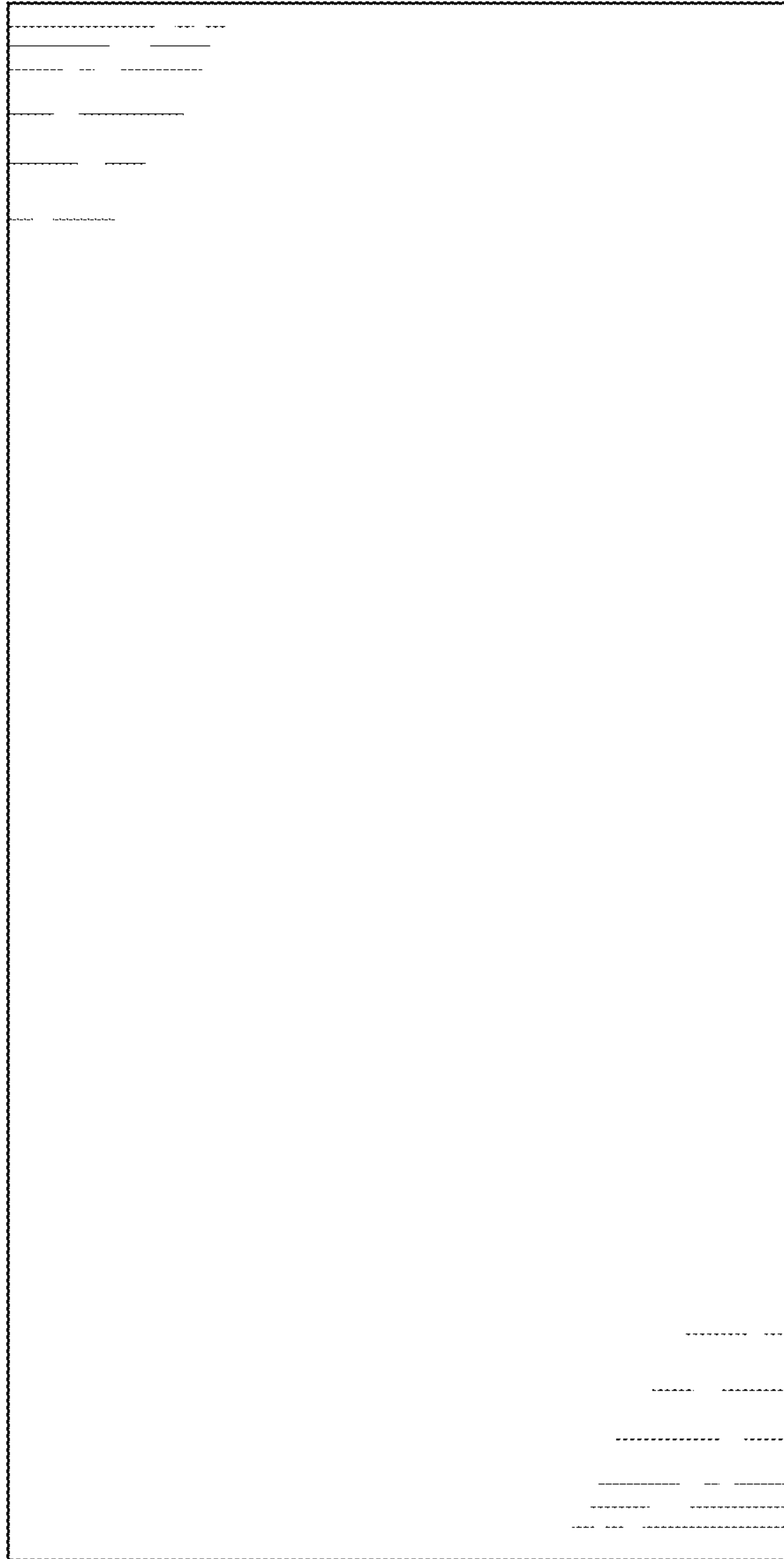

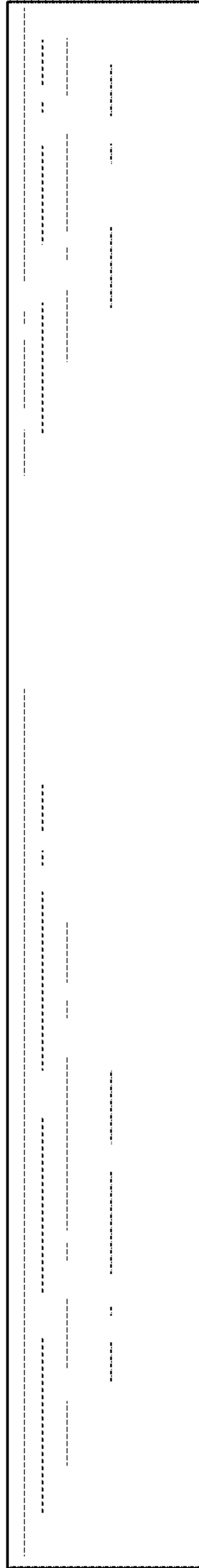
