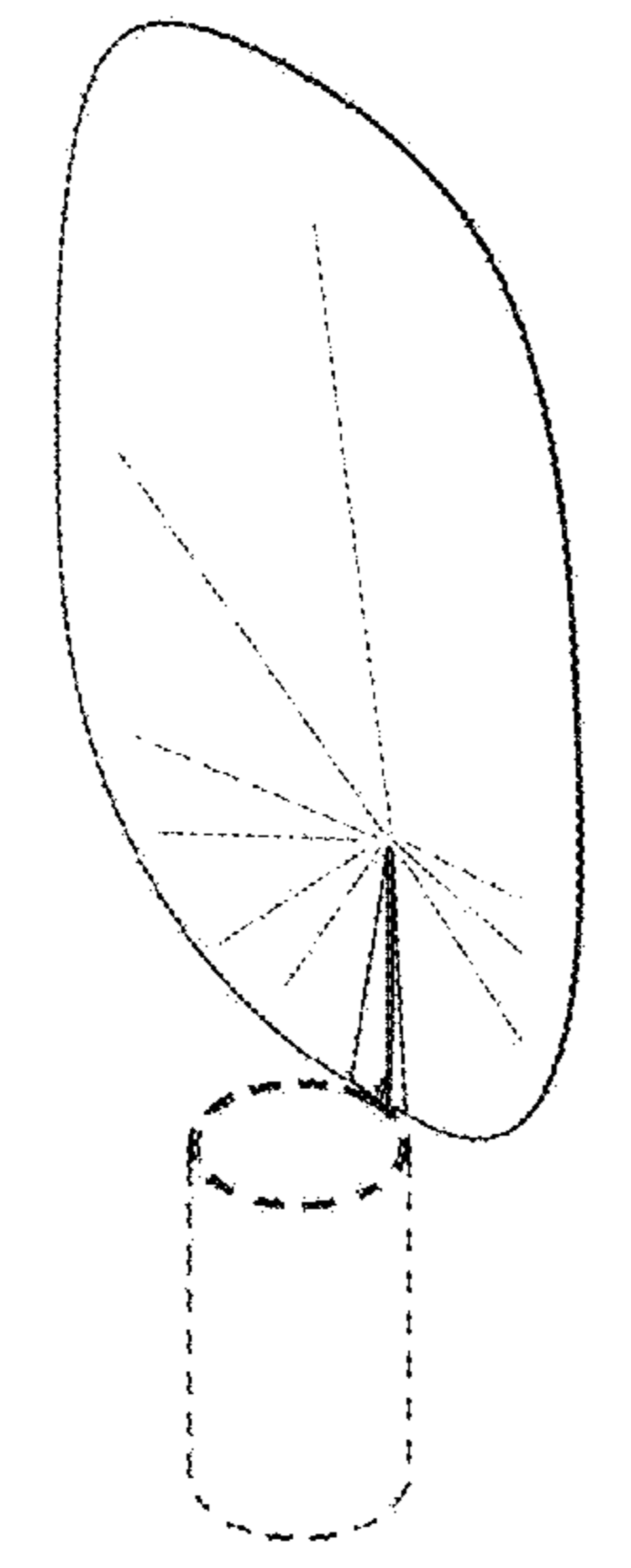
The ornamental design for a table lamp, as shown and described.

DESCRIPTION

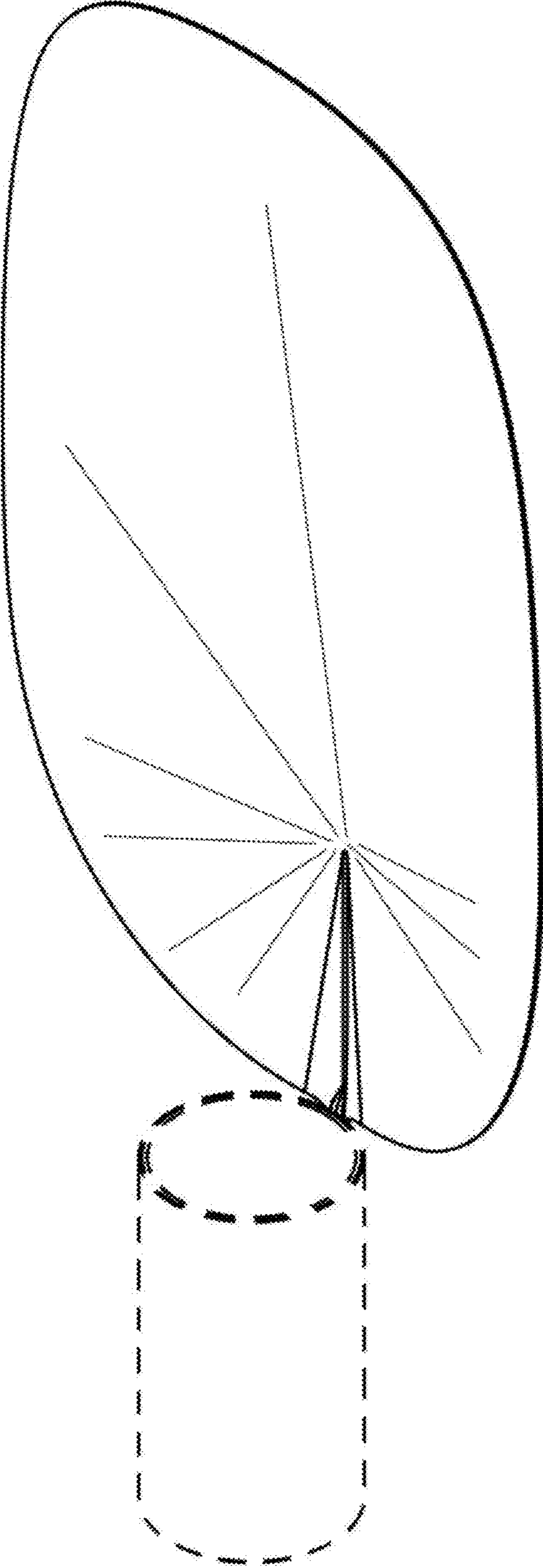
1. Table lamp
- 1.1 is a perspective view;
- 1.2 is a side view;
- 1.3 is a side view;
- 1.4 is a rear view;
- 1.5 is a front view;
- 1.6 is a top view and;
- 1.7 is a bottom view.

The model regards a table lamp; the lamp comprises a base and a thin shade supported by the base; the base is open on the top; the light source is located into the base and a light is emitted towards the shade.

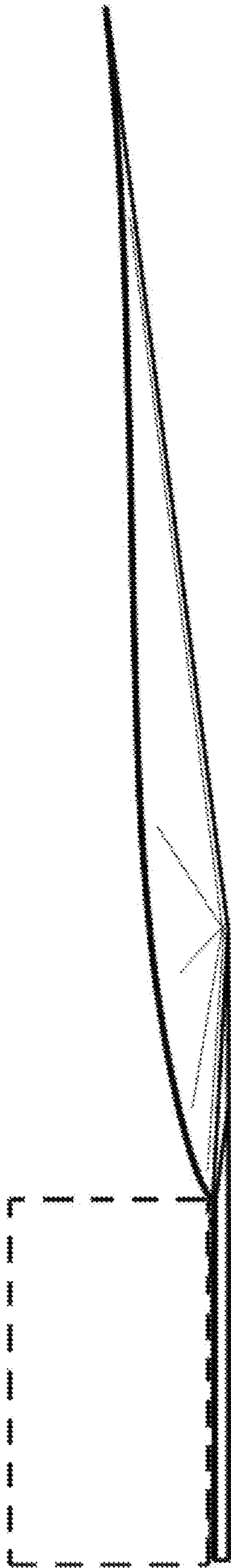

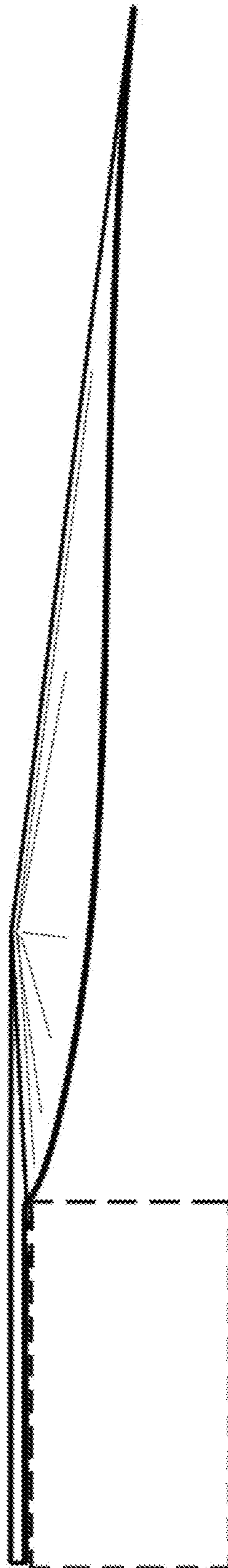

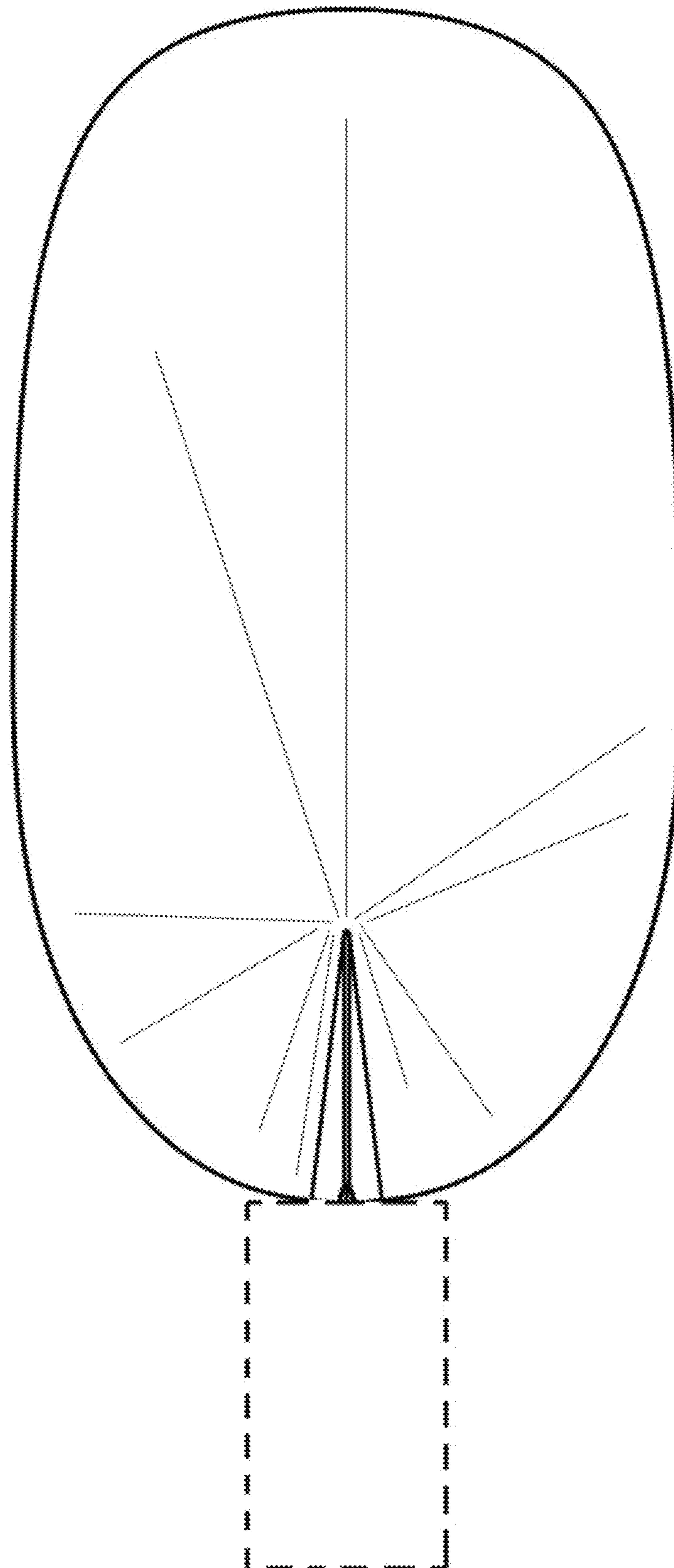

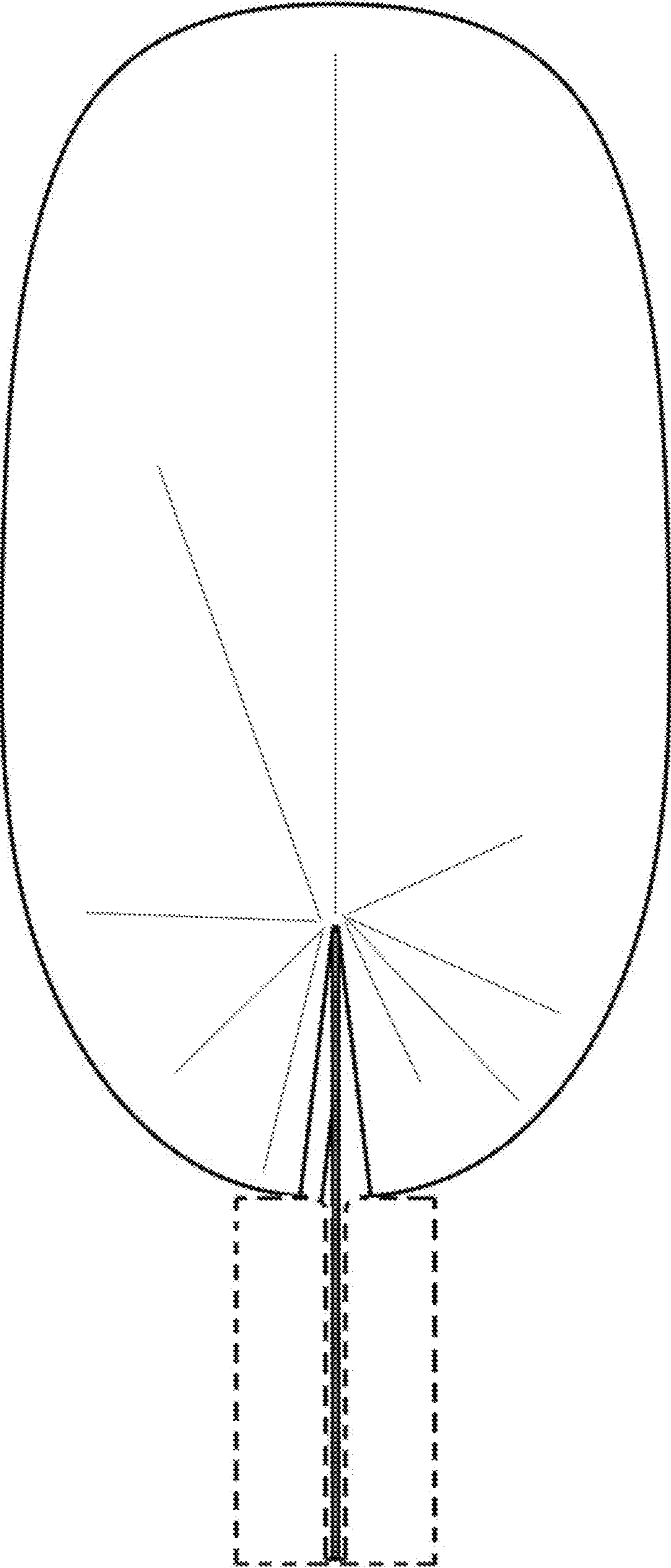

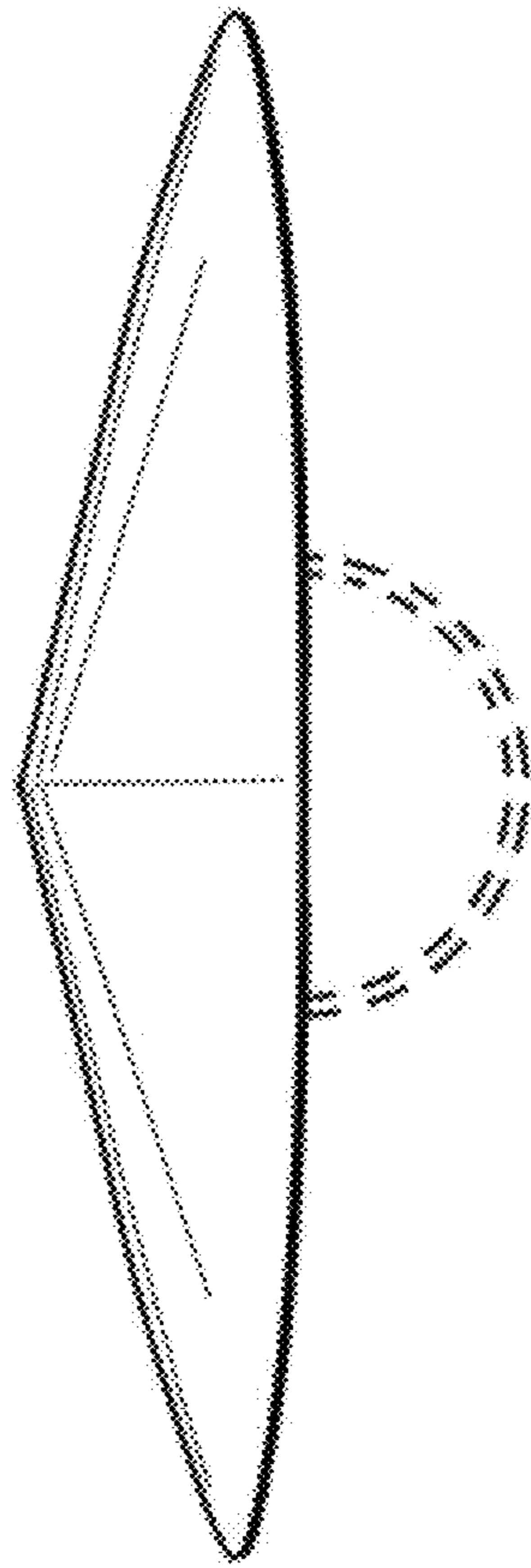
