FIG. 17 is a front elevation view of the lighting fixture of the third embodiment;

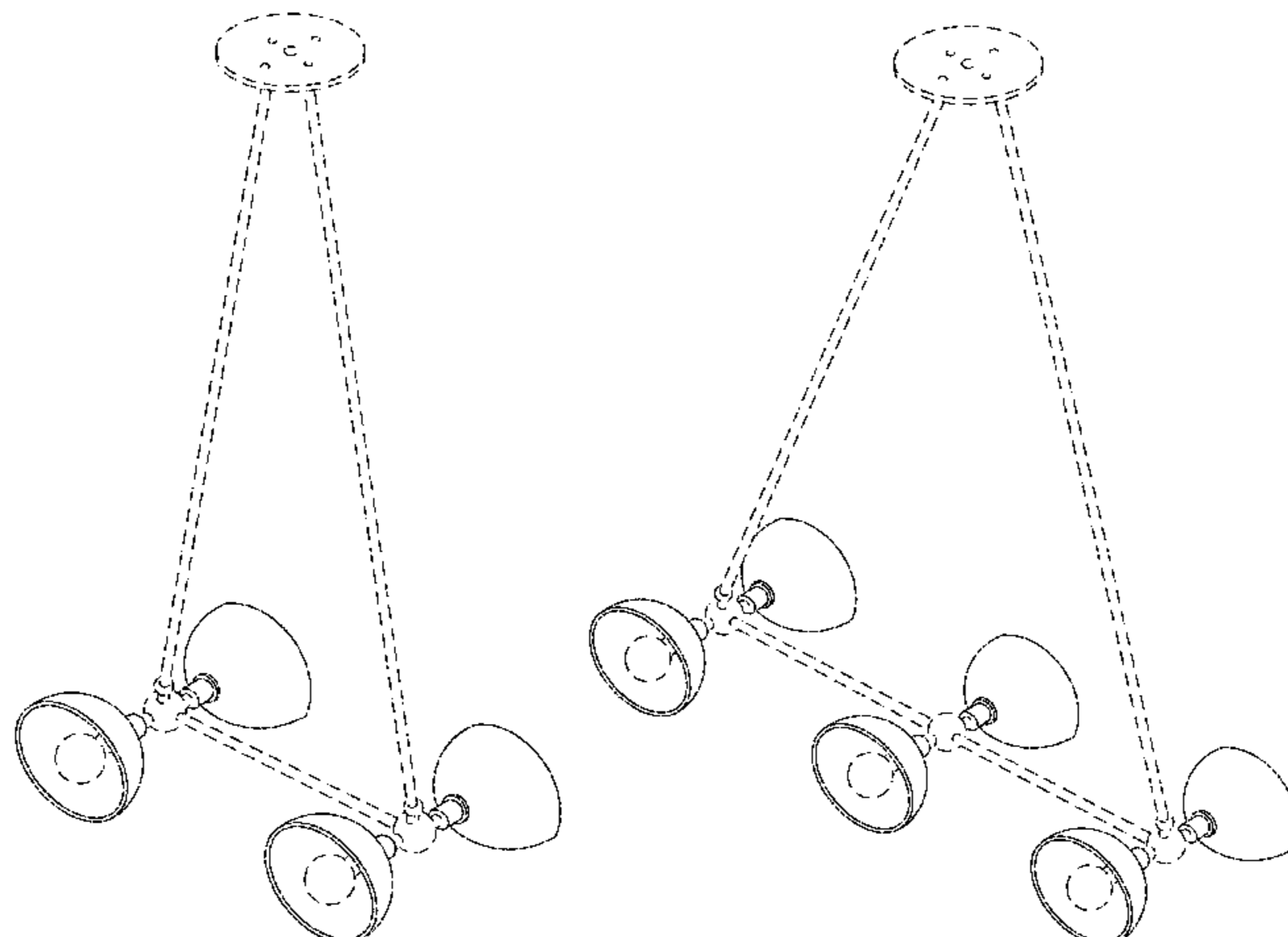
FIG. 18 is a rear elevation view of the lighting fixture of the third embodiment;

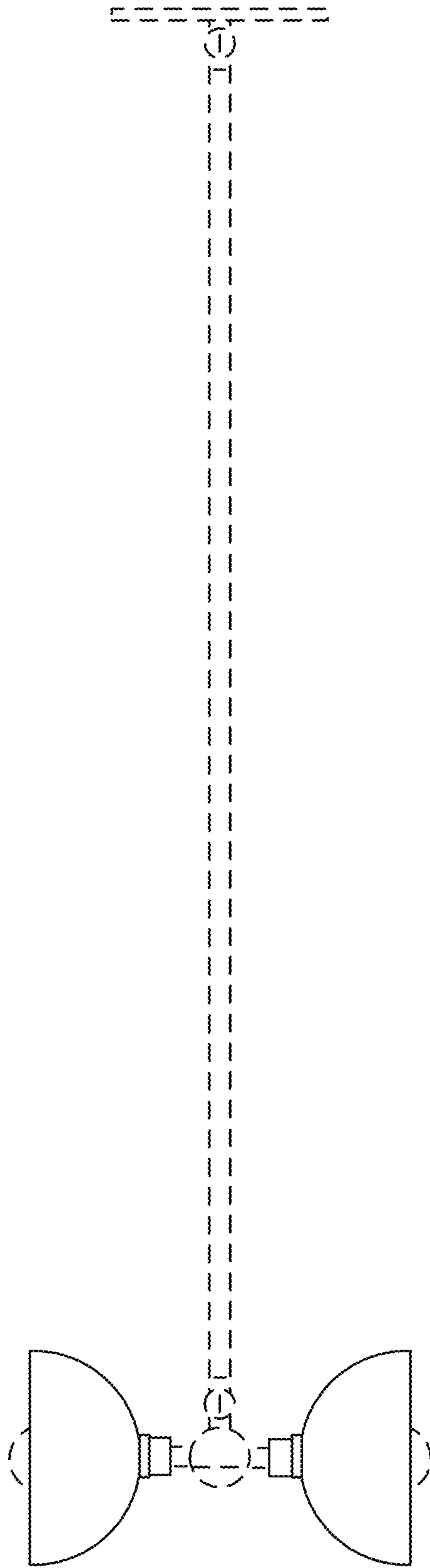
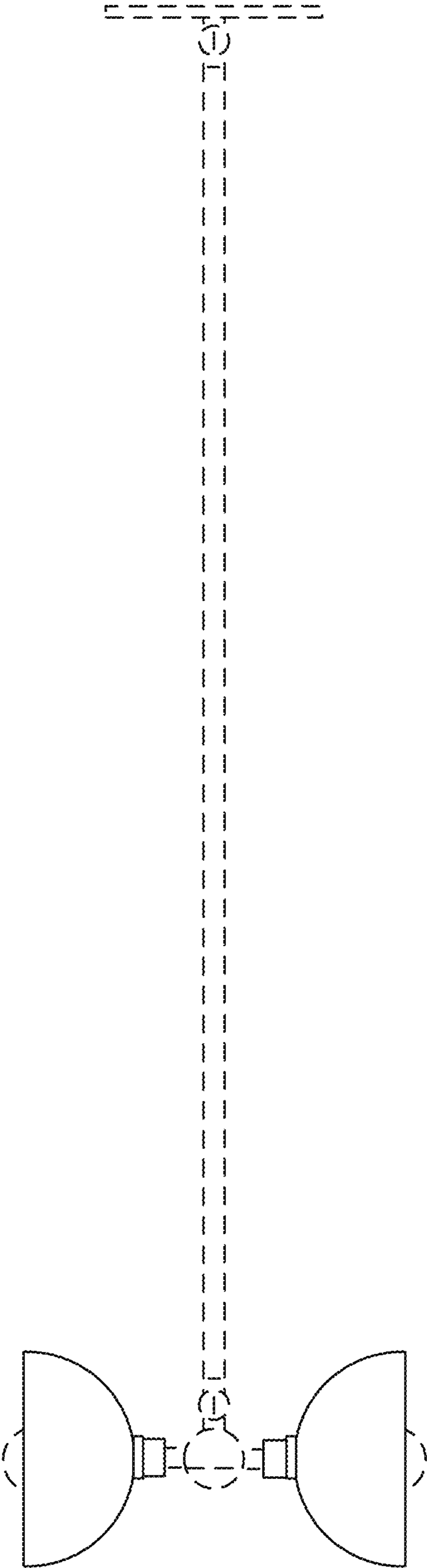

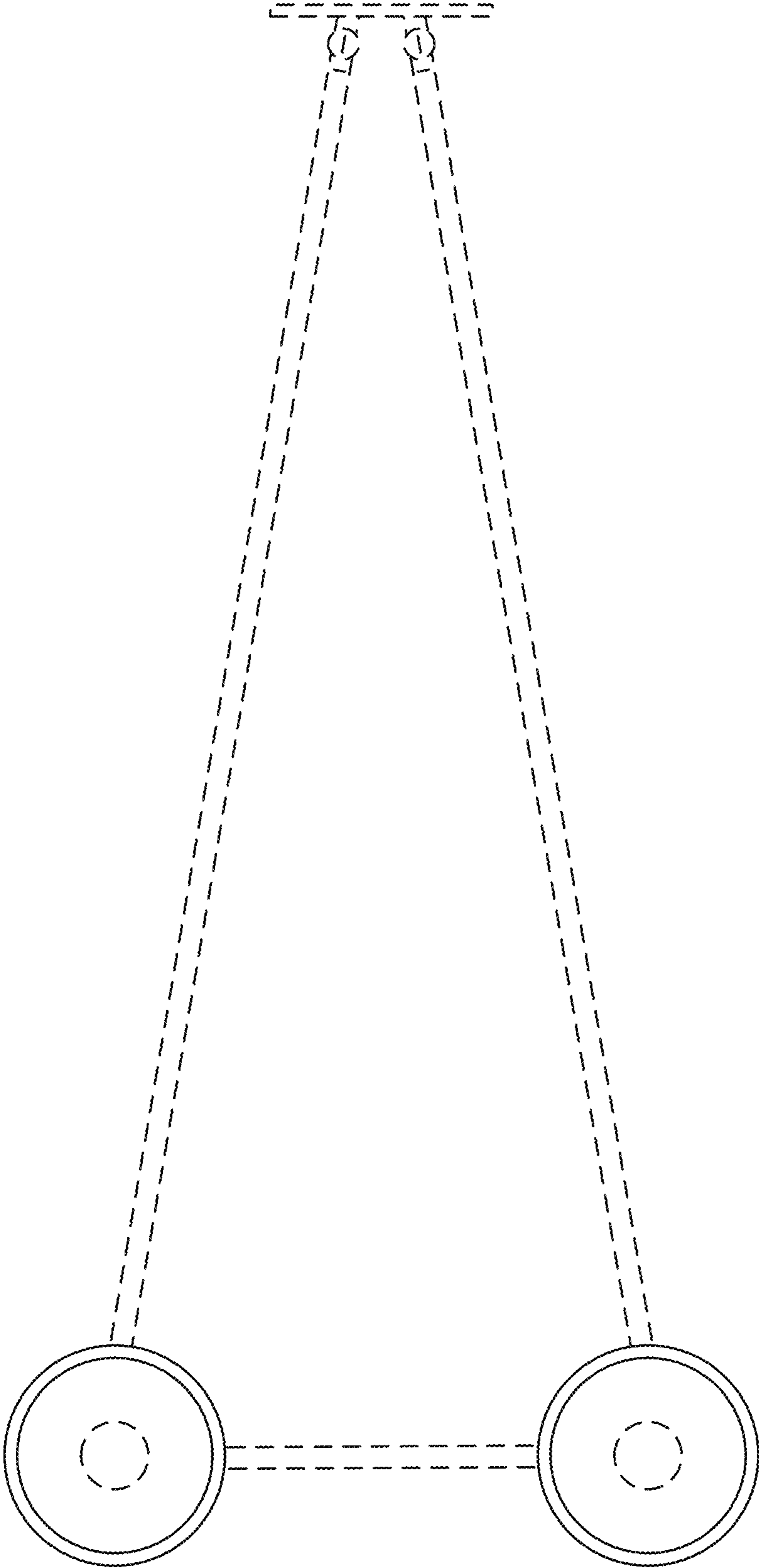
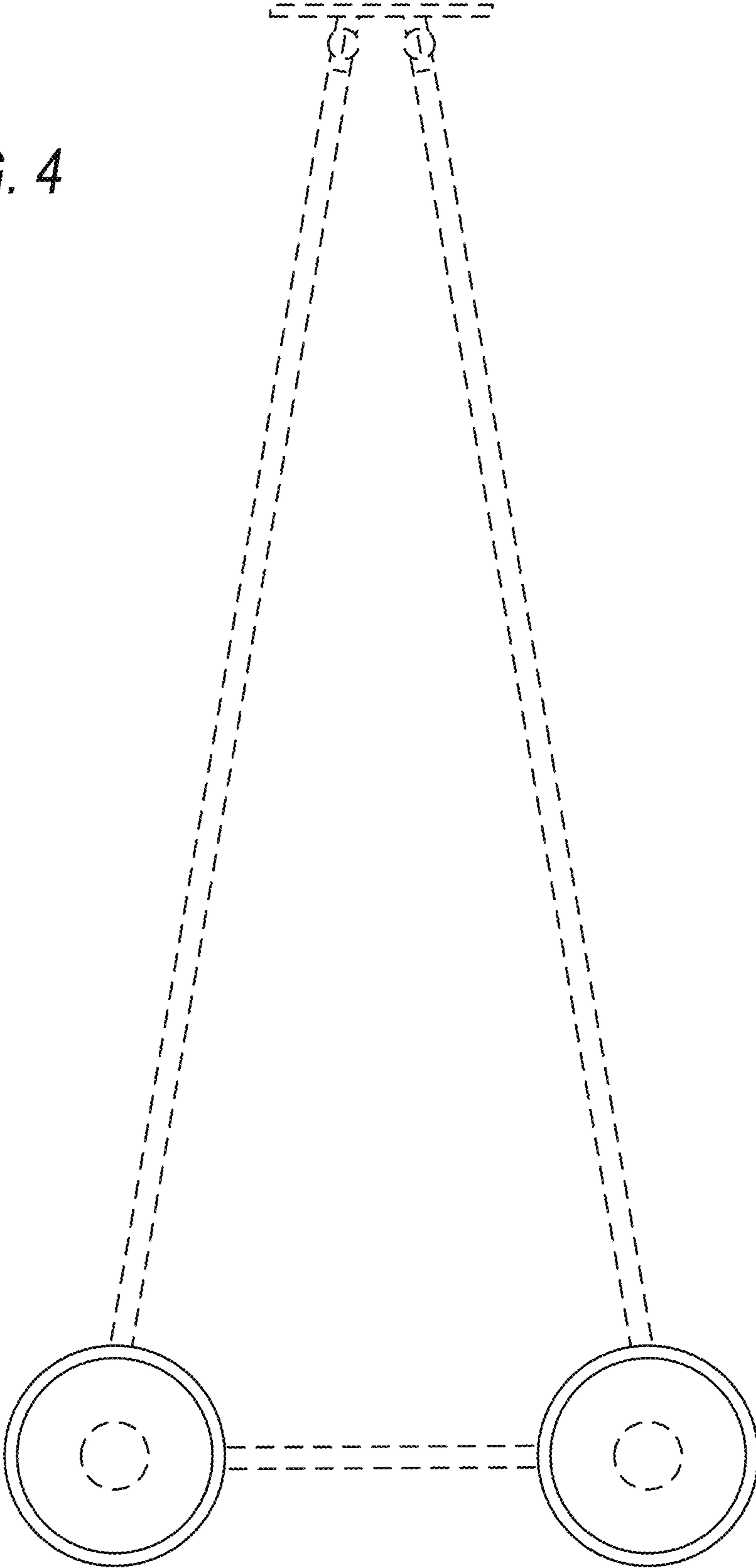

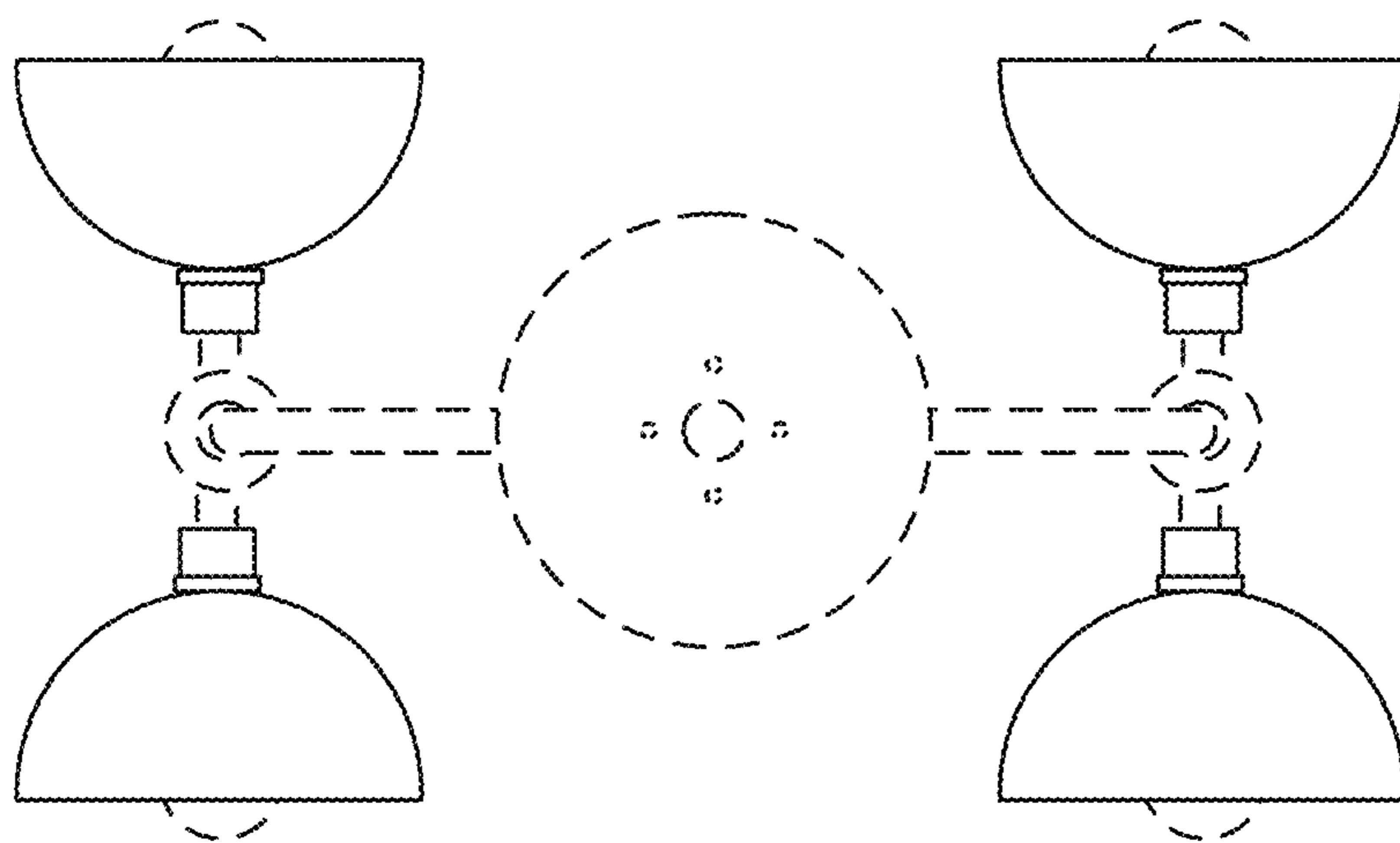

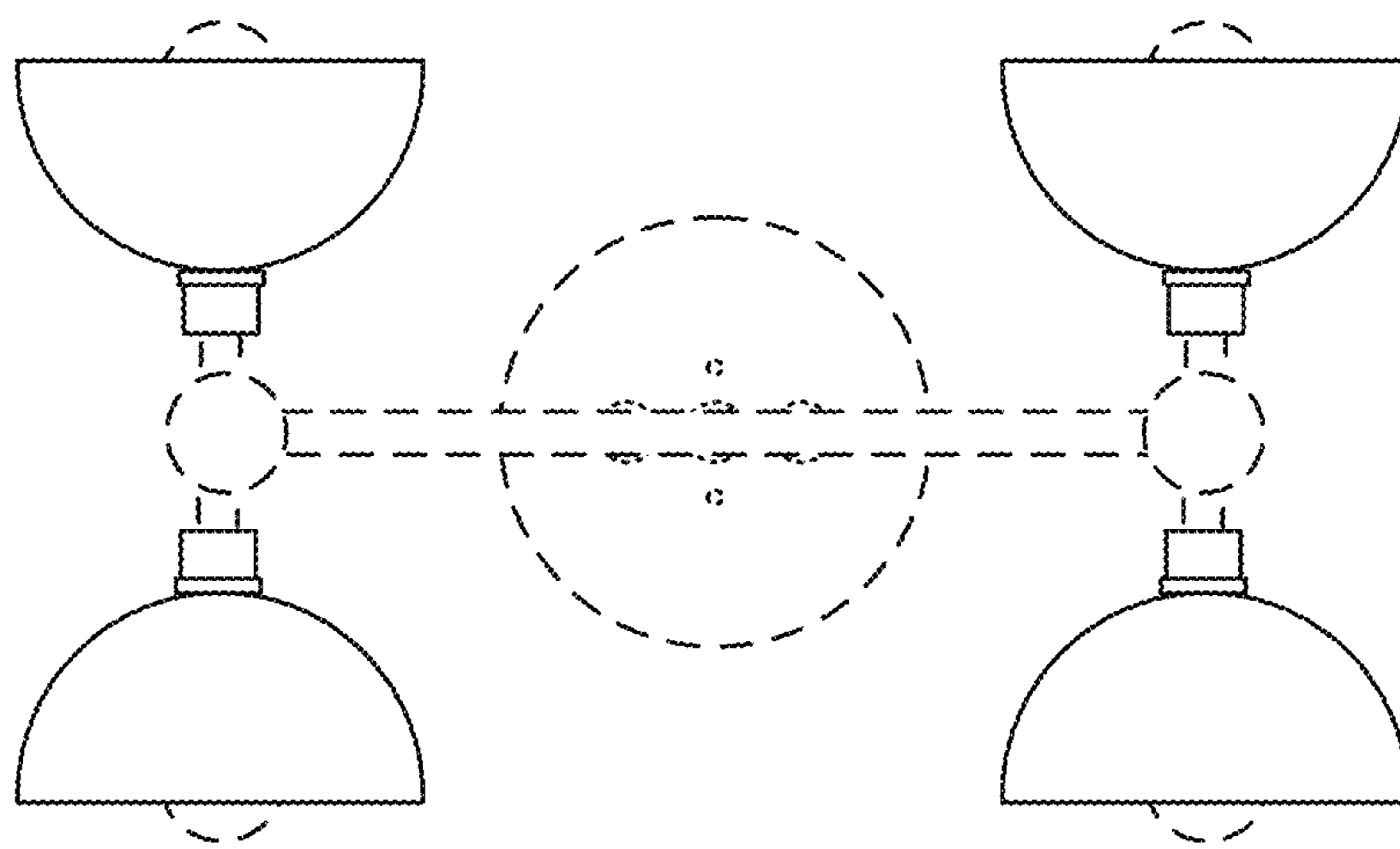
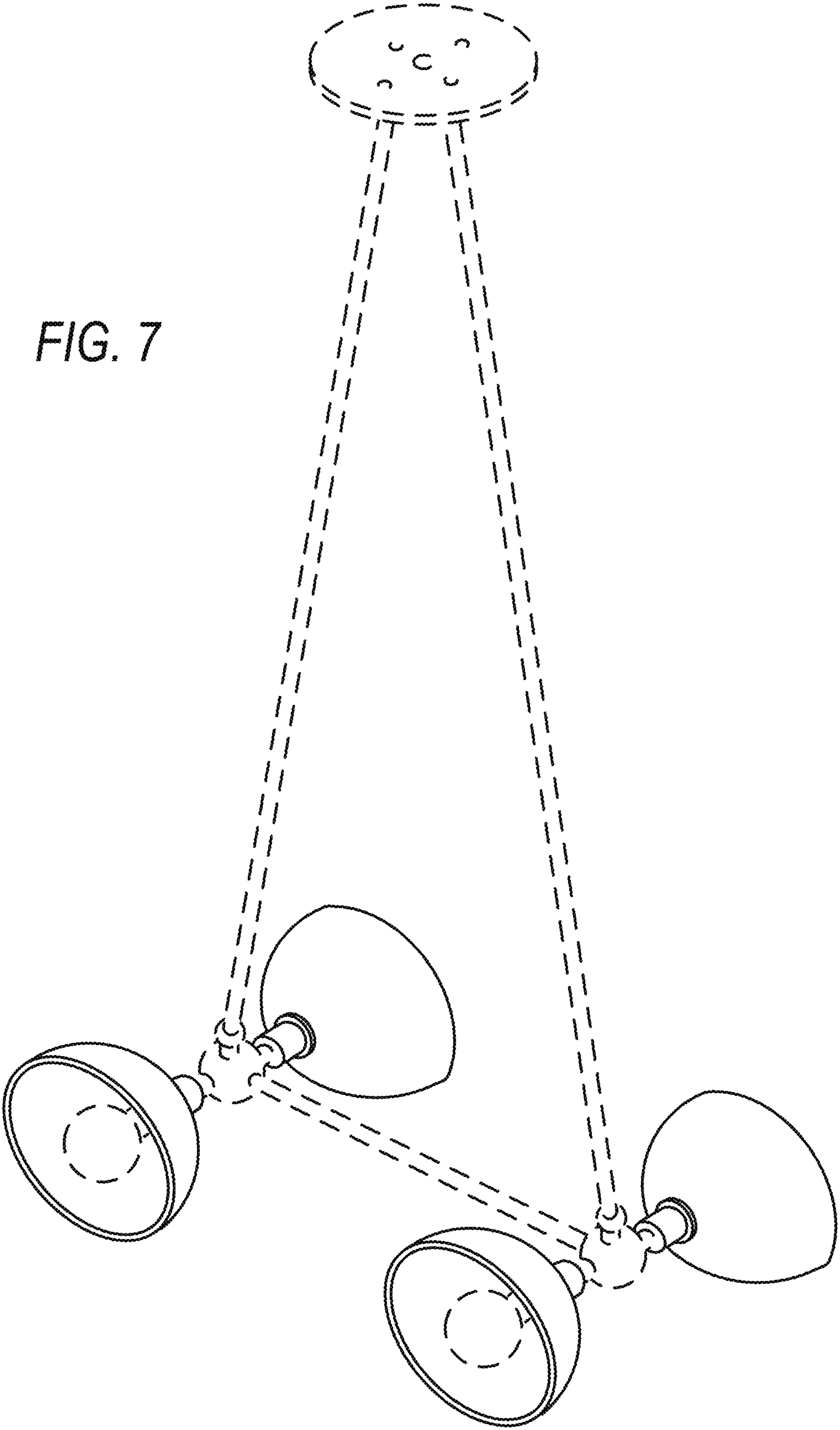

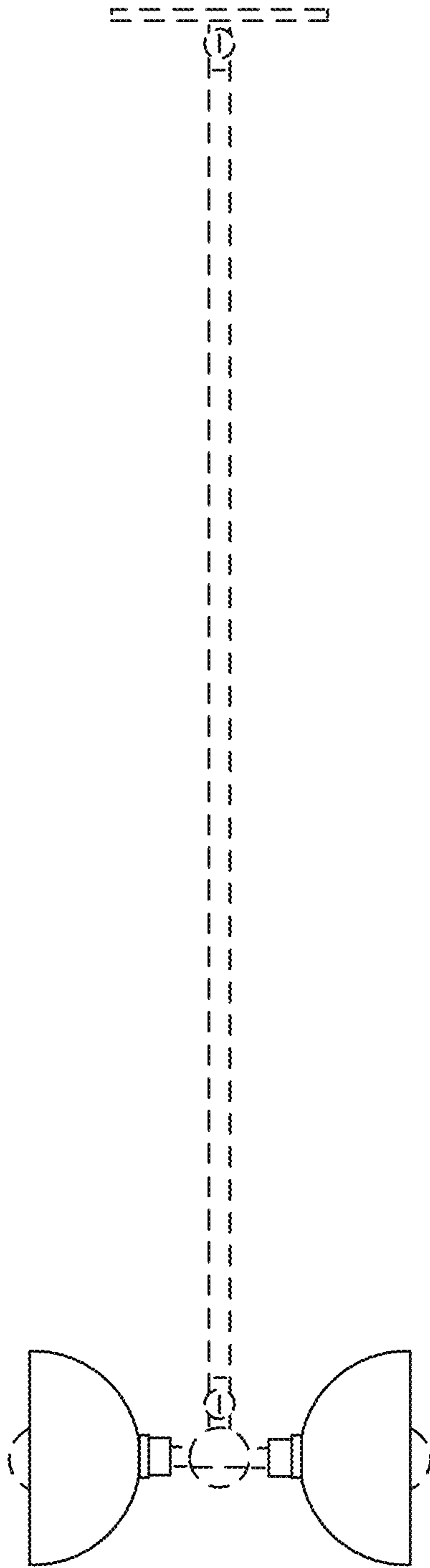

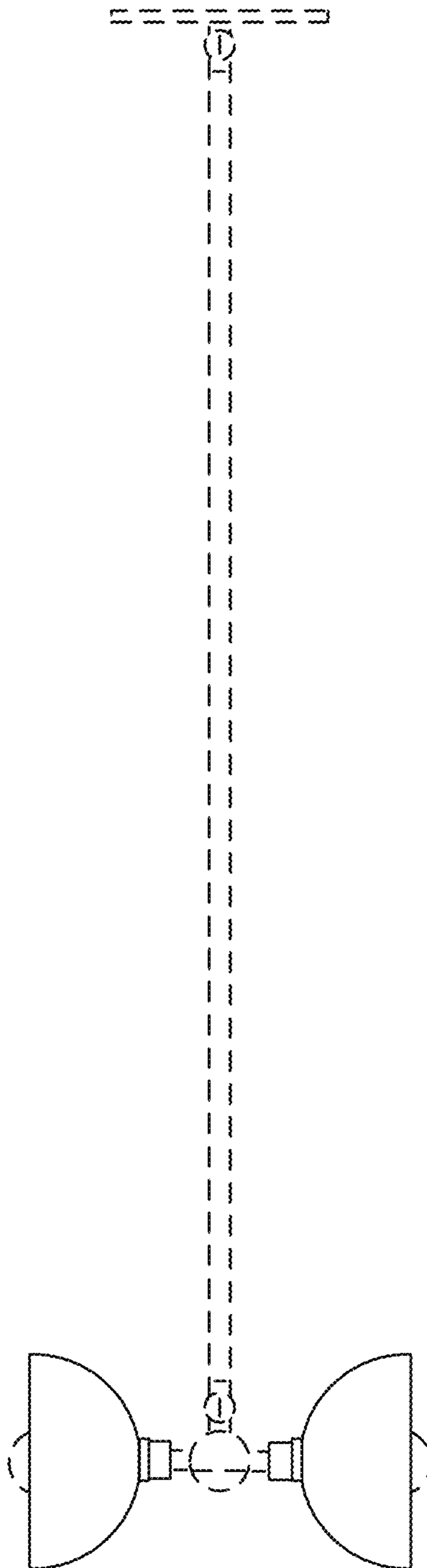

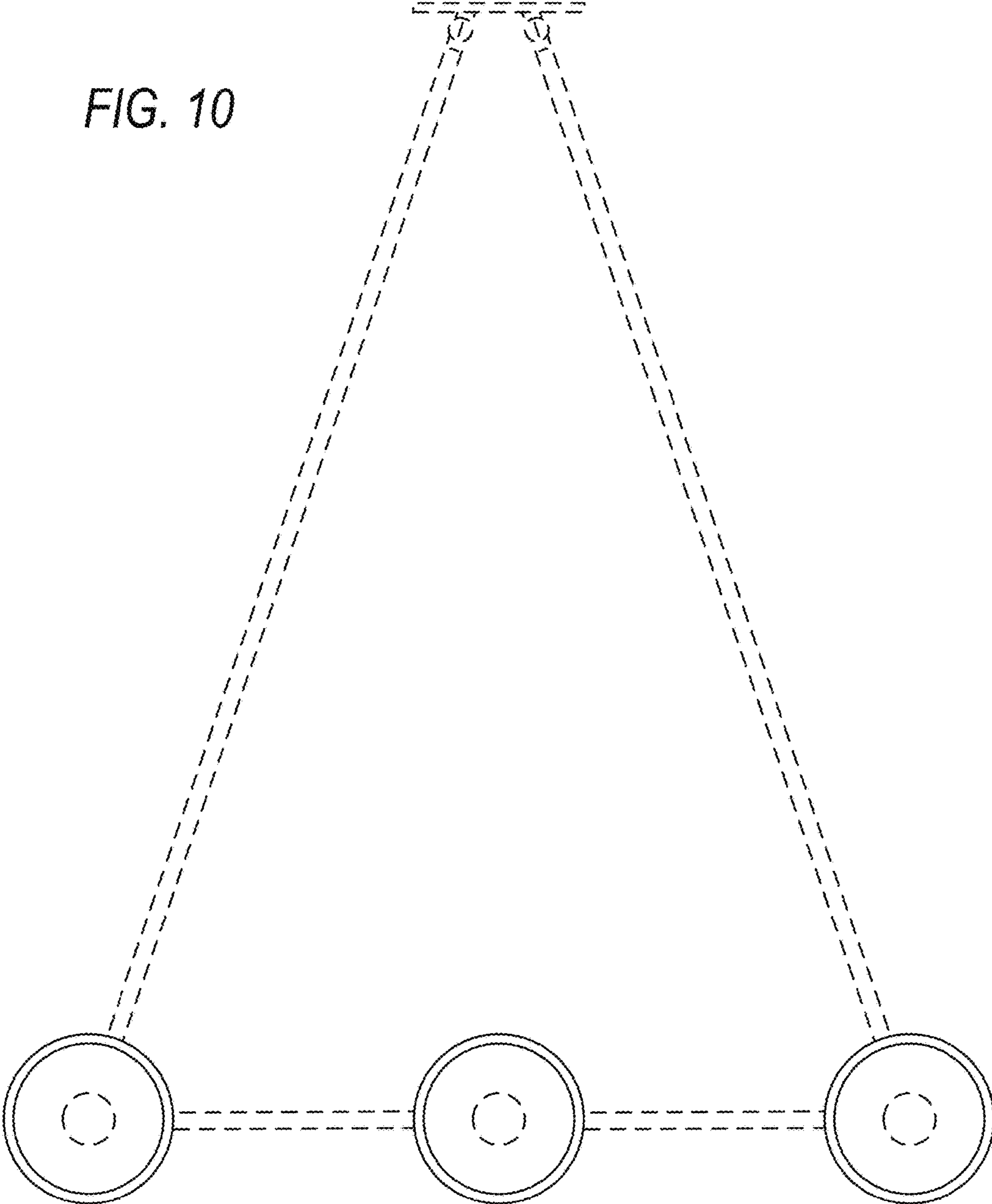
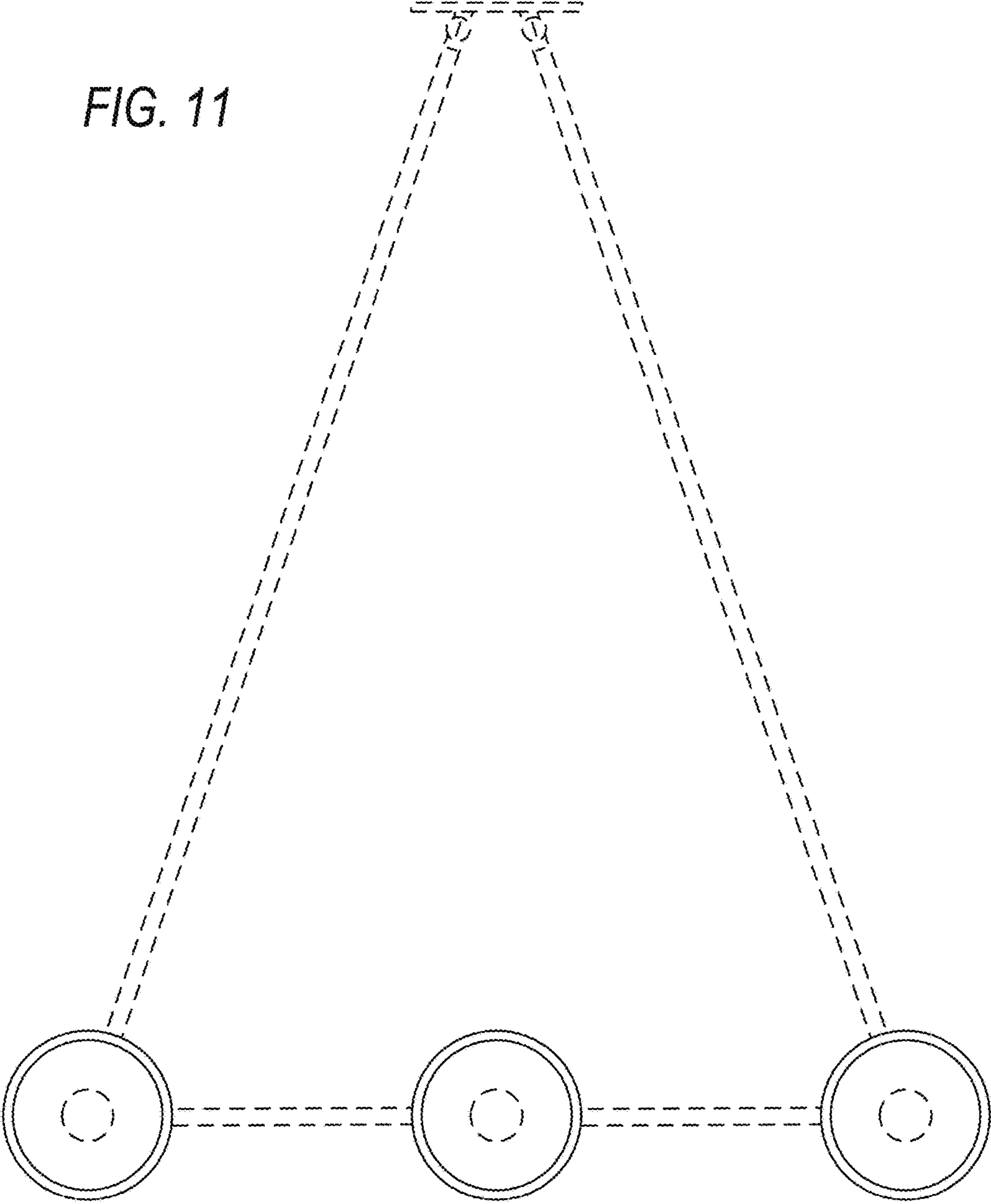

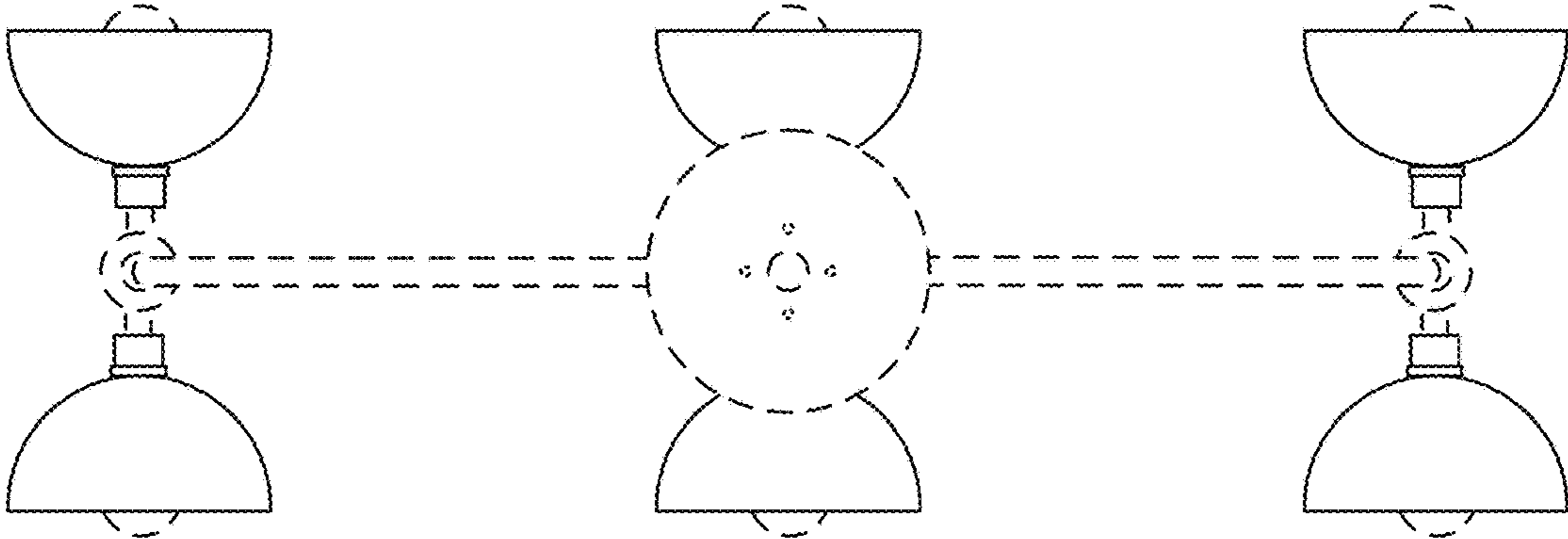

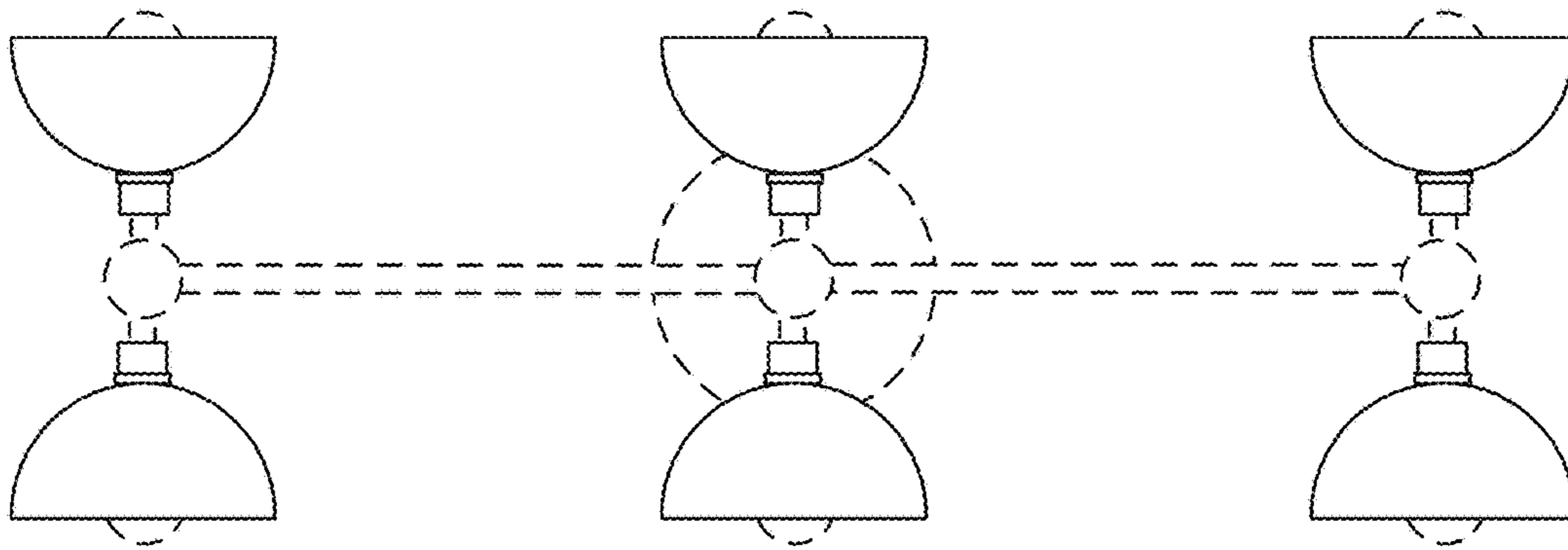

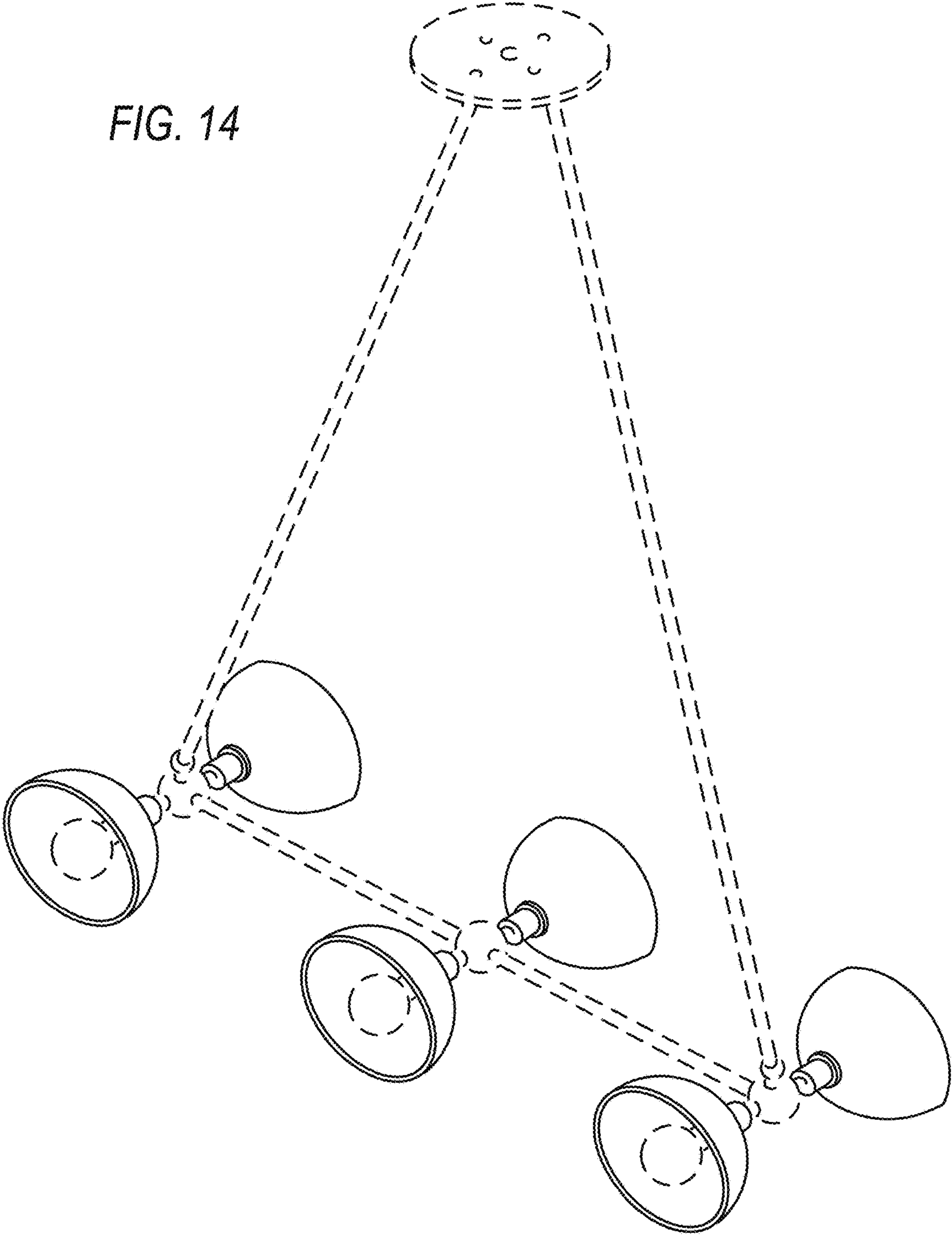

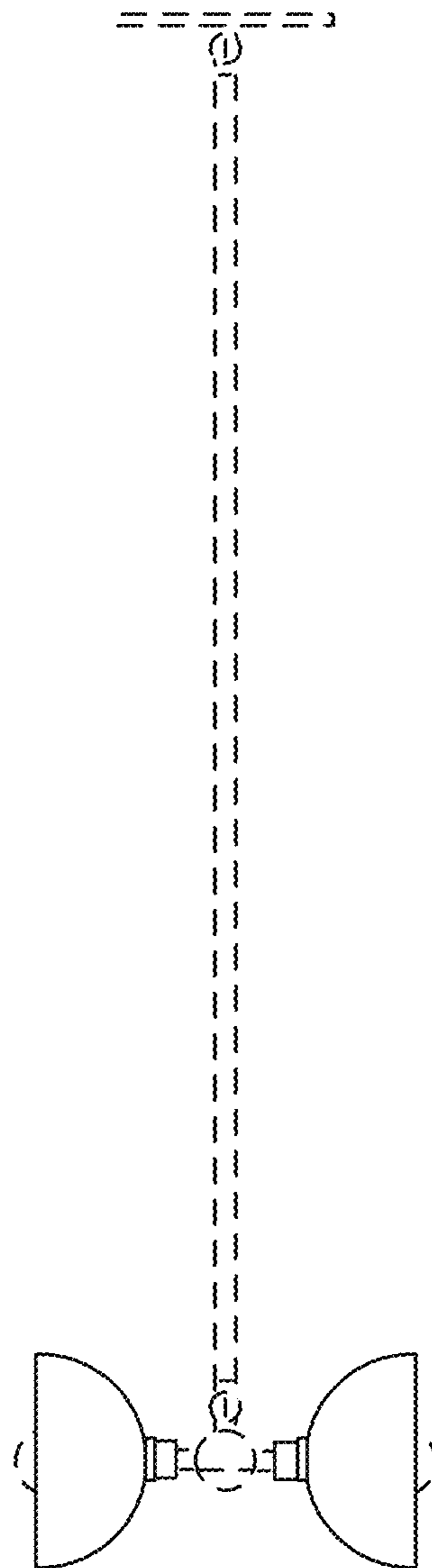
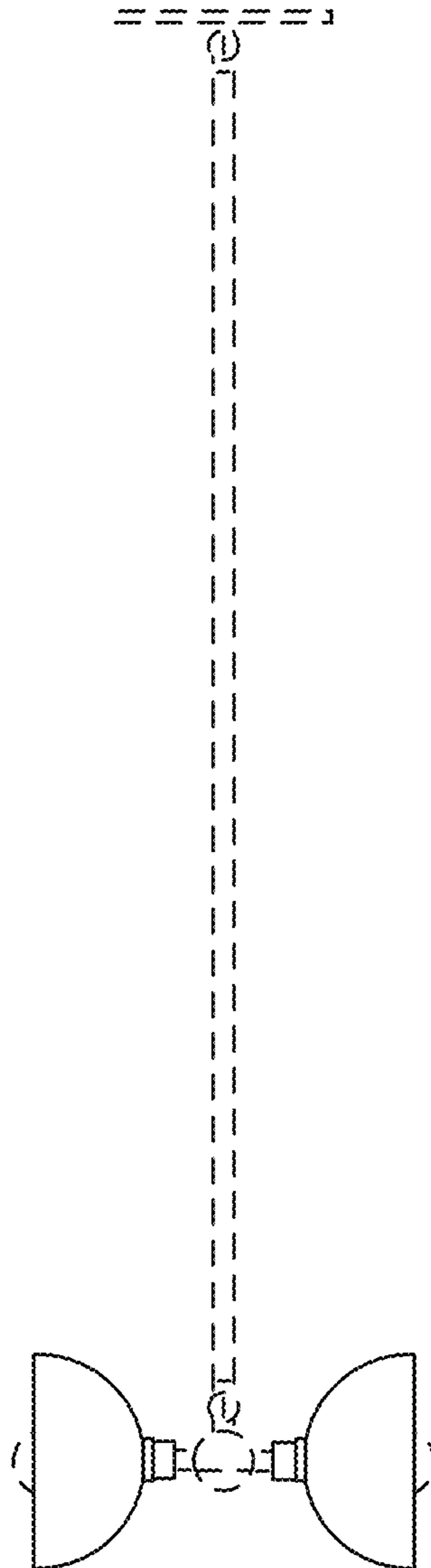

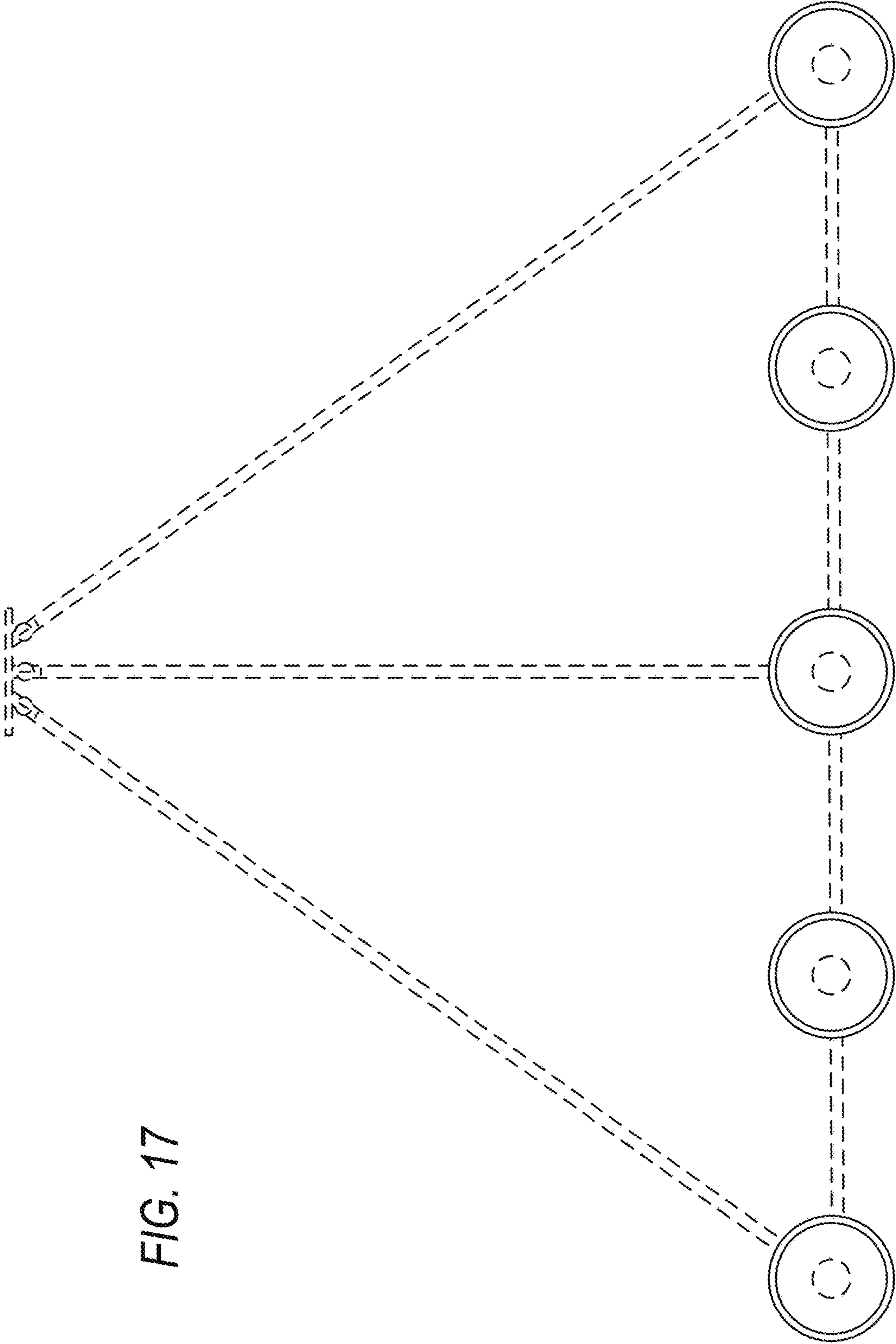

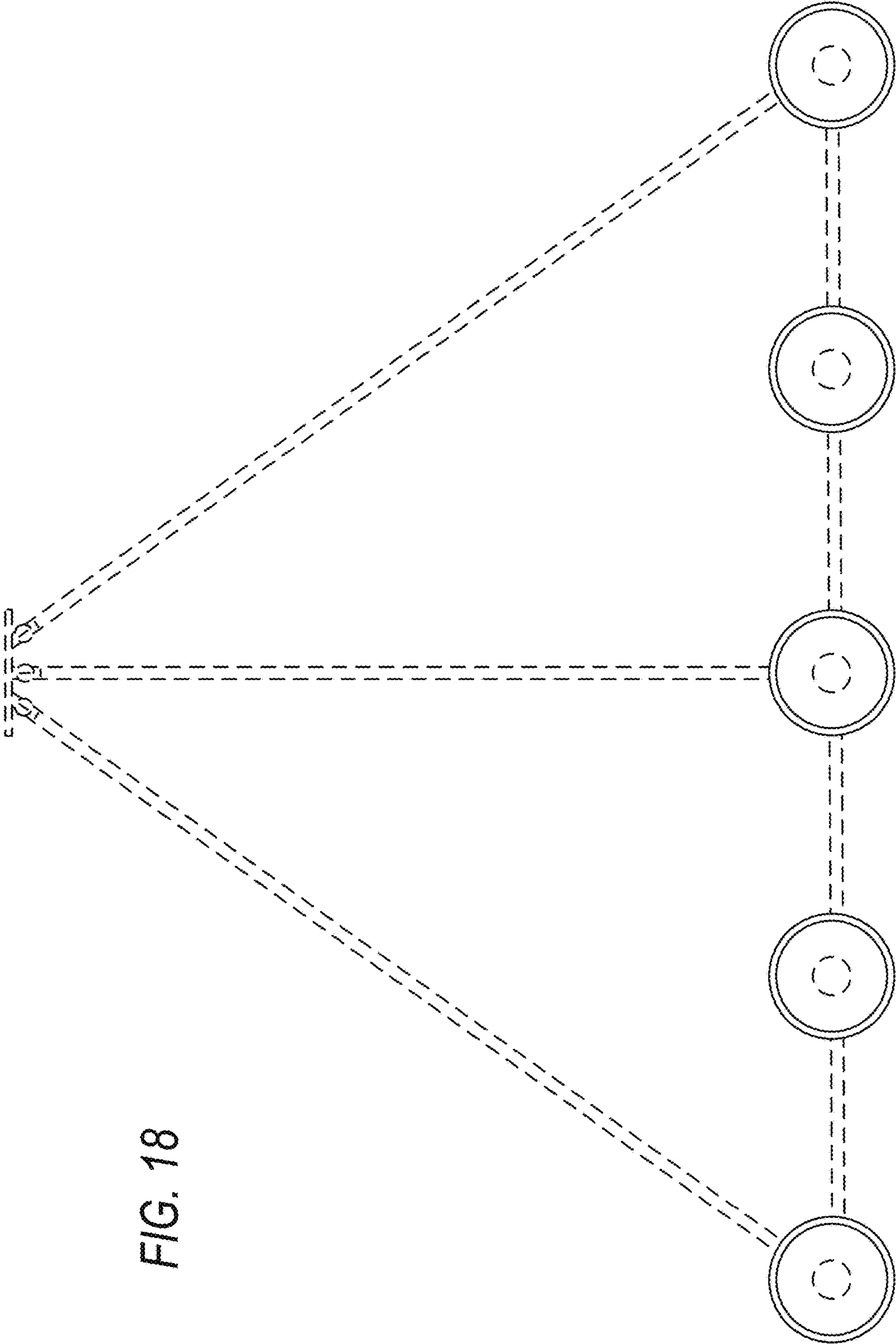

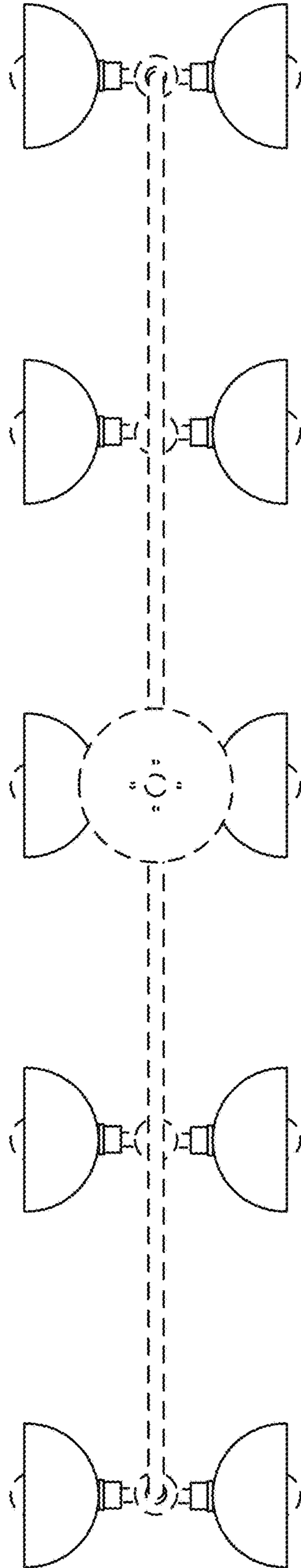

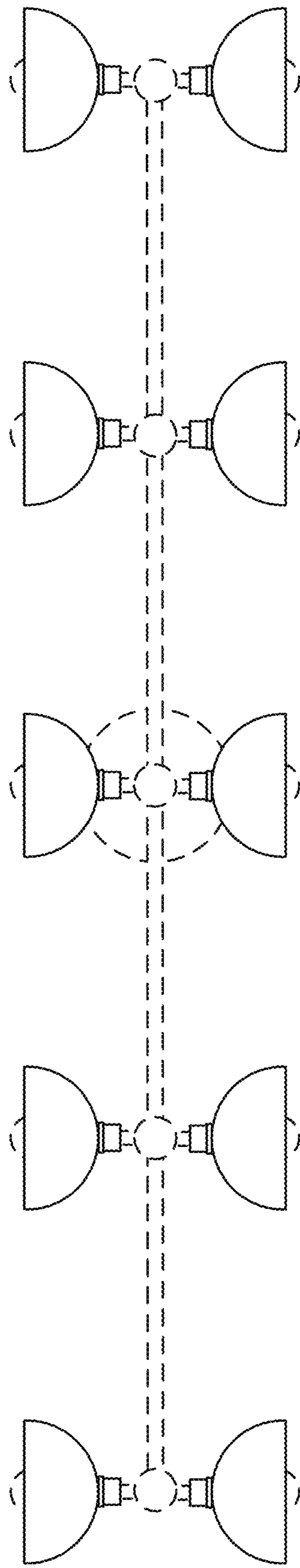

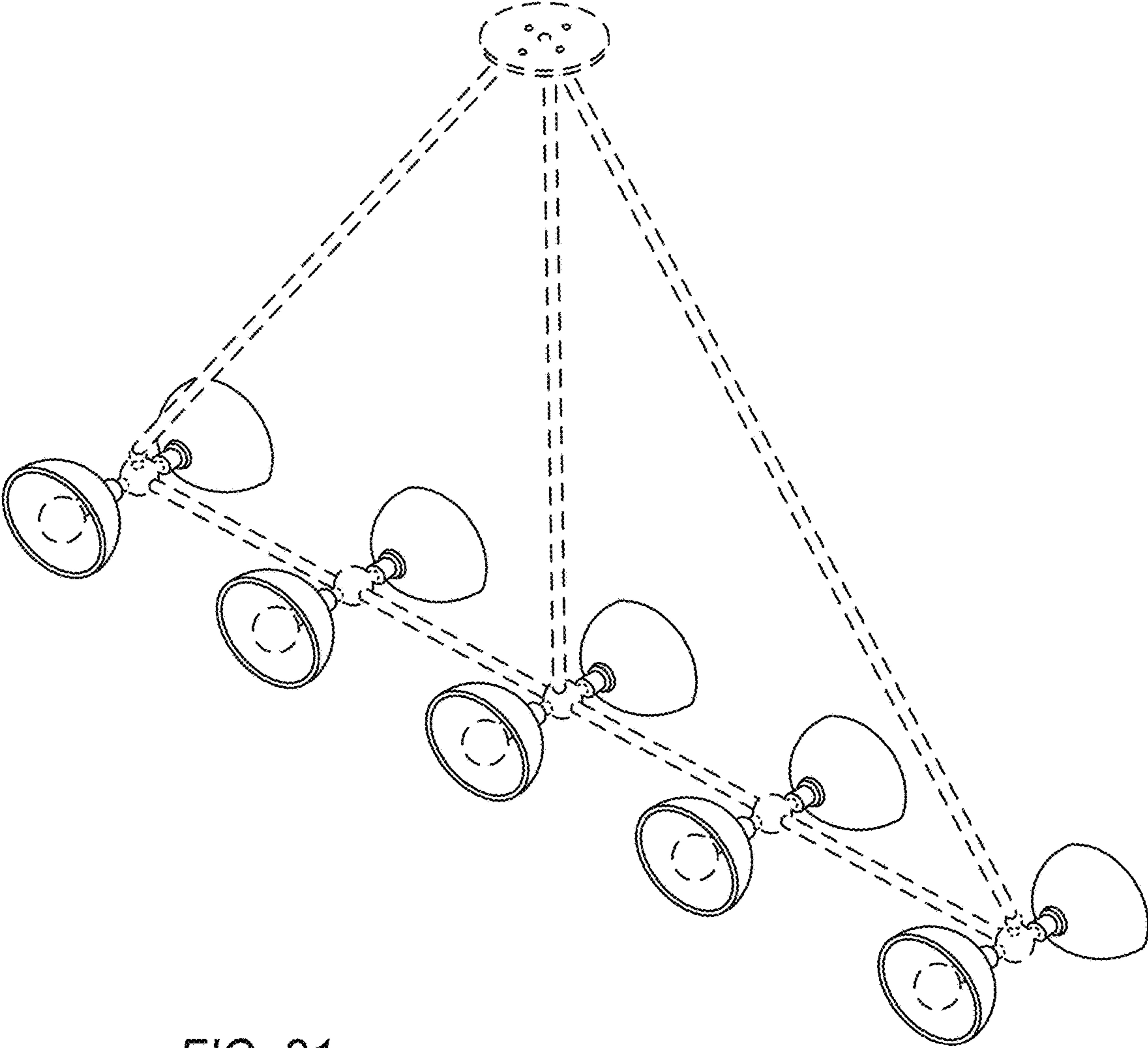
