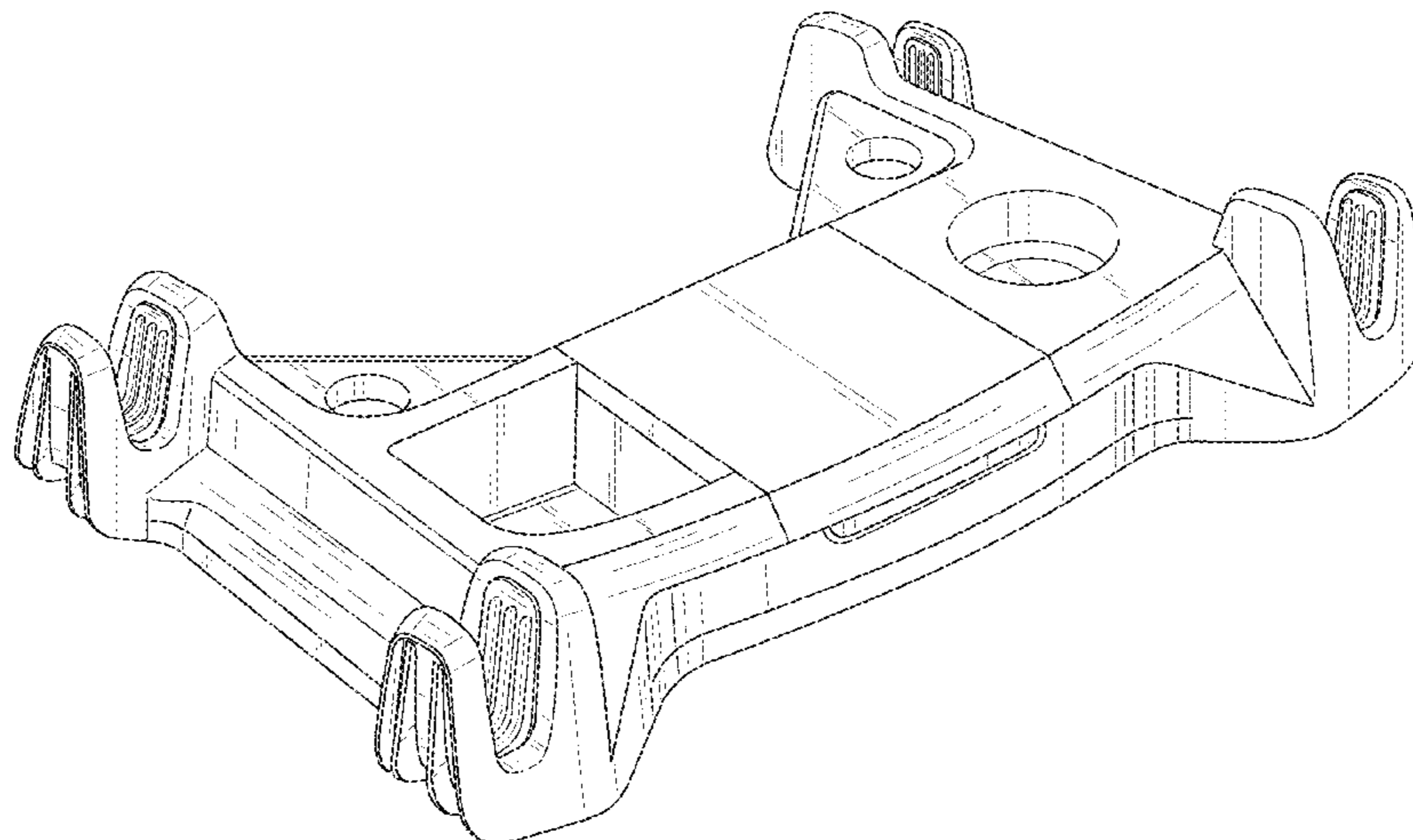
(57) **CLAIM**

The ornamental design for a carrier attachment for a vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a carrier attachment for a vehicle showing my new design; FIG. 2 a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a right side elevation view thereof, the left side elevation view being a mirror image of the right side elevation view; FIG. 5 is a rear elevation view thereof; and, FIG. 6 is a front elevation view thereof. The dashed broken lines in FIG. 3 are to show portions of the carrier attachment for a vehicle and form no part of the claimed design.

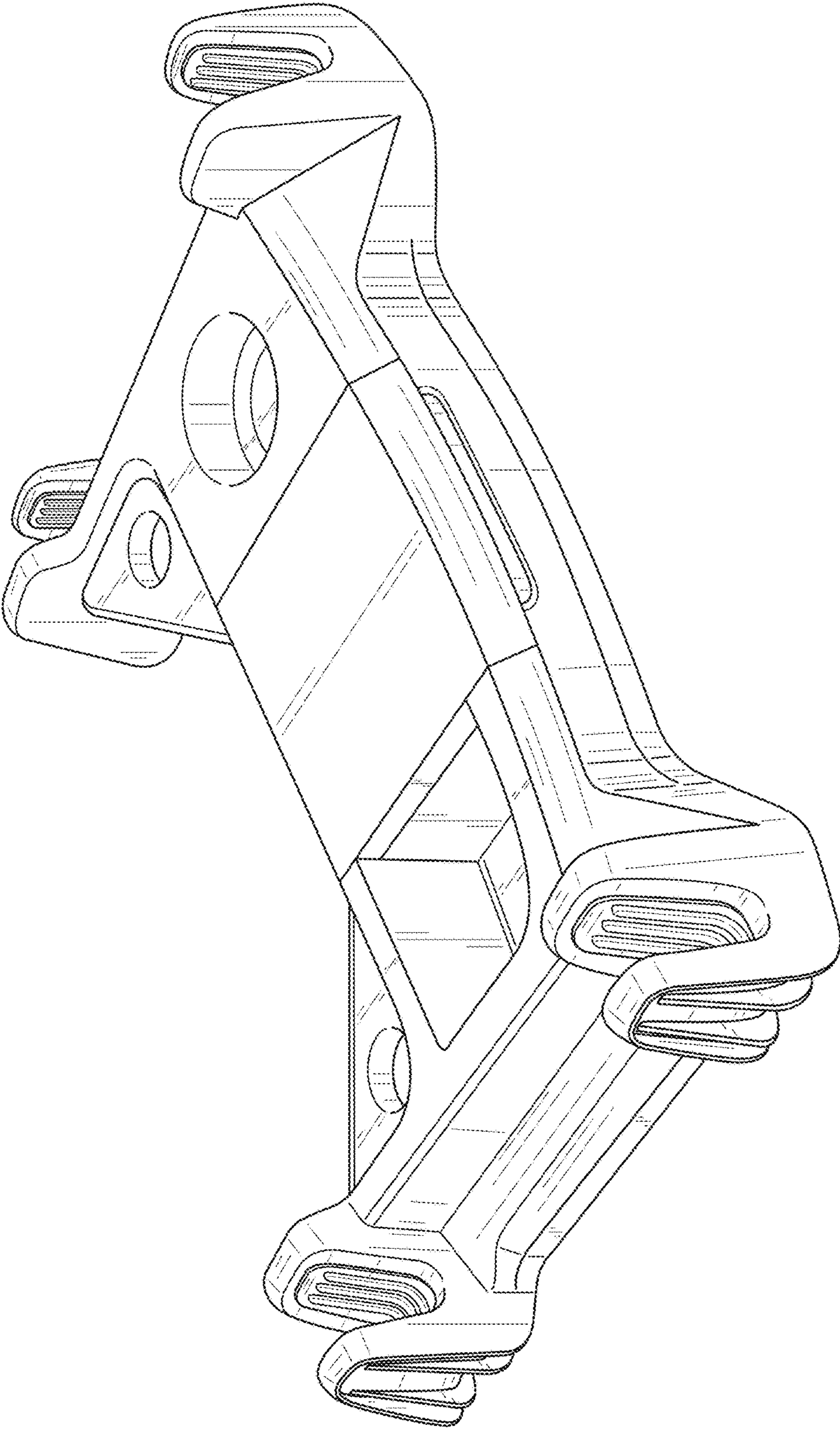

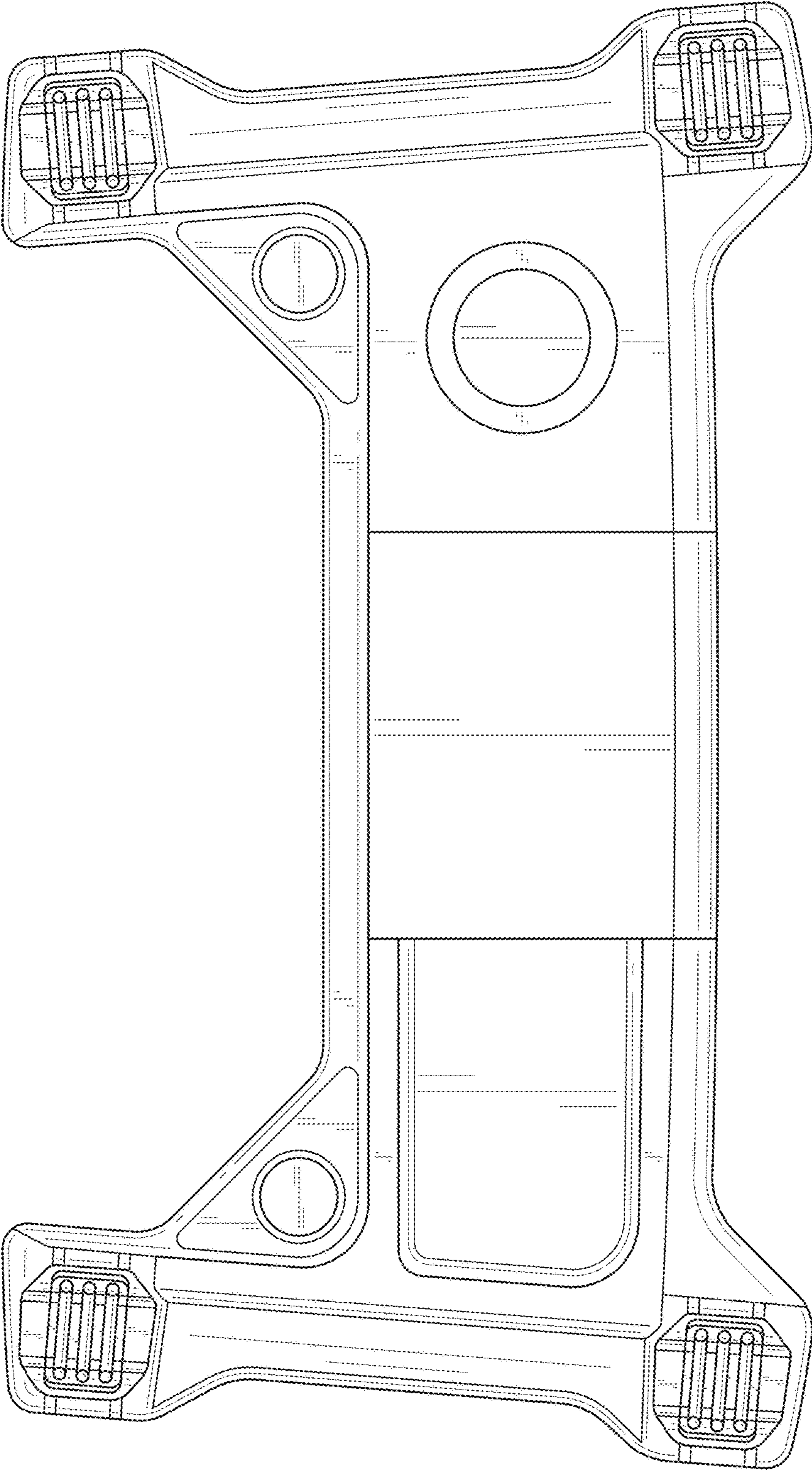

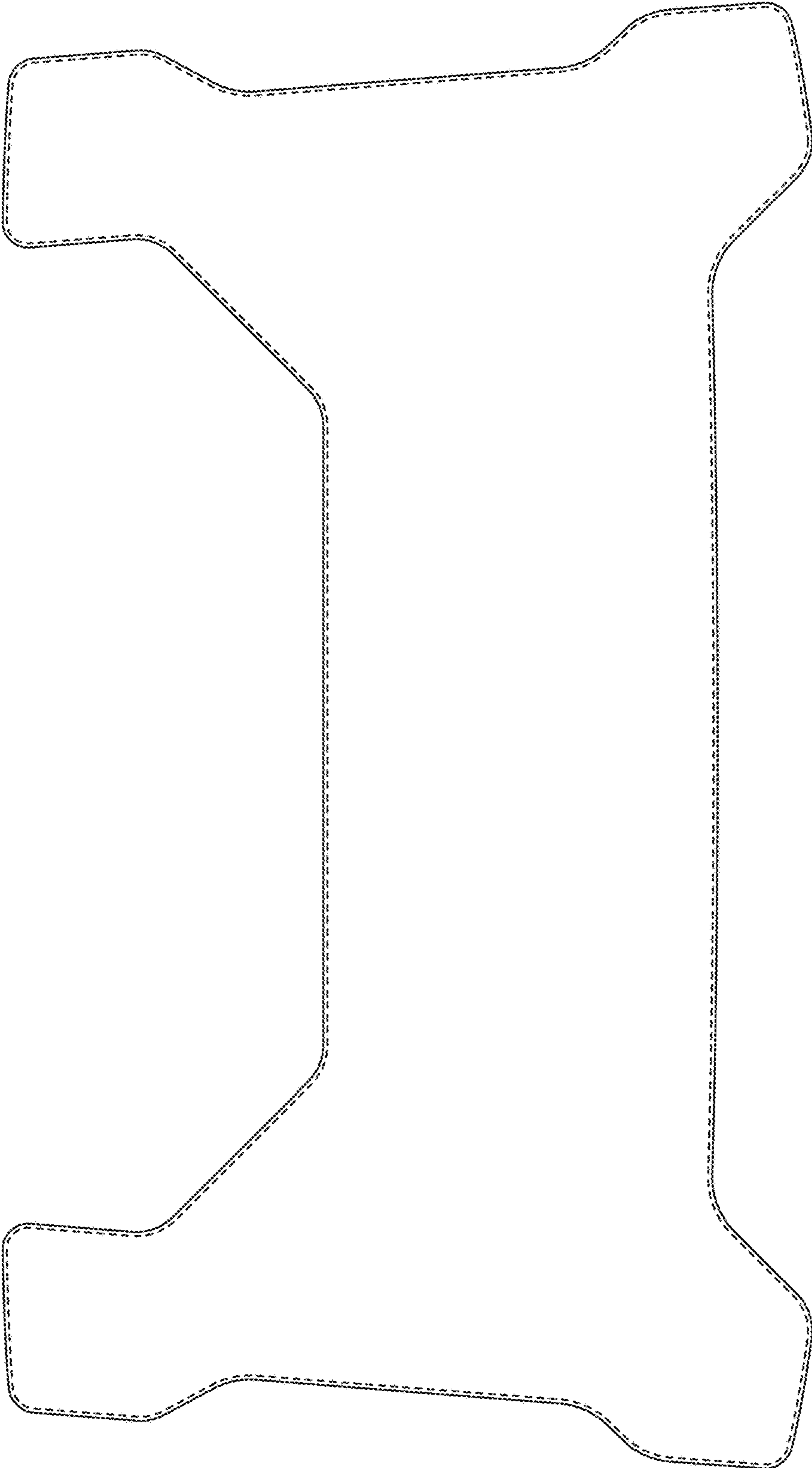

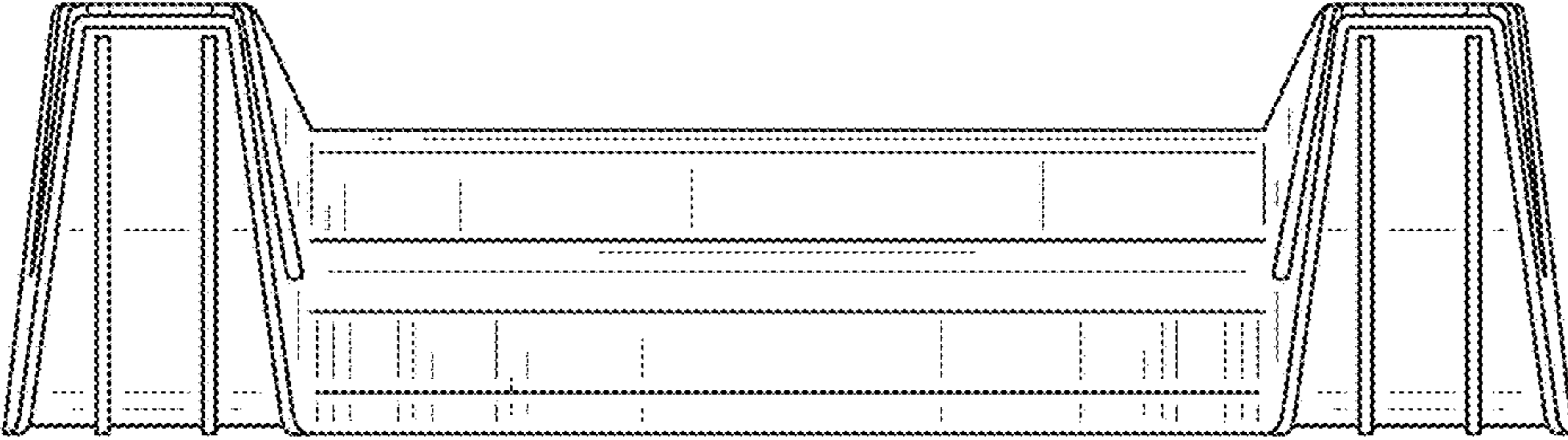

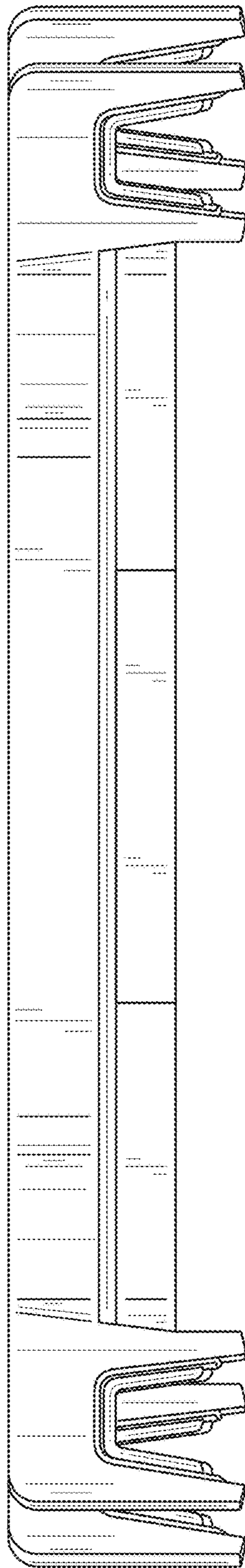

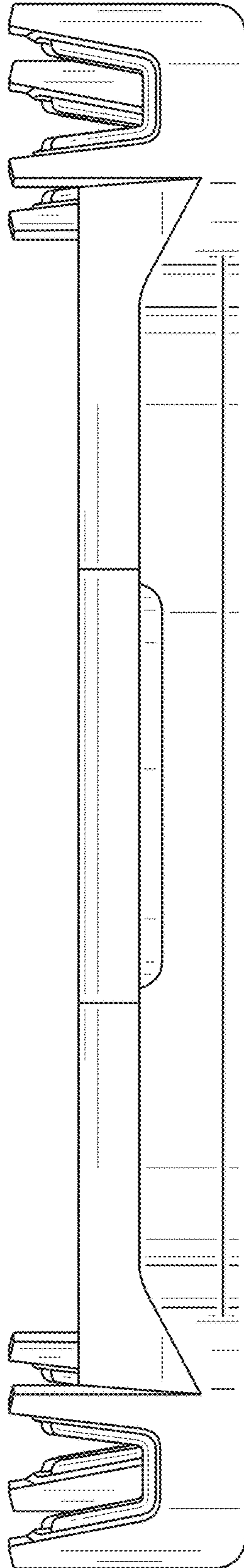
