DESCRIPTION

FIG. 11 is a left side view of a second embodiment of the pet treat;

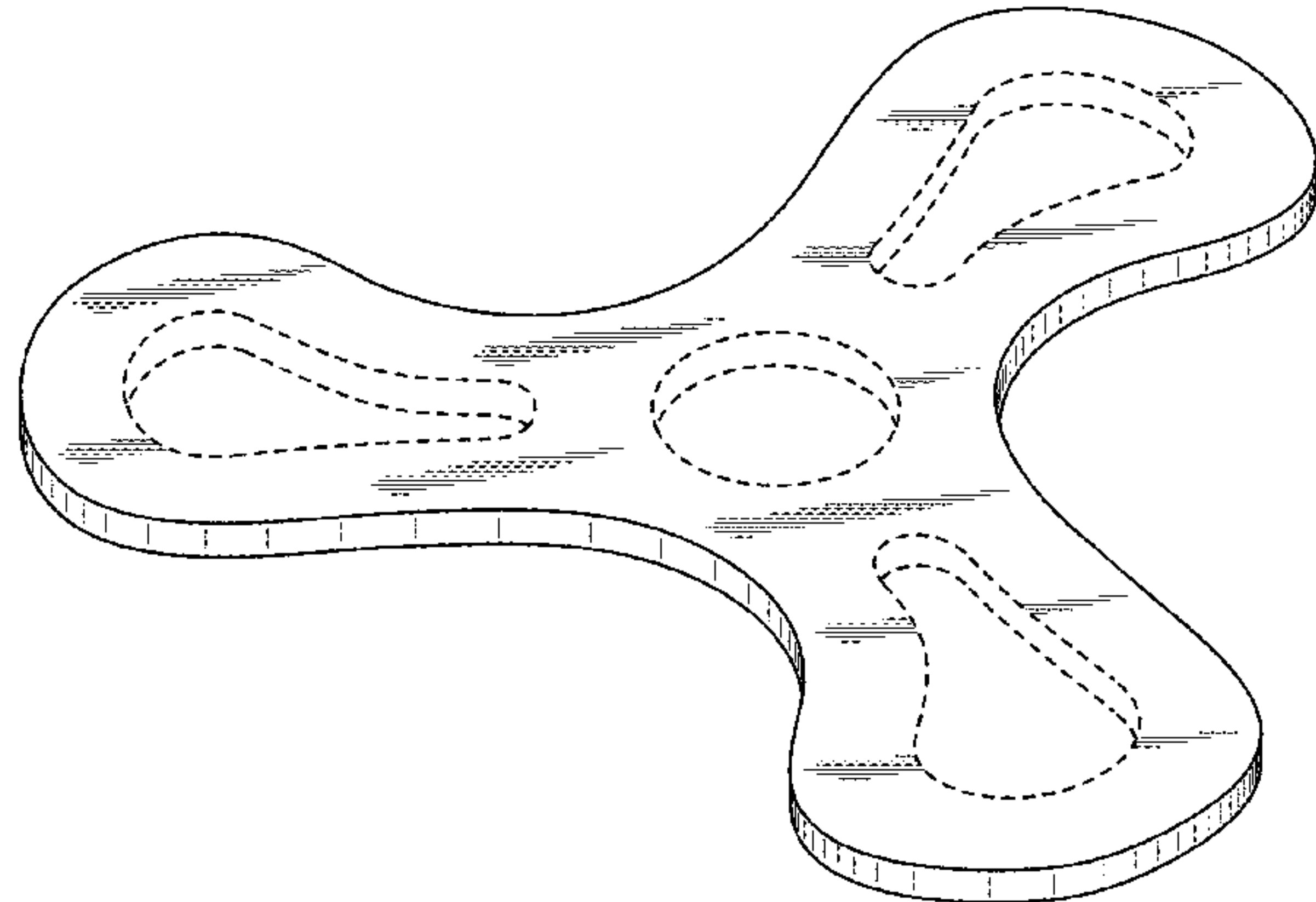
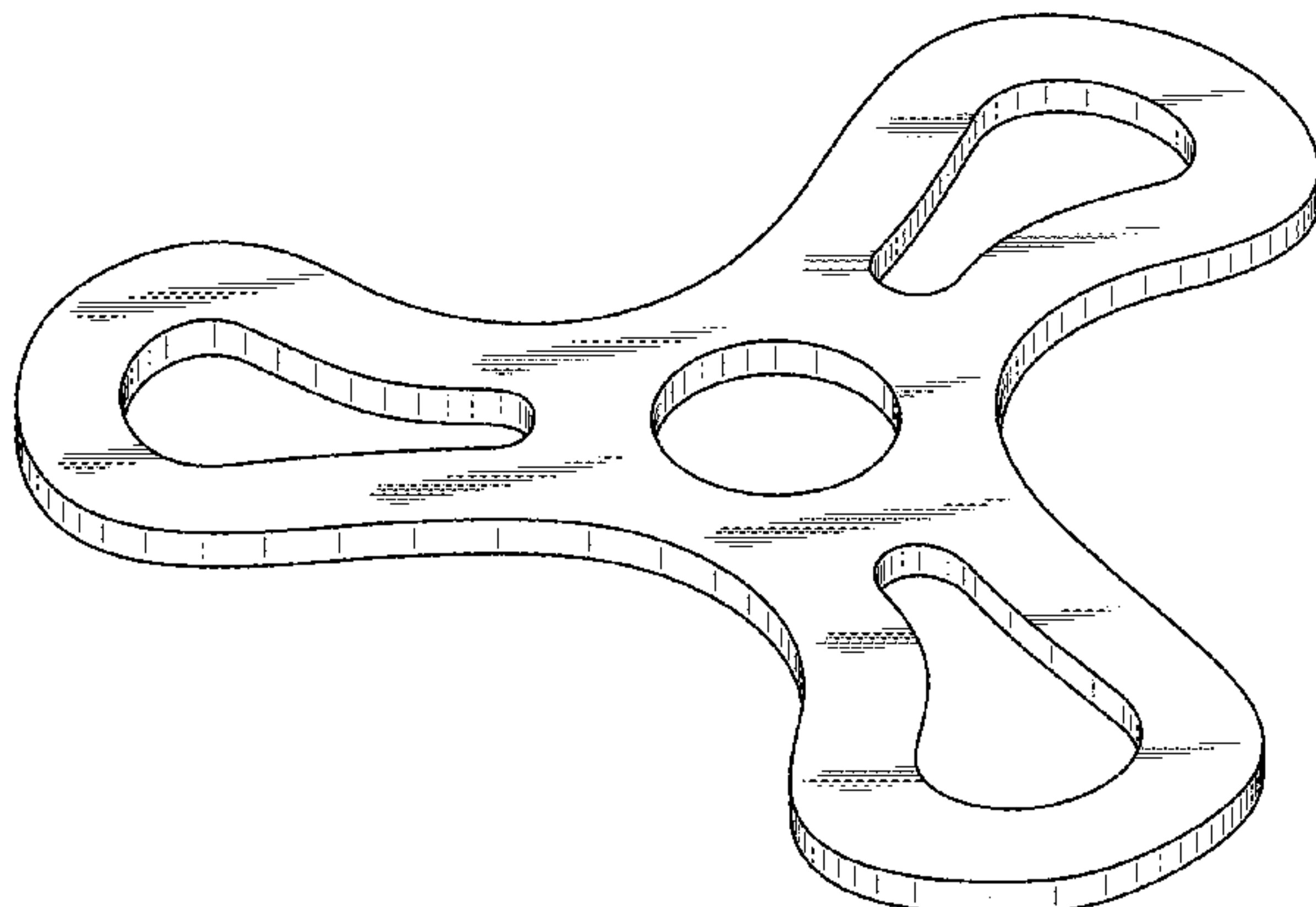
FIG. 12 is a right side view of a second embodiment of the pet treat;

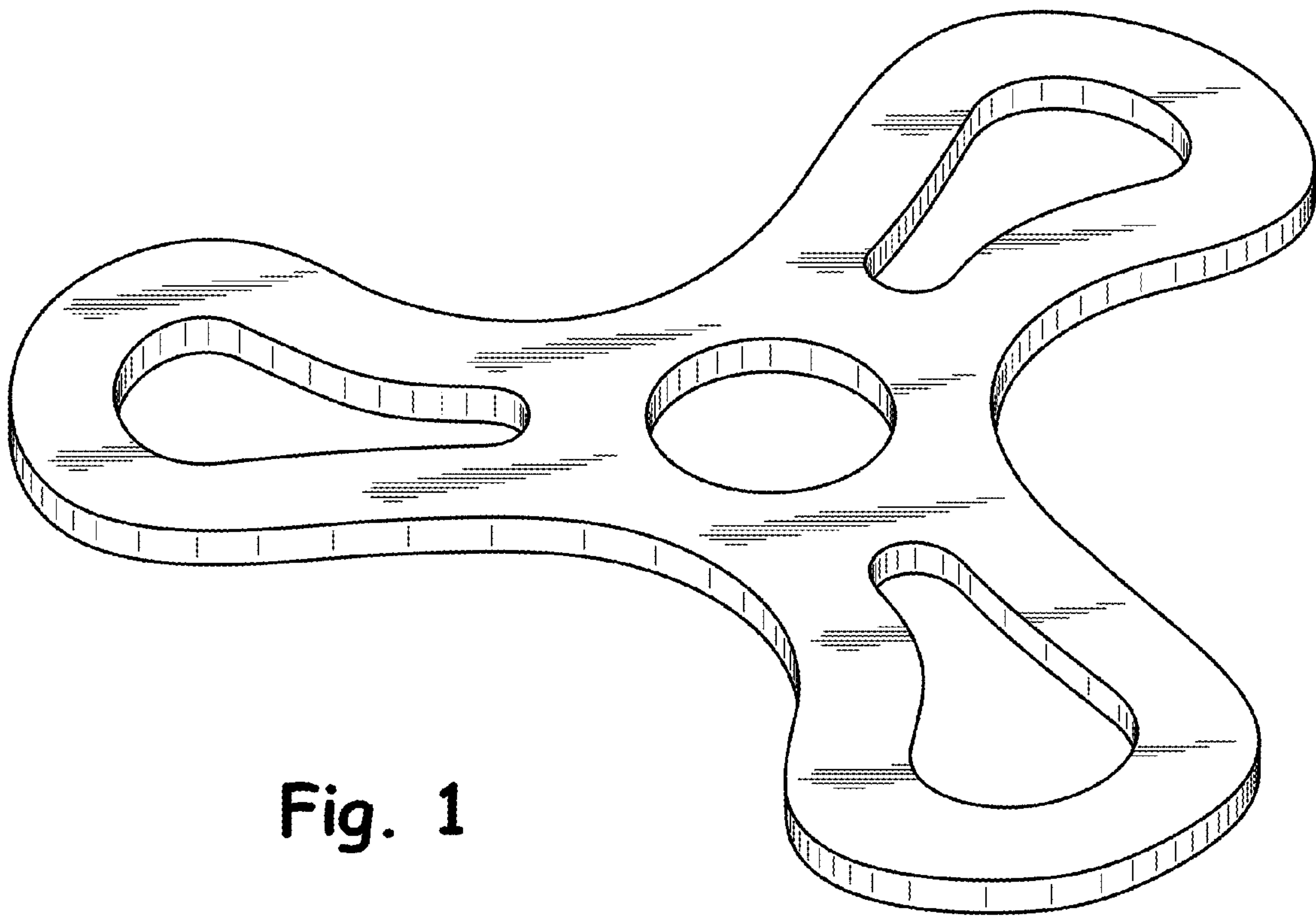
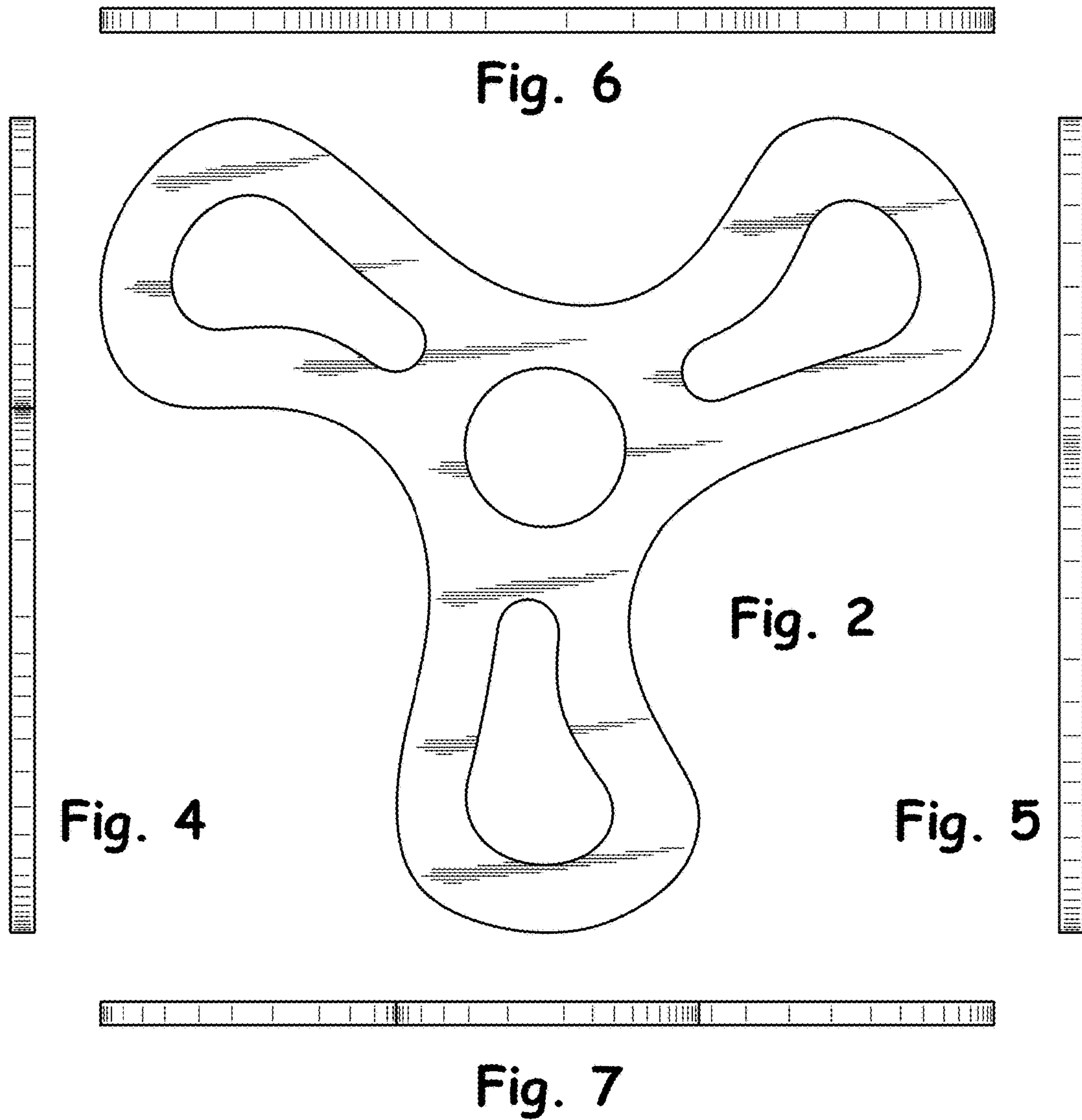

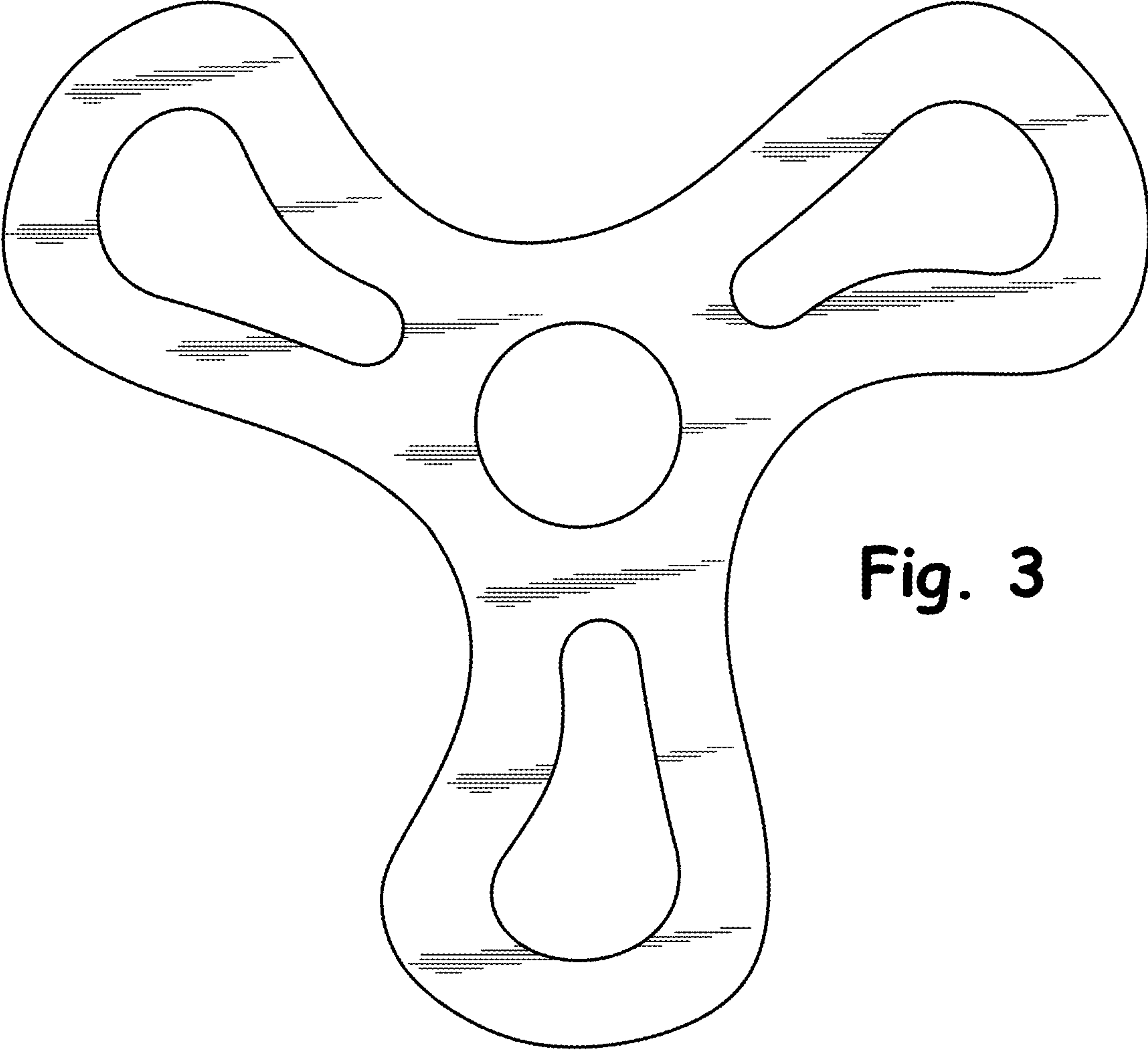

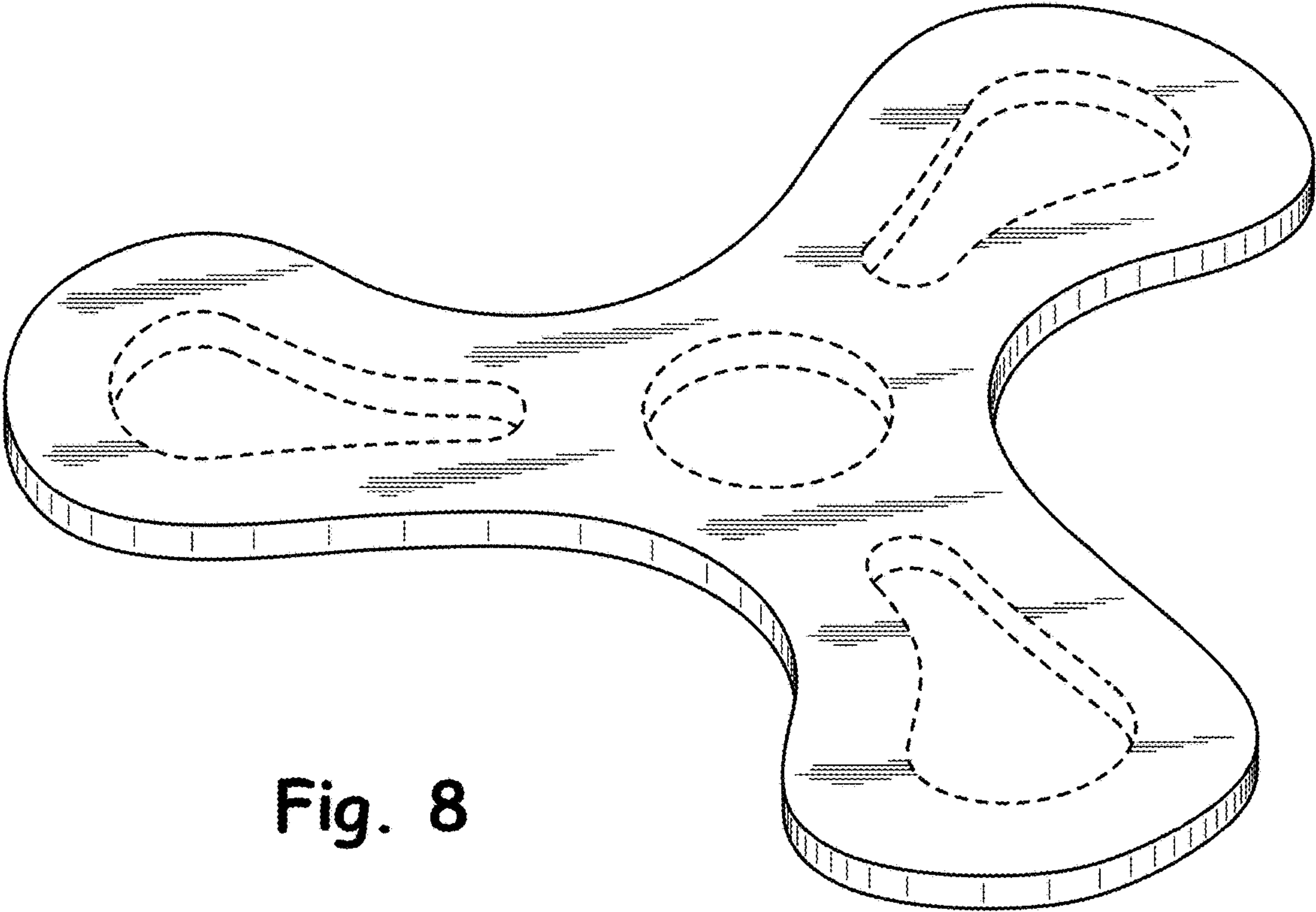

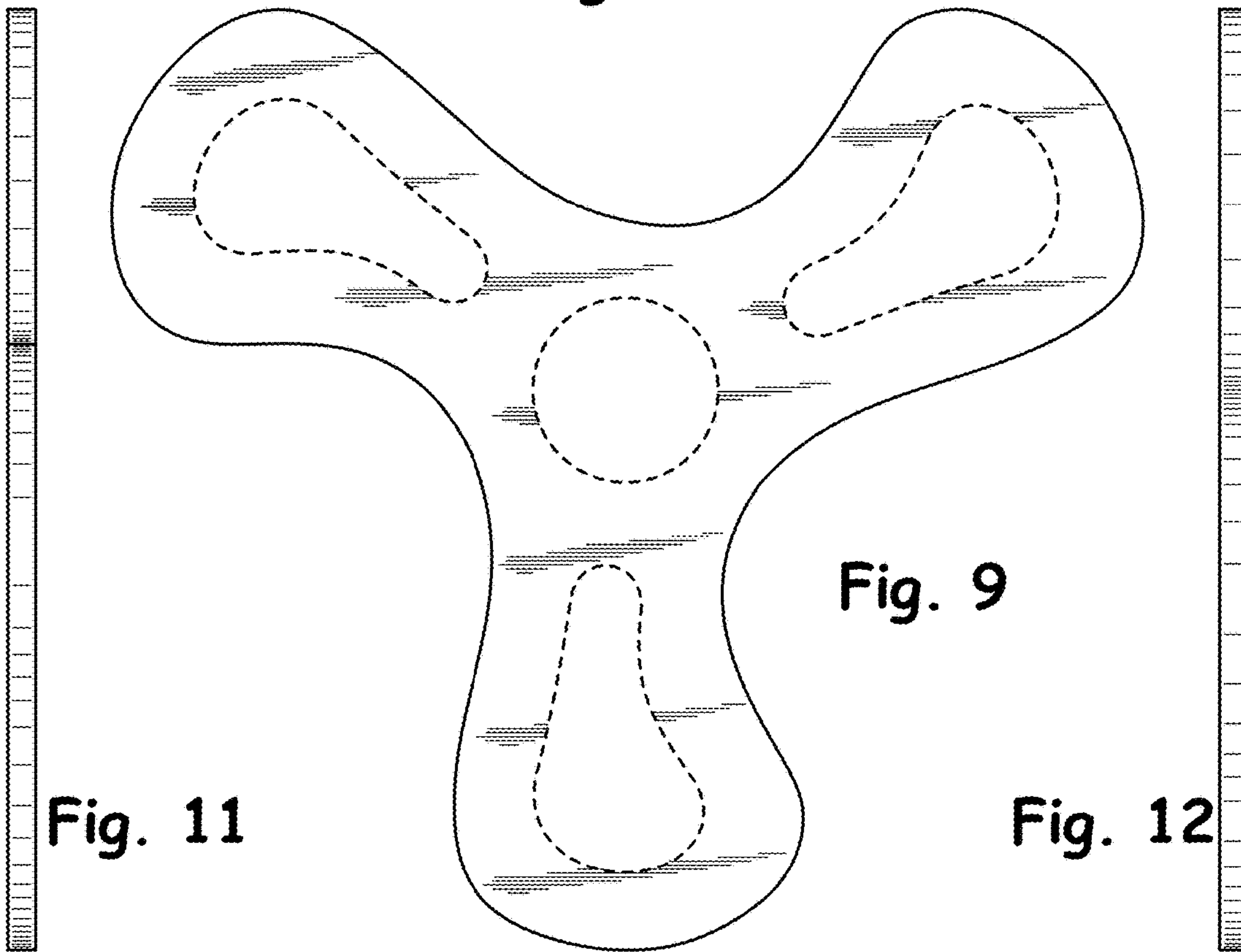

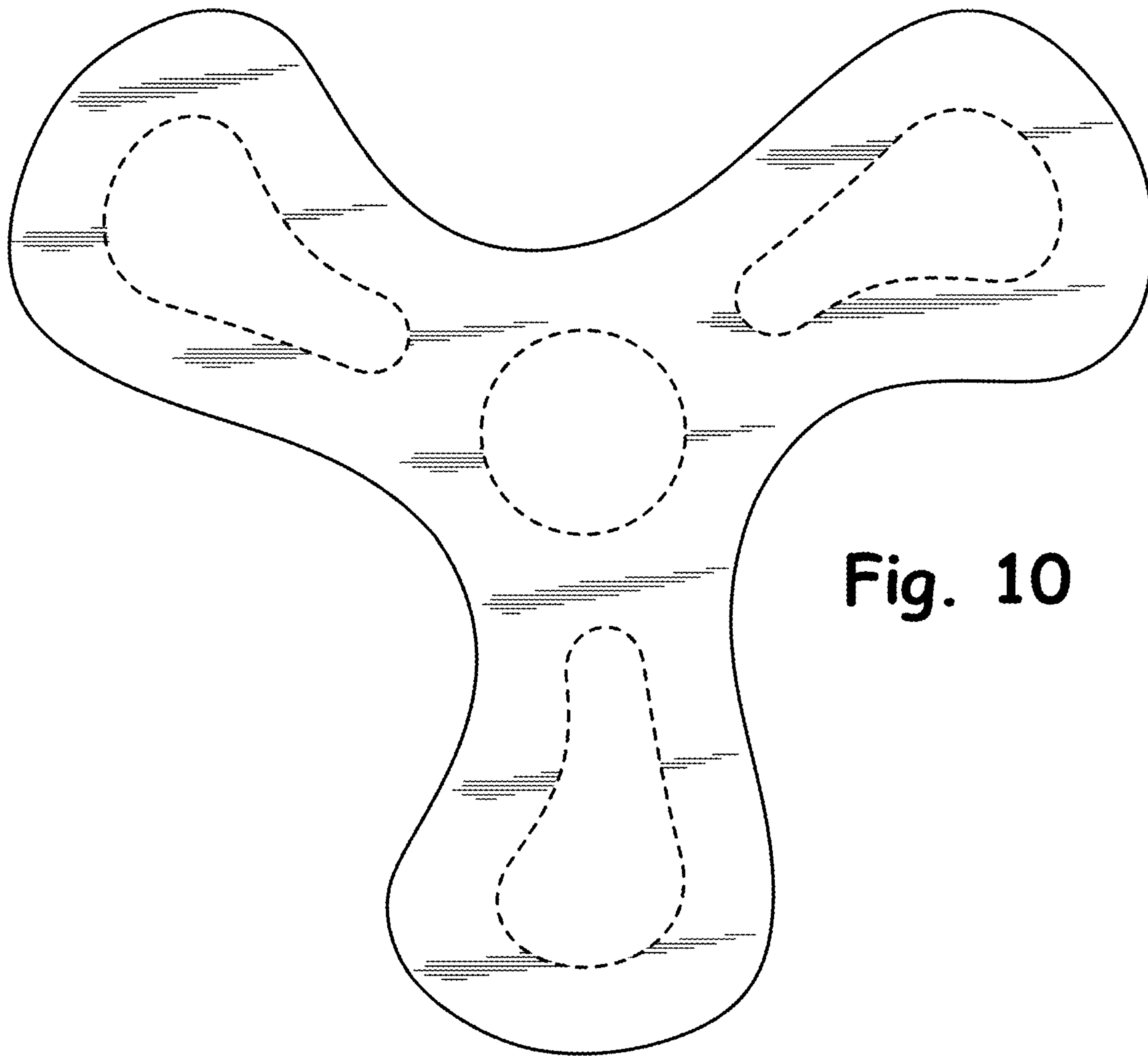
