FIG. 4 is a side elevational view thereof;

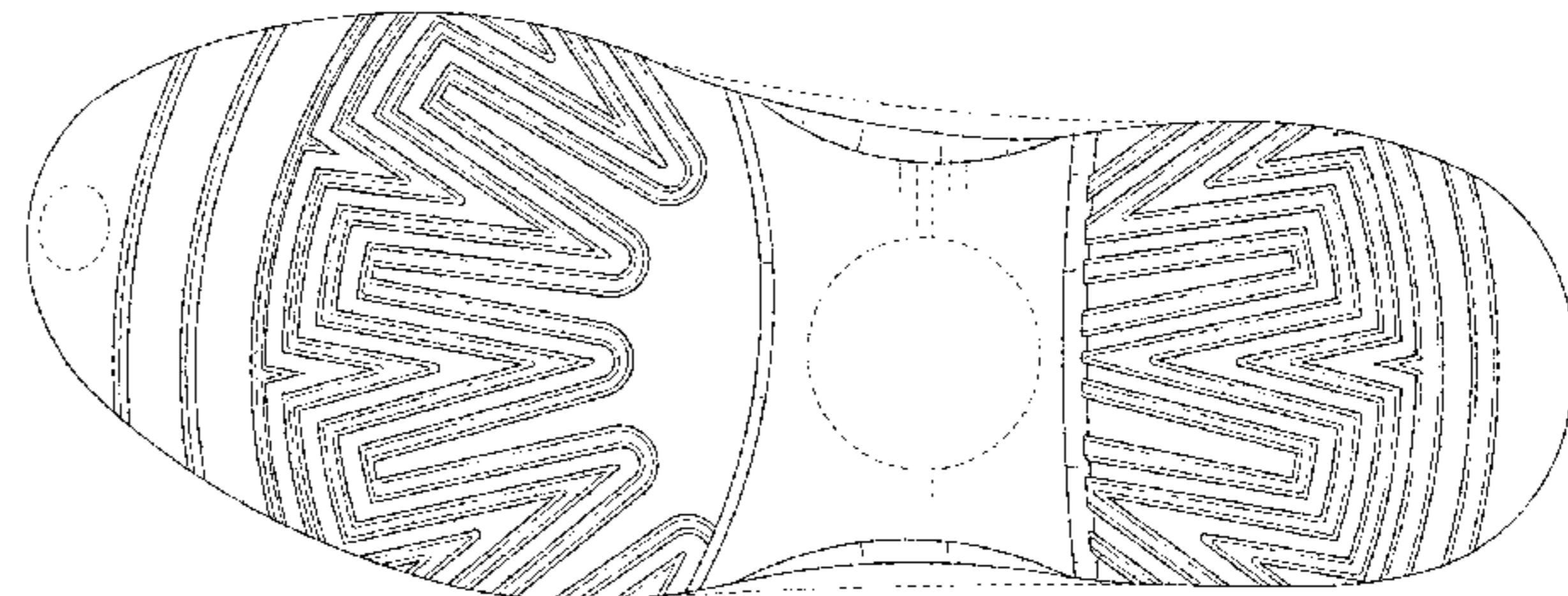
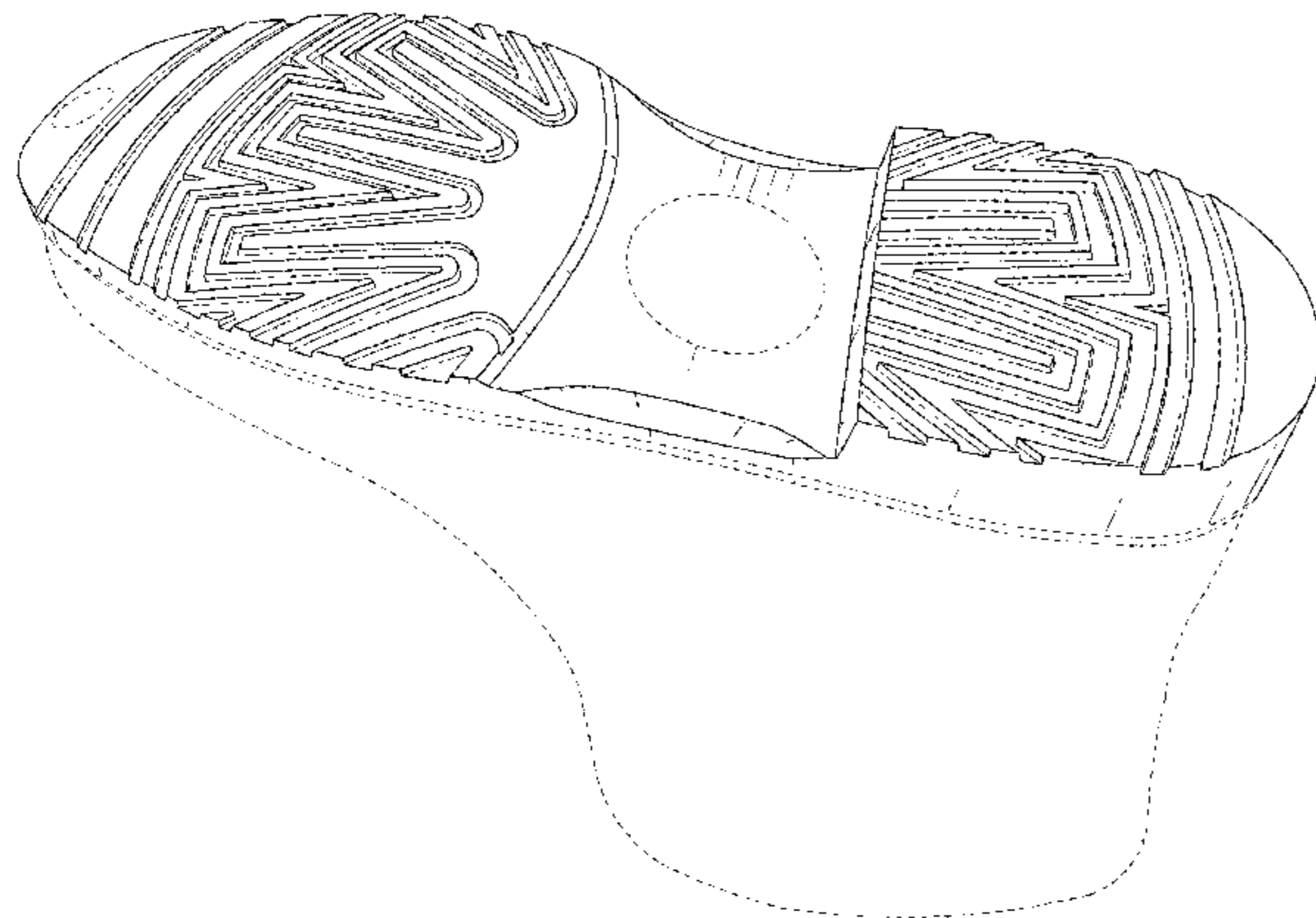
FIG. 5 is an opposite side elevational view thereof;

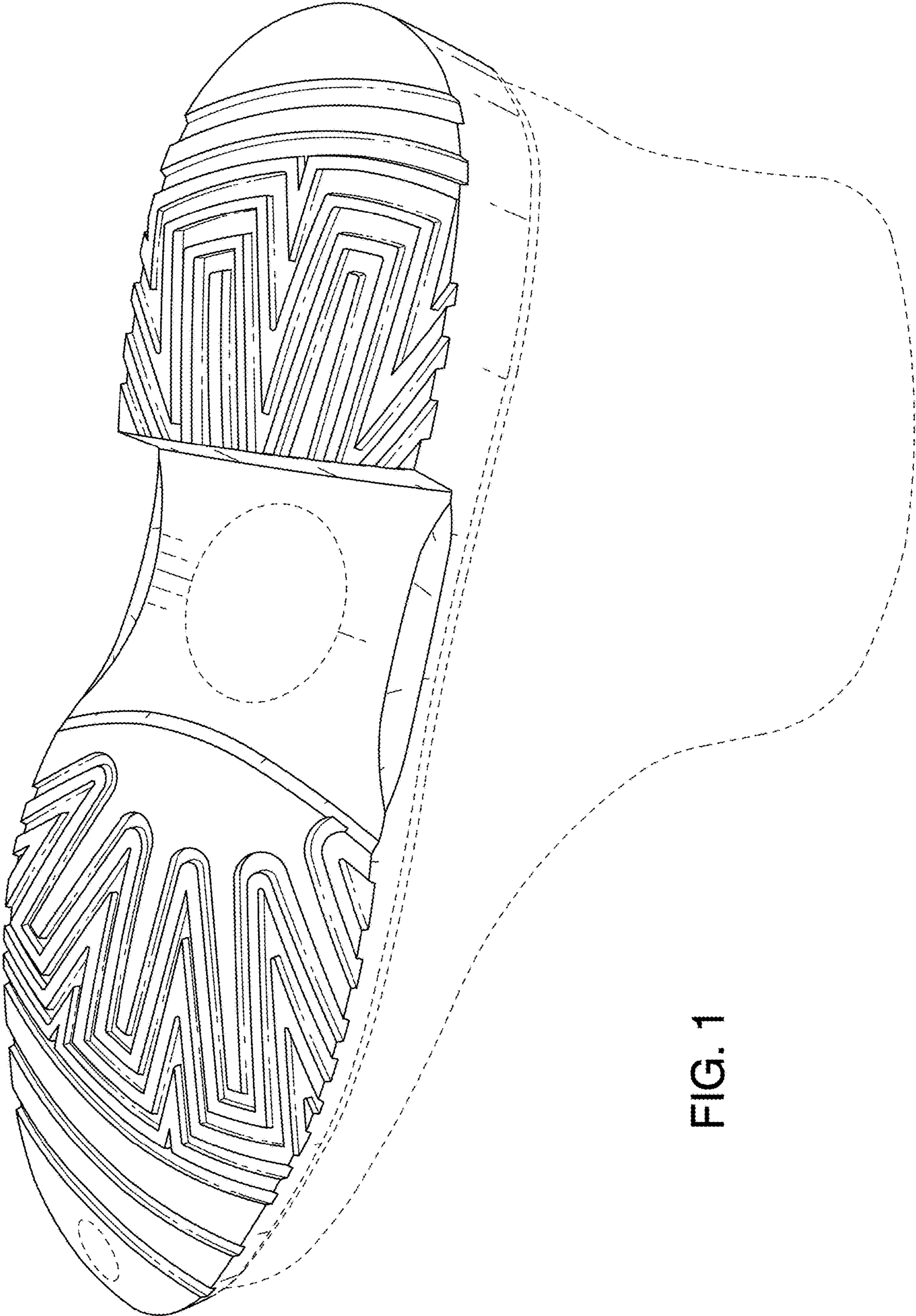

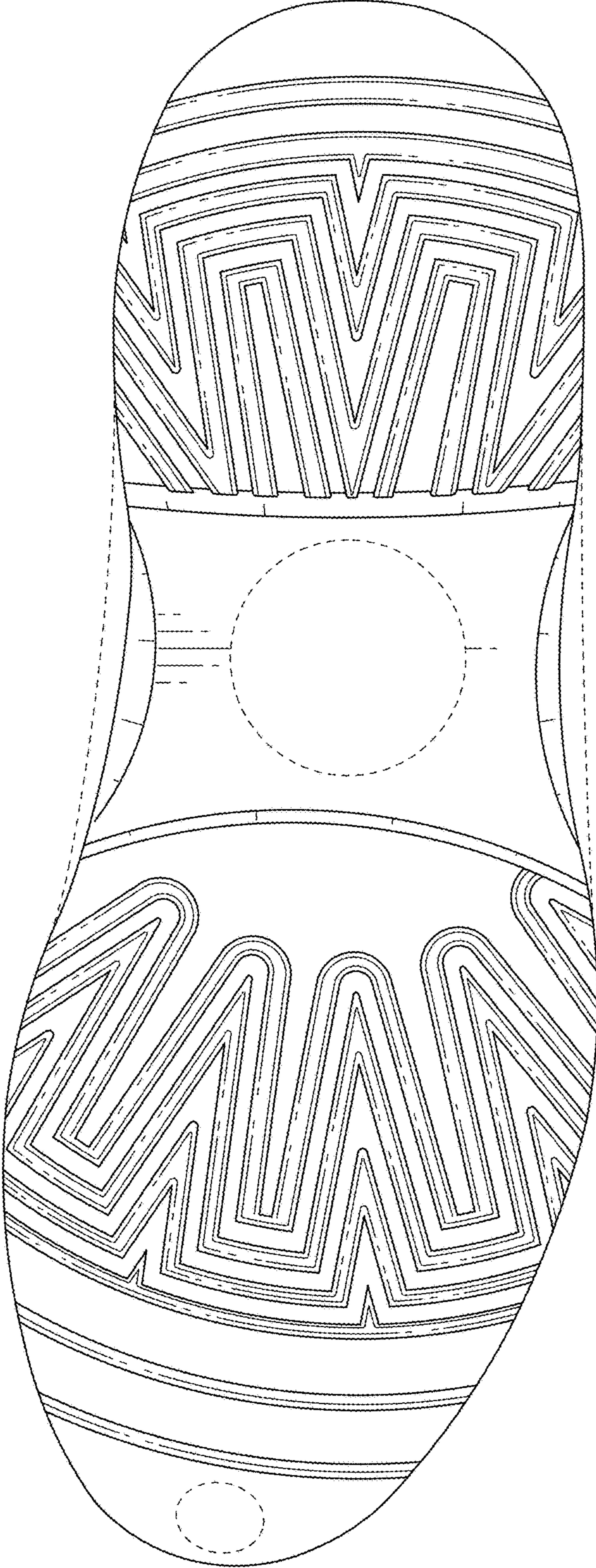
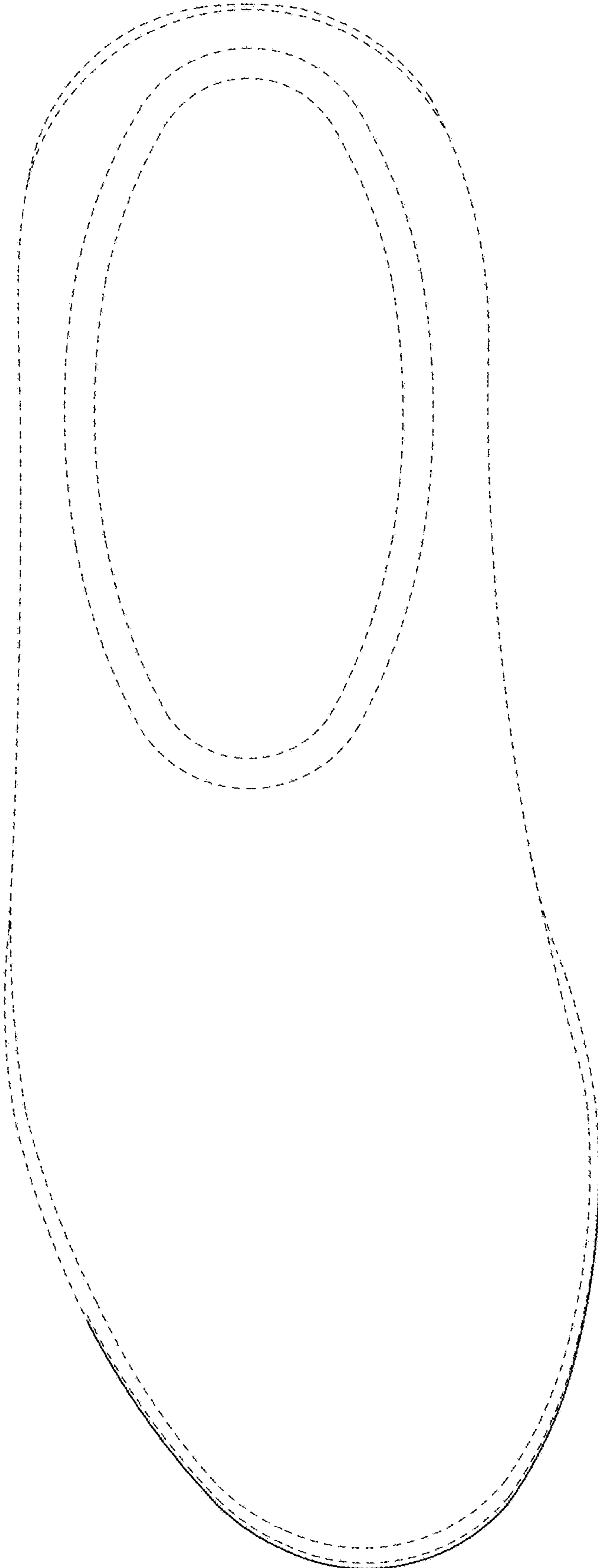

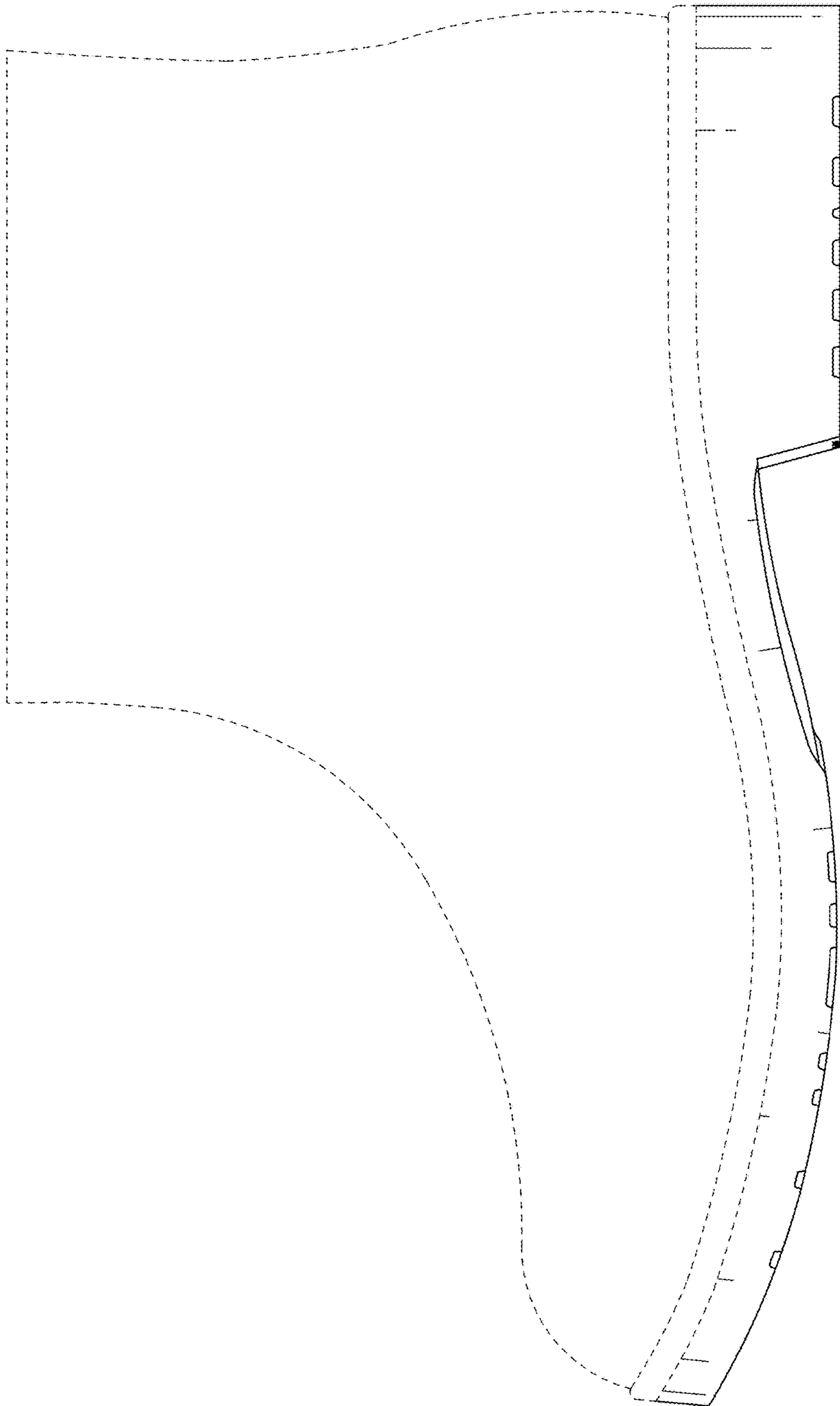

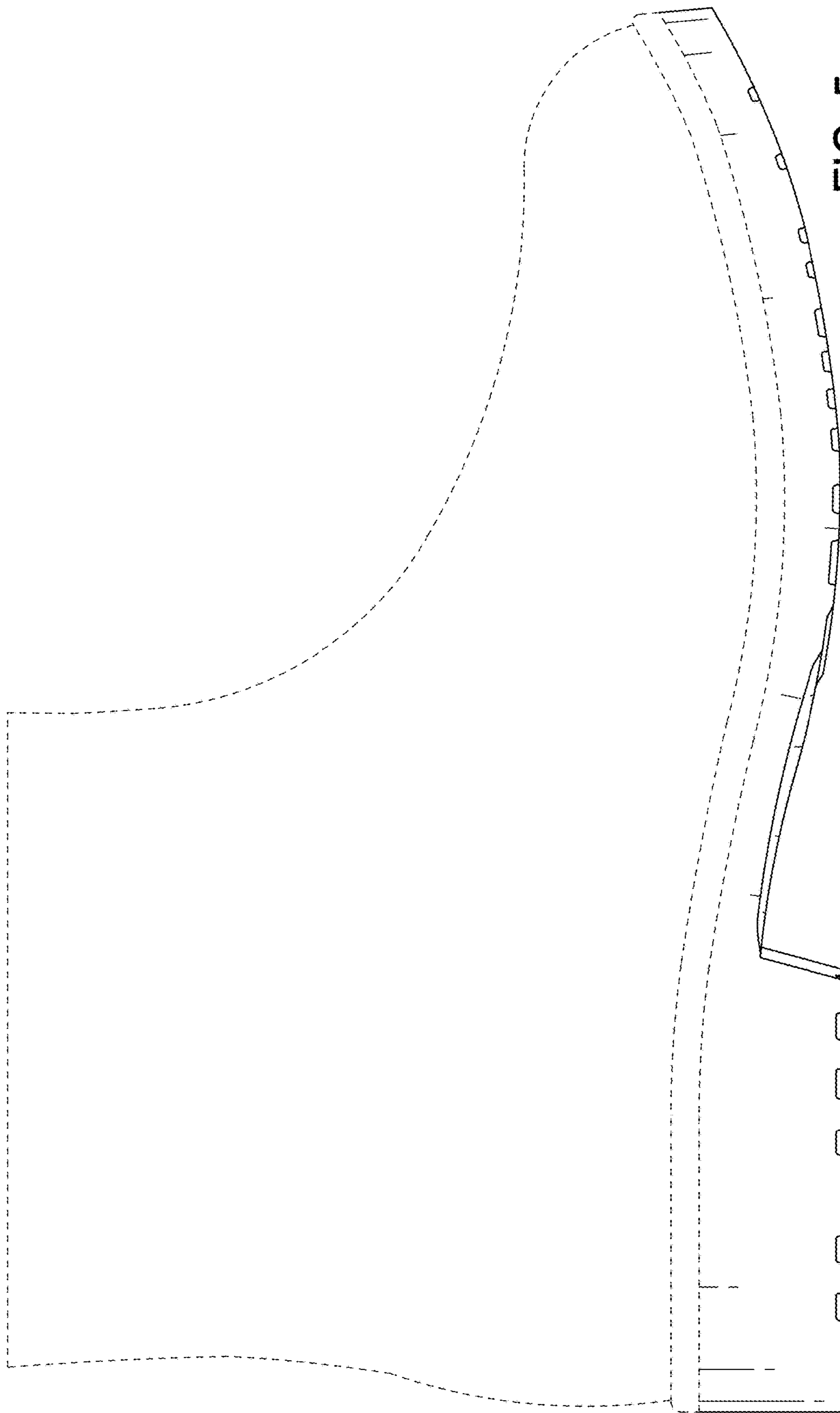

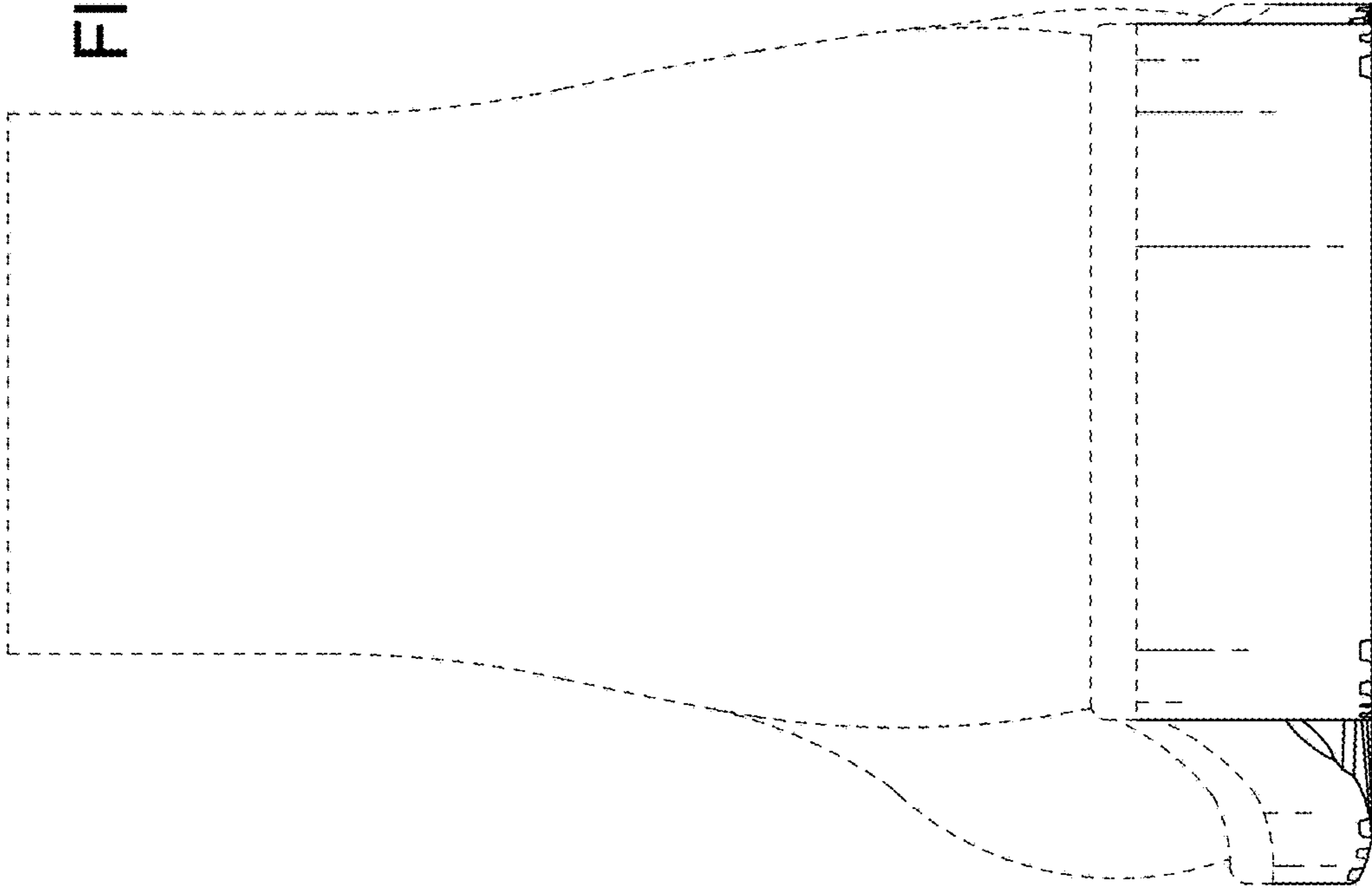
