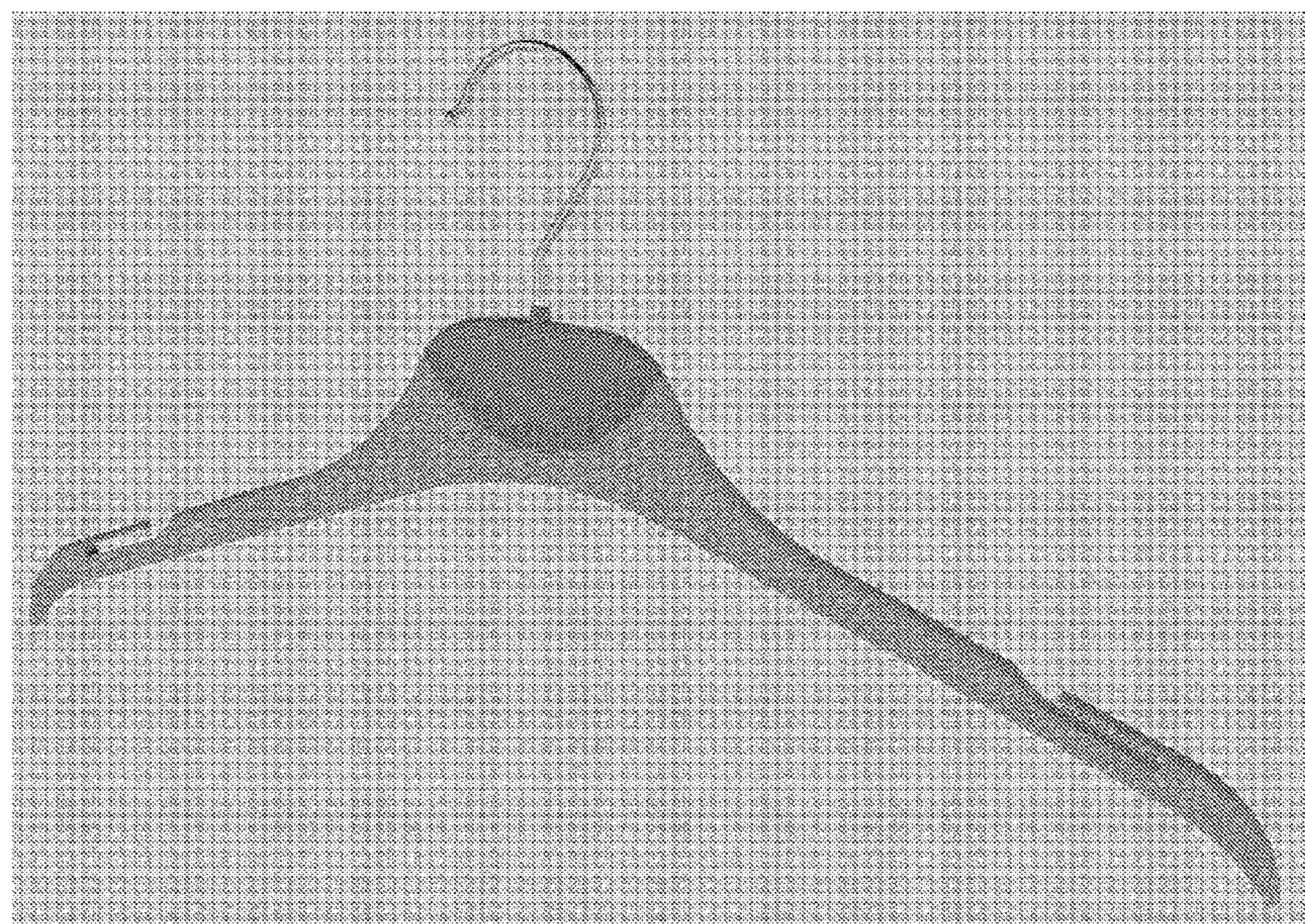
(57) **CLAIM**

The ornamental design for a garment hanger, as shown and described.

DESCRIPTION

1.1 is a perspective view of a garment hanger according to a first embodiment of the present invention.
1.2 is a front view of the garment hanger of **1.1**.
1.3 is a top view of the garment hanger of **1.1**.
1.4 is a left-side view of the garment hanger of **1.1**.
1.5 is a rear view the garment hanger of **1.1**.
1.6 is a bottom view of the garment hanger of **1.1**.
1.7 is a right-side view of the garment hanger of **1.1**.
2.1 is a perspective view of a garment hanger according to a second embodiment of the present invention.
2.2 is a front view of the garment hanger of **2.1**.
2.3 is a top view of the garment hanger of **2.1**.
2.4 is a left-side view of the garment hanger of **2.1**.
2.5 is a rear view the garment hanger of **2.1**.
2.6 is a bottom view of the garment hanger of **2.1**.
2.7 is a right-side view of the garment hanger of **2.1**.
The hook portion of the design that is shown in blue wash is excluded from protection.

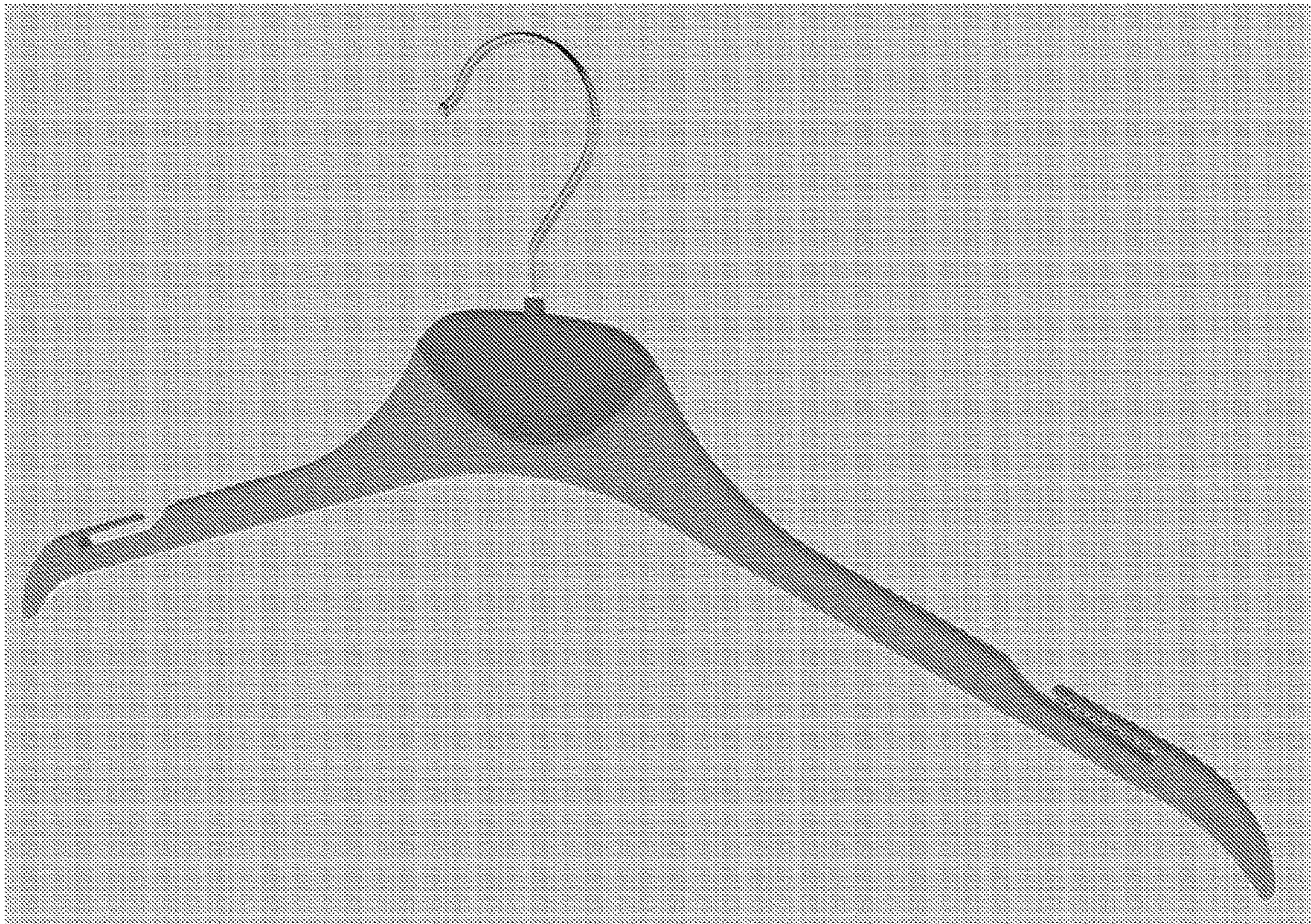

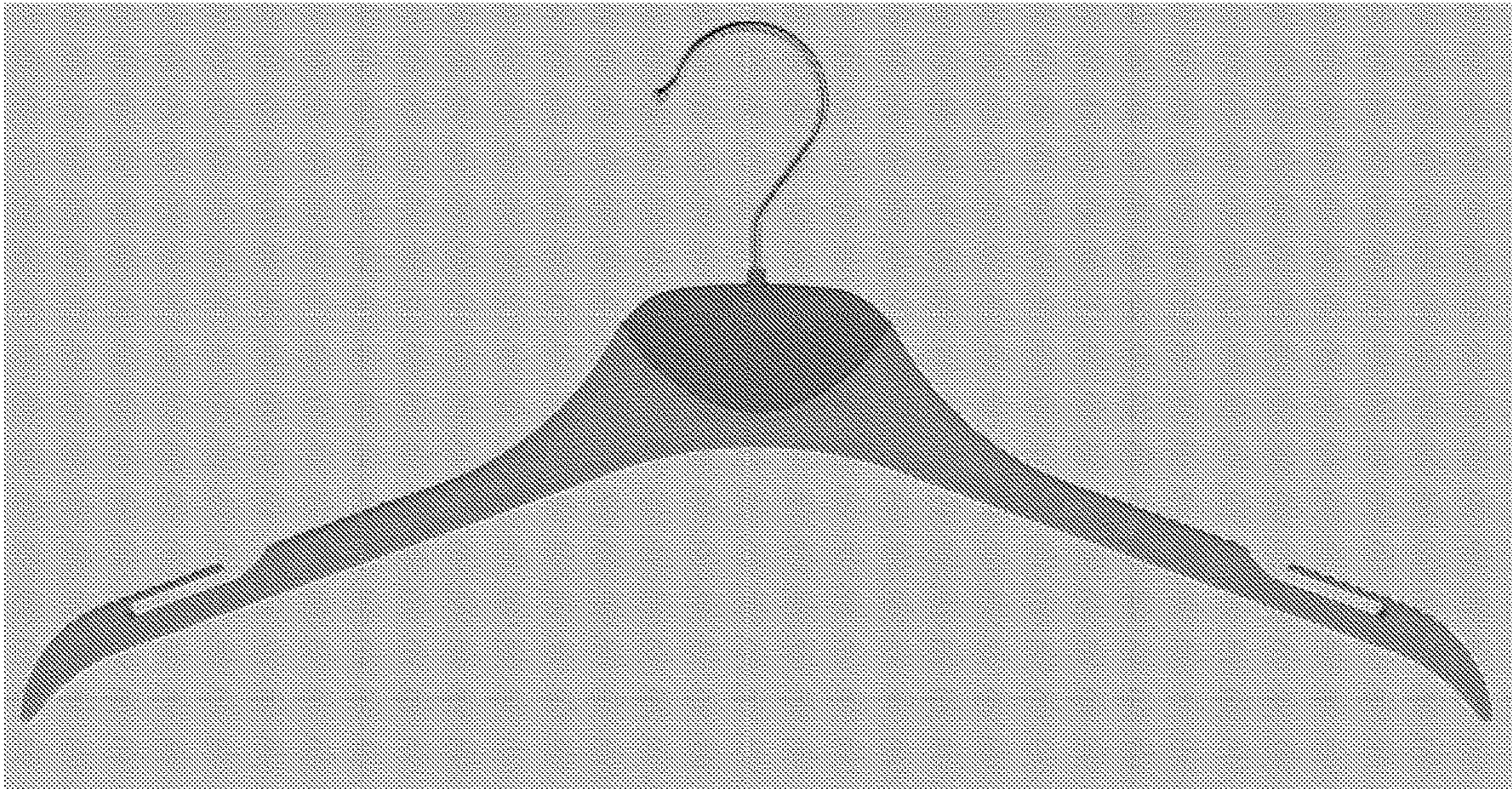

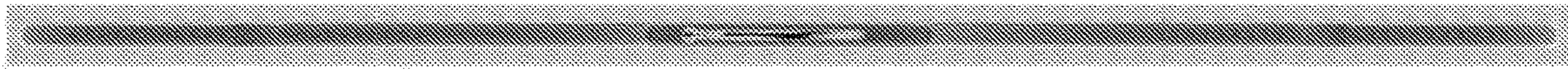

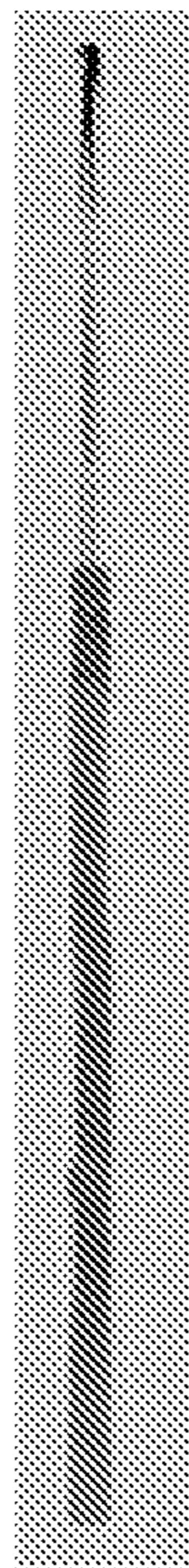

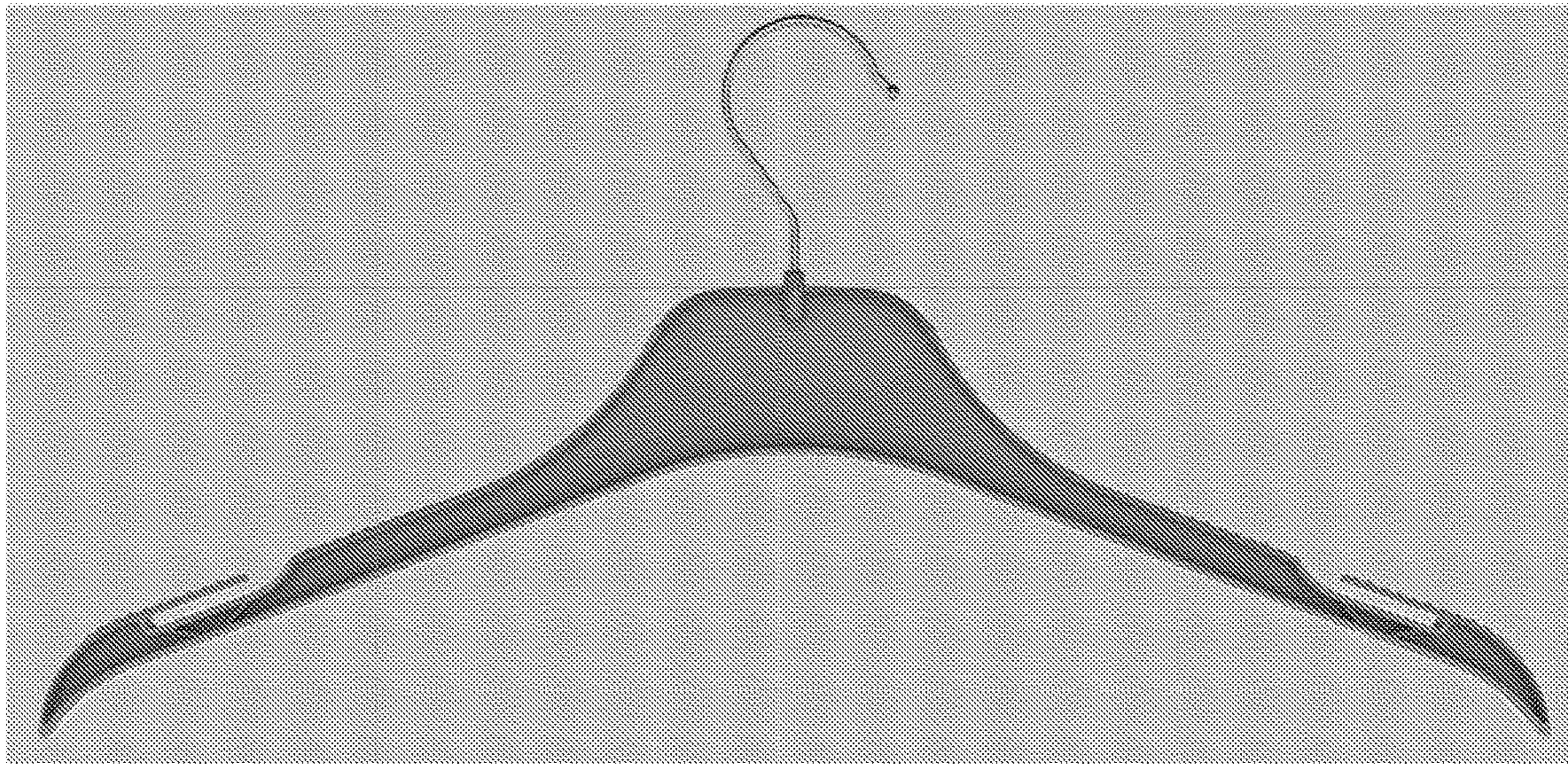

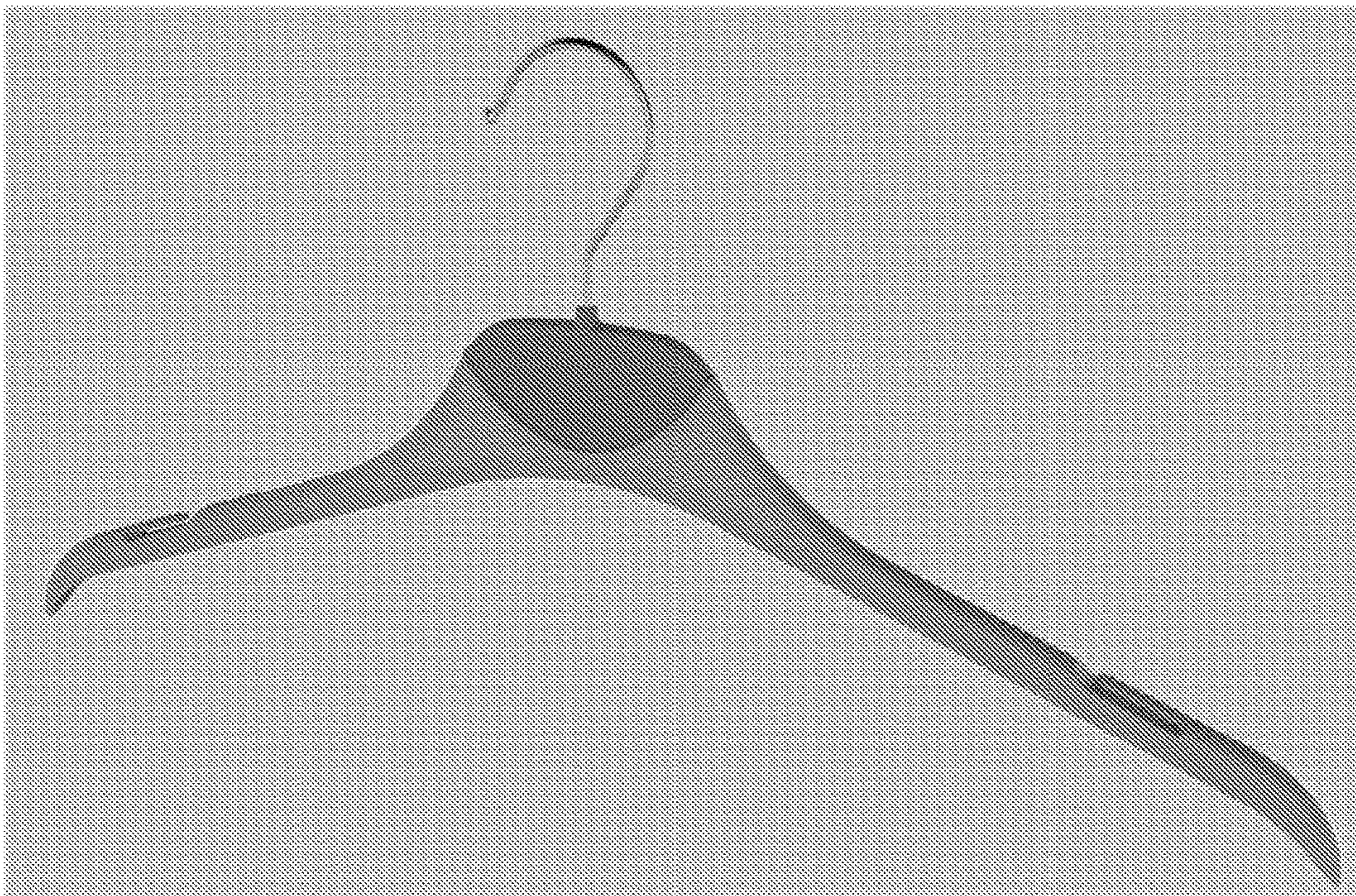

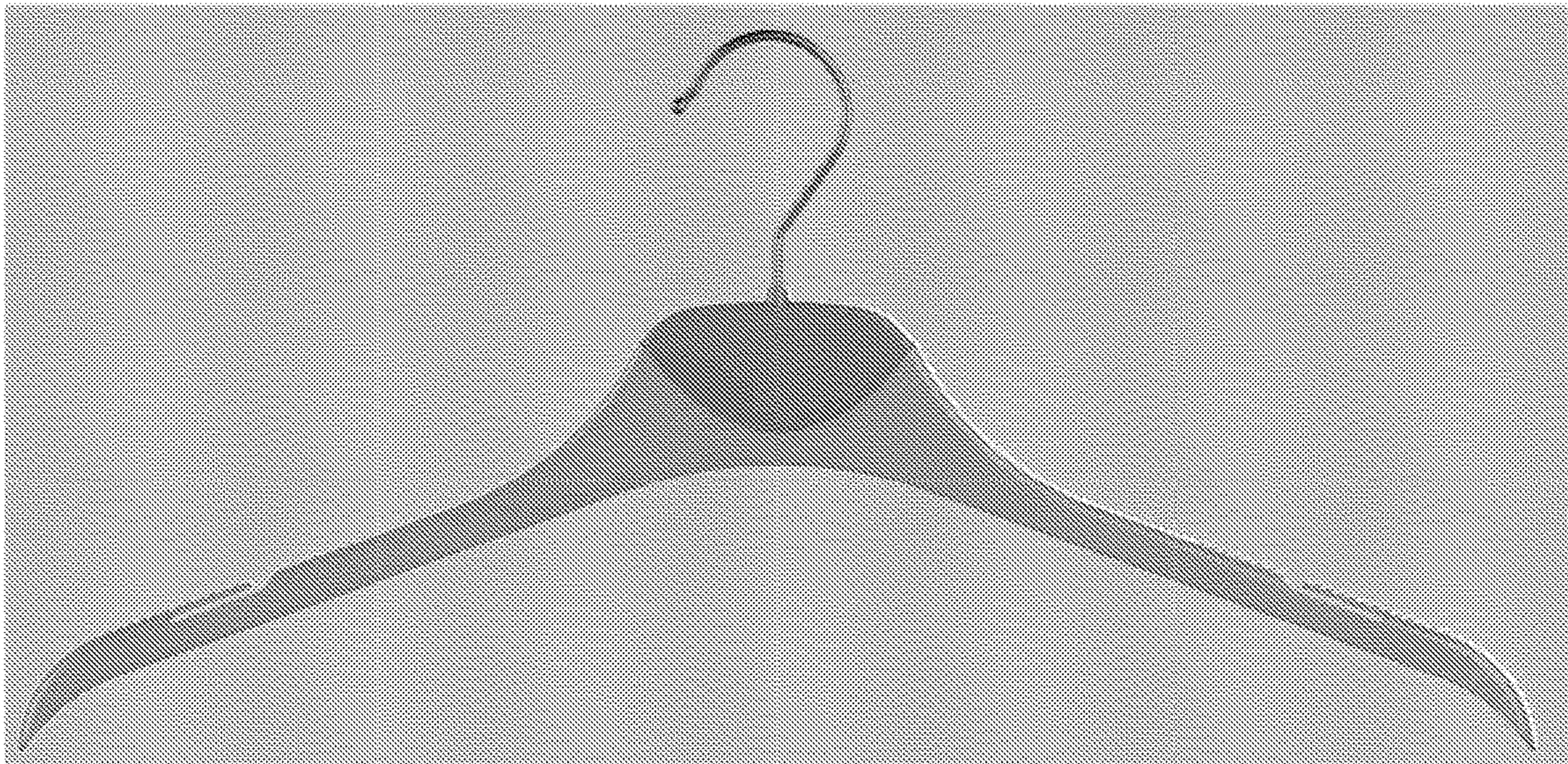

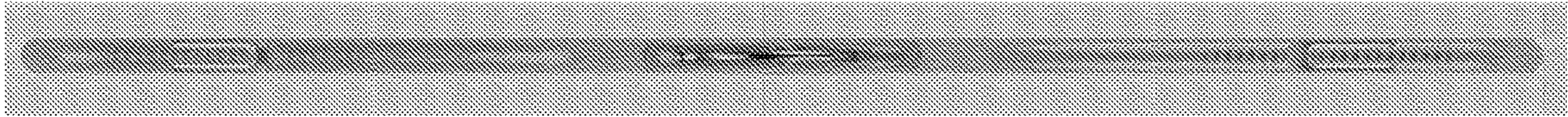

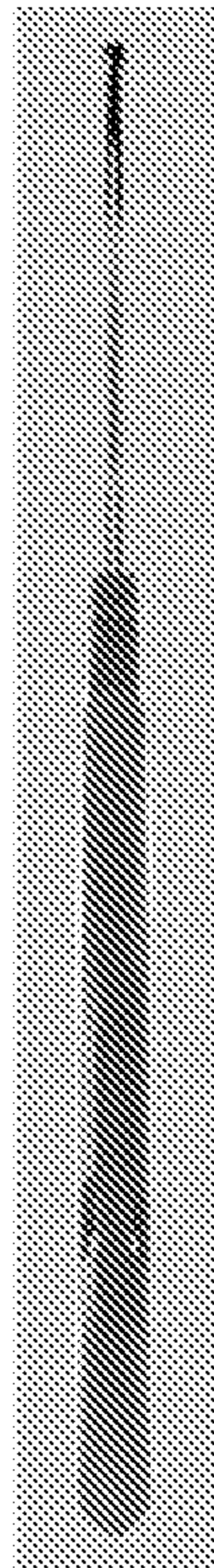

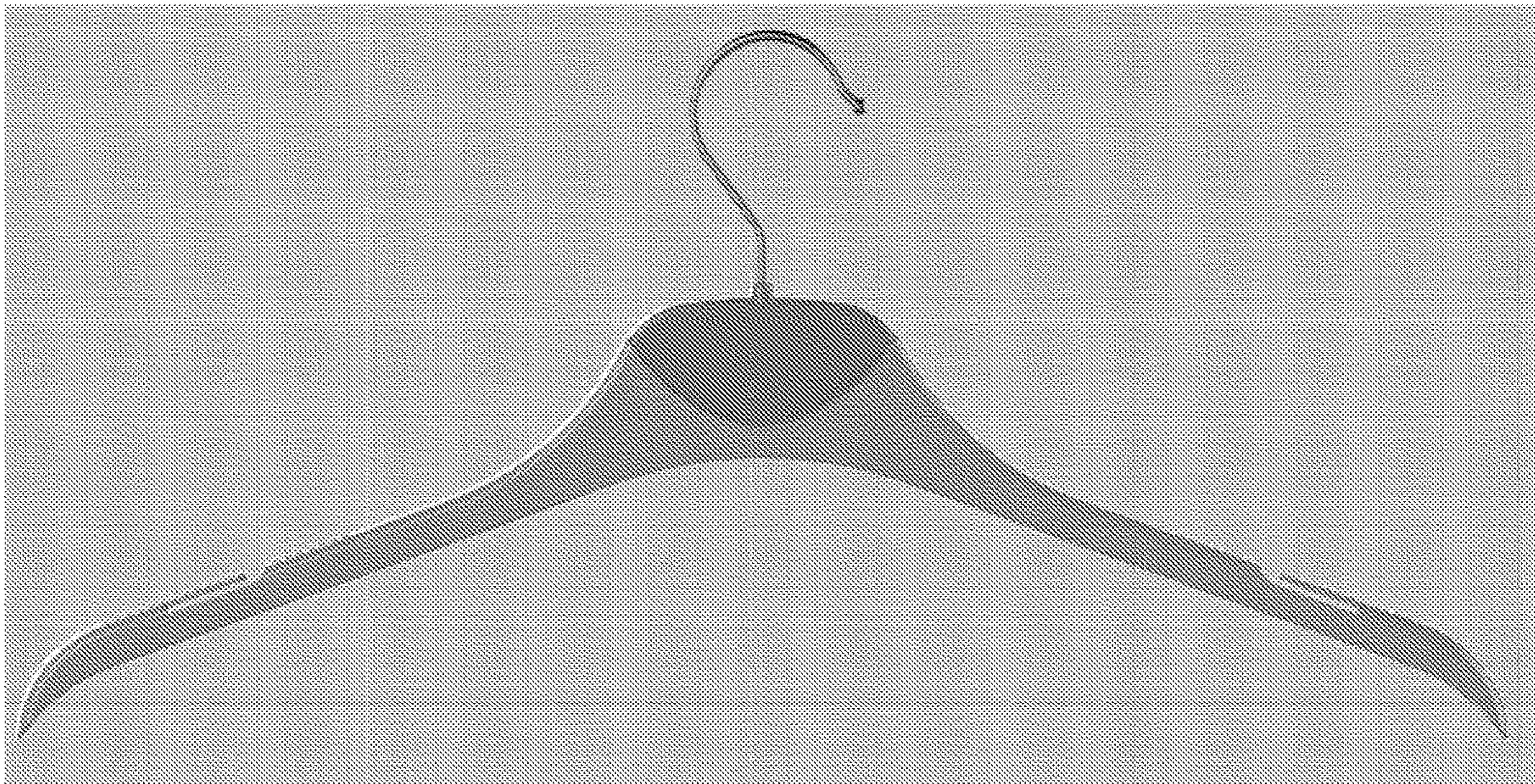

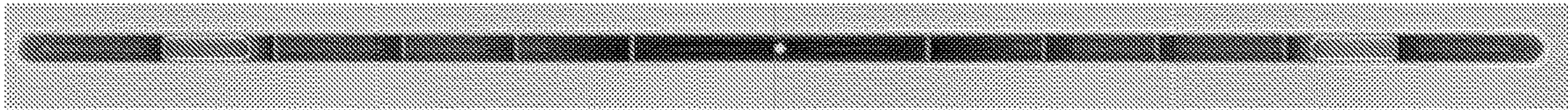
