The ornamental design for a headrest hanger, as shown and described.

DESCRIPTION
FIG. 1 is front perspective view of a headrest hanger.
FIG. 2 is an enlarged front view of the headrest hanger of FIG. 1.
FIG. 3 is an enlarged back view of the headrest hanger of FIG. 1.
FIG. 4 is an enlarged top view of the headrest hanger of FIG. 1.
FIG. 5 is an enlarged bottom view of the headrest hanger of FIG. 1.
FIG. 6 is an enlarged left side view of the headrest hanger of FIG. 1; and,
FIG. 7 is an enlarged right side view of the headrest hanger of FIG. 1.

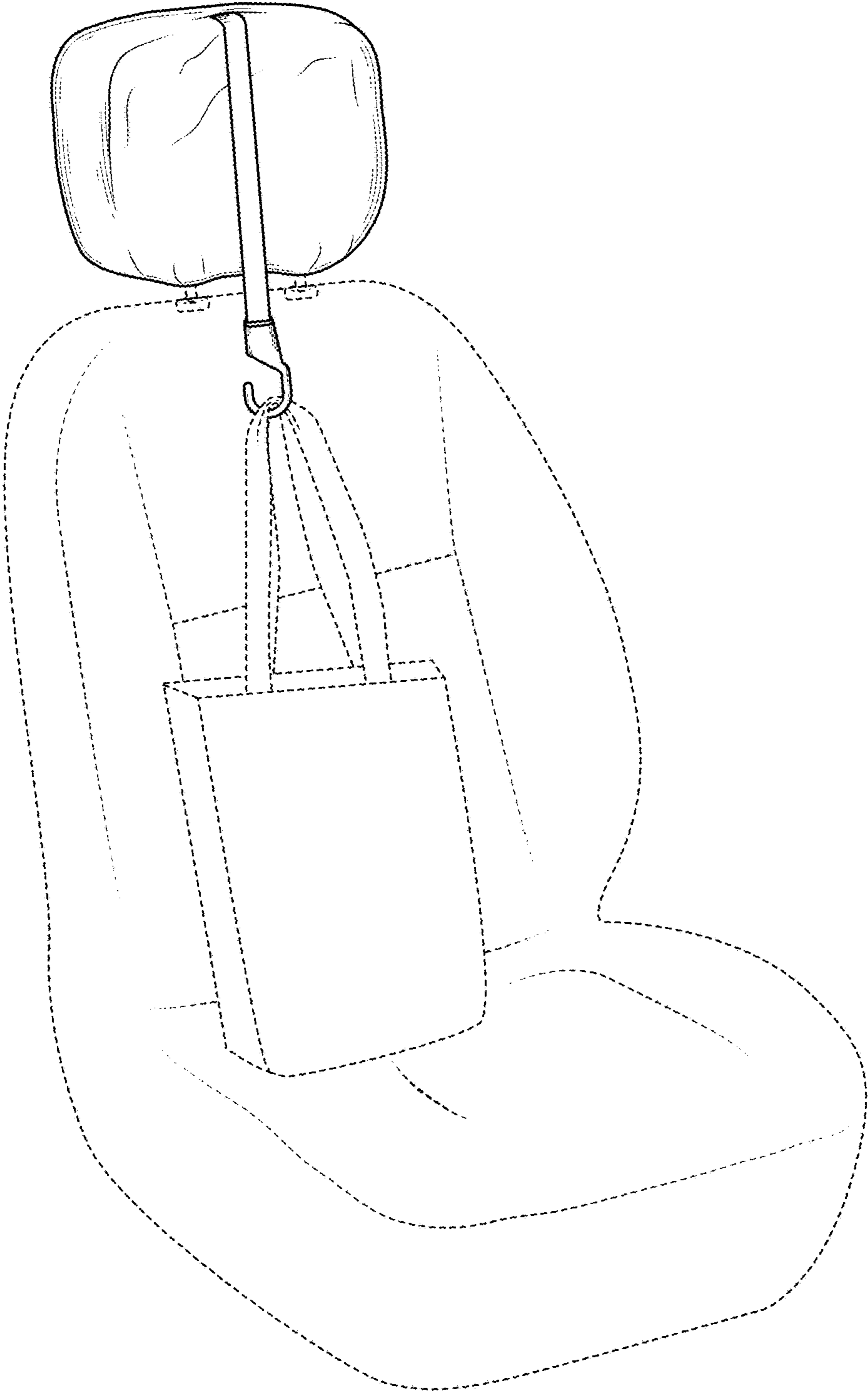

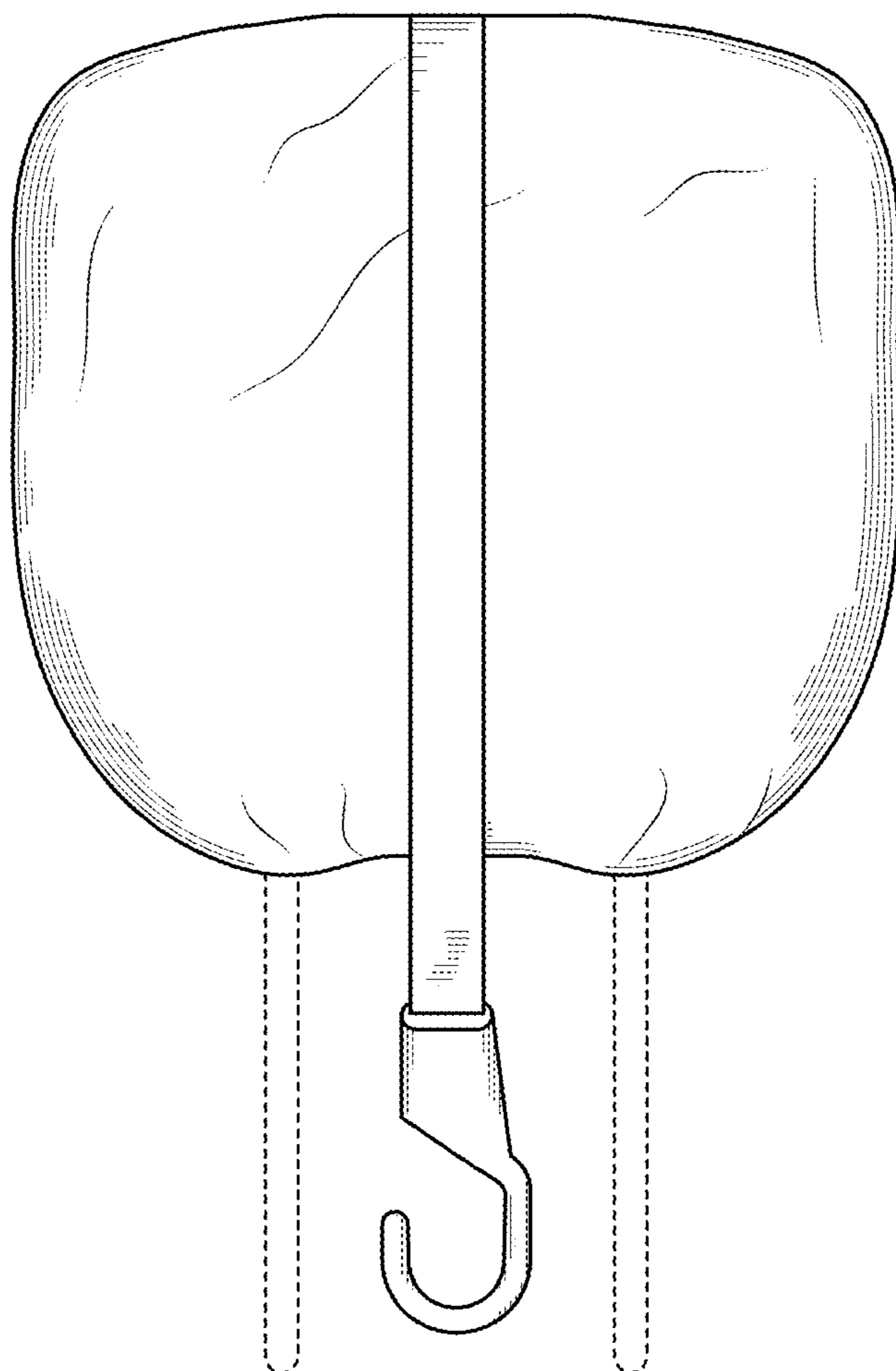

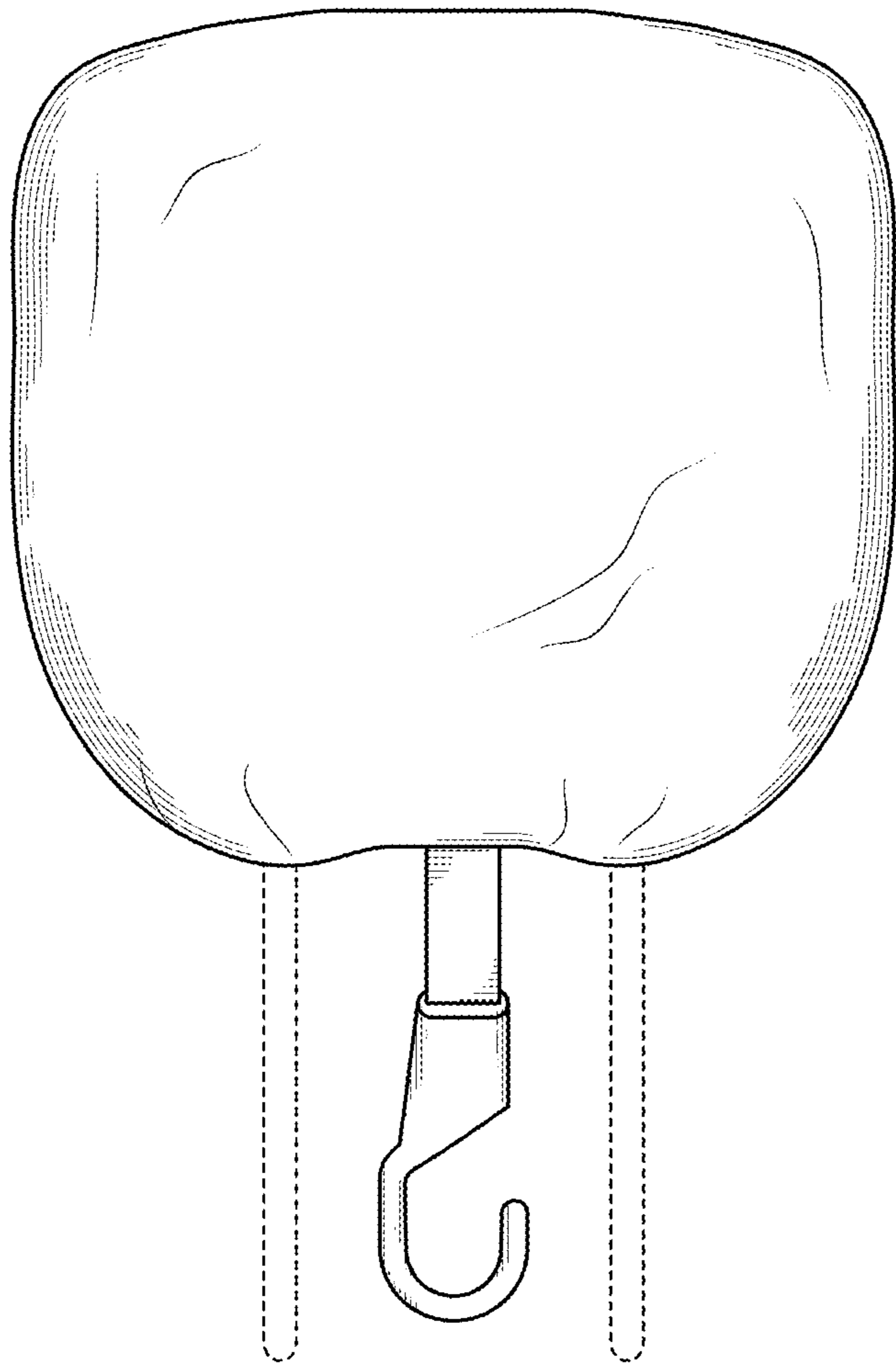

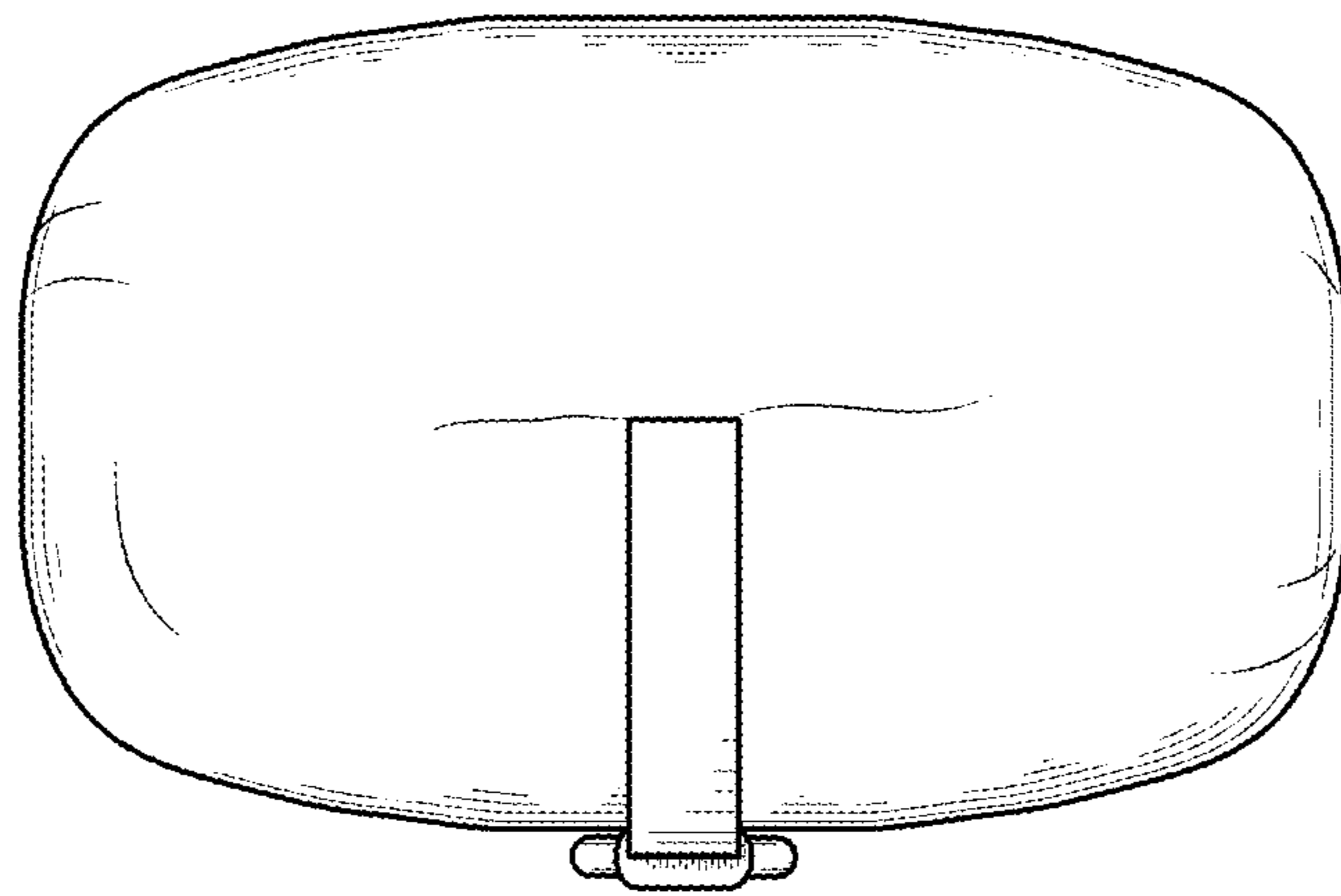

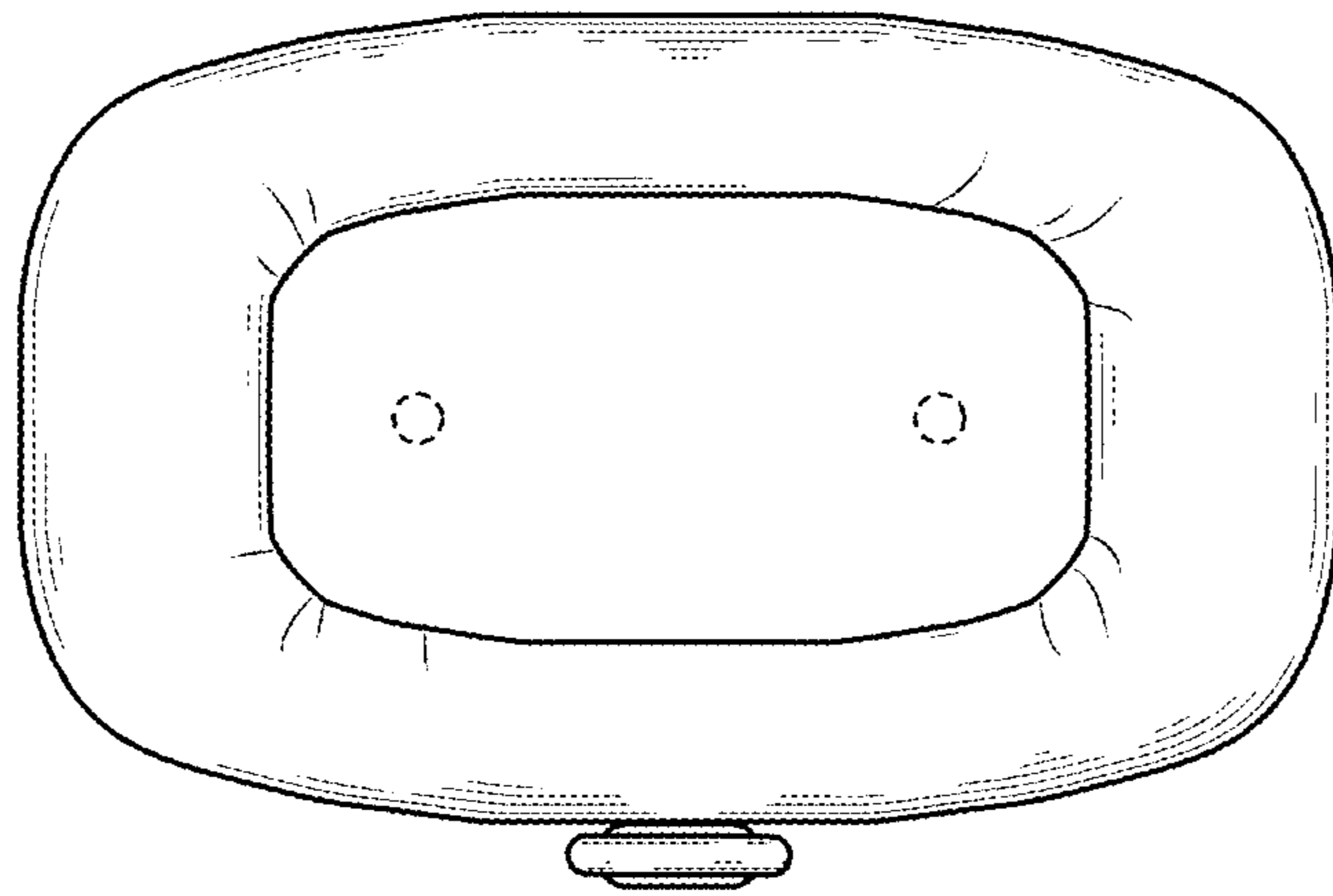

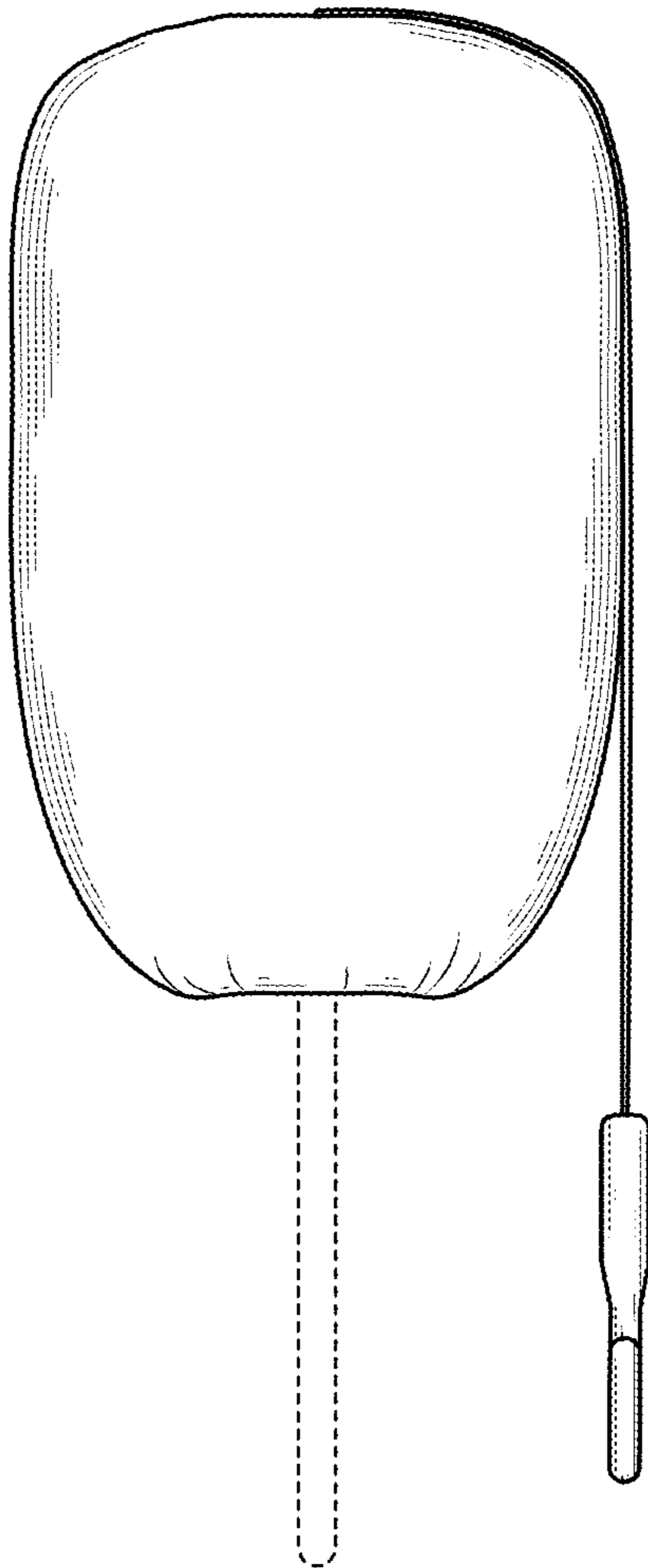

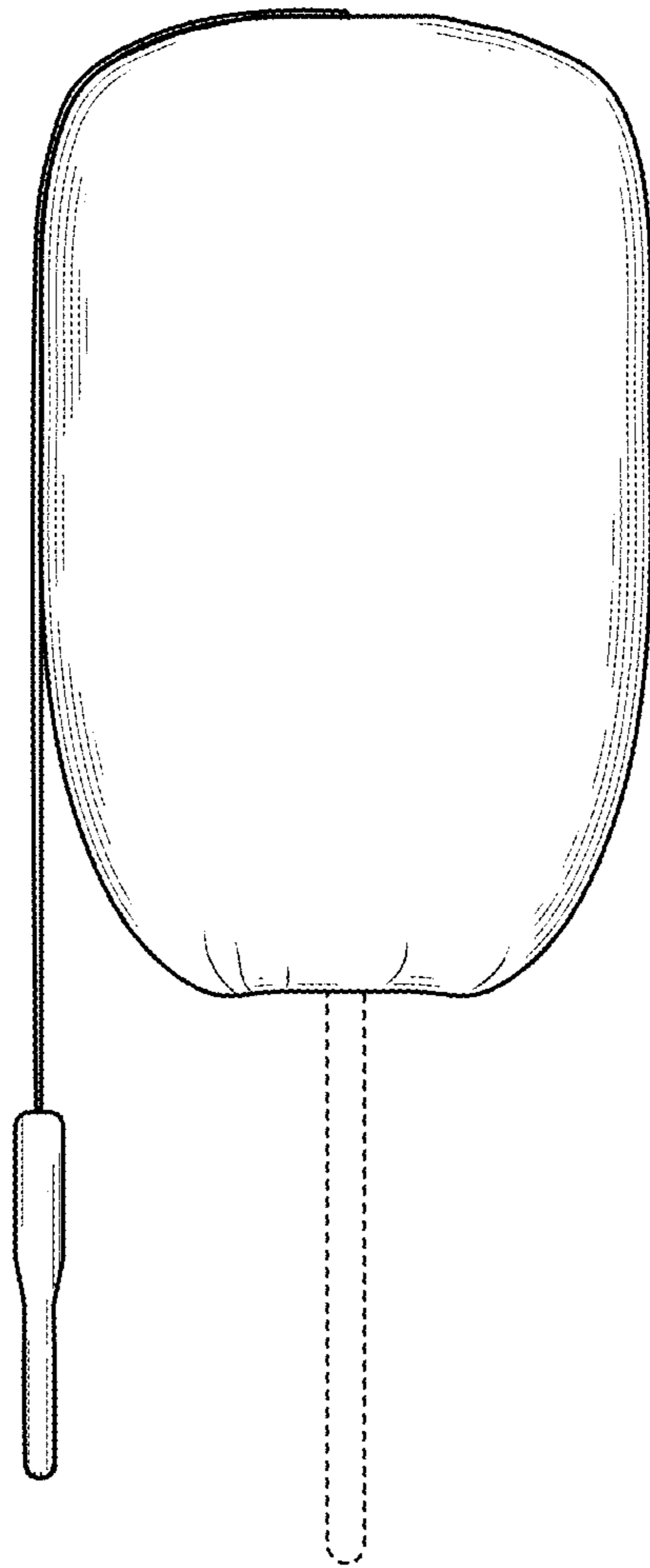
