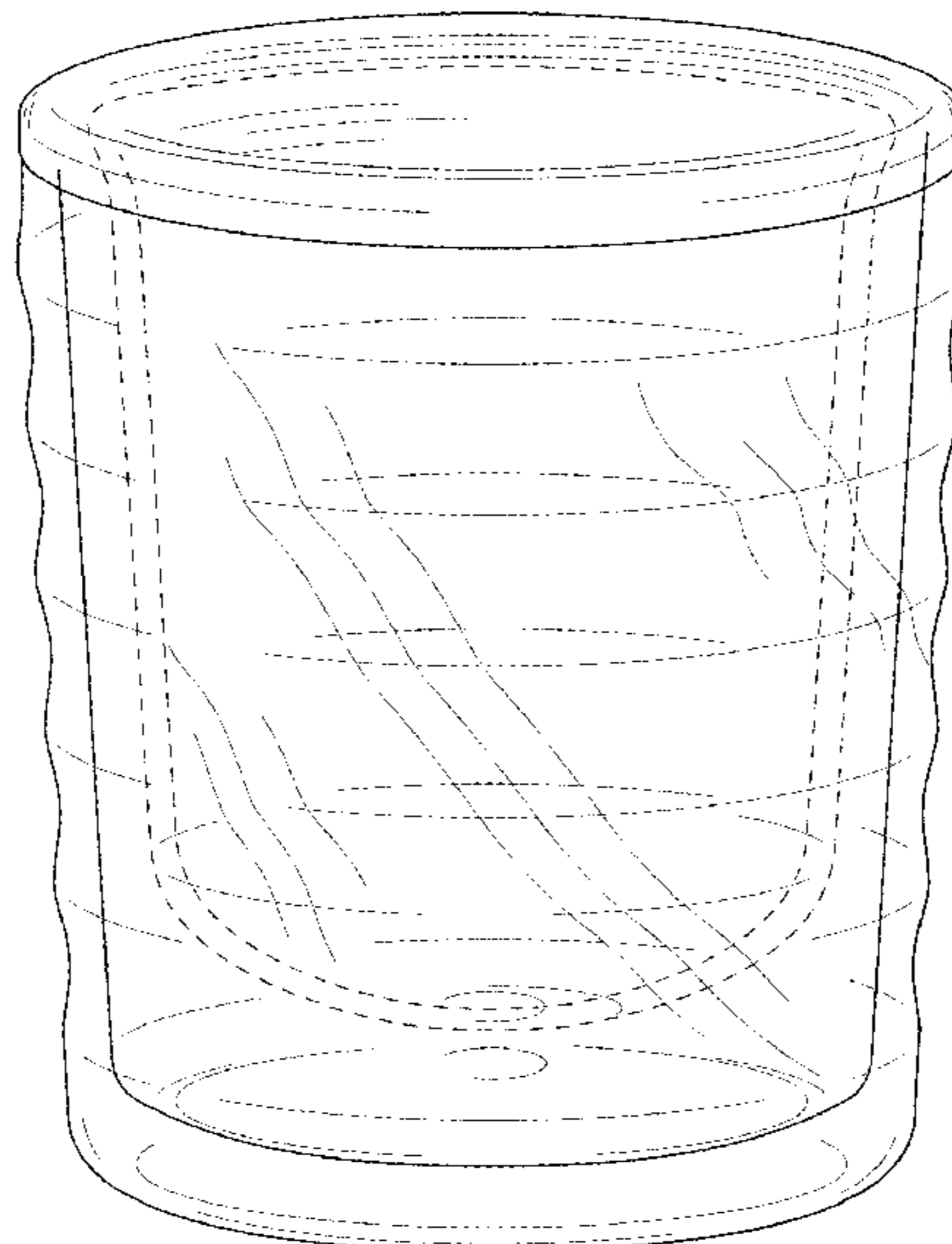
(57) **CLAIM**

The ornamental design for the transparent drinking vessel, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of transparent drinking vessel; FIG. 2 is front elevation view of the transparent drinking vessel shown in FIG. 1; FIG. 3 is a top plan view of the transparent drinking vessel shown in FIG. 1; and, FIG. 4 is a bottom plan view of the transparent drinking vessel shown in FIG. 1. 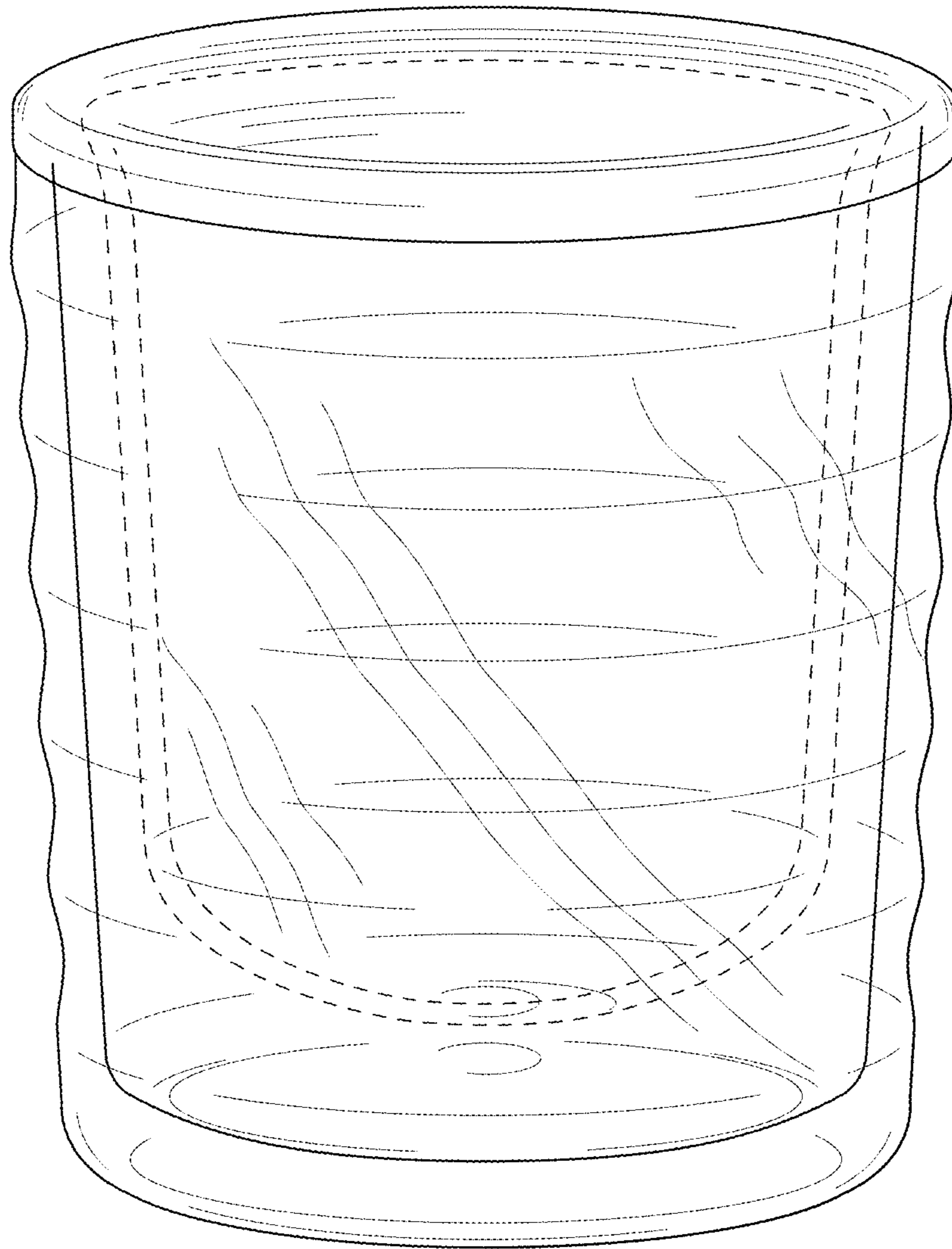

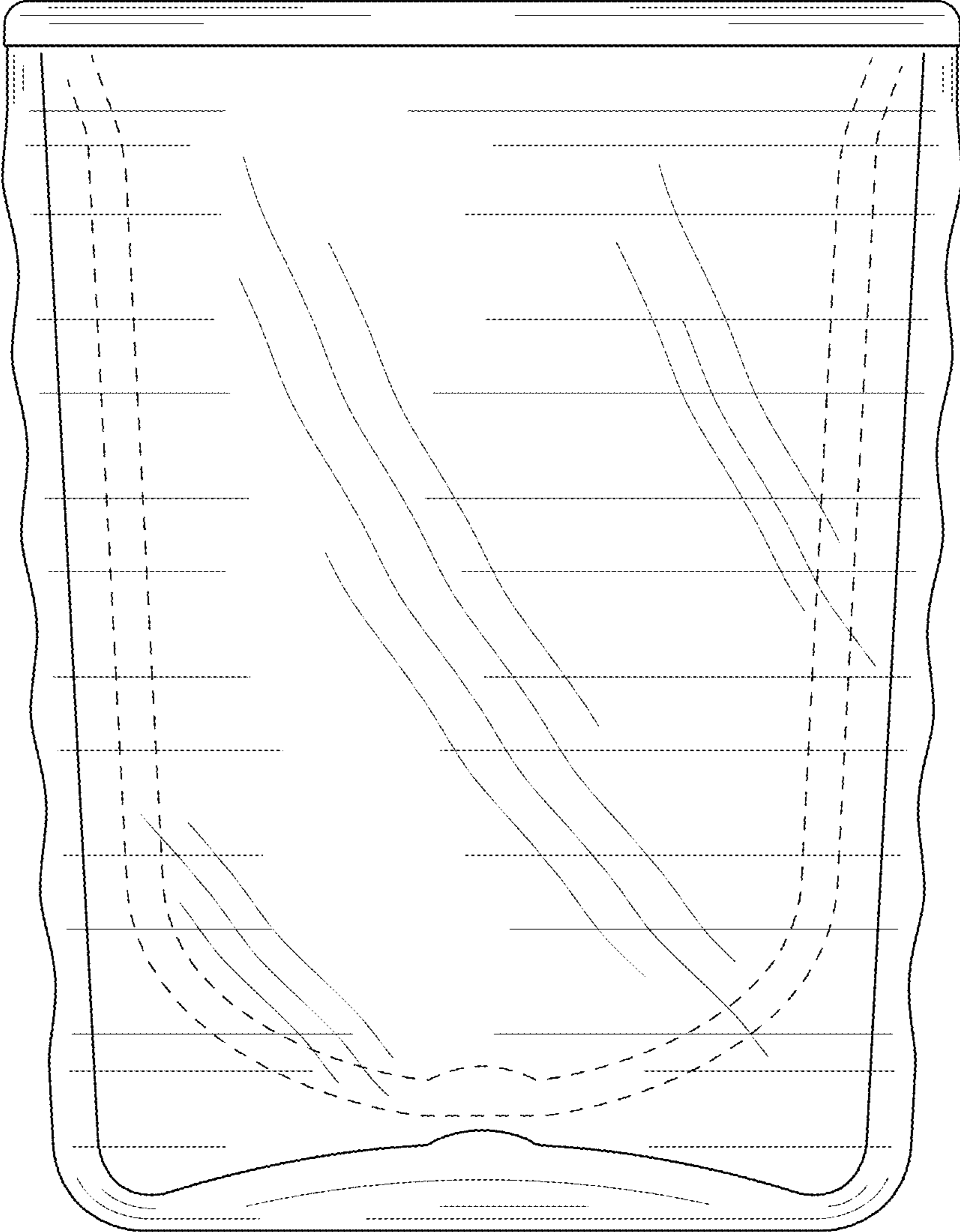

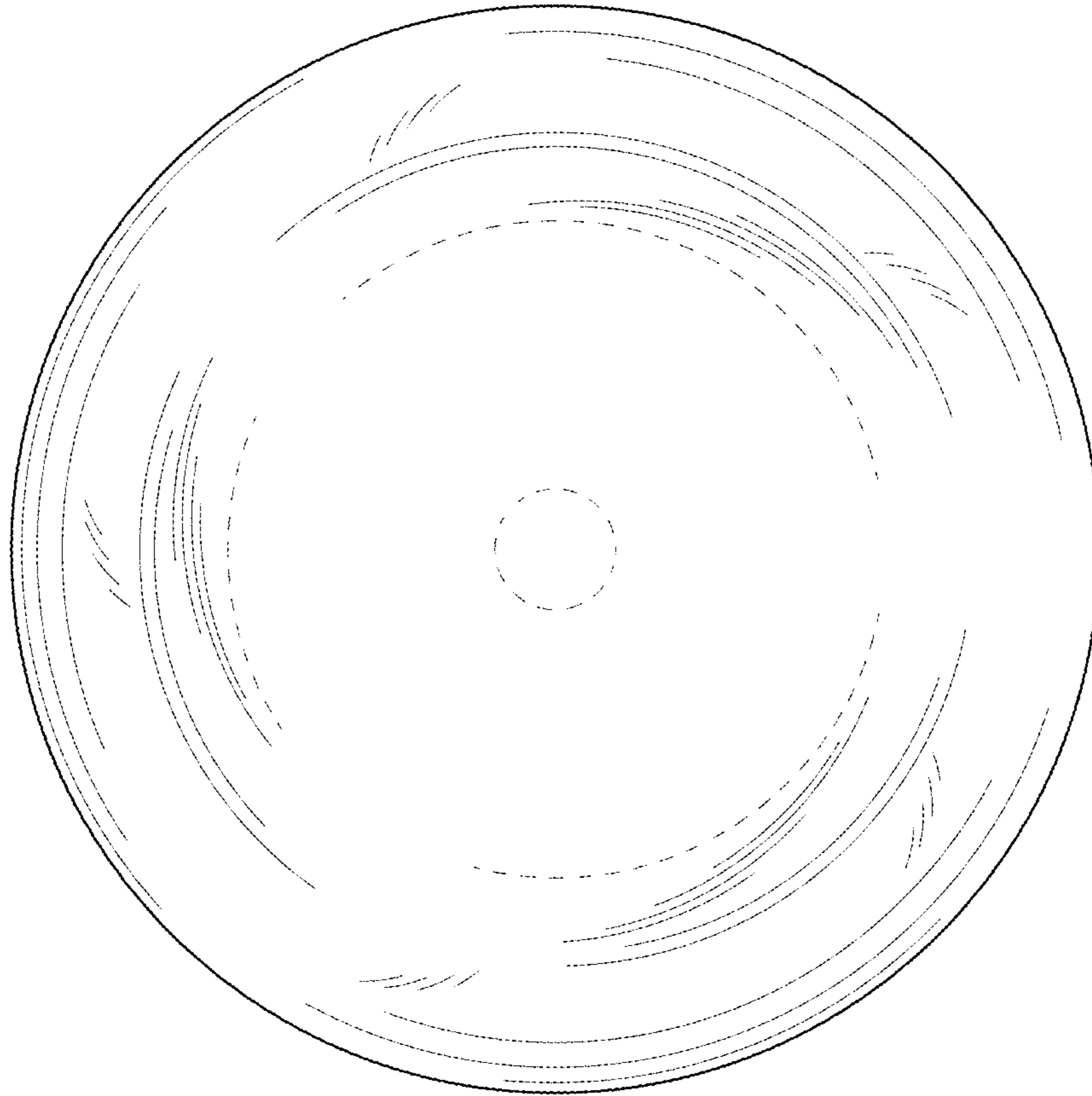

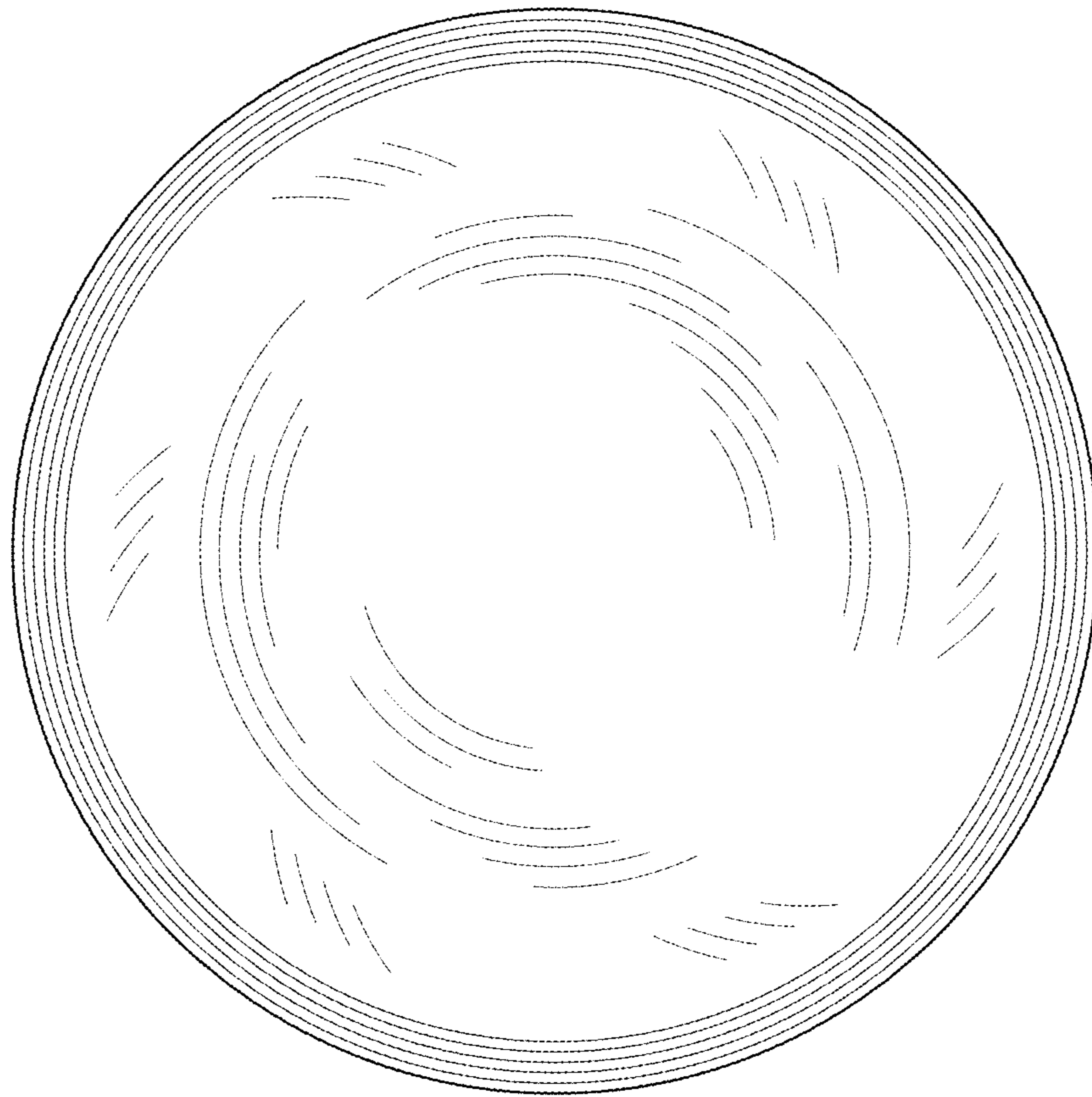
