The ornamental design for a camera bracelet, as shown and described.

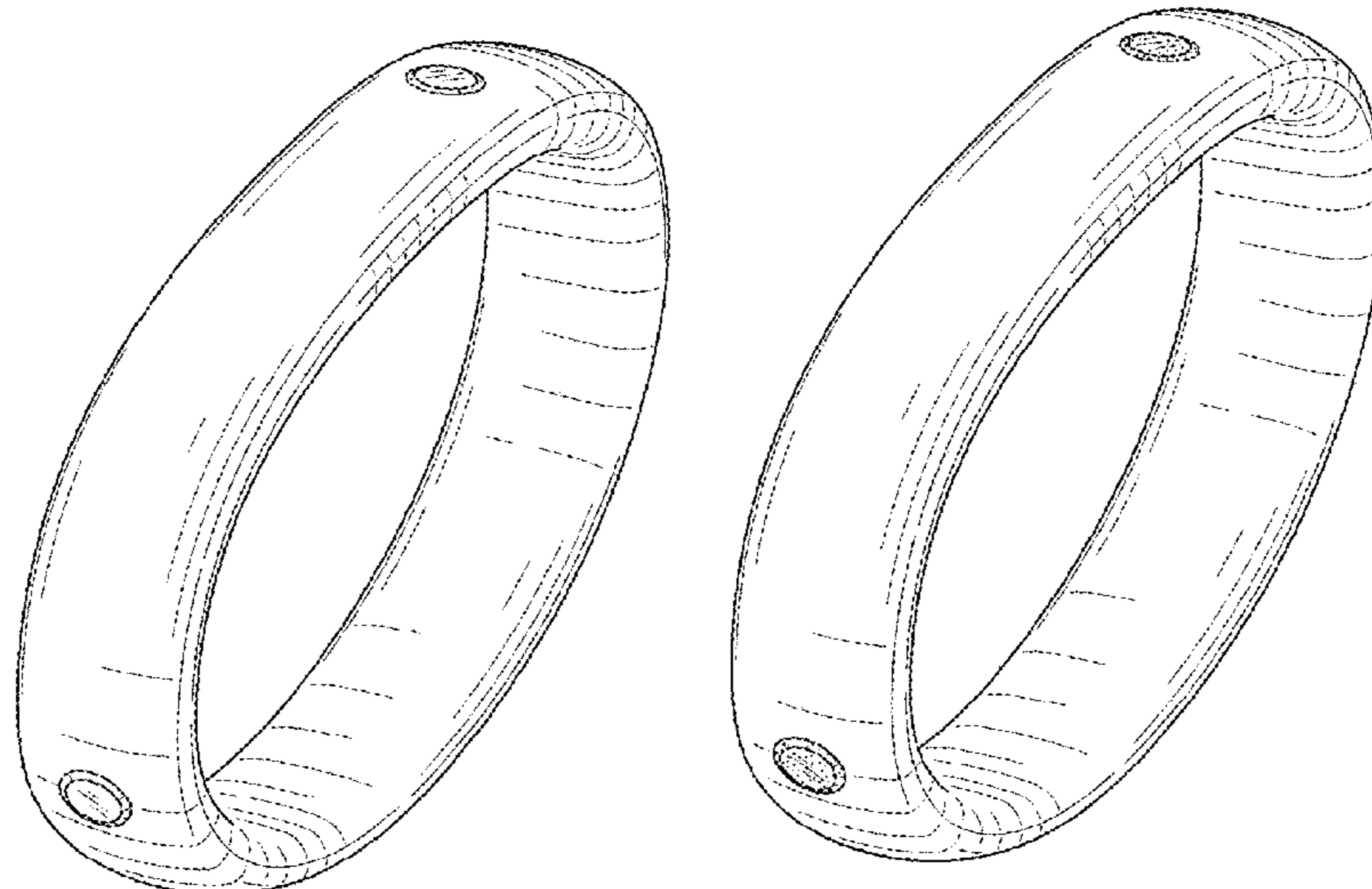
DESCRIPTION

FIG. 1 is a front perspective view of a camera bracelet according to a first embodiment of our design; FIG. 2 is a front view thereof; FIG. 3 is a back view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; FIG. 8 is a front perspective view of a camera bracelet according to a second embodiment of our design; FIG. 9 is a front view thereof; FIG. 10 is a back view thereof; FIG. 11 is a right side view thereof; FIG. 12 is a left side view thereof; FIG. 13 is a top view thereof; FIG. 14 is a bottom view thereof; FIG. 15 is a front perspective view of a camera bracelet according to a third embodiment of our design; FIG. 16 is a front view thereof; FIG. 17 is a back view thereof; FIG. 18 is a right side view thereof; FIG. 19 is a left side view thereof; FIG. 20 is a top view thereof; and, FIG. 21 is a bottom view thereof.

The broken lines shown in the drawings represent portions of the camera bracelet that form no part of the claimed design.

Stipple-fill areas represent portions of the design that have a color that contrasts with a color of the non-stippled filled areas.

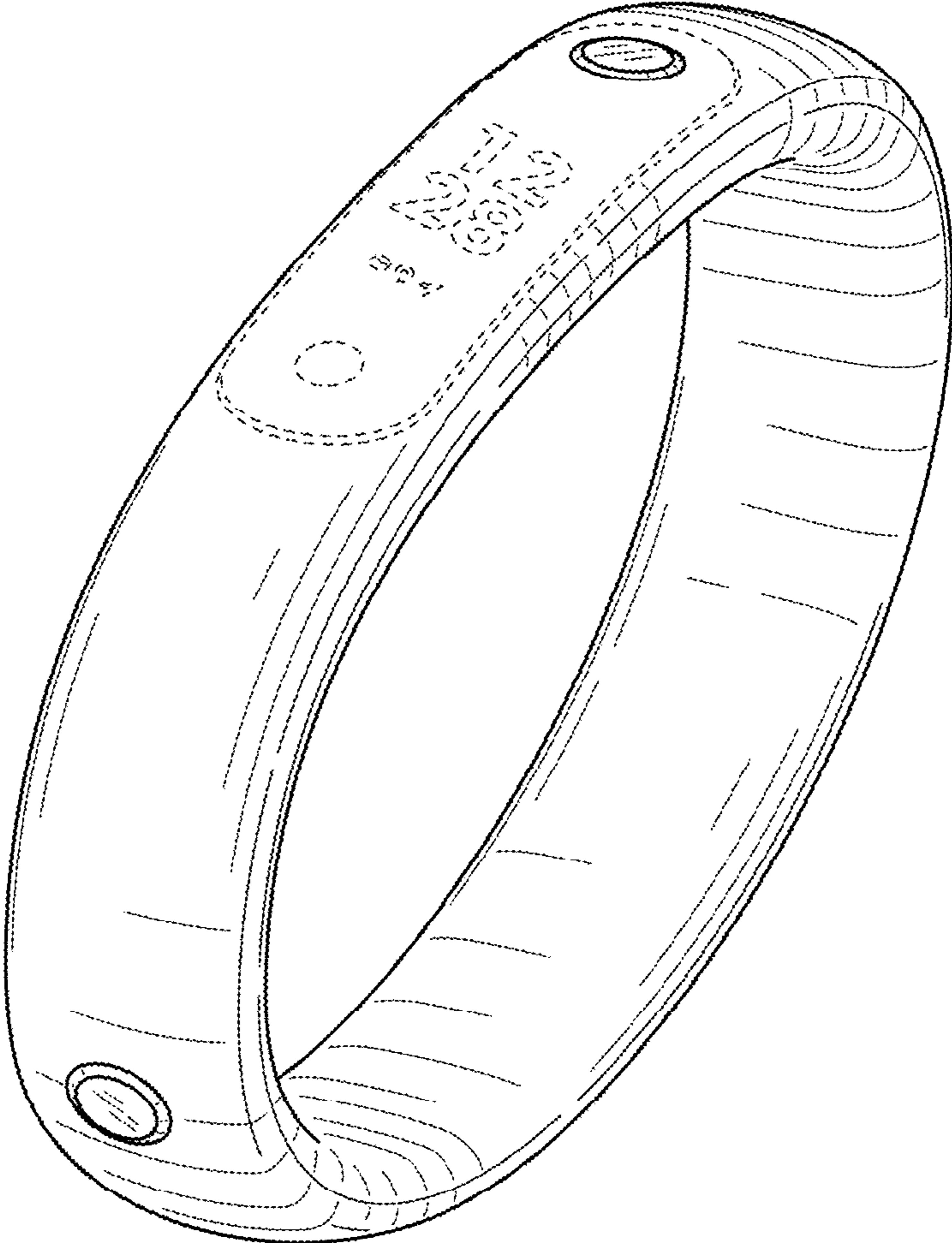

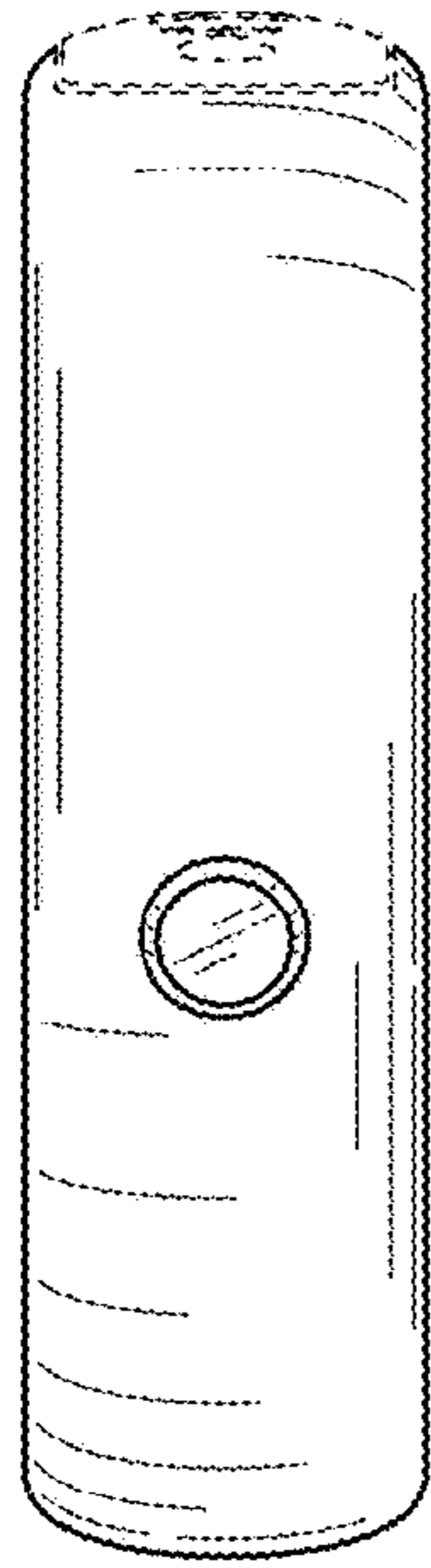

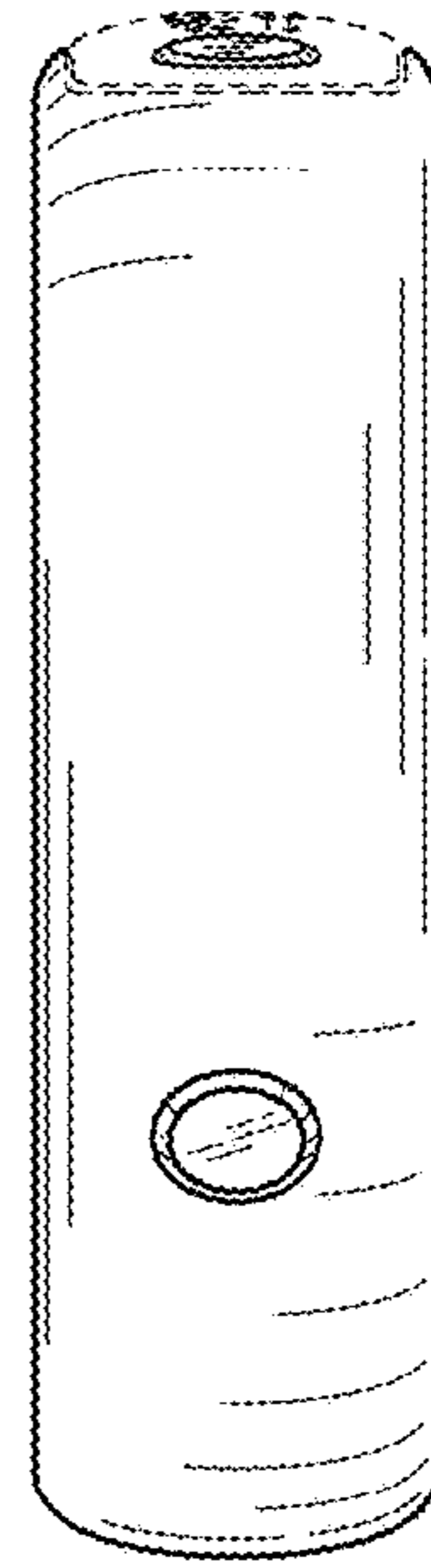

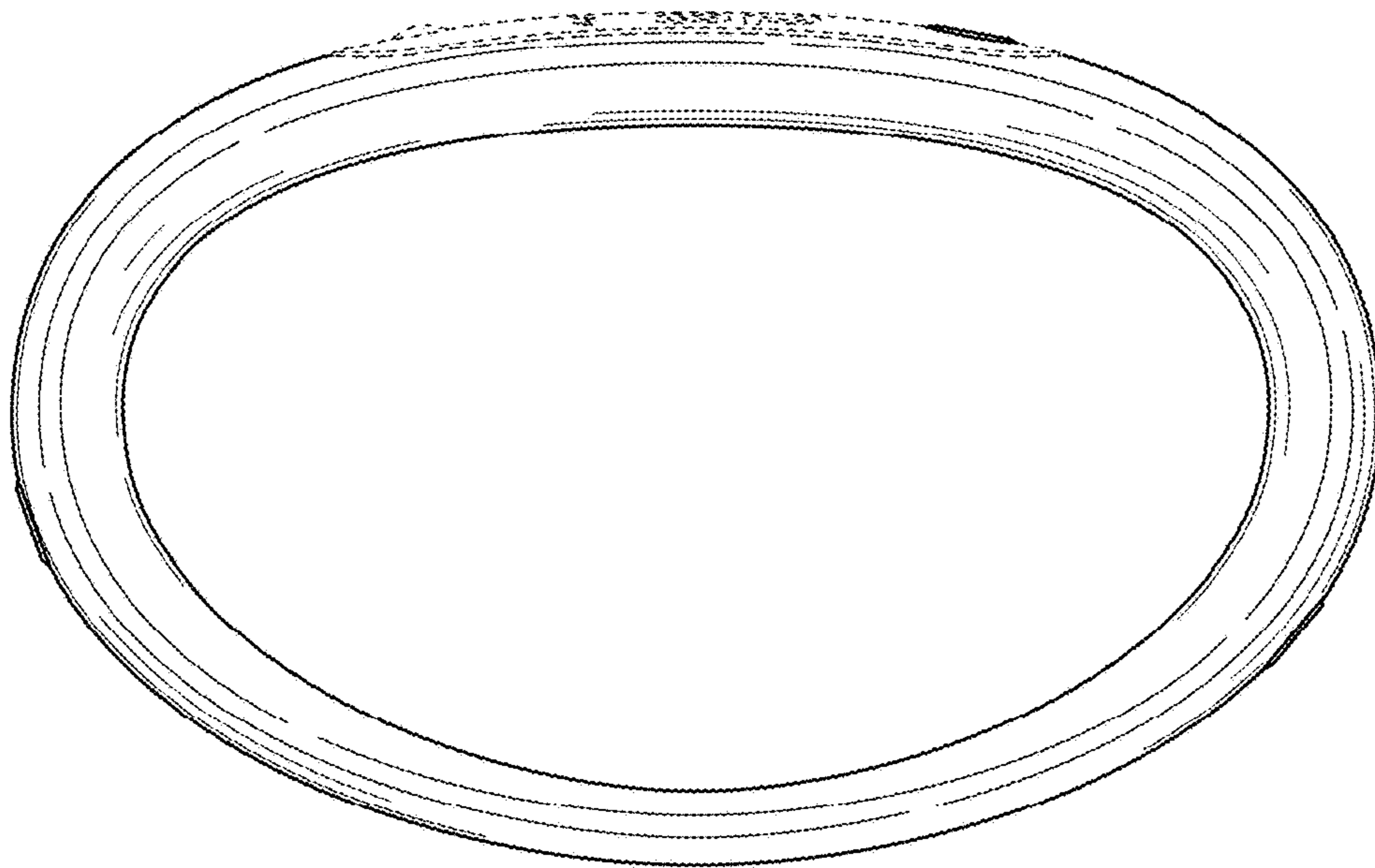

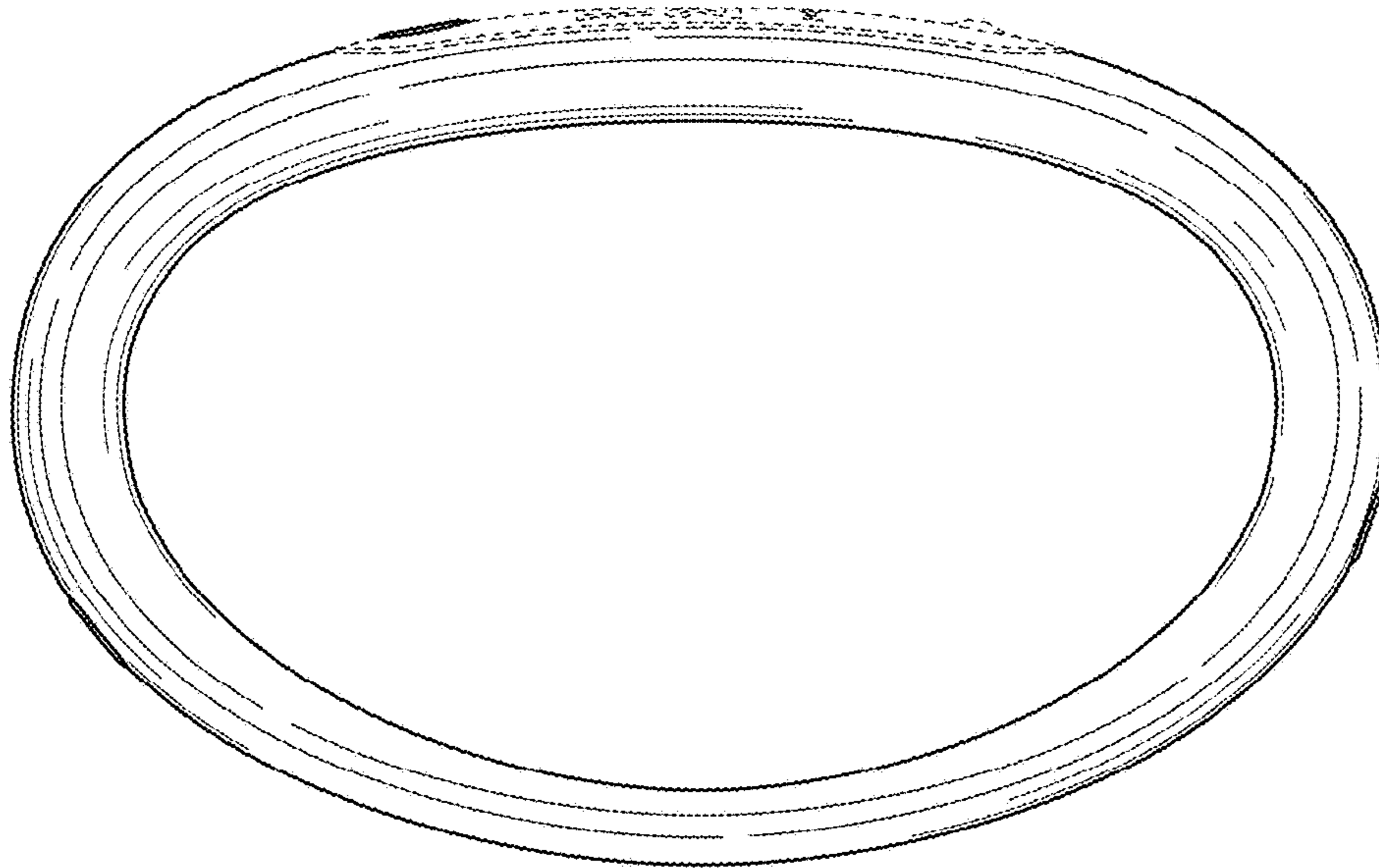

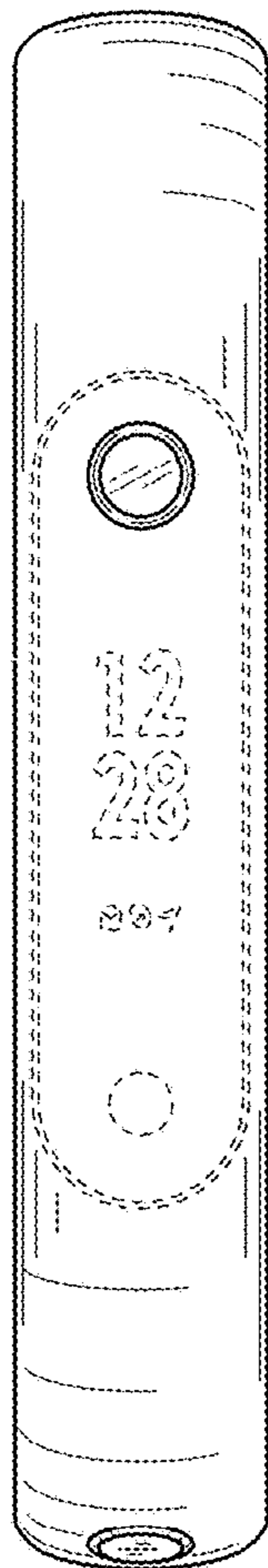

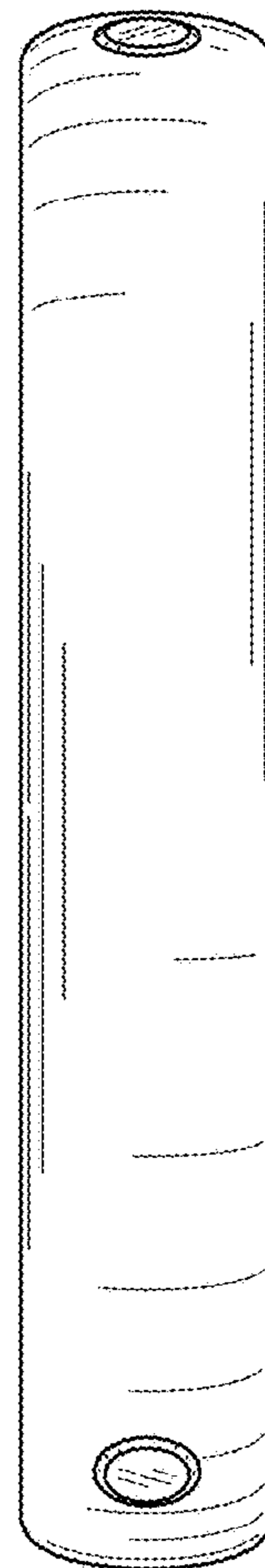

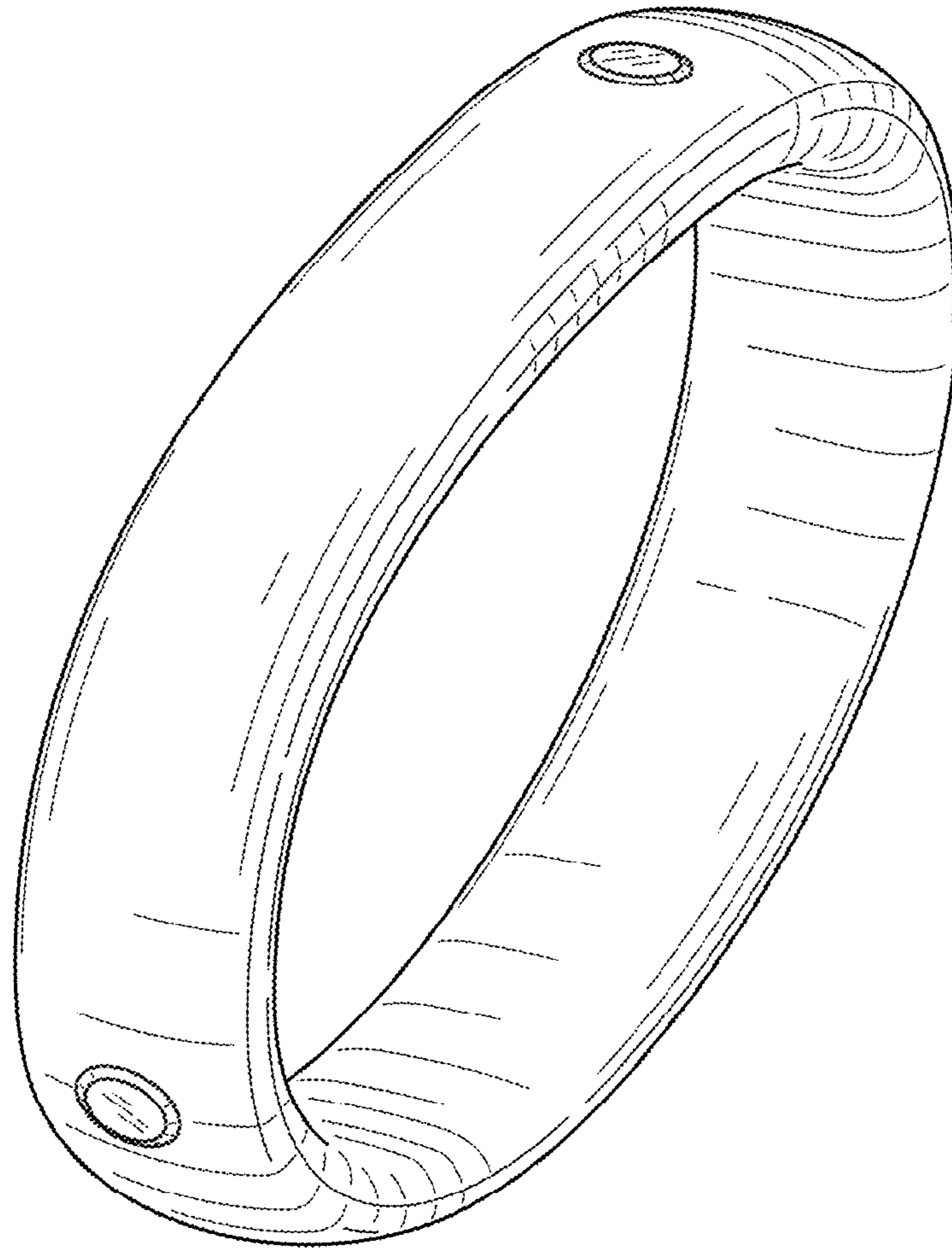

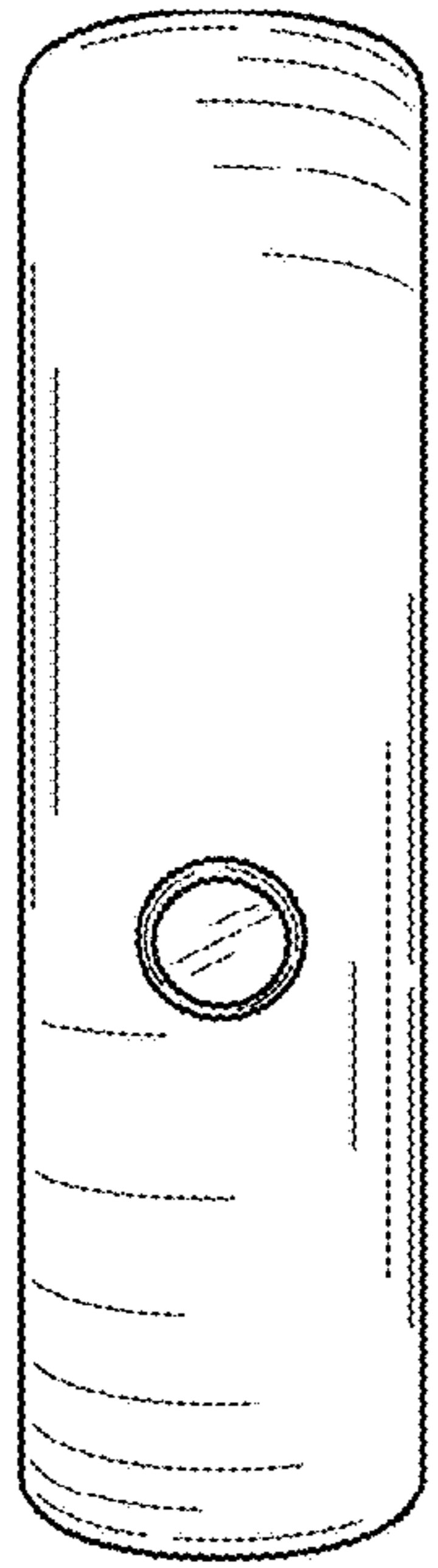

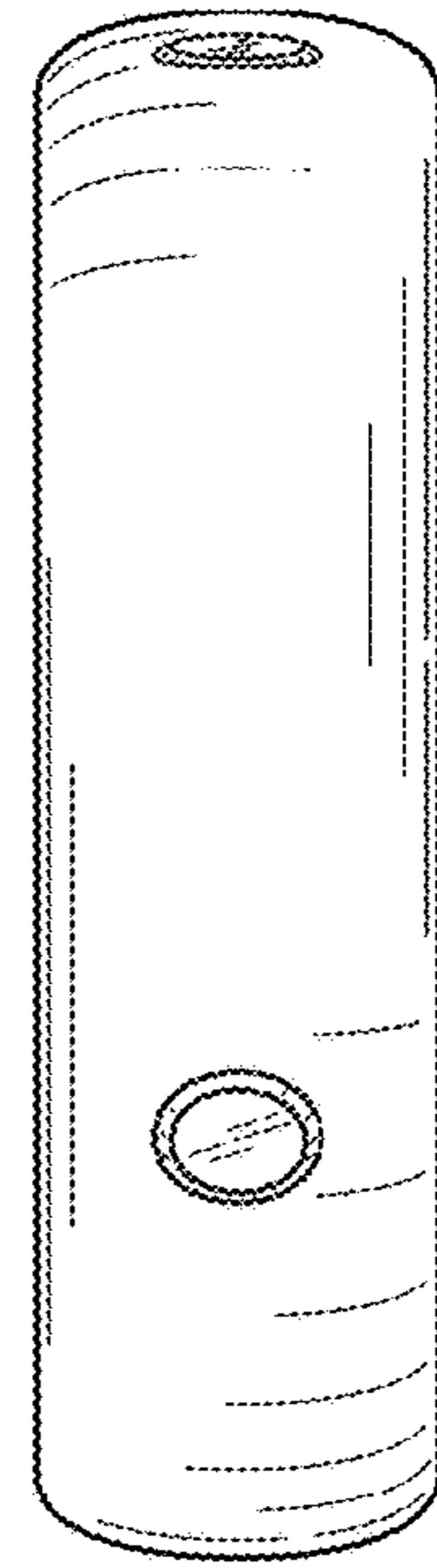

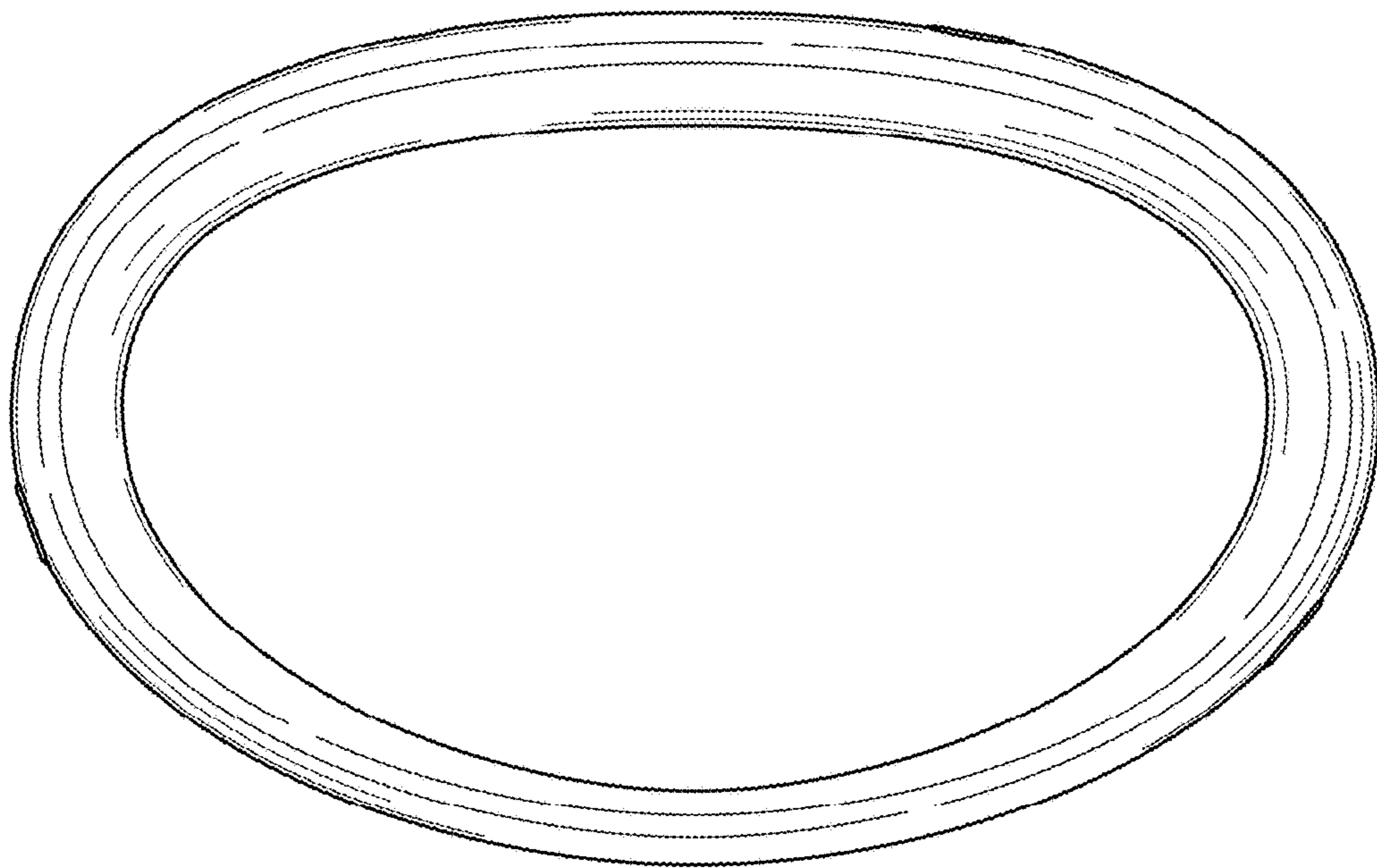

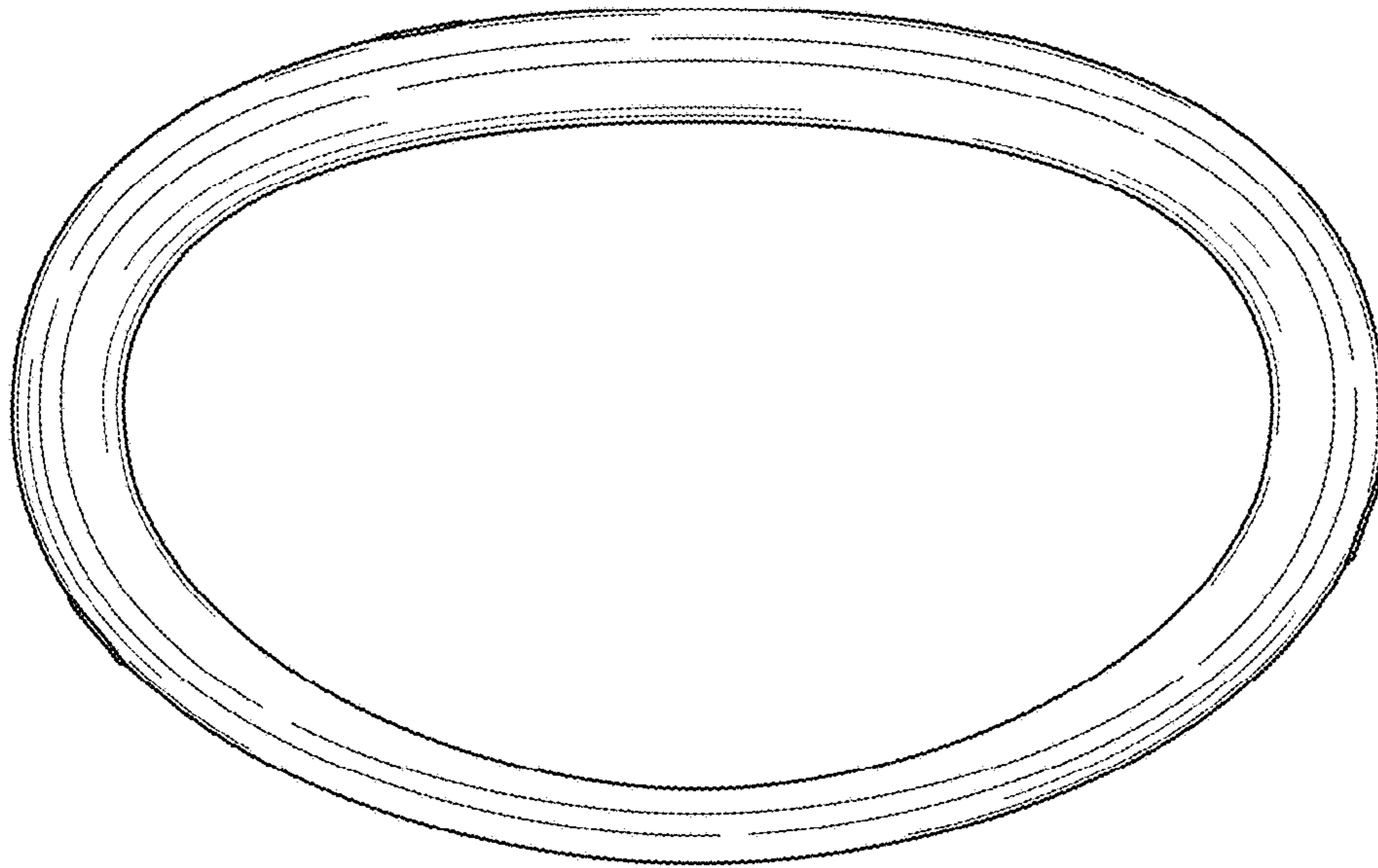

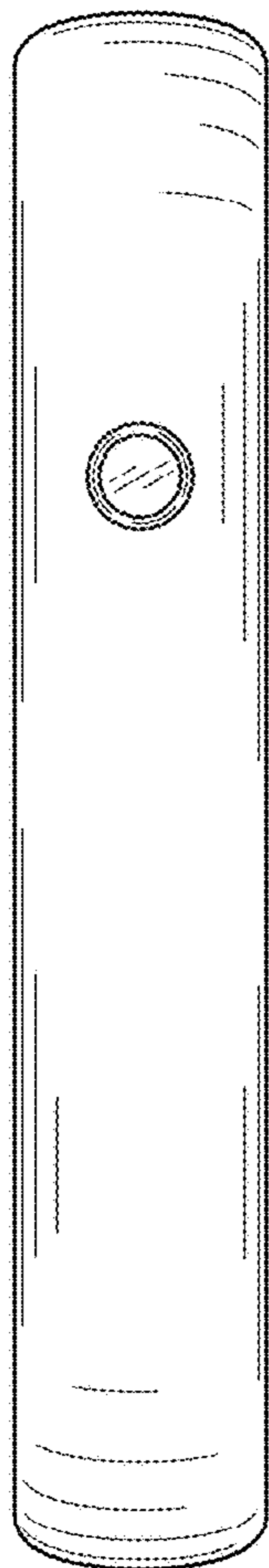

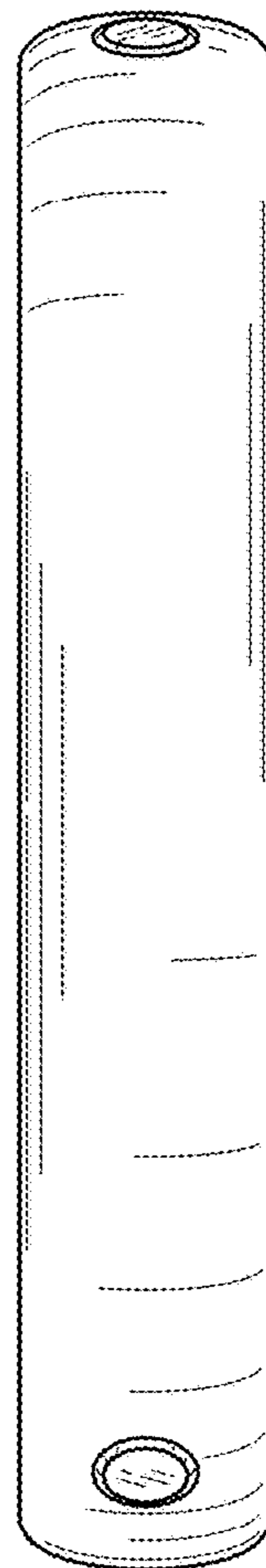

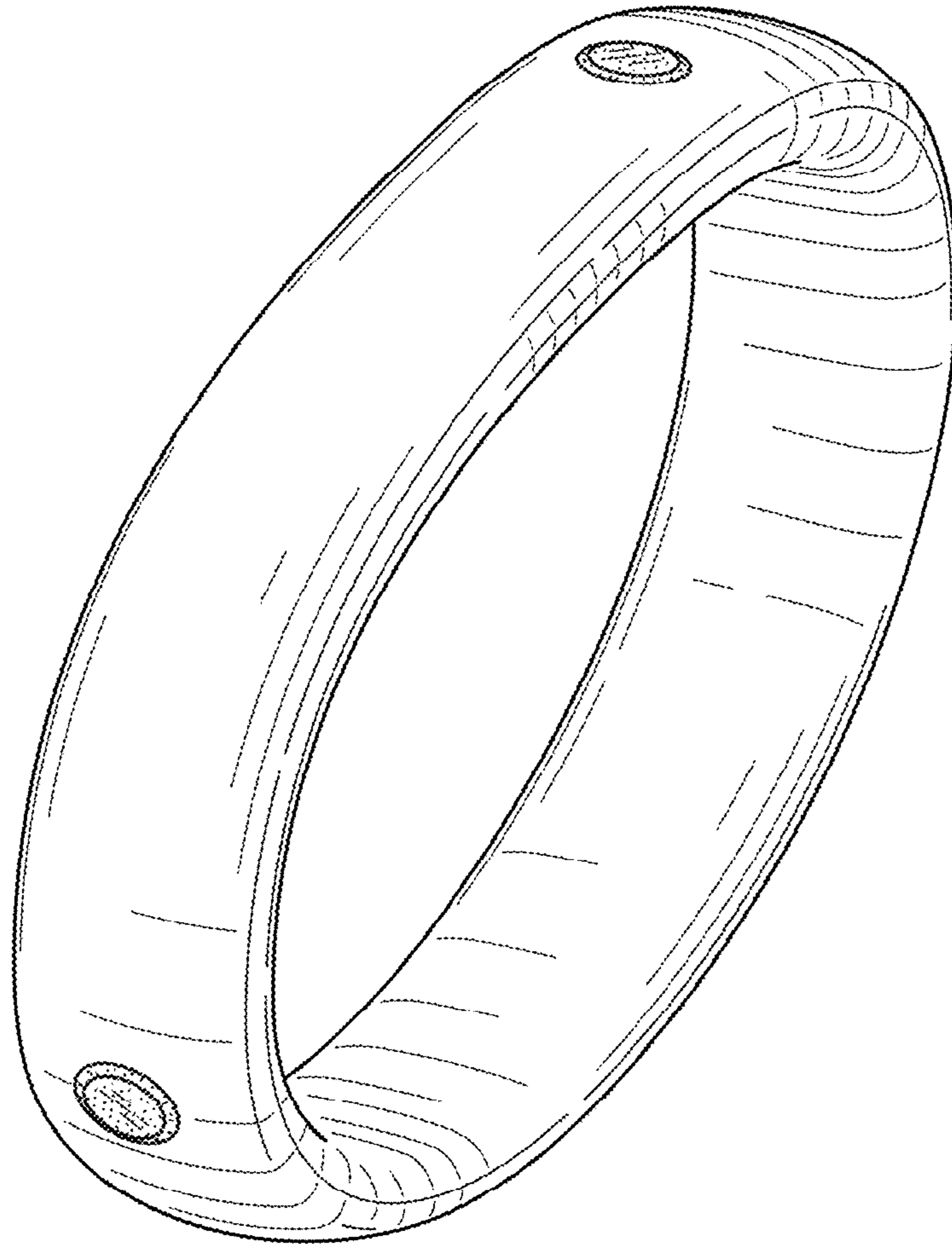

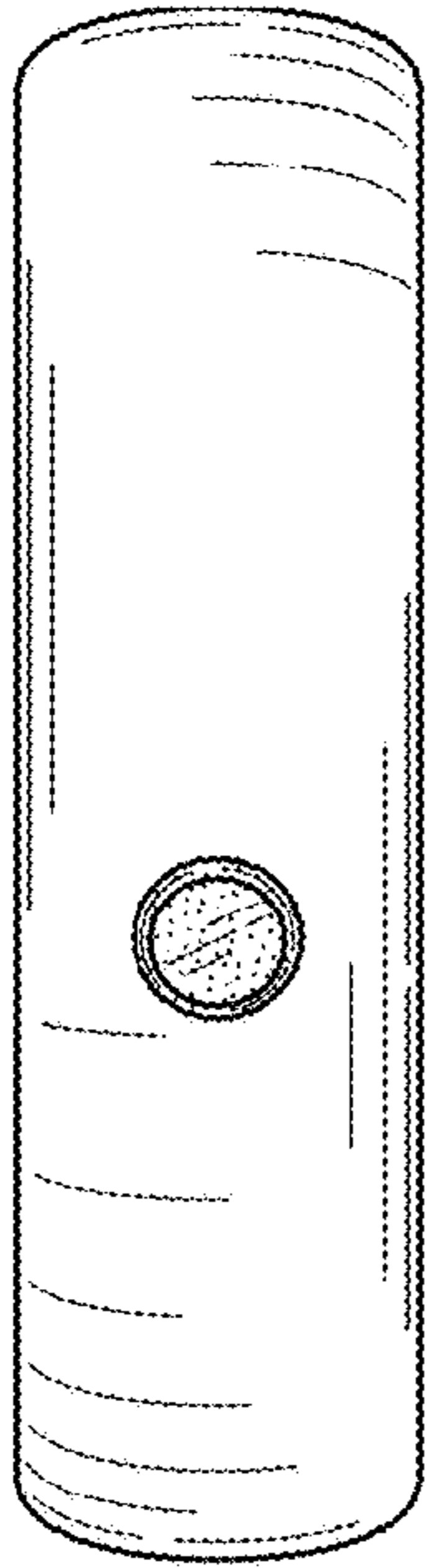

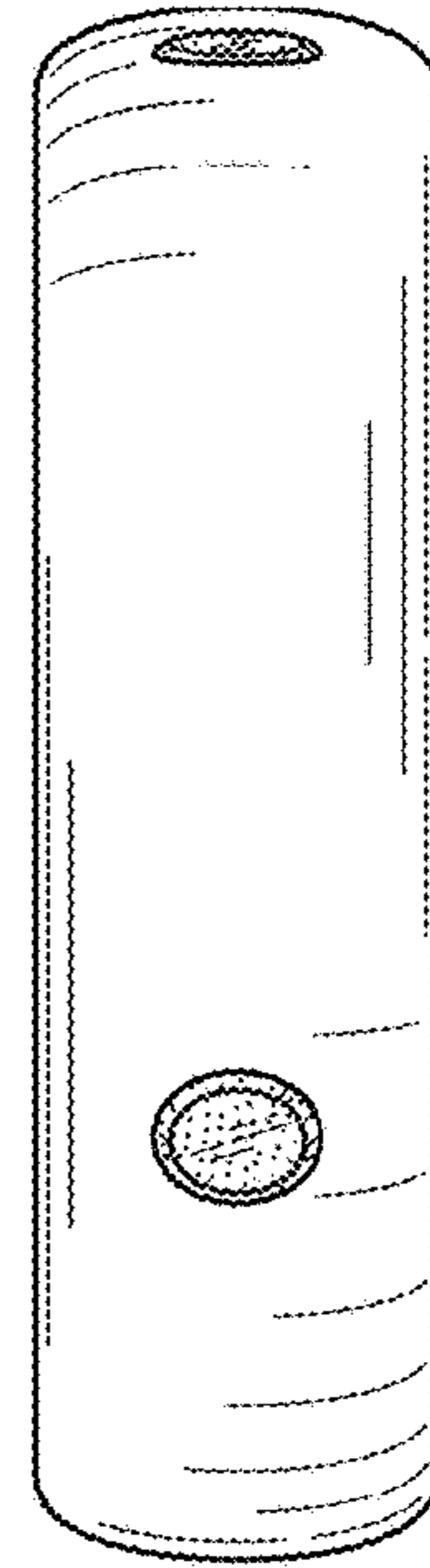

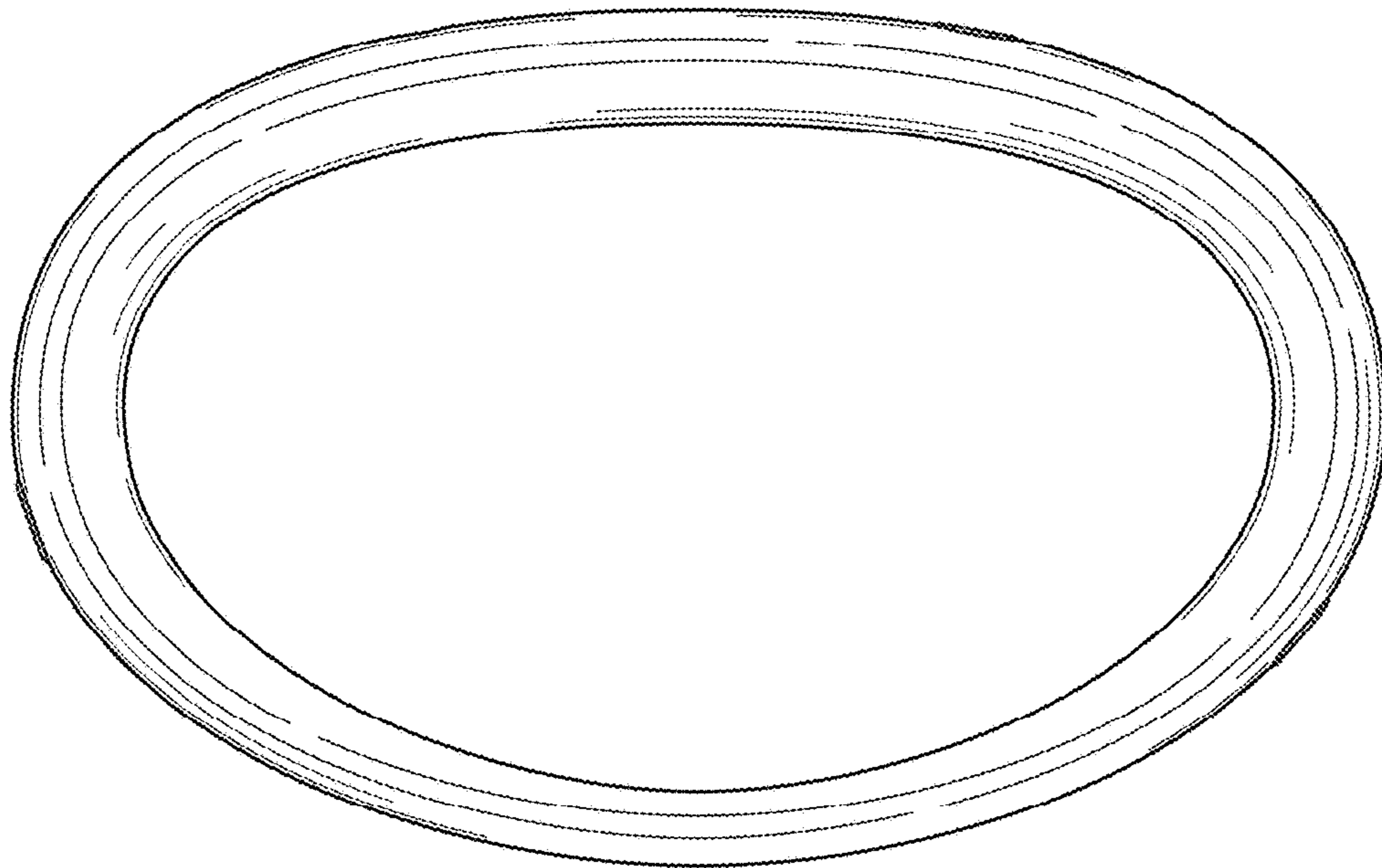

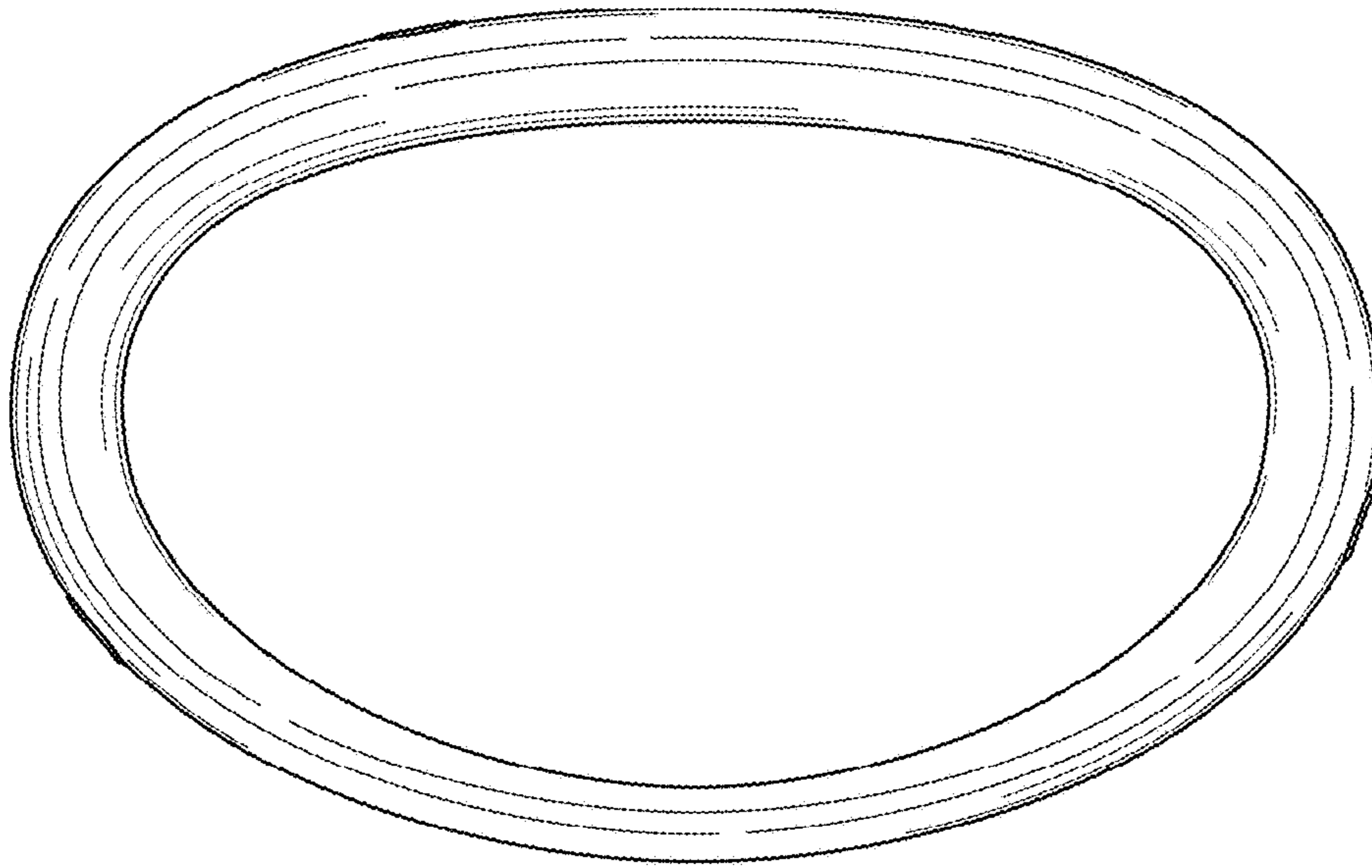

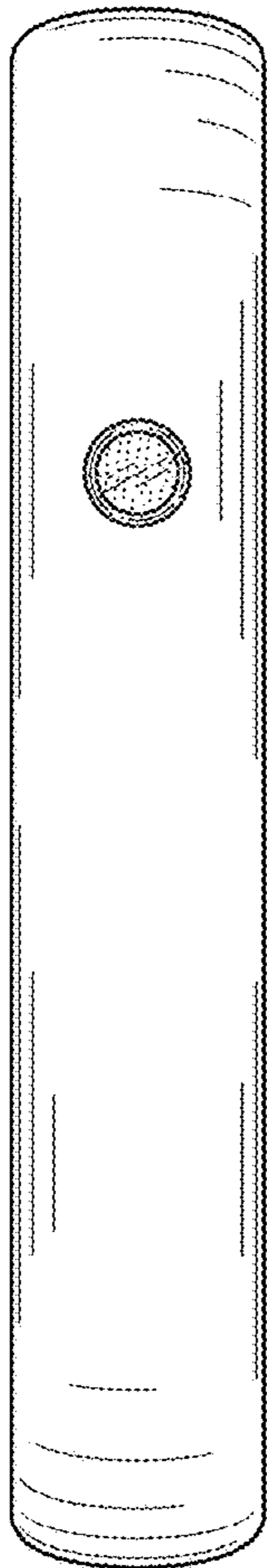

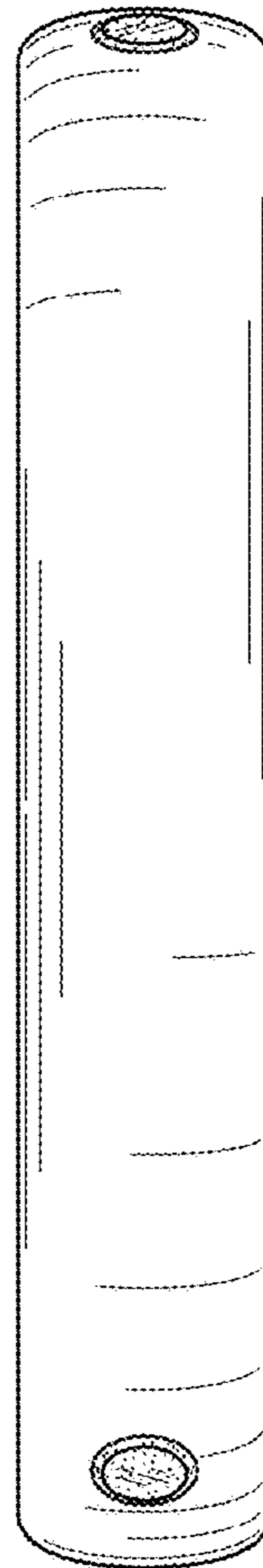
