DESCRIPTION

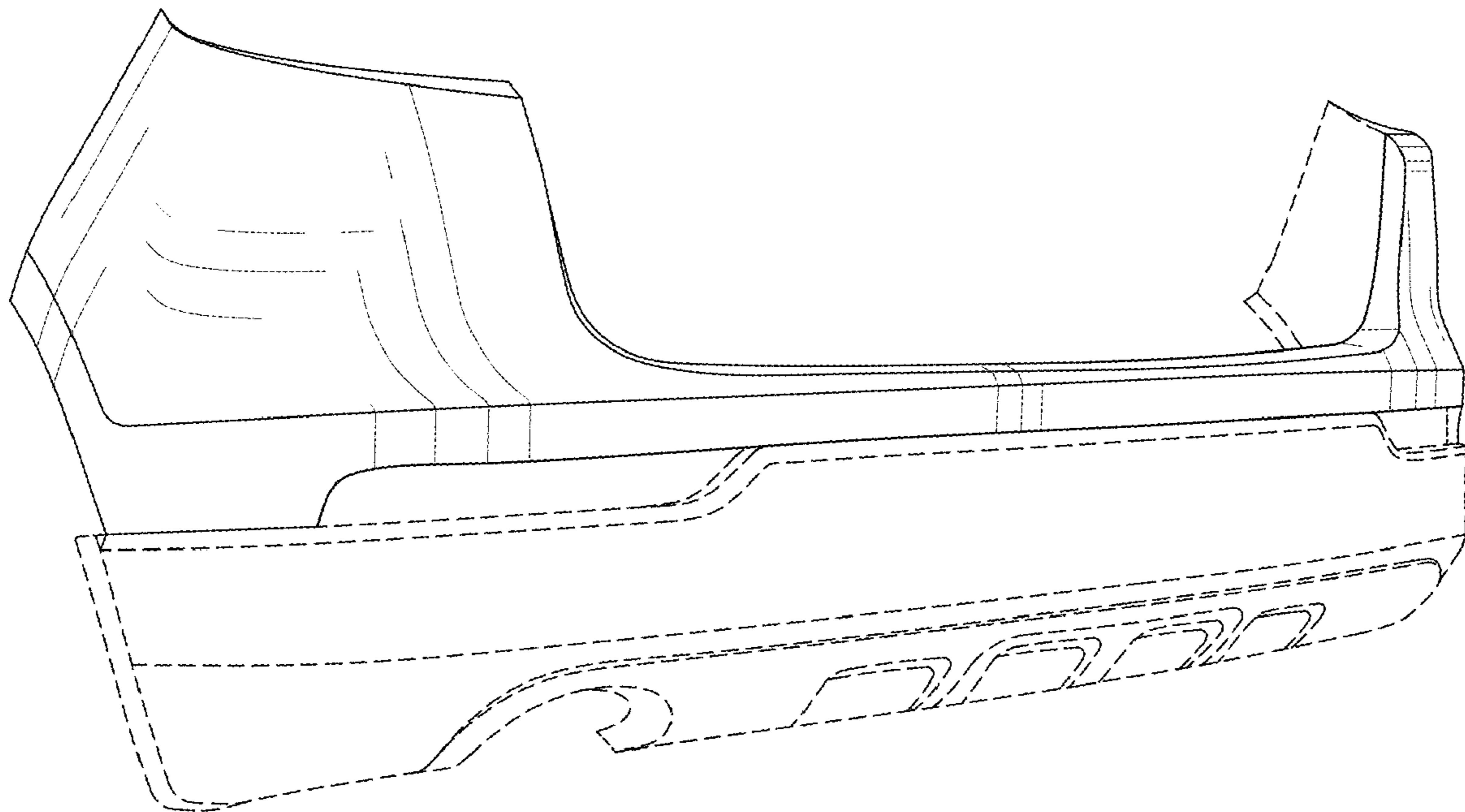
FIG. 1 is a front view of the vehicle rear fascia;

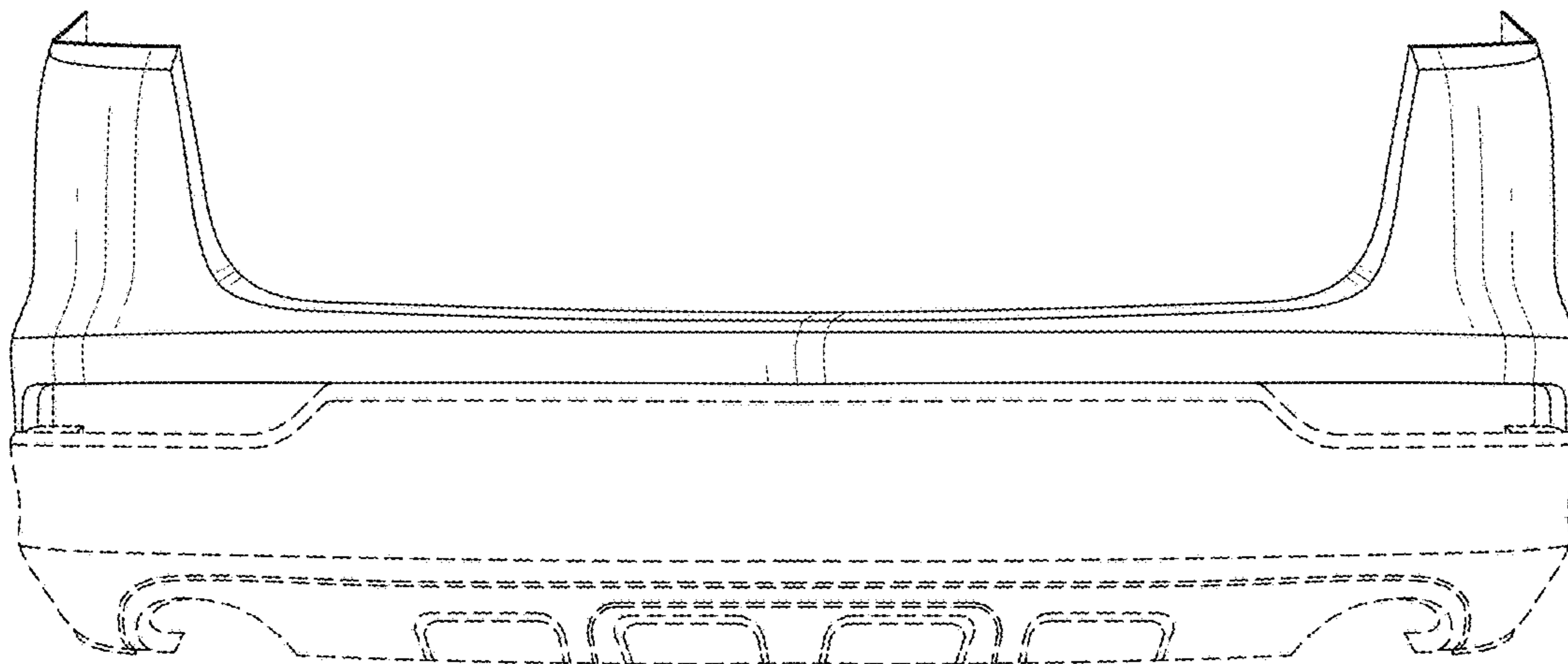

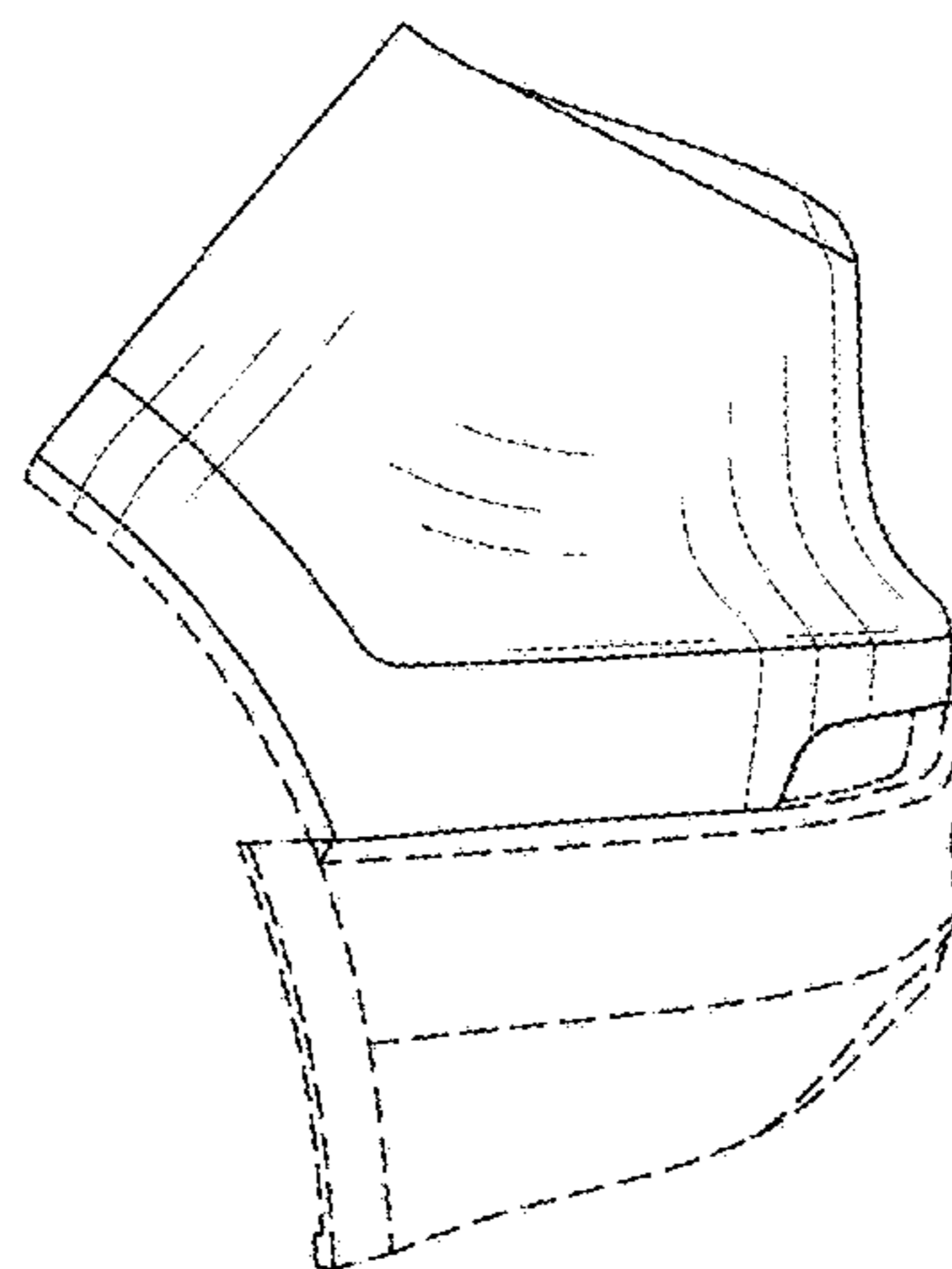

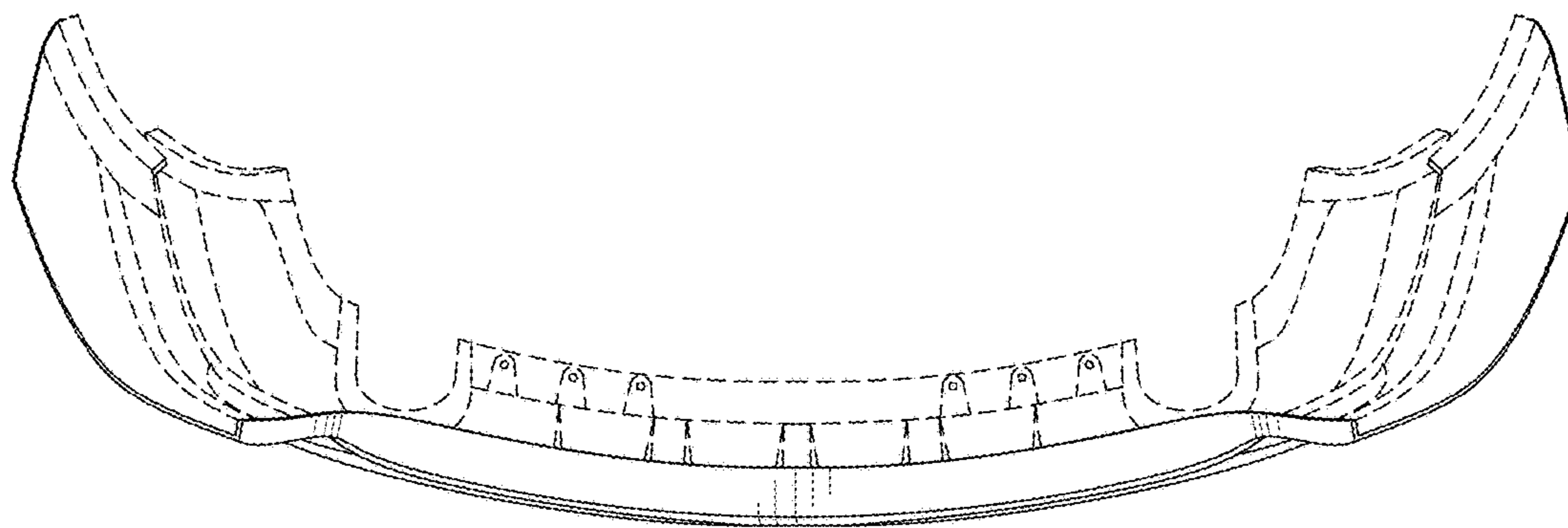

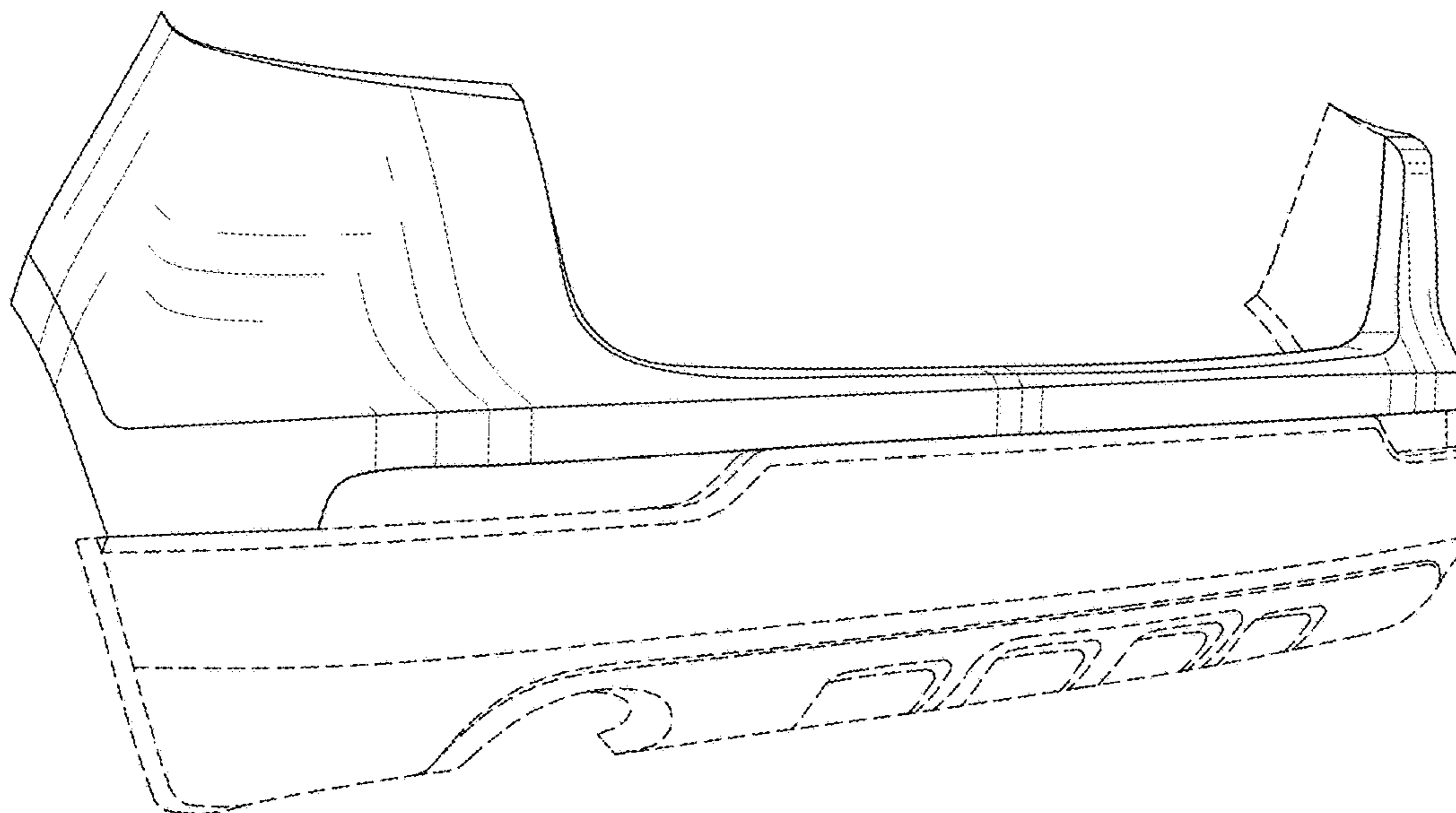
