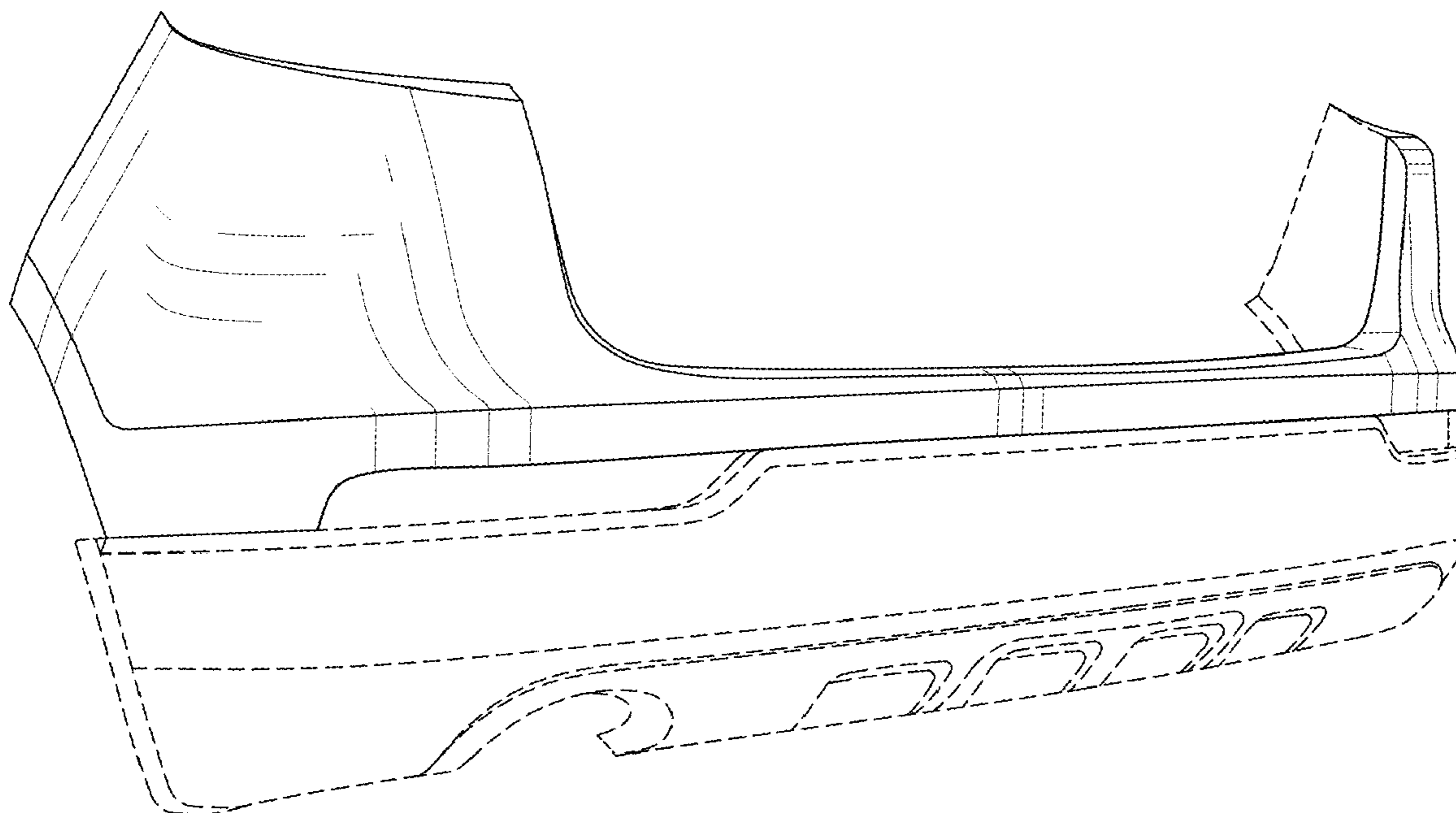
(57) **CLAIM**

The ornamental design for a vehicle rear fascia, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the vehicle rear fascia;
FIG. 2 is a left side elevation view thereof, wherein the right side elevation view is a mirror image;
FIG. 3 is a top view thereof; and,
FIG. 4 is a perspective view thereof.

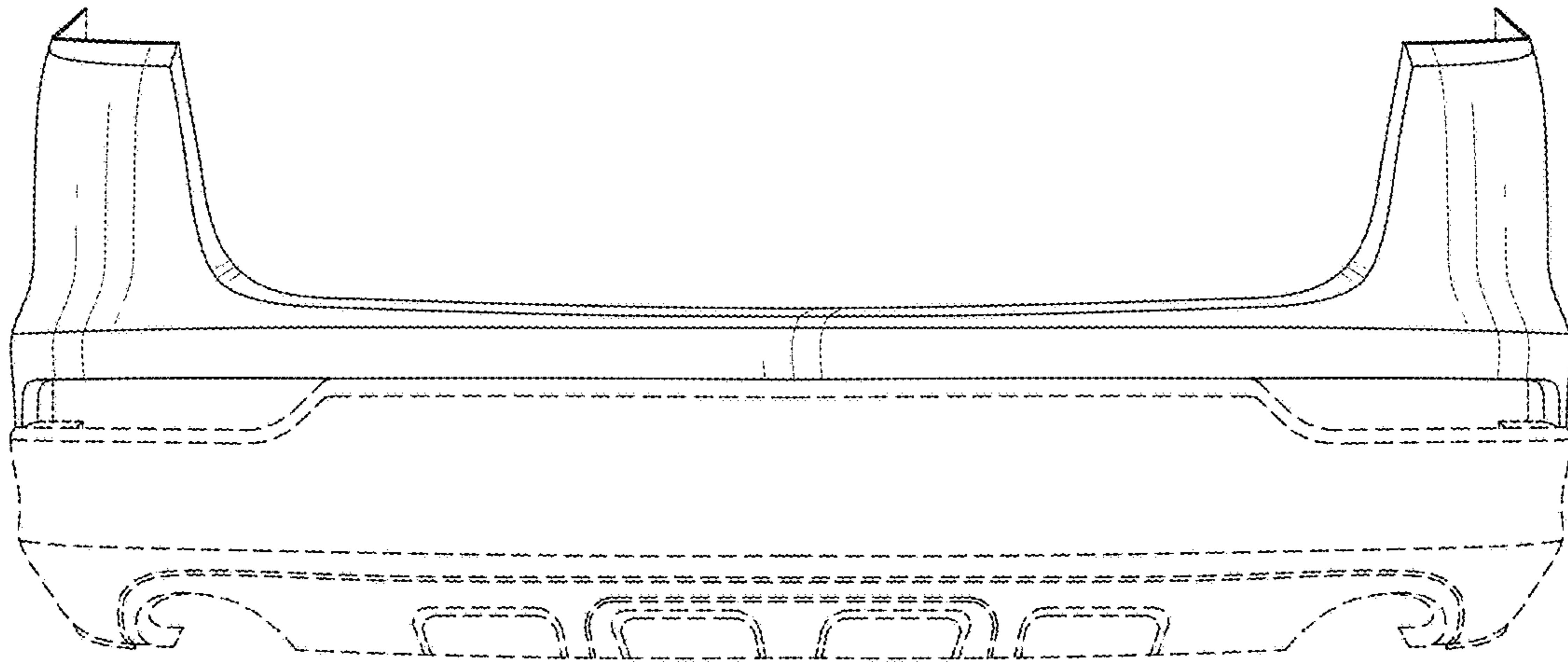

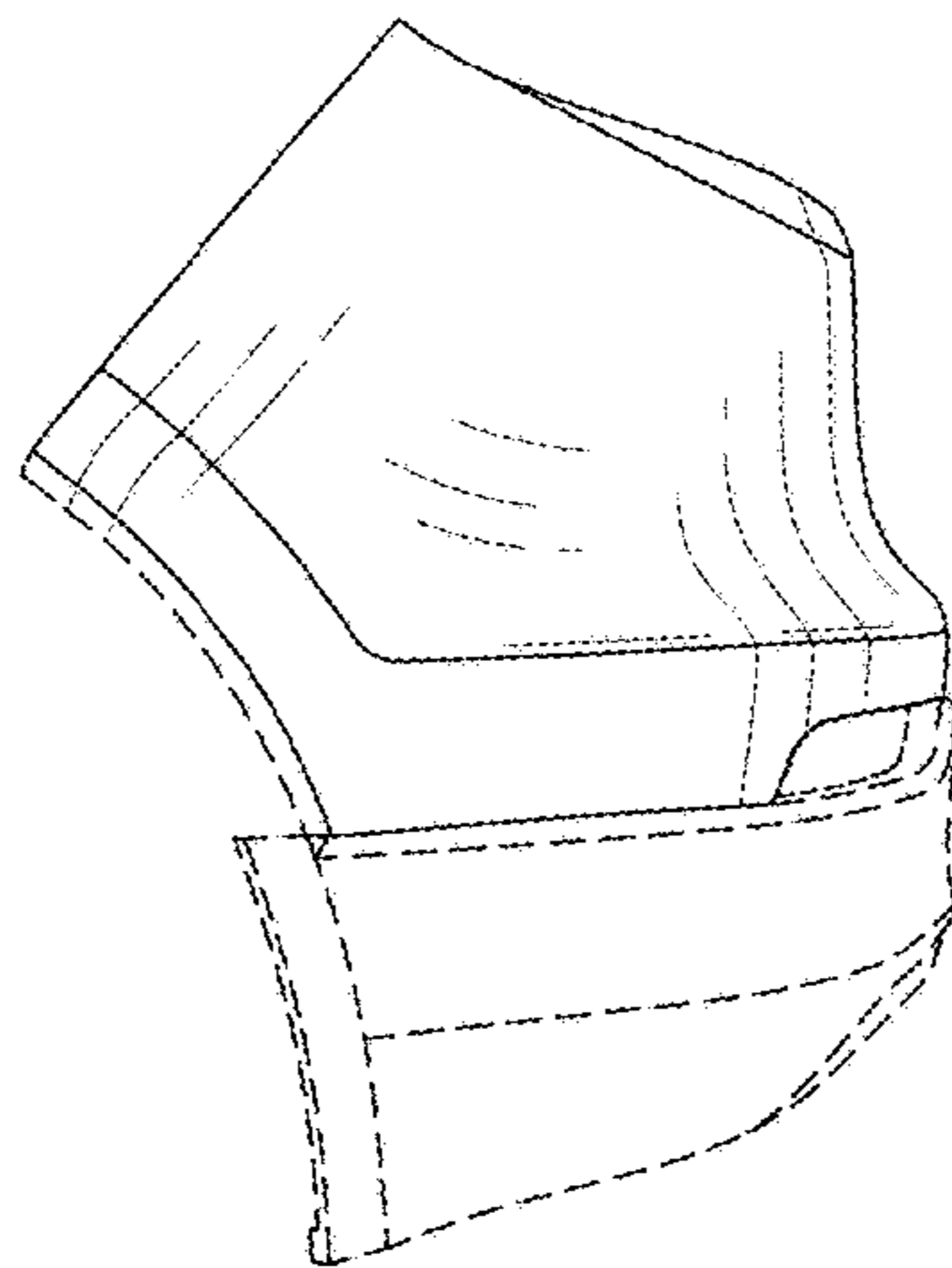

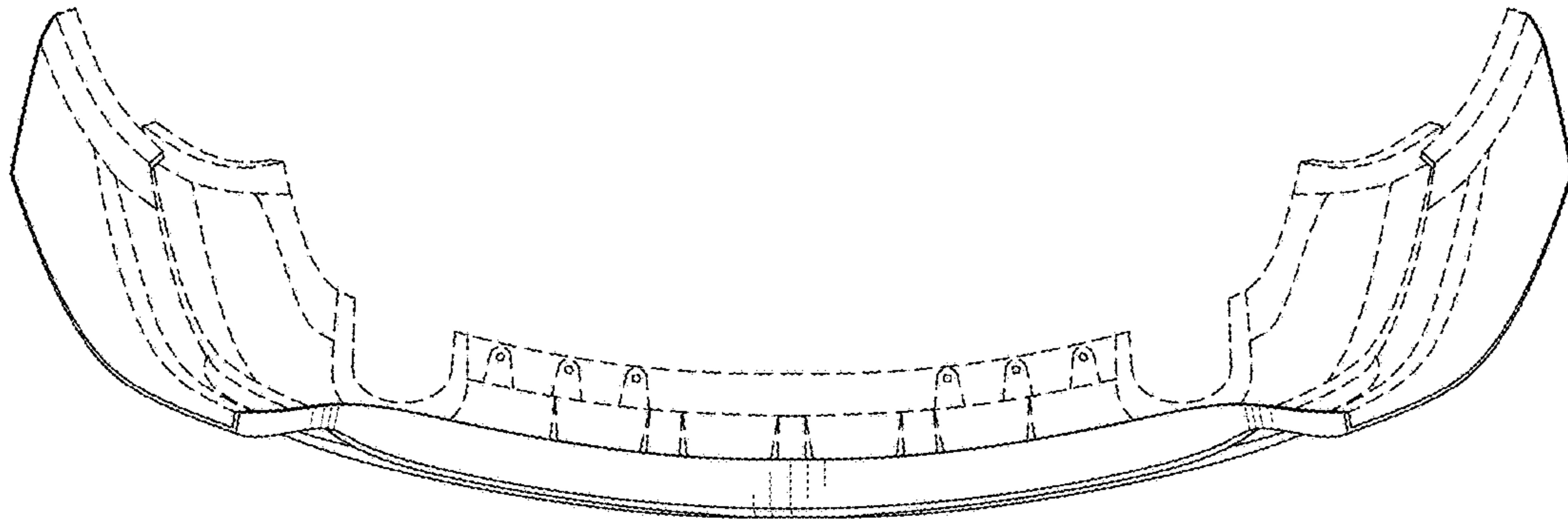

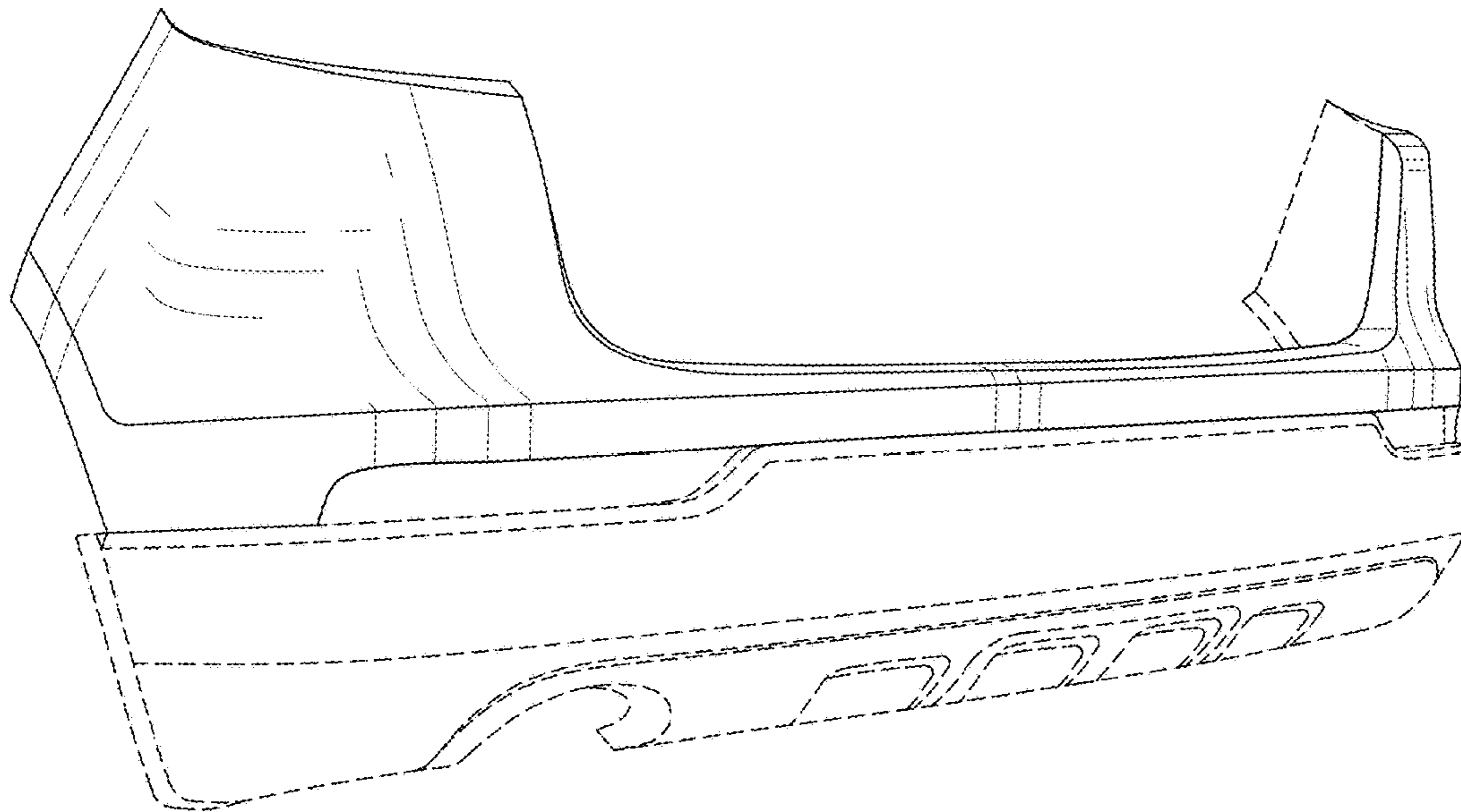
