FIG. 5 is a left side view thereof.

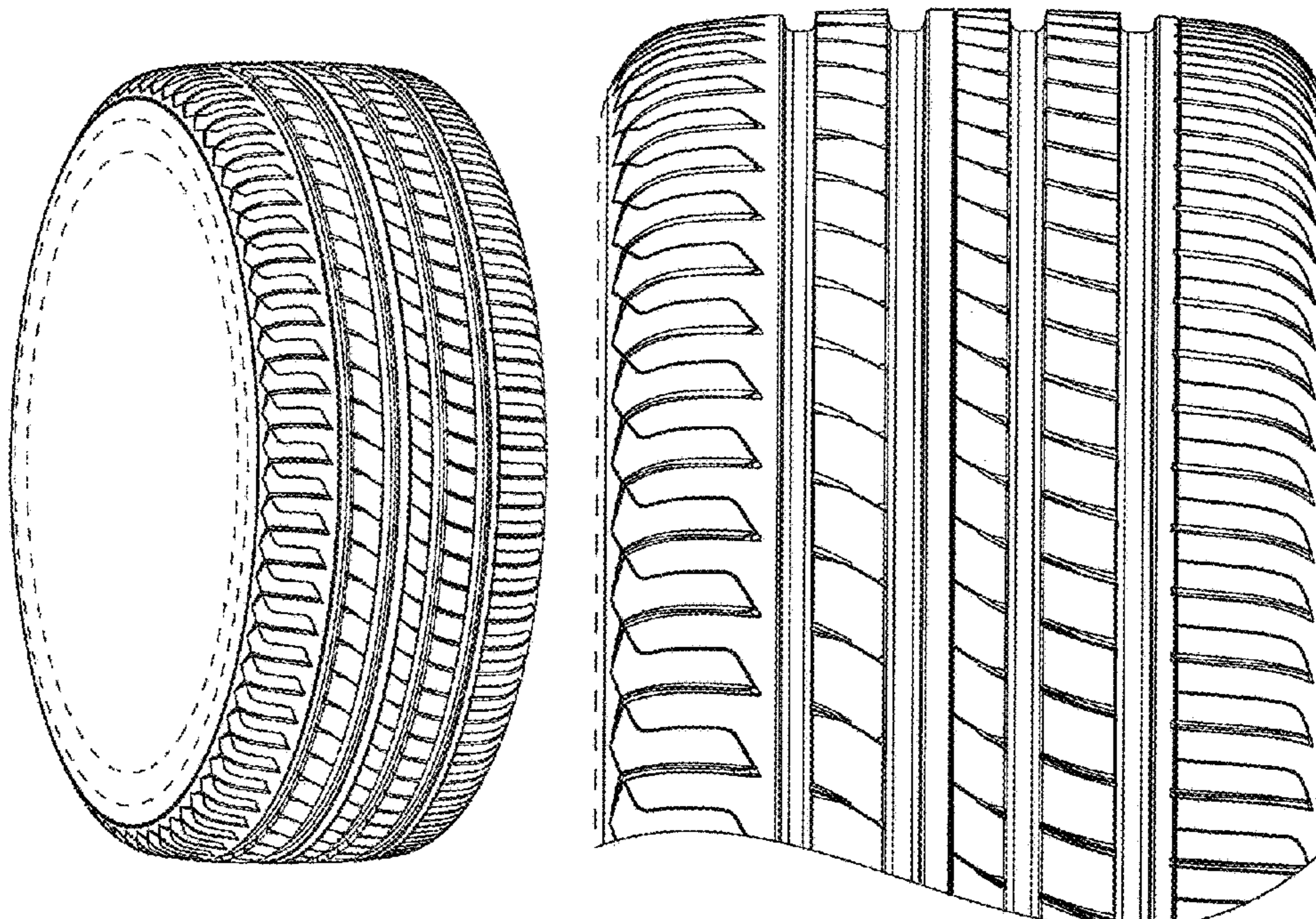
The broken lines illustrate portions of the tire sidewall and bead, and form no part of the claimed design.

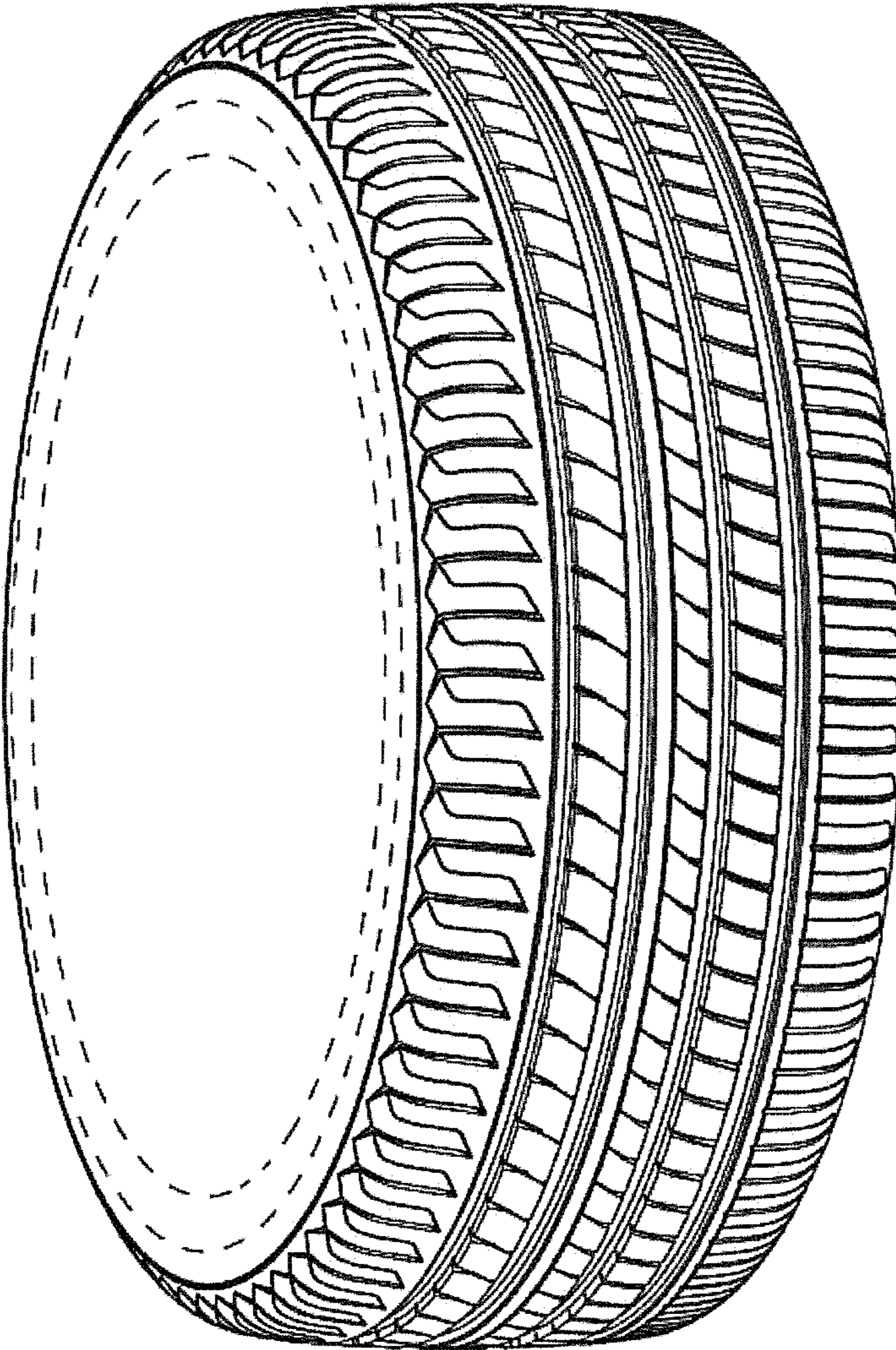

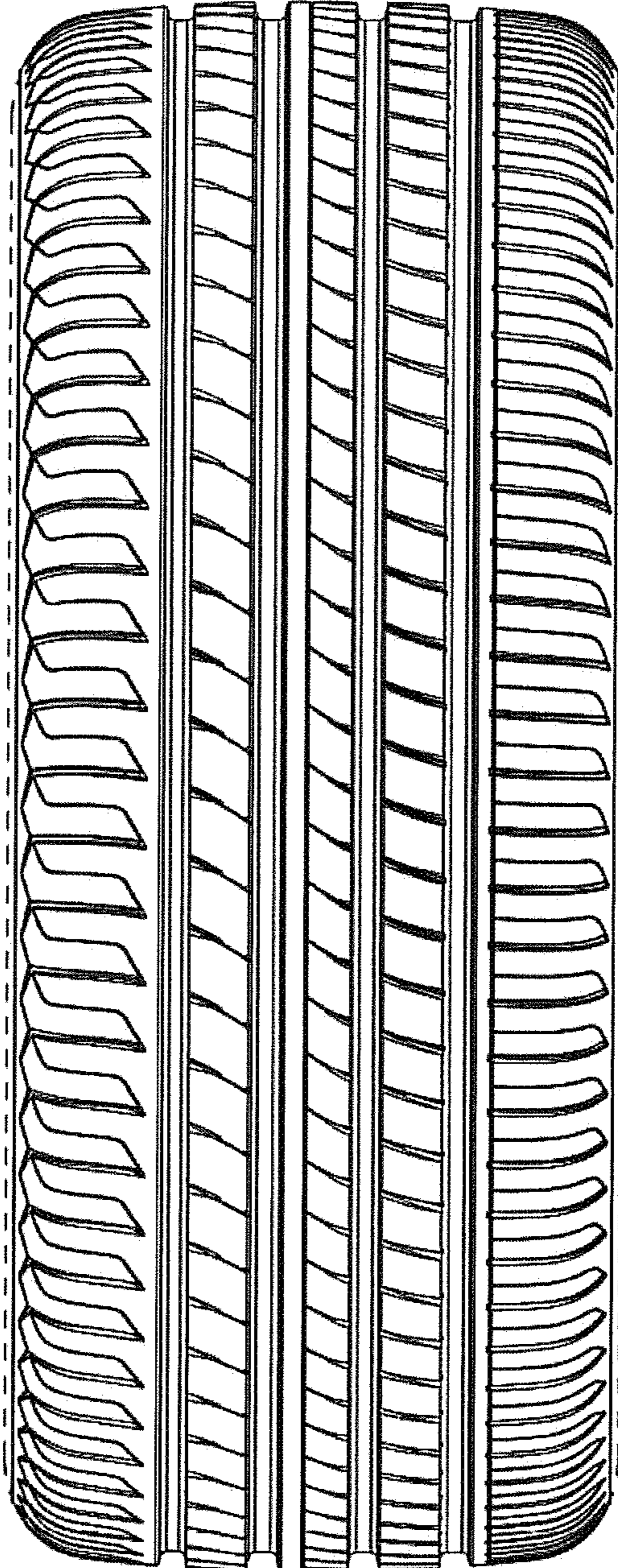

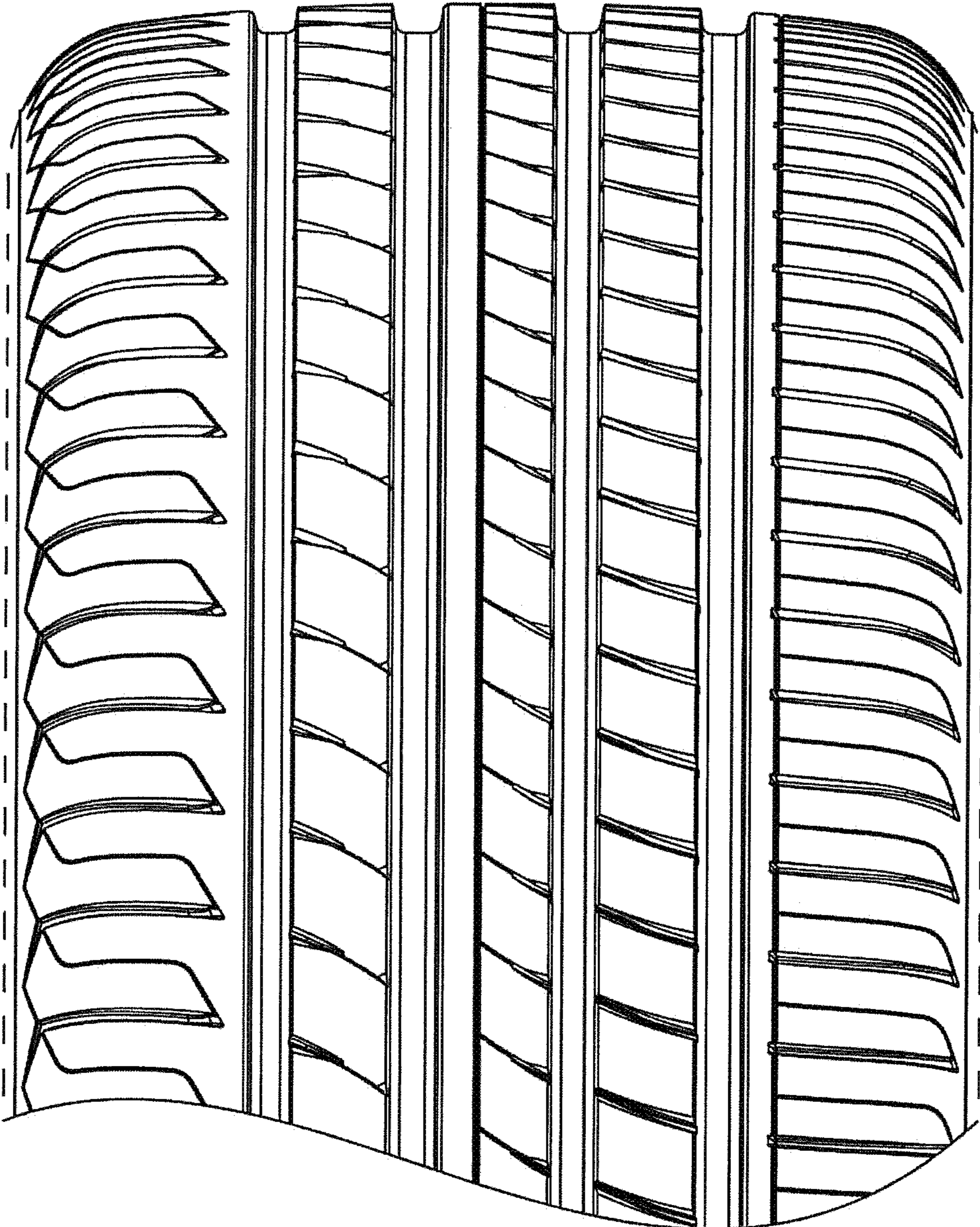

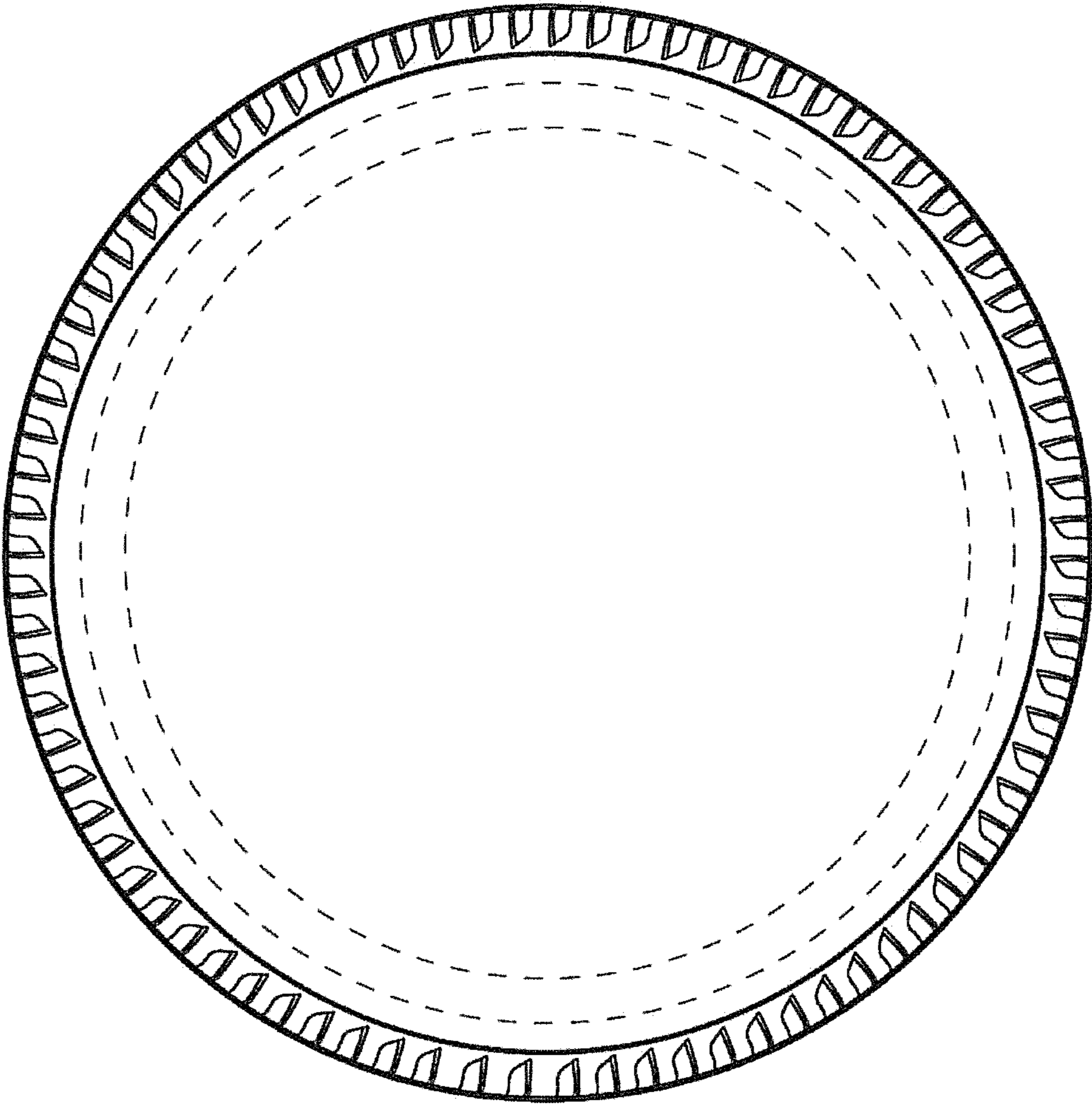

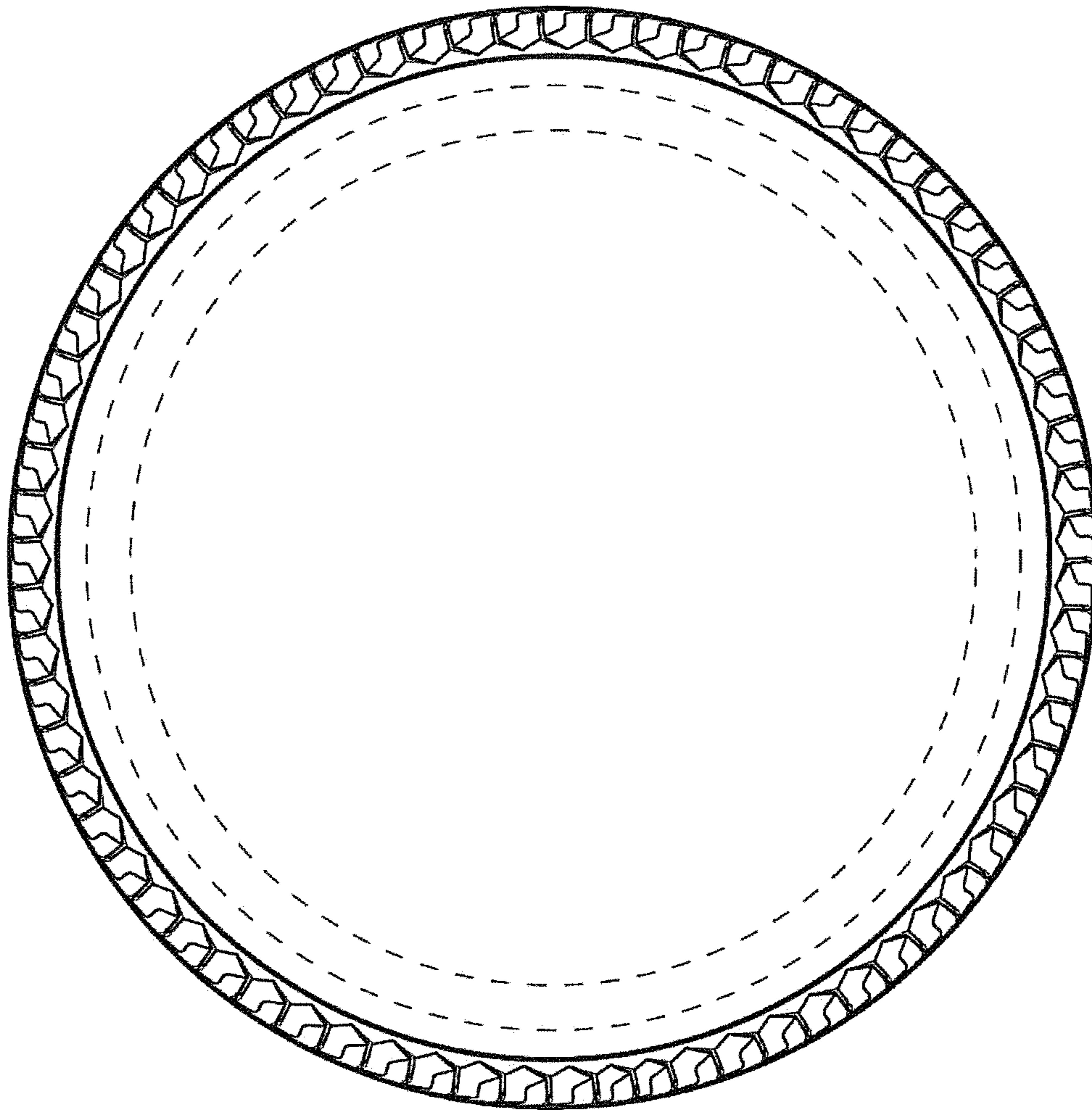
