FIG. 2 is a partial front view thereof;

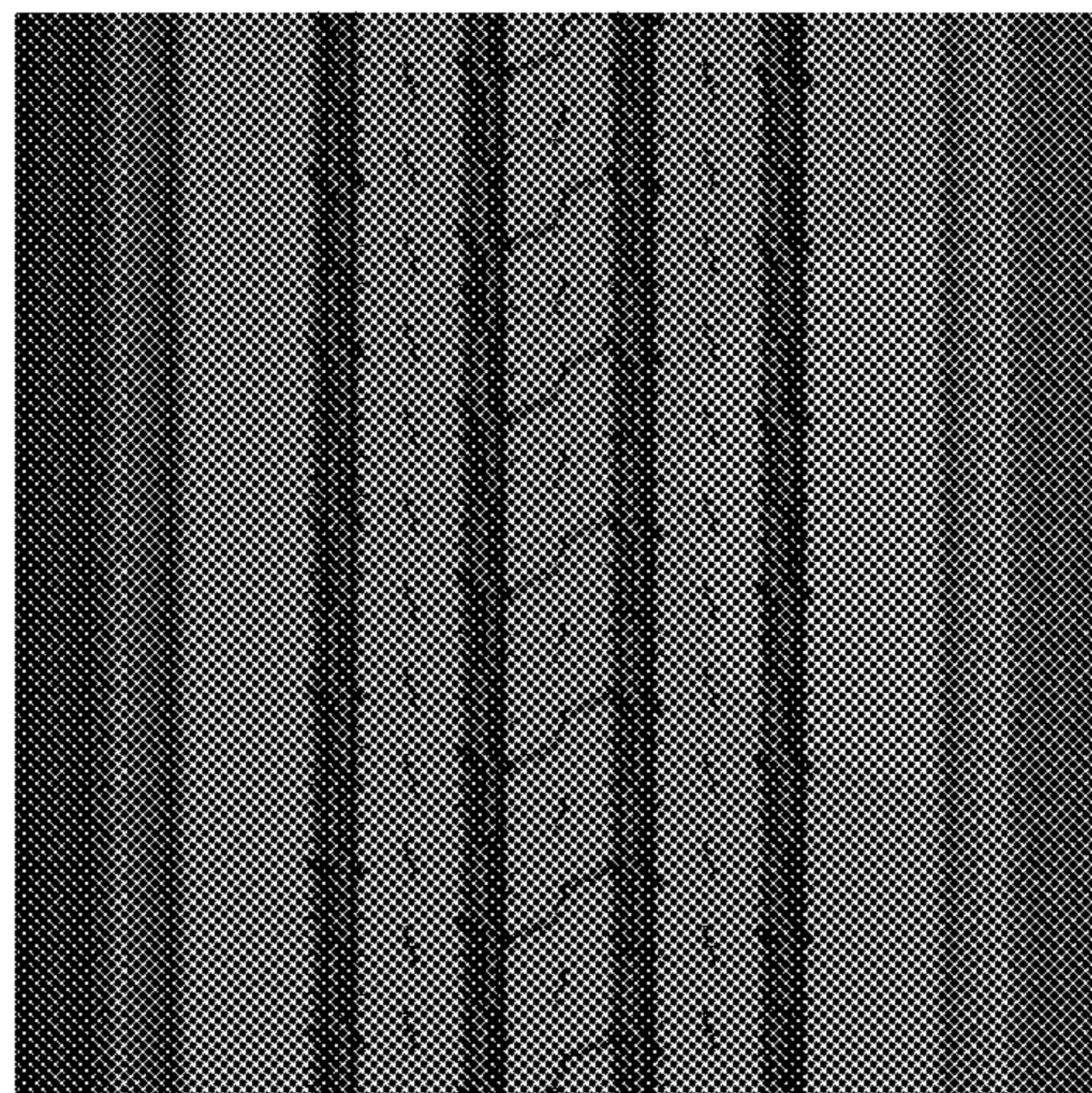
FIG. 3 is a perspective view thereof;

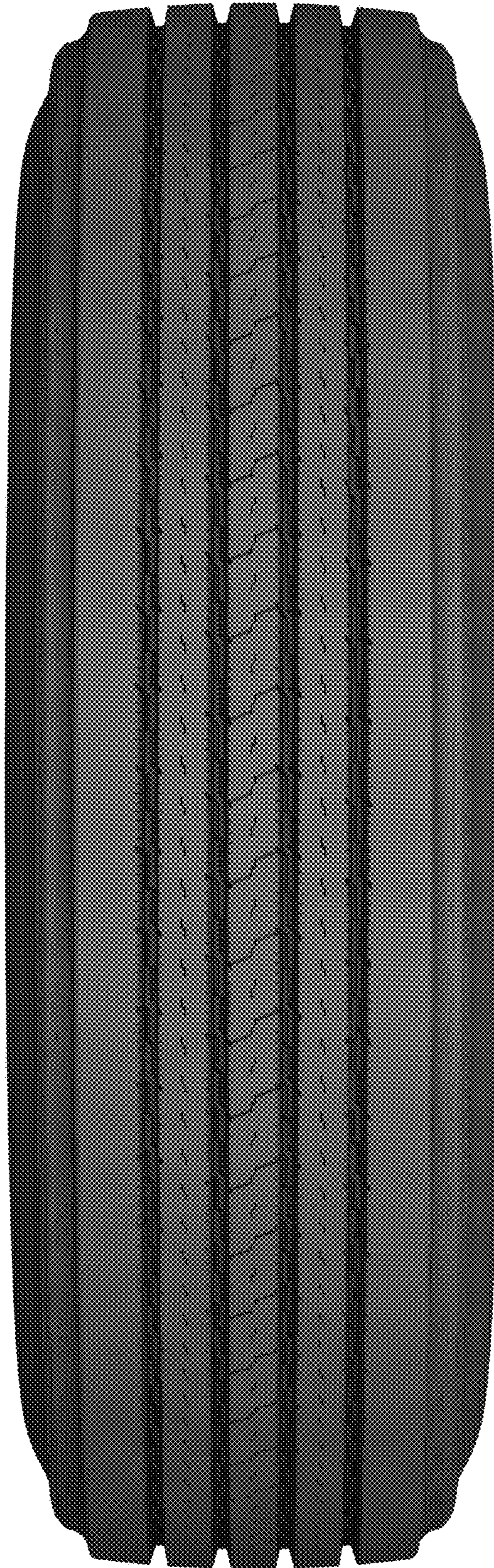

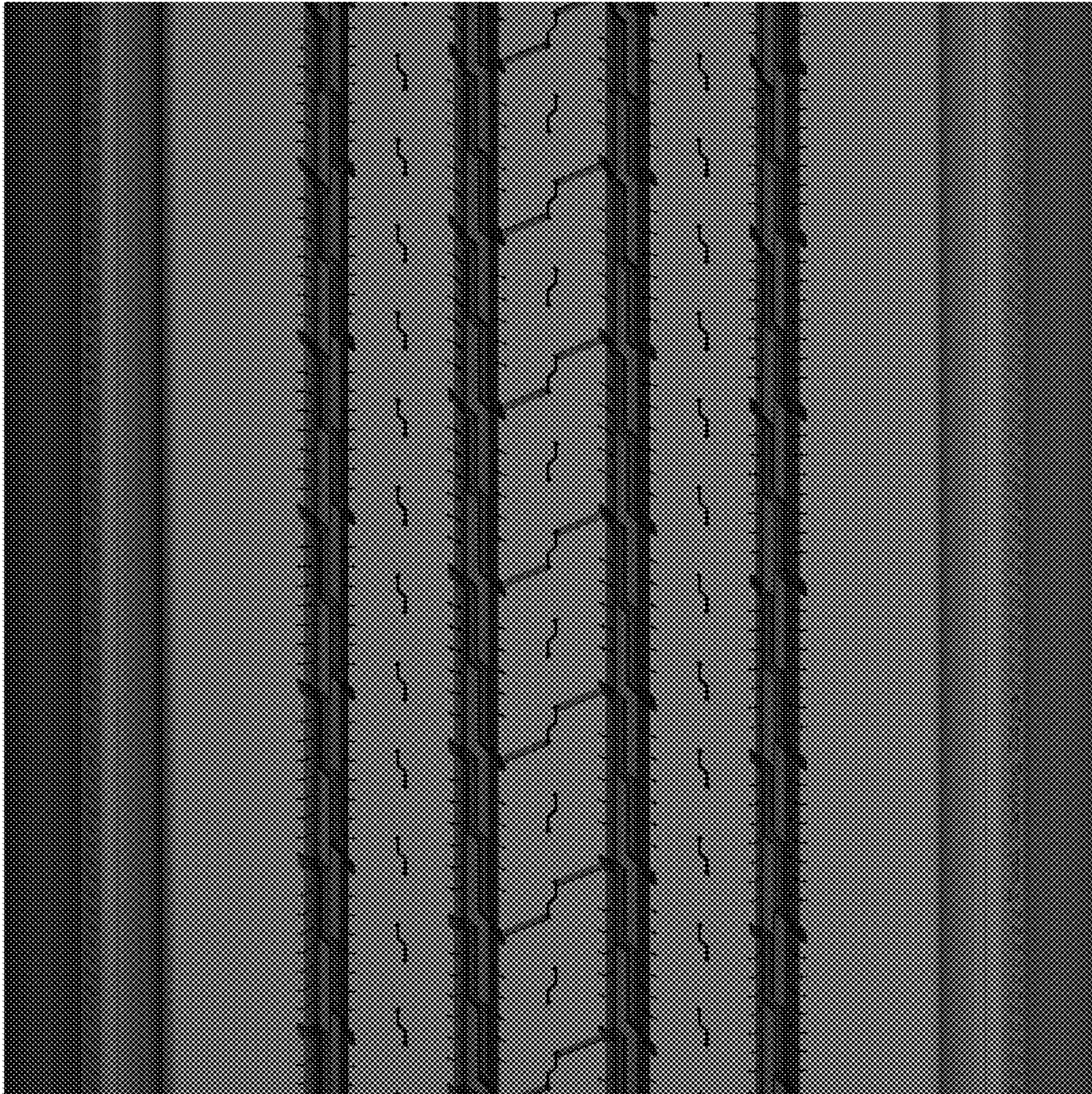

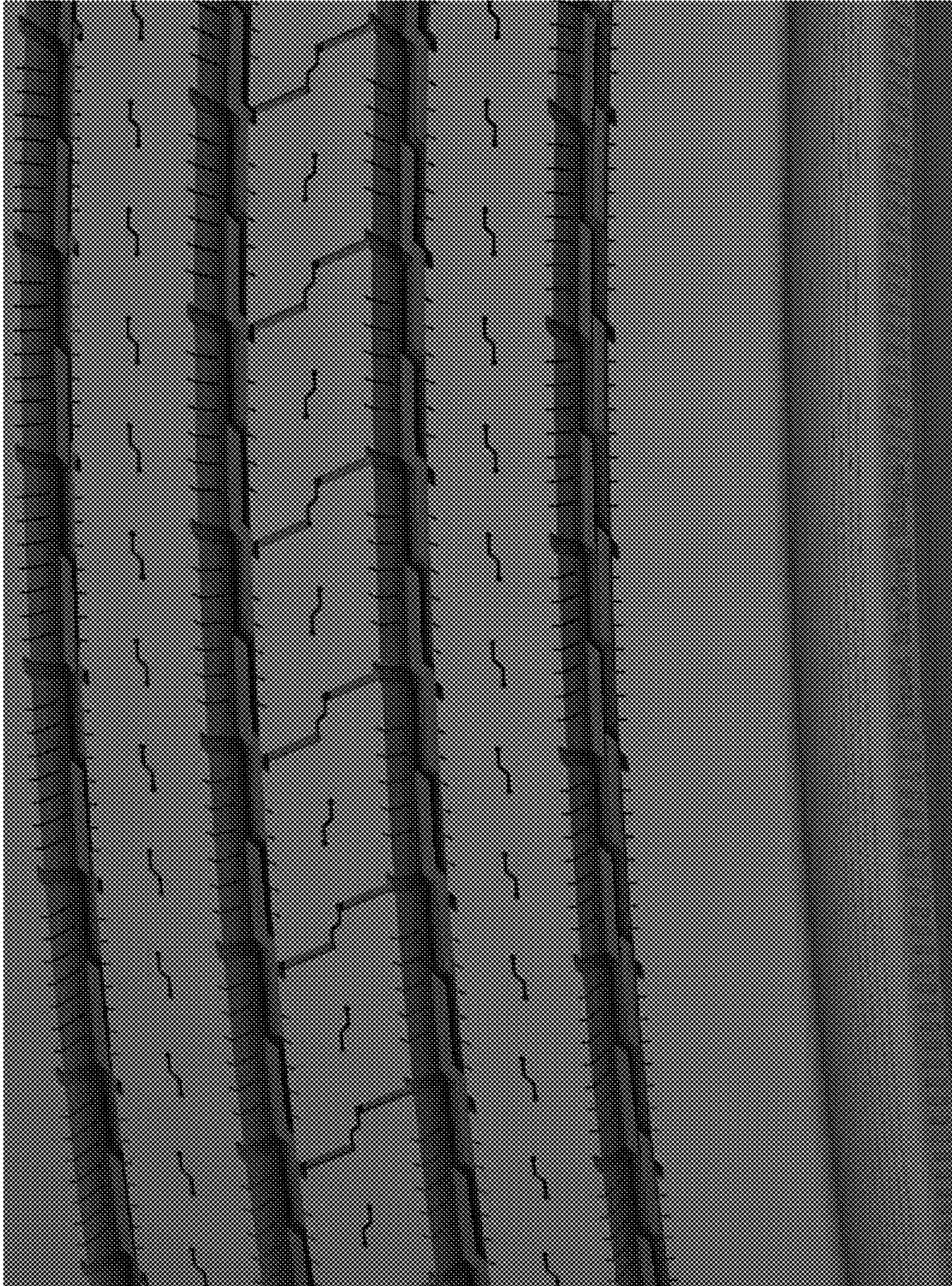
