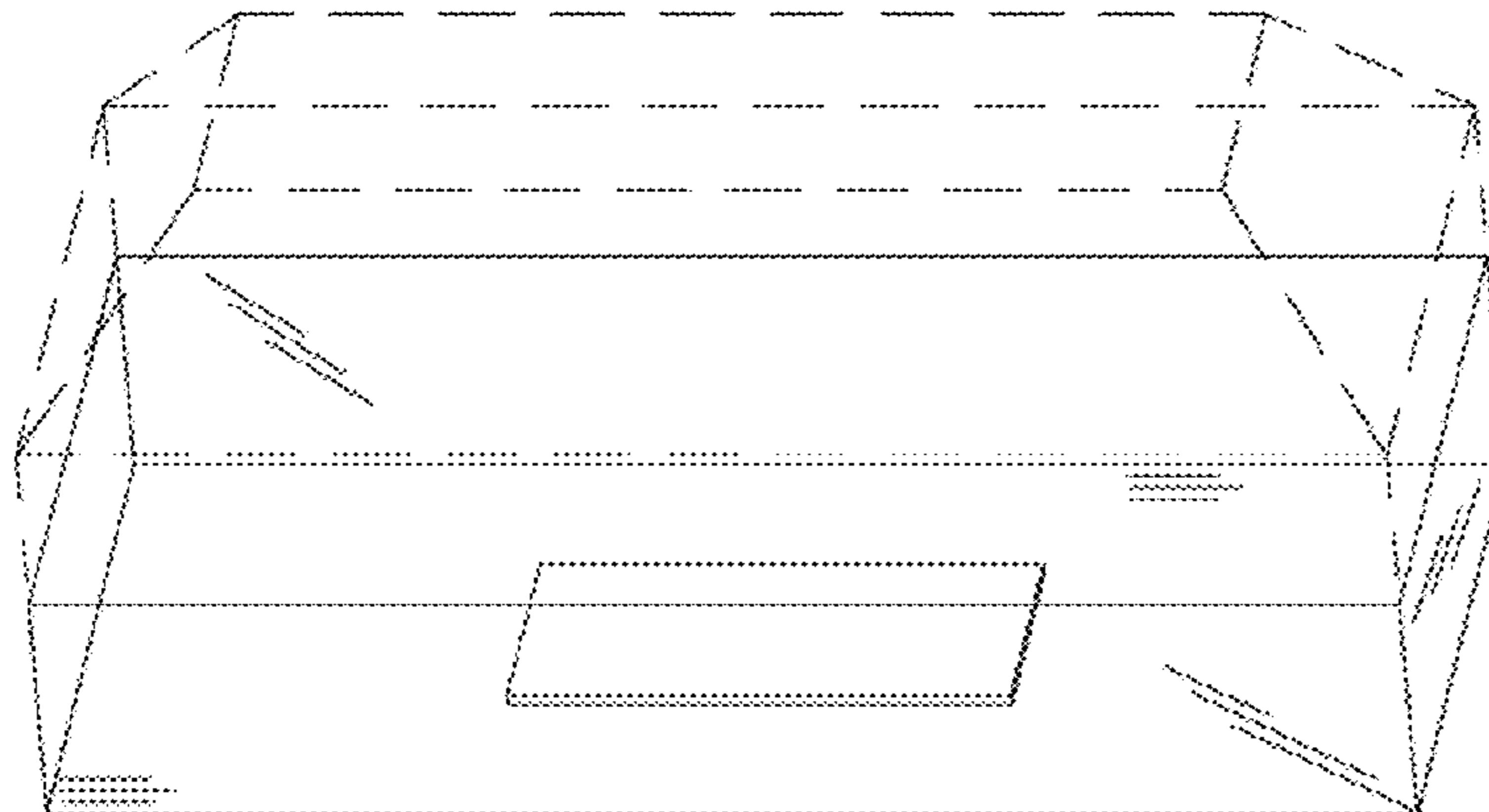
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top perspective view of the light-emitting diode showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is the top perspective view of FIG. 1, with the environmental structure removed for ease of view.
The broken line showing is for the purpose of illustrating environmental structure, and forms no part of the claimed design.

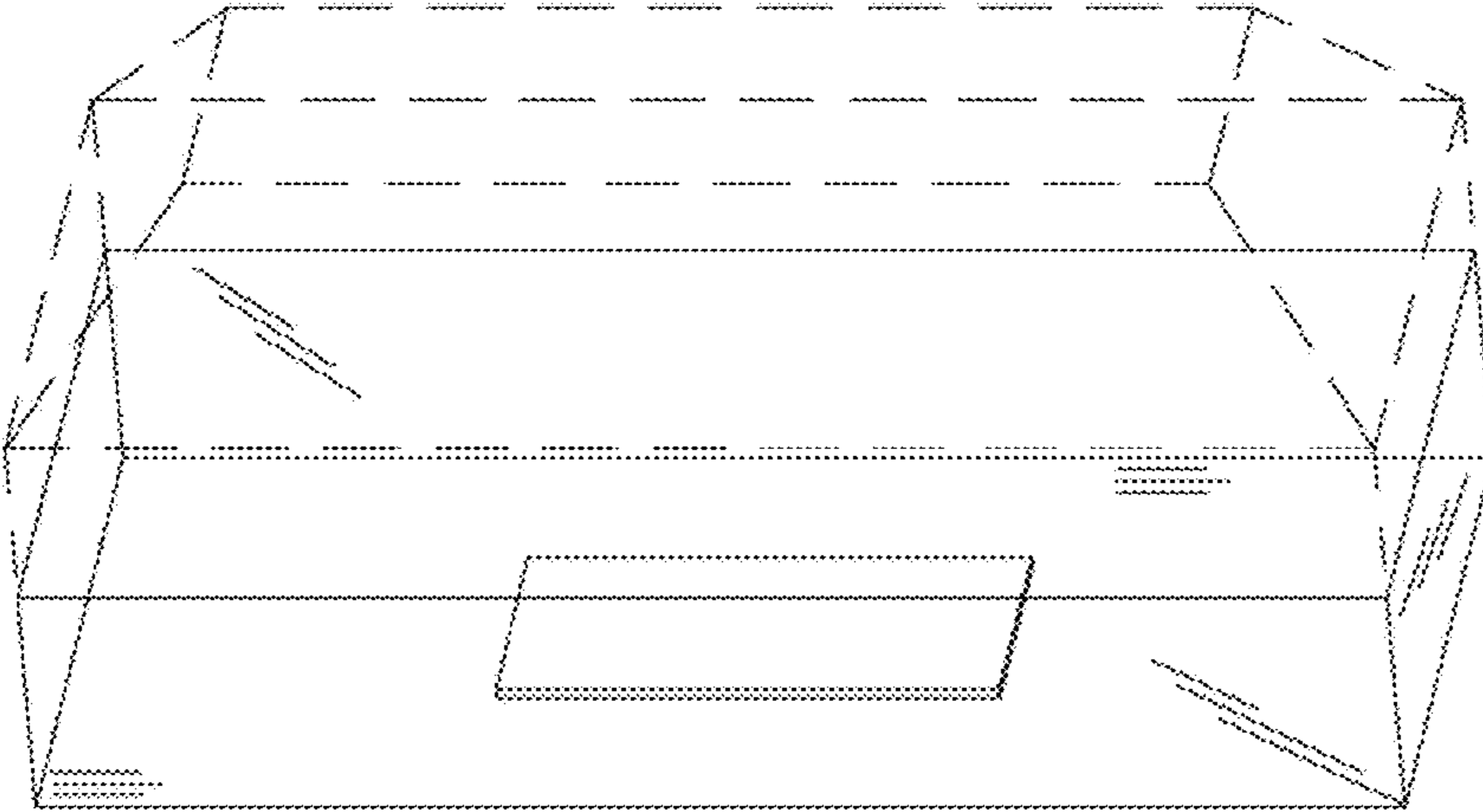

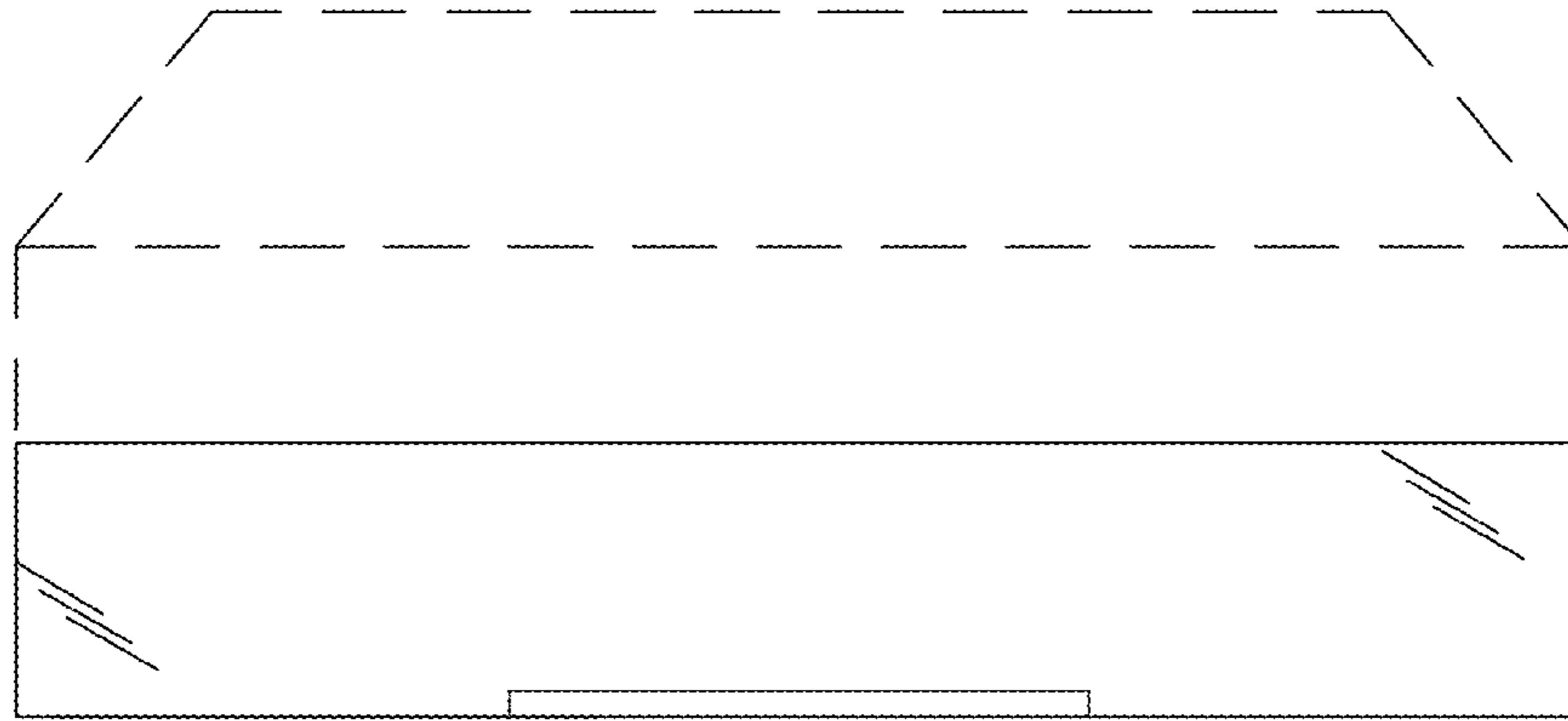

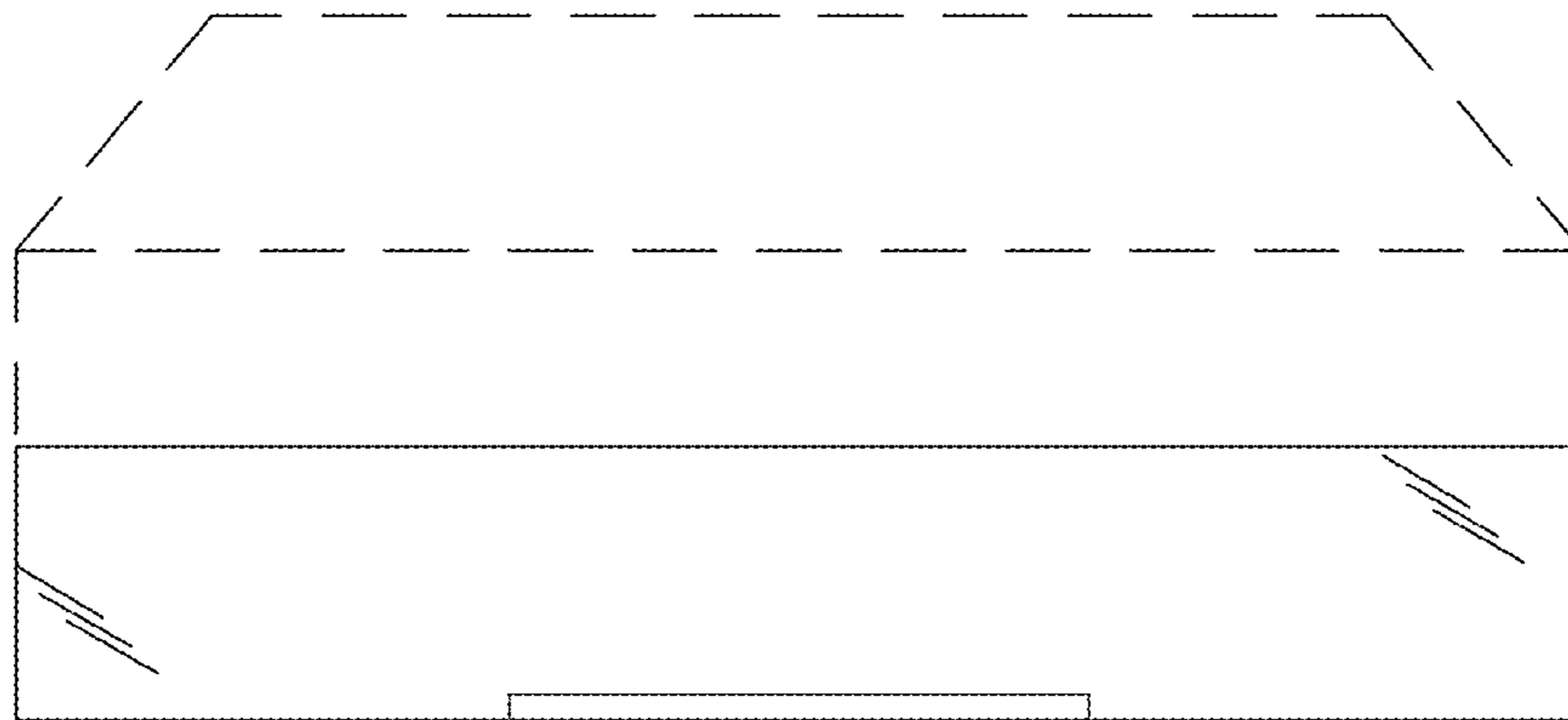

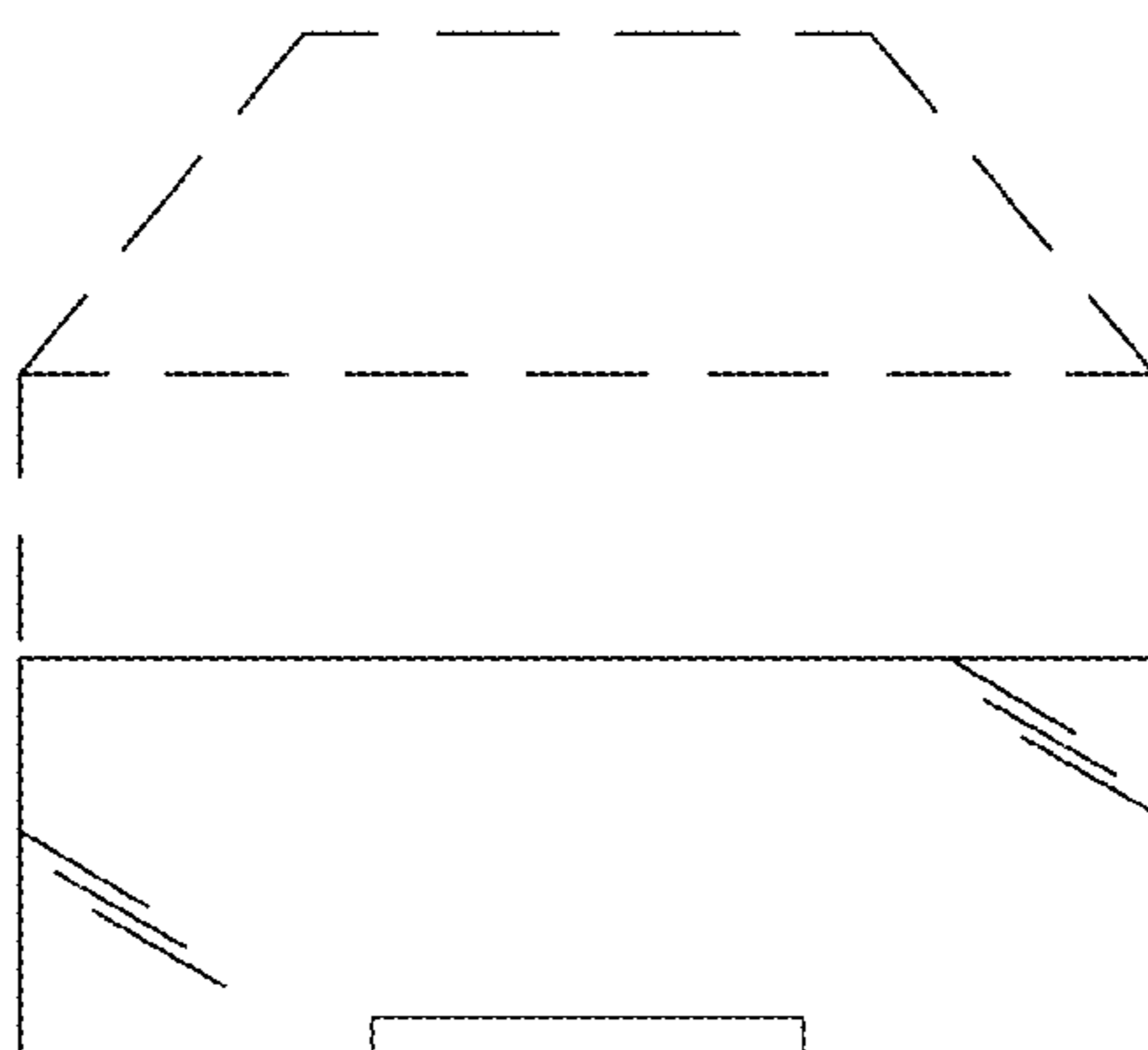

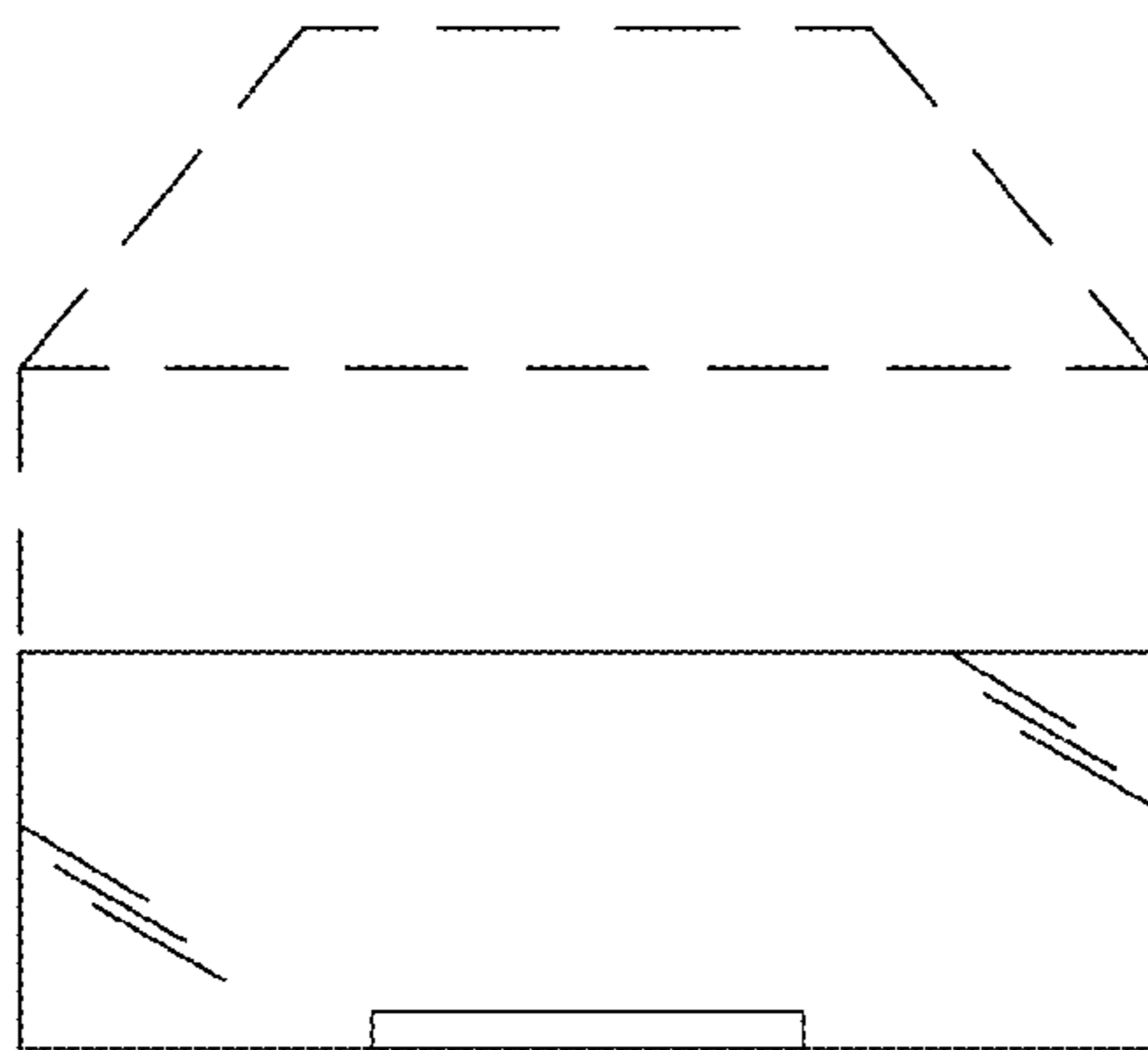

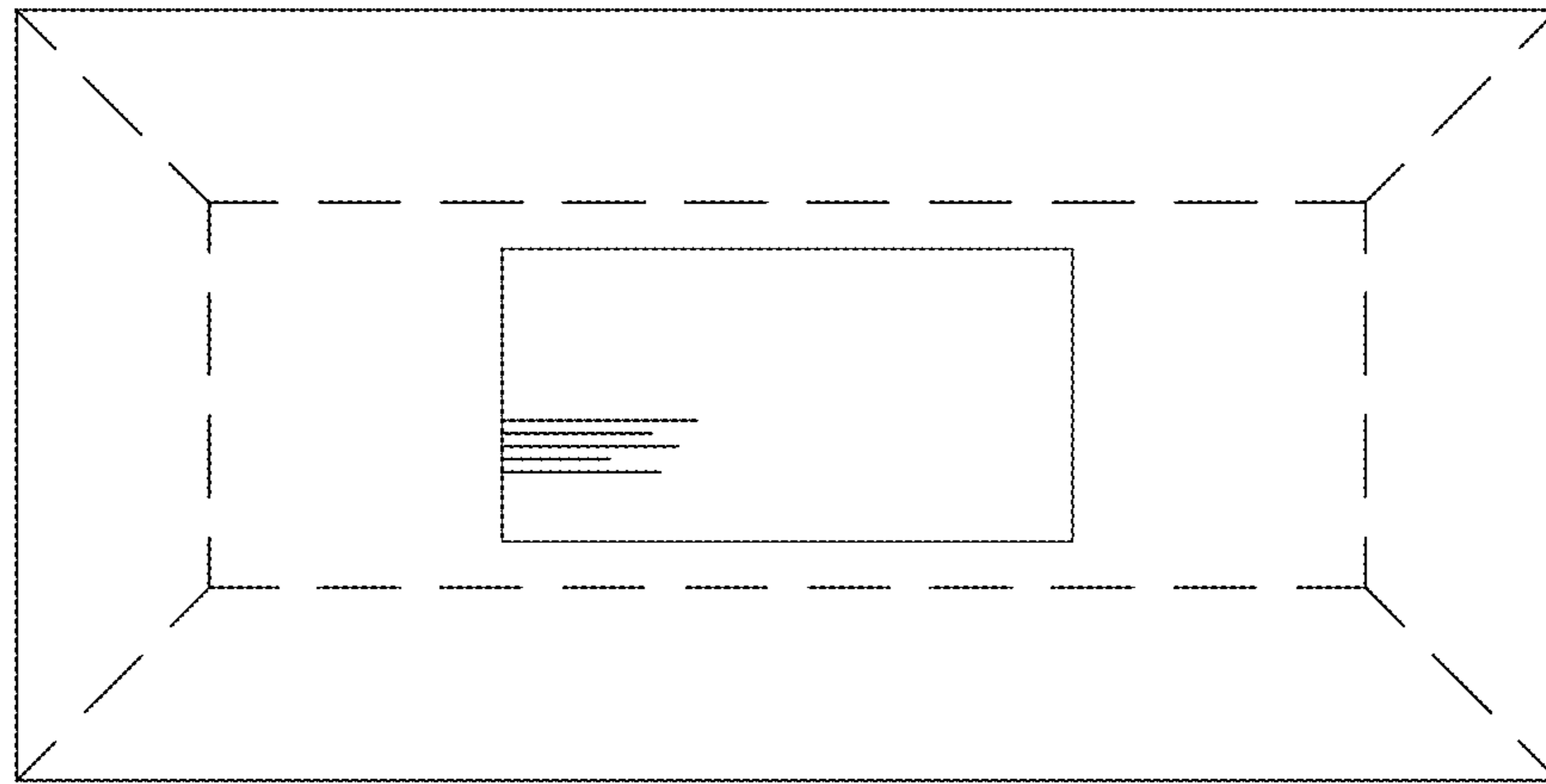

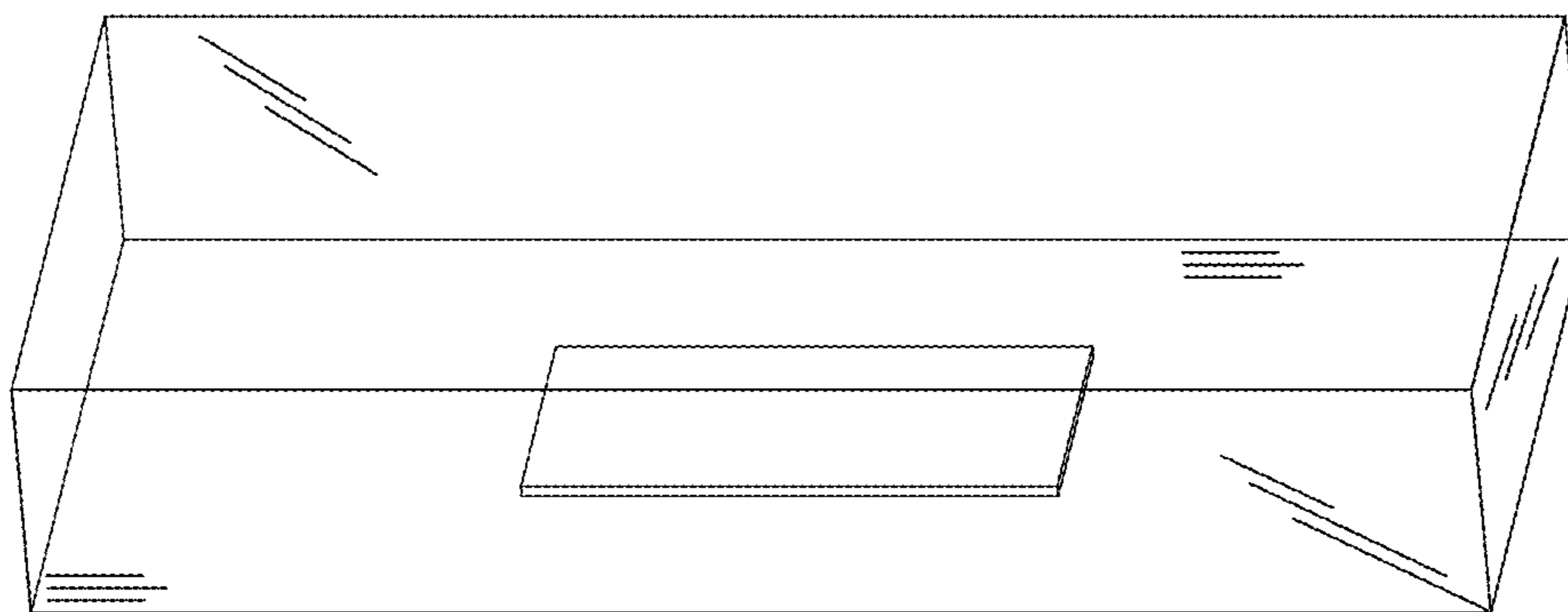
