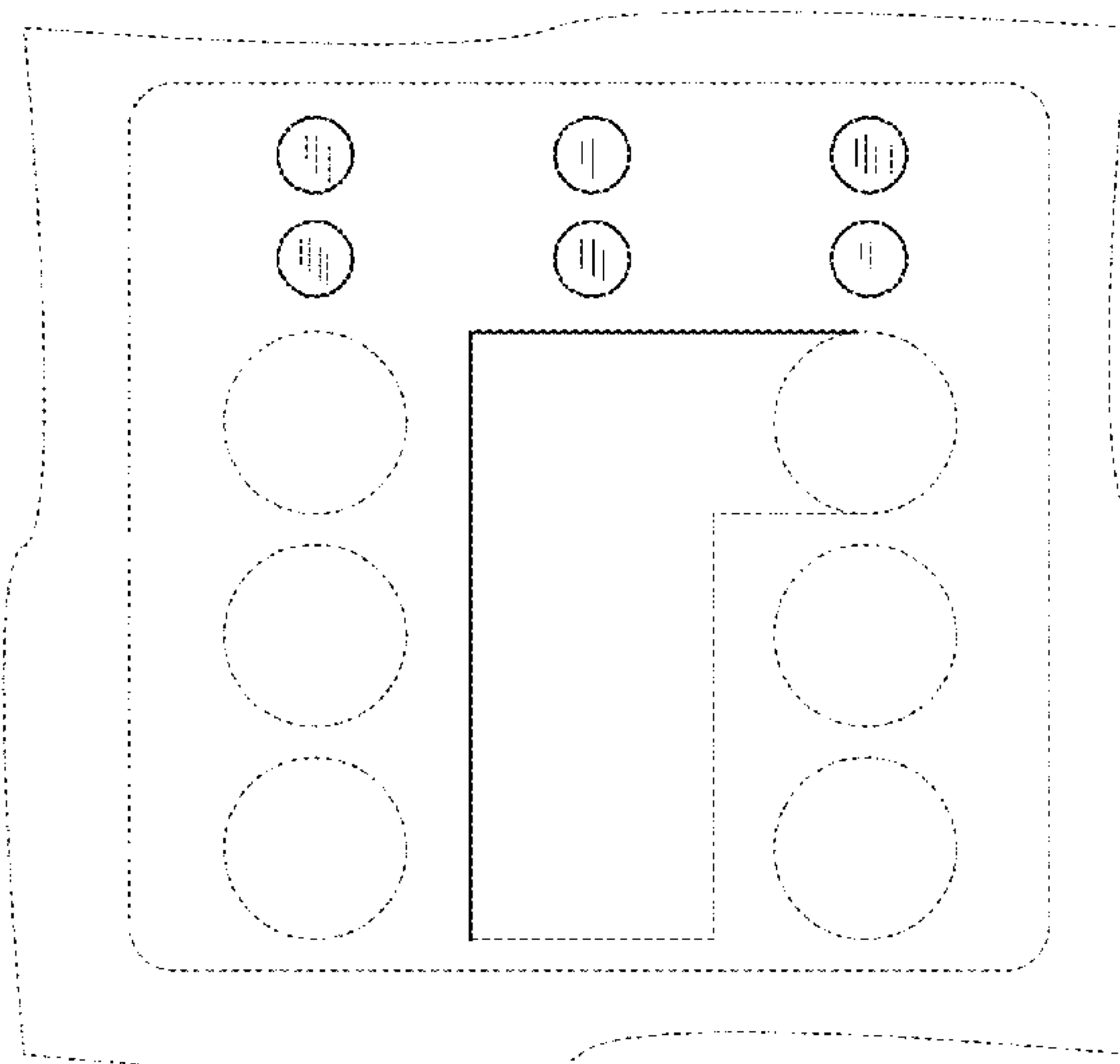
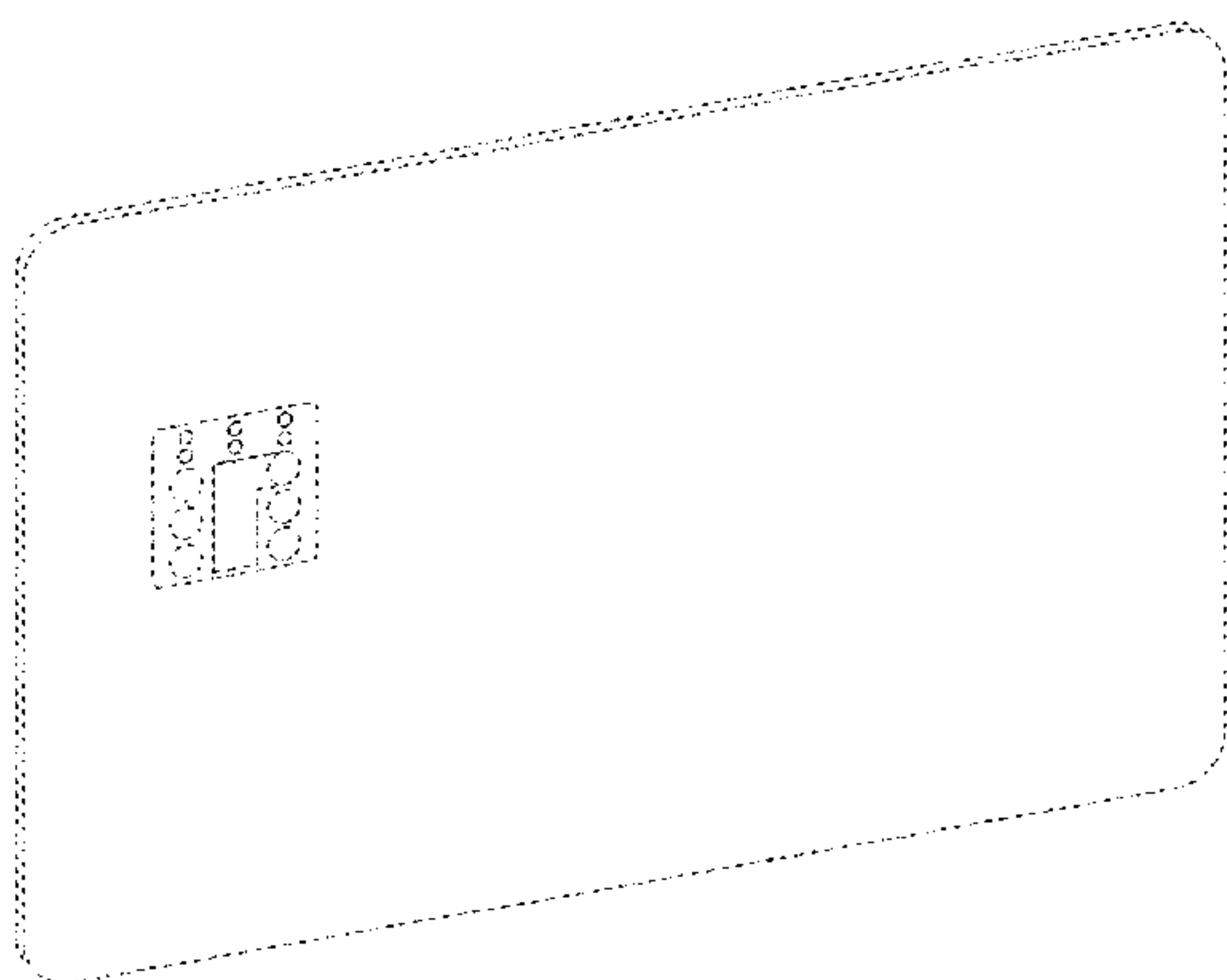
(57) **CLAIM**

The ornamental design for a smart card interface, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a smart card interface showing our new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is an enlarged view of the contacts portion of the smart card interface of FIG. 1;
FIG. 4 is a front perspective view of the smart card interface according to a second embodiment;
FIG. 5 is a front elevation view thereof; and,
FIG. 6 is an enlarged view of the contacts portion of the smart card interface of FIG. 4.
The portions depicted in broken line illustrate parts of the smart card interface that form no part of the claimed design.

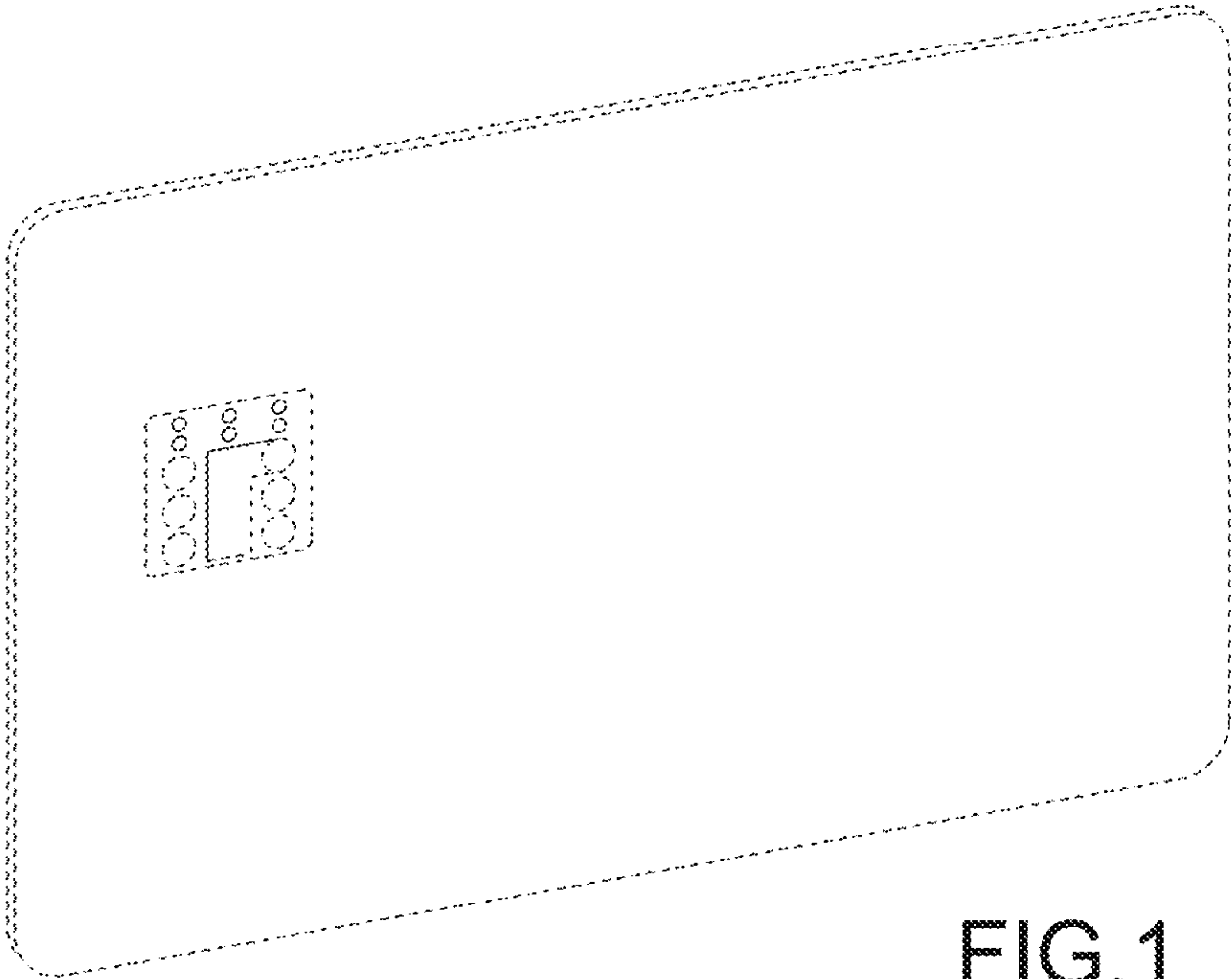

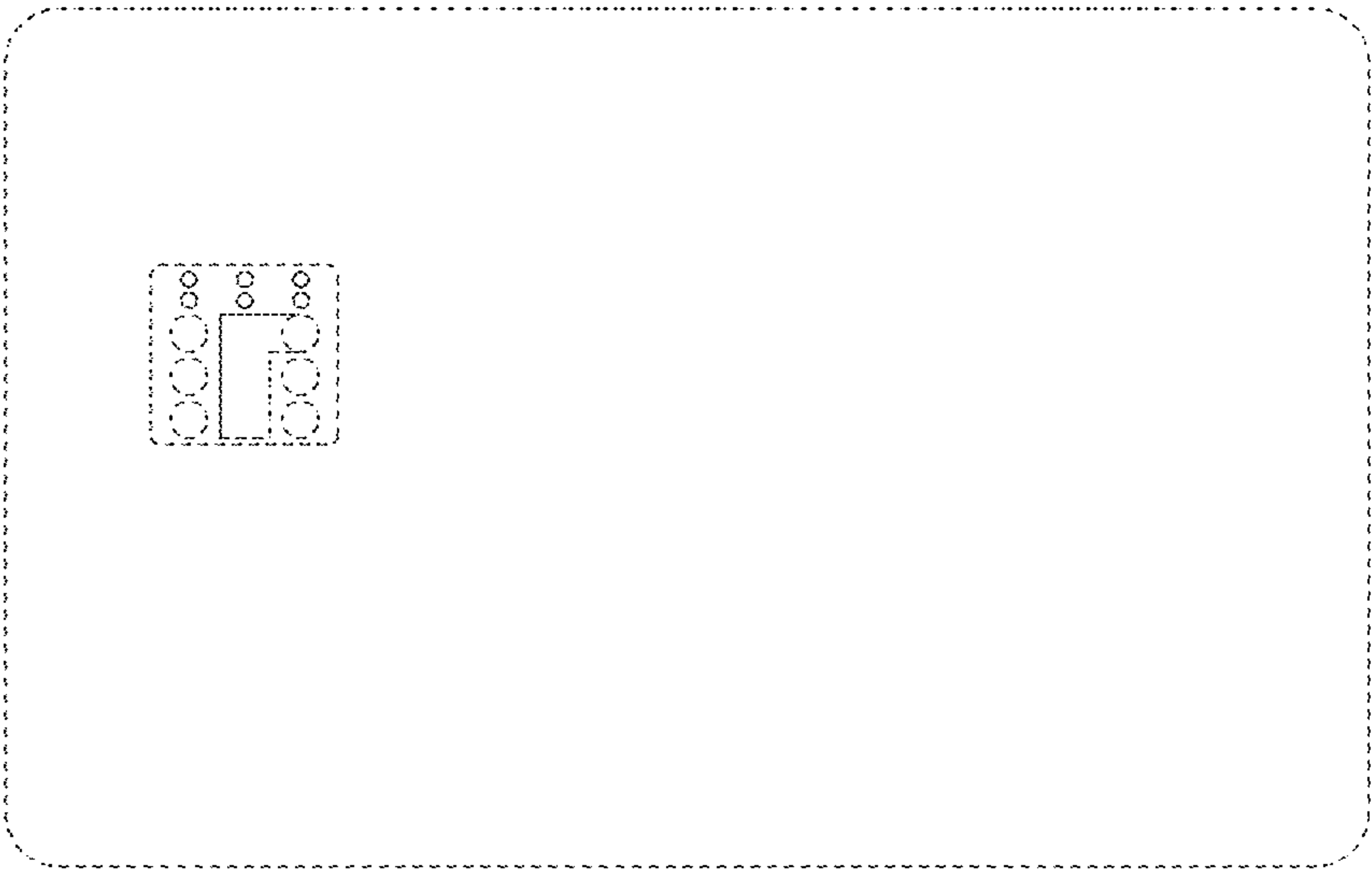

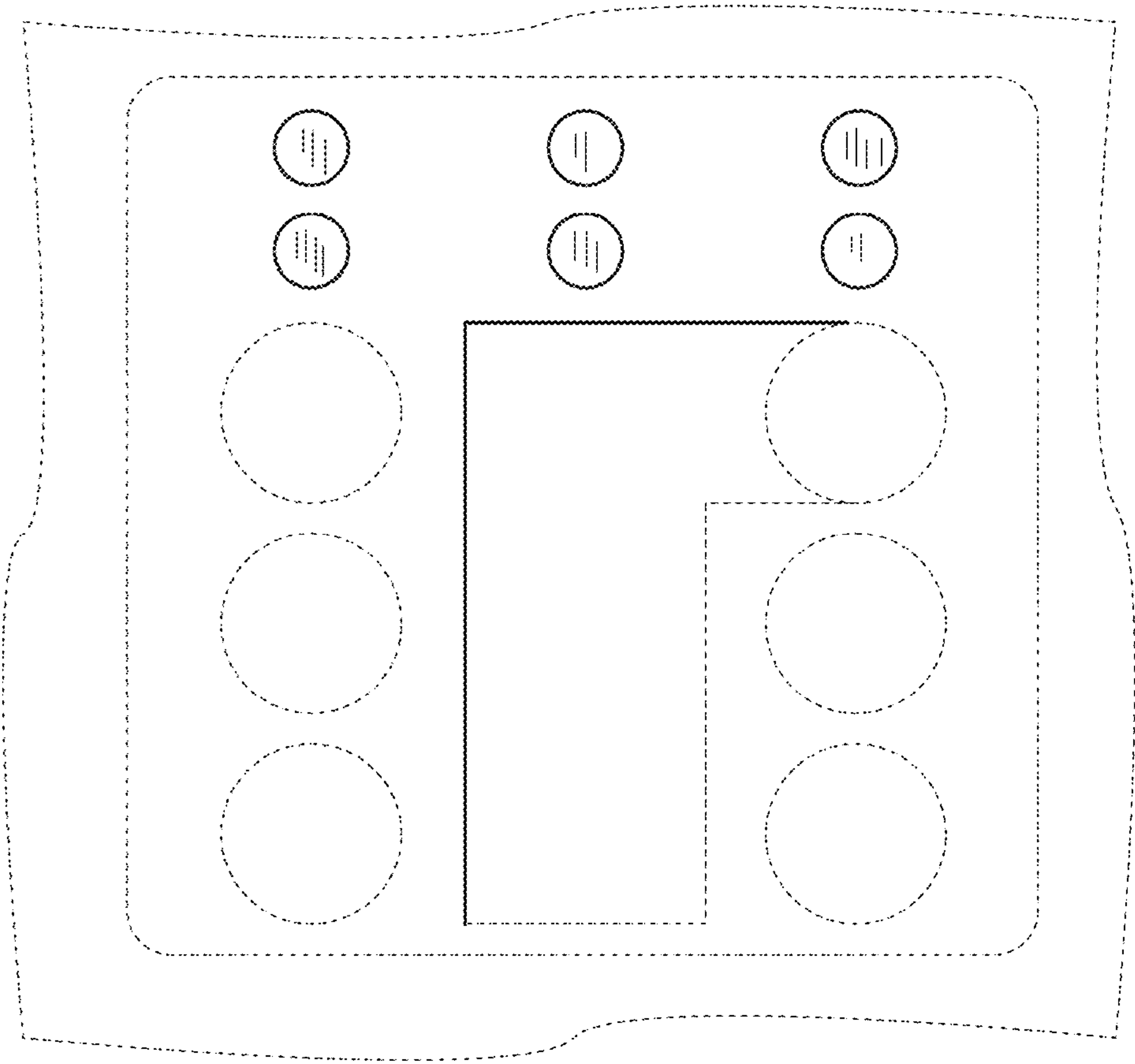

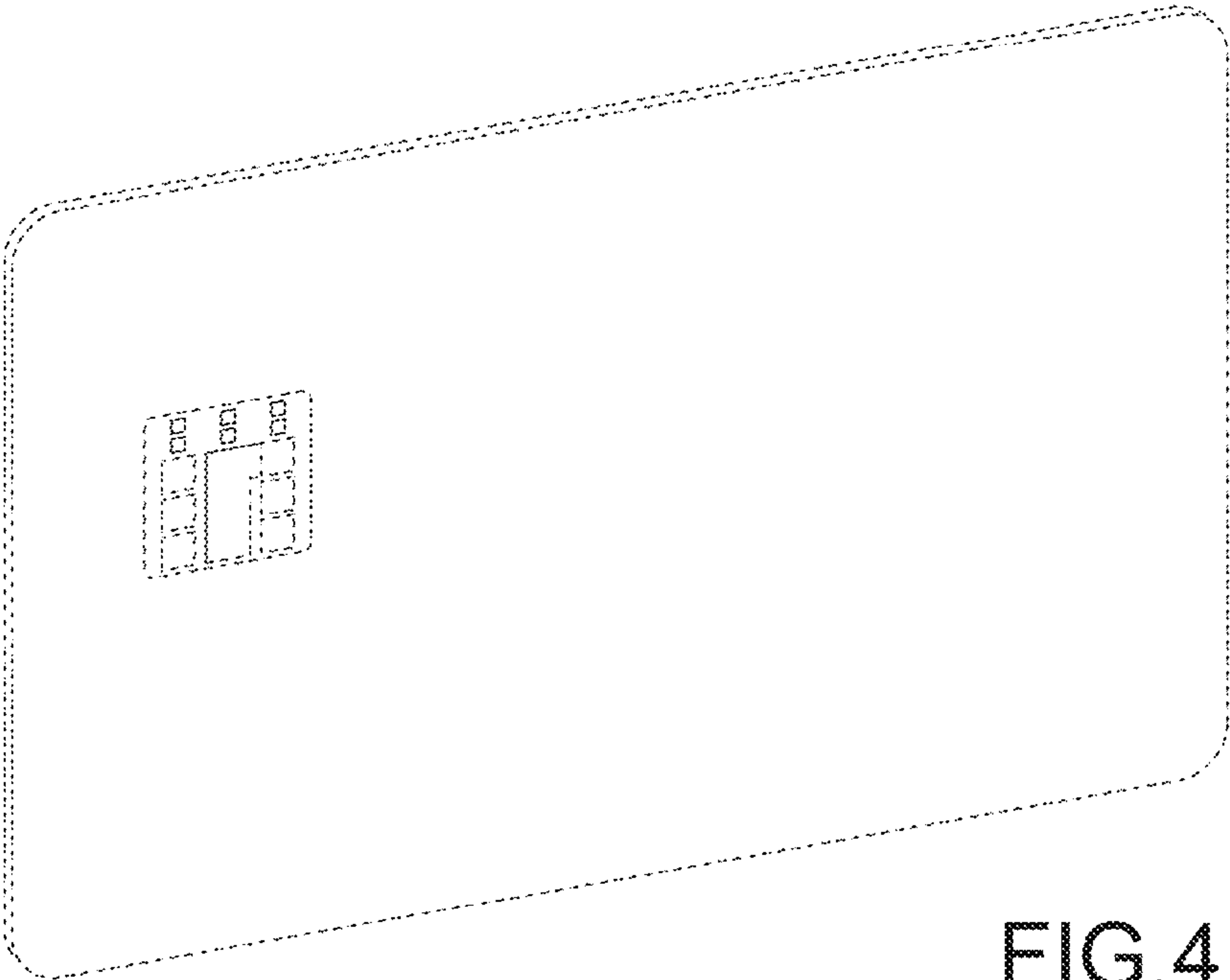

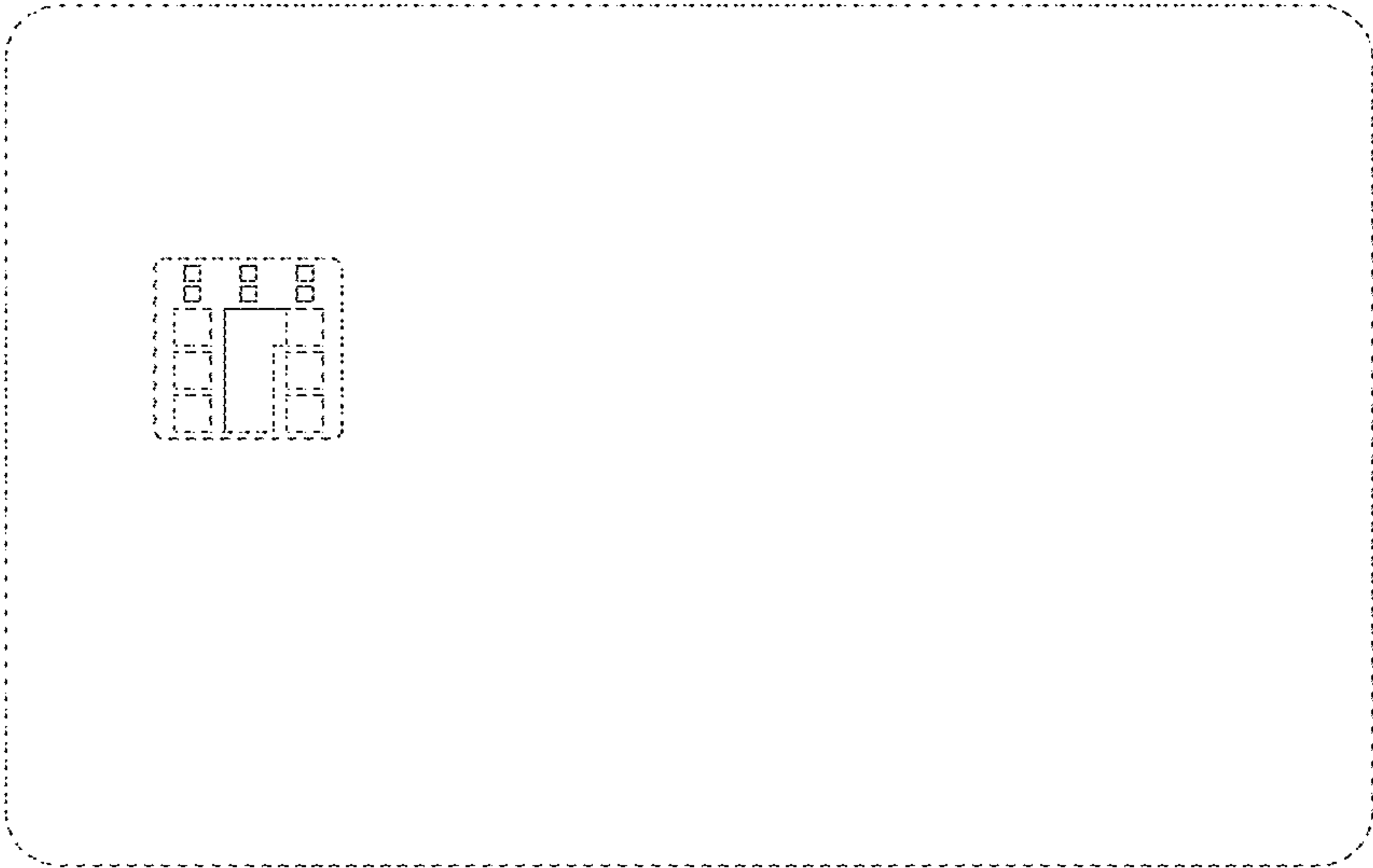

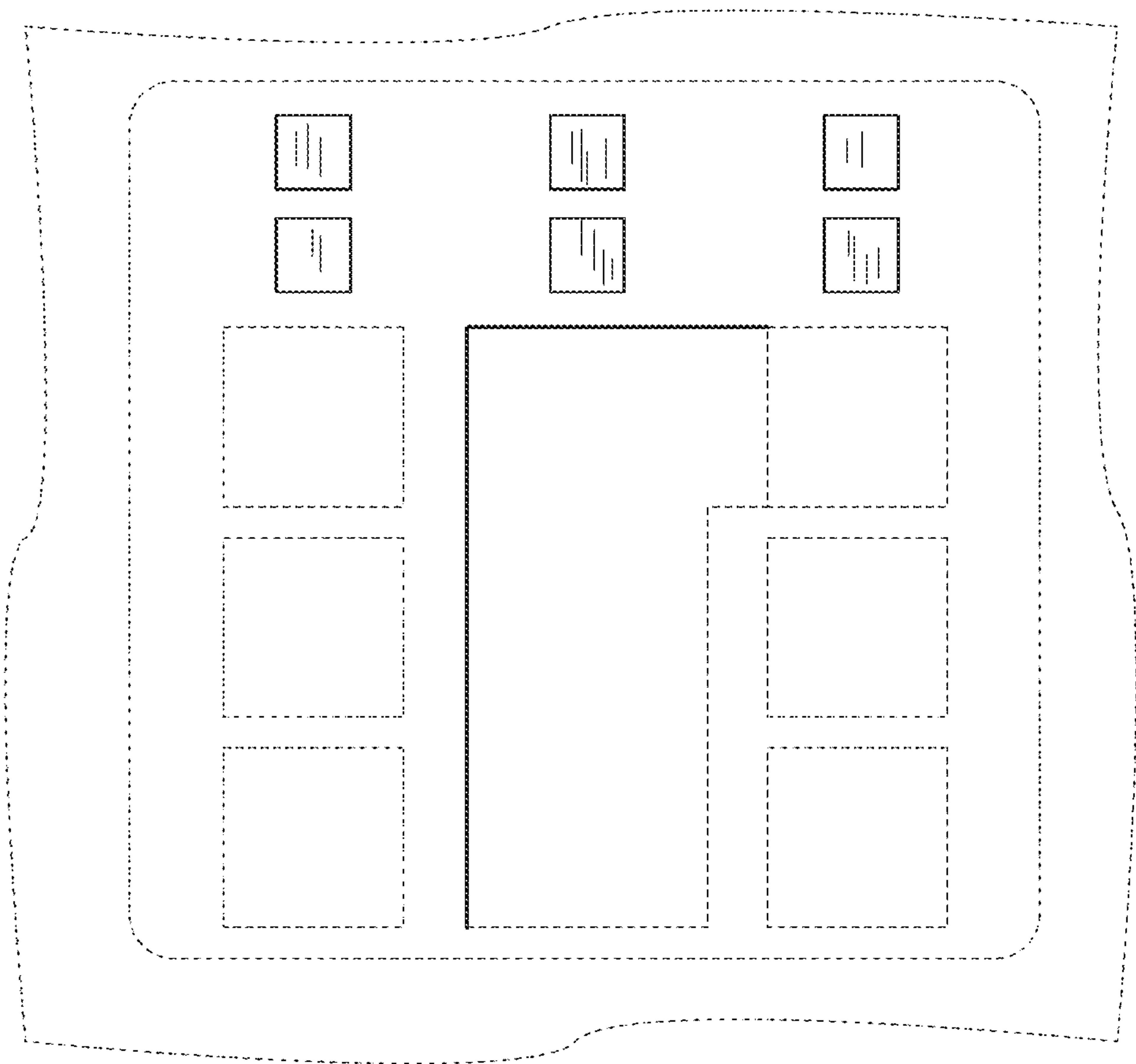
