The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

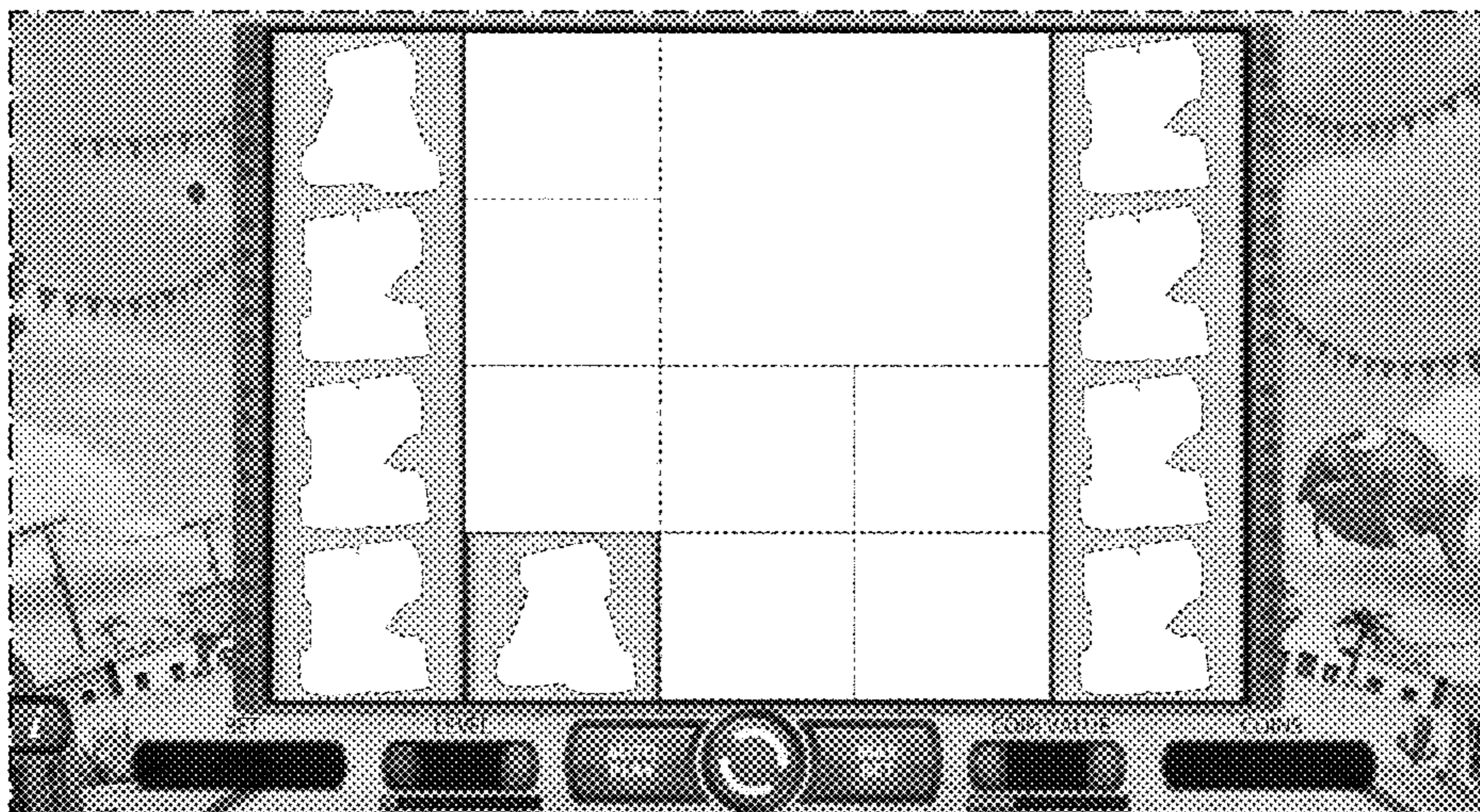
**DESCRIPTION**

FIG. 1 is a front view of an embodiment of a display screen or portion thereof with graphical user interface of the new design;

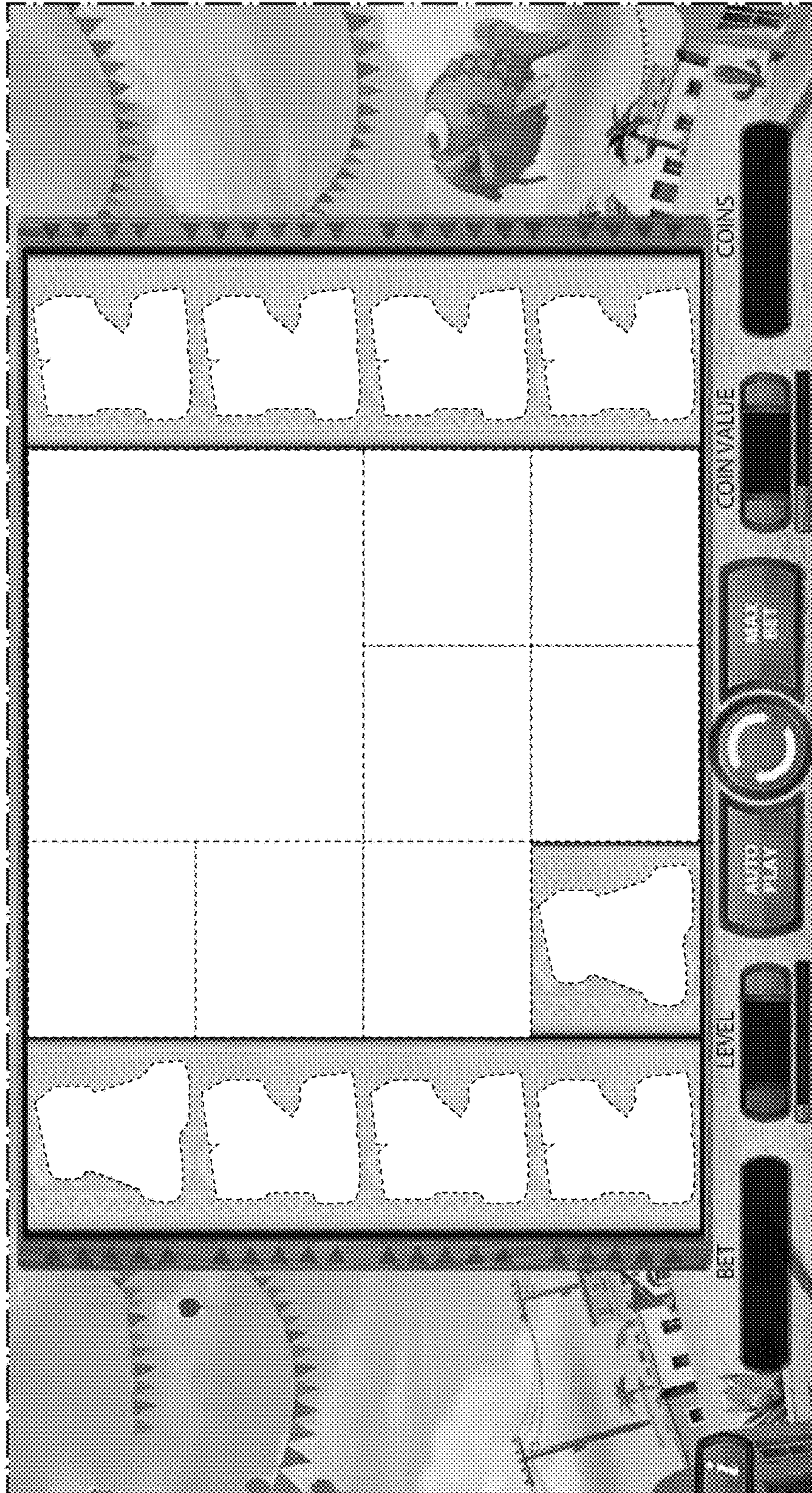

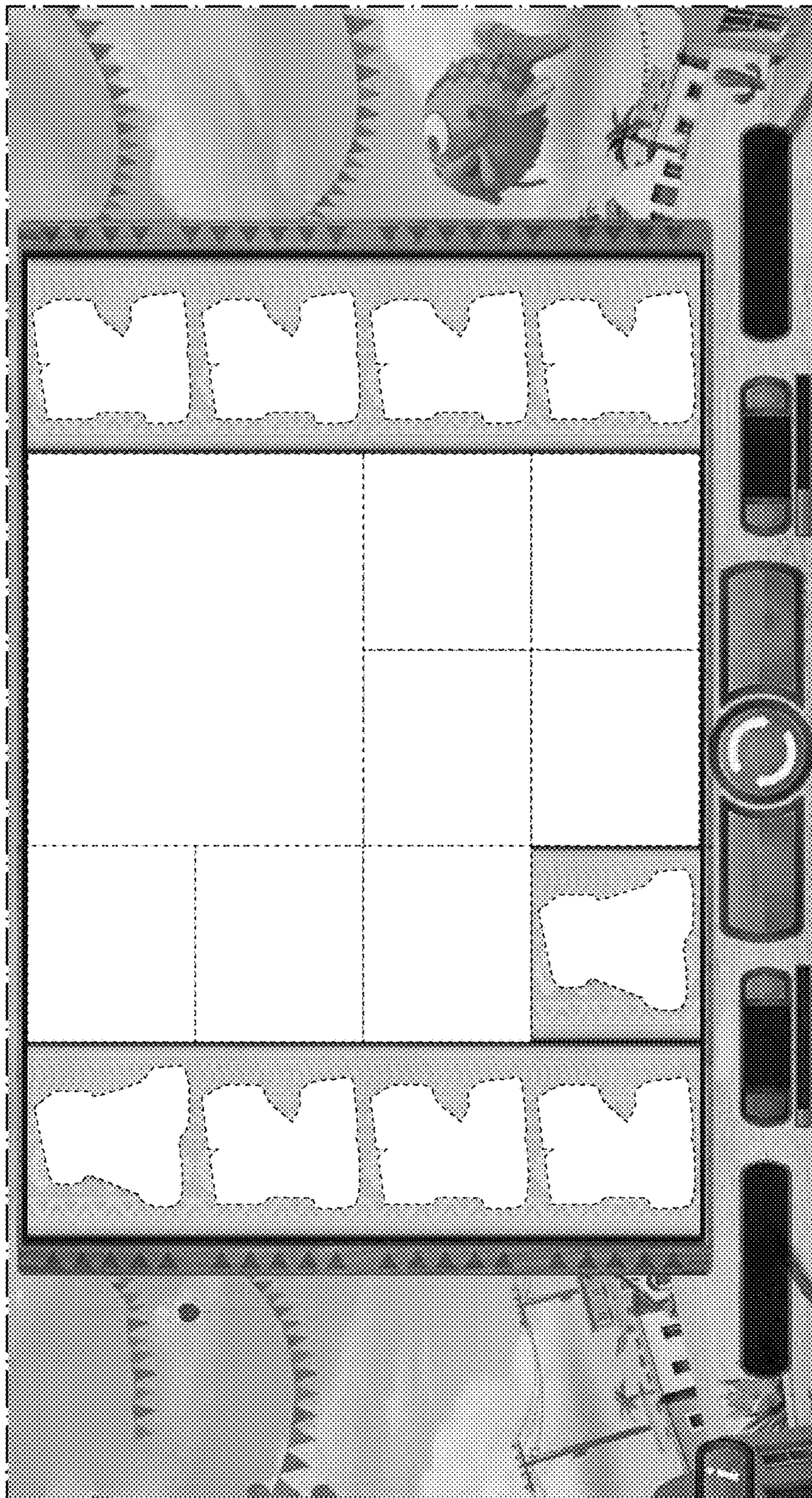

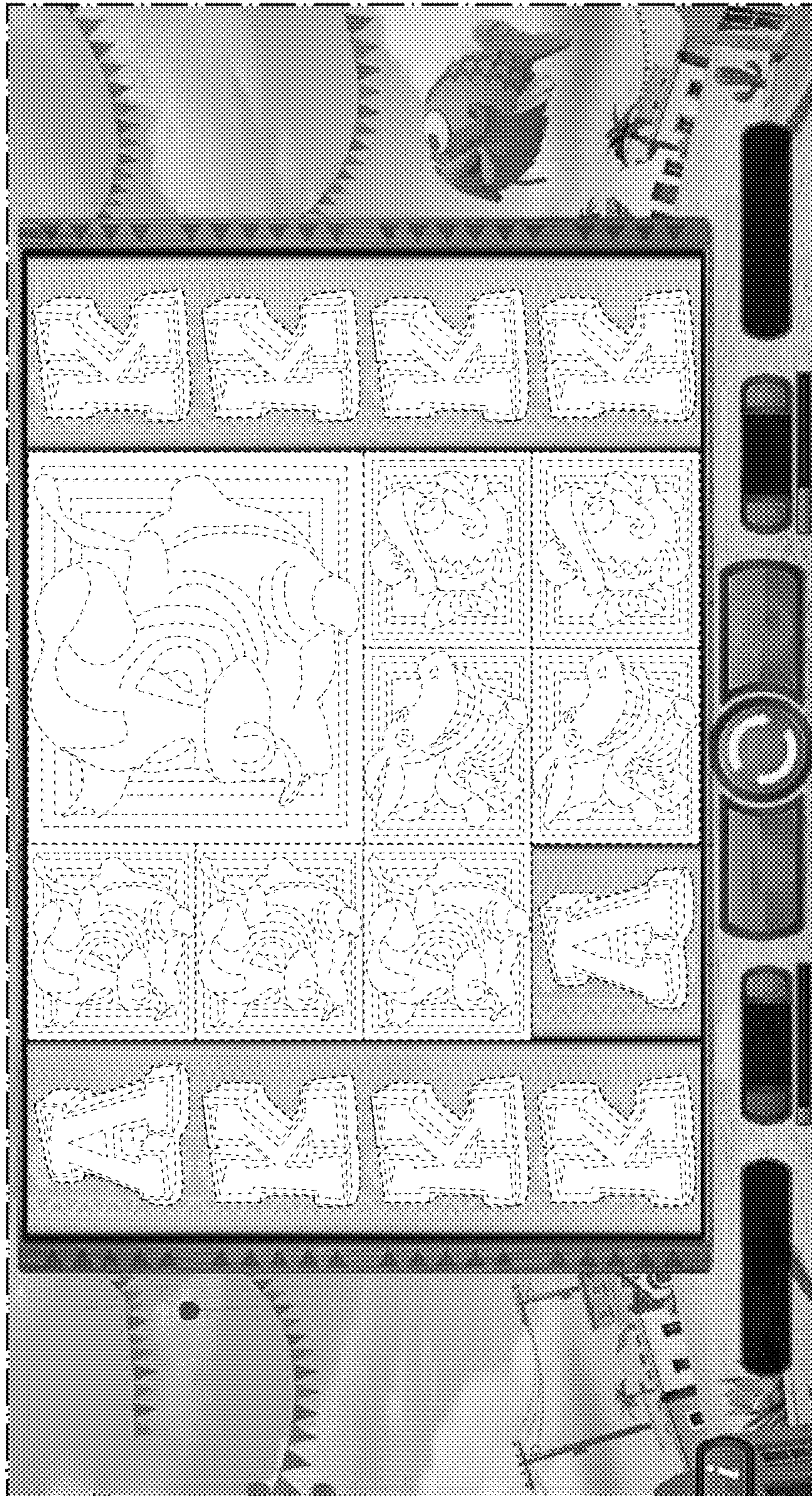
