FIG. 4 is a left side view of the greeting card with window of FIG. 1.

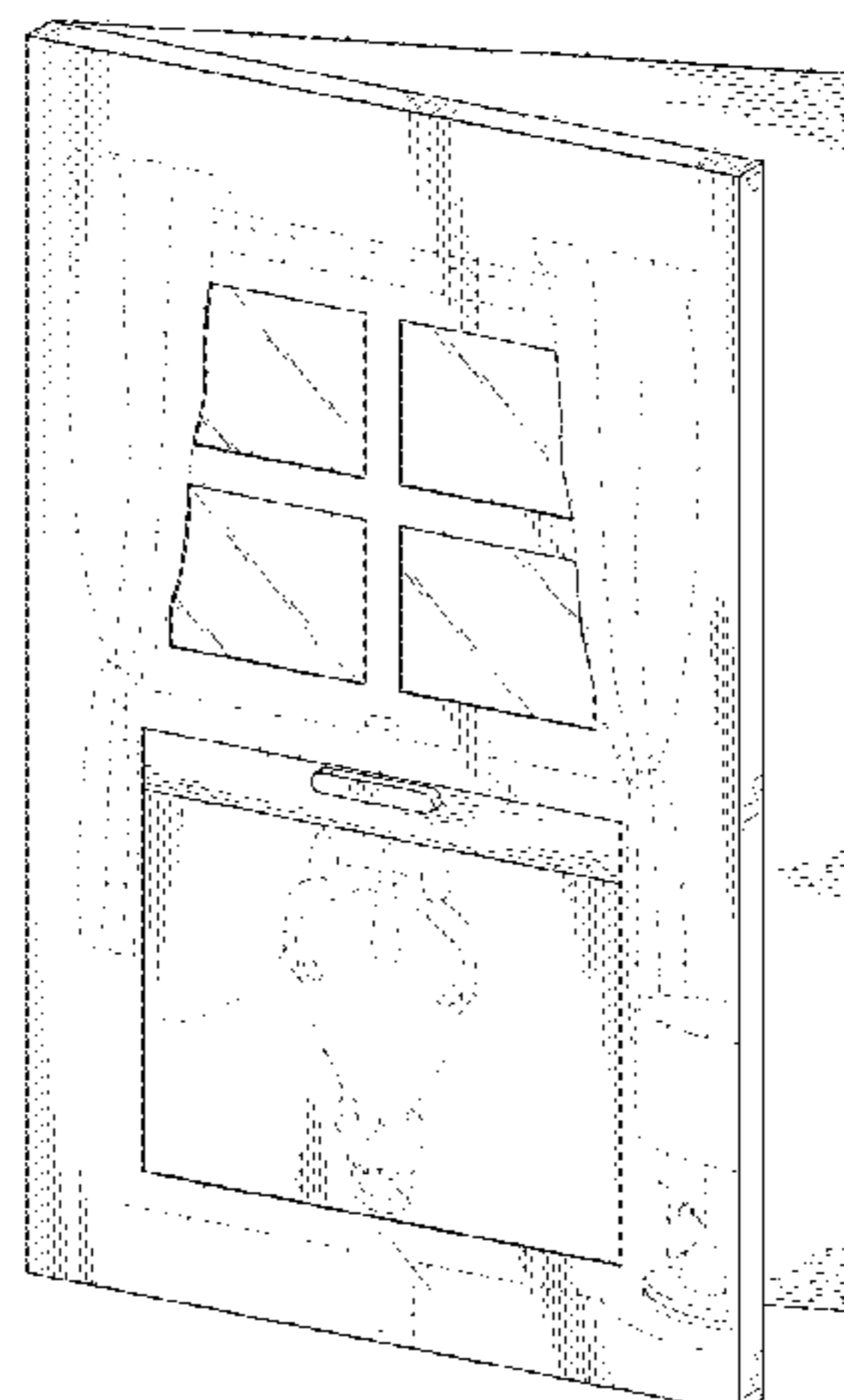
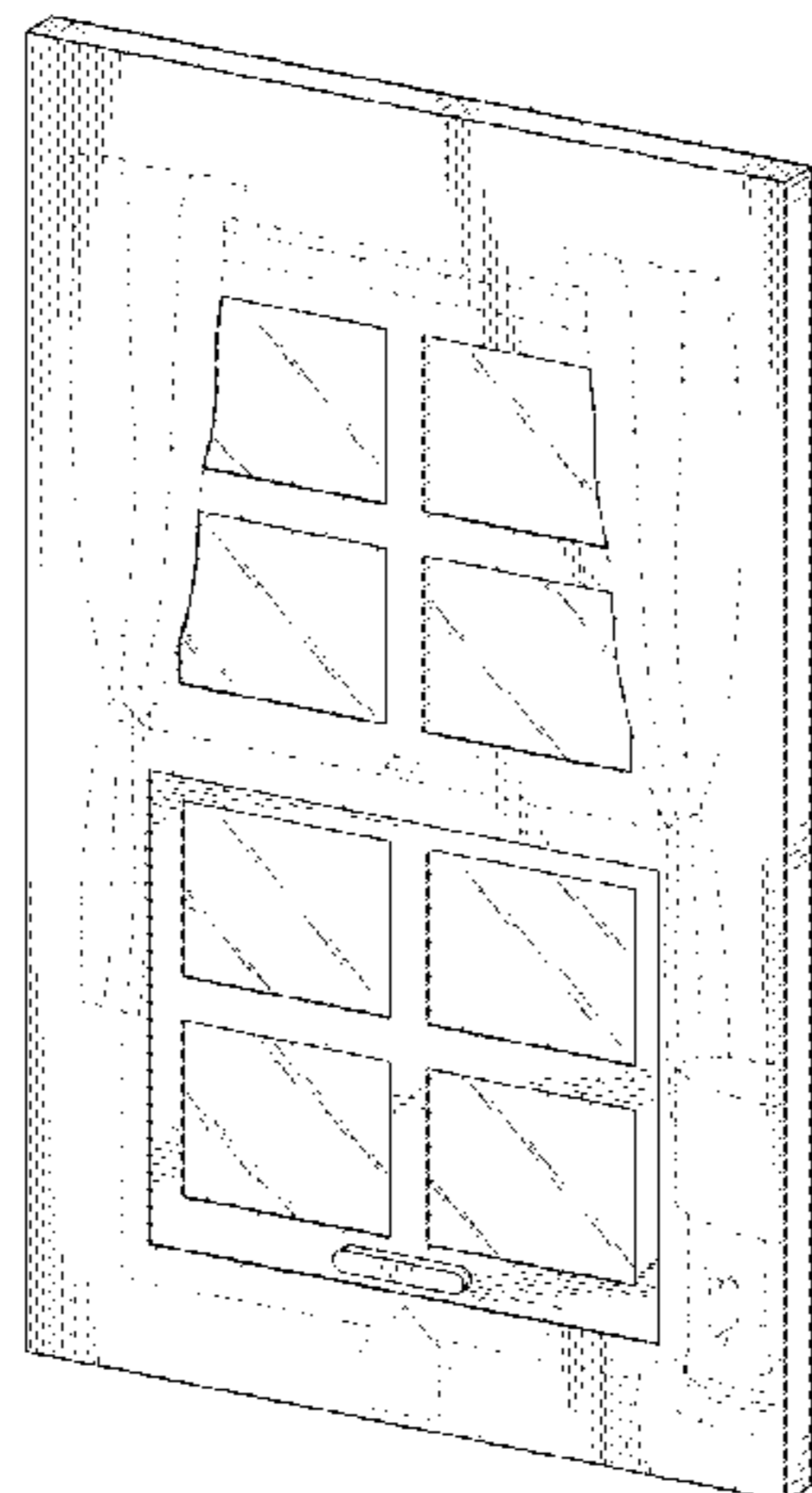
FIG. 5 is a right side view of the greeting card with window of FIG. 1.

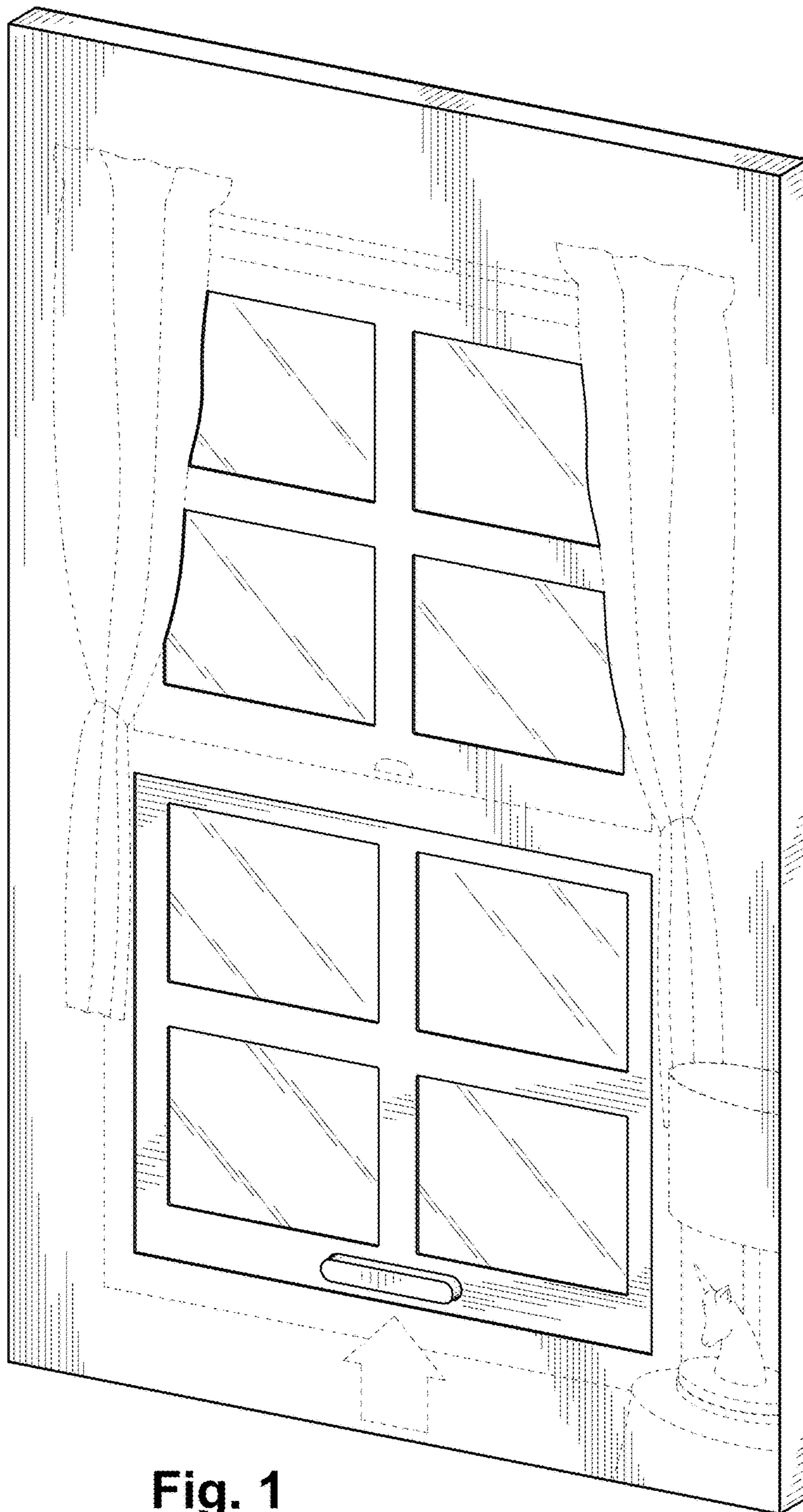

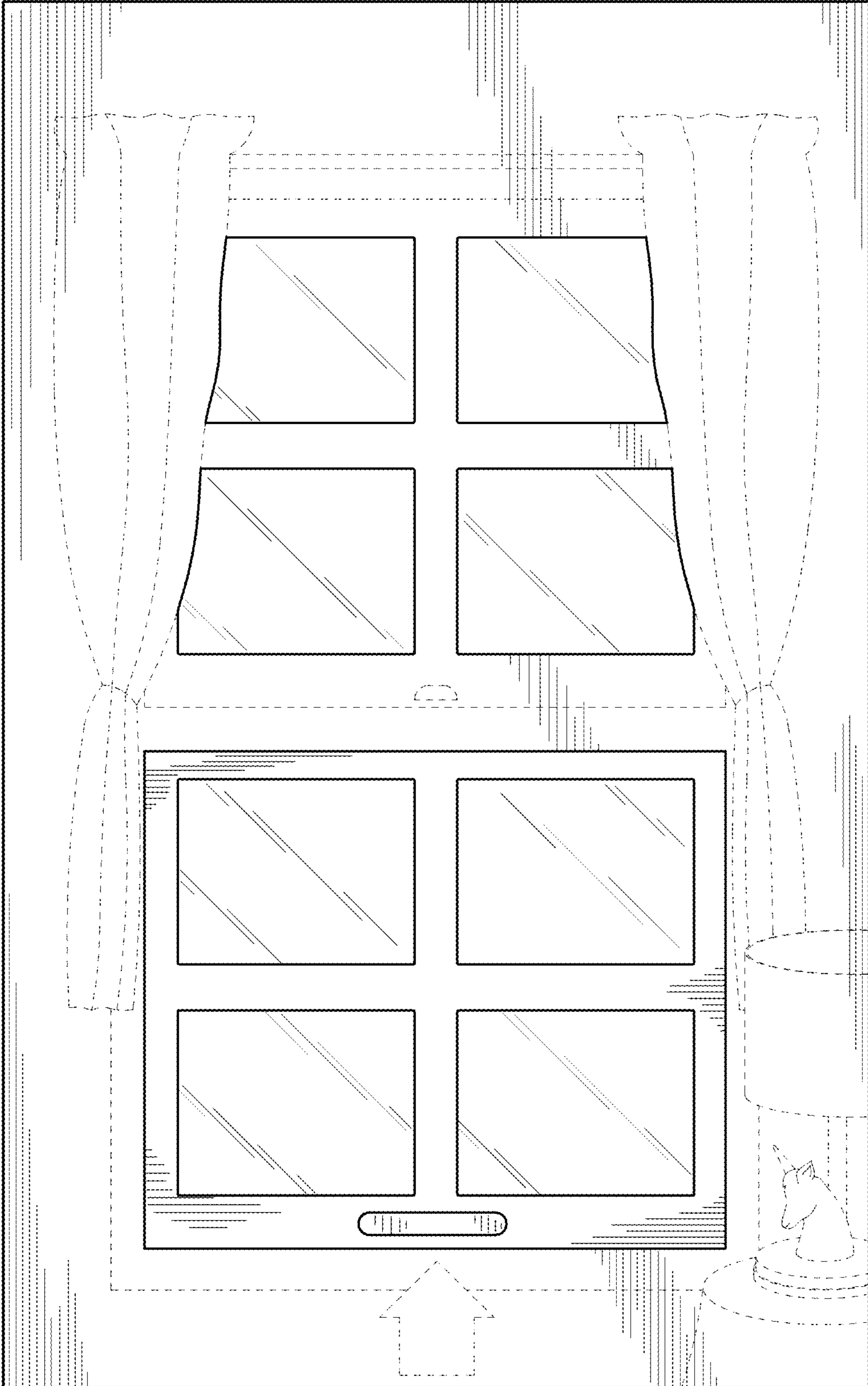

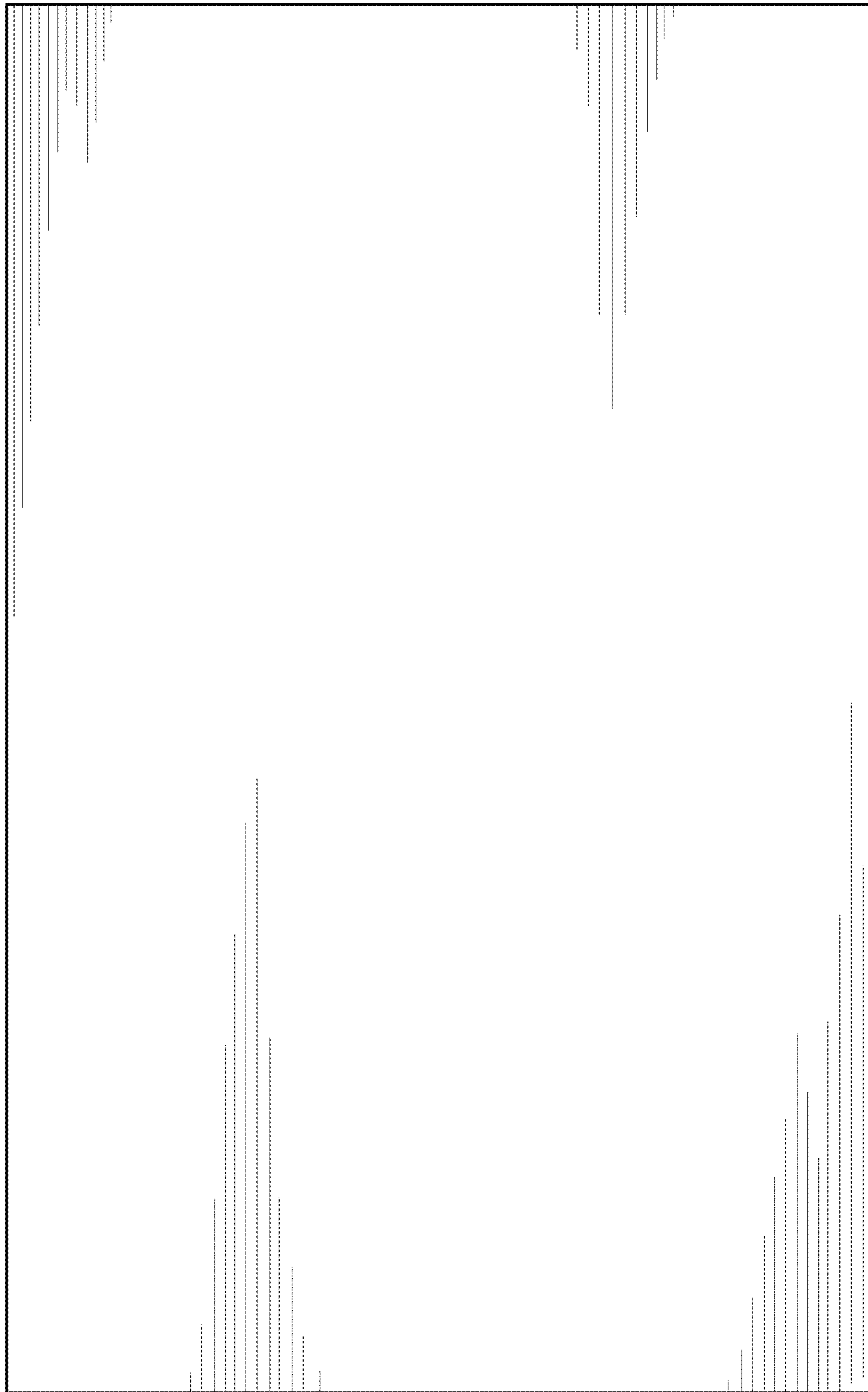

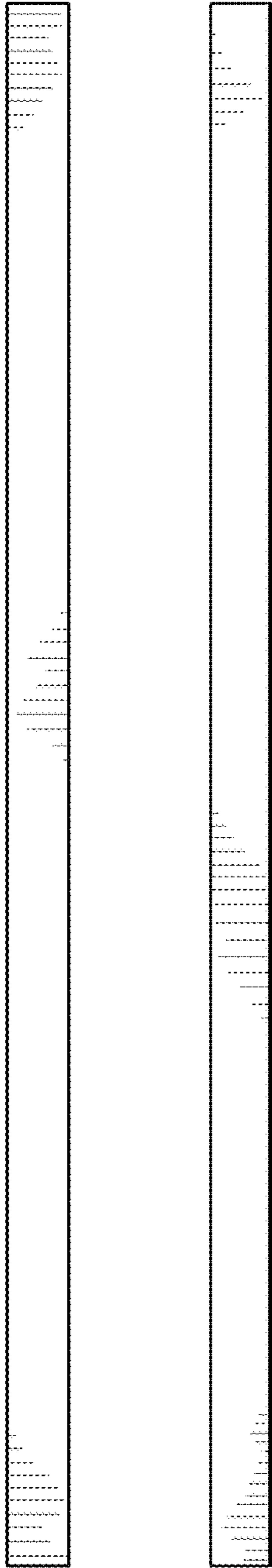


Fig. 4 Fig. 5

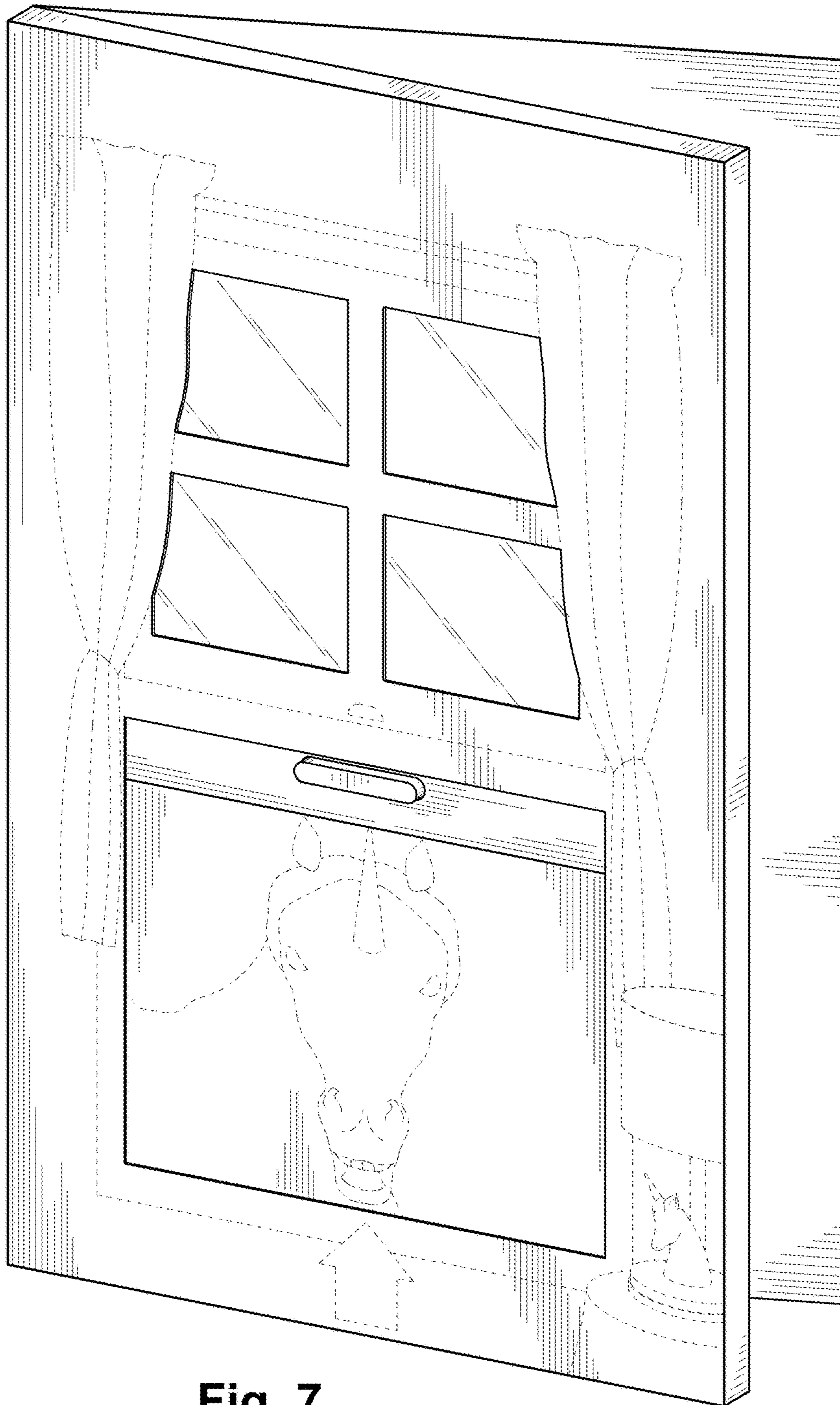
