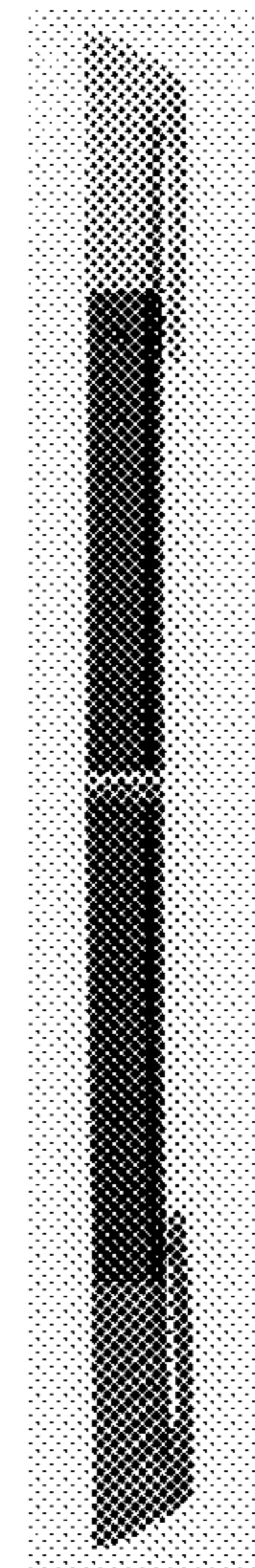
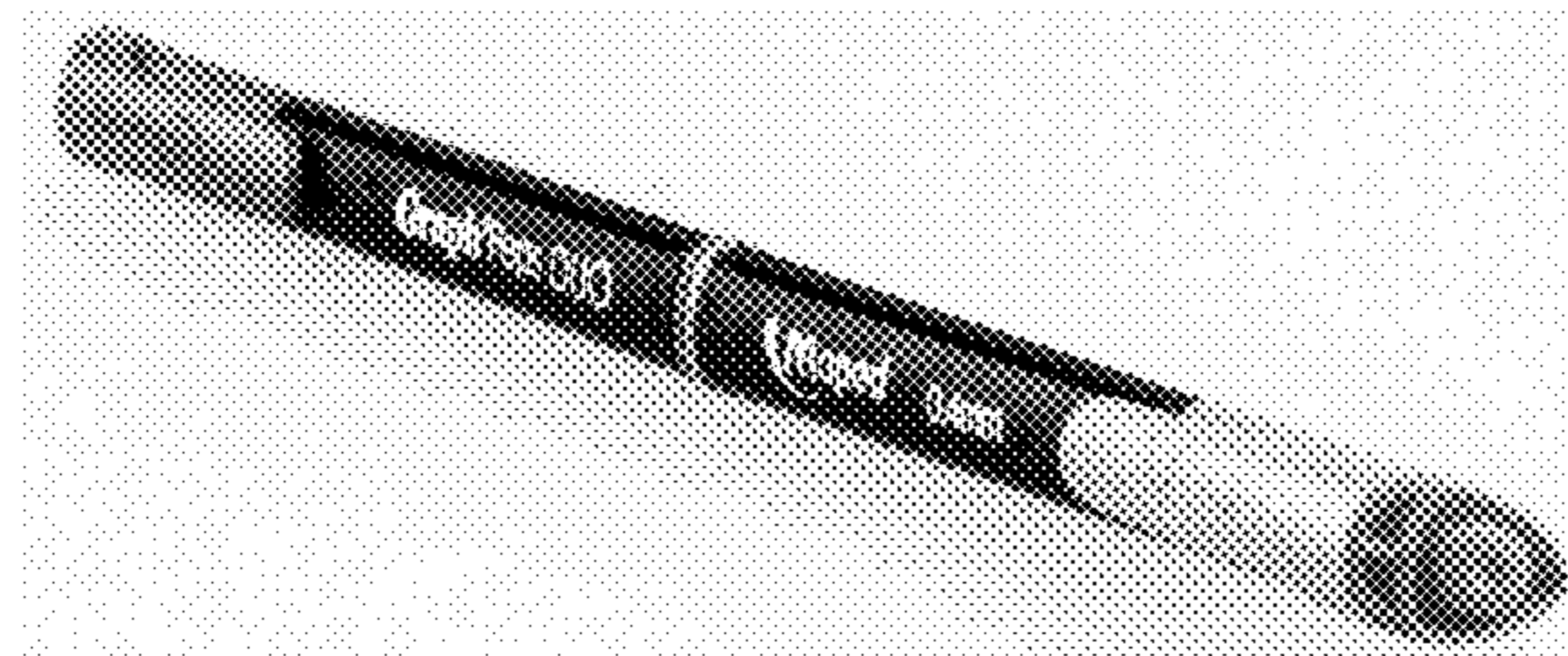
(57) **CLAIM**

The ornamental design for a writing implement, as shown and described.

DESCRIPTION

1. Writing implement
- 1.1 is a front perspective view of a writing implement showing our new design;
- 1.2 is a front elevation view thereof;
- 1.3 is a rear elevation view thereof;
- 1.4 is a first side elevation view thereof;
- 1.5 is a second side elevation view thereof slightly rotated;
- 1.6 is a slightly rotated side elevation view thereof with the two ends separated and placed next to each other;
- 1.7 is an enlarged side view of one of the ends thereof, shown without the rest of the writing implement for convenience; and
- 1.8 is an enlarged rear view of one of the ends thereof, shown without the rest of the writing implement for convenience.

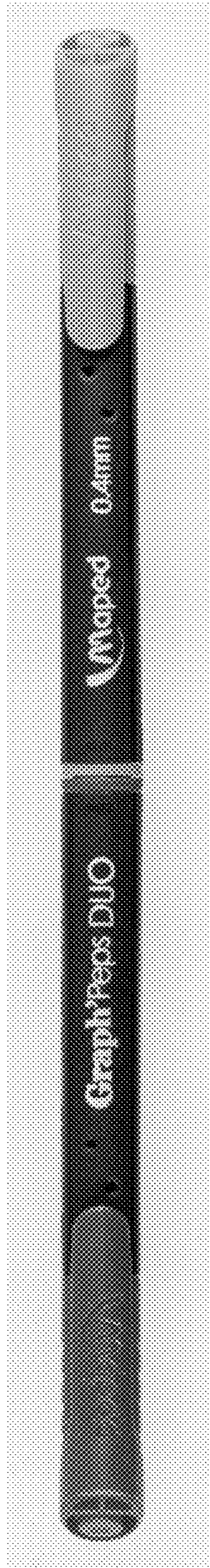

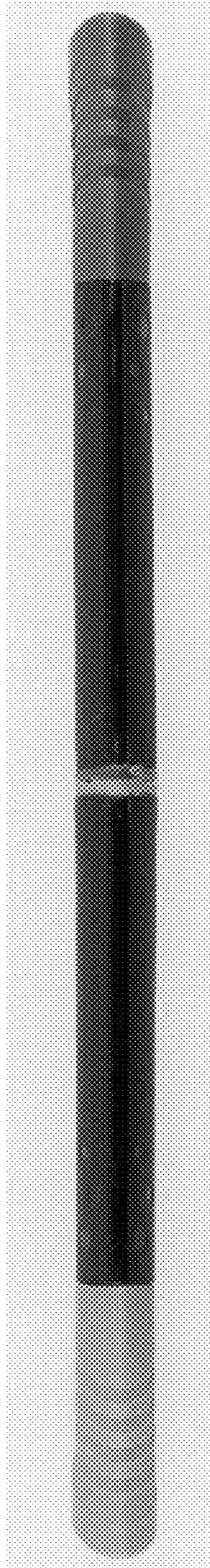

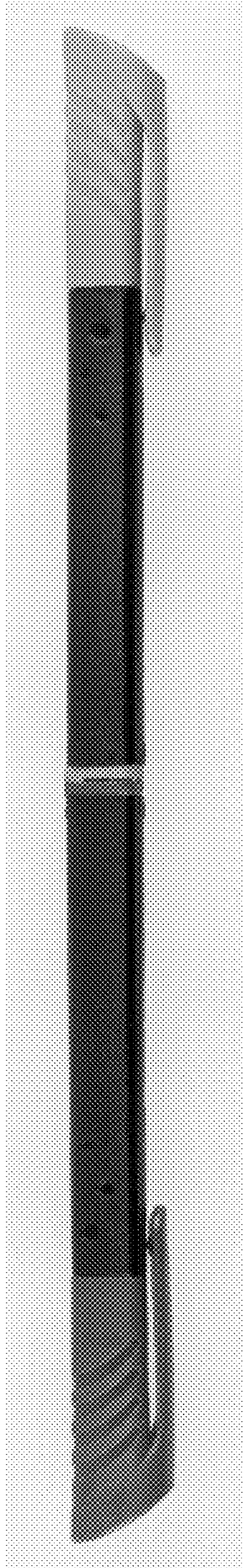

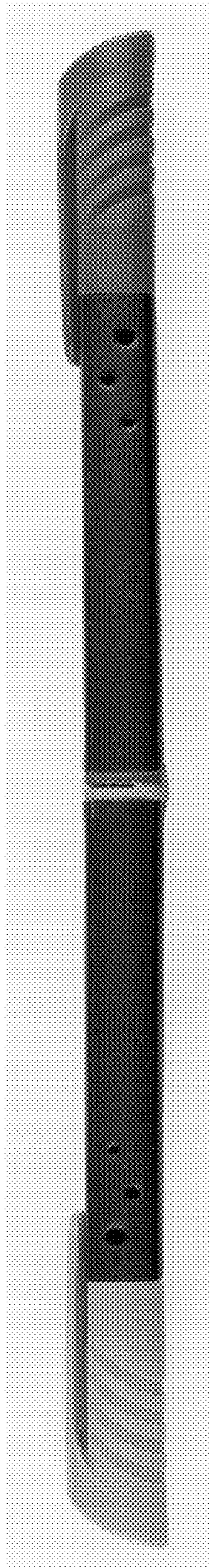
