FIG. 5 is a top view of the badge of FIG. 1;

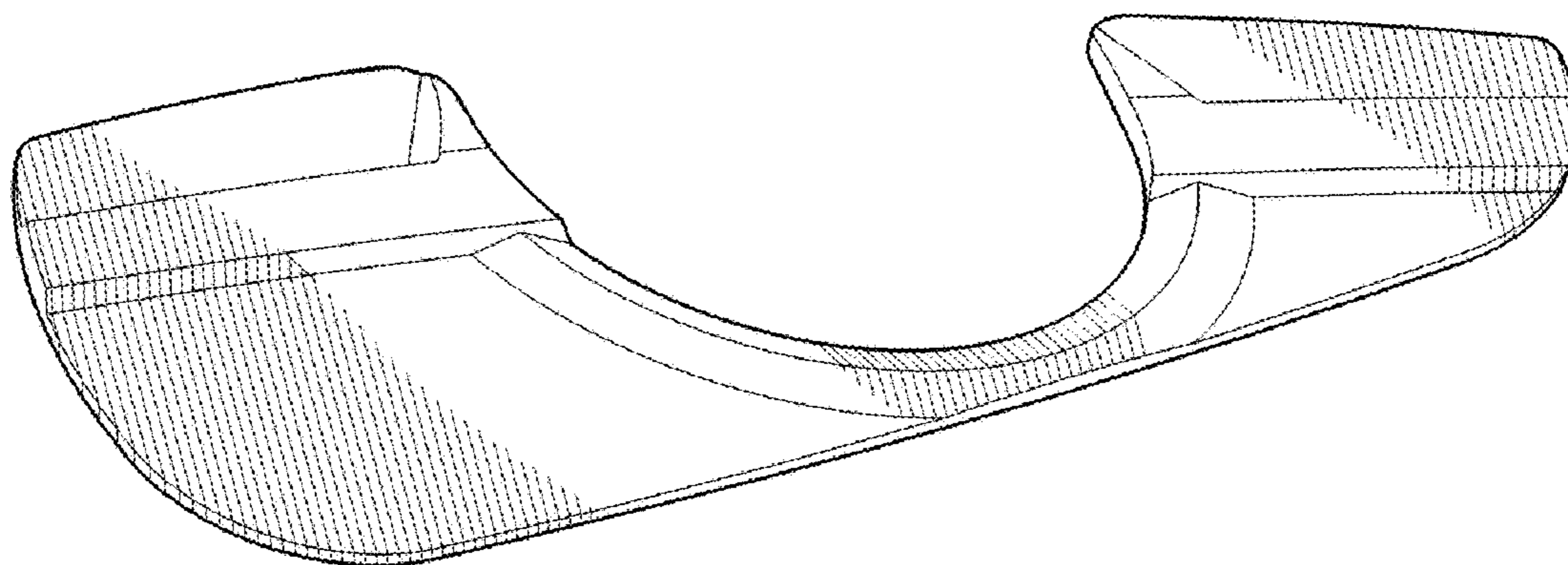
FIG. 6 is a bottom view of the badge of FIG. 1;

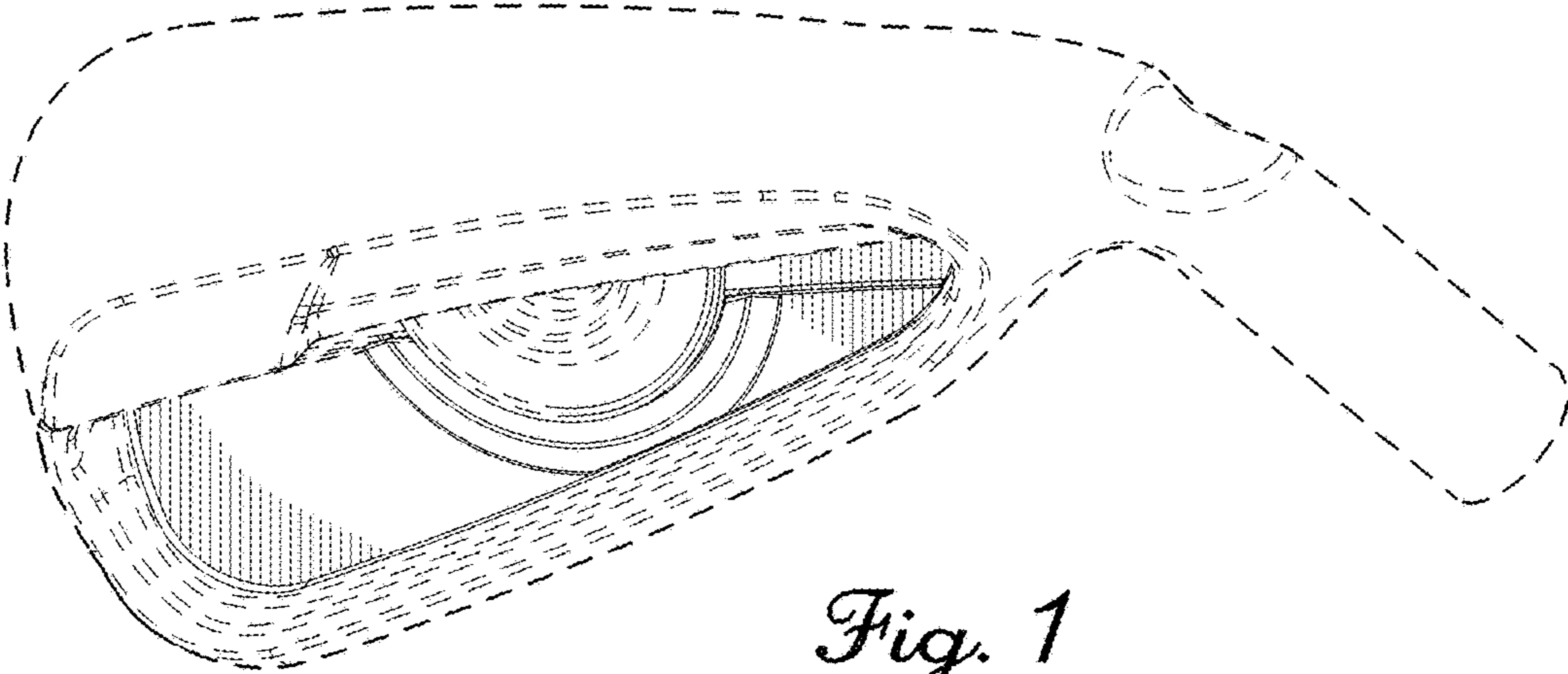

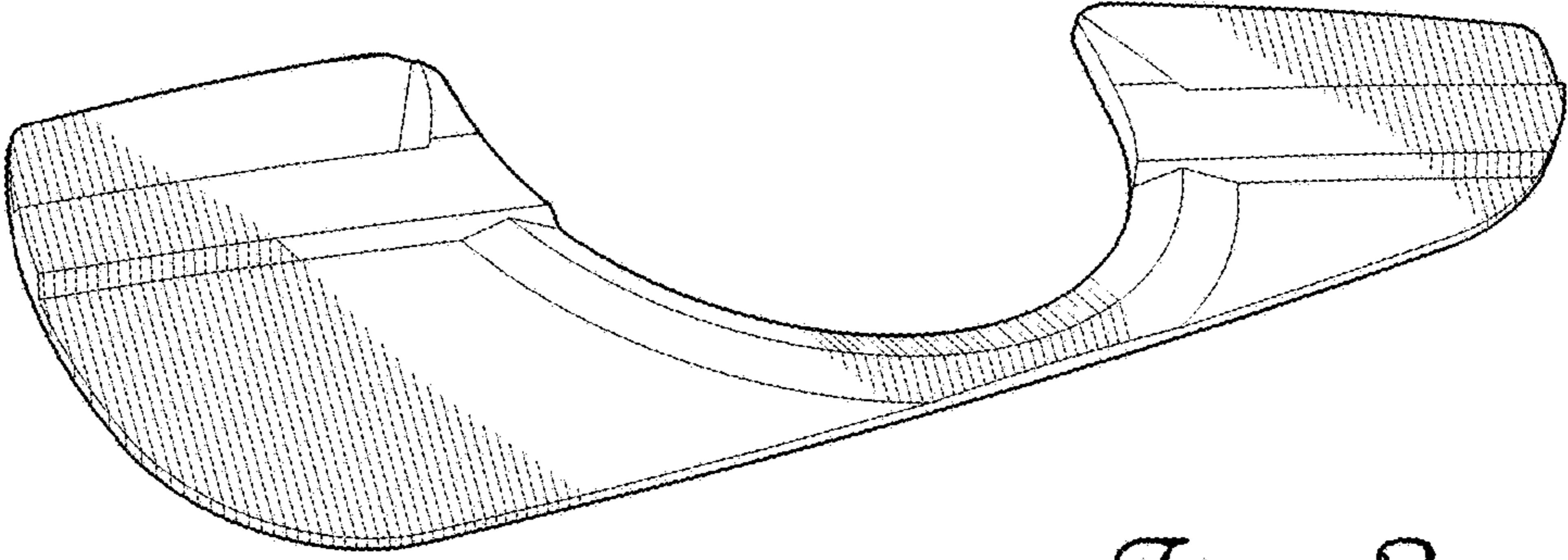

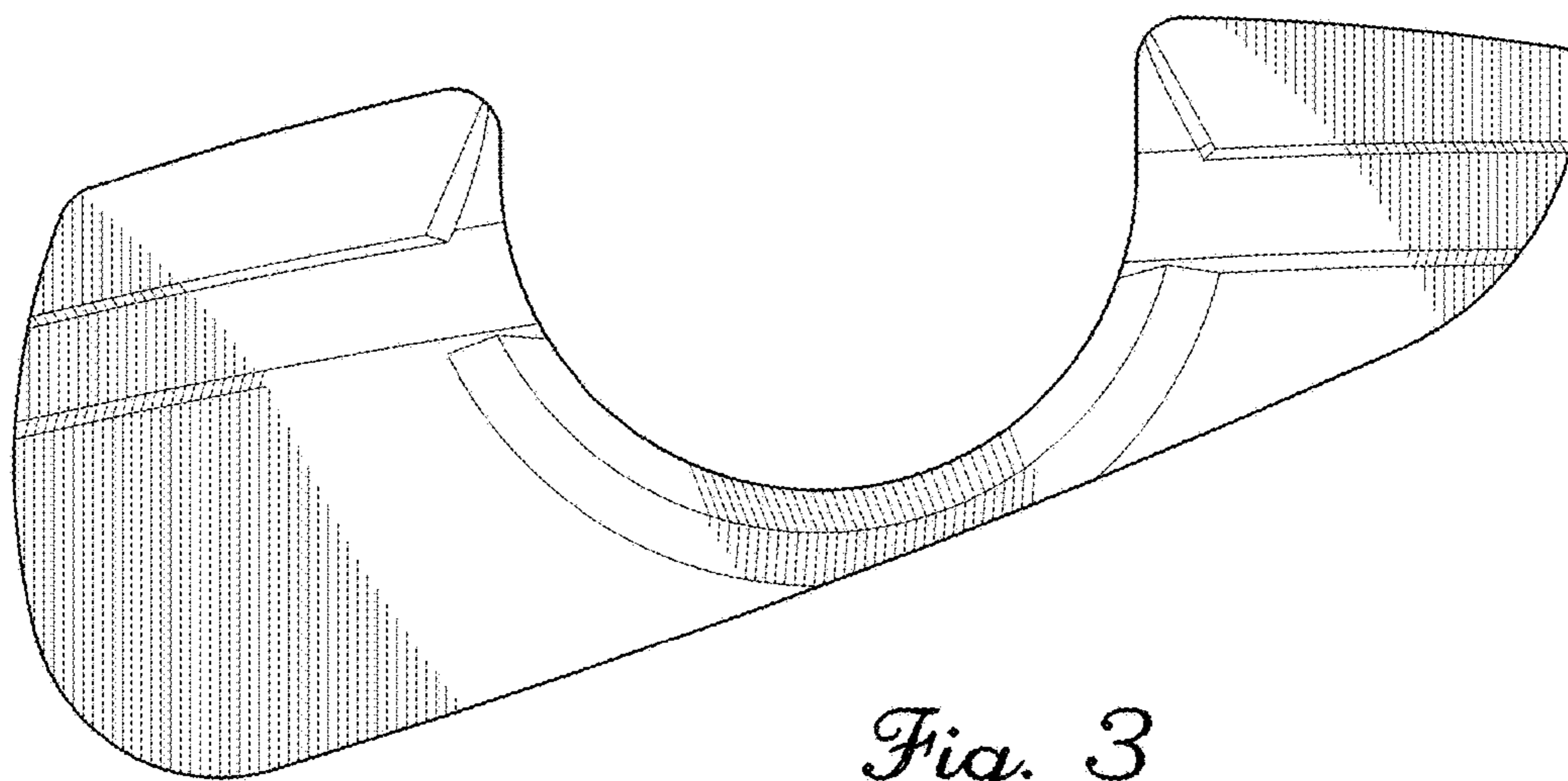

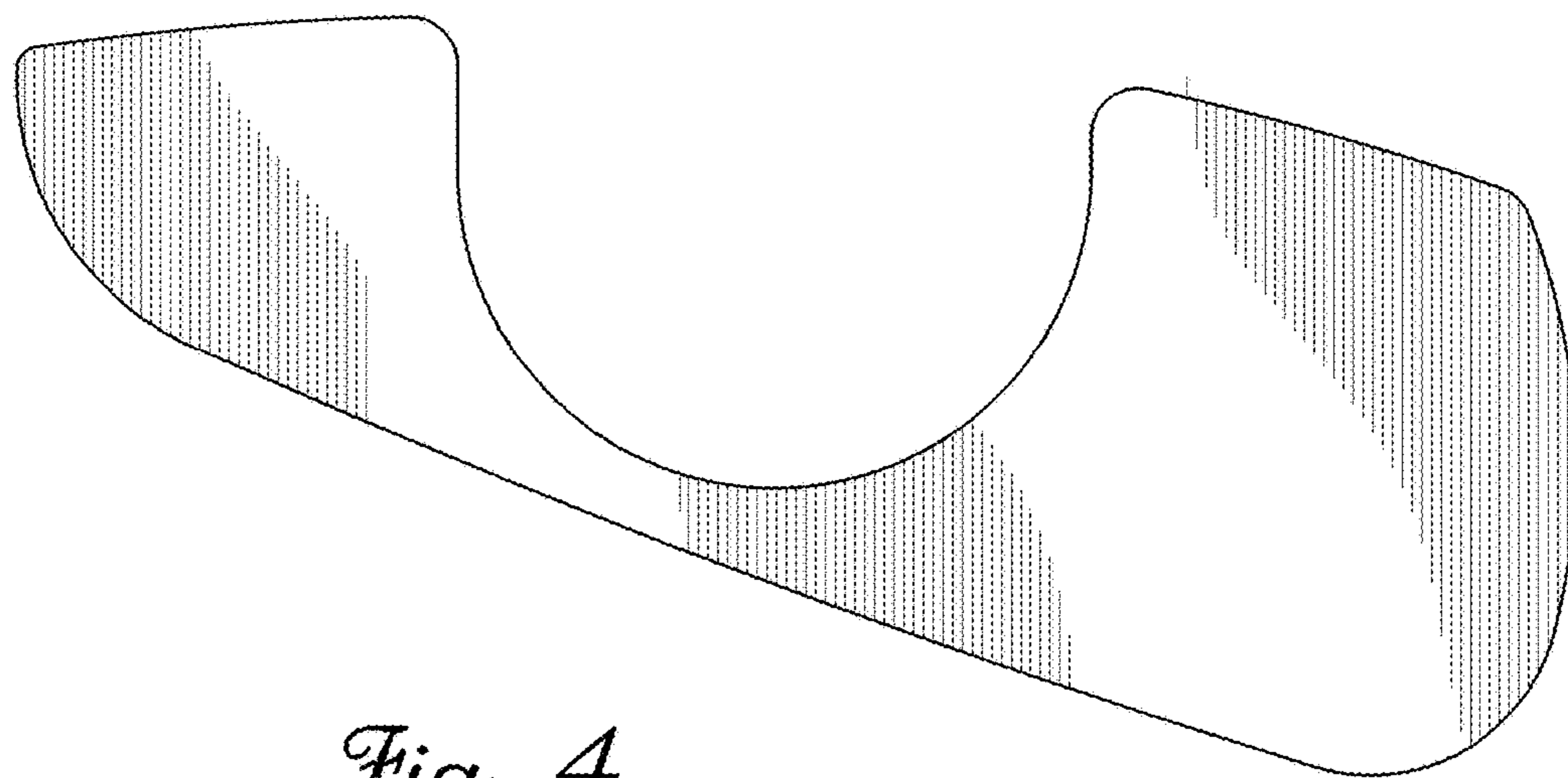

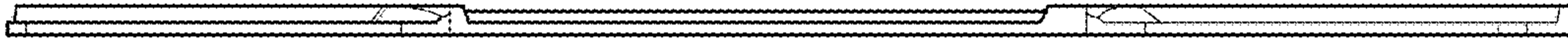

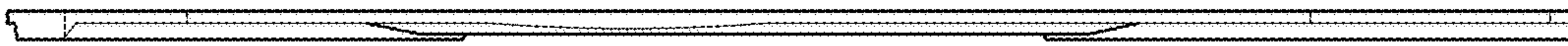
