DESCRIPTION

FIG. 4 is a left side elevational view of the light fixture illustrated in FIG. 1.

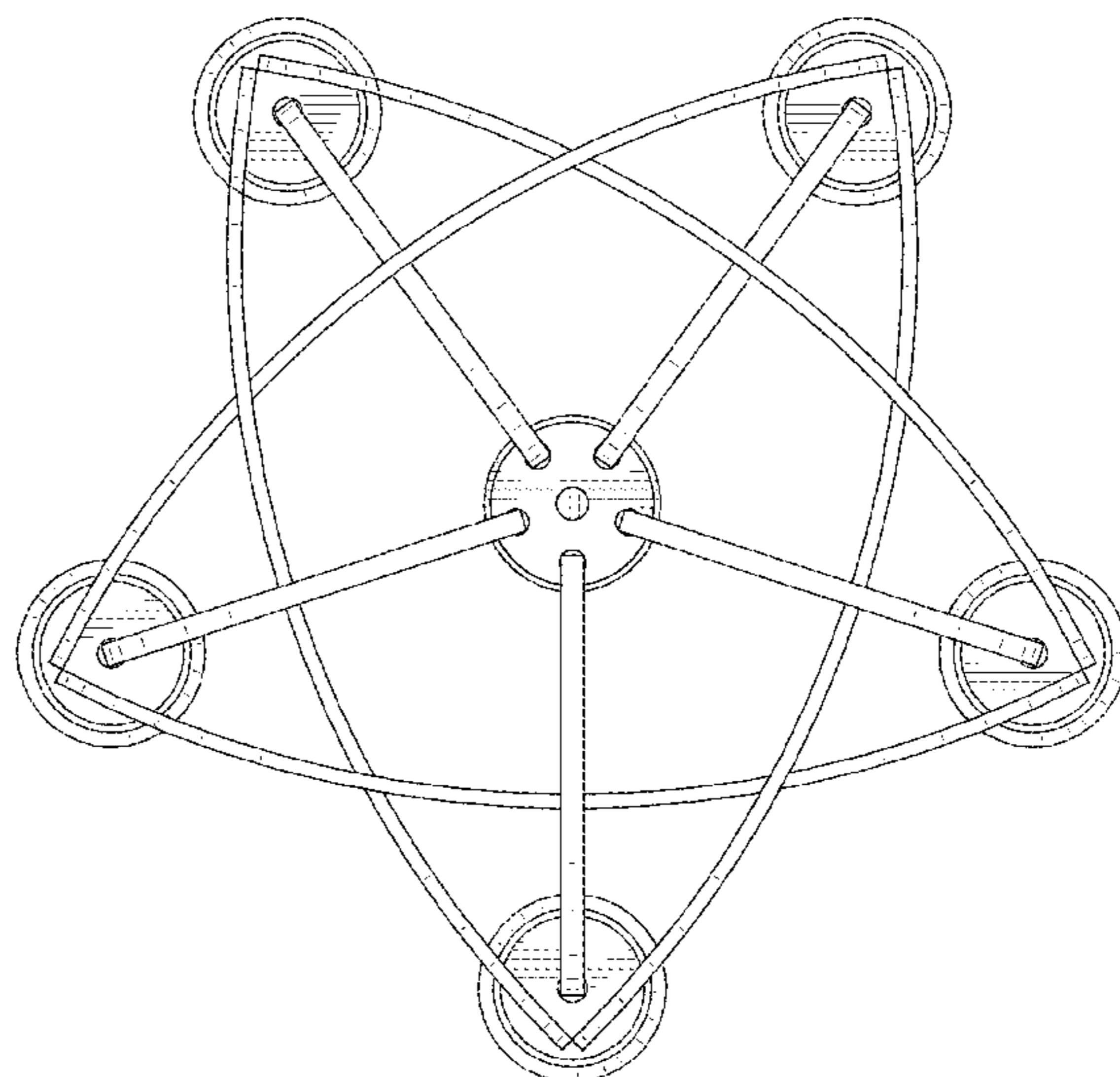
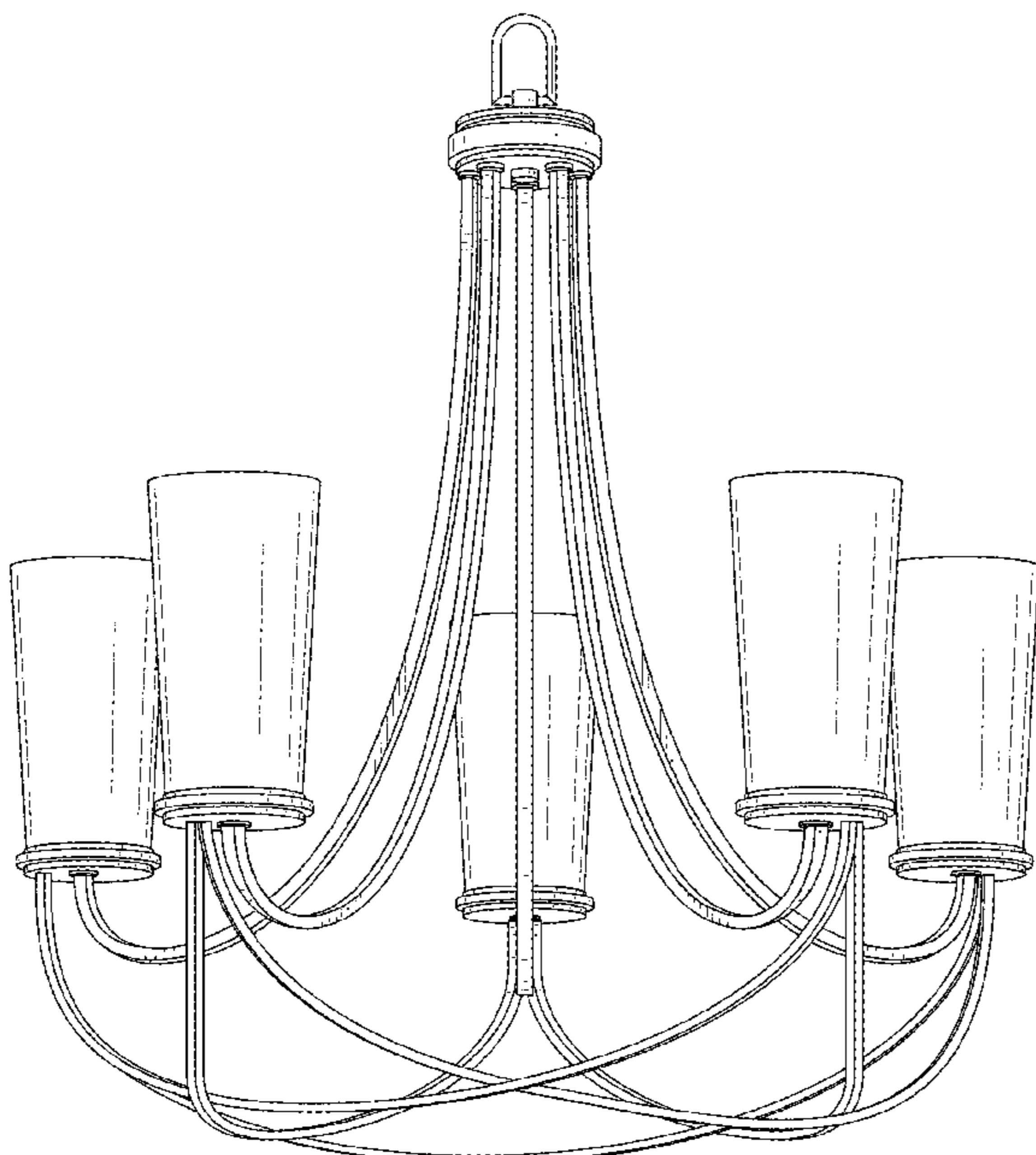
FIG. 5 is a right side elevational view of the light fixture illustrated in FIG. 1.

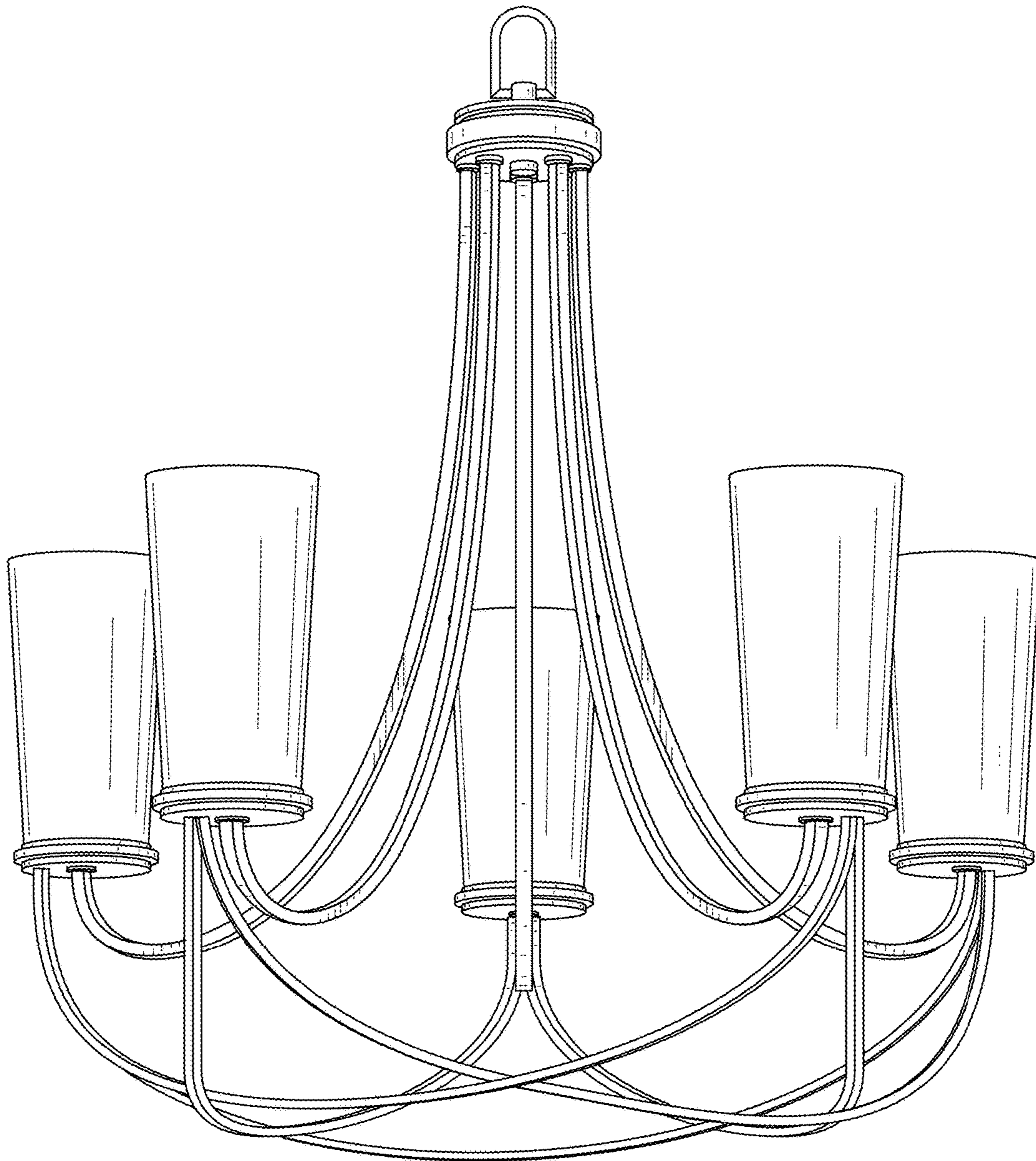

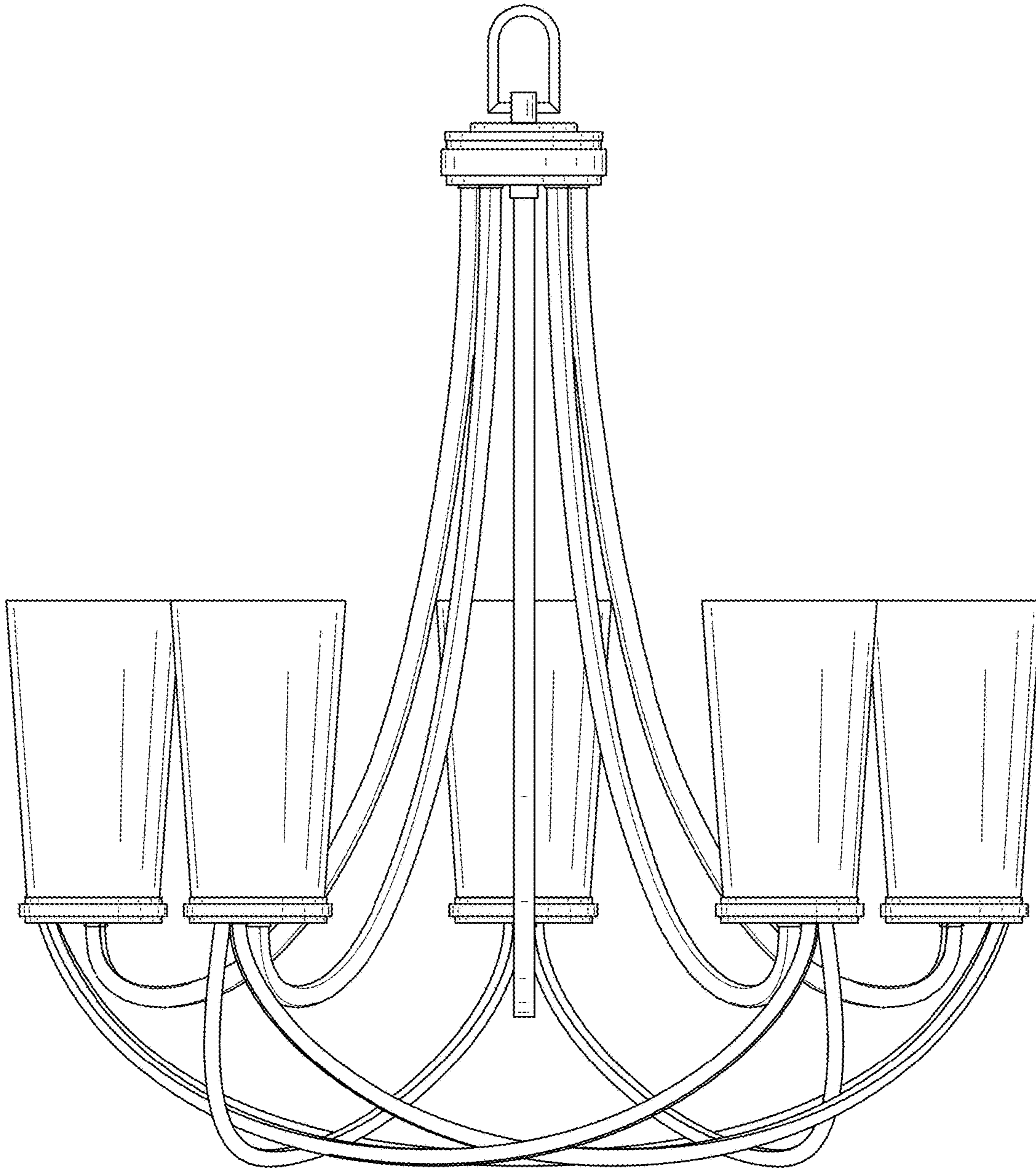

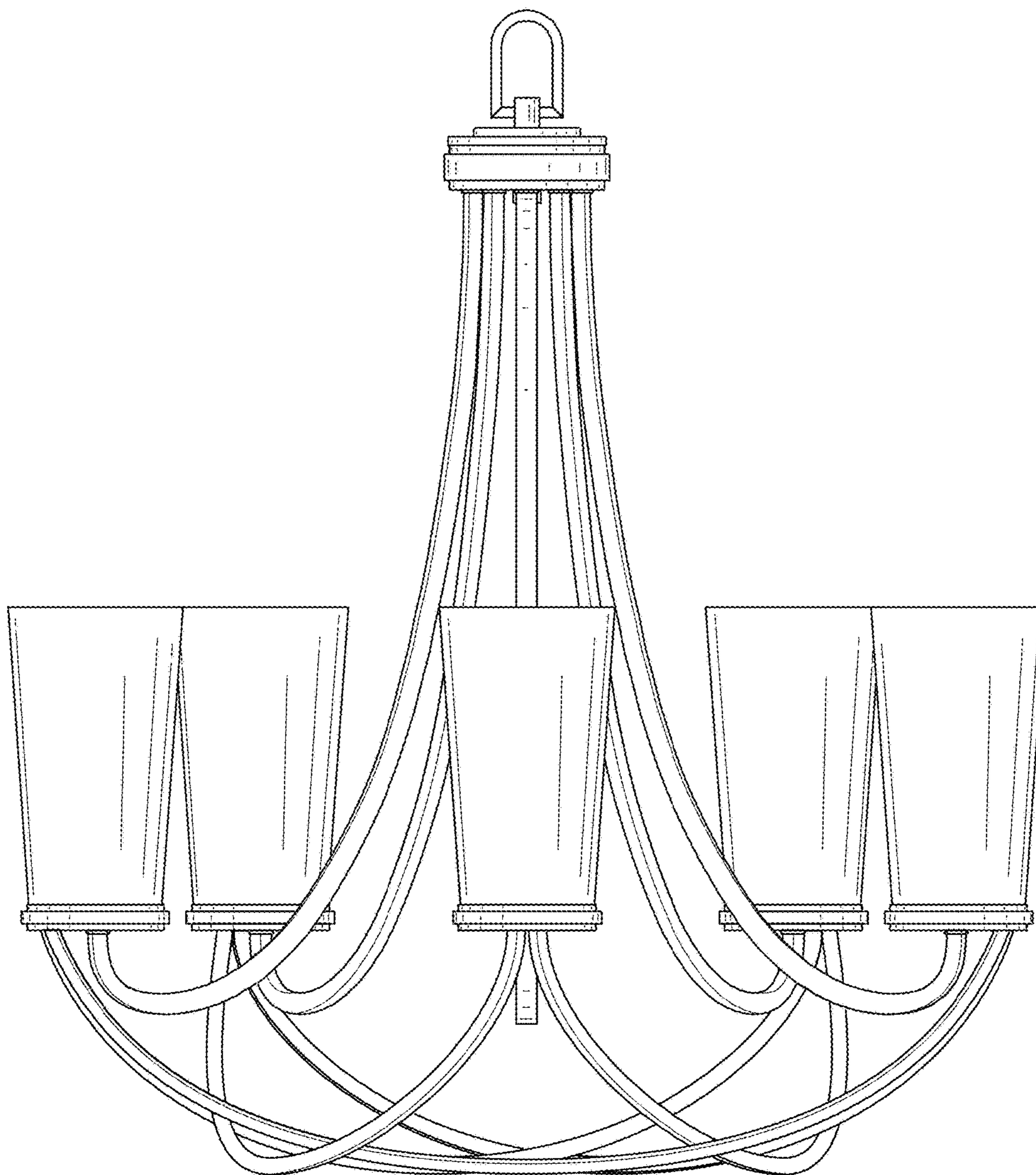

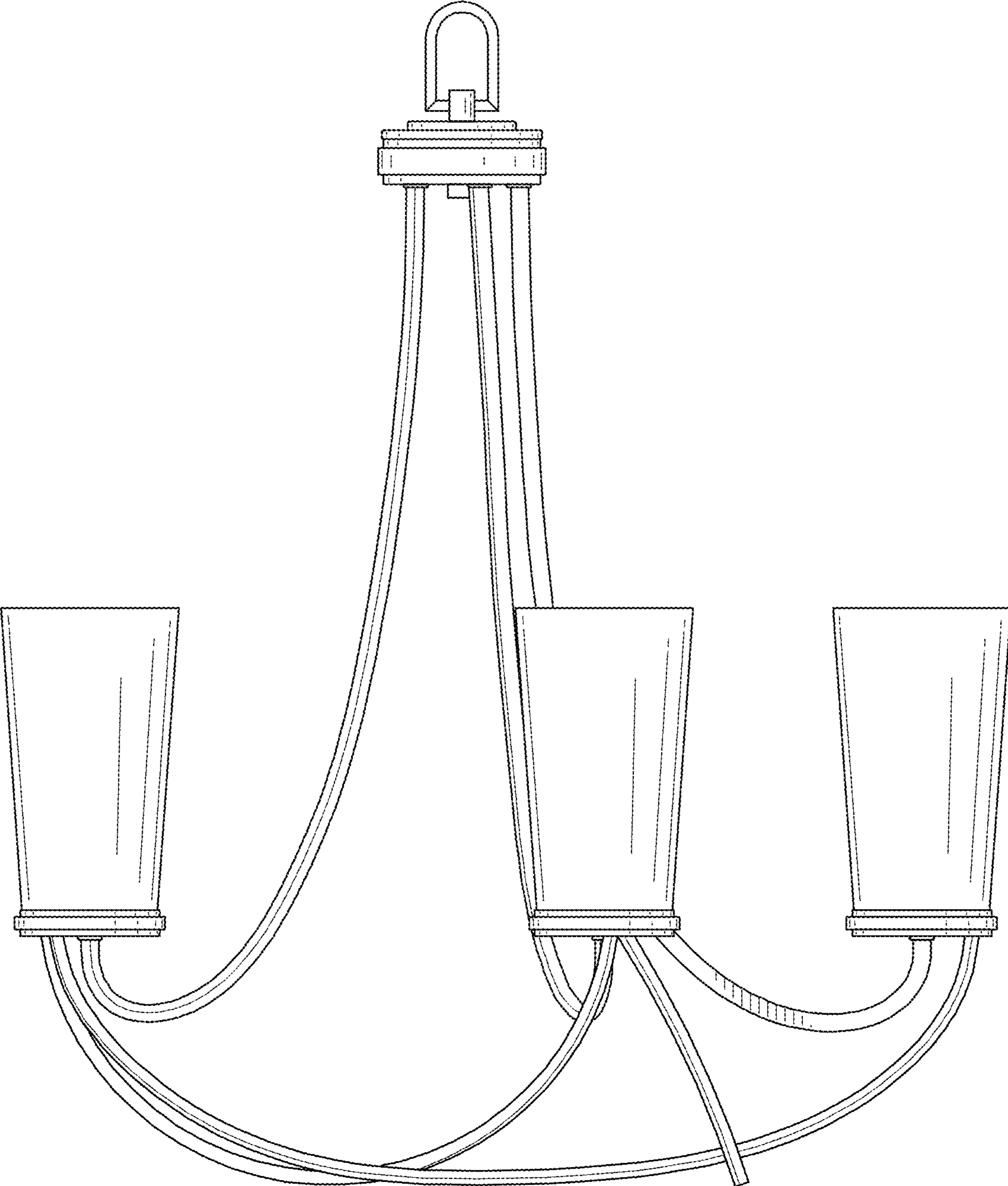

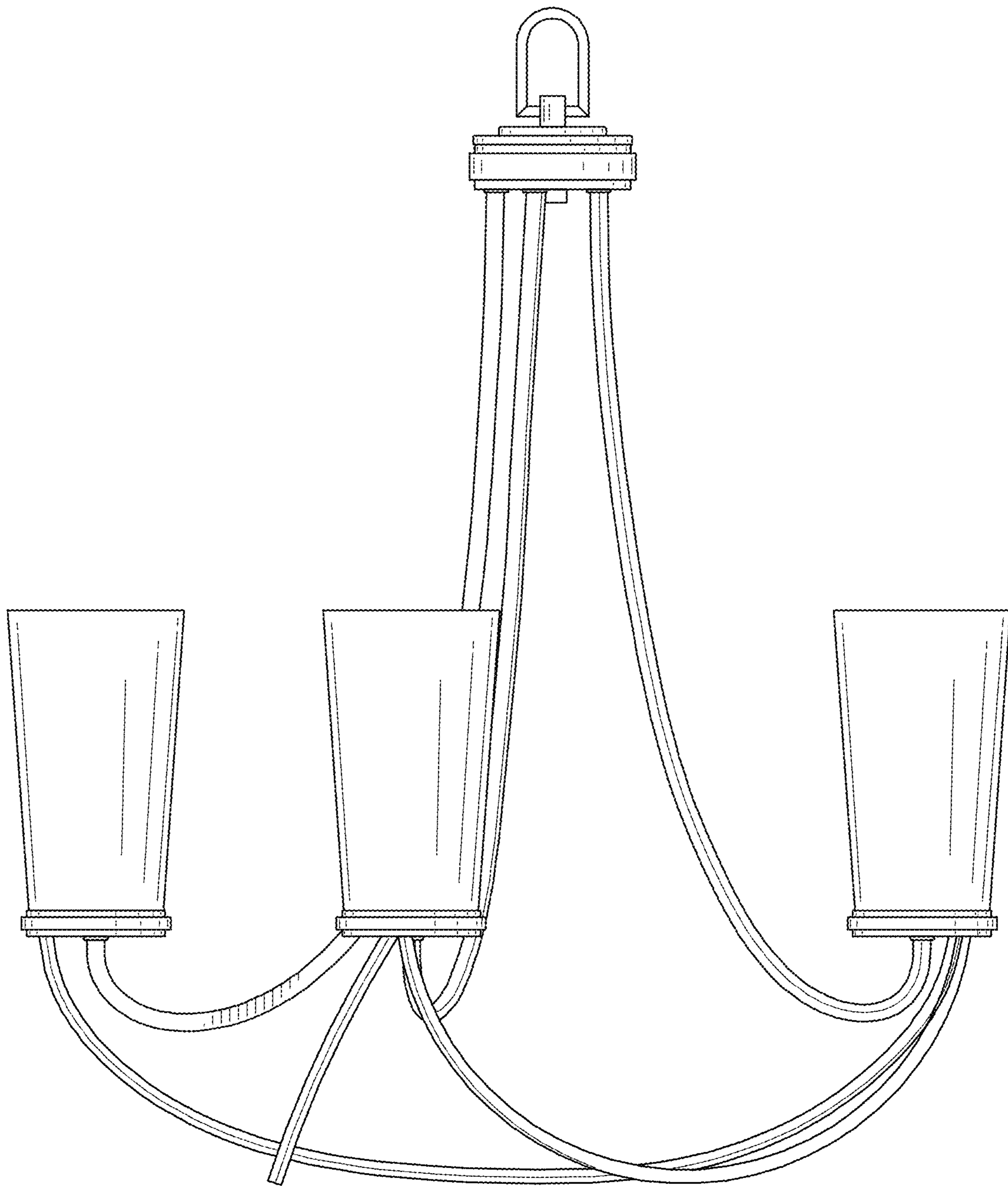

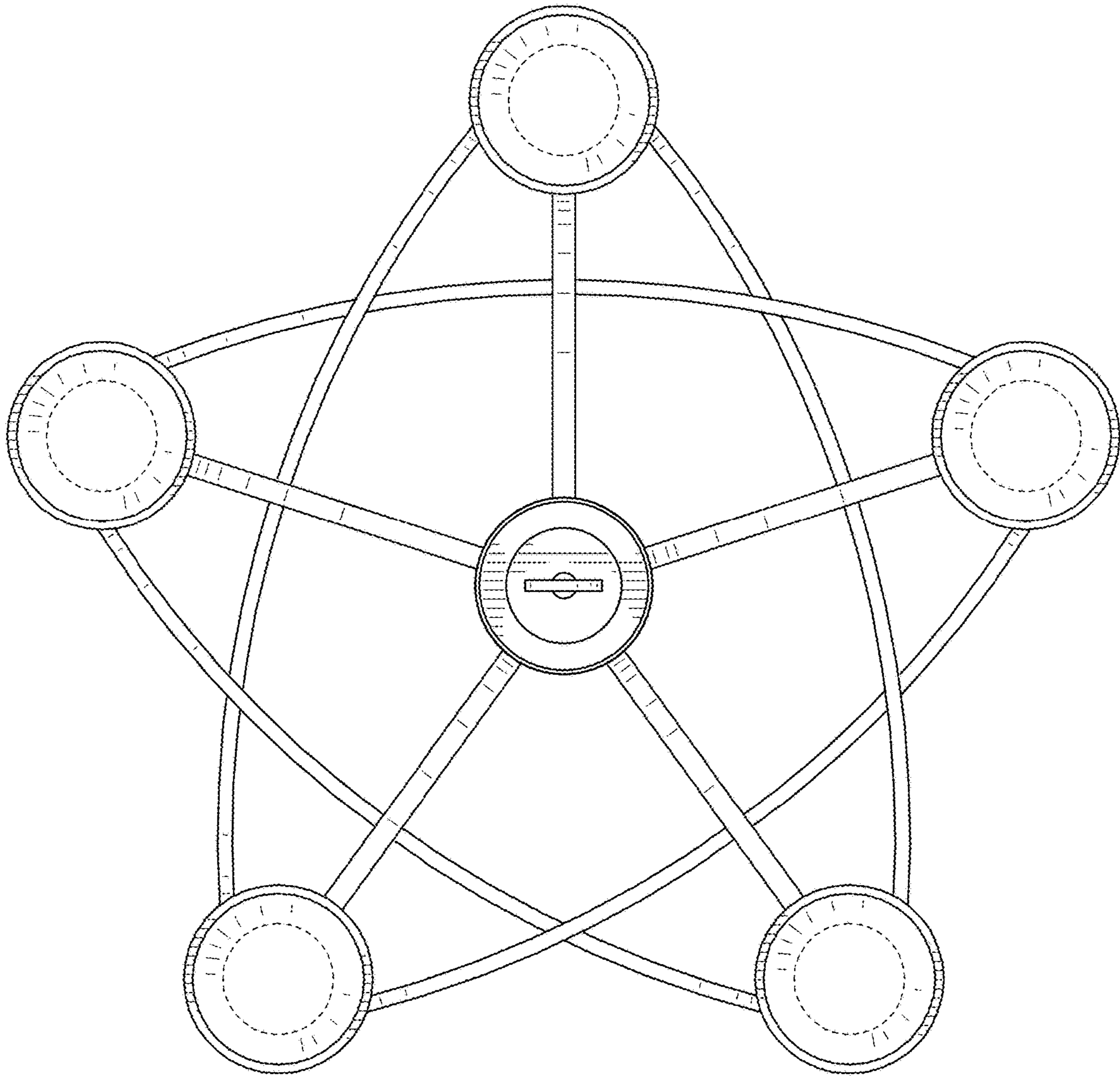

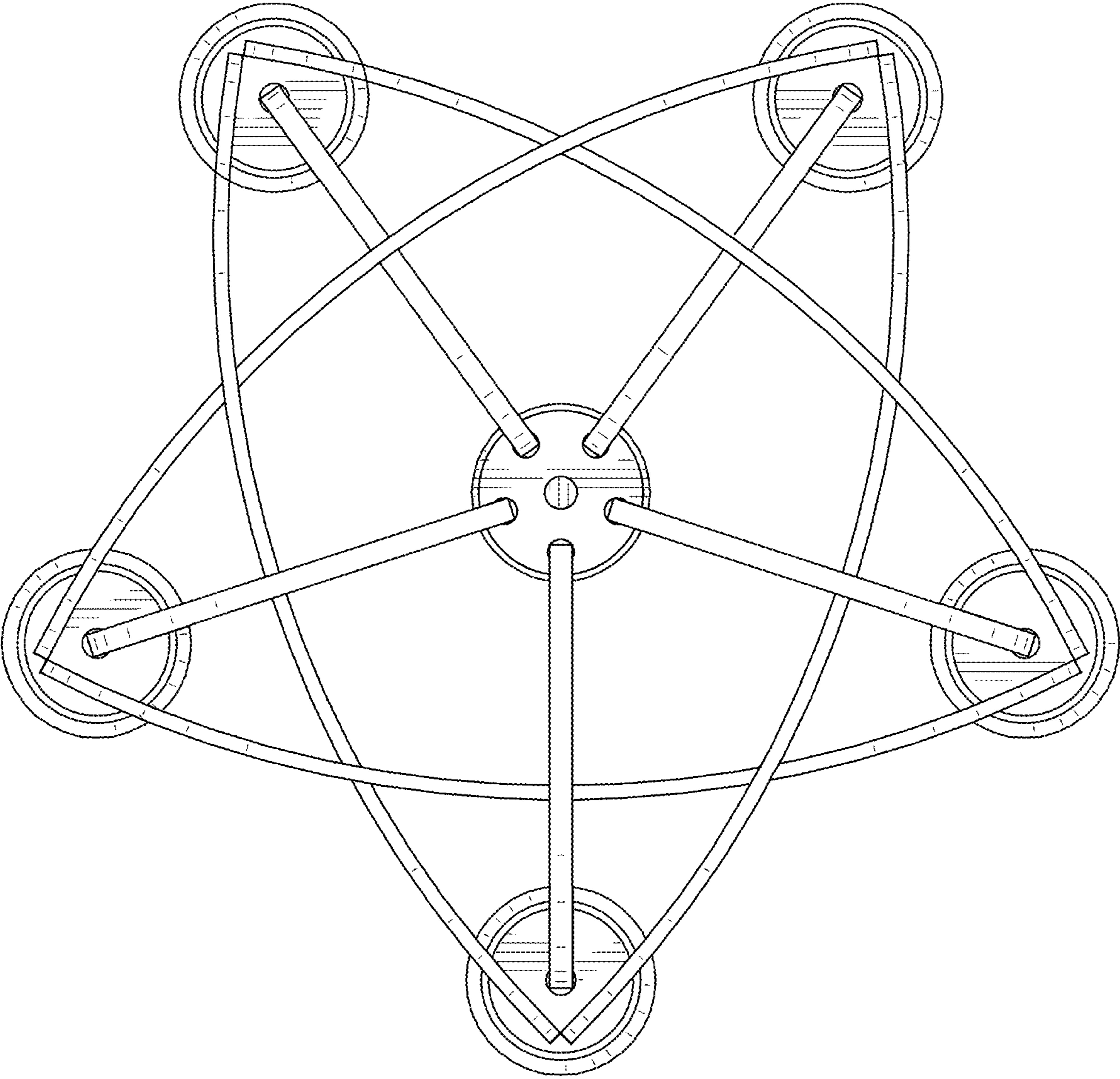
