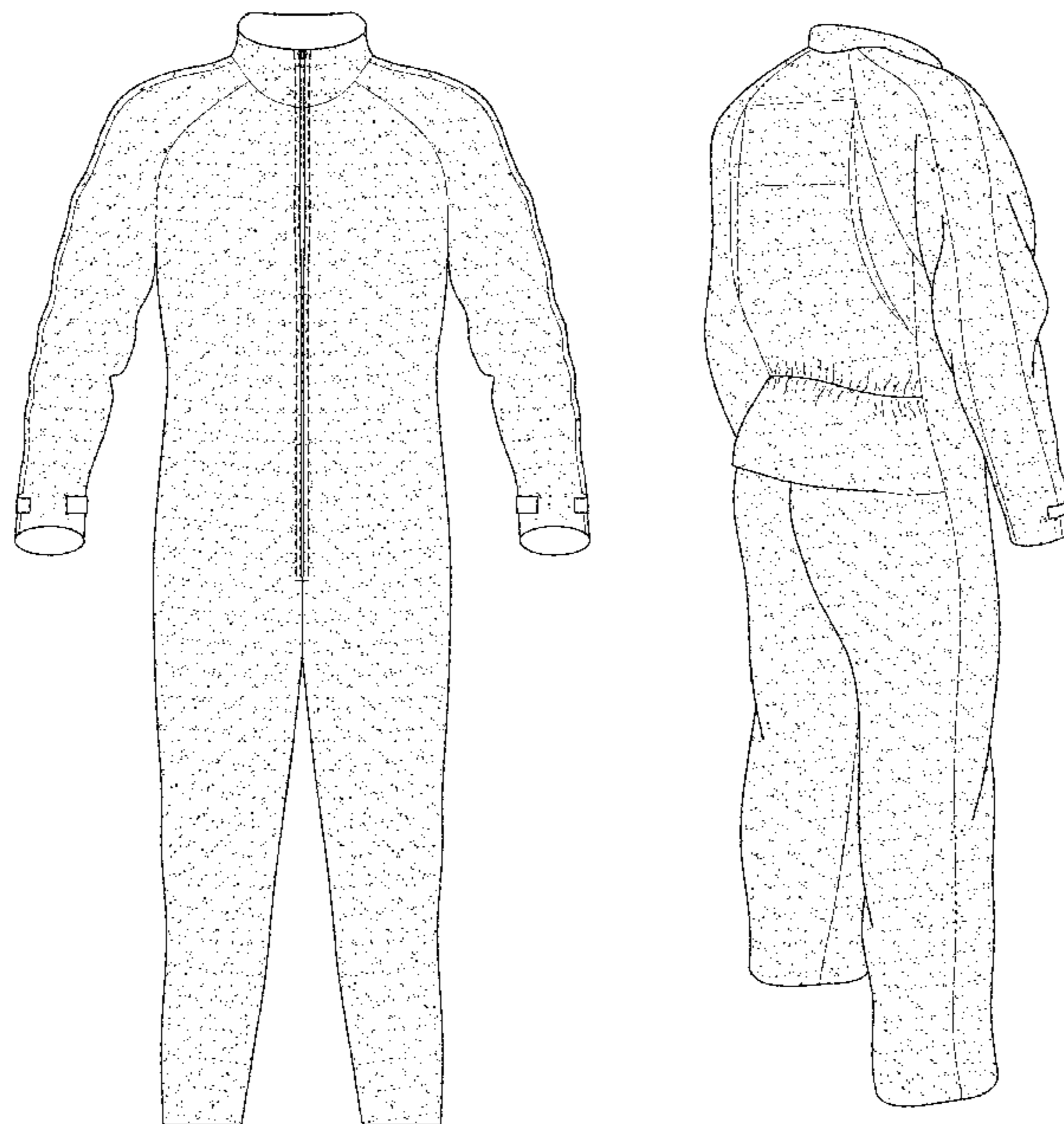
(57) **CLAIM**

DESCRIPTION

FIG. 1 is front elevation view of the paint suit in accordance
with a first embodiment of my new design;

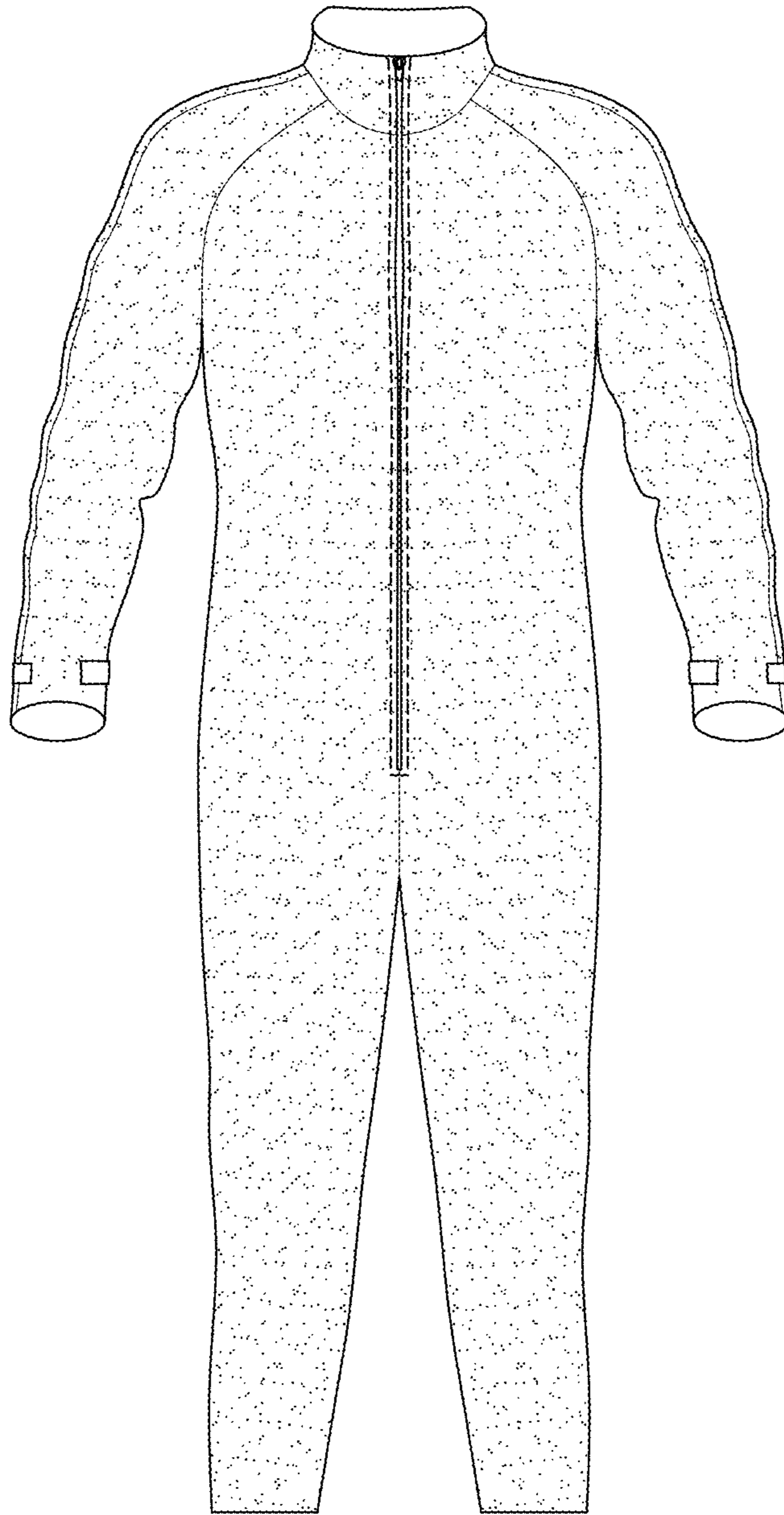

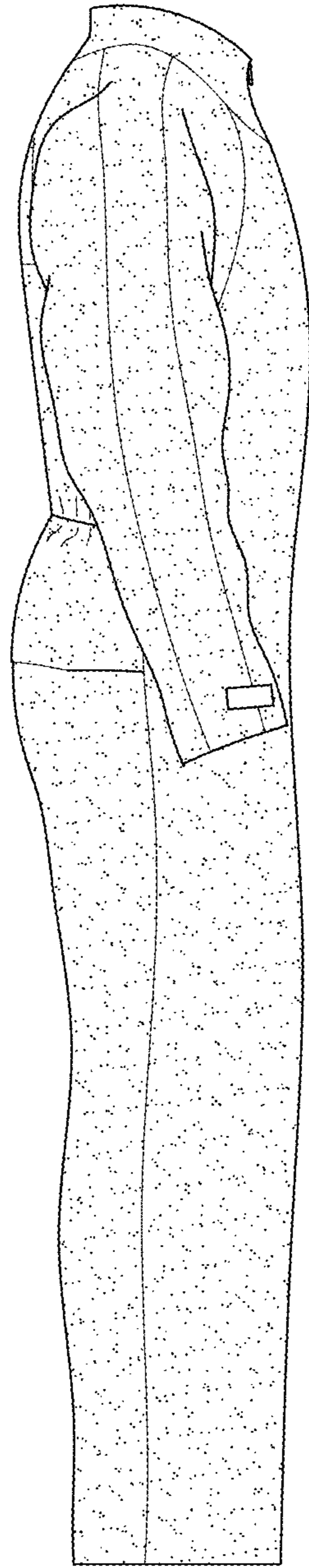

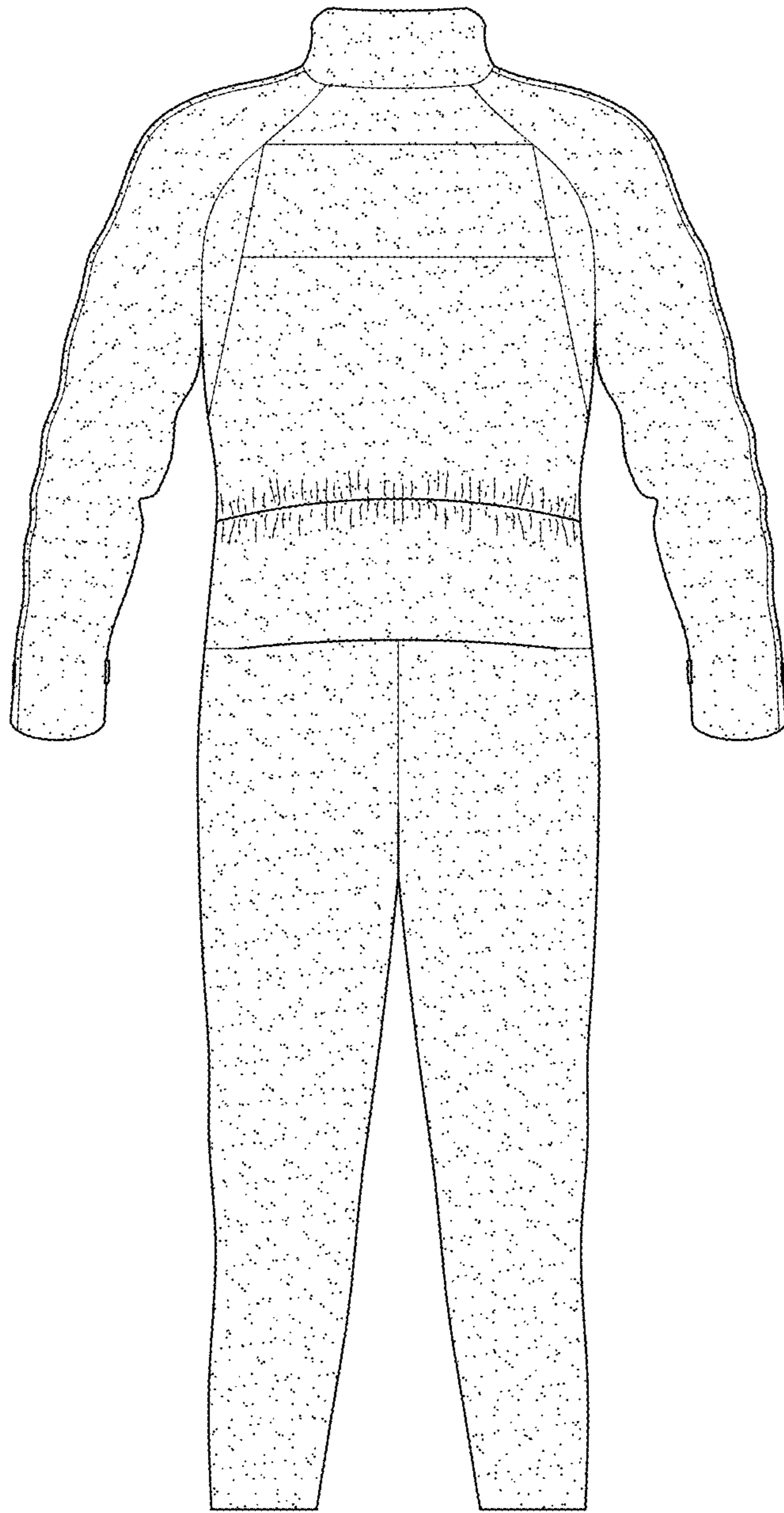

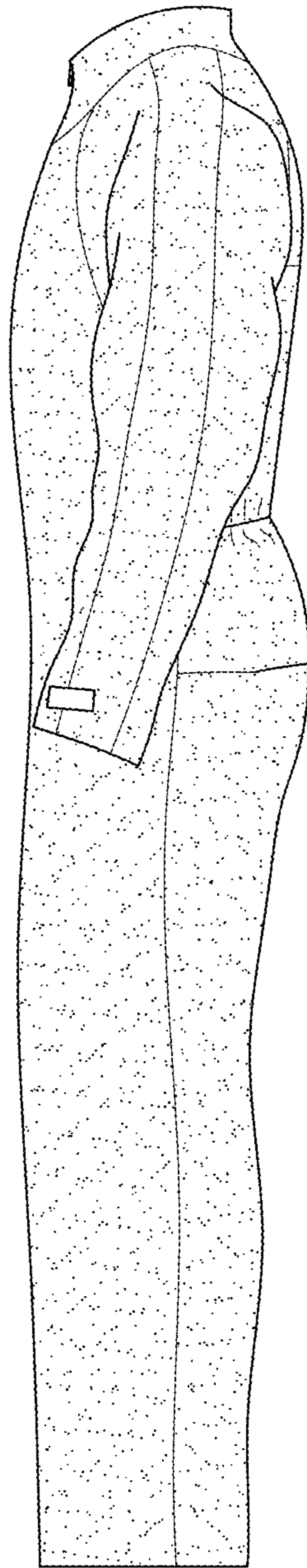

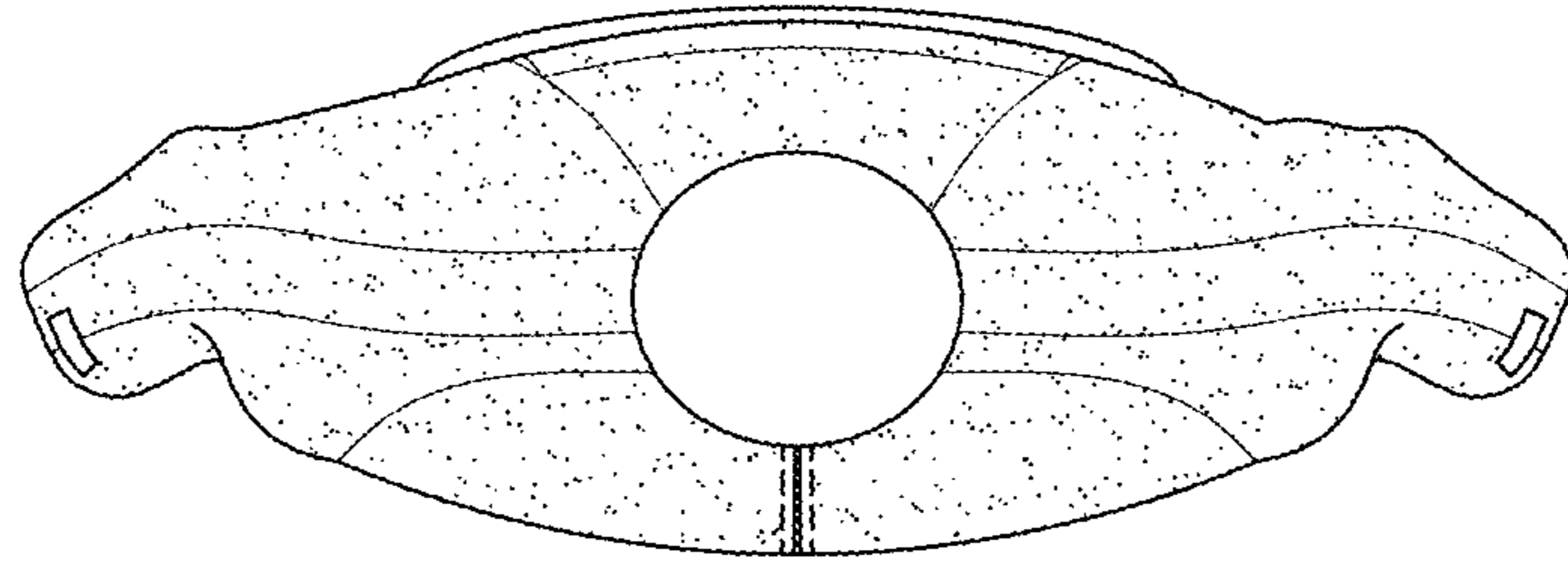

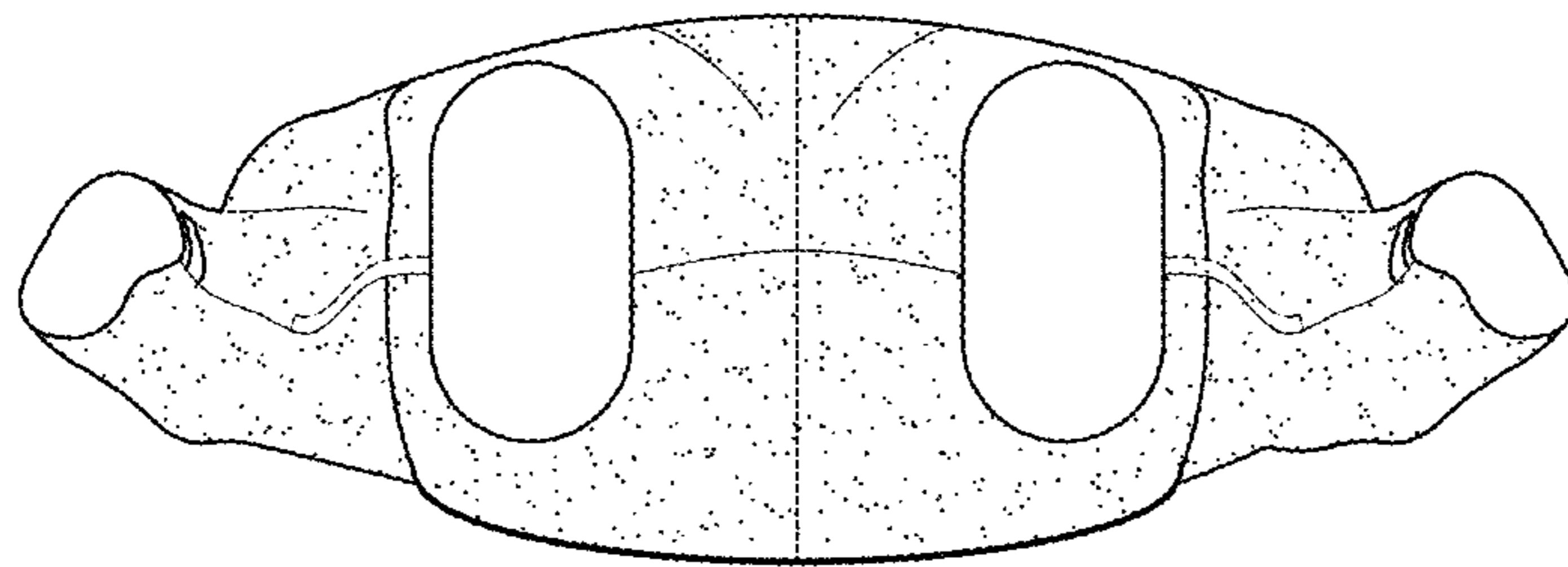

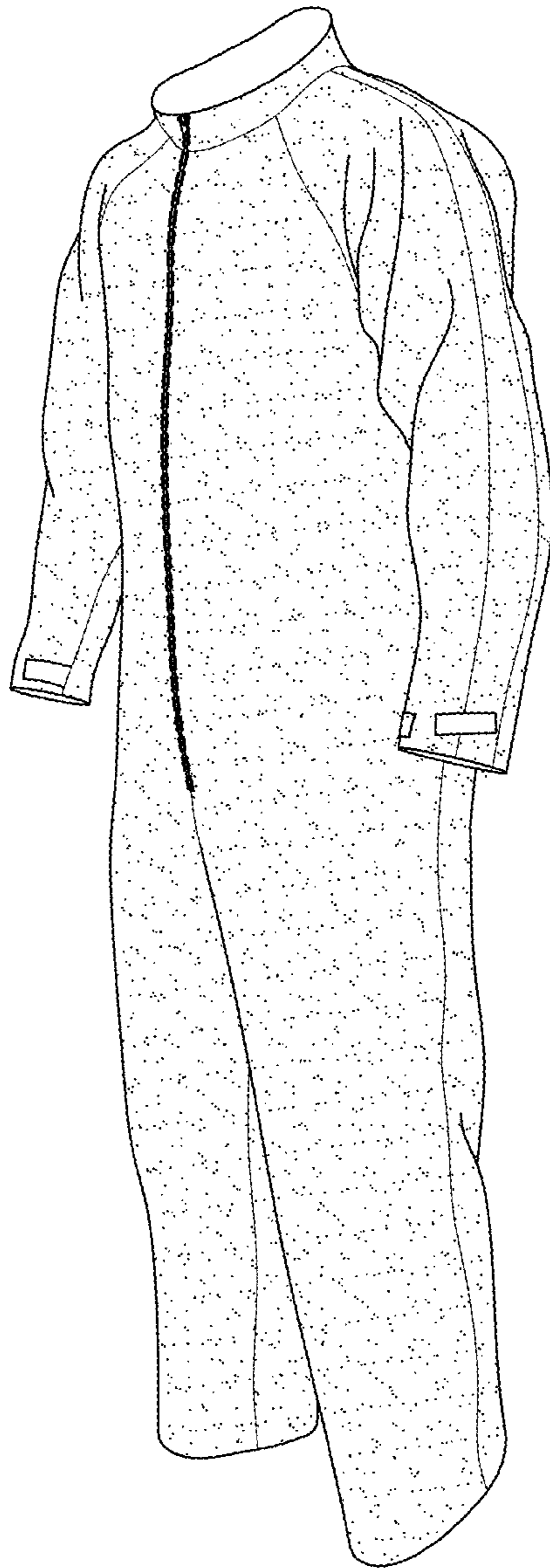

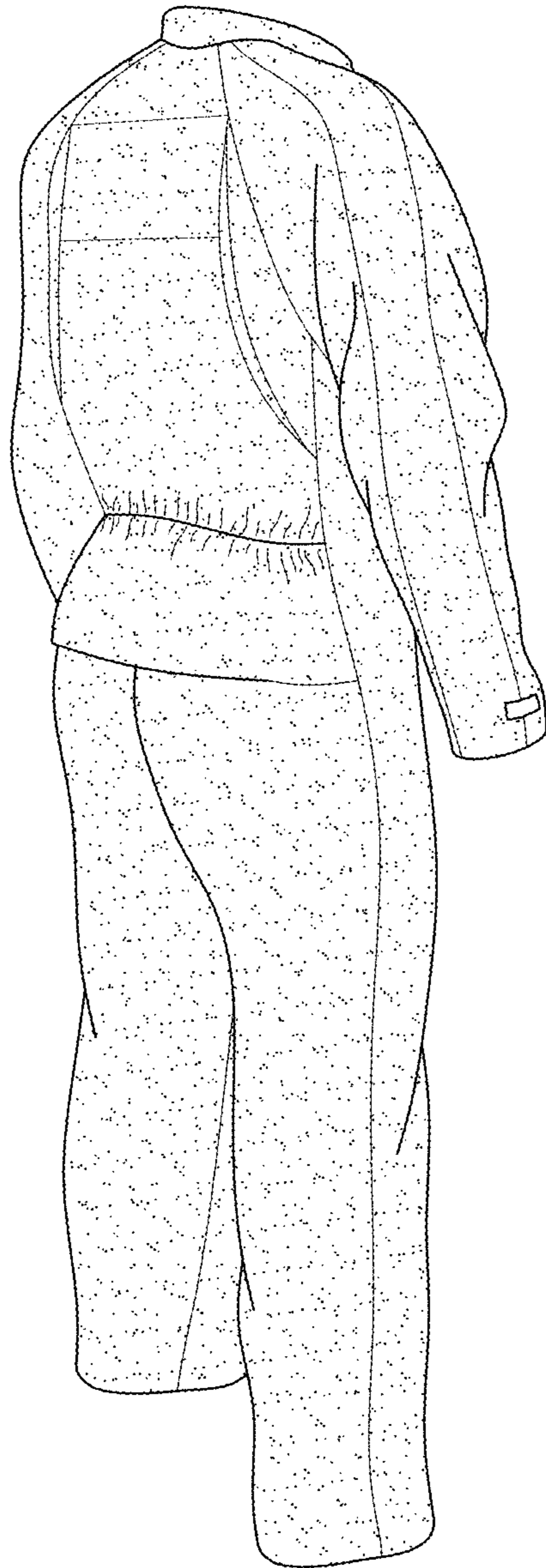

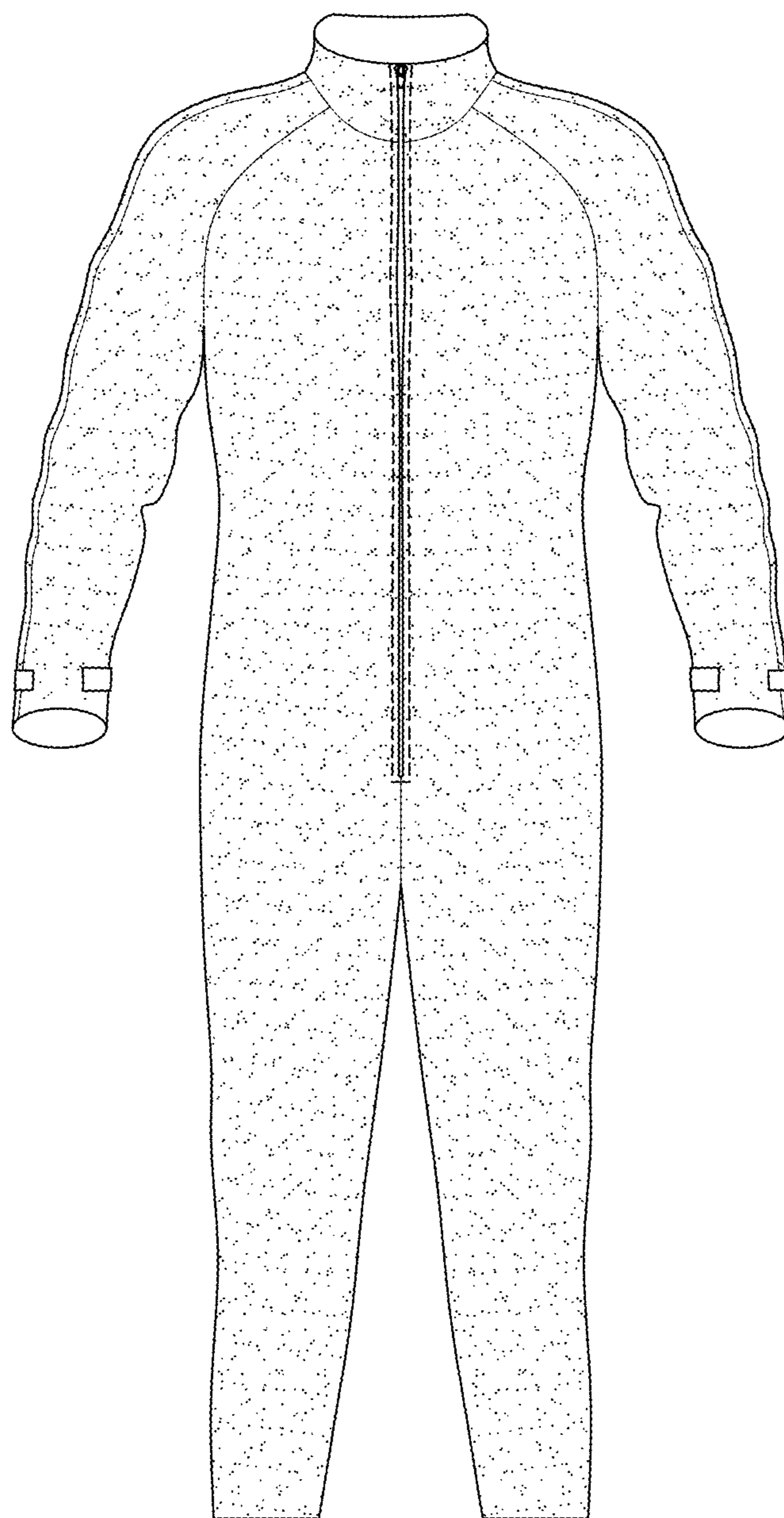

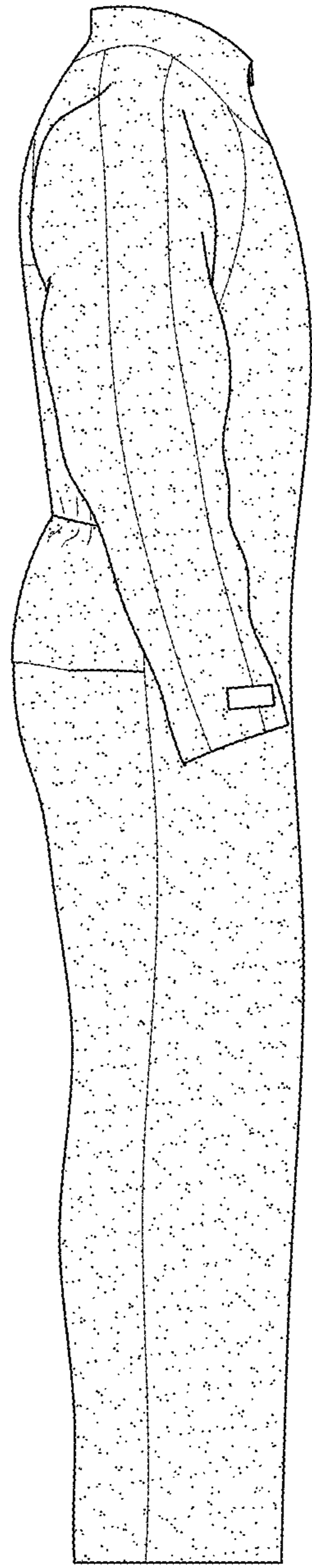

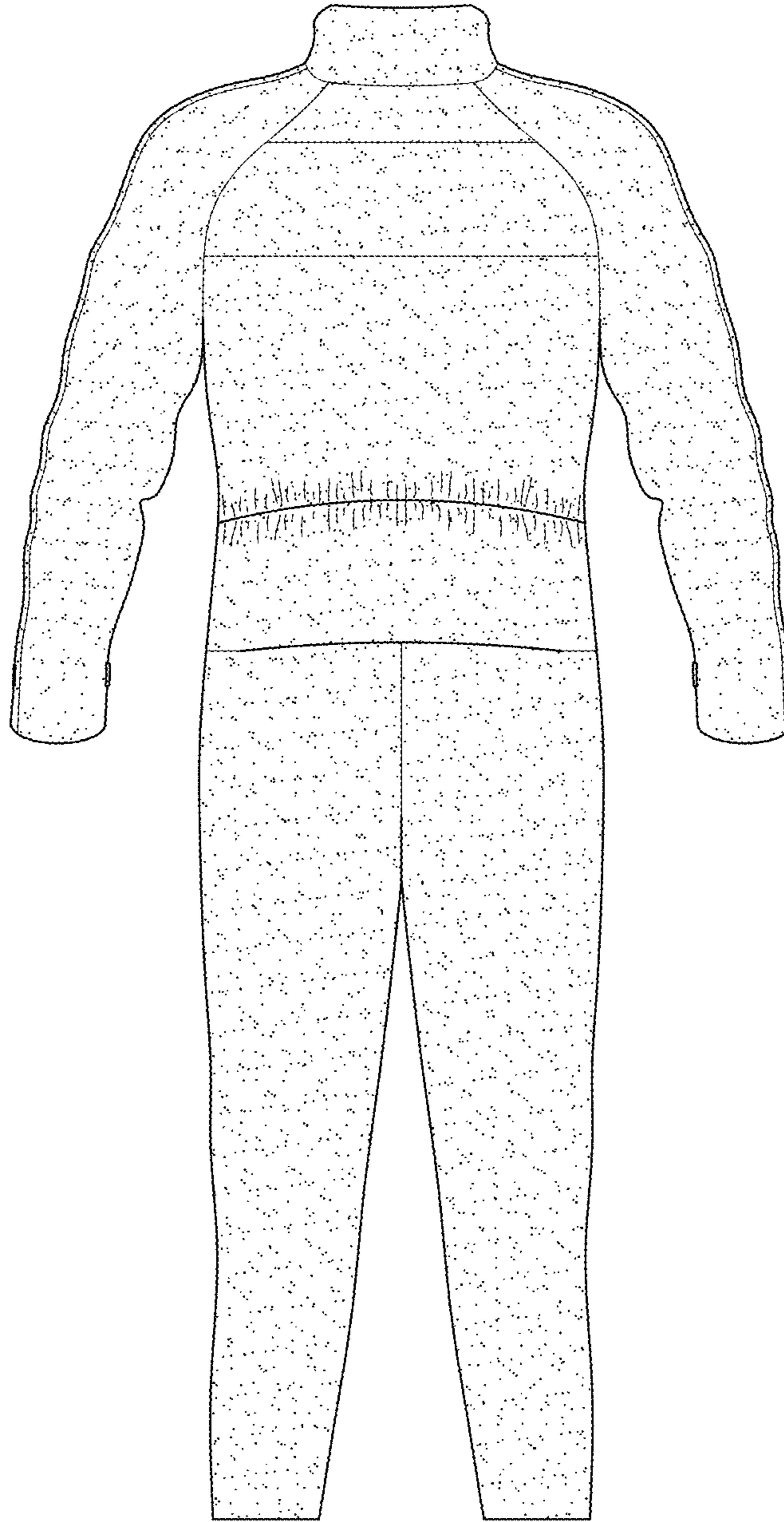

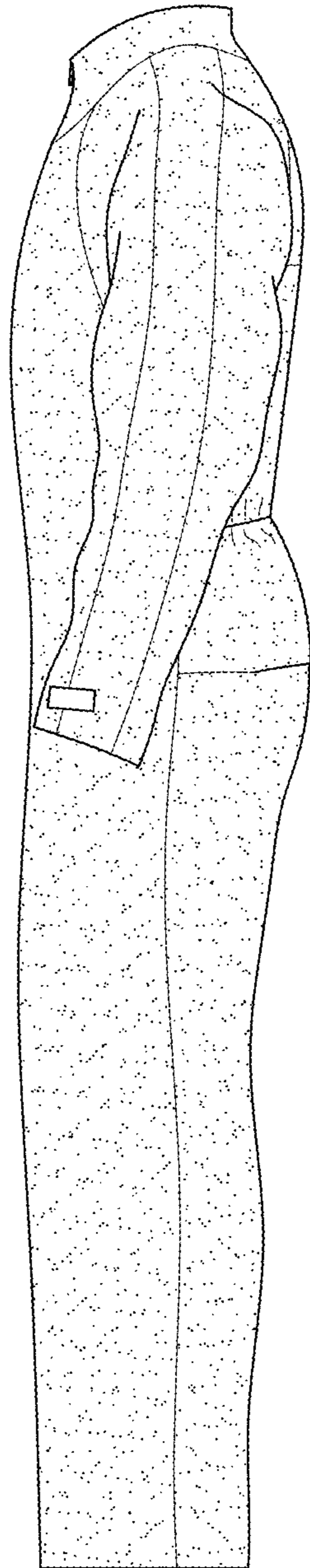

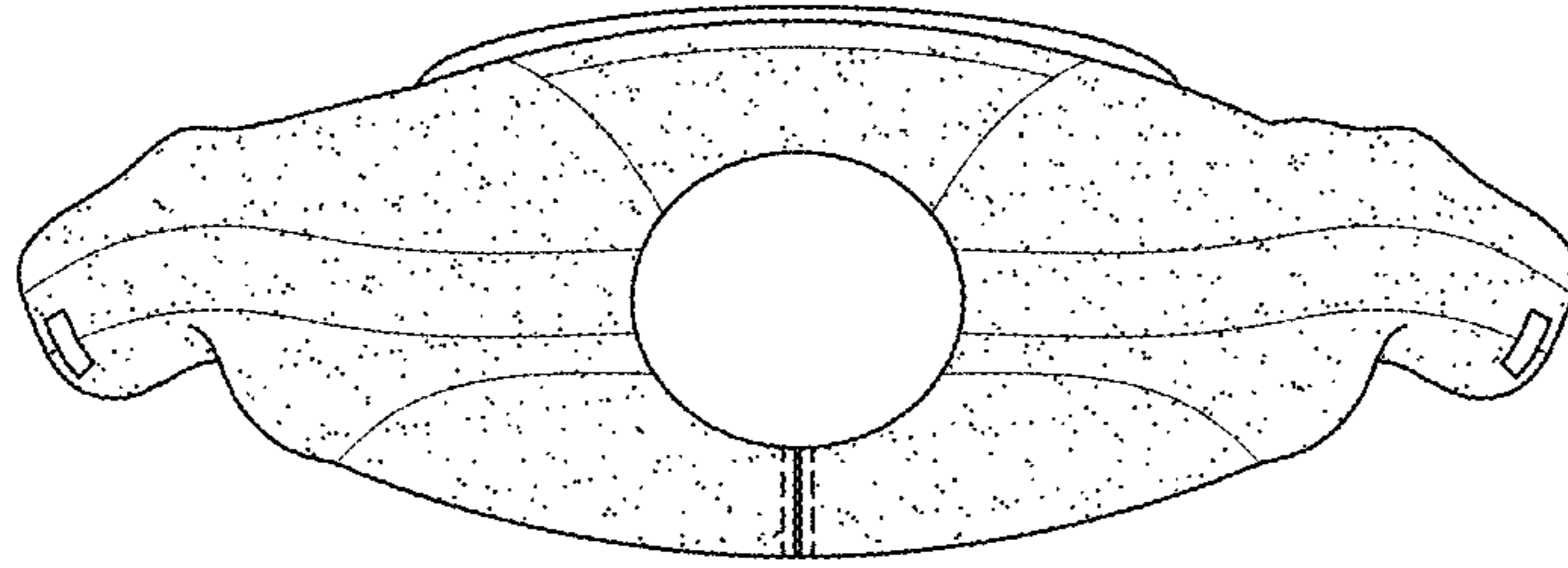

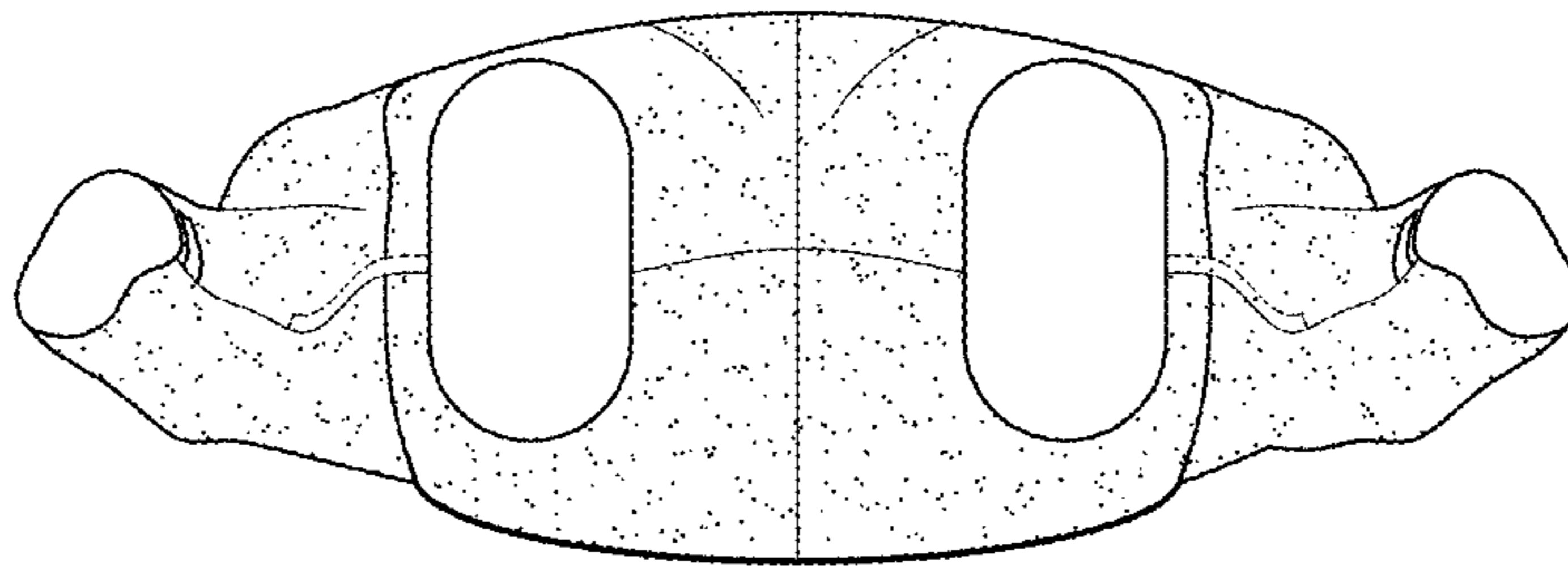

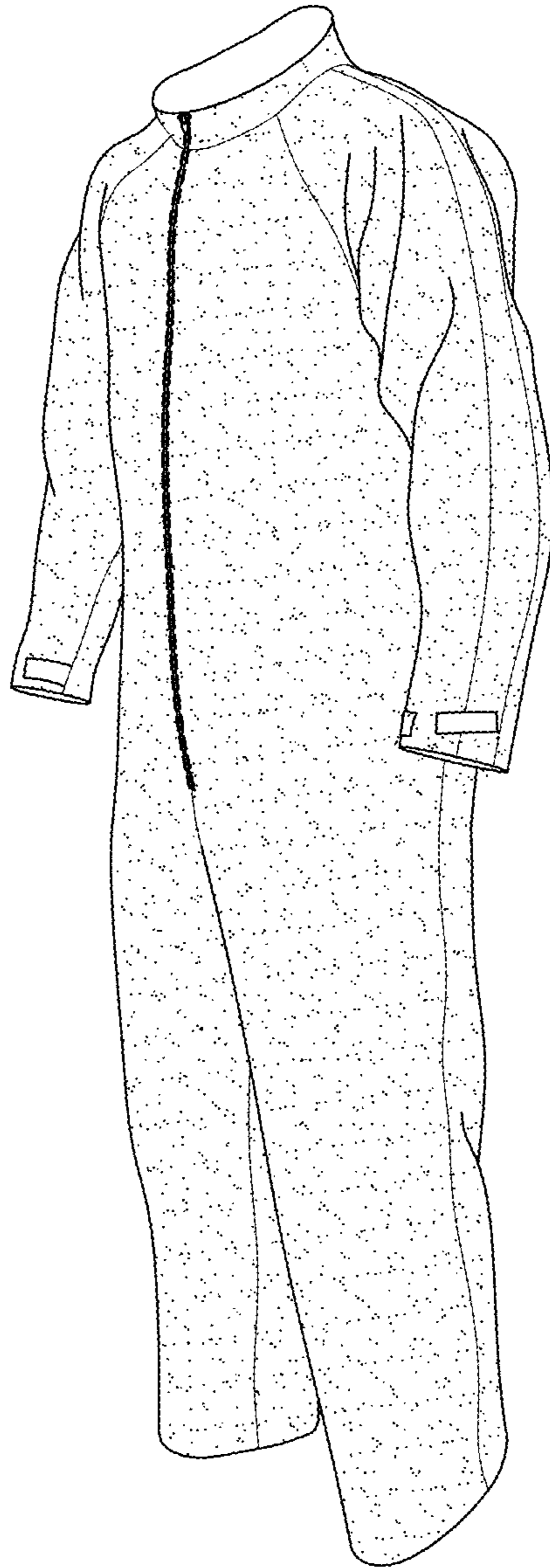

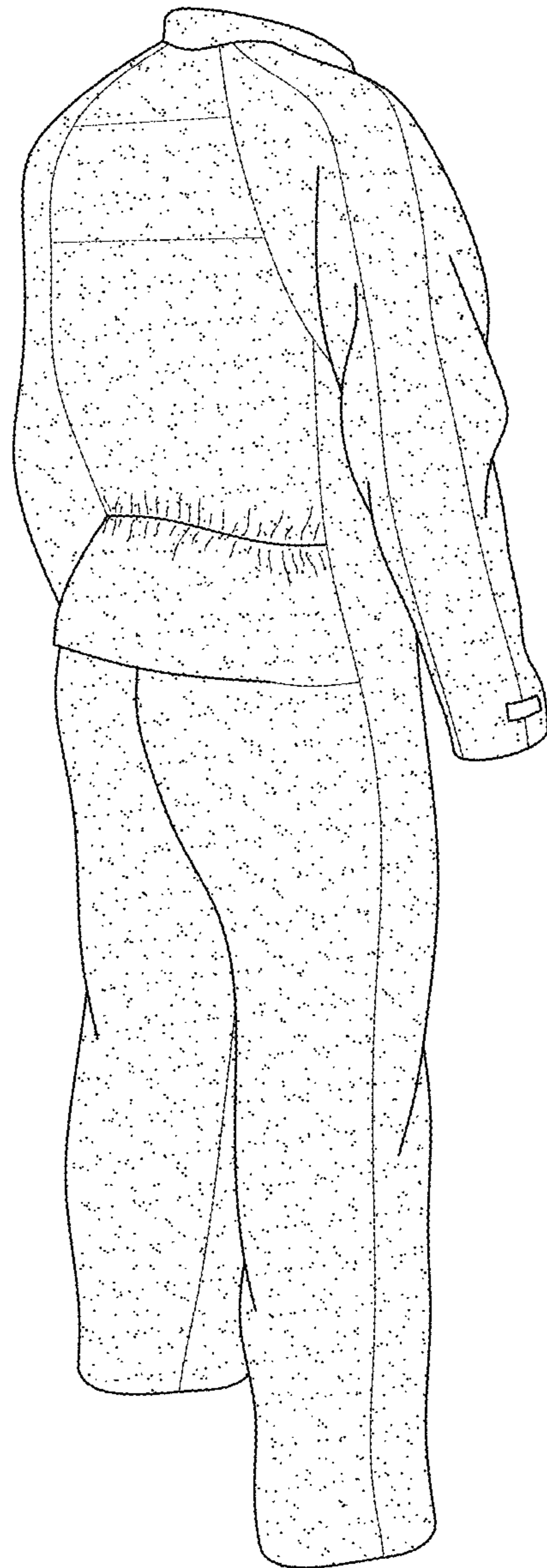
