DESCRIPTION

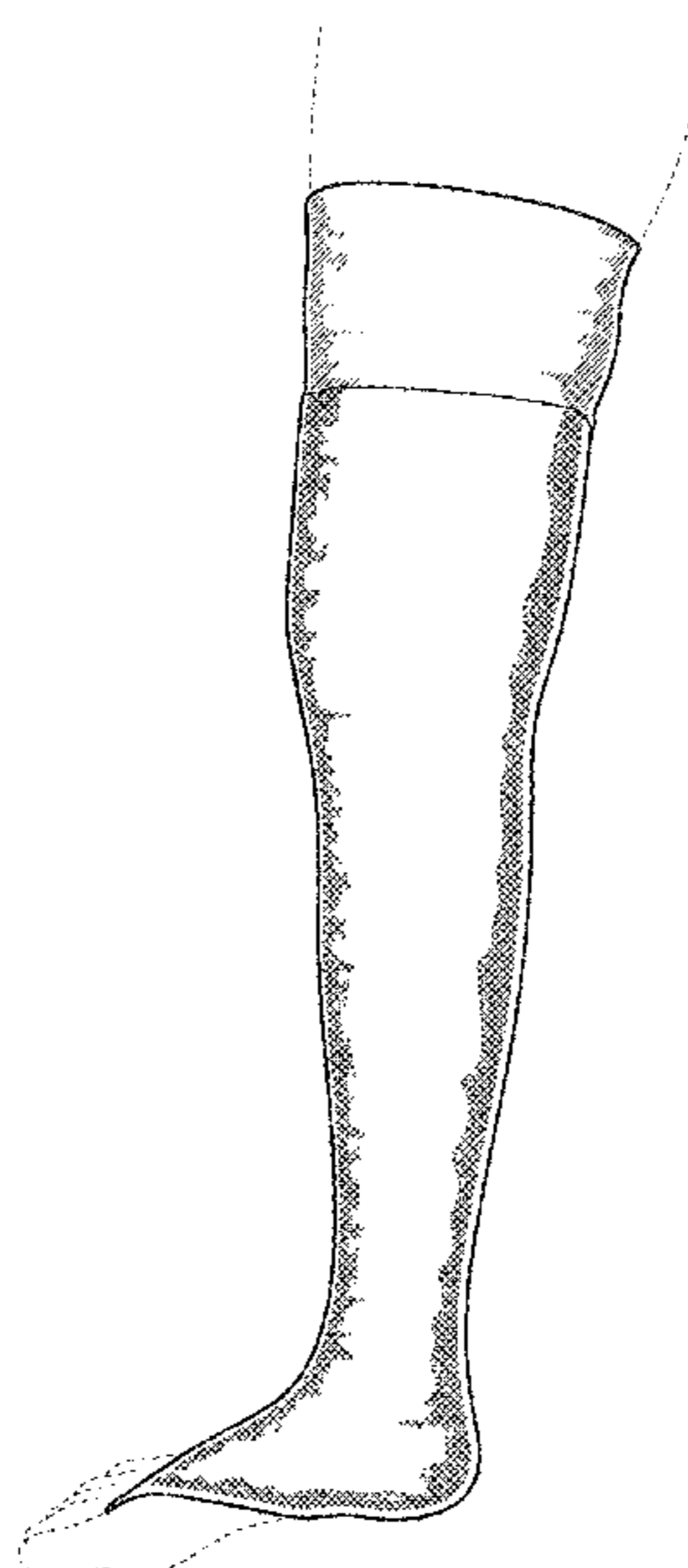
FIG. 1 is a left perspective view of a thigh high foot thong showing our new design;

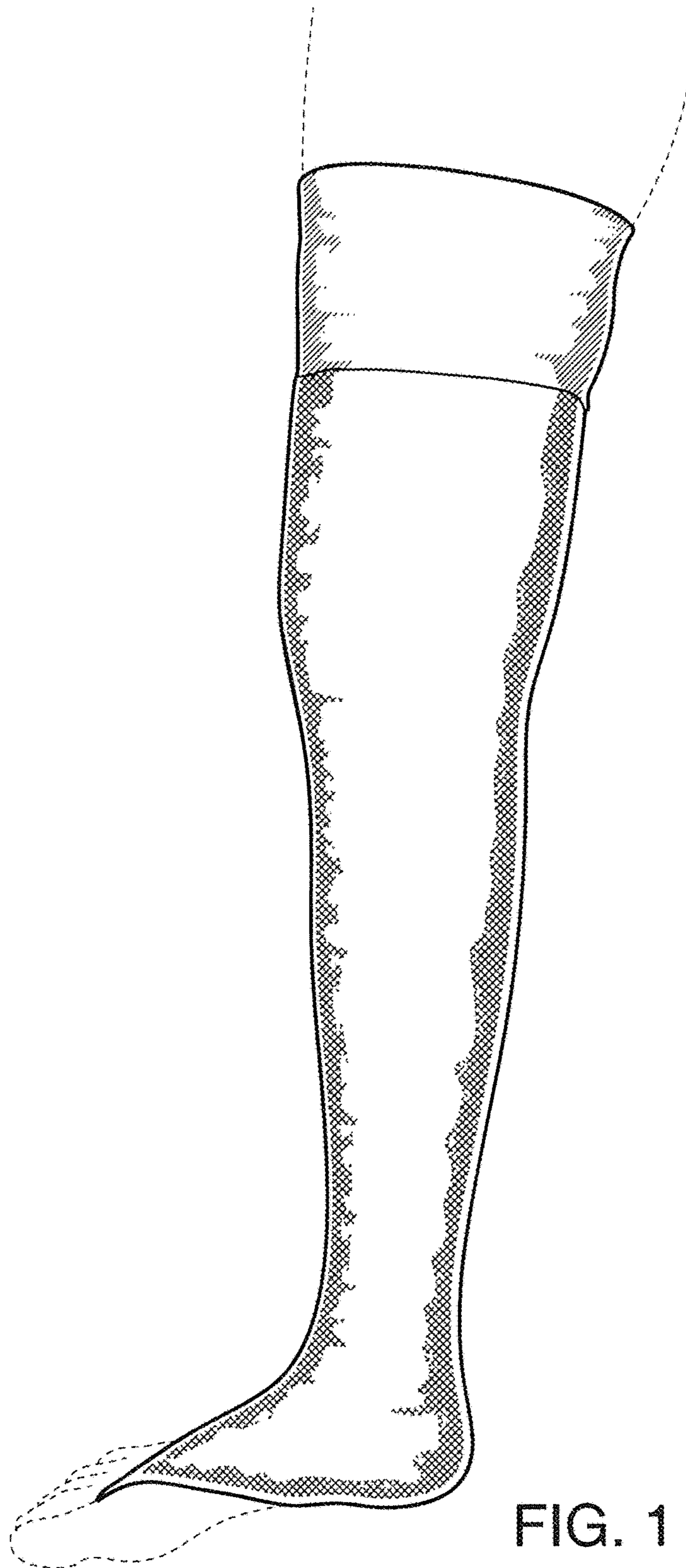

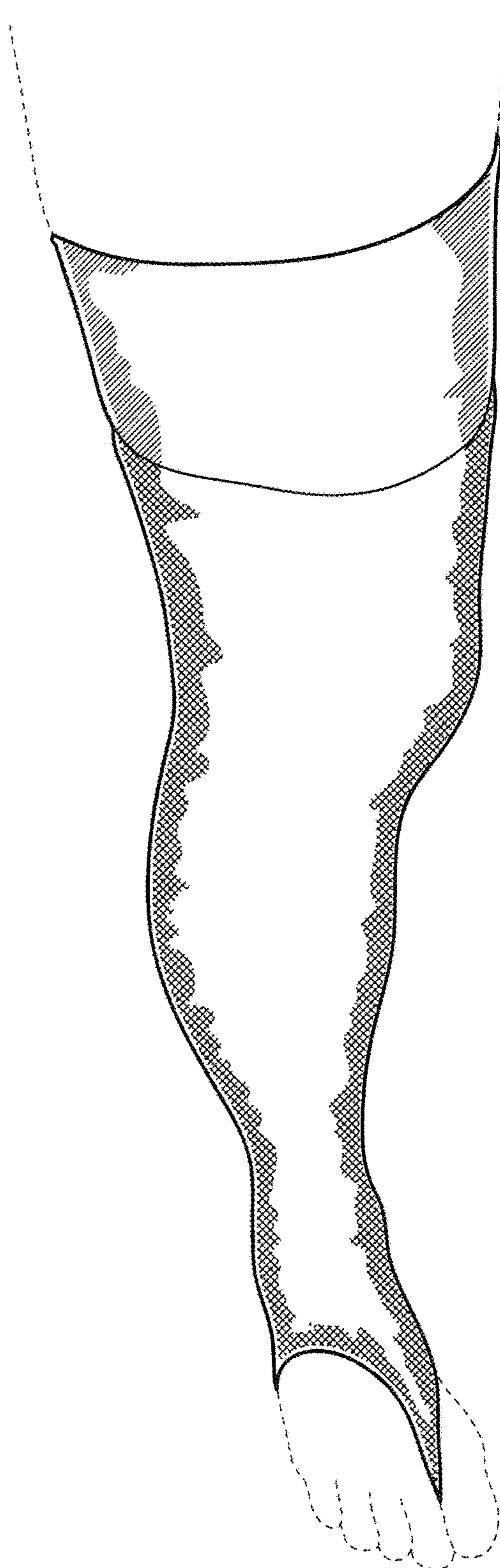

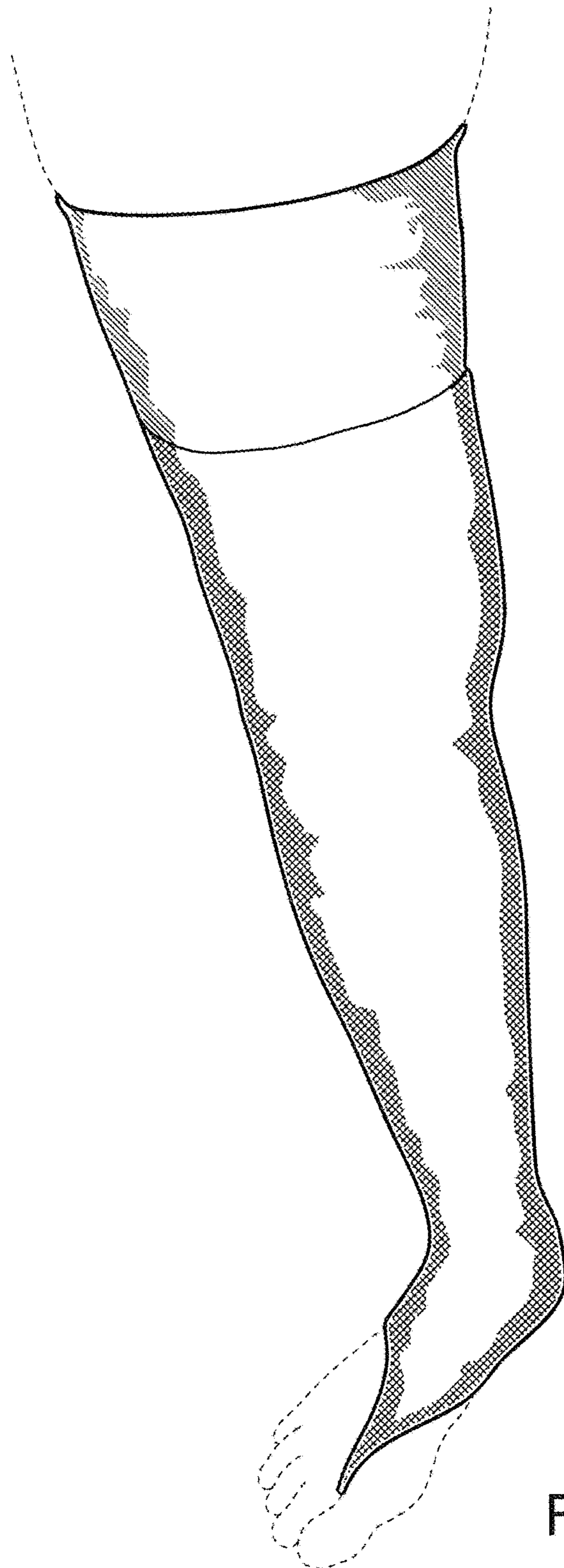

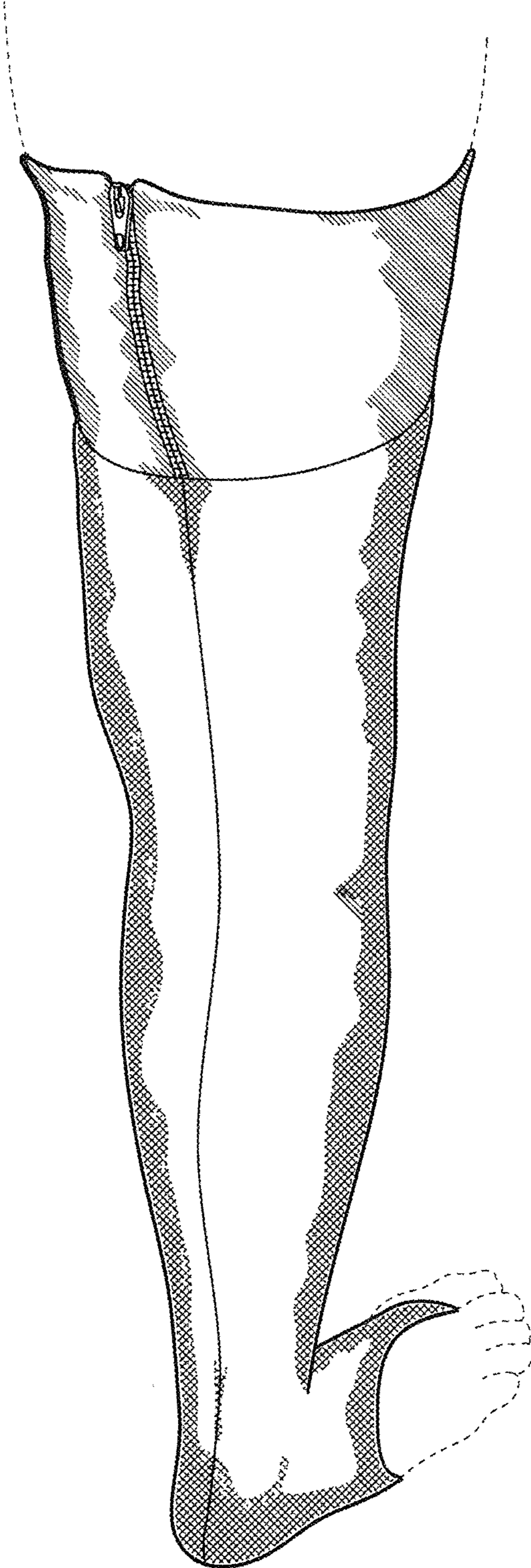

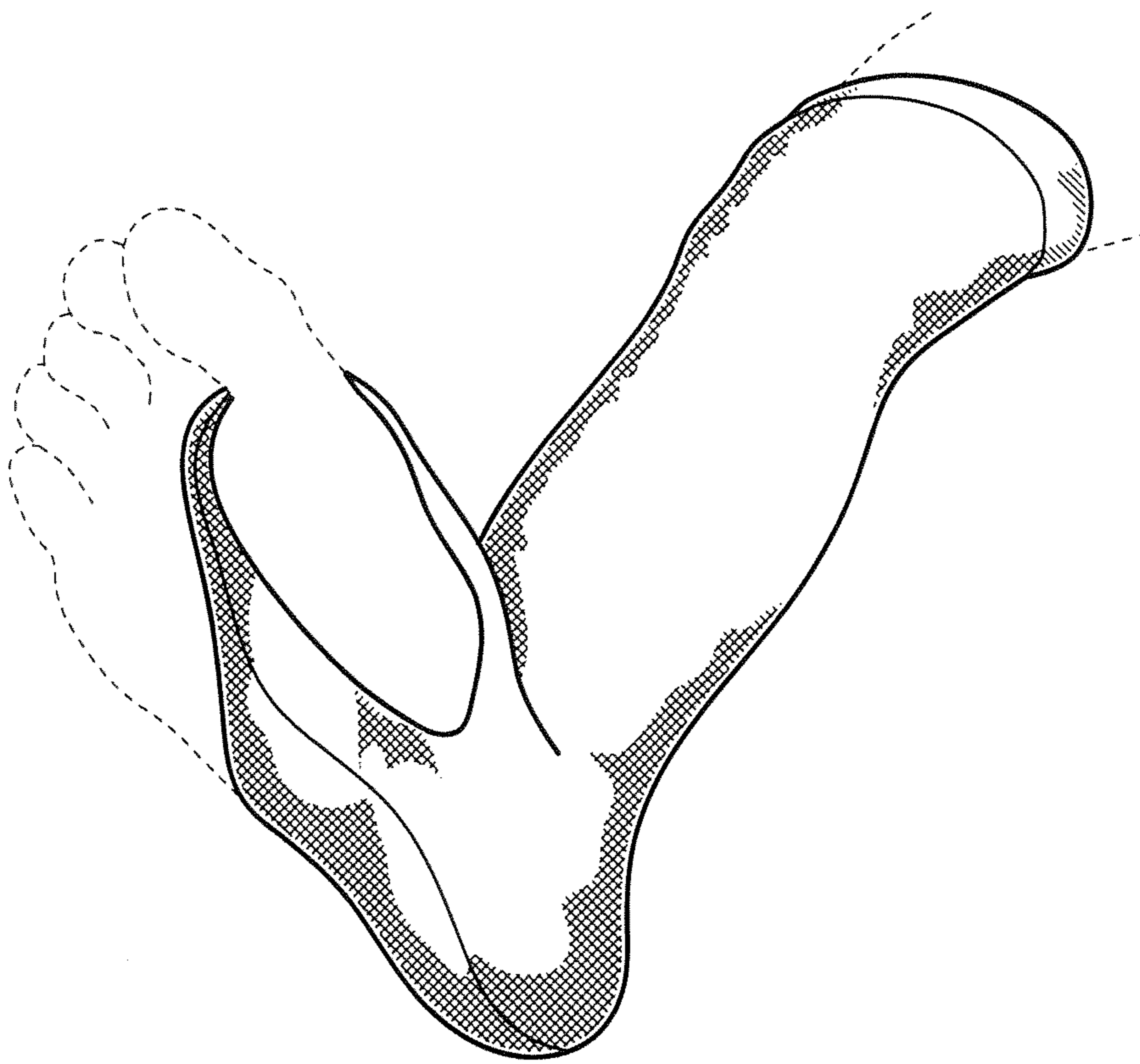

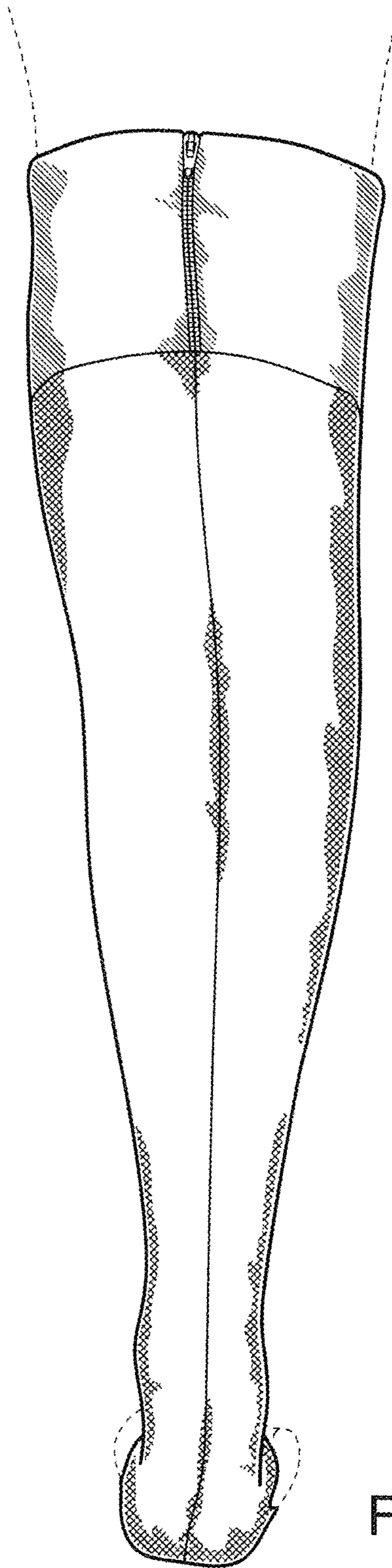

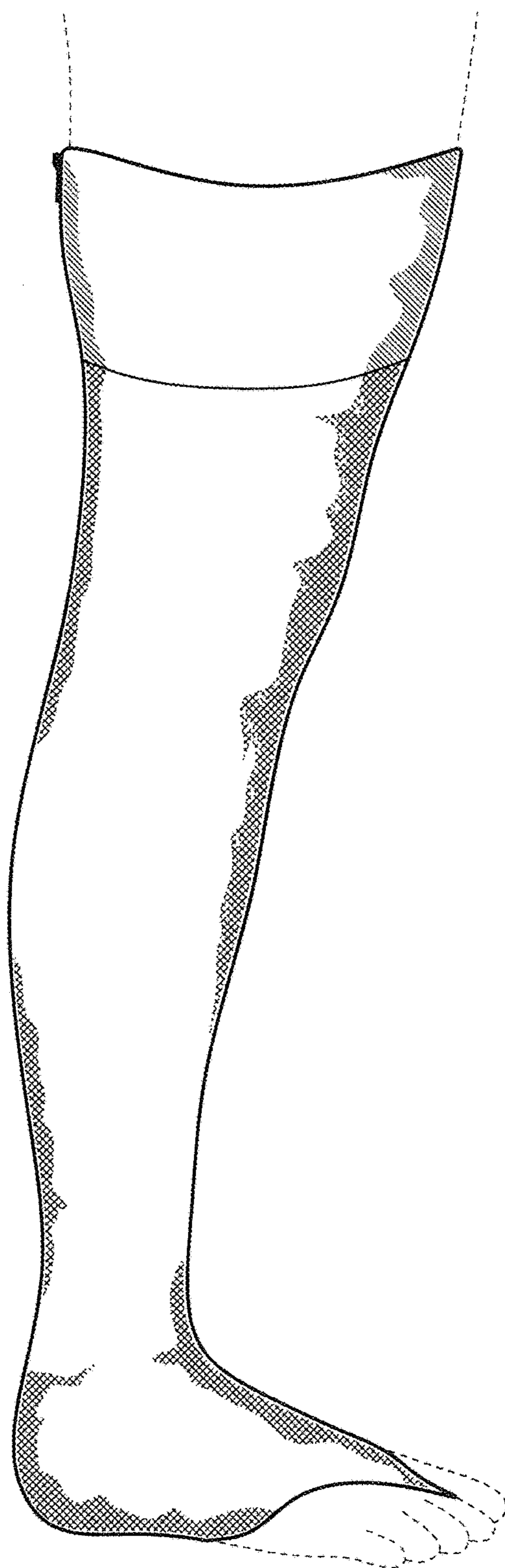
