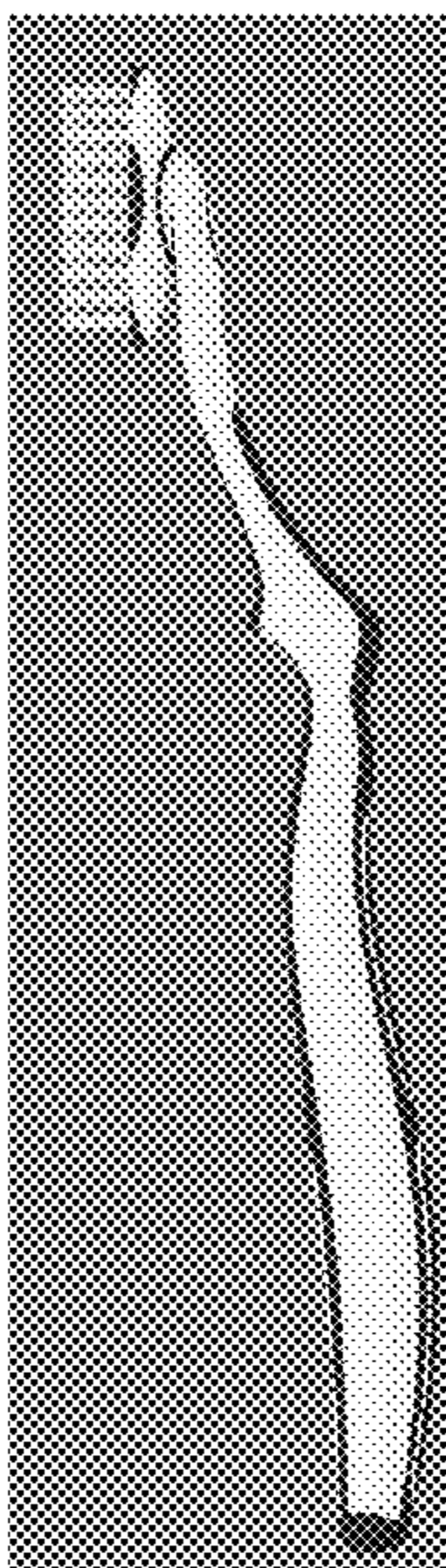
1. Toothbrush

1.1 is a side view;

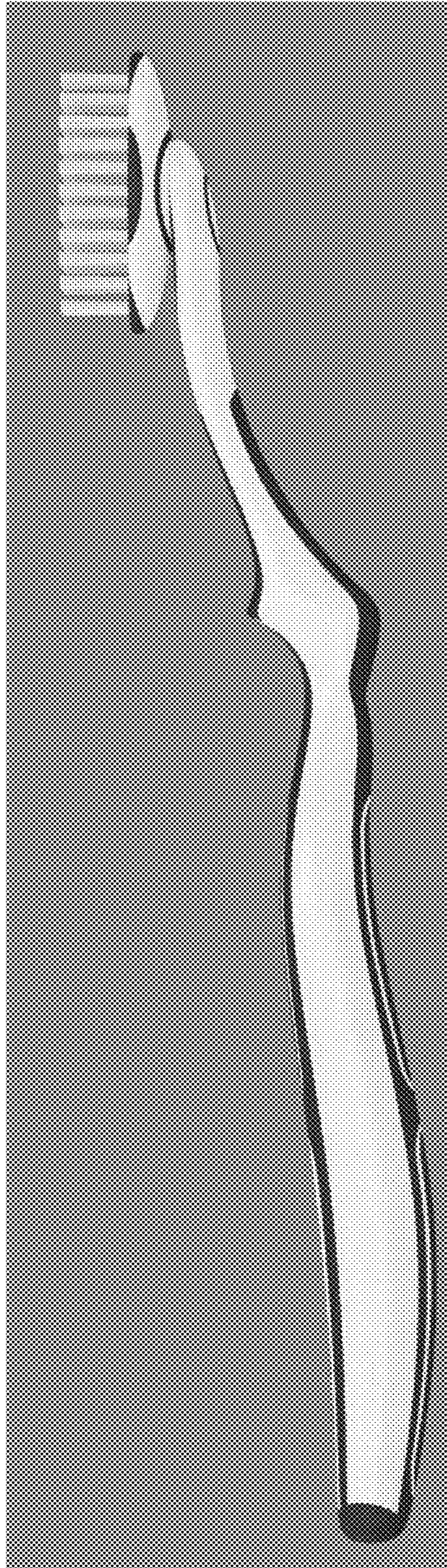
1.2 is a front perspective view, with the head in an alternate position of use, rotated 90°; and

1.3 is another front perspective view.

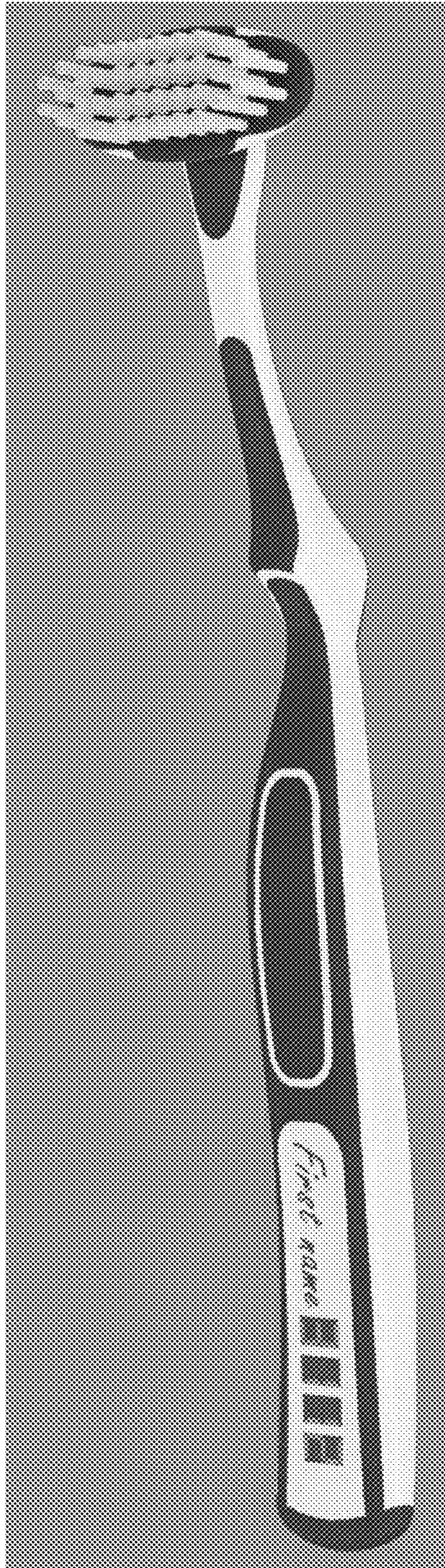
