The ornamental design for a sheet document with security element, as shown and described.

DESCRIPTION

FIG. 1 is a top view of a first embodiment of a sheet document with security element;

FIG. 2 is an enlarged detail view of area 2 circumscribed within FIG. 1;

FIG. 3 is a top view of a second embodiment of a sheet document with security element;

FIG. 4 is an enlarged detail view of area 4 circumscribed within FIG. 3;

FIG. 5 is a top view of a third embodiment of a sheet document with security element;

FIG. 6 is an enlarged detail view of area 6 circumscribed within FIG. 5;

FIG. 7 is a top view of a fourth embodiment of a sheet document with security element;

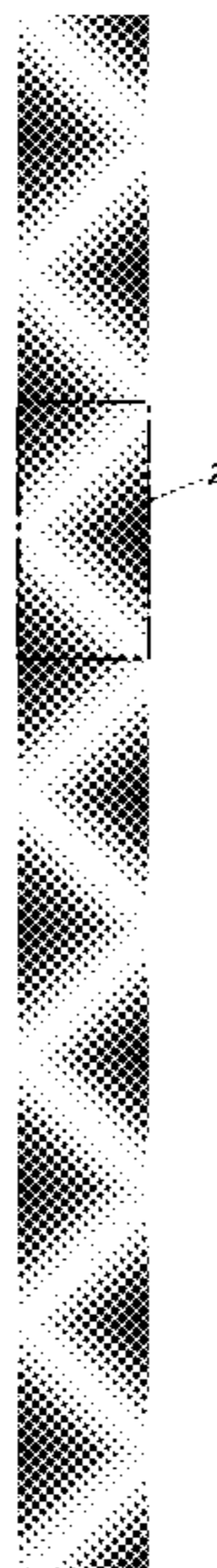
FIG. 8 is an enlarged detail view of area 8 circumscribed within FIG. 7;

FIG. 9 is a top view of a fifth embodiment of a sheet document with security element; and,

FIG. 10 is an enlarged detail view of area 10 circumscribed within FIG. 9.

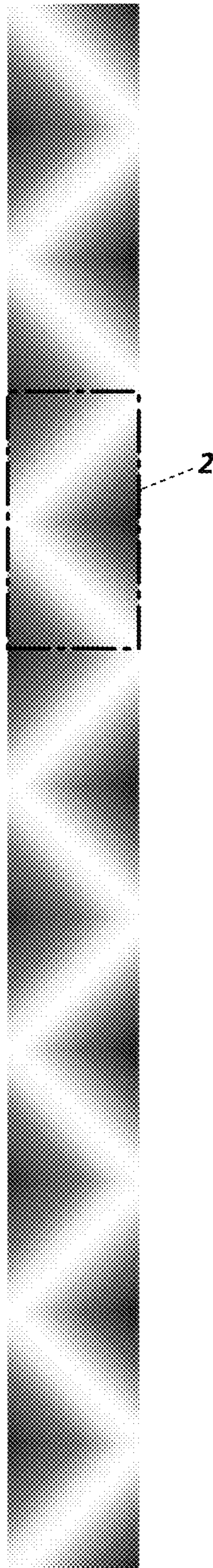

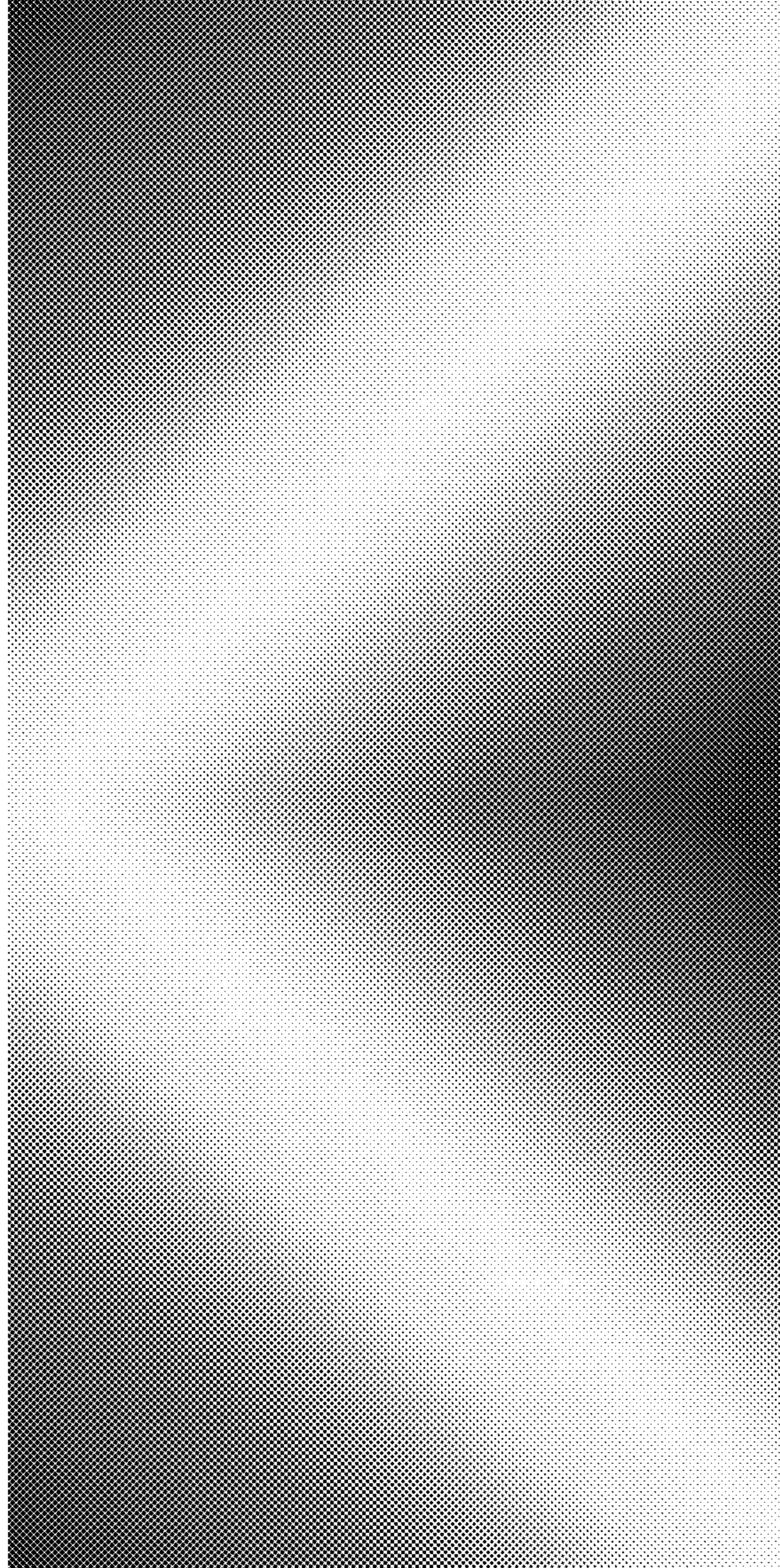

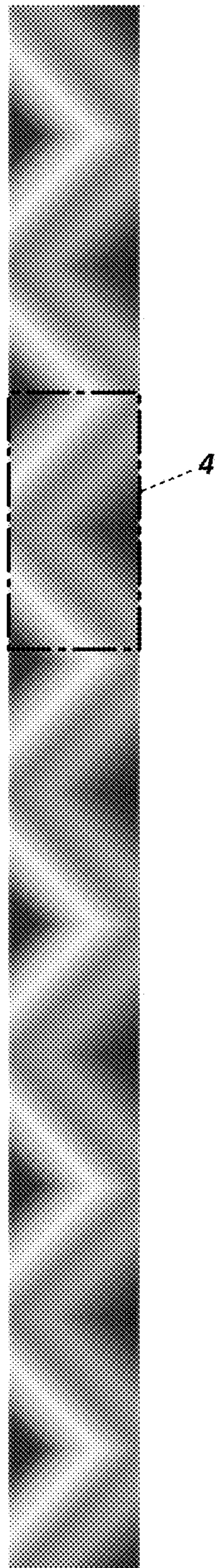

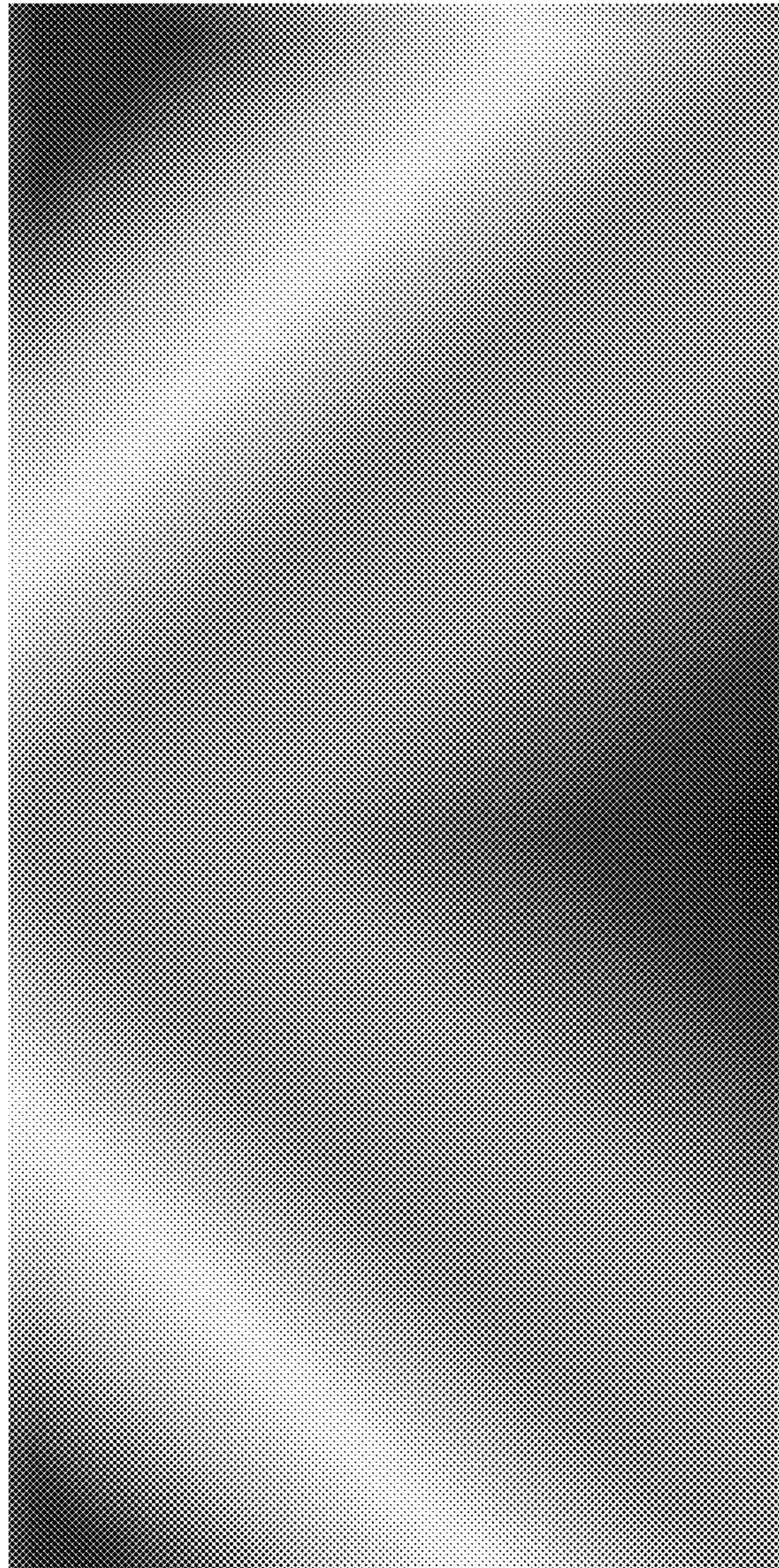

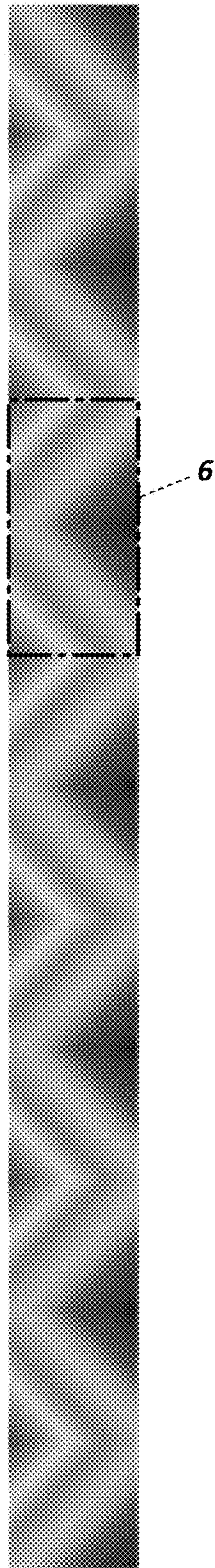

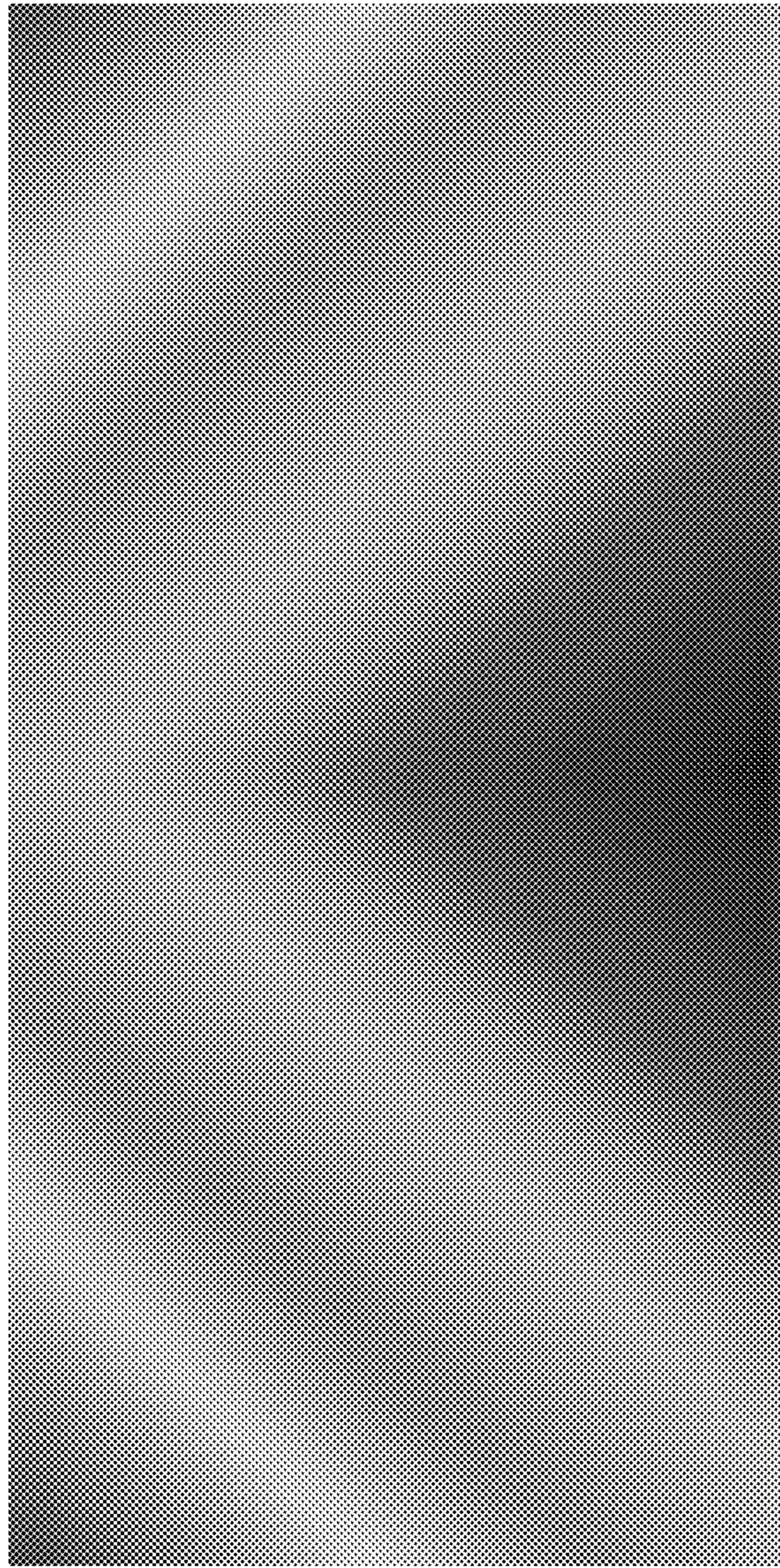

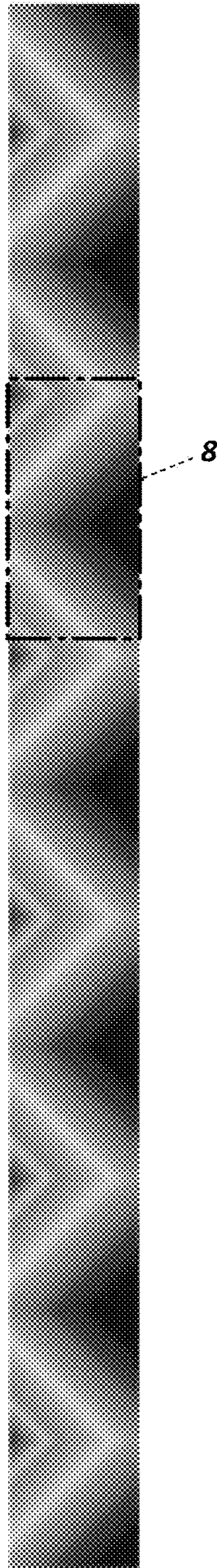

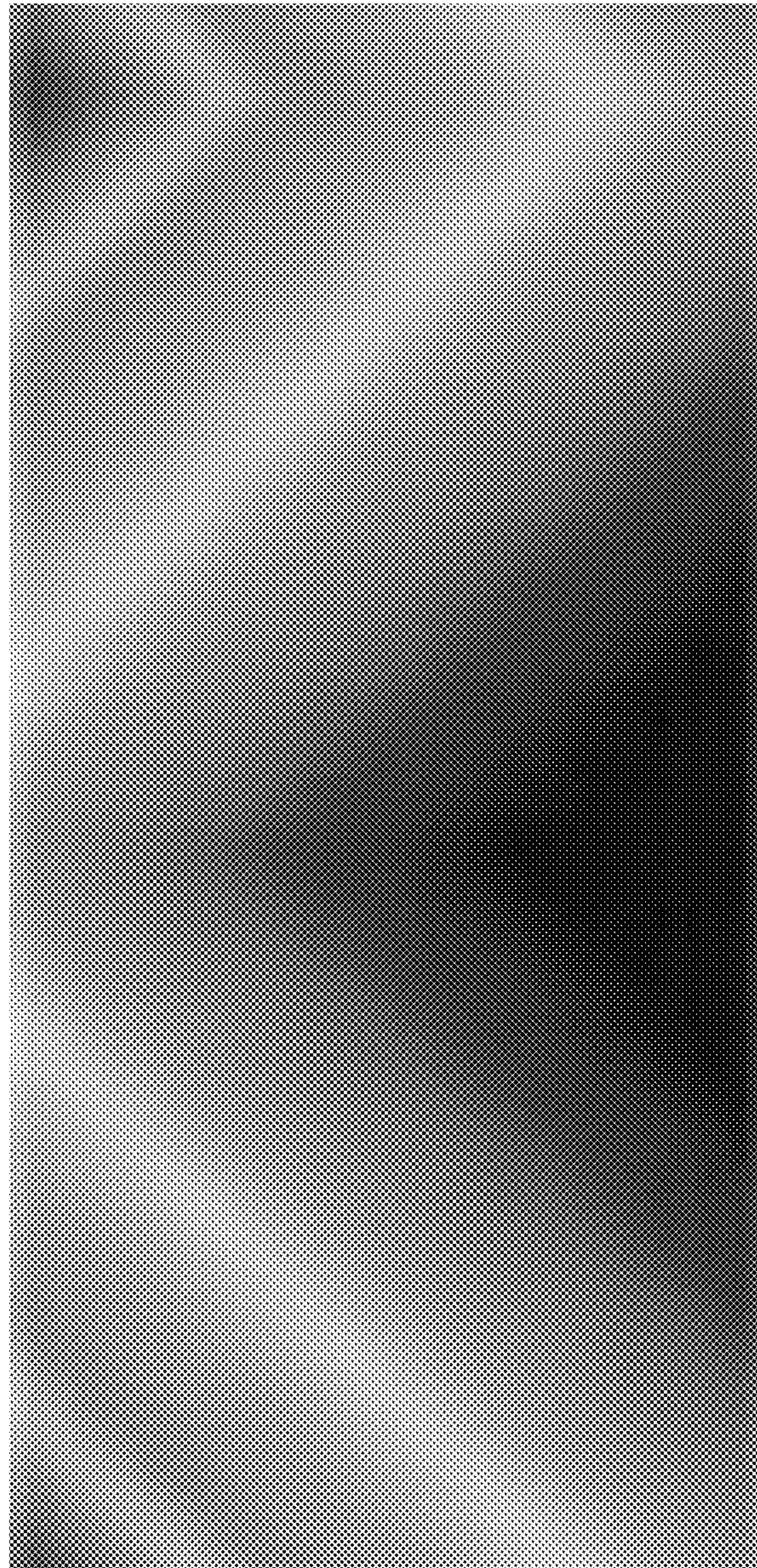

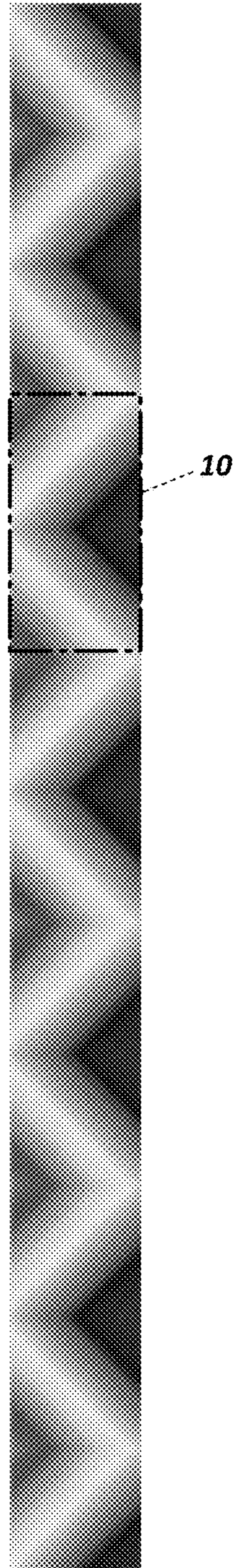

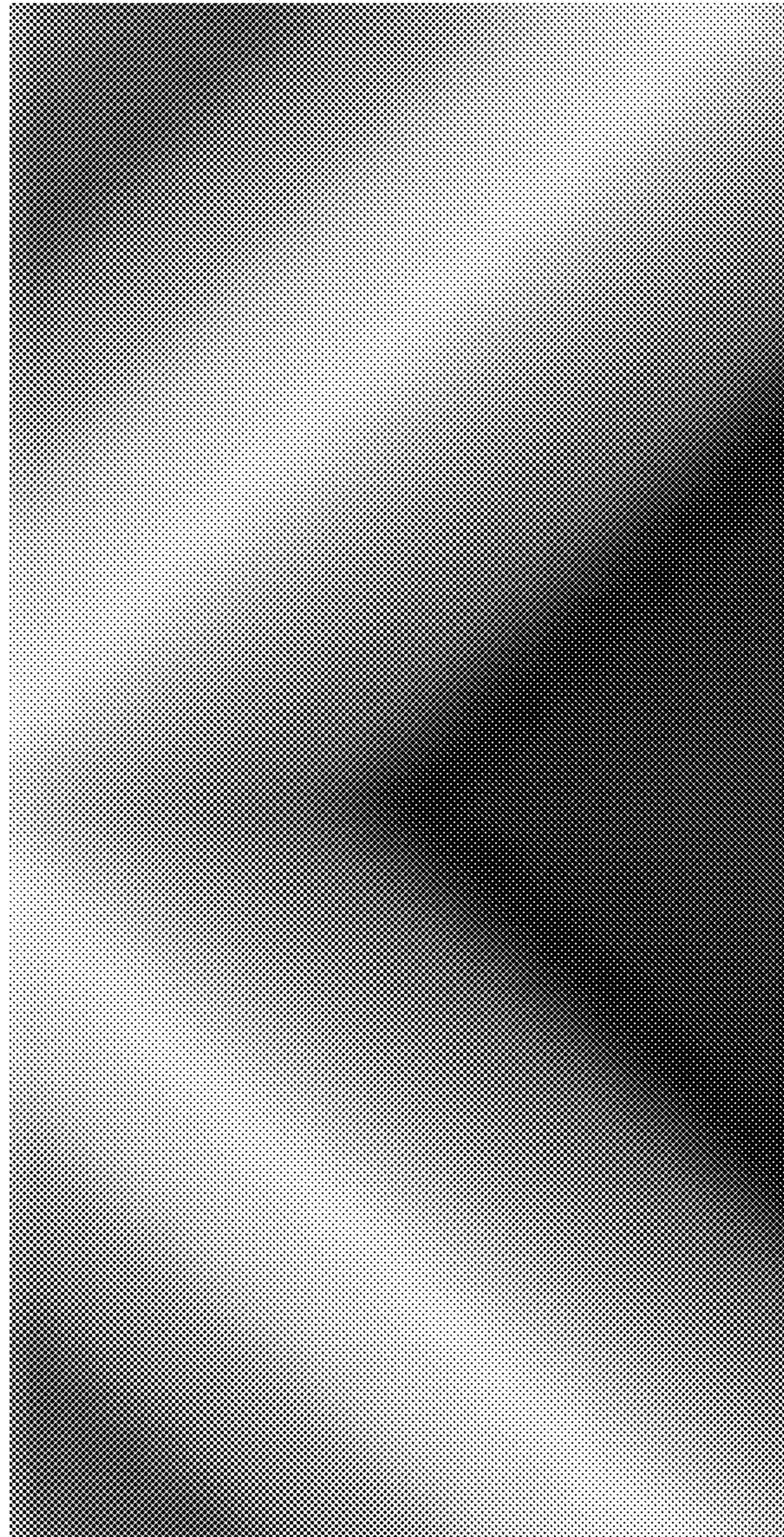
