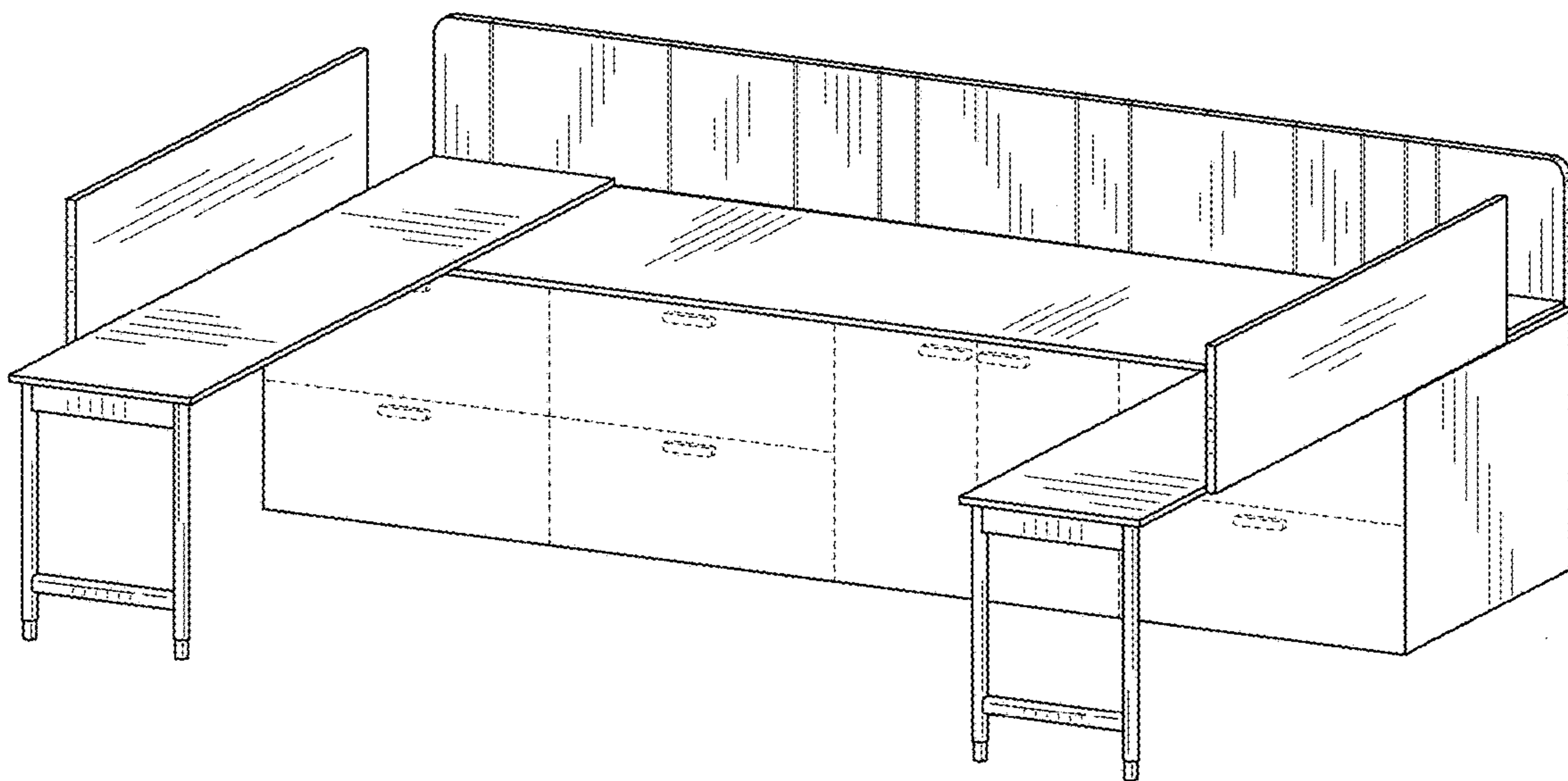
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the workstation; FIG. 2 is a front elevational view of the workstation; FIG. 3 is a rear elevational view of the workstation; FIG. 4 is a left side elevational view of the workstation; FIG. 5 is a right side elevational view of the workstation; FIG. 6 is a top plan view of the workstation; and, FIG. 7 is a bottom plan view of the workstation. The broken lines in the figures represent portions of the workstation which form no part of the claim.

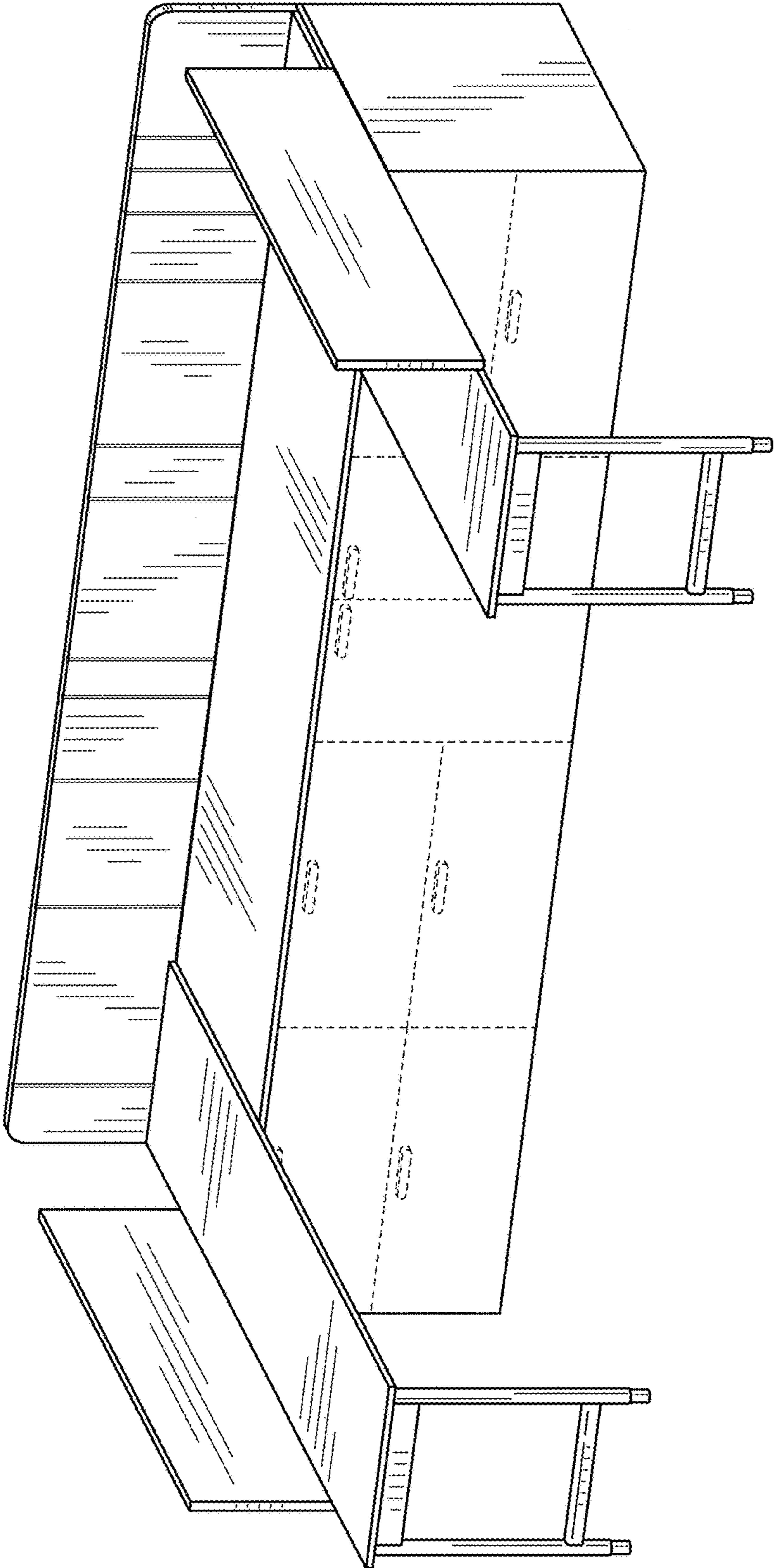

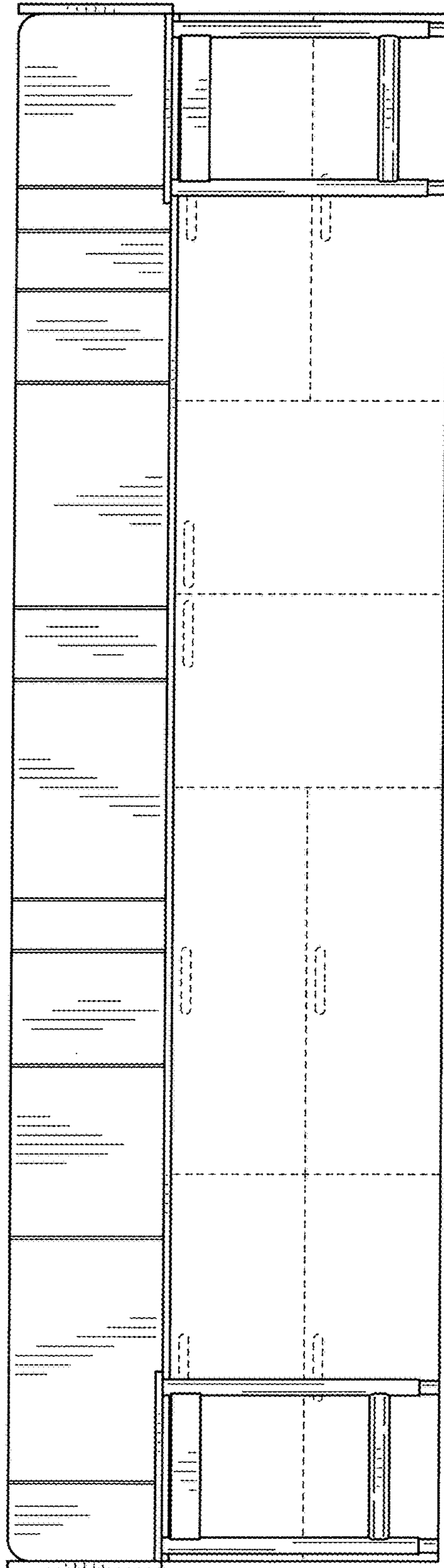

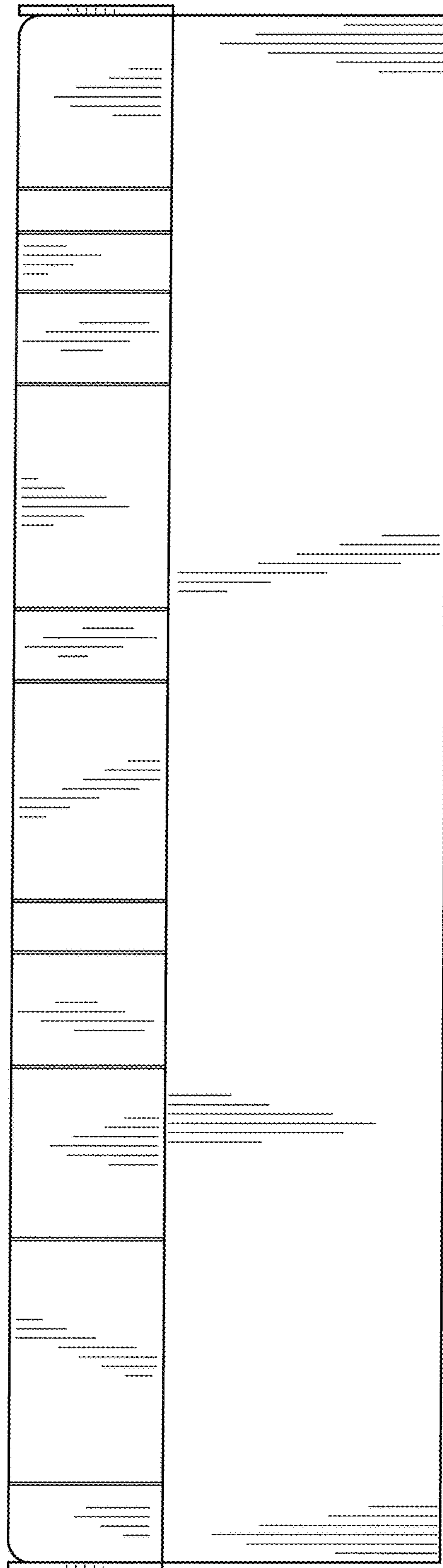

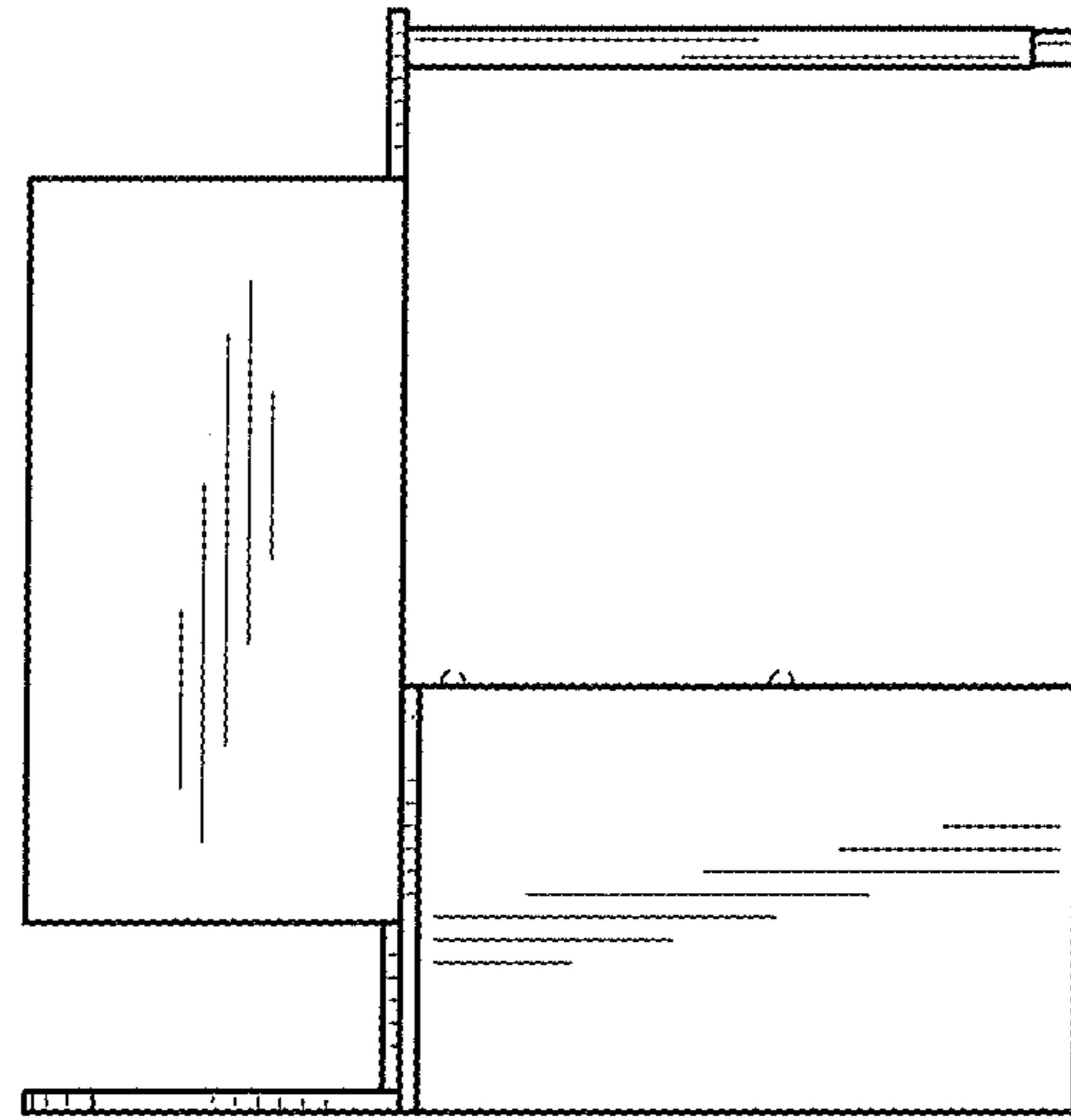

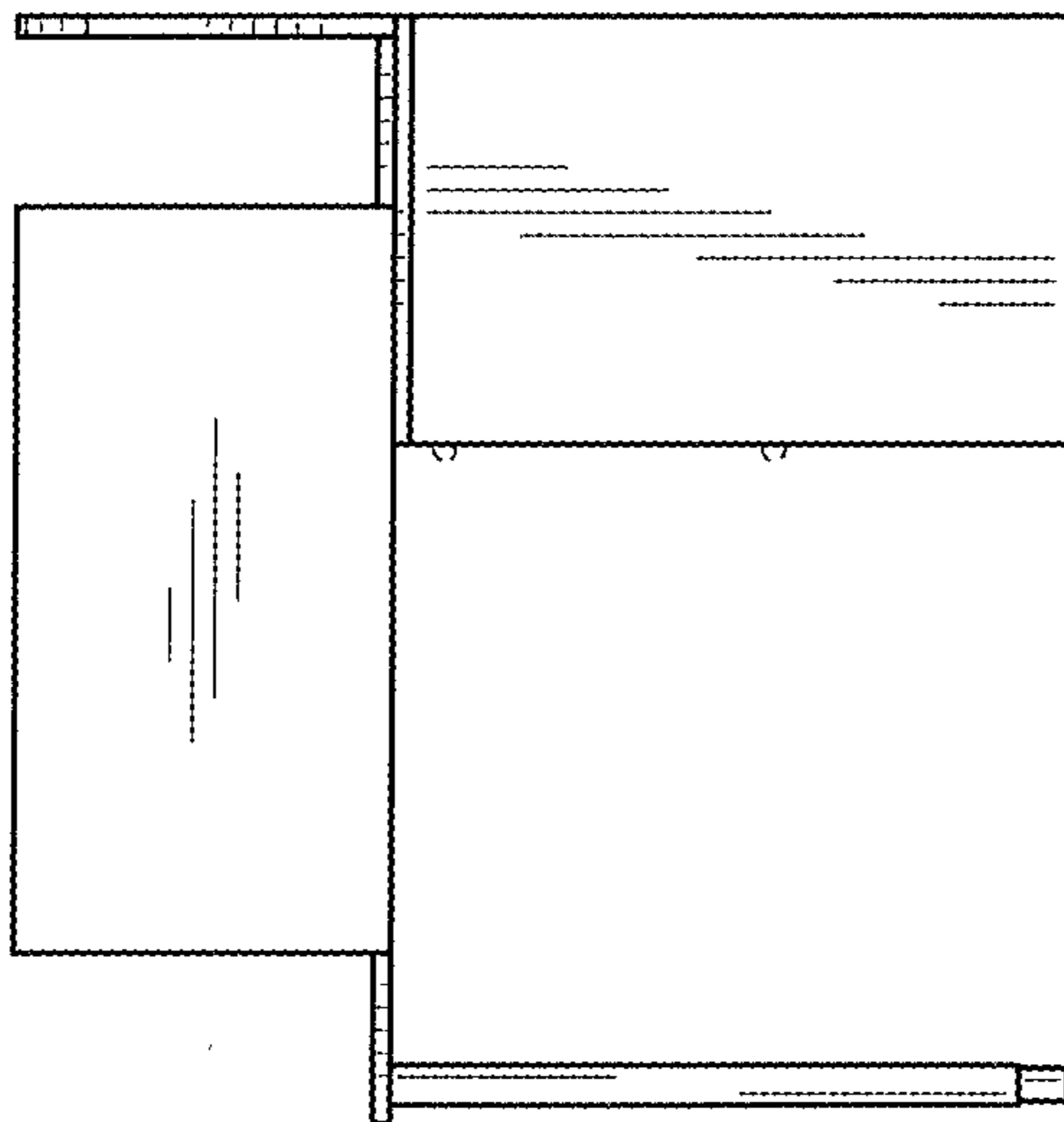

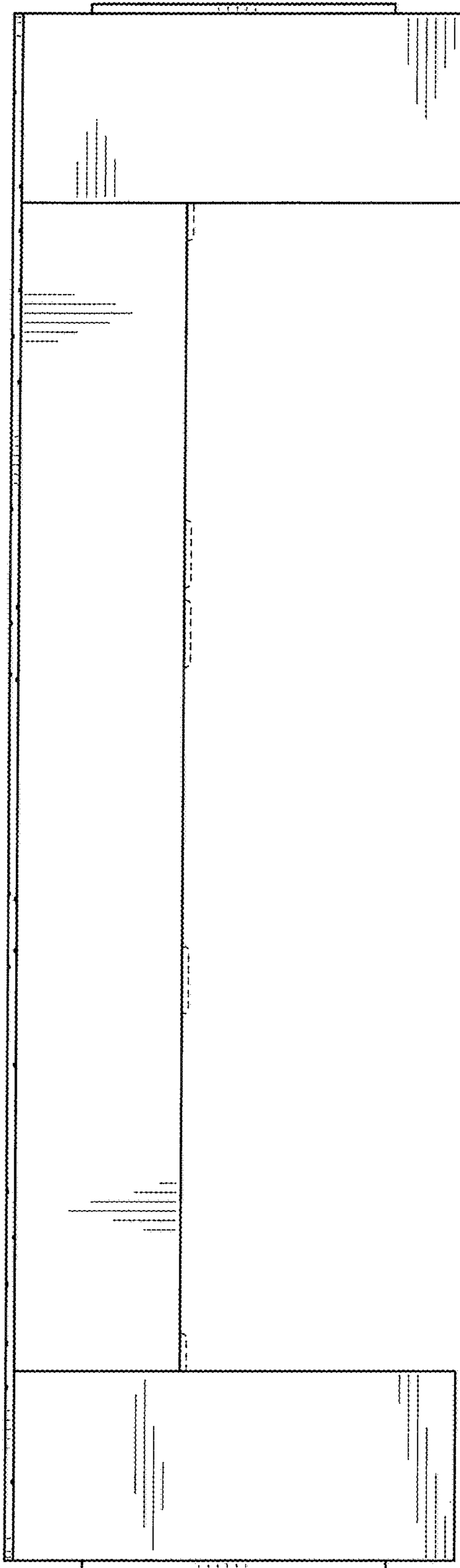

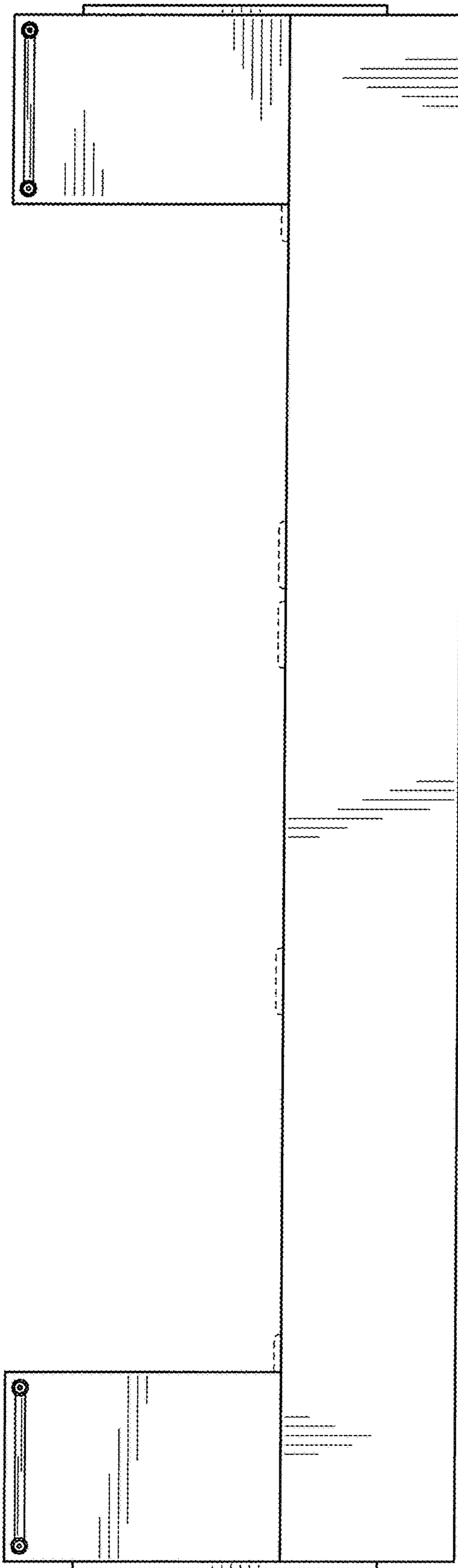
