(57) **CLAIM**

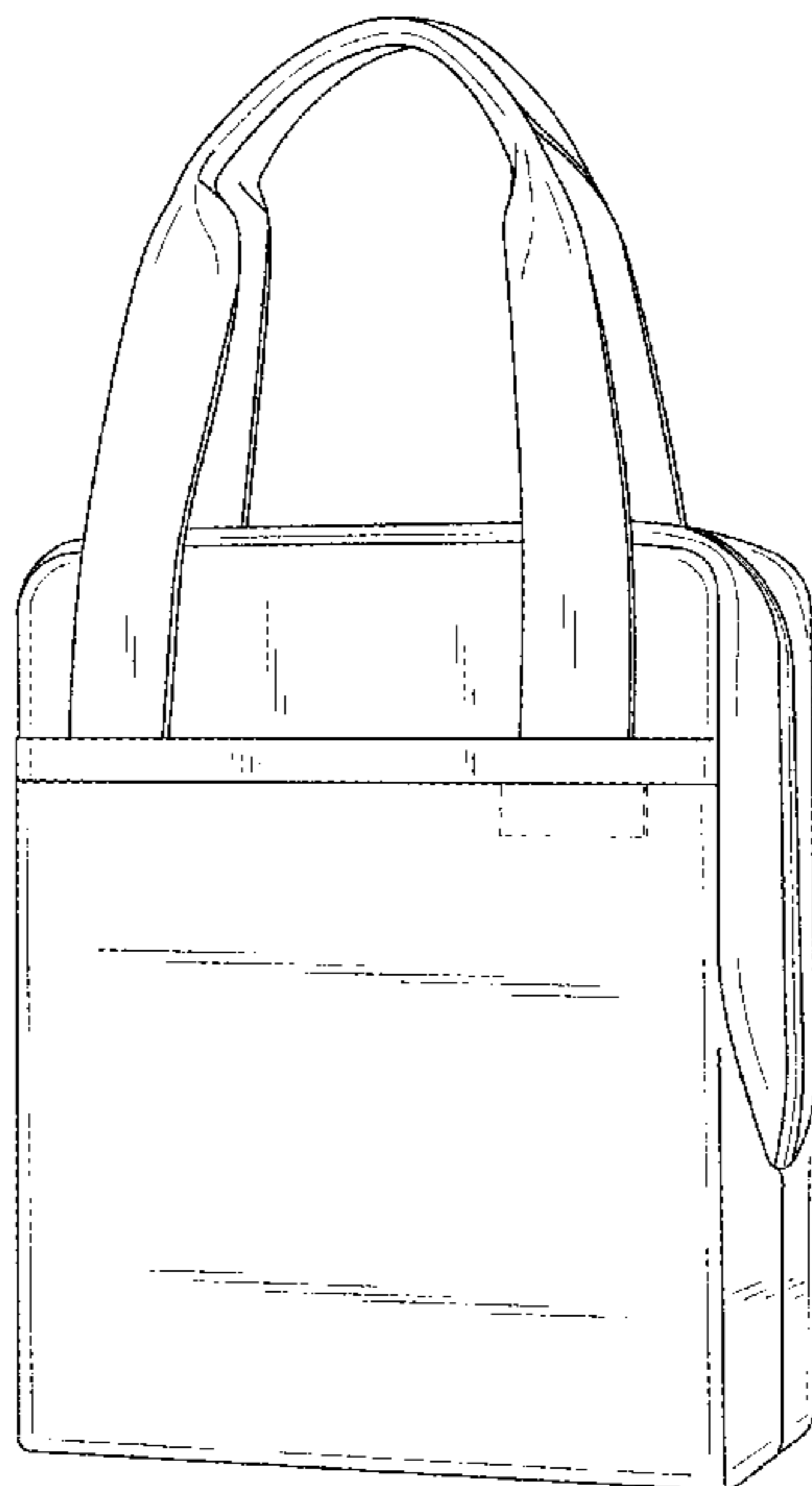
The ornamental design for a lunch bag, as shown and described.

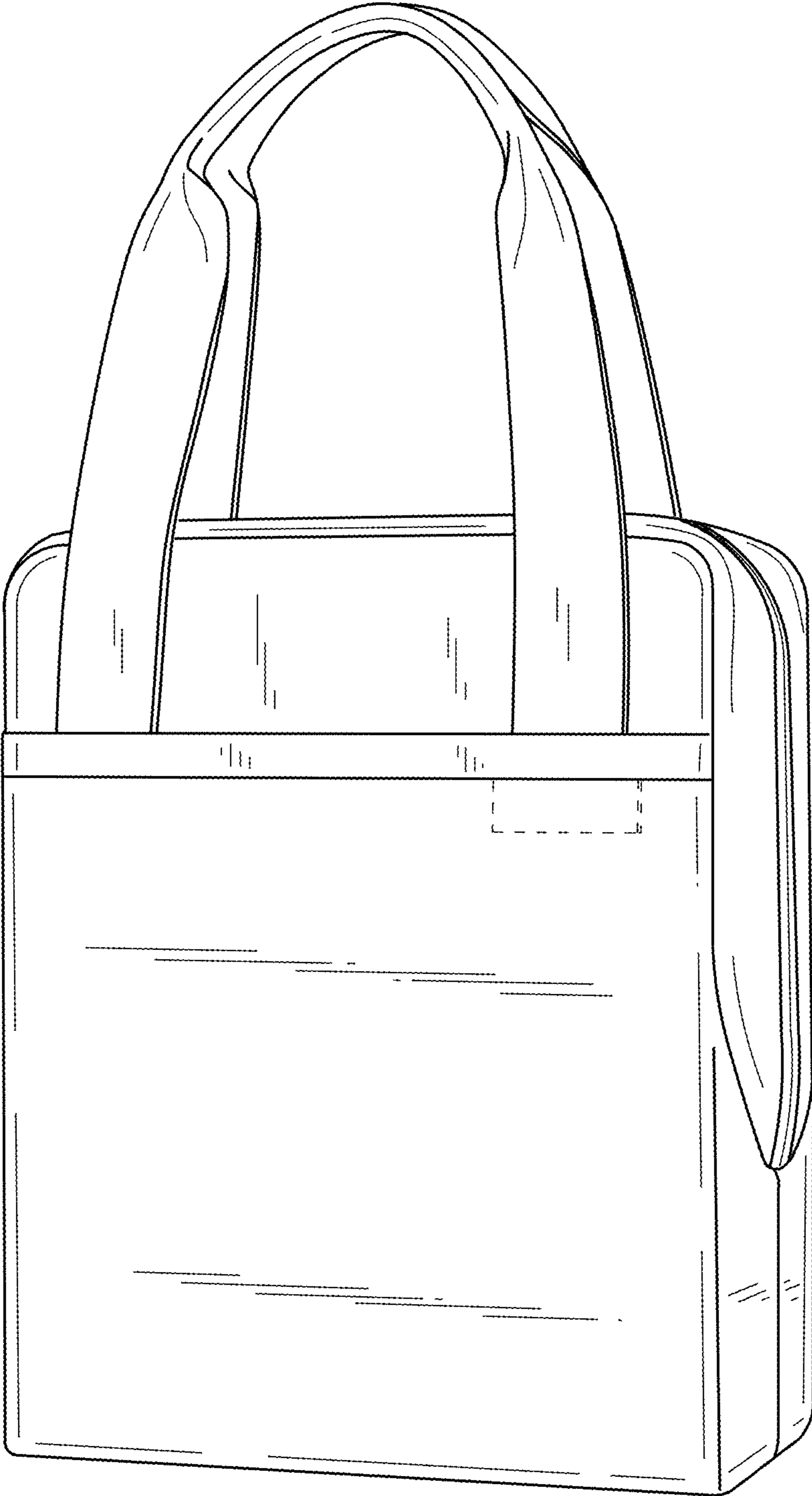

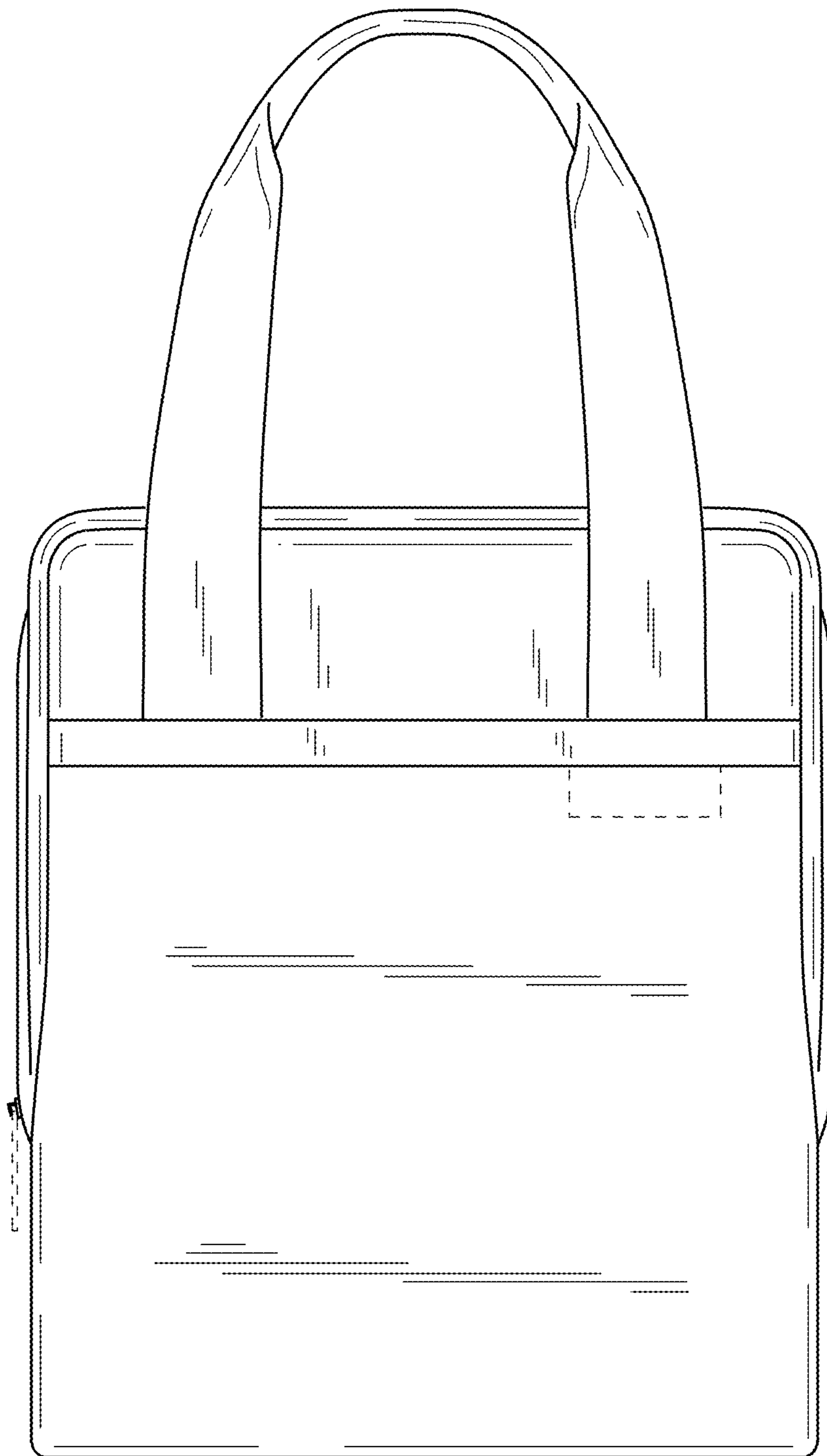

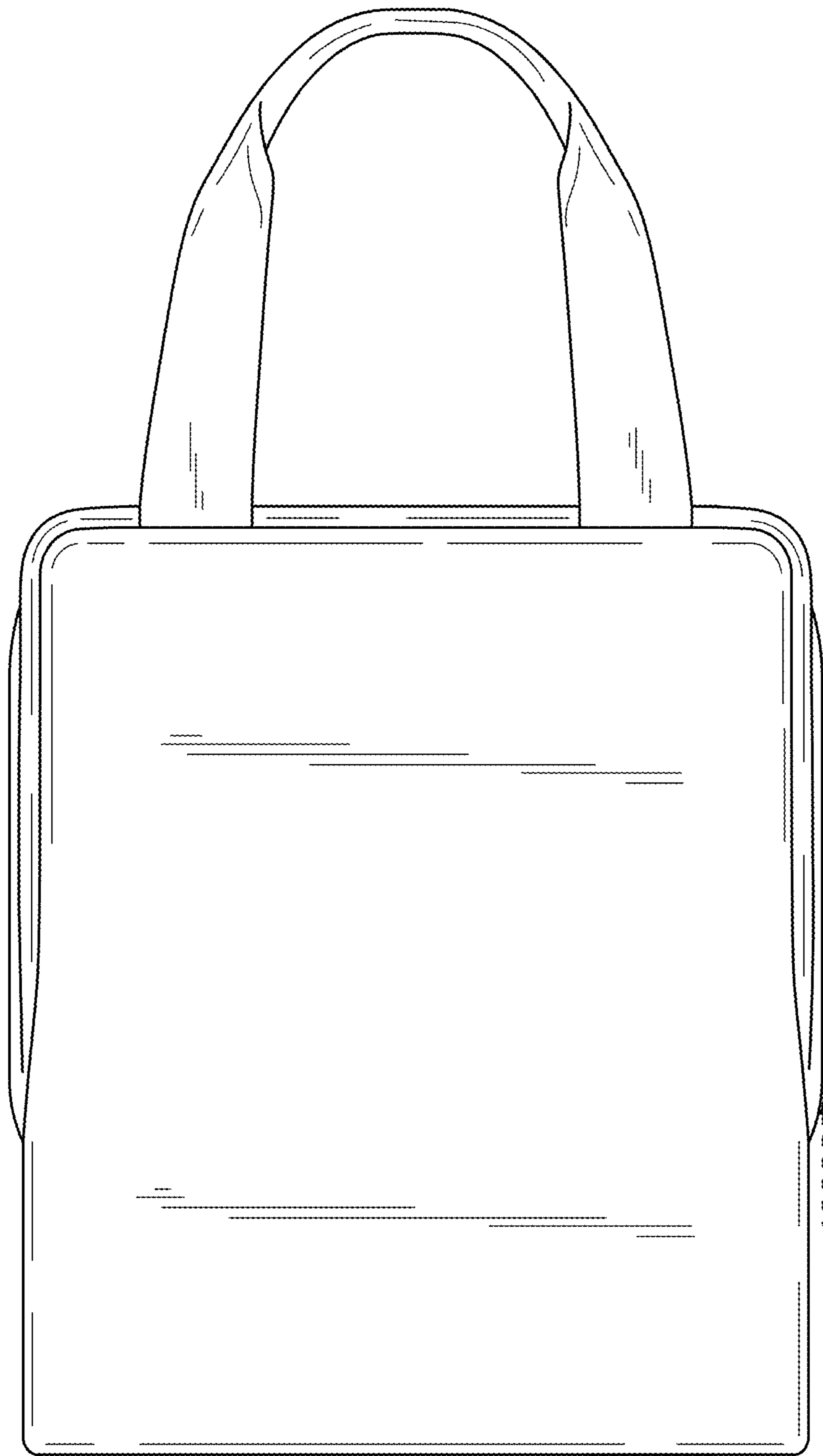

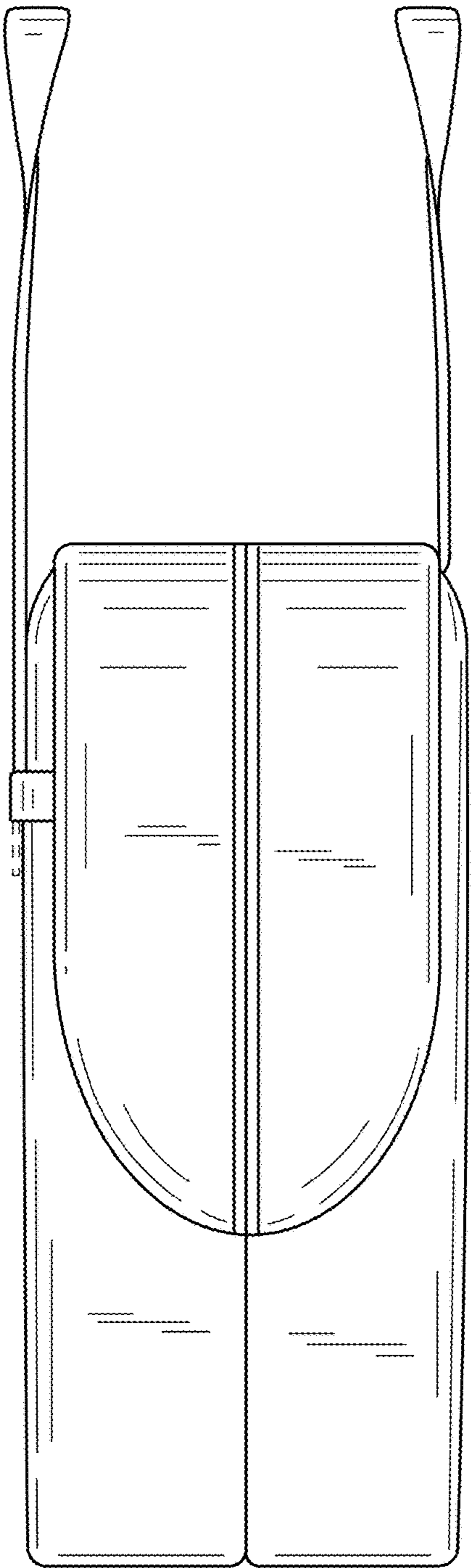

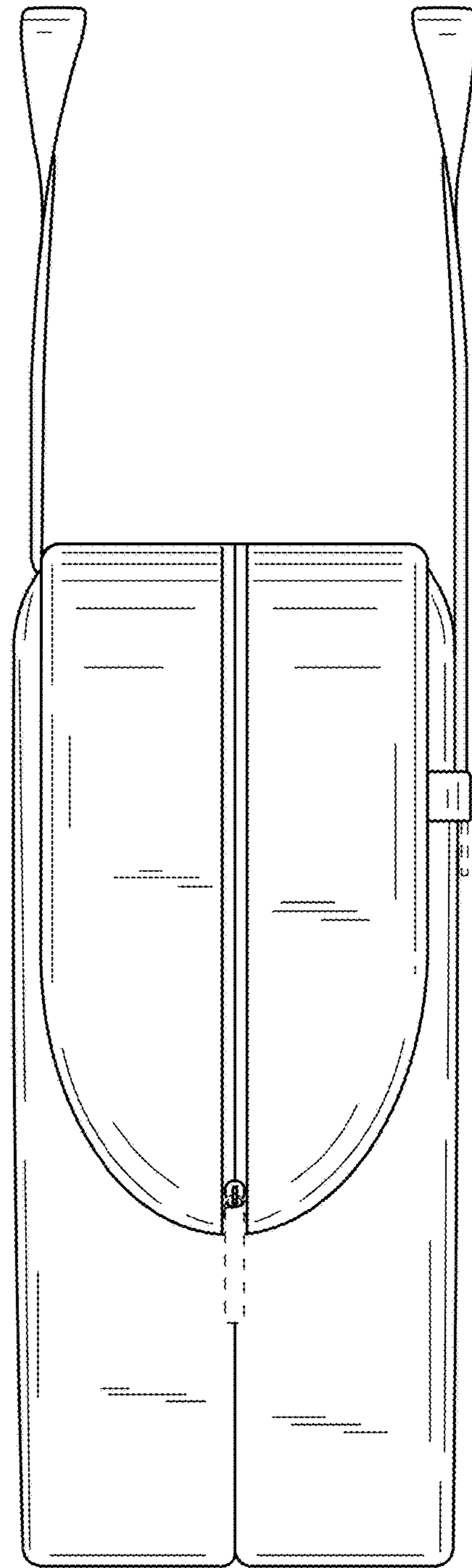

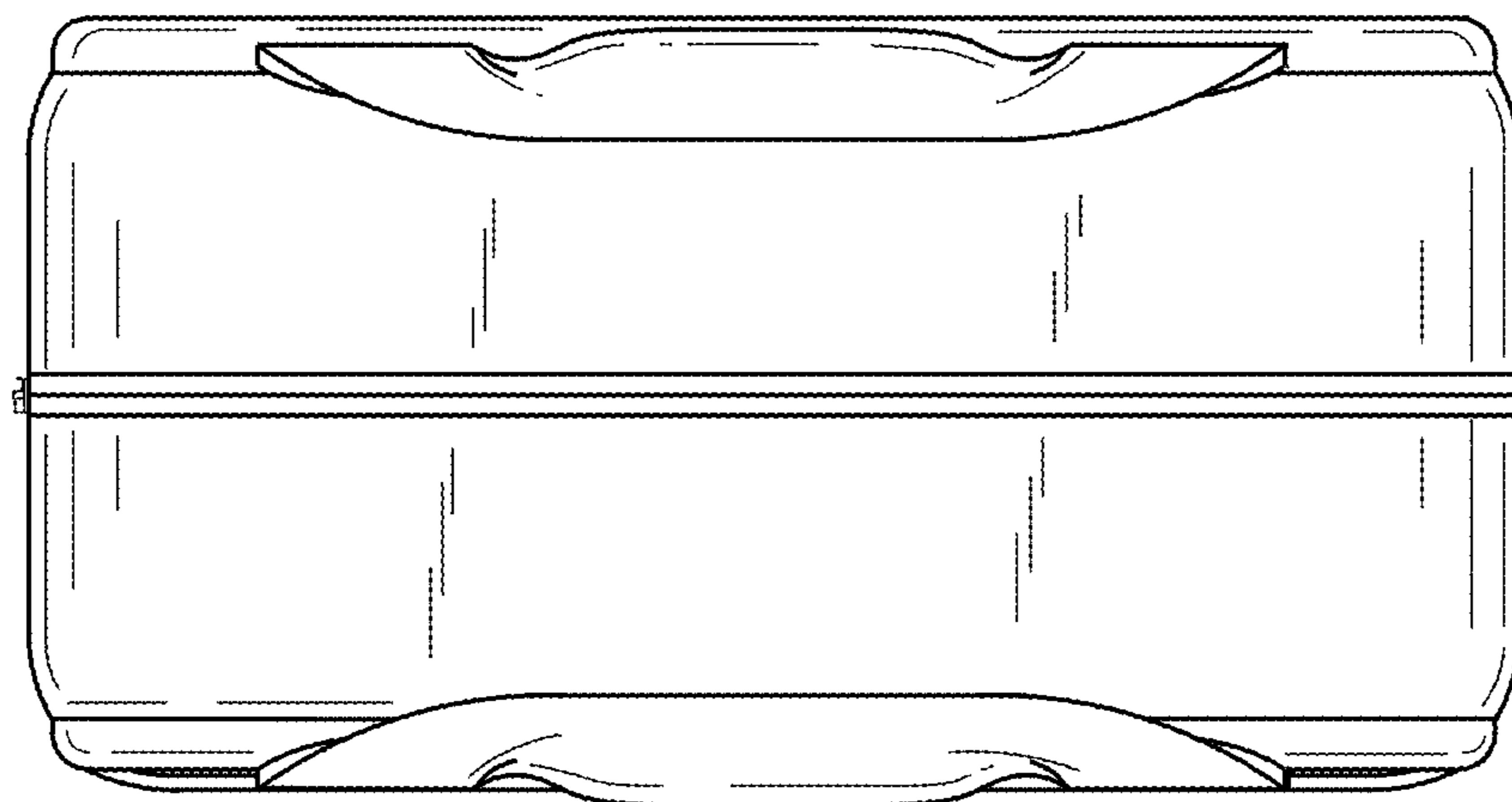

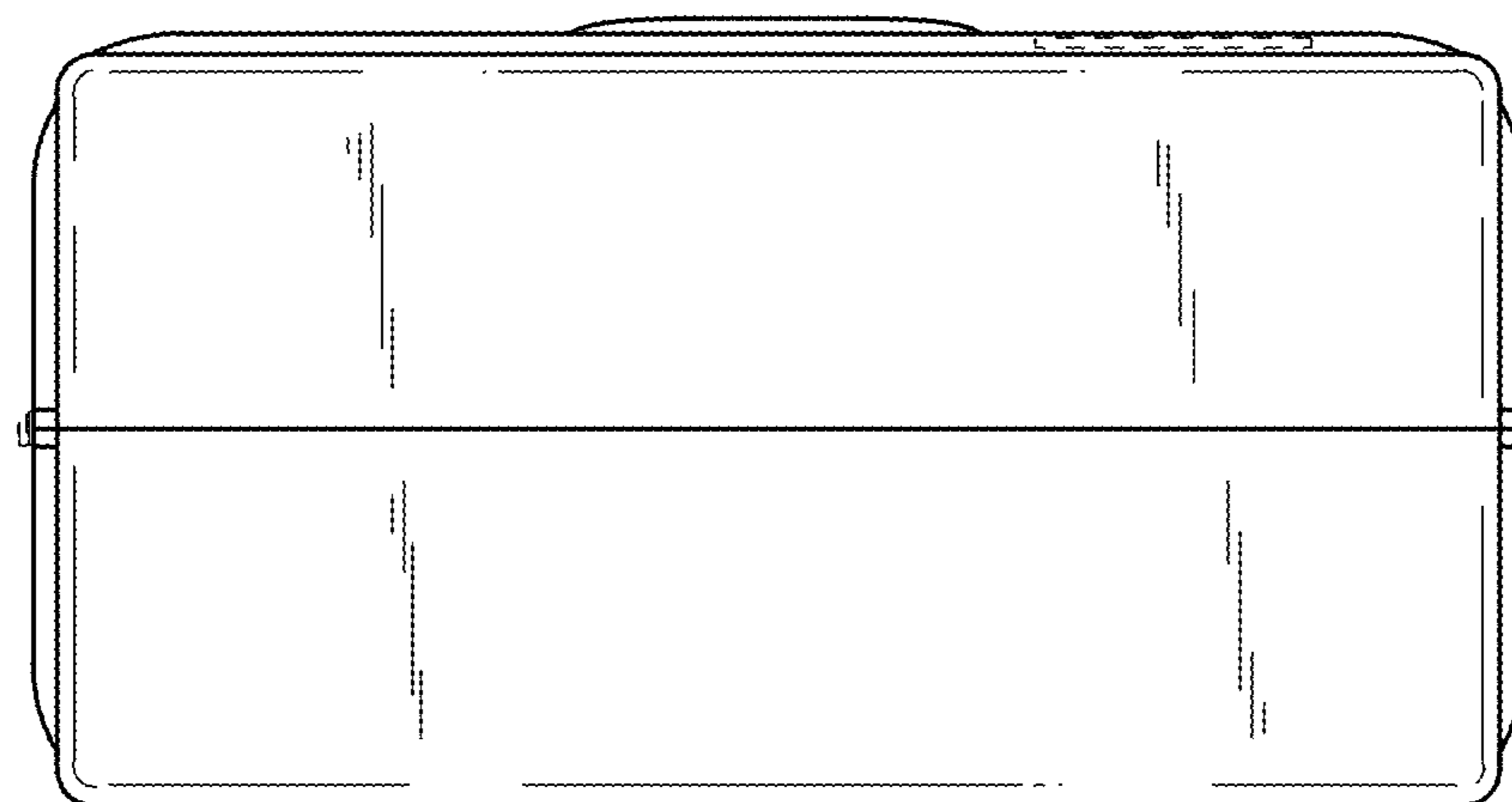
