(57) **CLAIM**

The ornamental design for a beverage holder, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right perspective view of a beverage holder showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a right side view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a left side view thereof; and,
FIG. 6 is a top view thereof.
The broken lines immediately adjacent to the shaded areas represent unclaimed boundaries of the design. The unshaded regions within or adjacent to the shaded areas form no part of the claimed design. The broken lines showing the remainder of the beverage holder are for environmental purposes only and form no part of the claimed design.

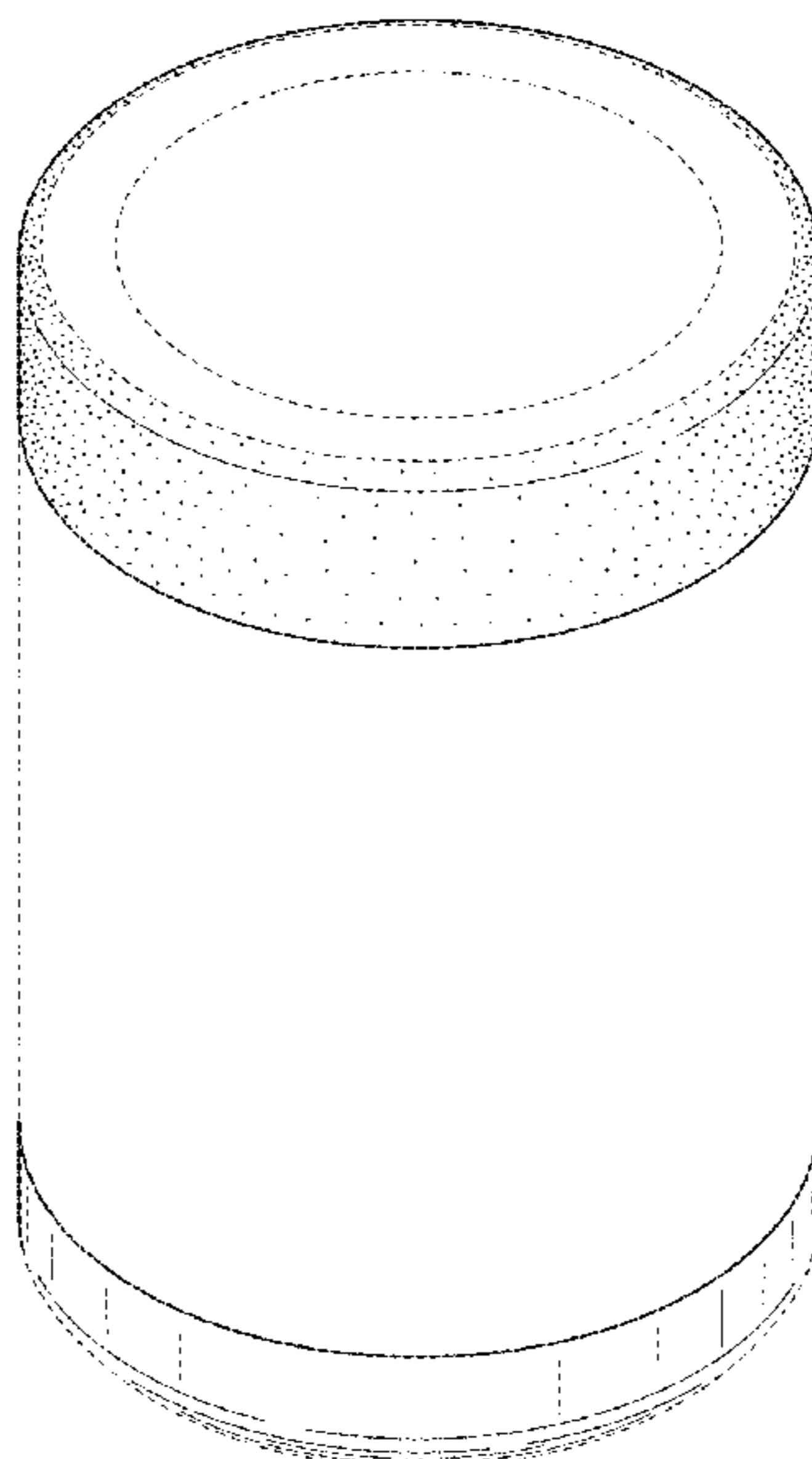

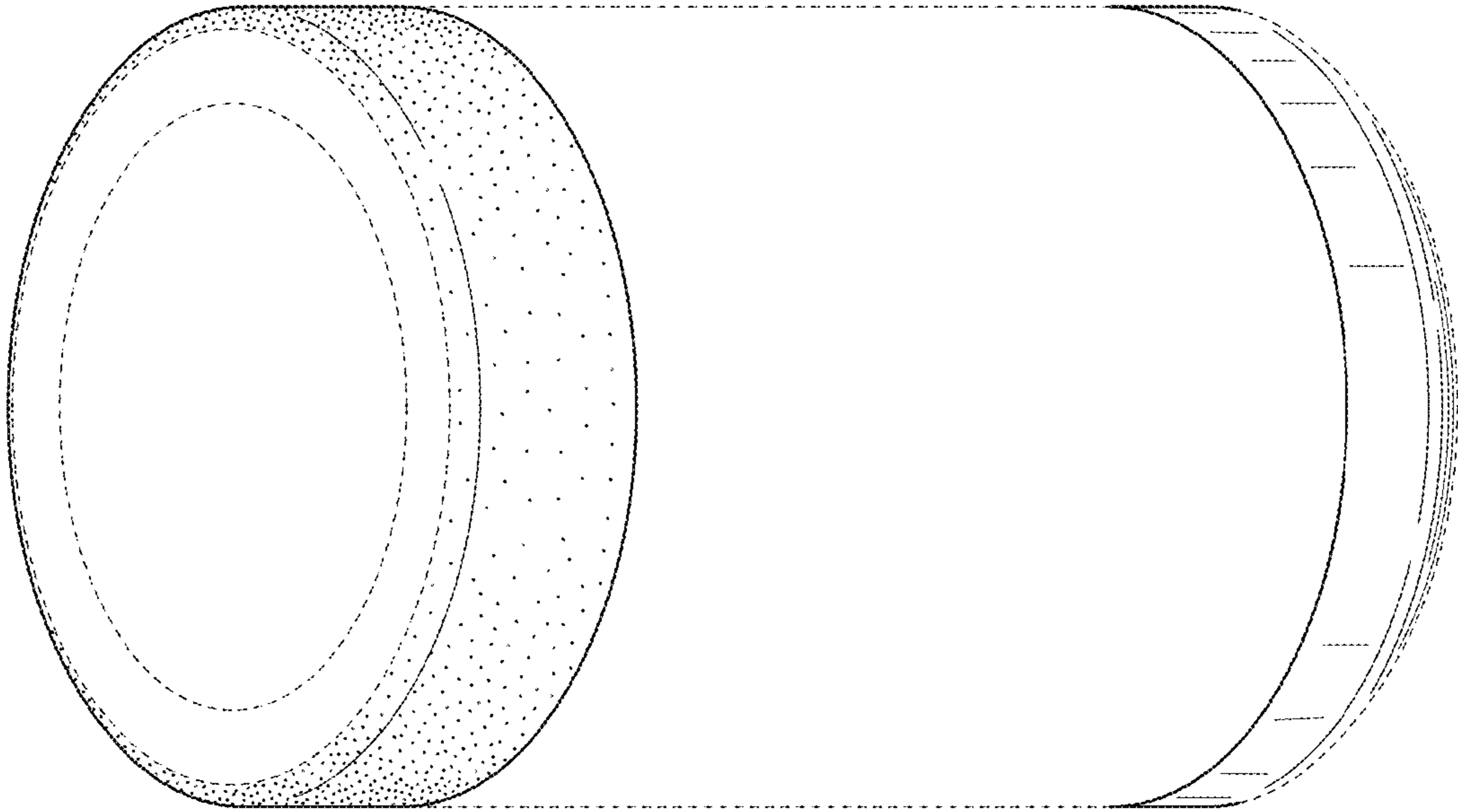

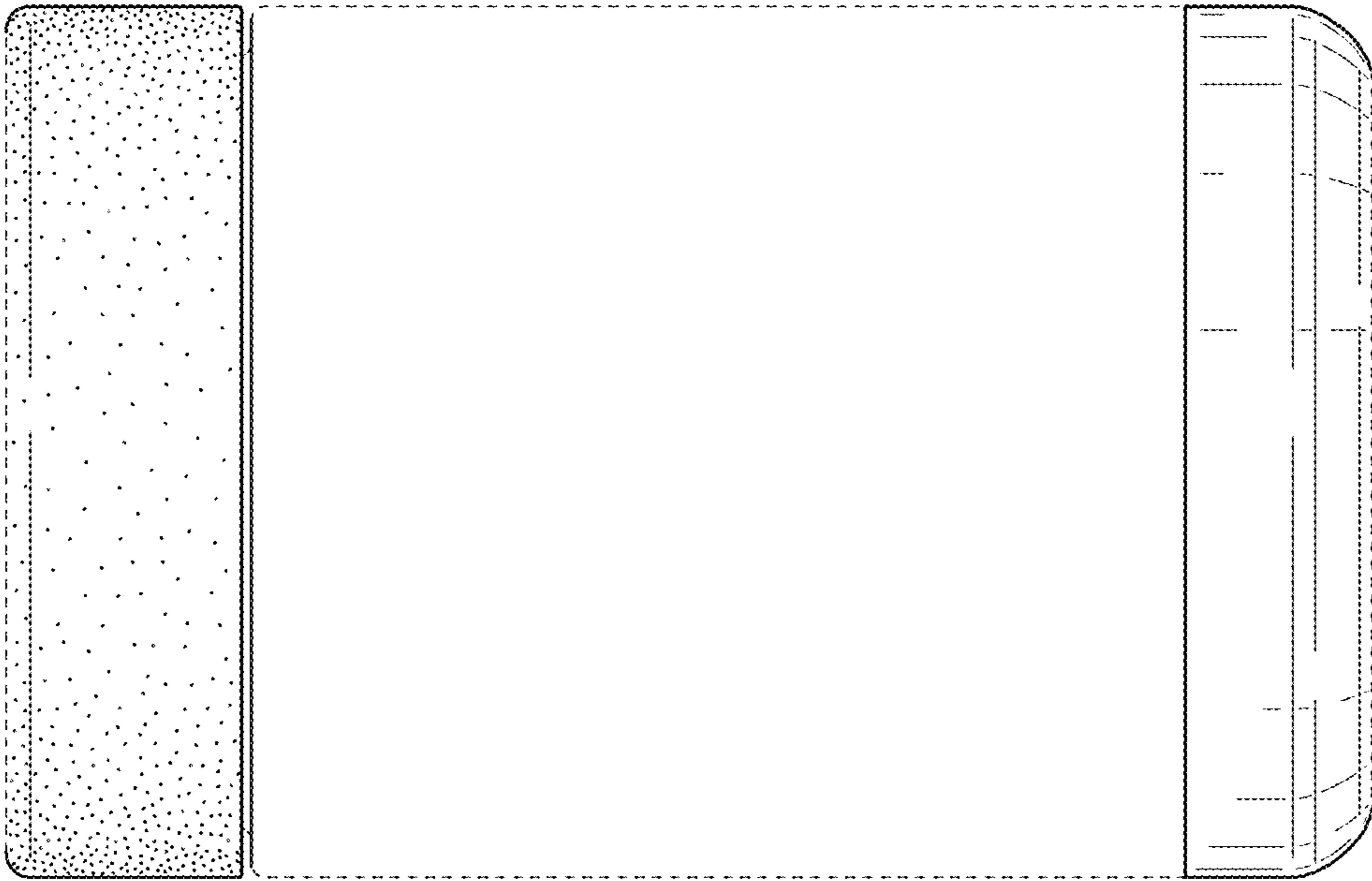

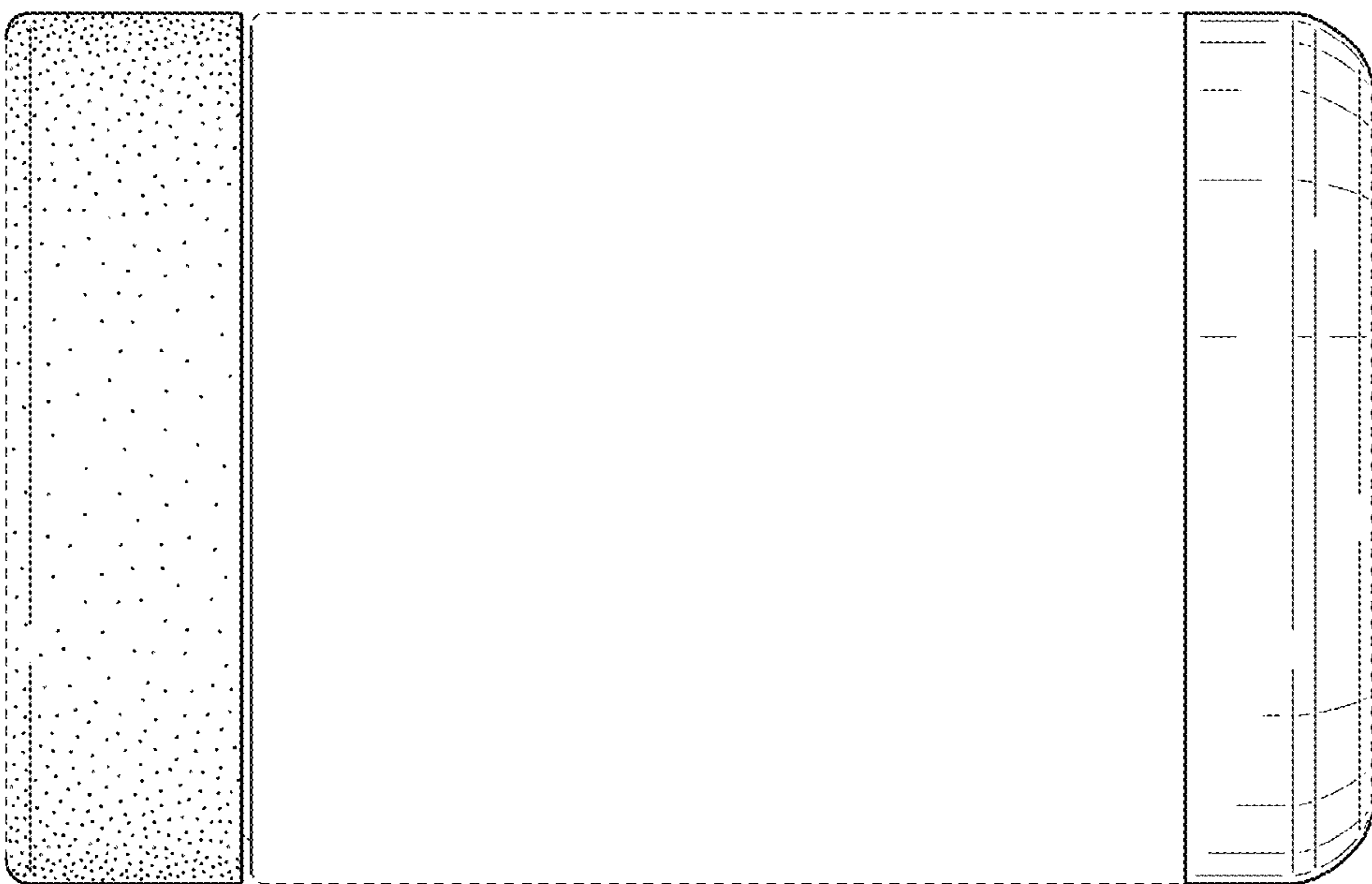

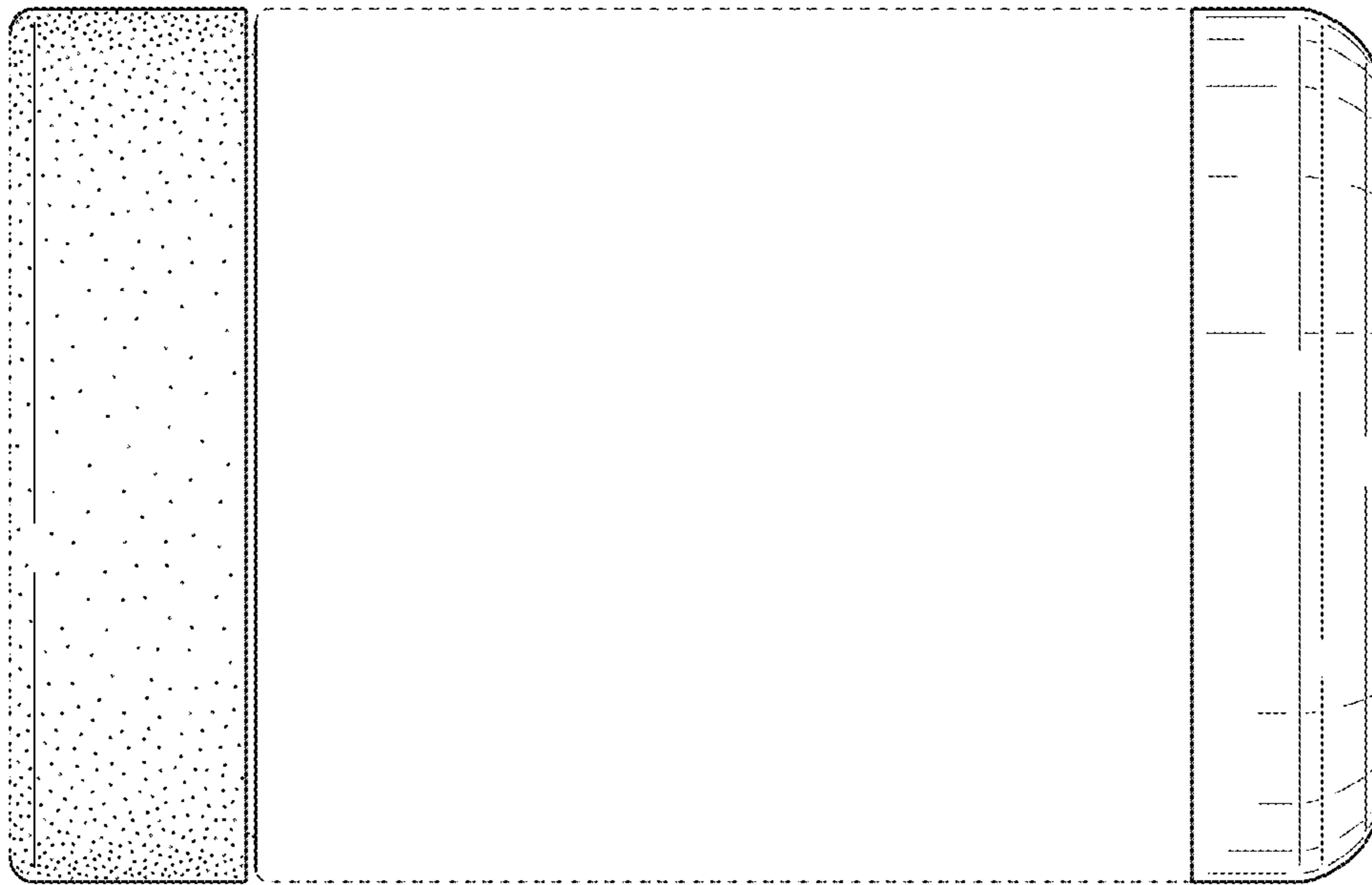

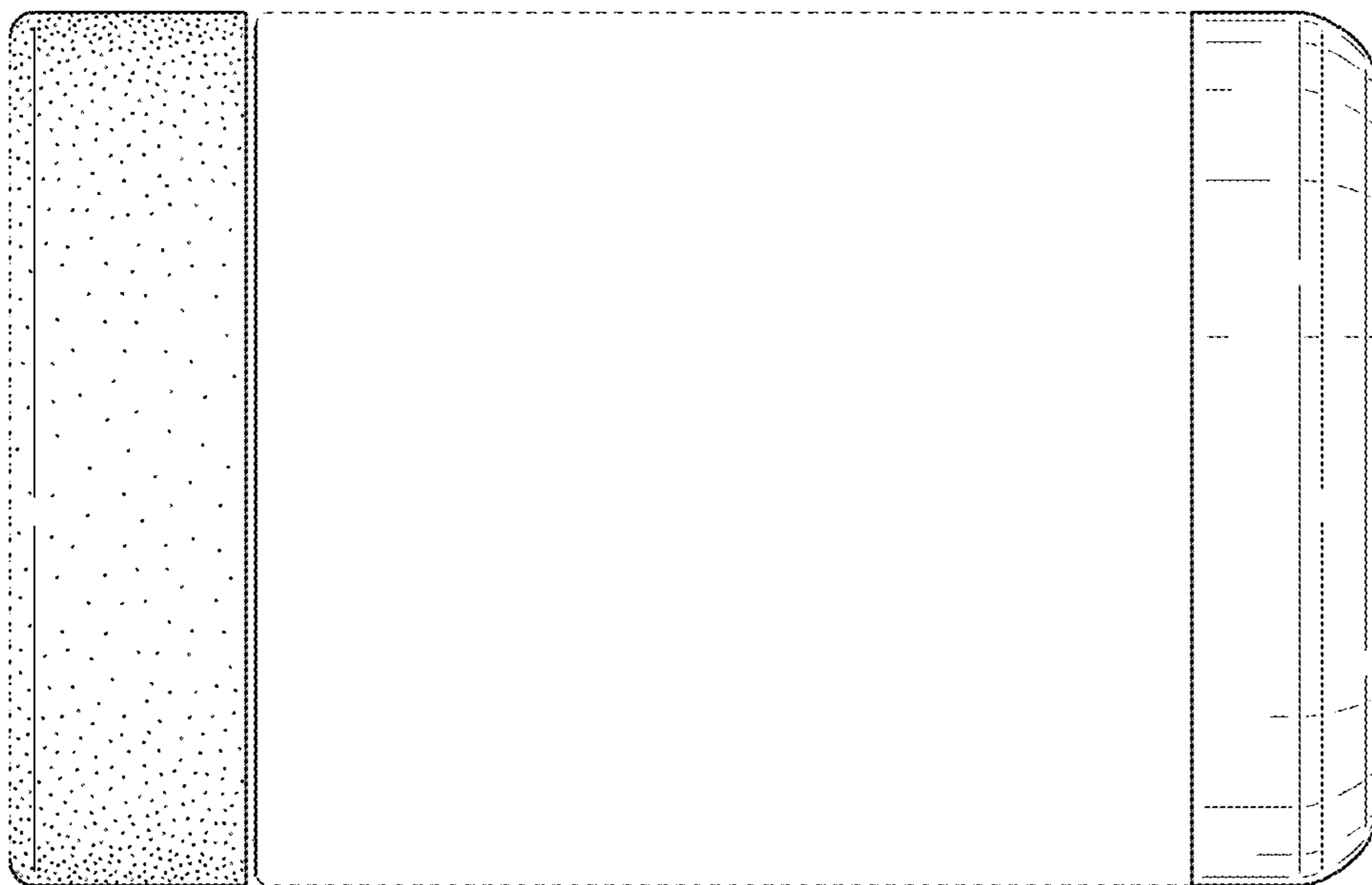

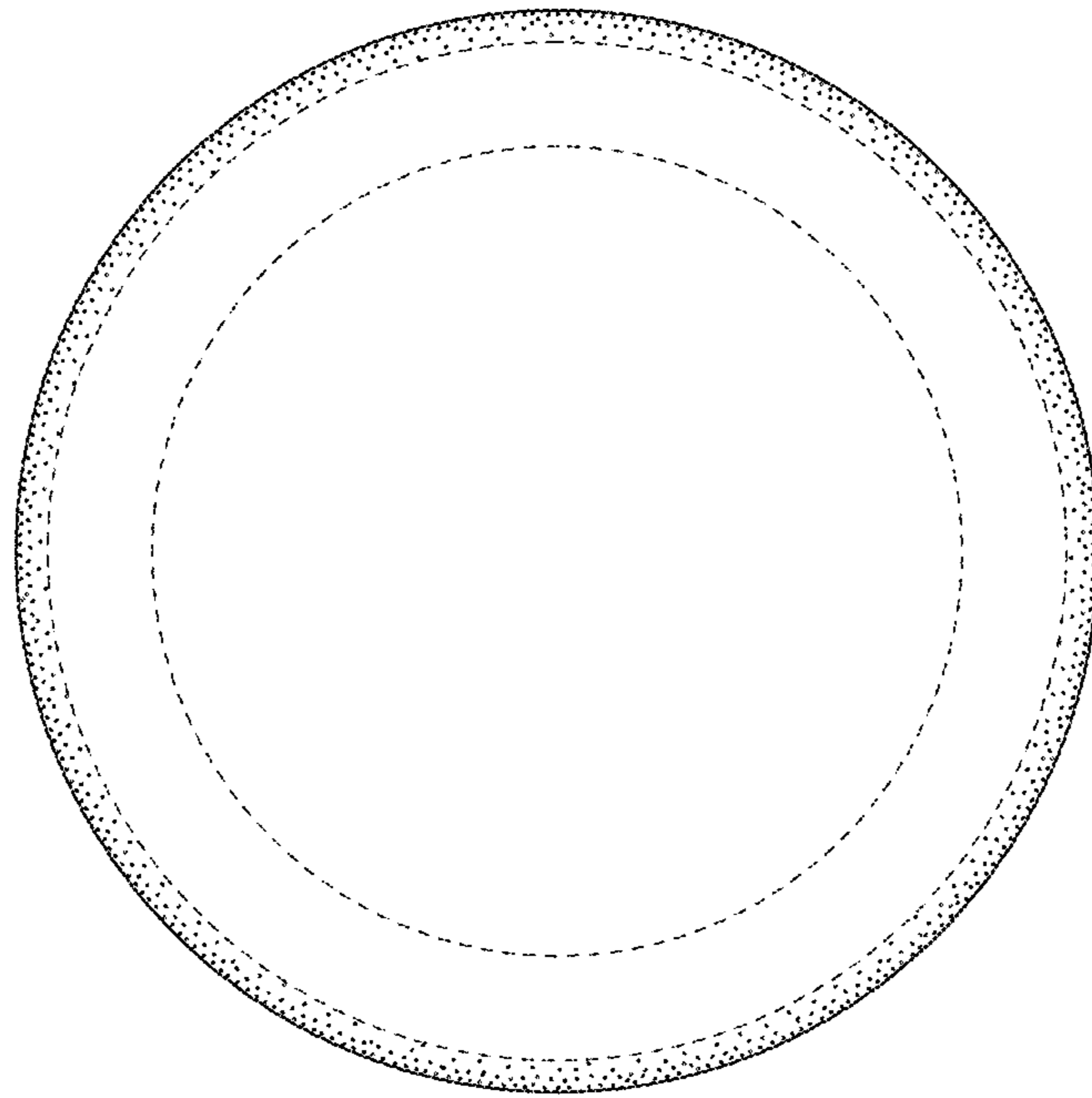
