FIG. 3 is a back view of FIG. 1;

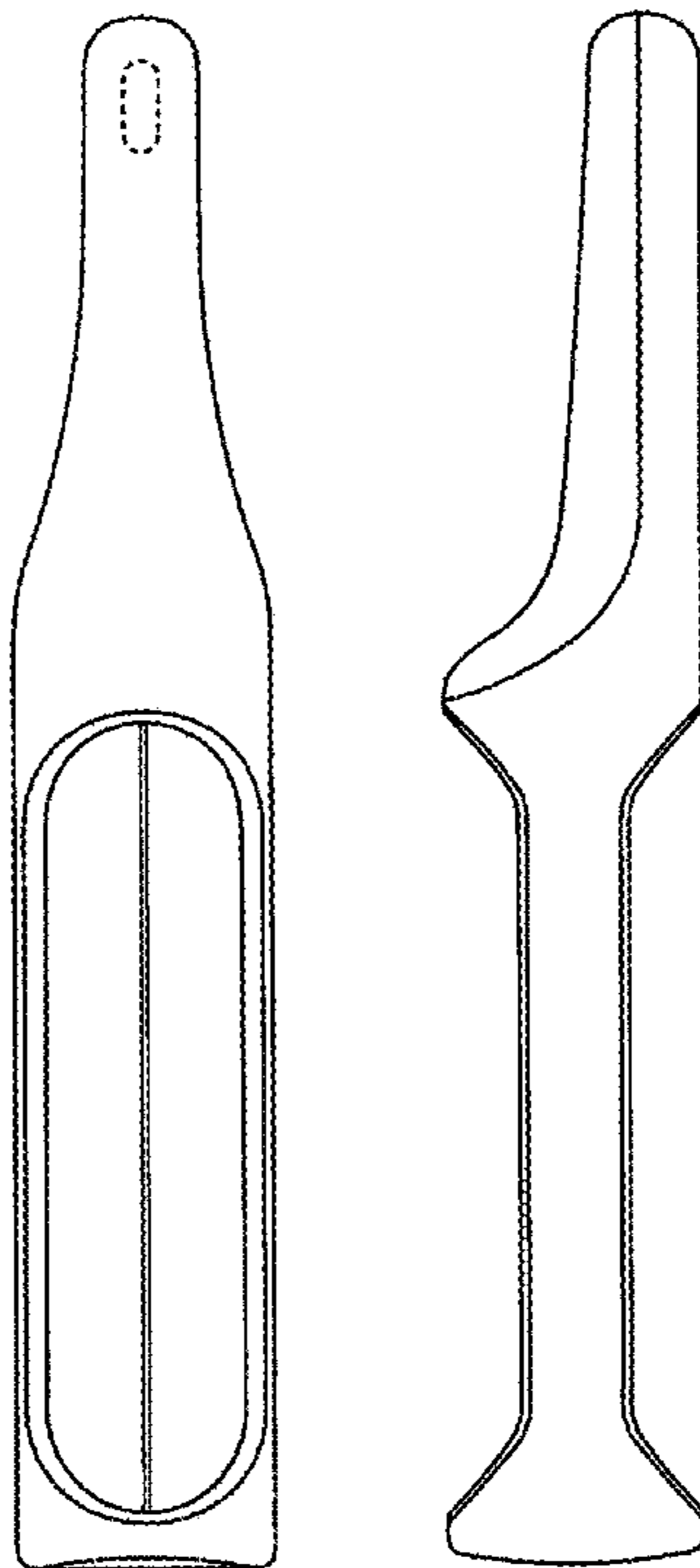
FIG. 4 is a side view of FIG. 1;

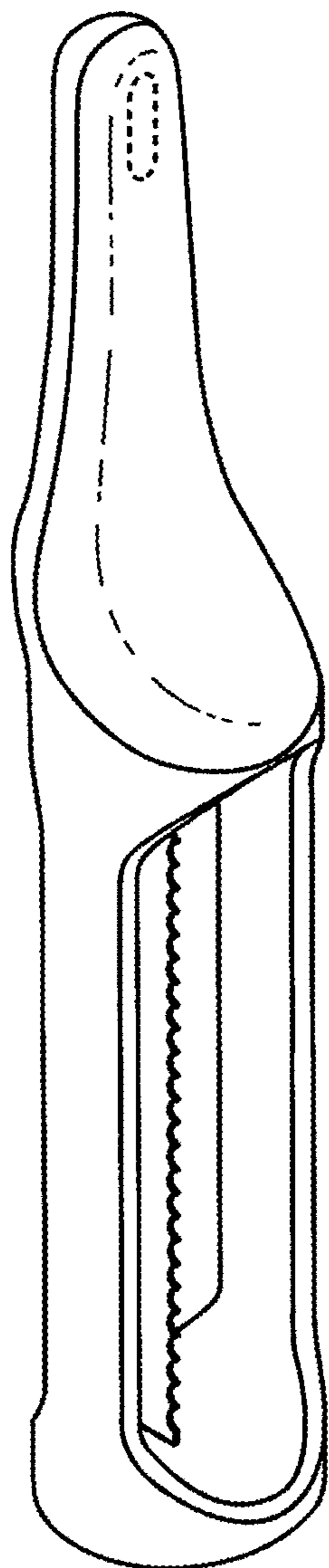

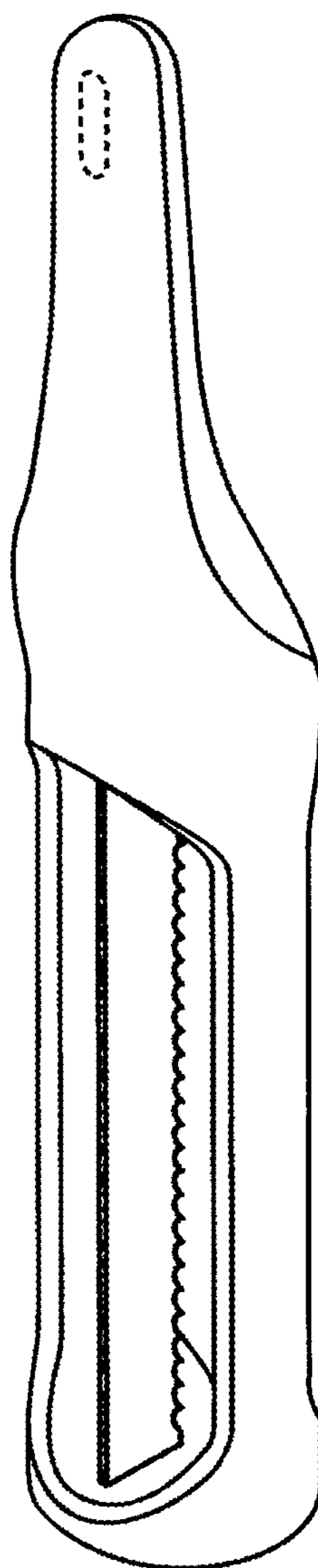

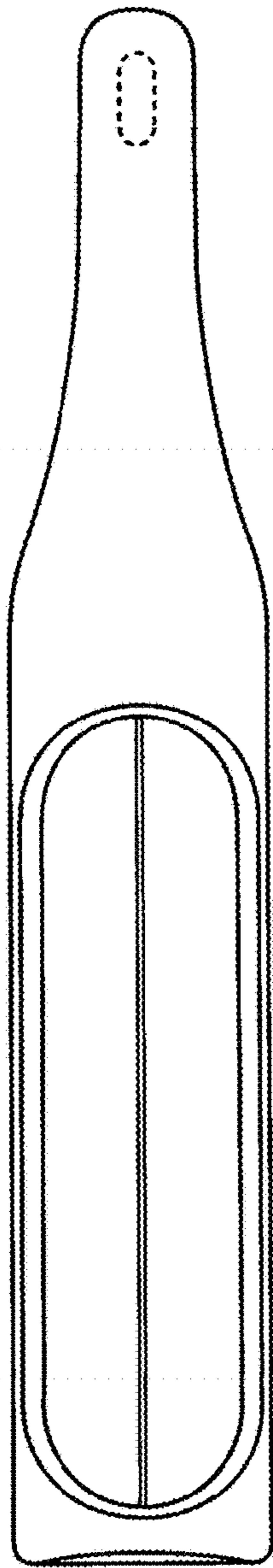

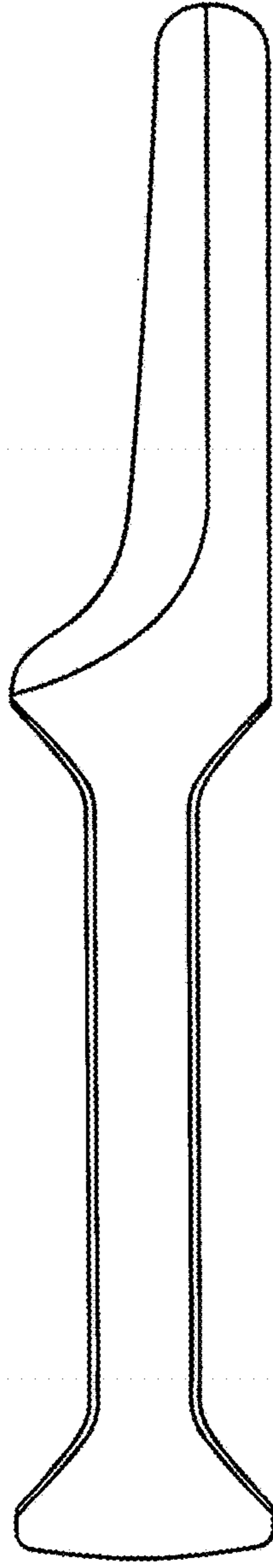

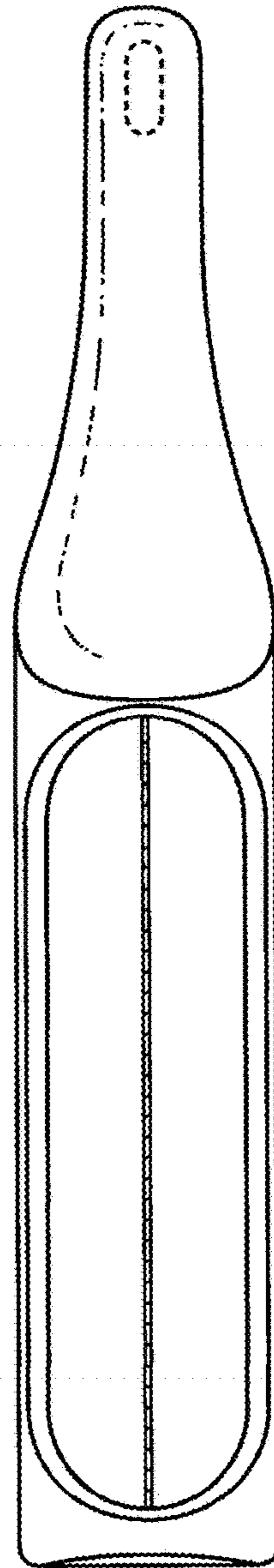

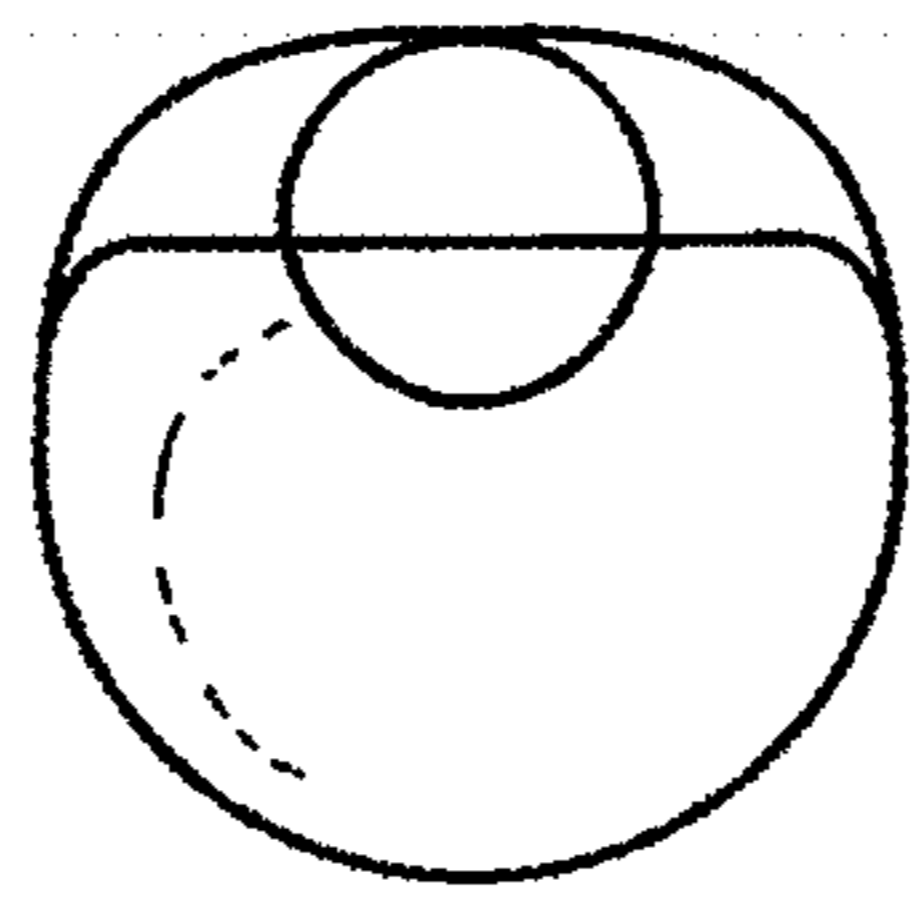

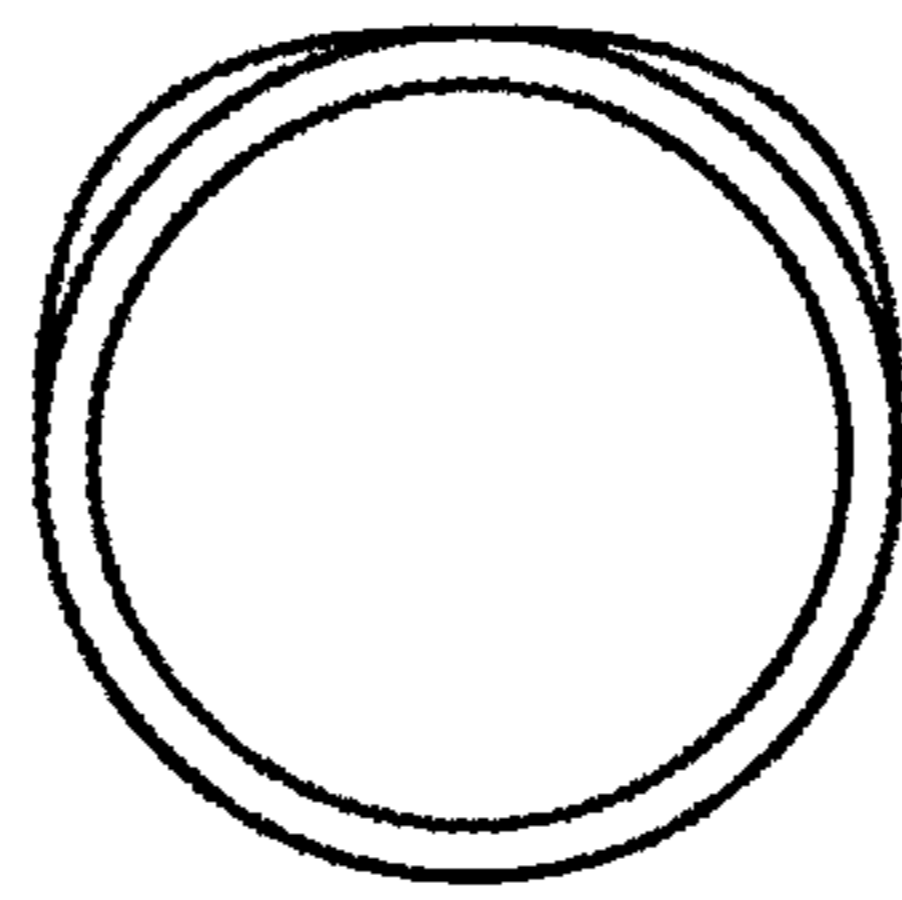
