**DESCRIPTION**

FIG. 1 is a front perspective view of a head mount display showing our new design;

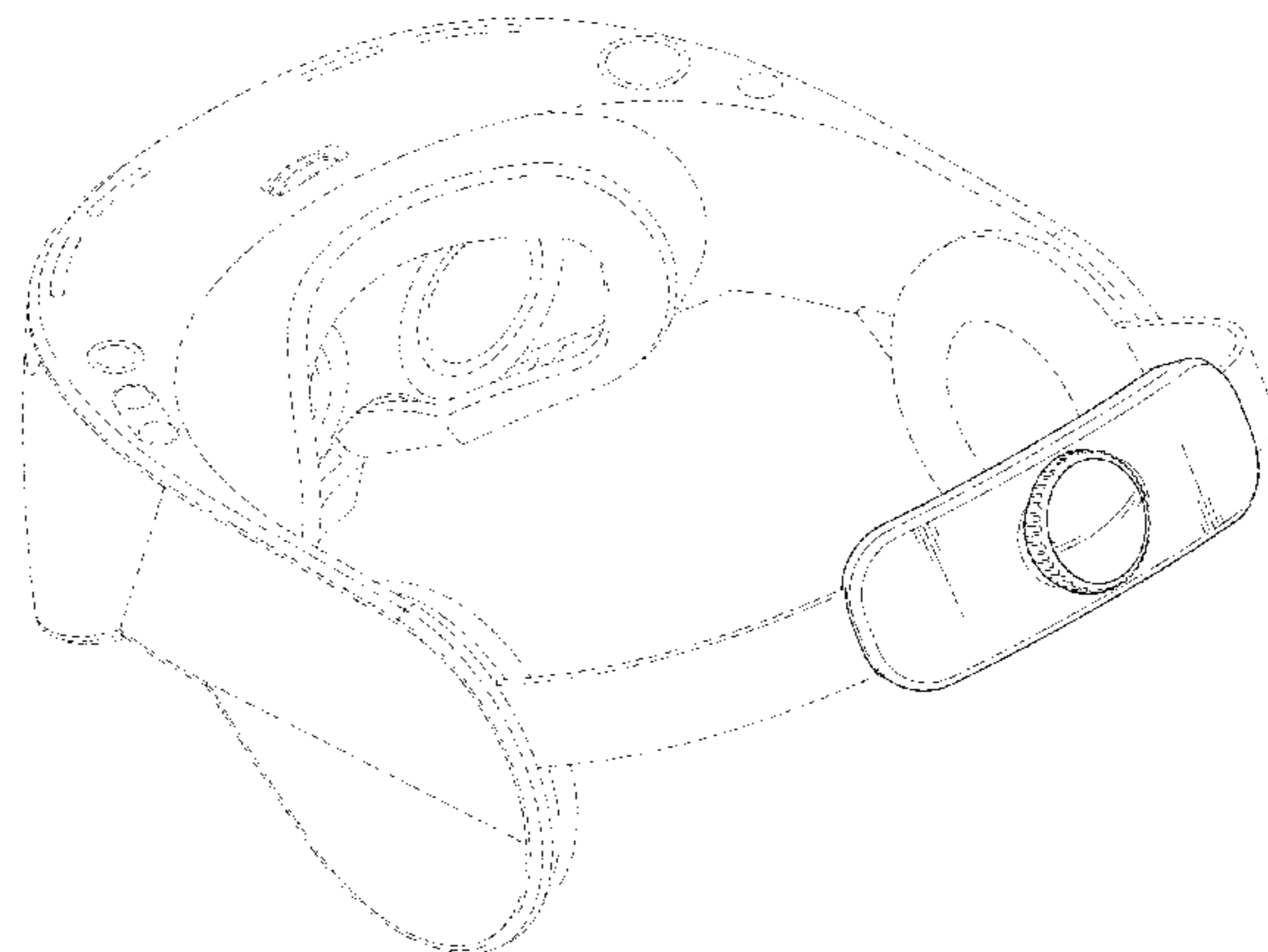
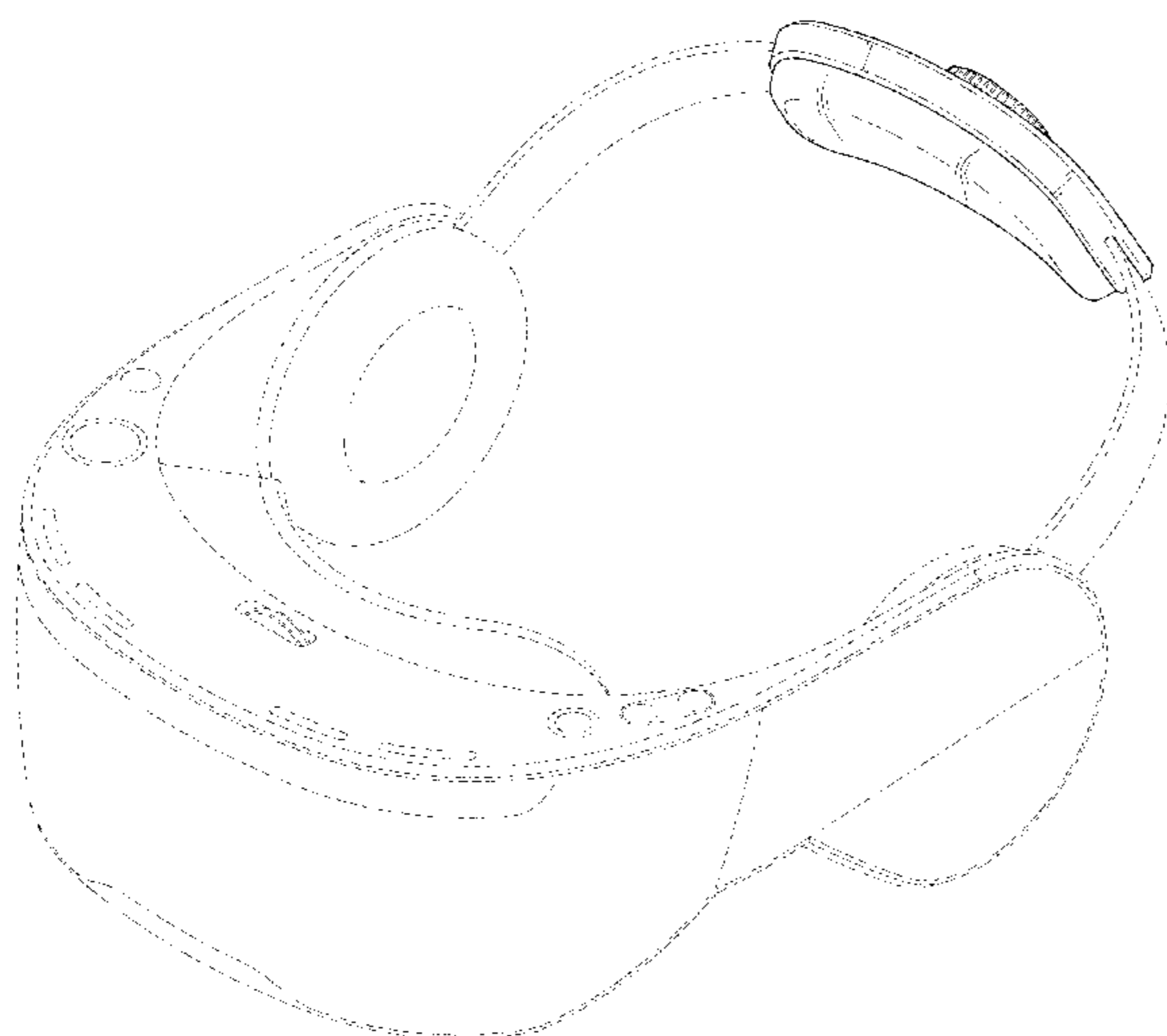

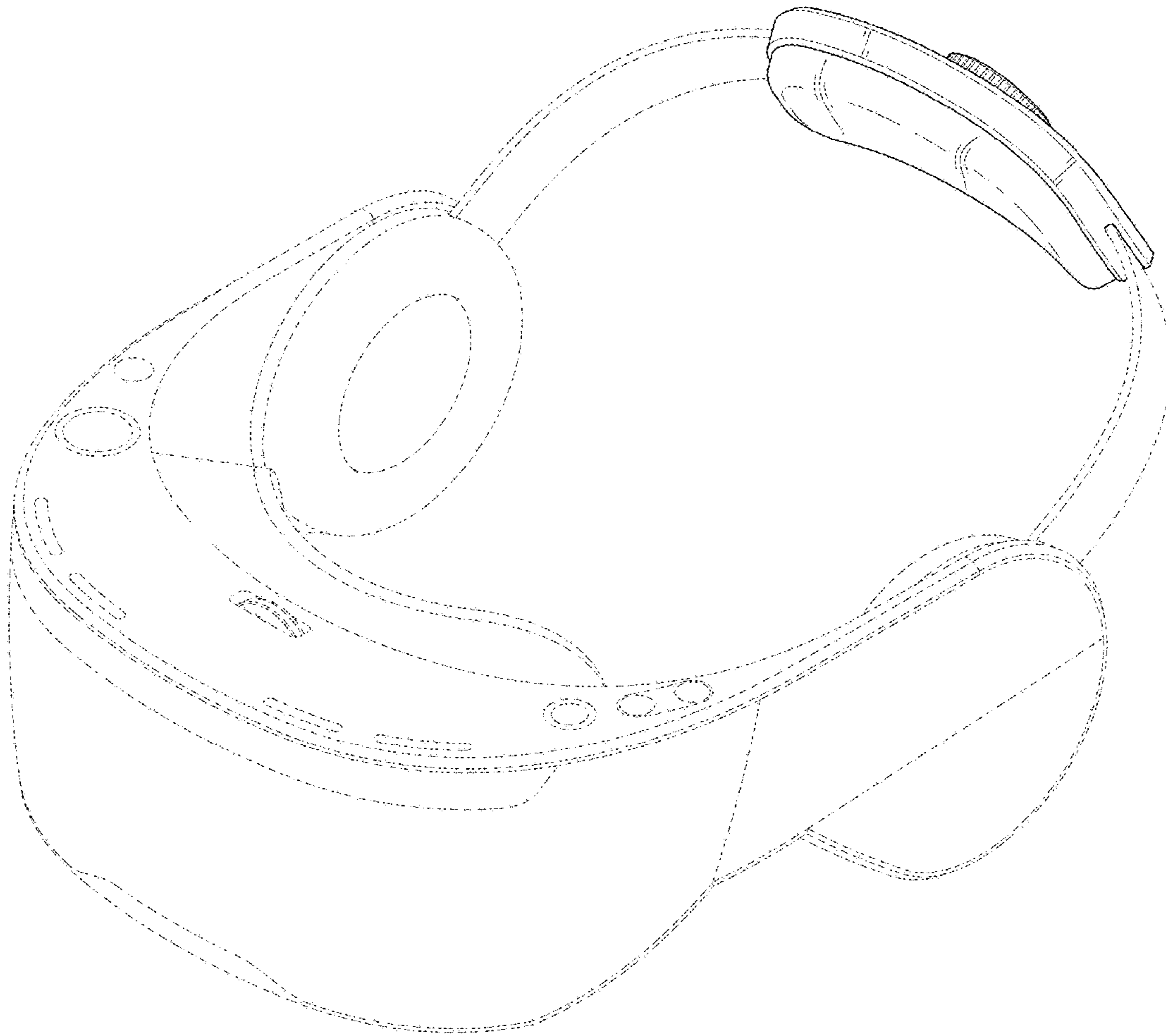

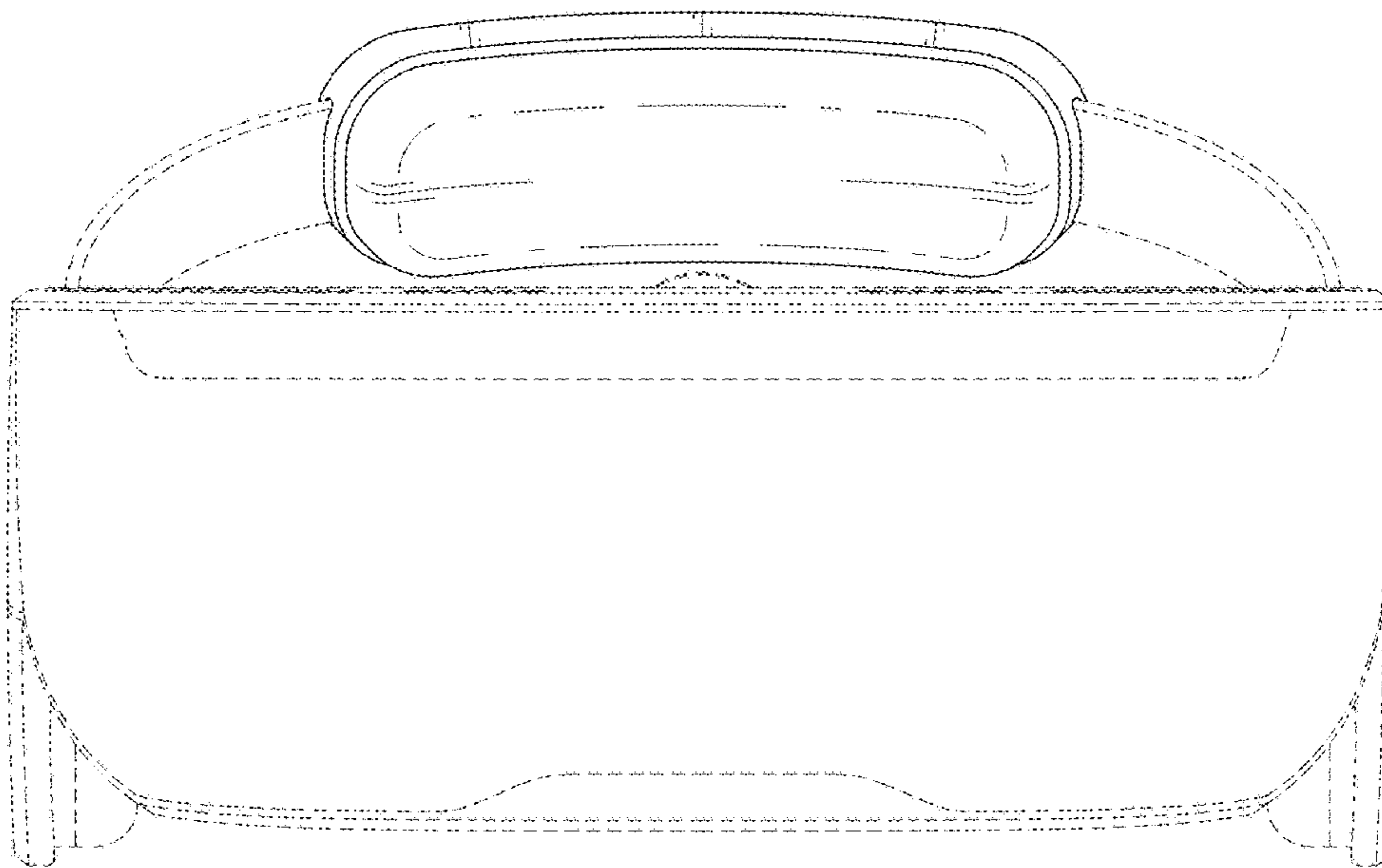

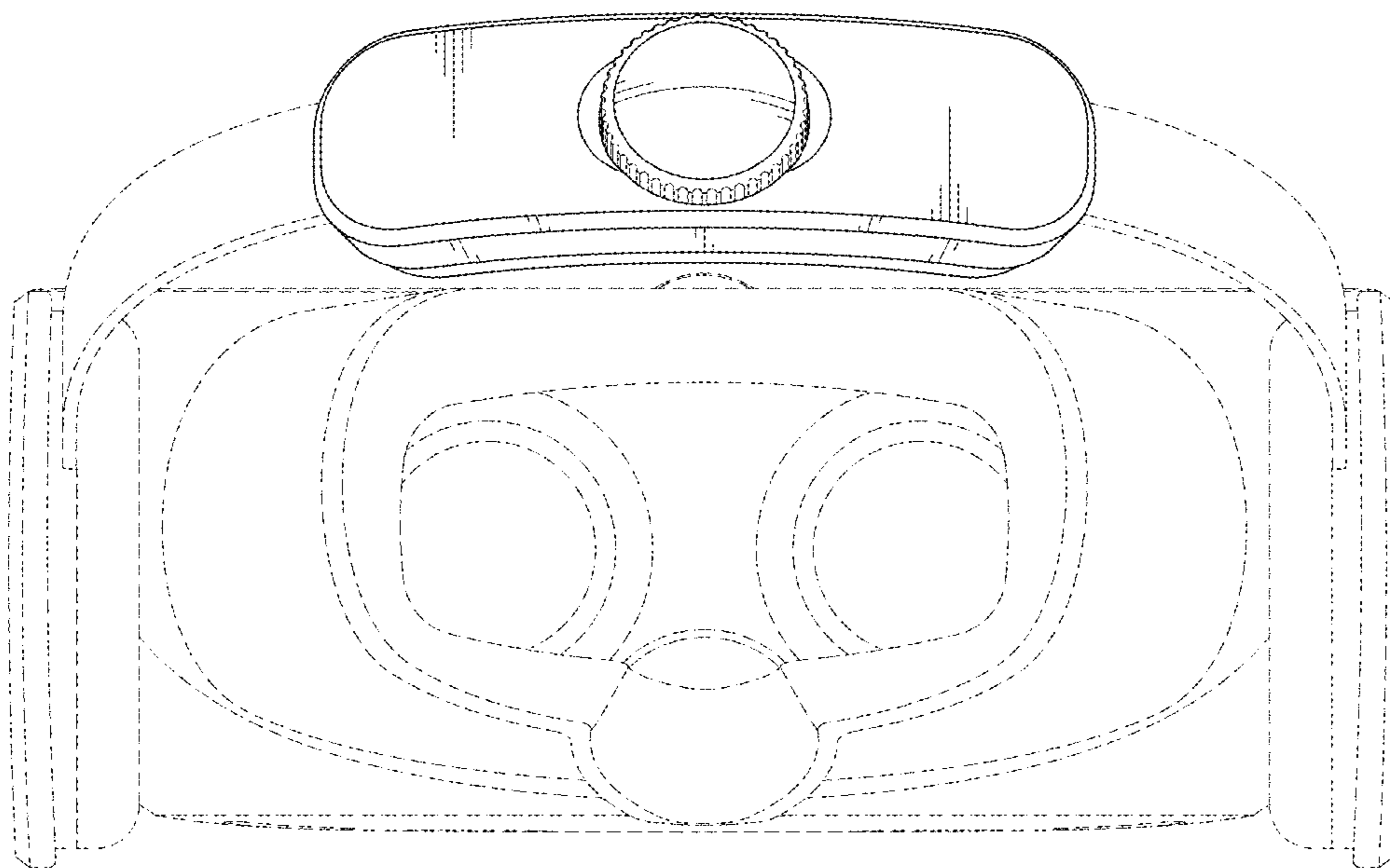

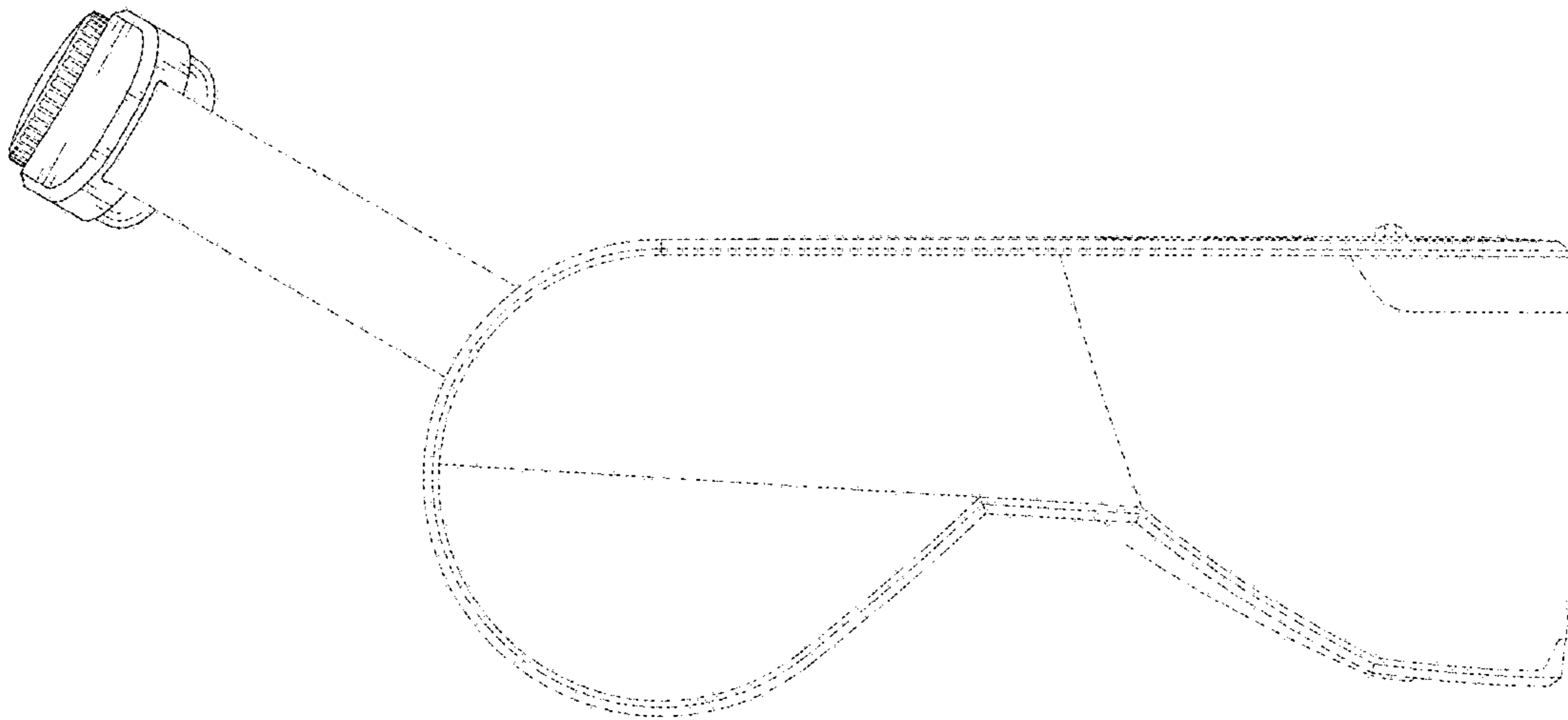

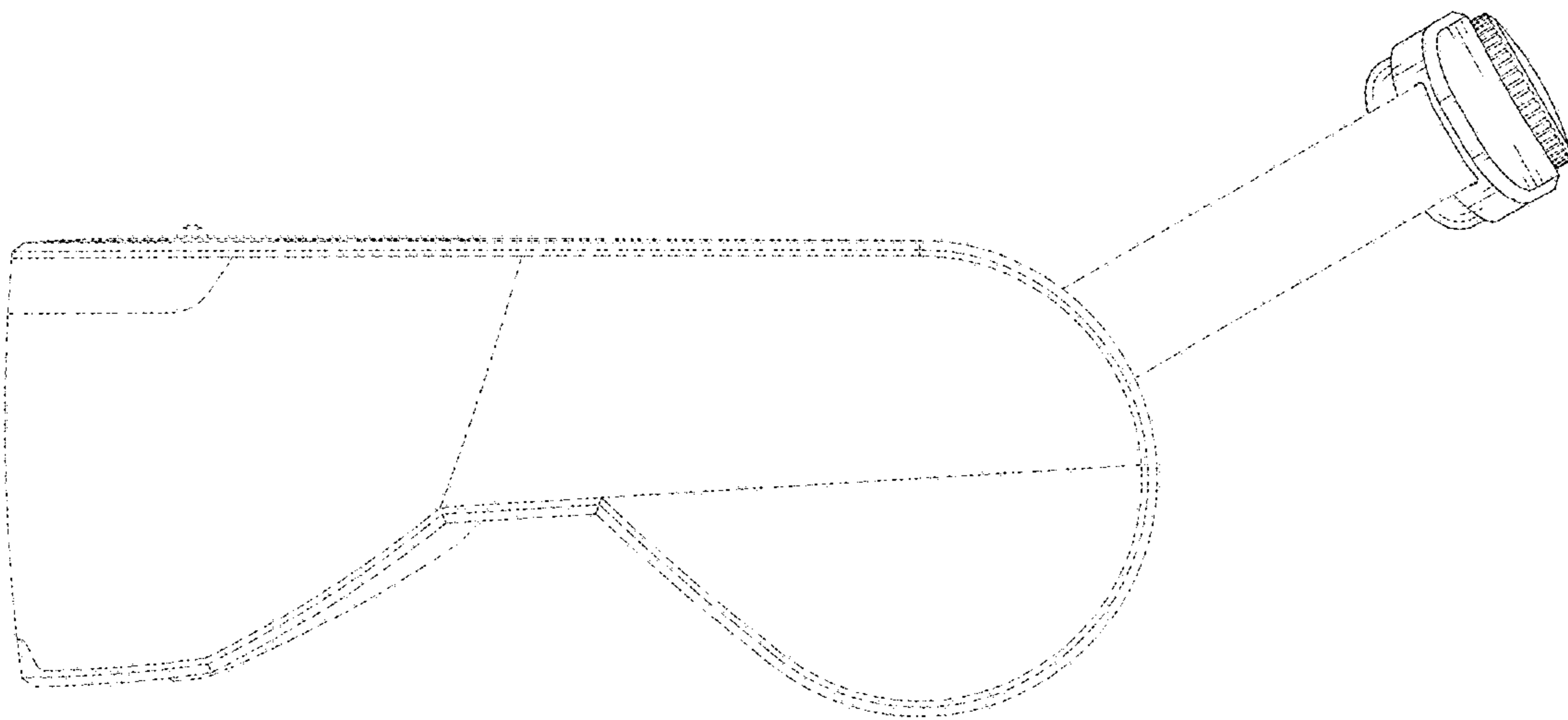

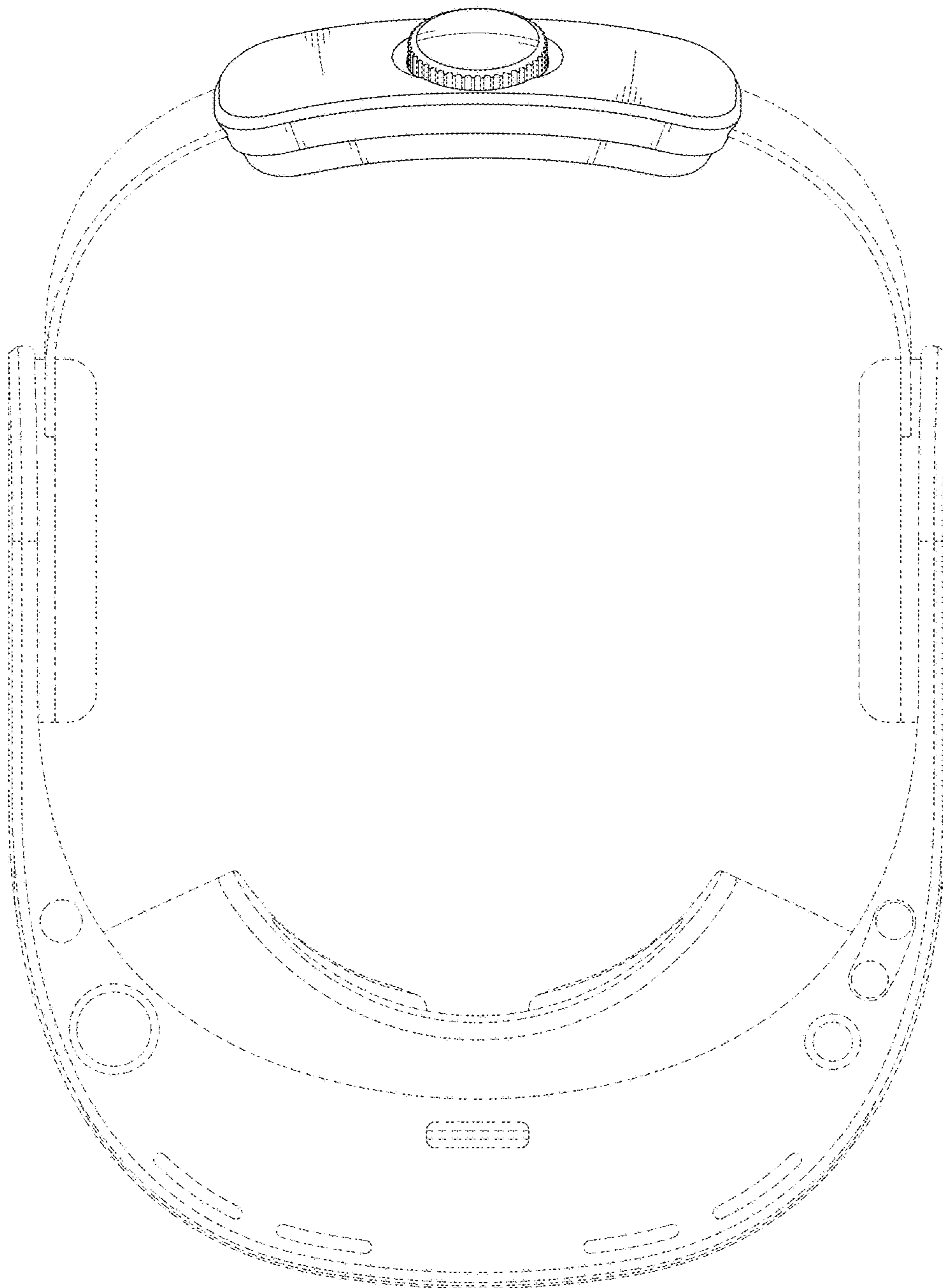

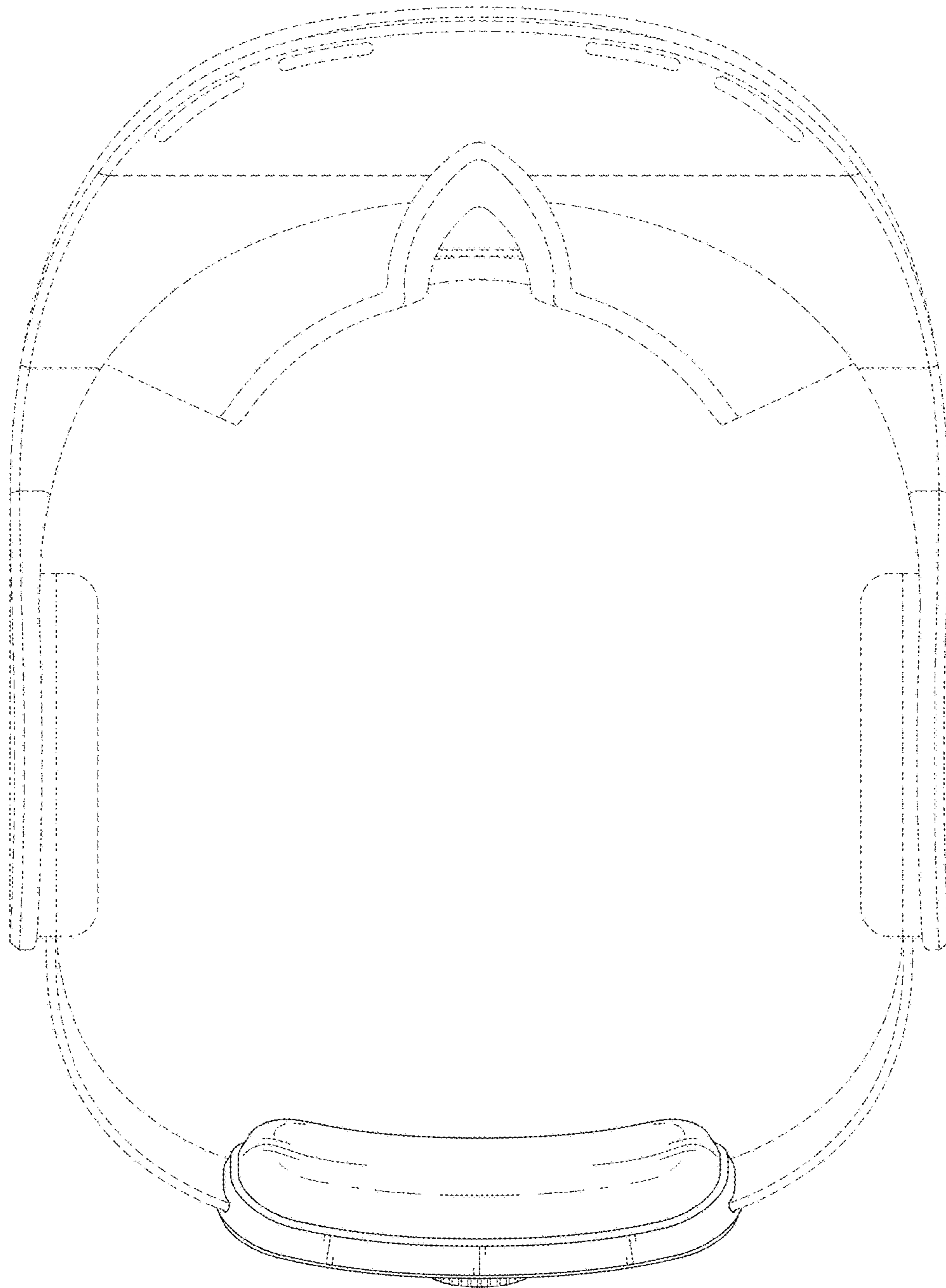

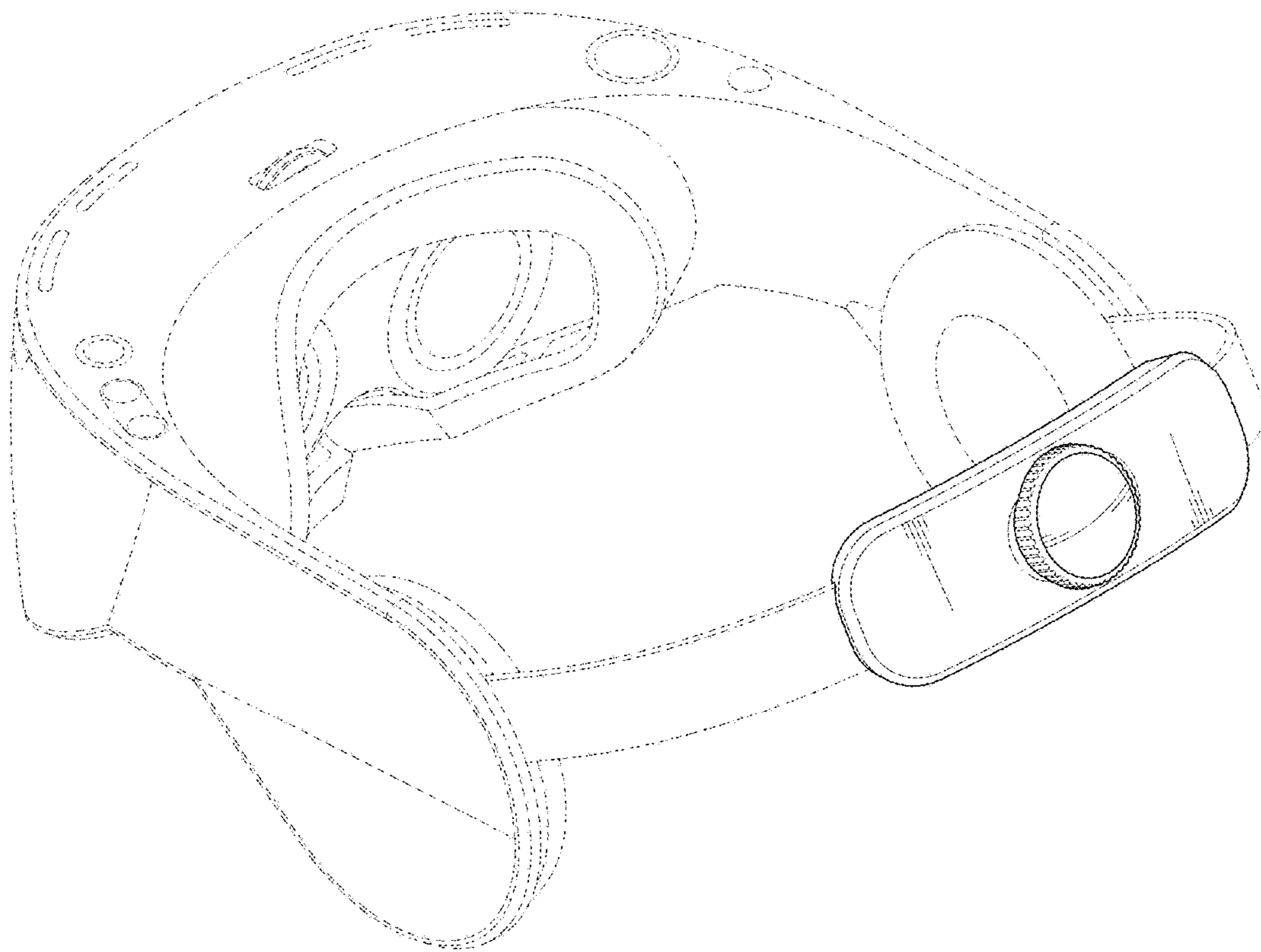
