The ornamental design for a display screen for image-editing apparatus, as shown and described.

DESCRIPTION

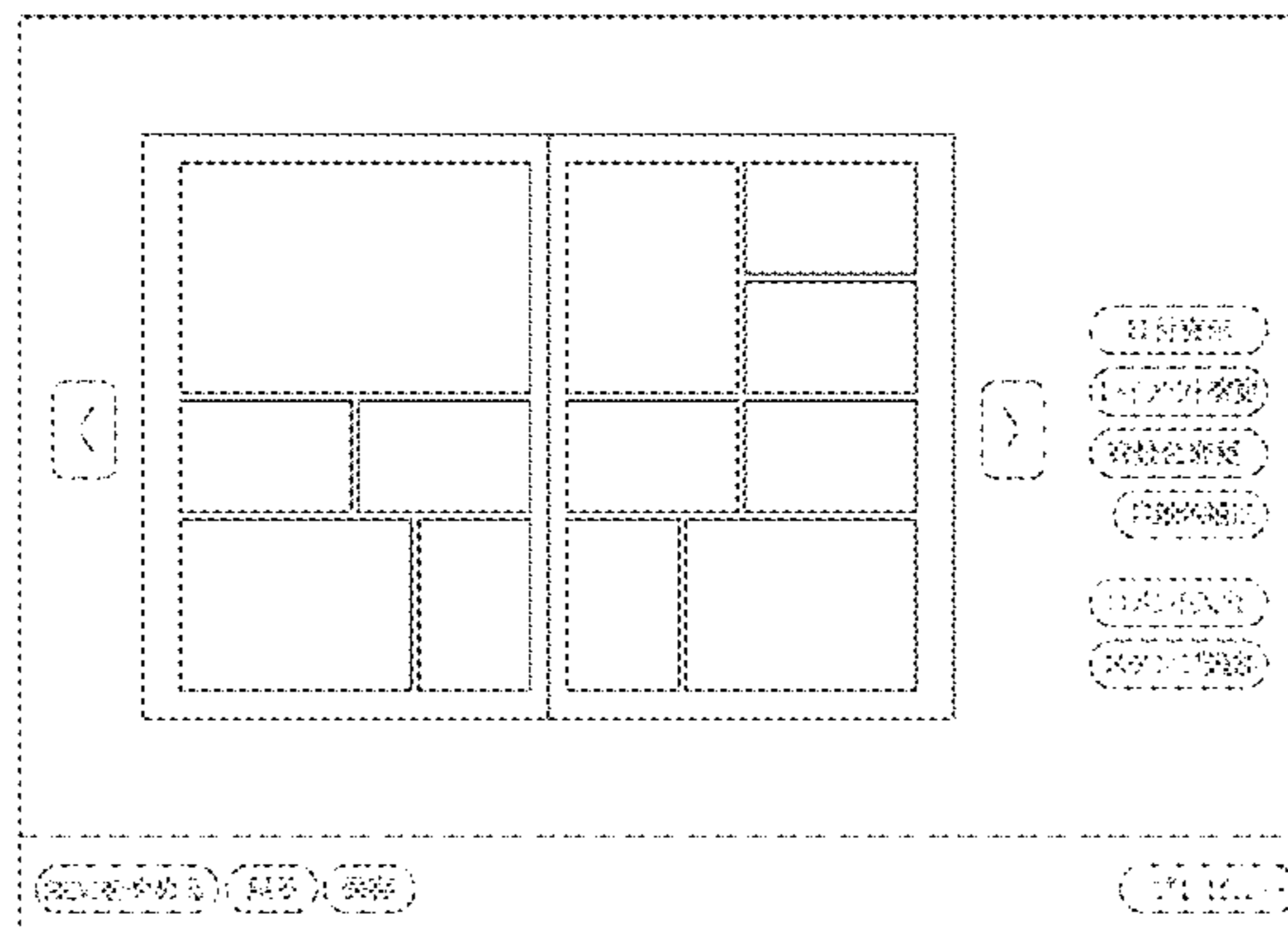


FIG. 10 is a top, front, and side perspective view of a display screen for image-editing apparatus showing a fourth embodiment of our new design;

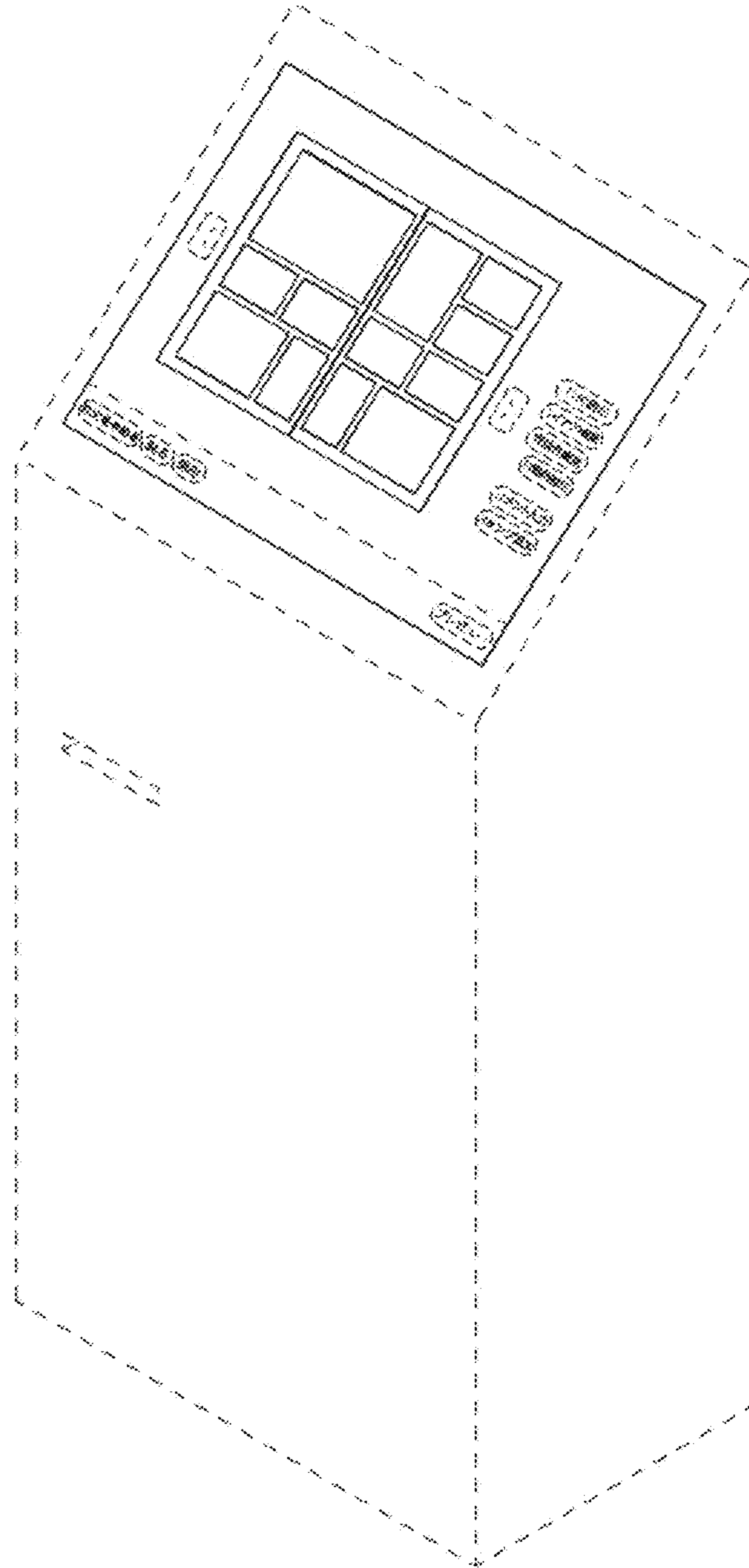

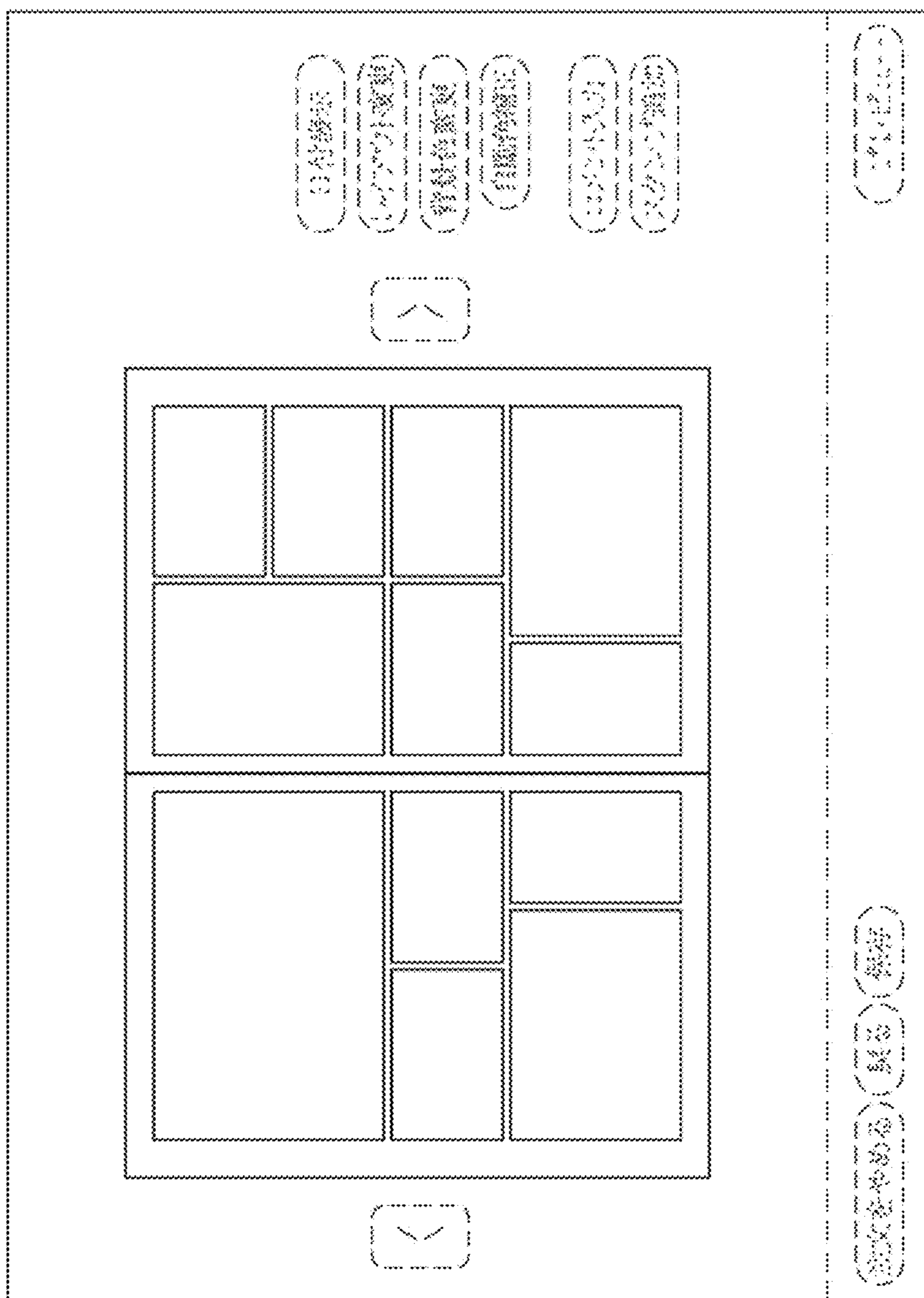

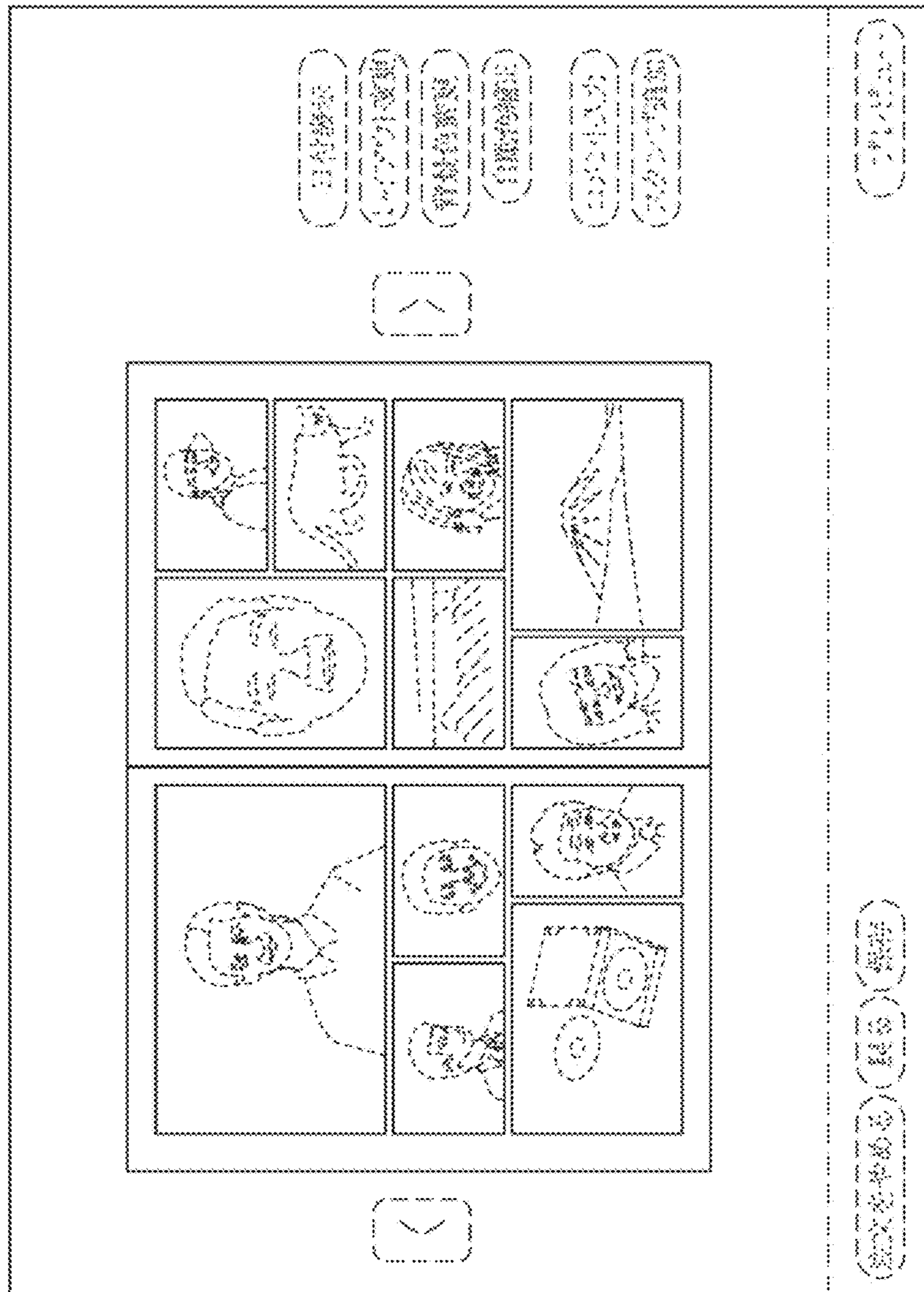

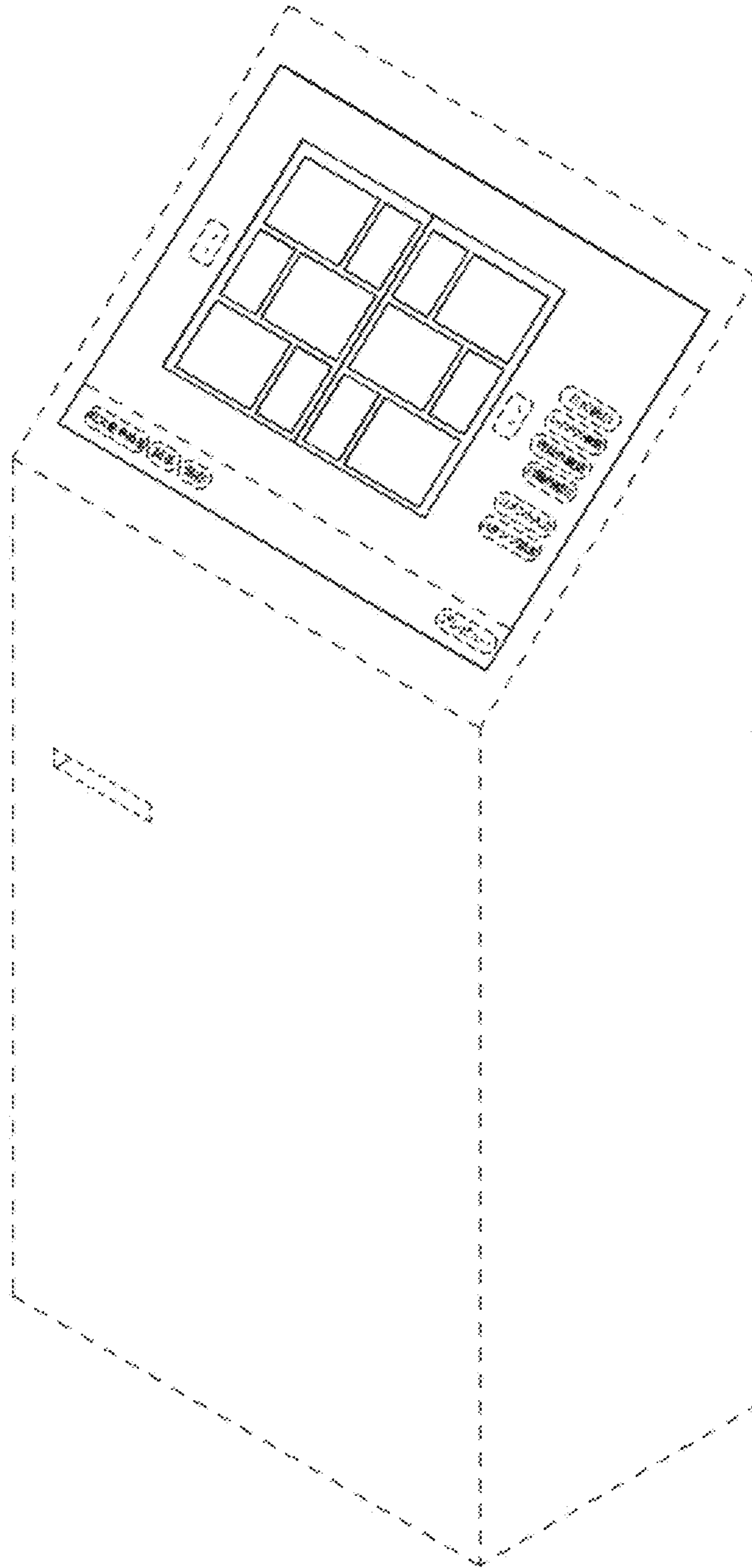

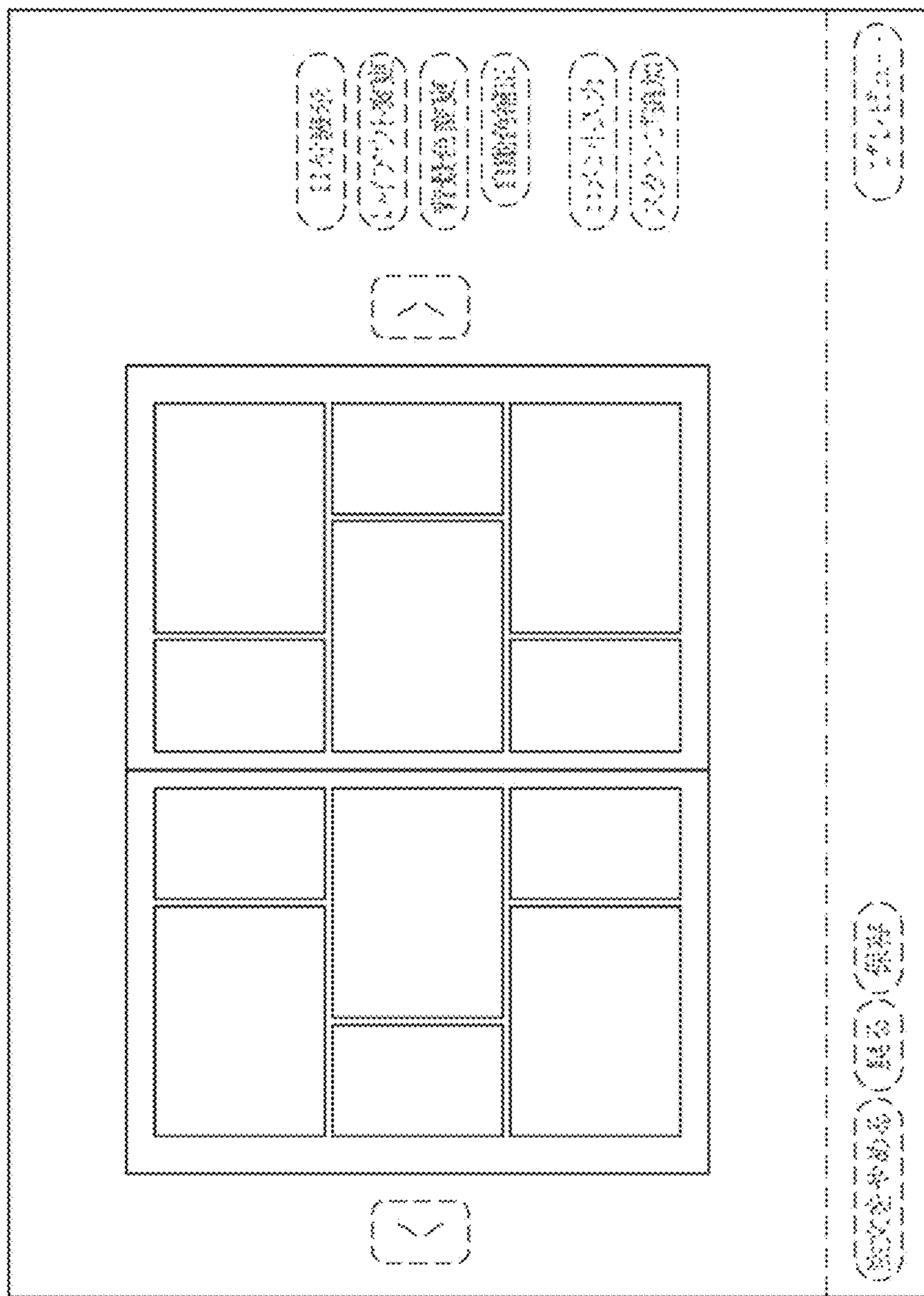

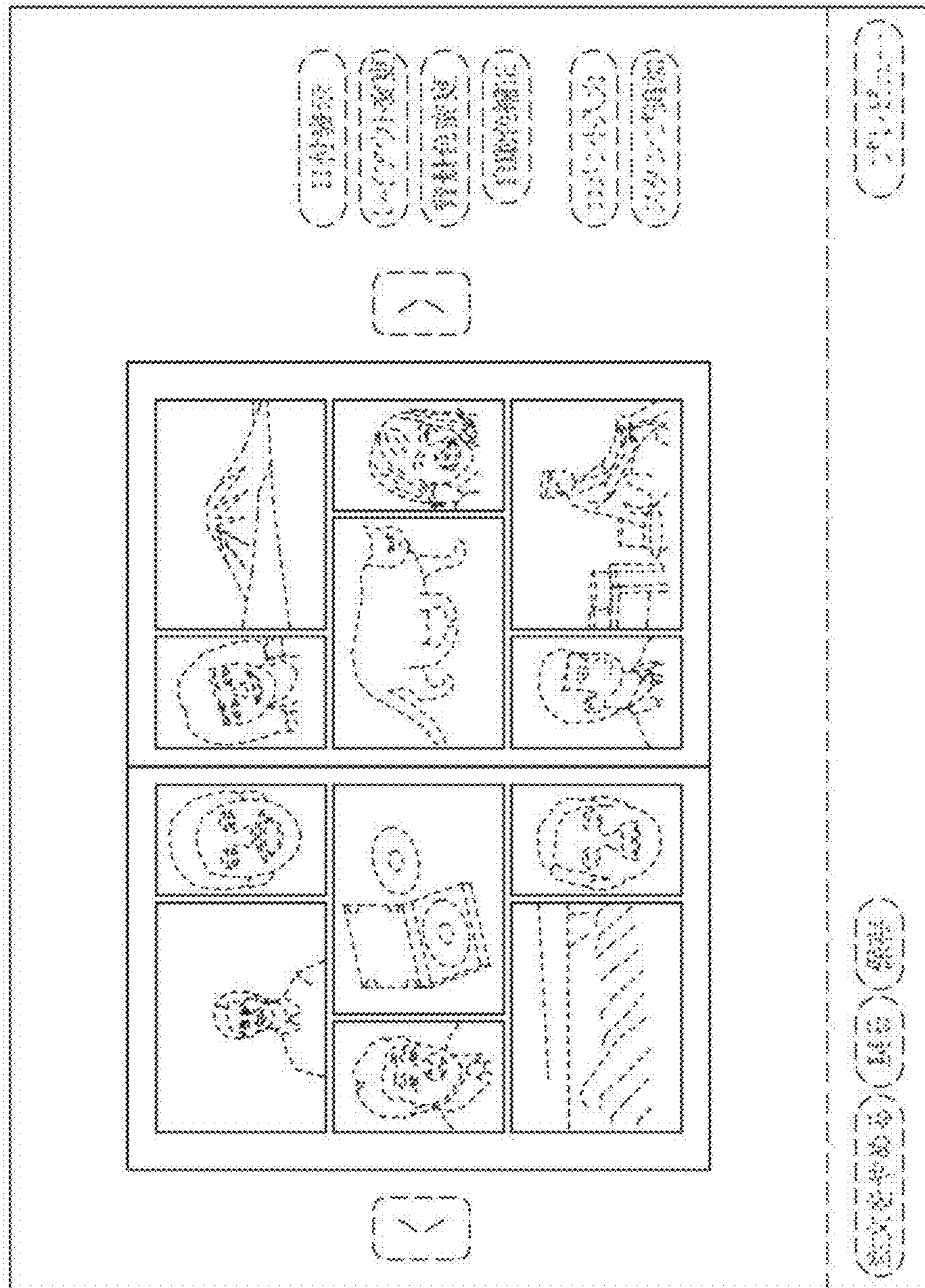

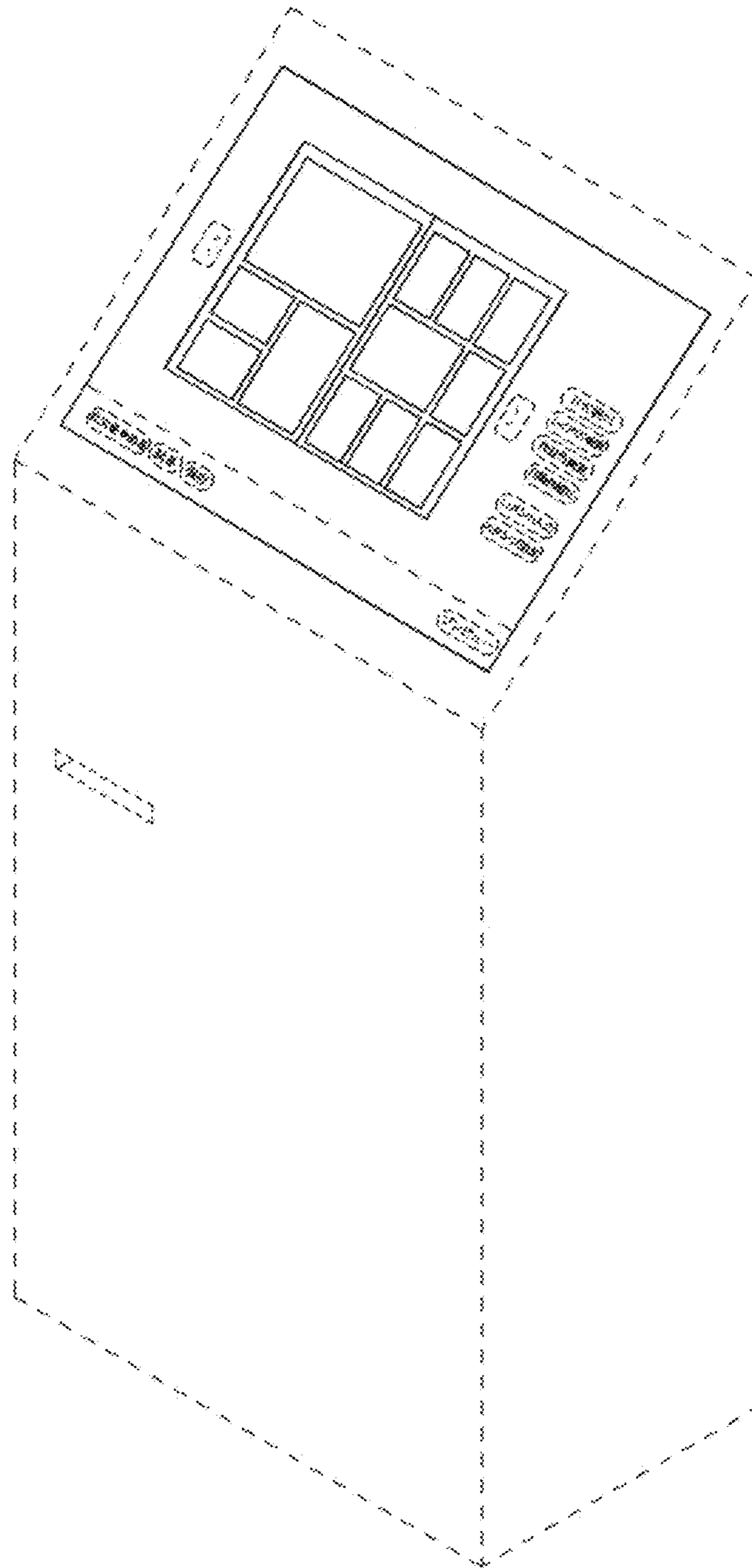

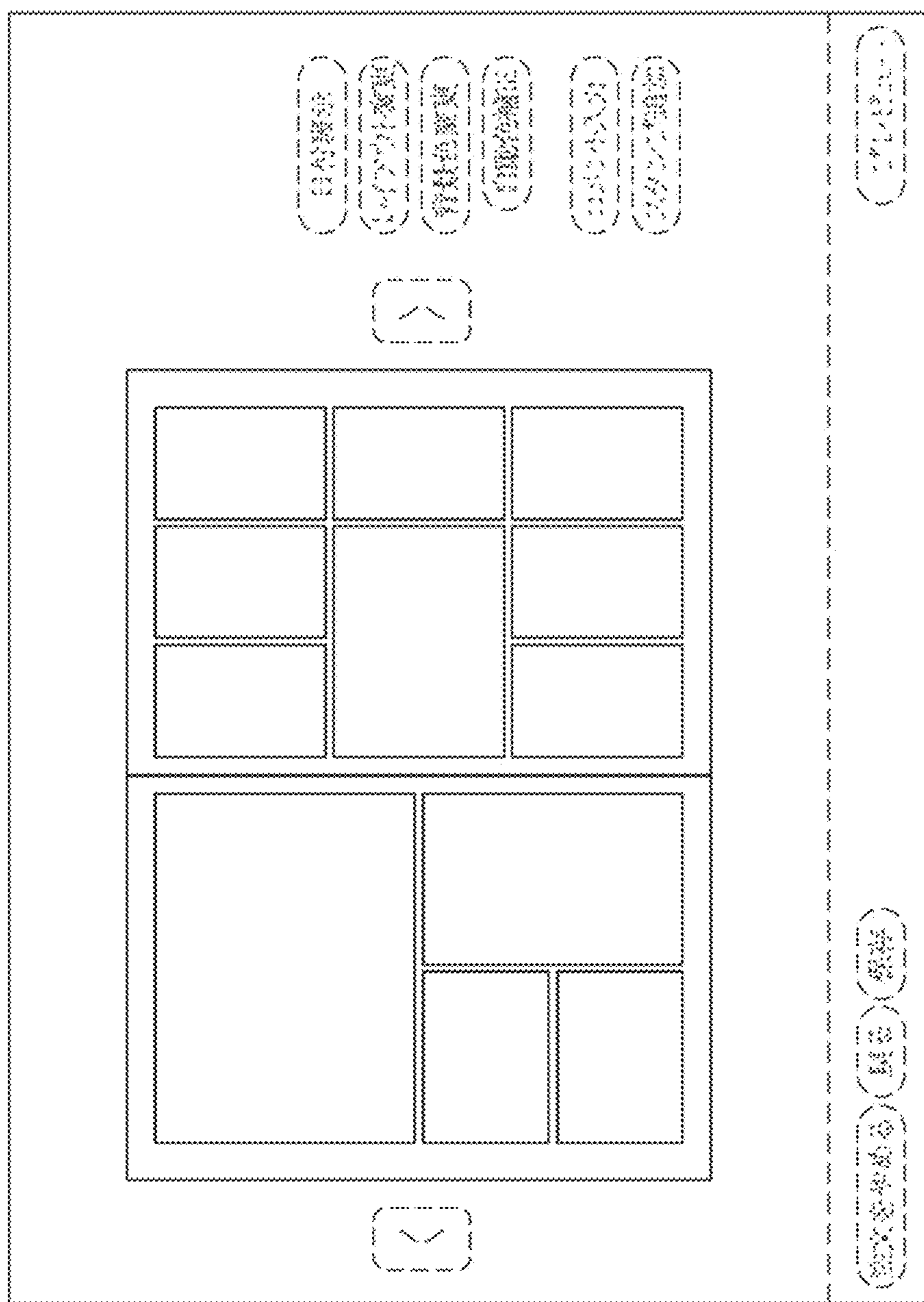

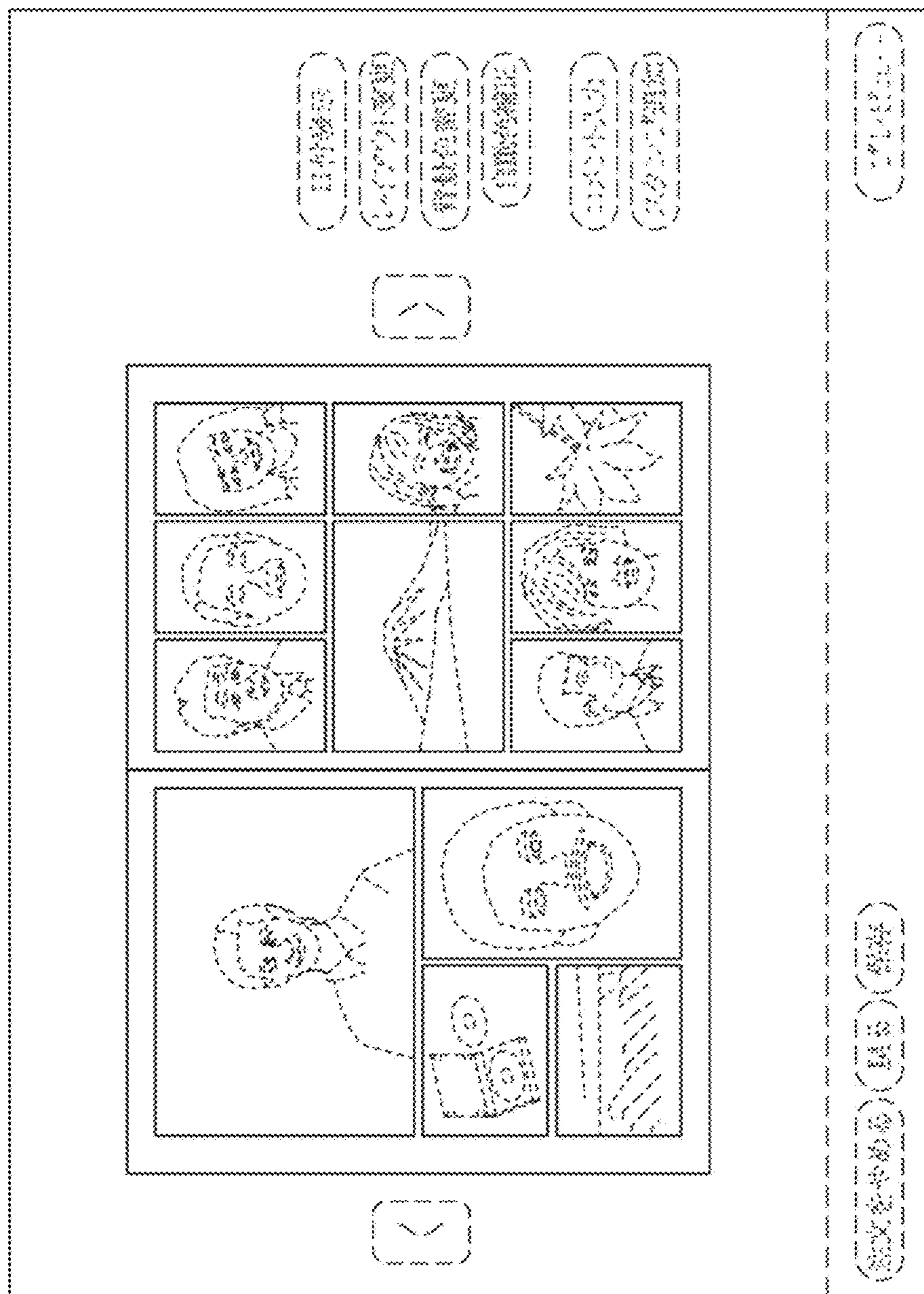

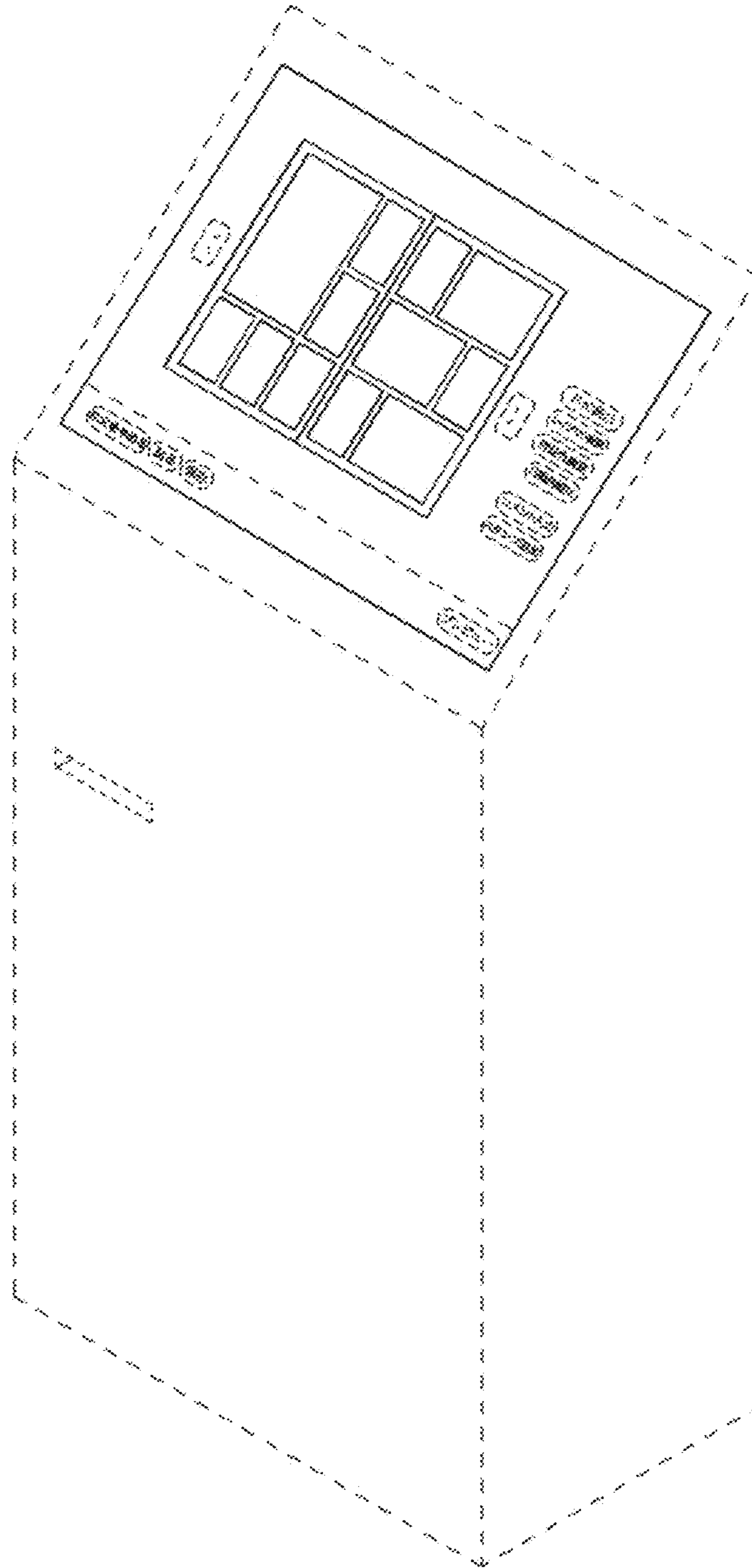

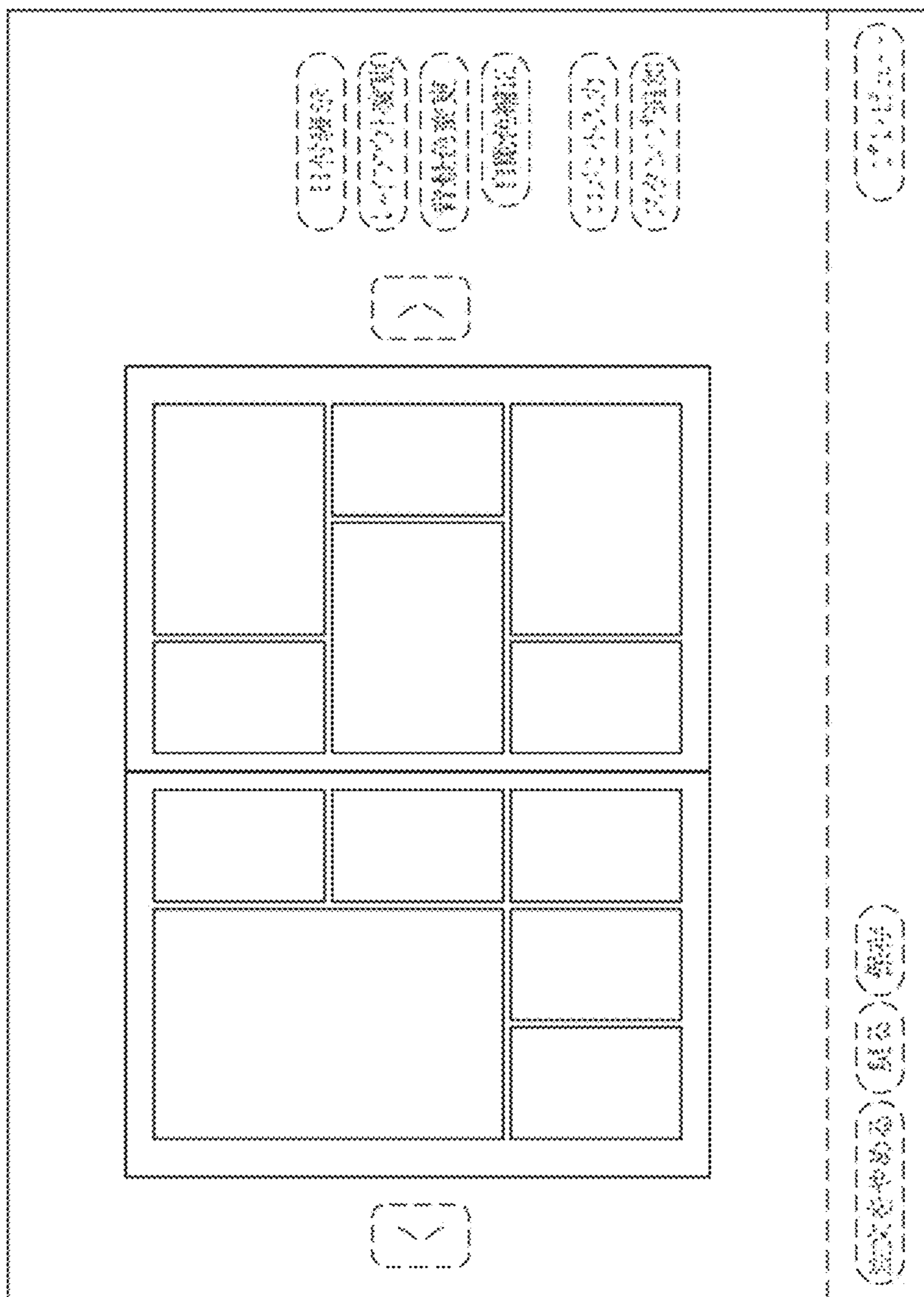

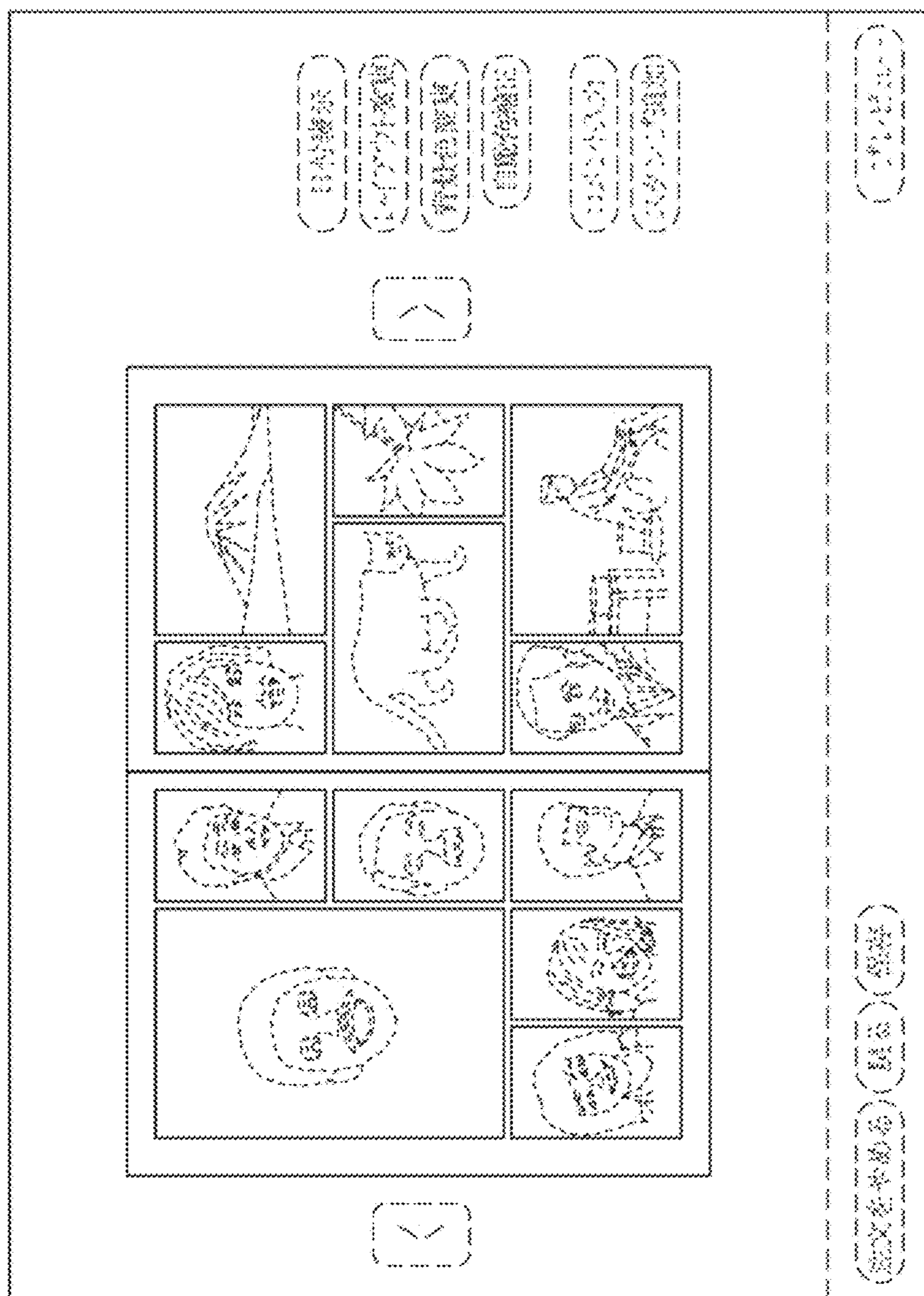

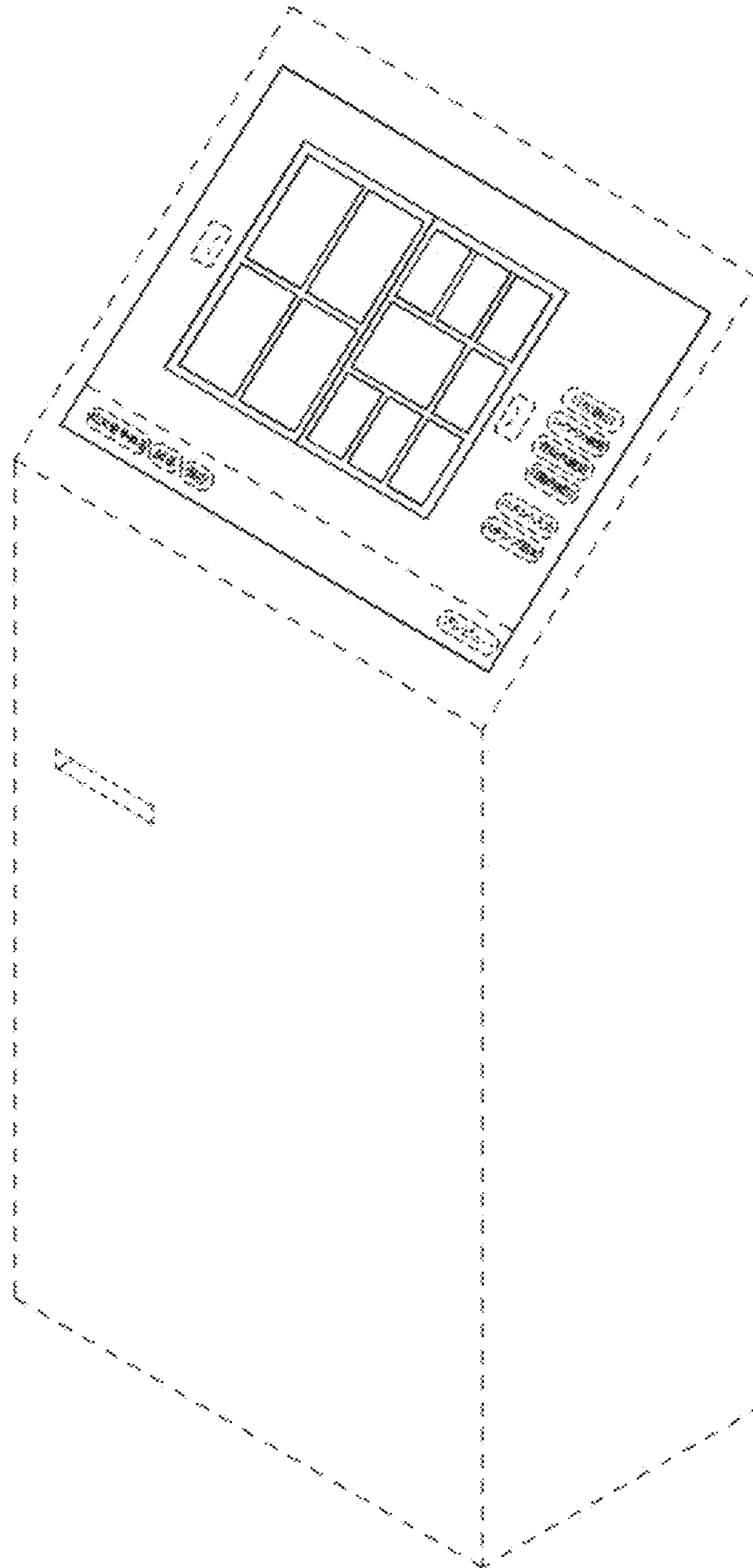

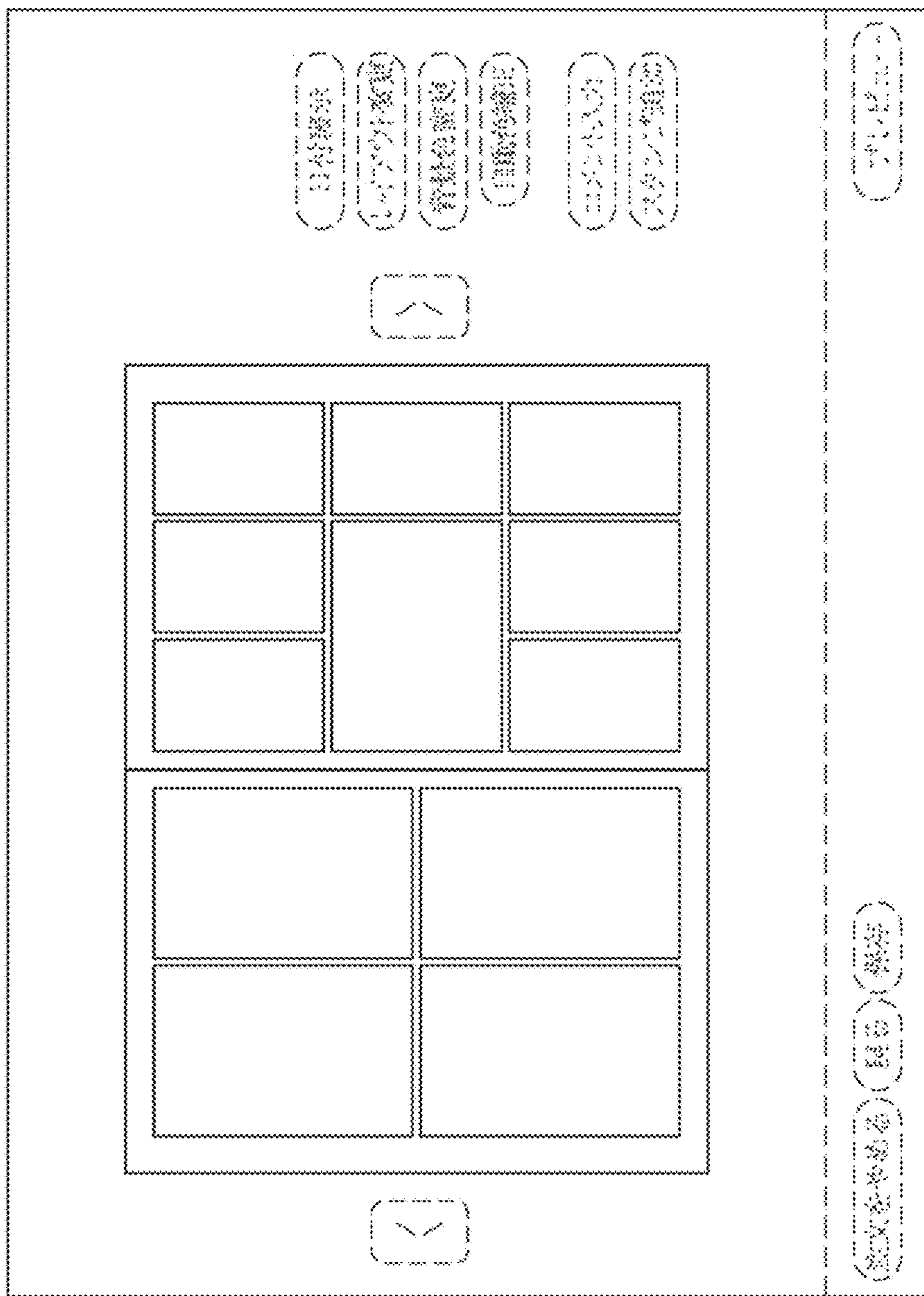

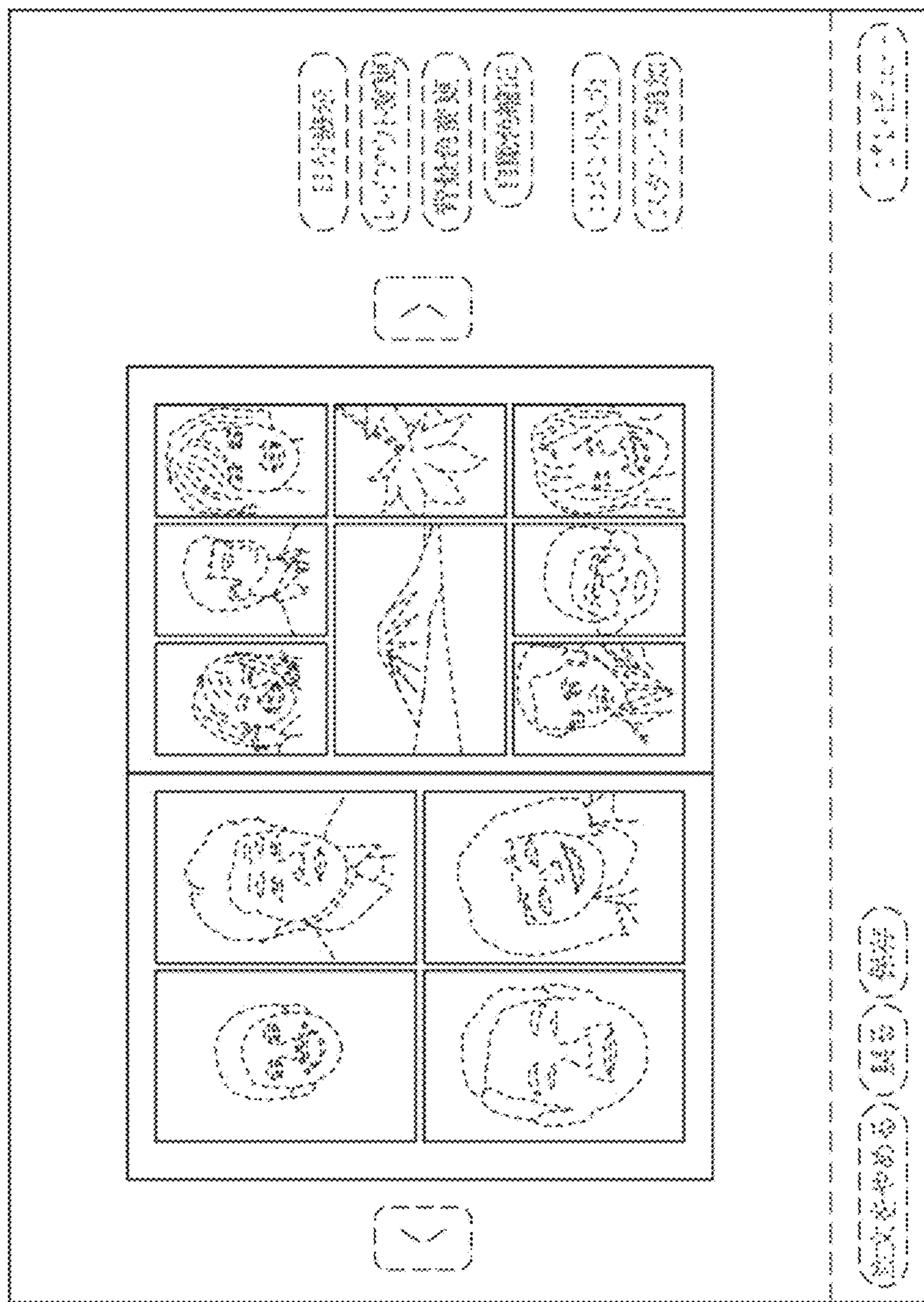

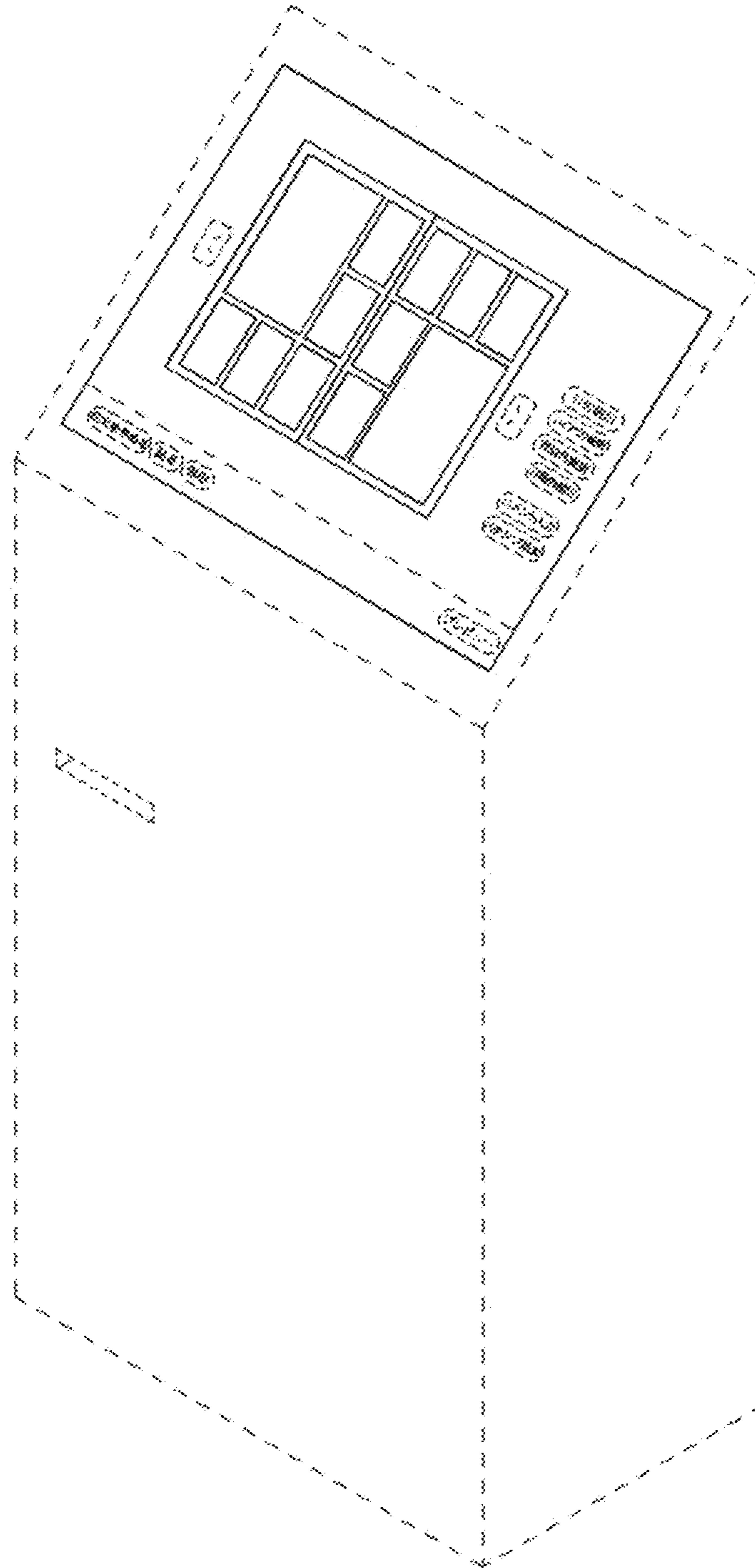

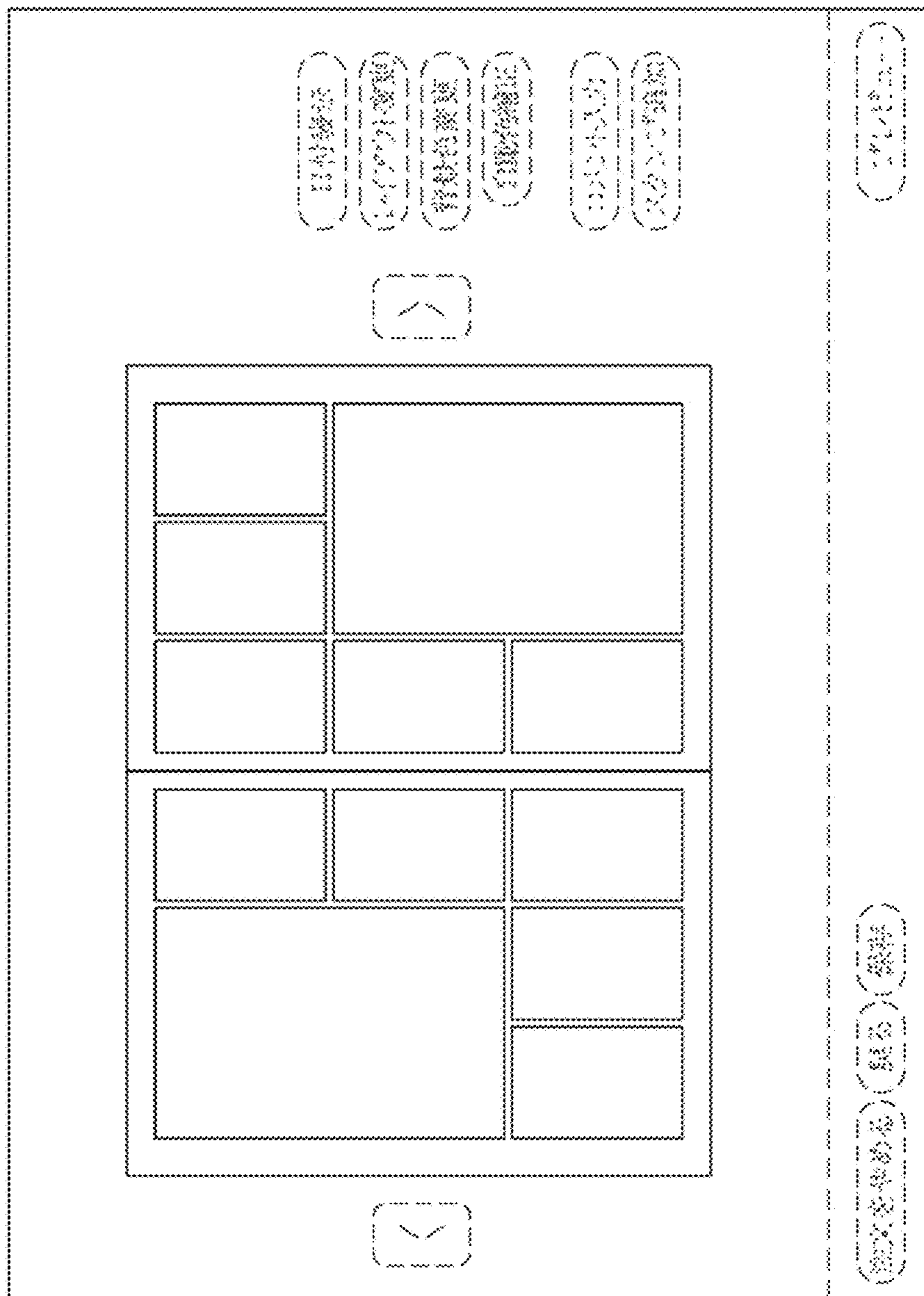
