FIG. 3 is a left side elevational view as shown in FIG. 1.

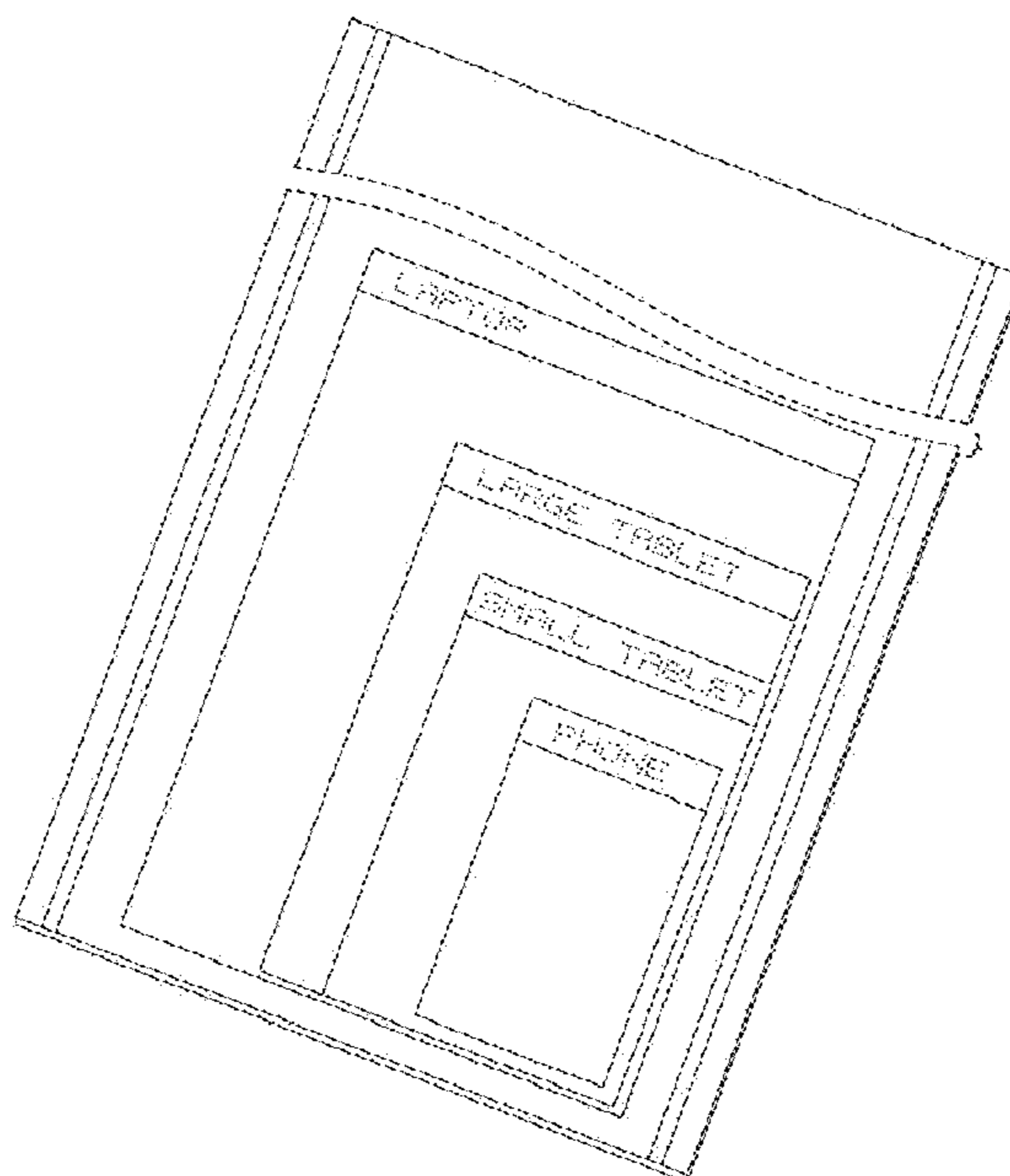
FIG. 4 is a right side elevational view as shown in FIG. 1.

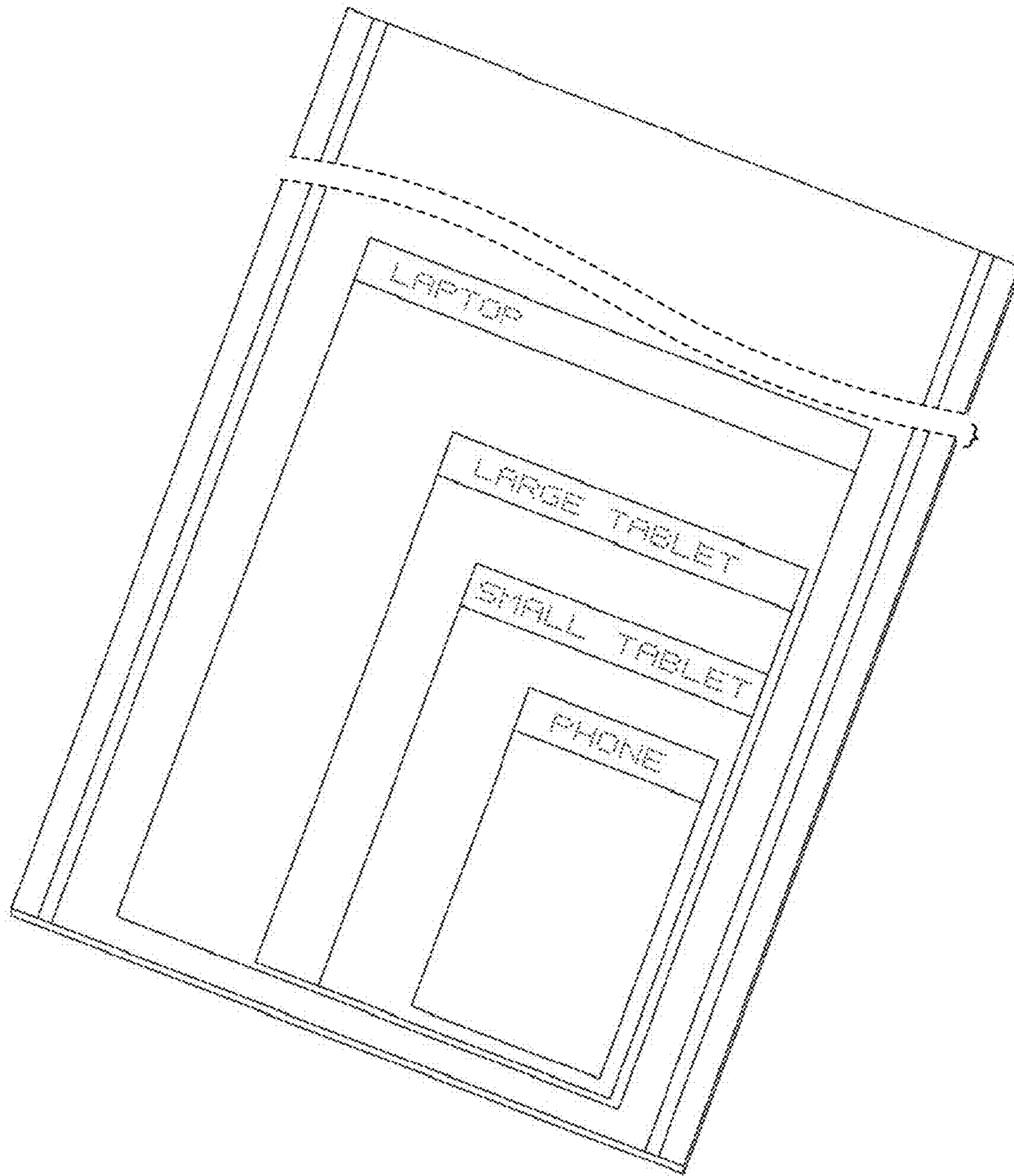
