The ornamental design for a knife handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a knife handle, illustrated with a first optional knife blade configuration, which is provided for context;

FIG. 16 is a left end elevational view of the knife handle of FIG. 11;

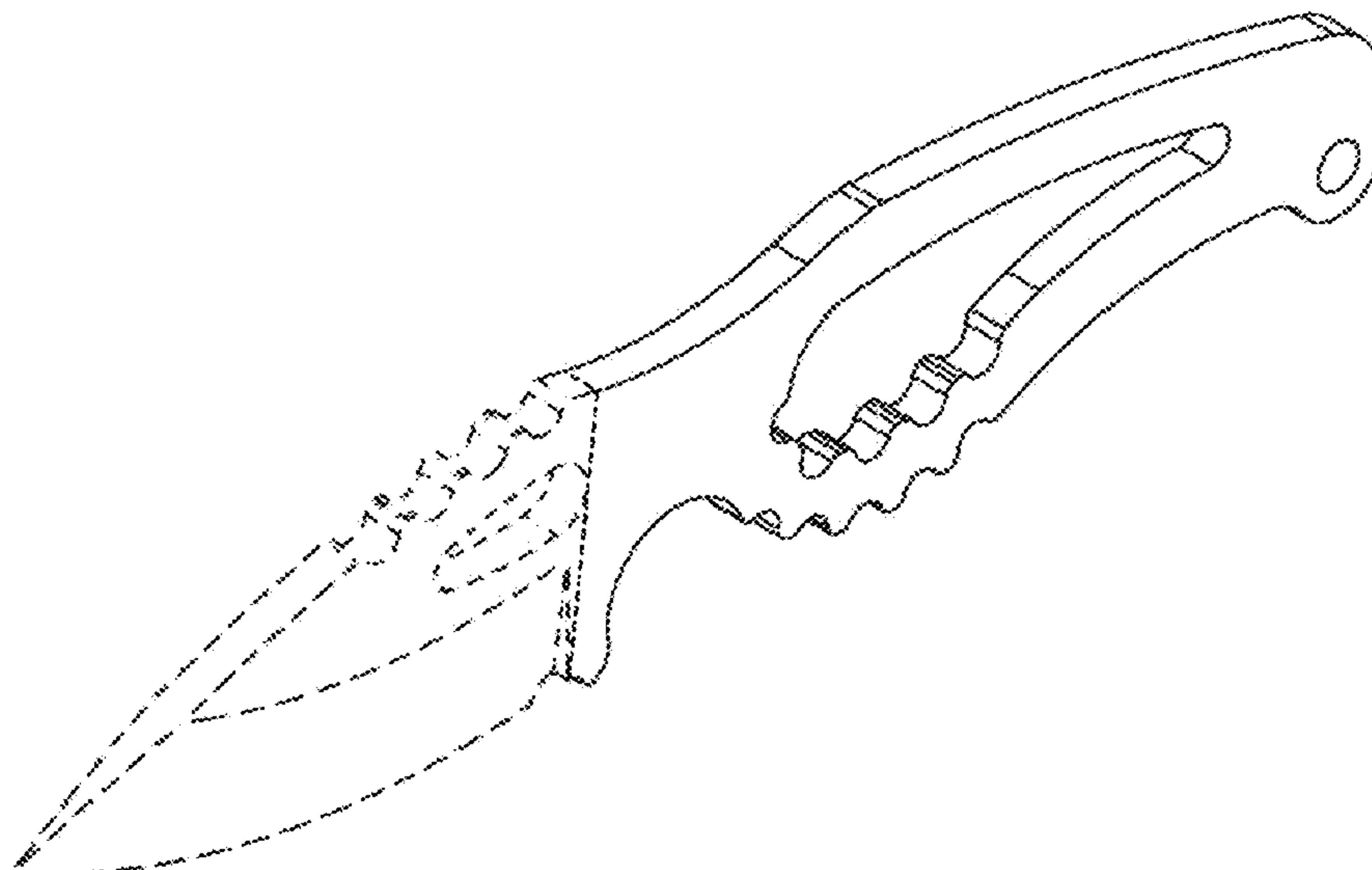
FIG. 17 is a right end elevational view of the knife handle of FIG. 11;

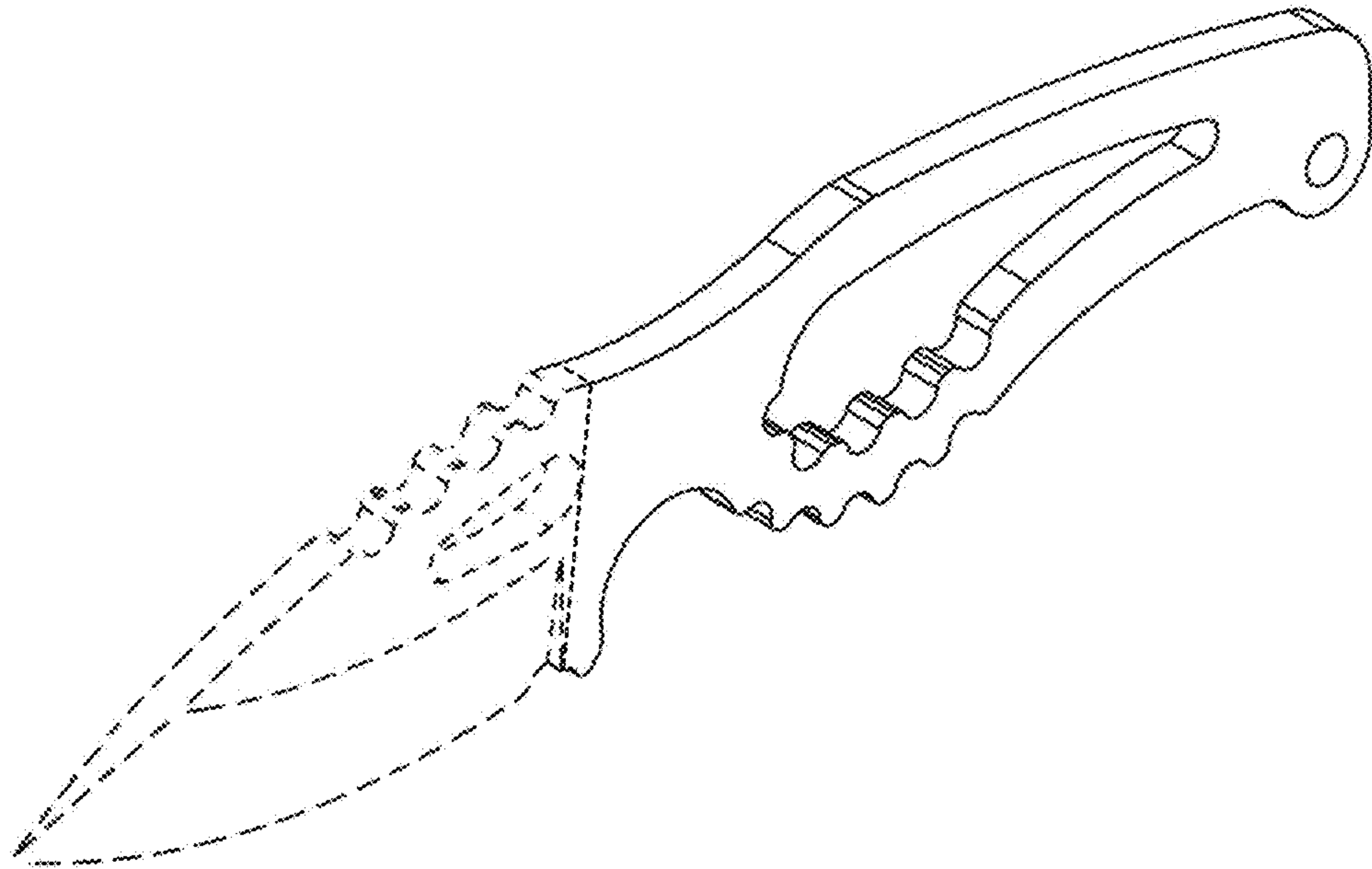

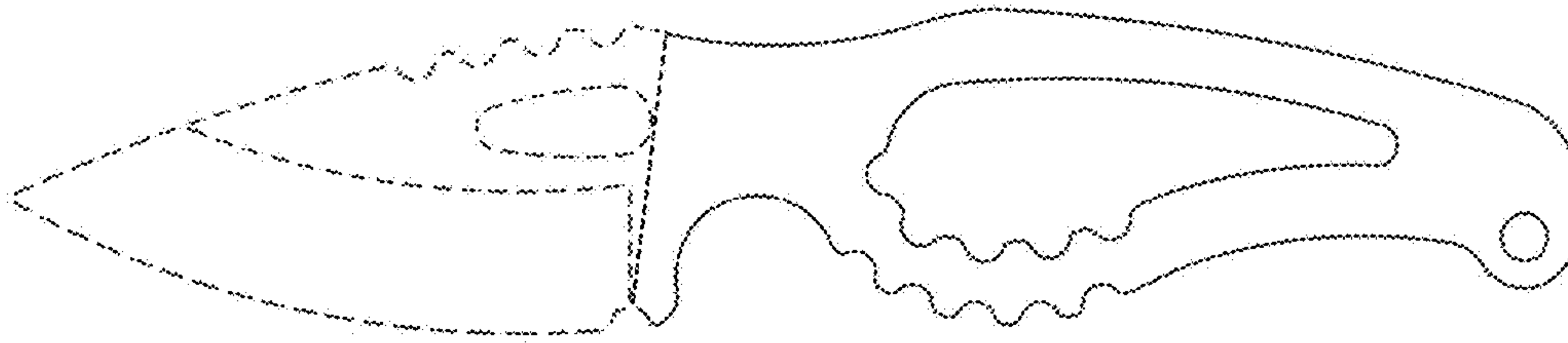

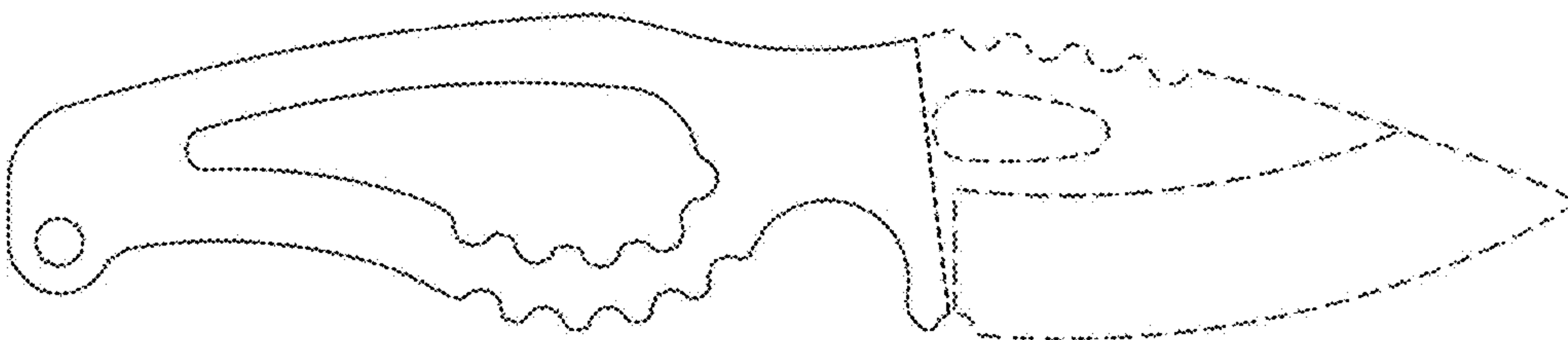

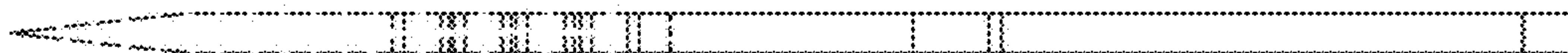

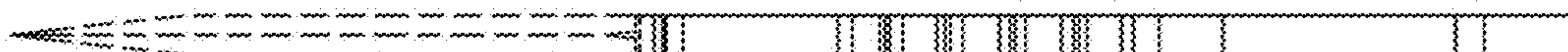

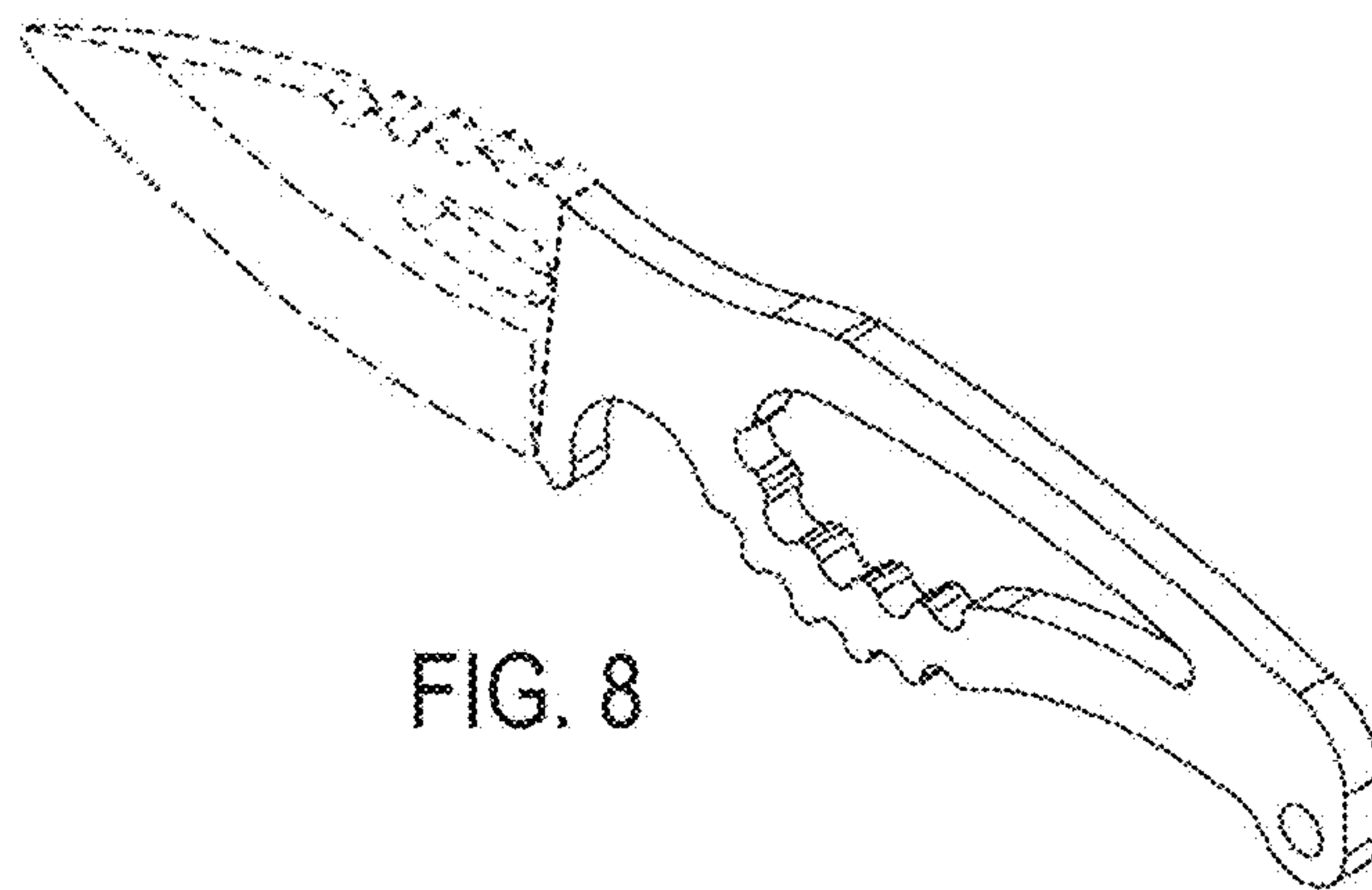

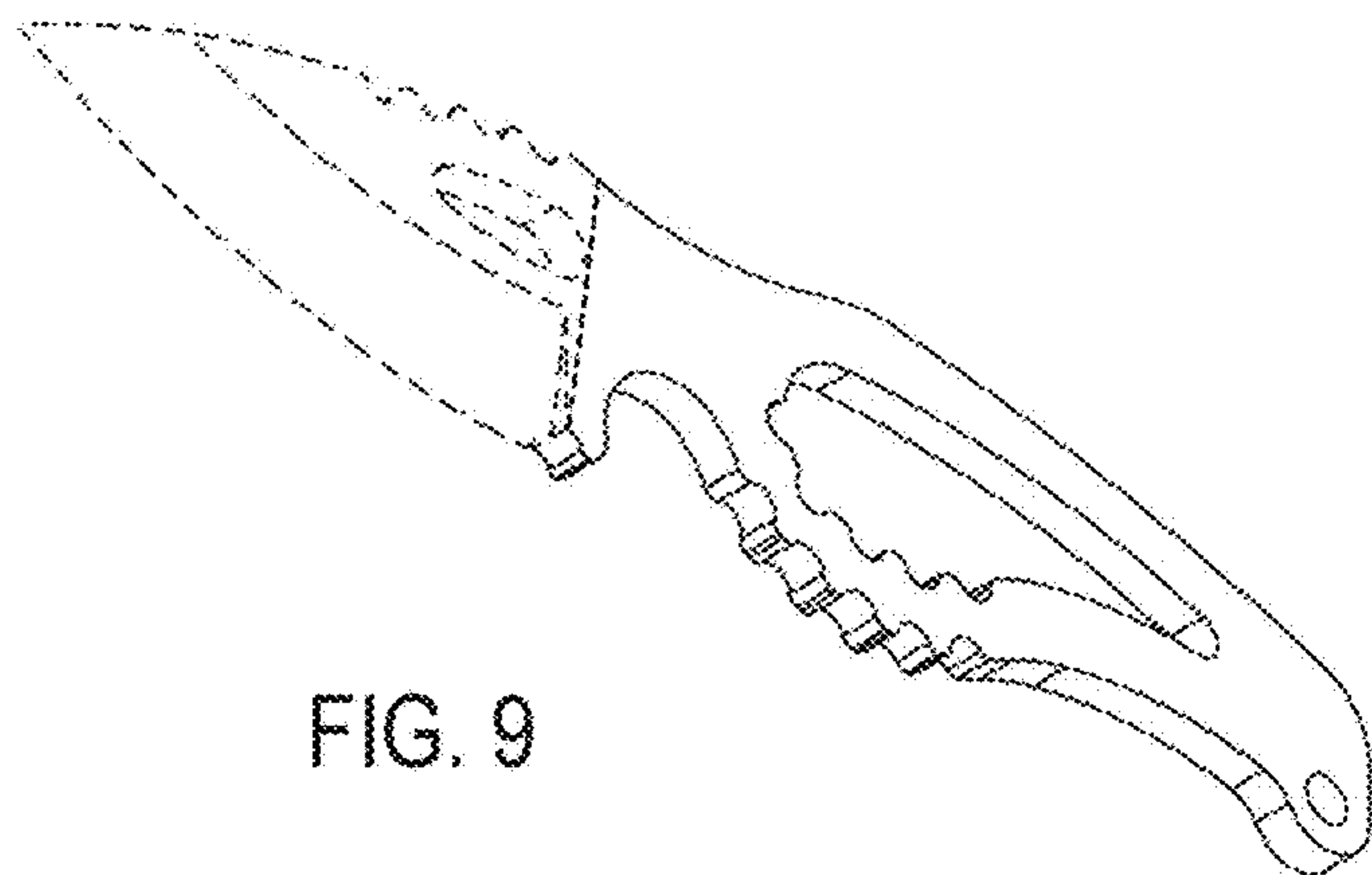

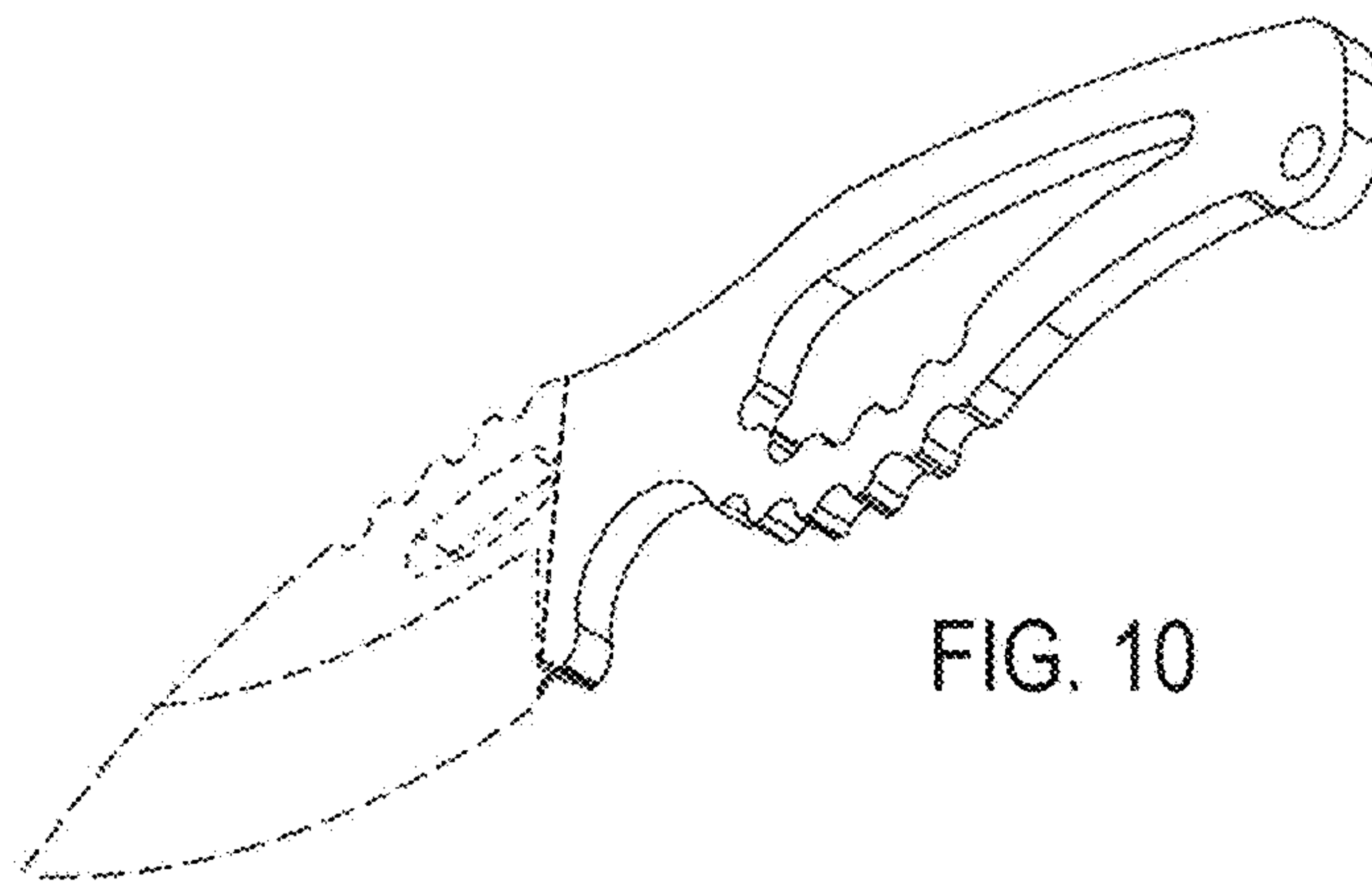

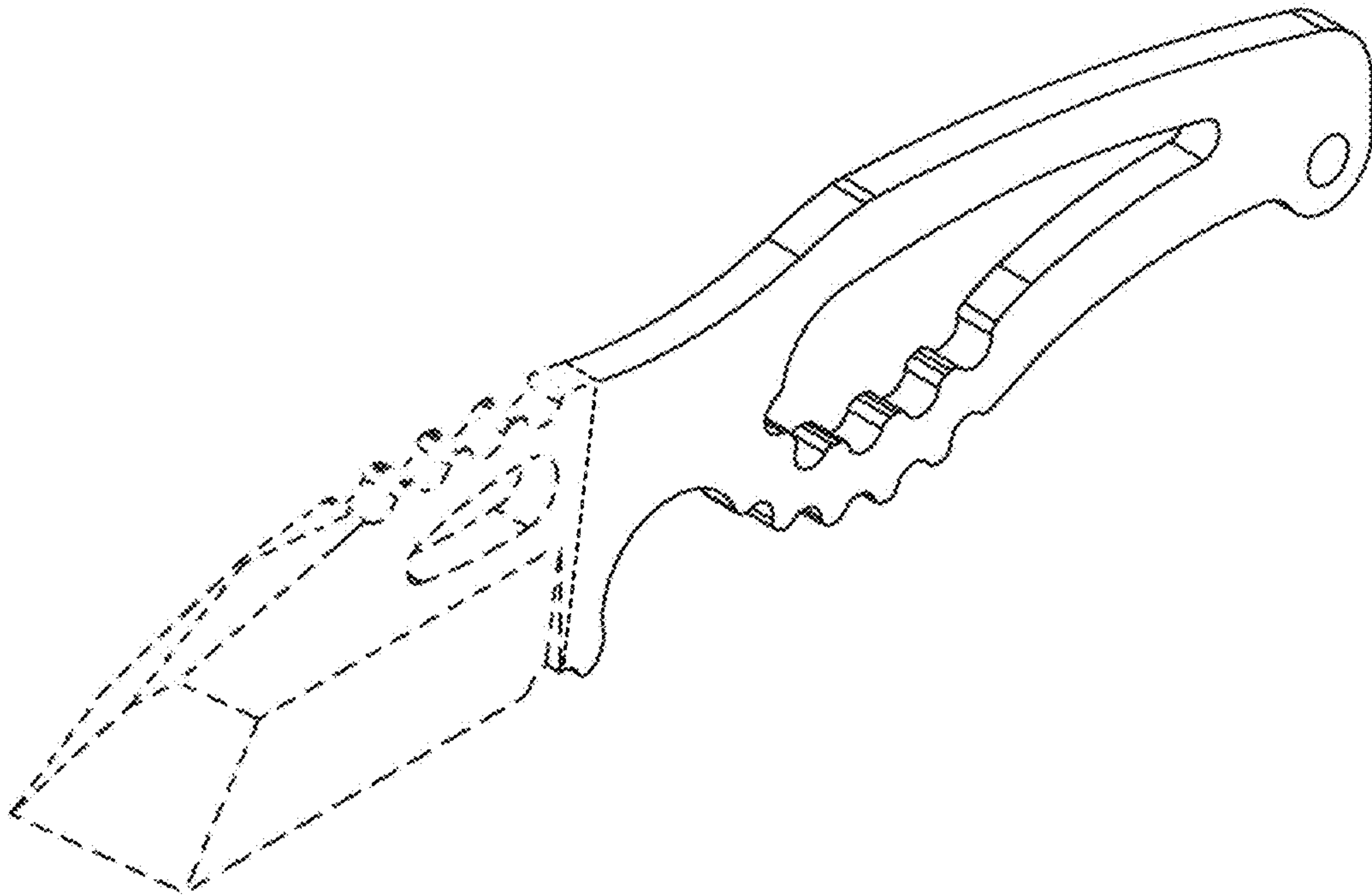

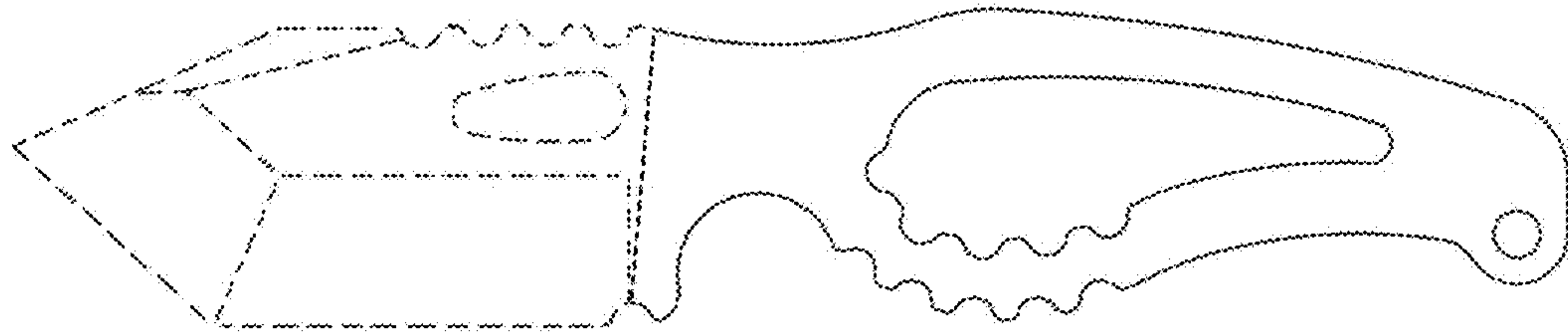

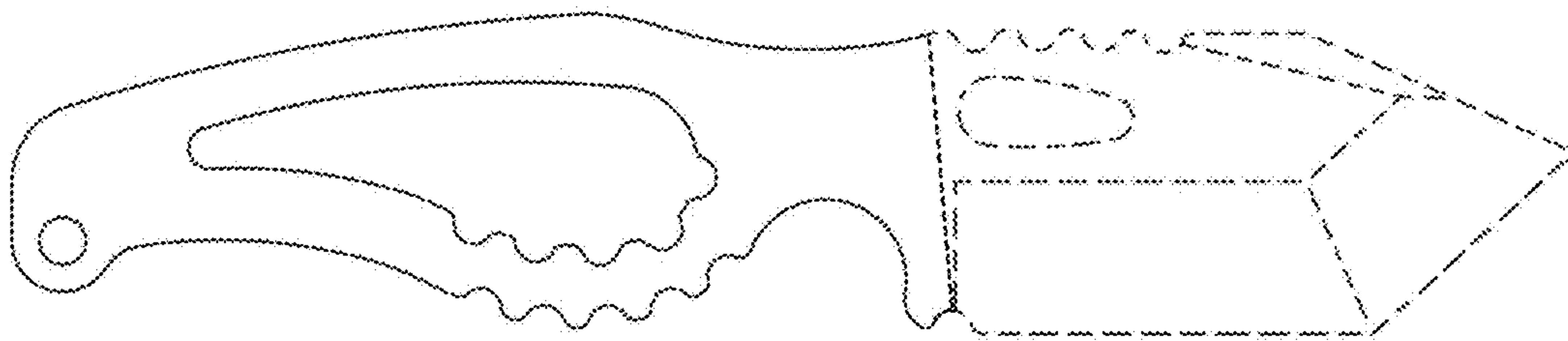

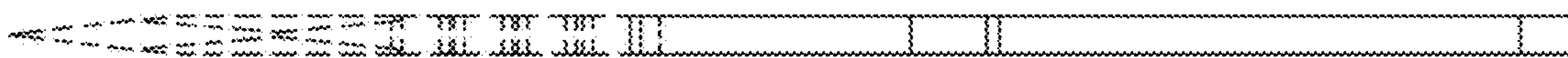

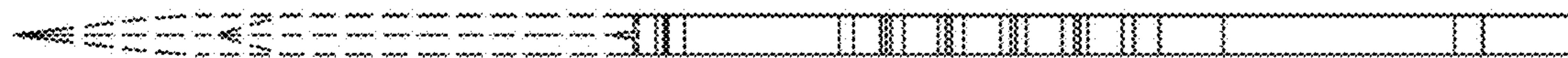

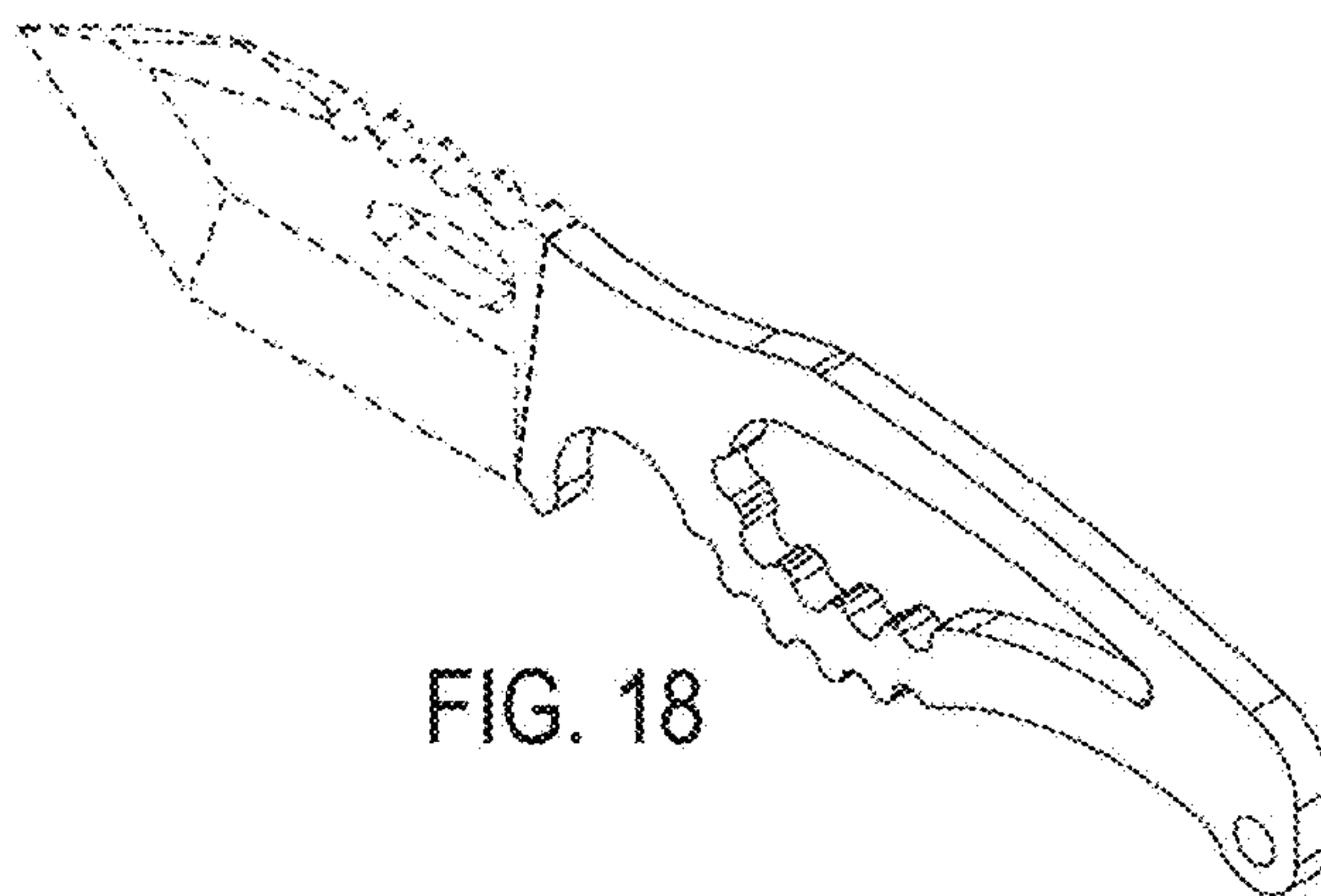

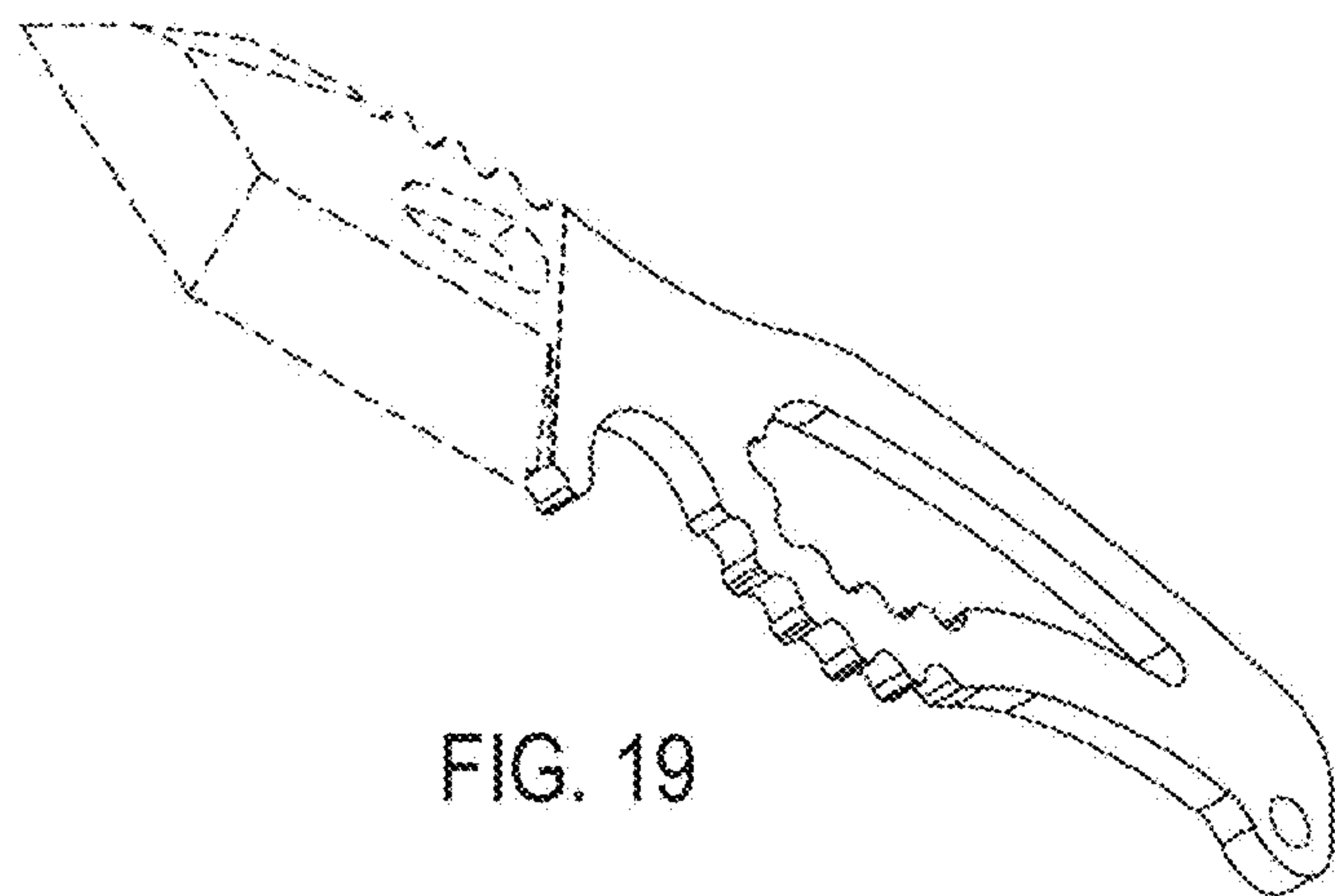

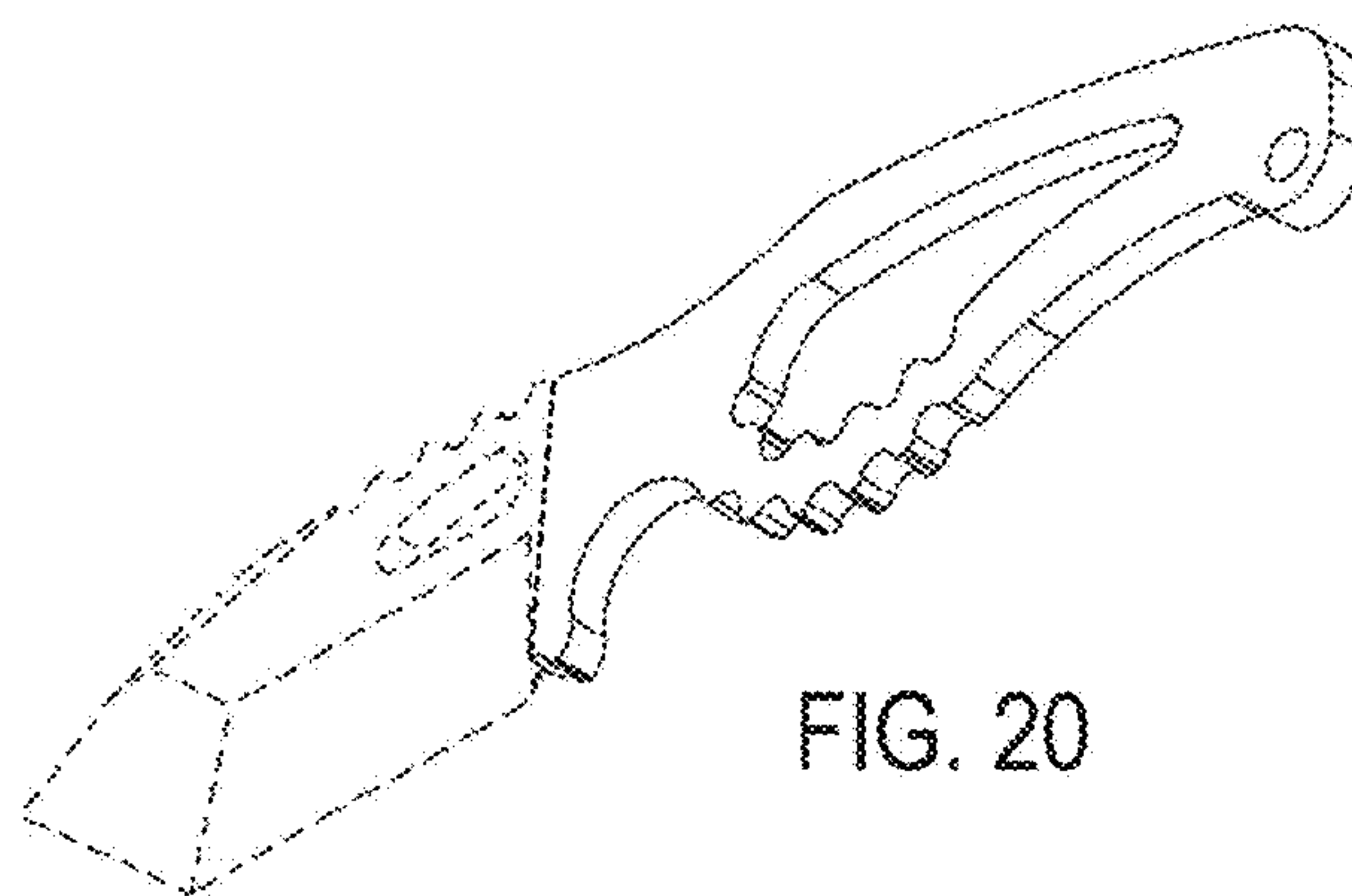
